### HAWAII NEI.

The Impressions of Miss Mabel Craft on Our Island Home.

Miss Mabel Clare Craft has in her book, *Hawaii-nei*, added a valuable volume to the literature which deals with Hawaiian affairs. The talented authoress visited Hawaii as a newspaper correspondent, representing several great journals which favored the policy of annexation, approved of the Stevens cabal of 1893, which, ended, in the overturn of the monarchy, and which sent Miss Craft to Hawaii to write up annexation and boom the oligarchy, masquerading as the Republic of Hawaii.

Every page in *Hawaii-nei* shows that Miss Craft used her eyes and ears while here, and carefully sifted the true situation, and she has succeeded in a marvelous way to catch on to the true inwardness of the characters and qualities—good, bad and indifferent of the men who have played a conspicuous part in Hawaii's recent history.

The book is written in a brilliant and fascinating style, and has been shorn of the dry details and statistics, which generally make a descriptive work tiresome to the ordinary reader.

That the "missionaries" will condemn the book goes without saying. If possible they would forbid the sale of it, and condemn it to be burned by the common hangman in front of the Central Union Church. But to the people who believe in reading the naked, unvarnished truth, "*Hawaii Nei*" will be welcomed, and the gifted authoress given a vote of thanks.

As she says in the introduction, "It is the thing as I saw it," and she saw it well when she adds: "In Hawaii is the old spirit that abides in unhappy Poland, that burns in the breast of Alsace-Lorraine. The looting of the Hawaiian monarchy by a few Americans was a sort of successful Jamieson raid, and not an exploit over which any American need thrill with pride. What I have said is only what every unprejudiced observer who goes to original sources may find for himself. Official sources are not always safe guides. The registration reports are open to all—so are the land titles—and the white oligarchy, which, seventy years ago, was a hungry missionary band with emaciated purses, speaks for itself."

The first two chapters are devoted to a vivacious narrative of the voyage from San Francisco to Honolulu and the first impression of that capital on the visitor. In the third chapter "The tropic republic" is dealt with.

"I have come to the conclusion," says Miss Craft, "that in Hawaii as in America, true religion and practical politics have not even a bowing acquaintance."

And she adds, "the men who went to Hawaii to teach the native the way in which he should go, began by being the power behind the throne, and ended by being the power in front of it."

"They cannot speak of Hawaii's latest sovereigns without a pious imprecation. To their cross-eyed mental vision all *luau*s were orgies and all pleasure unholy. \* \* \* And as for Hawaiian royalty, its behaviour was much the same as that of royalty in other lands—much as it will always be while wealth and power can buy everything in the world except happiness."

The description of the Thurston Home at Kailua is delightful. The use for a dairy of an underground cave which was *tabu* and sacred to the chief, and which eventually through an earthquake tumbled into the Thurston milk pans, is narrated in amusing language.

"The trouble with the missionary plan here, as in most places, was that it purposed to establish out of hand

a scheme of civilization for which the islanders were all unprepared. \* \* \* When the missionaries taught them religion, they should also have taught them how to maintain themselves in the throat-cutting civilization of the Anglo Saxon. \* \* \* It was, in little, a perfect feudal state, with all the civil war and trouble that attended feudalism in Europe. And upon this basis, constantly changing with the ambitions of petty chieftains, the missionaries expected to rear New England systems and New England ideas. History does not like to jump five hundred years. \* \* \* A little well-meant regret for the passing of the good-tempered, good-looking Polynesian, is greeted with the contemptuous remark: 'Oh, that is mere sentiment. We do not want a picturesque government. We want one that we can make money under. No white man is going to be ruled by a black one.' The suggestion that the white man might have stayed at home, is received with scorn and answered with silence."

When Miss Craft writes about the personnel of the republic she becomes sarcastic. She says: "These people who were willing to crawl on all fours to win favor of many sorts, mainly pecuniary and official, were the very first to cry, 'Down with the Monarchy!' and to make a great outcry about republicanism and the equal rights of free men, when their knees were still aching from the constant wear and tear."

Miss Craft has not a very high opinion of the newspapers of Hawaii, "The Muzzled Press," as she calls it. "The President was spoken of as though he were a god, and any disposition, even to inquire, was put down with all the savage intolerance of the descendants of those men who are responsible for that little episode at Salem. Here, under the palms, in a climate that would be expected to soften anything, appeared again that adamantine bigotry and intolerance which made the name of Puritan feared and hated, and which blackens their memory in spite of many virtues, even to this day. The one newspaper that dared to criticize is mentioned in the street with bated breath—never at all in polite missionary circles."

Our contract labor laws and the "act to mitigate" are dealt with "without gloves," and Miss Craft derides the men who could "find it in their hearts to license prostitution, but never the importation of opium."

Chapter IV. deals with the "American colony" which the authoress has sized up very well indeed, and in Chapter V. her subject is "Native Living."

Miss Craft admires the Hawaiians' knowledge of etiquette and all matters relating to precedent, and she enjoys the idea that if there is any color line in Hawaii, the brown man is above the salt and the paleface below. She claims that the Hawaiian-born Americans are sticklers for precedent. "For instance, President Dole, on his official trip to America, had with him as factotum and aide a man who went with Queen Kapiolani and Princess Liliuokalani to the Victoria Jubilee. He was not sure of the President's name, and registered him as 'Sanford B. Dole,' but he is considered the most eminent authority in court etiquette and state procedure on the Islands."

Miss Craft says the Hawaiians must be a cheerful people because they are so fat. "The stately women are shapeless heaps of fat, and the men are not much better, except that exercise keeps them in somewhat better form. But I doubt if such a tendency to rotundity would be found in any but a cheerful people."

INTERCEPTED TELEGRAM.

(Not from W. A. Kinney.)

WASHINGTON, D. C. — Legislation on Hawaii hung up—Appropriation bills pressing—Canal lobby claim precedence of Hawaii—Extension of immigration and labor laws may be passed at the last moment—Tariff legislation on Hawaii has too many influential opponents—Navigation laws held up because of protests from Maritime powers. Should all legislation on Hawaii go over to next Congress the delay will lead to recasting of Hawaiian legislation, and colonial forms will be adjusted to Hawaii. This will mean a duty of one-half to one cent a pound on Hawaiian sugars, to support colonial governor and staff. Impressions here that planters money is being used by Hawaiian lobby. Anti-expansionists gaining in numbers and influence. Republican party managers will have to give way on some points.

### JUDD'S JUBILEE.

They bowed to him, they ko-towed to him, and they honored Alapeka and his father at that dinner which was given on Saturday night at the Hawaiian hotel.

Dole made a speech, Hartwell said a few words, Judd looked at the champagne bottle and addressed the guests. Only a few of the men present represented the Bar of Hawaii and speeches were only made by new-comers like Stanley, Perry and Ballou.

It was well, however, that the kamaainas, except Hartwell, preferred to be silent. The people of Hawaii cannot join in the official adulation of Mr. Judd. They cannot throw incense on the altar erected for the special worship of his father, Dr. G. P. Judd, and they fail to see what good Alapeka ever did to the Hawaiians.

It is nice to see a fine menu arranged for the professional meddler, who disturbed for years the peace of district magistrates and officials who did their best to carry out the laws of the land, according to their abilities.

The members of the Bar dined the guest of honor very well indeed. They gave him "Eastern oysters," which are supposed to be "mum." Realizing his character they served "Mock turtle," and admiring his figure they brought out "Stuffed olives."

Russian caviar on toast was a side dish which showed the determined stand of the C. J. in being an American and devouring the Russians. He passed over the mullets from some of the stolen fish ponds and naturally enjoyed the sauce Corbett. A fillet of beef a la Bank-account was enjoyed, and green peas on top of Molokai venison outlets were received with applause.

The noble jubilant then had punch a la Richelieu, and added to his indigestion by eating a few asparagi. The stuffed ducklings which followed the speech-making very nearly spoiled the whole business, but Alapeka woke up when "Pudding a la Reine" and "Gelee Harlequin" were served.

The judiciary clown is an excel-

lent Harlequin and he was always around when there was something "a la Reine."

The banquet is "pau" and we devoutly hope that A. F. Judd can be described by the same word.

The members of the mutual admiration society may throw bouquets at each other, and Mr. Judd may gain a reserved seat on the rainbow. To us he is simply N. G., and he will retain the title.

It is understood that at the Bar dinner to the Chief Justice on Saturday night considerable stress was laid upon the advisability of organizing a Bar Association with the object, among others, of aiding congress in Hawaiian legislation in reference to matters pertaining to the judiciary system and the protection of the interests of poorer litigants. It was felt that it would be manifestly unfair and unjust for this class, in a contest with wealthy corporations or individuals, to be driven from court to court and eventually be crushed out of court by having the matters at issue appealed at great expense to Washington. It was also felt that as there was but little hope of our fundamental law coming into operation this year there was ample time for such a contemplated organization to get to work and use its influence before December next in furnishing necessary information to Congress to prevent unintentional injustice being done to litigants by "half-baked" legislation. The suggestion emanating from the senior lawyers is an eminently good one, and with the advent of a large number of bright and ambitious young practitioners should be easier of accomplishment than the previous attempts which have only resulted in failure. It is a matter, however, entirely in the hands of the lawyers themselves, but the opportunity is accorded to them of doing some public good, and the Bar of Hawaii is not devoid of talent and ability.

### He Goes.

H. S. Padgett, well-known as a fireman in the local bureau, has resigned and said good-bye to the work allotted to the employees of the fire extinguishing engines.

Padgett, who for years was the stand-by of the Fire Department, has deserted his old friends and has accepted a position as engineer of the steam ploughs on Oahu Plantation.

He started on his new job last Thursday, and the old crowd says "good-bye Mr. H. S. Padgett."

### Pacific Cable Probabilities.

WASHINGTON, Feb. 8.—It is asserted that the opposition to the Pacific Cable Bill has been modified, and another attempt will be made to take it up into the House of Representatives for passage. The administration is now said to be behind the measure, and will use its power to have the bill pass before the adjournment of Congress. To this end changes are to be made in the bill. For instance, there is to be a clause which will give the Postmaster-General discretion in awarding contracts, which may bring into the field other bidders for the franchise than President Strymser of New York, with the result that the cable may be laid without the expenditure of a dollar for bounty by the United States Government. While in San Francisco Mr. Strymser declared that Wake Island could not be used as a cable station as it was uninhabitable. He strongly favored Ualan Island for the purpose.

 The U. S. collier Brutus arrived off port on Saturday night from Guam. She reports that the condensers of the U. S. S. Bennington are out of order, and that she is consequently detained until the Brutus returns with necessary machinery from the Honolulu Iron Works.  
 The S. S. Belgian King of the California and Oriental S. S. line arrived yesterday afternoon, 17 days from San Diego. She is consigned to Alexander & Baldwin. Her officers are, Capt. Thos. L. Weiss; Chief Officer M. Coles; Purser T. A. Masterson and Chief Engineer J. T. Vanies. Her crew are all Chinese.

**ACTIS REVM IMPLET.**

The Chief Justice Dines with the Bench and Bar in Recognition of Twenty-five Years Continued Service as a Justice of the Supreme Court.  
 The banquet given by the Hawaiian Bar to Chief Justice Judd at the Hawaiian Hotel on Saturday evening was an incident probably unexampled and unprecedented in the annals of the Bar of any country. Few judges have served in the same court continuously for twenty-five years, and none under such conditions as the radical and elemental changes of form of government that Hawaii underwent during the term of office of Chief Justice Judd. The only other example that strikes the memory as being pertinently applicable to the present instance is that of the famous Vicar of Bray whose motto was, "whatever king shall reign, I will be the Vicar of Bray, sir." He served in "good King Charles' glorious reign" and accommodated himself to old Noll, the regicide, with equal facility; but, after all, elasticity of human conscience is aptly at times the safety of the commonwealth when the principle at stake is the perpetuation of fundamental principles attaching to sound constitutions inherited from the days of the Witenagemote or of Runnymede, and which principles must ever rule and reign in the preservation of the liberties of the English-speaking races.

Chief Justice Judd has participated in more than one fundamental revolution, and however much his political opponents may disapprove of his personal conduct they are constrained to admit that the lines of action laid down by him as a judge were conservative in the great struggle between absolutism on the one hand and oligarchical centralization on the other. The latter is, perchance, less dangerous than the first, for it is one step nearer to popular rule, which naturally follows in due course, and may be obtained with minor fractions.

With a radical political judge in power during those passion stirring times the condition of Hawaii would not have been as pleasant or honorable to-day as it even now is while on the threshold of the ever-coming dawn of hope and prosperity.

The mere fact of the retention in office of the Chief Justice for so long a period and during such important political changes reflects, perhaps, even more honor upon our Hawaiian system than upon the incumbent himself, and yet it stands to reason that had the incumbent been a notoriously incompetent or unworthy man he could not have maintained his position and received, at the conclusion of a twenty-five years term of office, so cordial a recognition of his services as was granted to him on Saturday evening by so honorable and influential a body of gentlemen; so the honors must be accepted as "standing even."

The banquet was presided over by Ex-Judge Hartwell, who had the guest of the night on his right hand with the President of the Republic on his left. There were forty-seven guests assembled including Associate Justice Whiting, Judges Perry and Stanley, the Attorney-General and his assistants, and ex-Ministers Hatch and Thurston.

The feast being in the nature of a "family gathering" the Press was not invited to participate in the historical event, and under these conditions THE INDEPENDENT deems it indecorous to report the speeches made by the following, among other speakers: Judge Hartwell, the Chief Justice, President Dole, Judges Whiting, Perry and Stanley, the Attorney-General, Messrs. Davidson, Hatch, Thurston, McCants Stewart, McClanahan, Humphreys, Ballou, Kaulukou, Weayer and Atkinson. Mr. Humphreys also read a witty poem and a letter from Judge Hardy.

The dual patriotism of the diners was aroused by the national hymns of "Hawaii Pono" and the "Star Spangled Banner," and they remained standing while they were

played, and then gave three lusty cheers for the latter.

A high tribute is paid to Princess Kaiulani. "This refined and gently bred girl is a model of the feminine graces and proprieties. Only a royal temper and a will of her own that brooks no contradiction have descended to this daughter of fiery chiefs."

In regard to Island morality Miss Craft says: "The question of Hawaiian morality is still a hotly disputed one. There are Americans in Honolulu, who declare to you that the Hawaiian women are without chastity, and they point triumphantly to the fact that there is no word in their language to express this virtue. And there are other equal reputable American men—husbands of Hawaiian wives—before whom these critics would not dare to make this remark. The truth lies somewhere between the extremes. The Polynesian's ideal of morality is far below the Caucasian's. His practice is about the same."

Miss Craft in Chapter VI deals with the "transplanted Oriental," describing his arrival and life here and says: "It seems odd that the fugitive slave law over which men fought and bled forty years ago should be in force in a republic at the end of the century."

The narrative in Chapter VII of how Hawaii became American has been published before in the San Francisco Chronicle and other journals. It is a strong, pathetic and sympathetic story of that historic event.

Queen Liliuokalani's home coming is graphically told in Chapter VIII, and in the next chapter a description is given of a royal burial, Miss Craft being here at the time of the funeral of Ninito.

In Chapter X the passing of the kahuna is the subject of the author. It was Miss Craft's good fortune to see a genuine kahuna at work, and it is to be hoped that the disclosures of the priest craft will not lead to the *anaana* of Miss Craft.

The remaining five chapters are devoted to a description of travels in the country districts and to "Legends and Folk-Lore." They are written in the same excellent style as the historic chapters, from which we have culled the above printed gems.

Hawaii nei is published by William Doxey of San Francisco and is profusely and beautifully illustrated. Miss Craft dedicates the volume: "To those well-remembered ones, dwellers, some in peaceful, ocean-girt Hawaii, voyagers, others, faring upon many seas whose gentle courtesy added unforgettable pleasure to the midsummer's journey, of which some account is here set down this book is inscribed a token of grateful appreciation and esteem."
