THE industries of this country have received some attention from the Legislature and bills have been brought in by several members and by the Government to assist in certain undertakings. These have been advocated in the columns of this newspaper and are likely to bear good fruit in the future.

A paragraph in this paper, some months ago, showed that in the Kula lands of Maui a large quantity of potatoes and corn are now being raised. There is no reason why a pound of potatoes should be imported into these Islands.

Corn, ground with the husk, is now being used on many plantations for feed for horses and the finer kinds of stock. But corn could be put to better uses than this with the expenditure of a little energy and some capital.

We have indicated a few of the industries which are beginning to occupy the attention of some of our young men. There are many others which they may go into and find themselves far happier and more independent than simply occupying positions as clerks or lunas.

We feel assured that there is a future for small farming in this country, and once it is properly started we shall have a sturdy and independent class growing up amongst us which will make its weight felt in the political councils of the nation.

LEGISLATURE OF 1888.

The Best Eighty-eight Days' Practical Legislation ever Accomplished in the Kingdom.

The Legislative Assembly that closed its first regular session on Tuesday evening last was, without question, composed of a body of men more thoroughly representative of the people than any body of legislators ever before brought together, the session of 1887 excepted, in these Islands.

That the members of the House were experienced legislators or eminent statesmen has never been claimed on their behalf. Several of them, however, have been active members of legislatures under the old Constitution.

What is claimed for the body of men who assembled on the 29th of last May to deliberate on affairs of state is that, during the eighty-eight days they were in session, they devoted themselves diligently to business. Hard, conscientious and honest work was done.

While a large portion of the eighty-eight days of the session of 1888 was necessarily absorbed in the consideration of measures finally consigned to the waste basket, the House has placed on the statute book a larger quantity of progressive, practical and useful legislation than has ever before been effected by any legislative assembly in this Kingdom.

Conspicuous among the measures for which the people of this island realm will have cause to remember with gratitude the session of 1888 and which the future historian of the country will delight to record, are (1) the election law, (2) the free schools law, and (3) the contempt of Court law.

Following is a list indicating the Acts passed during the session and added to the statutes of the country, either as new laws or amendments to those previously existing:

Explosives in taking fish. Sale and slaughter of beef. Proof of service of process. Abolish office of Governor. Limit permits for Chinese. Bureau Public Instruction. Registration of Copyrights. Repeal rewards to Sheriffs. Proceedings in bankruptcy. Honolulu Fire Department. Street railway in Honolulu. Jurisdiction Circuit Judges. Prevent coffee leaf diseases. Clerks of Courts to tax costs. Keeping of books of account. Convey land Lunalilo Home. Internal taxes, amend sec. 15. Internal taxes, amend sec. 21. Internal taxes, amend sec. 22. Records to be kept by officers. Taro flour and products of taro. Importation and sale of alcohol. Peremptory challenges to jurors. Registration of spirits, labels, etc. Illicit traffic in spirituous liquors. Suits by and against government. Payment salaries to Aug. 31, 1888. Number Justices of Supreme Court. Cultivation and manufacture ramie. Notices Public to administer oaths. Sale of goods by commercial agents. Convey land for charitable purposes. Prevent steamers carrying lepers, etc. Remit postage, "Paradise of Pacific." Married persons deserting each other. Commutation terms of imprisonment. Property and rights of married women. Street railway completion, extend time.

Appropriations for the biennial period. Prohibit importation and sale of opium. Duties formerly performed by Governors. Security depositors Postal Savings Bank. Commissioners private ways and water rights. Re-establish Commissioners boundaries. Chief Clerk, Interior Office, to sign Licenses. Prevent issue of commercial paper as a circulating medium.

A statistical abstract of the business of the House shows 285 reports, including 151 Ministerial reports relative to bills presented to the King for signature; 207 petitions; 138 bills, a considerable number of which were substitutes submitted by committees on the original bills; 92 resolutions; 84 notices of bills; 51 Ministerial answers to questions; 12 miscellaneous documents; and 77 Acts passed, one of which failed to become law.

Four of the bills passed became law by the operation of the ten days' limit clause in the 48th Article of the Constitution. The bills relating to the military forces, the keeping of books of account and to abolish the office of governor became laws, notwithstanding the veto of the King.

The only case in which members present failed to vindicate their inherent rights as representatives of the people to legislate as seemed best to their own assembled wisdom, was when they allowed the coffee bill to be killed by the exercise of the irresponsible veto power, although in this instance the vote stood about three to one against the veto.

AN ACT

TO AMEND CHAPTER XXVIII. OF THE LAWS OF 1887, RELATING TO THE REGULATION OF CHINESE IMMIGRATION.

Be it Enacted by the King and the Legislature of the Hawaiian Kingdom.

SECTION 1. Section 2 of Chapter XXVIII. of the Laws of 1887, being an Act entitled "An Act to Regulate Chinese Immigration," is hereby amended so as to read as follows:

"SECTION 2. From and after the passage of this Act, no Chinese coming from parts beyond the Hawaiian Islands shall land, be landed or permitted to land in or upon the Hawaiian Islands, except such Chinese as shall, at the time of his arrival at any port of this Kingdom from abroad have a permit personal to himself to enter the Kingdom, granted, signed and sealed by the Minister of Foreign Affairs of the Hawaiian Kingdom under and subject to regulations to be prepared and published by him, by and with the consent of the Cabinet, excepting as hereinafter provided; and excepting all Chinese to whom or for whom such personal permit to enter the Kingdom has heretofore been granted, as shall be shown by the records of the office of the Minister of Foreign Affairs. Provided, however, that nothing herein shall be held to conflict with the provisions of an Act to limit the time within which permits for Chinese to enter the Kingdom may be used, approved July 4, 1888.

SECTION 2. Section 3 of said Chapter XXVIII. is hereby amended so as to read as follows:

"SECTION 3. If any master of a vessel shall bring any Chinese without such permit into any port of this Kingdom from abroad with intent to land such Chinese in this Kingdom, or if such master shall land or attempt to land any Chinese in this Kingdom, without such permit, or if such master or any other officer of such vessel shall permit such Chinese to escape from such vessel while within Hawaiian jurisdiction, such master (or other officer in fault in the premises in case of an escape) shall be liable on conviction to a penalty of Two Hundred Dollars for each Chinese so brought into any port of this Kingdom, or landed, or attempted to be landed, or who shall escape from such vessel within Hawaiian jurisdiction; and the master of such vessel shall be compelled to re-embark such Chinese as shall unlawfully land or escape or be landed from such vessel, and upon his neglect or refusal to do so, after notification by the Minister of Foreign Affairs, the Marshal, any Sheriff, the Collector-General of Customs or any officer of Customs, he may be forthwith arrested without warrant, and upon conviction of such neglect or refusal as aforesaid, he shall be liable to a penalty of Two Hundred Dollars in respect of each Chinese whom he shall have so refused or neglected to re-embark."

SECTION 3. There are hereby added to said Chapter XXVIII. four new sections, to be numbered Sections 3A, 3B, 3c, 3d respectively, to read as follows:

"SECTION 3A. Any Chinese, whether a passenger on or a member of the crew of any vessel arriving in Hawaiian waters from abroad, who shall land, or attempt to land, upon Hawaiian shores, except he be provided with a personal permit to enter the Kingdom, as provided in Section 2 of this Act, shall be liable, on conviction thereof, to a penalty of two hundred dollars. If any Chinese shall, with intent and purpose to gain access to this Kingdom, tender or present, or cause to be tendered or presented, to any officer of Customs or other officer of the Hawaiian Government, any ticket, permit, passport or other document other than a valid permit personal to himself for such Chinese to enter the Kingdom, the fact of such tender or presentation shall be deemed conclusive evidence of an attempt on the part of such Chinese to land in this Kingdom without a permit."

"SECTION 3B. No vessel which shall have brought any Chinese into any port of this Kingdom with intent on the part of the master or owners of such vessel to land them on these shores, such Chinese being unprovided with valid personal permits, as in this Act provided, shall be granted a clearance from any Custom House, or permitted to leave any port of this Kingdom while any of the Chinese so brought into such port by or upon such vessel shall be in the custody of any officer of this Government, not upon such vessel, or on bail awaiting any judicial proceedings as to the right of any of such Chinese to land in this Kingdom: Provided, that if the master, owners, or authorized agents, of such vessel shall execute and deliver to the Collector-General or any Collector of Customs a good and sufficient bond or bonds, with sufficient sureties, in a sum of not less

than three hundred dollars in respect of each such Chinese so in custody, or on bail, conditioned for the prompt deportation from this Kingdom of all such Chinese as shall be upon such proceedings, denied the right to land in this Kingdom, together with all costs and expenses incident to the custody of such Chinese while awaiting such deportation, such vessel shall be allowed to depart the Kingdom. All bonds in this Section provided for shall be deemed forfeited, and suit may be sustained thereon unless within thirty days from the rendition of final judgment denying the right of any Chinese in respect of whom such bond shall have been given to land in this Kingdom, such Chinese shall be deported from this Kingdom by the obligor in such bond."

"SECTION 3c. No court of this Kingdom shall release or permit to land, or go abroad in this Kingdom, upon habeas corpus or other proceedings any Chinese who shall have come from ports beyond the Hawaiian Islands, unless such Chinese shall show affirmatively that he possessed and presented a valid permit, personal to himself, to enter the Kingdom."

"SECTION 3d. Any vessel by or upon which any Chinese shall be brought into any port of this Kingdom without a permit personal to such Chinese to land in this Kingdom shall be liable for any penalty that shall be adjudged against any officer of such vessel in respect of the bringing of such Chinese to Hawaiian ports, or landing or attempting to land, or permitting to land such Chinese upon Hawaiian shores, or permitting such Chinese to escape from such vessel within the Hawaiian jurisdiction, or for refusal of such officer to re-embark or deport such Chinese, and such penalty may be enforced by the seizure and sale of such vessel, or any of her apparel or furniture after rendition of a decree to that effect in any court of competent jurisdiction. Whenever in the course of any prosecution or other suit under this Act any person shall allege in defense of such prosecution or suit the possession by himself or any other person or persons of a permit or permits to enter this Kingdom, it shall be incumbent upon the person so alleging such possession to prove the validity of such permit or permits to allow the person or persons so possessing the same to enter this Kingdom."

SECTION 4. Nothing in this Act contained shall be construed to repeal or amend Paragraph 2 of Section 5 of said Chapter XXVIII. of the Laws of 1887.

SECTION 5. This Act shall take effect from and after its approval, and all acts and parts of acts in contravention herewith are hereby repealed.

MURDER MOST FOUL

Kapahoe of Kau Brutally Murdered by Chinese—His Head Mangled With Stones—Arrest of the Suspected Principal and an Accomplice—Aseu the Principal Under Commitment for Trial Dies on the Steamer W. G. Hall Under Suspicion of Suicide.

The steamer W. G. Hall has brought intelligence of the most shocking developments in the case of the previously reported mysterious disappearance of Mr. Kapahoe in the District of Kau, Hawaii. Mr. A. P. Peterson, Deputy Attorney-General, gives the particulars related below, of one of the most brutal murders that ever stained the soil of Hawaii.

On Monday forenoon, 3d inst., while Kapahoe was on his way to Captain Eldart, Deputy Sheriff's, he was waylaid and brutally murdered. His body was found on Wednesday afternoon about a mile from where it proved he had been killed. It was jammed in a crack among the rocks, and covered with stones. The head was terribly mangled as if with stones held in the murderous hands, while the hands of the victim were fearfully lacerated with similar crude weapons. Part of the mutilation of the man's head was probably caused by contact with the rocks and stones in the operation of concealment. The body had been stripped of the trousers, and any cash that might have been in the pockets would have gone with that garment.

A Chinaman named Ah Hop, suspected of having a share in the crime, was arrested in Puna on the next Thursday, by an ex-policeman who detained him until an officer took him off his hands and lodged him in Hilo jail. The supposed principal, a Chinaman named Aseu, was arrested by a Kau policeman near Pahala, on Saturday of last week, and taken to the Waiohuhu lockup.

The morning after his arrest, Sunday, Aseu escaped from the officer having him in charge, and on being surrounded with no chance of escape he got down on the ground and tried to butt his brains out on the stones. He was stopped in this desperate purpose, however, and taken back to jail, where another attempt at self-destruction was foiled. The prisoner had ripped his blanket up and twisted it into a rope, one end of which he fastened to the window grating all ready for strangling himself. When this plan was defeated Aseu made a statement confessing his implication in the tragedy, but trying to fasten a portion of the guilt on a native preacher named Kumoku, a witness for Kapahoe in a lawsuit pending between the murdered man and Aseu. This part of the statement has received no credence from the authorities, but being made will be investigated thoroughly as a matter of justice to all concerned.

On Wednesday Aseu was arraigned before Judge McCully of the Supreme Court as committing magistrate, who upon examination committed the prisoner for trial at the November Term of the Third Circuit at Waimea. Aseu was kept in jail over night and on Thursday morning was taken, in custody of an officer, on board the steamer W. G. Hall at Honolulu, to be brought to Honolulu for safe keeping in Oahu Prison until his trial. Just before getting on board the steamer the prisoner began acting strangely and he died about an hour and a half after he was with him, did everything that could be done to save Aseu's life without avail. It was the impression of the doctor and everybody else who knew anything about the case that the man had taken poison and so killed himself.

The body of the suicide was taken to Kaawaloa, where Dr. Oliver removed the stomach. This organ was brought on to Honolulu, while the body was buried at Kaawaloa. The contents of the stomach will be analyzed by Mr. Geo. W. Smith for the verification or otherwise of the poisoning theory, and in case it is poison the man who gave it to Aseu will be pursued.

The motive attributed to Aseu for the terrible crime with which he was charged is found in an incidental reference above to a pending suit between him and the victim which was to have been heard at the late Waiohuhu Term. It is believed that he took such a diabolical means of being rid of an opposing litigant. Ah Hop, the suspected accomplice, would be examined for commitment to the Waimea Term this week. The first report regarding the disappearance of the victim represented him as a school teacher named D. Kapahoe, who had drawn his salary from the school agent at Waiohuhu the day he was last seen alive, and the supposition was that he was murdered for the pittance of money he carried. Mr. Peterson, however, had not heard of the murdered man as having been a school teacher, but was only informed in his investigations of the lawsuit above-mentioned as the probable motive for the crime. Mr. Atkinson, Inspector-General of Schools, on being applied to for light on the subject, states that a teacher on the list as "D. Kapahoe" had been in the service of the Board of Education for twenty-five years, and that the same man was also a policeman. The evidence appears to be against this being the man who has been so shockingly murdered.

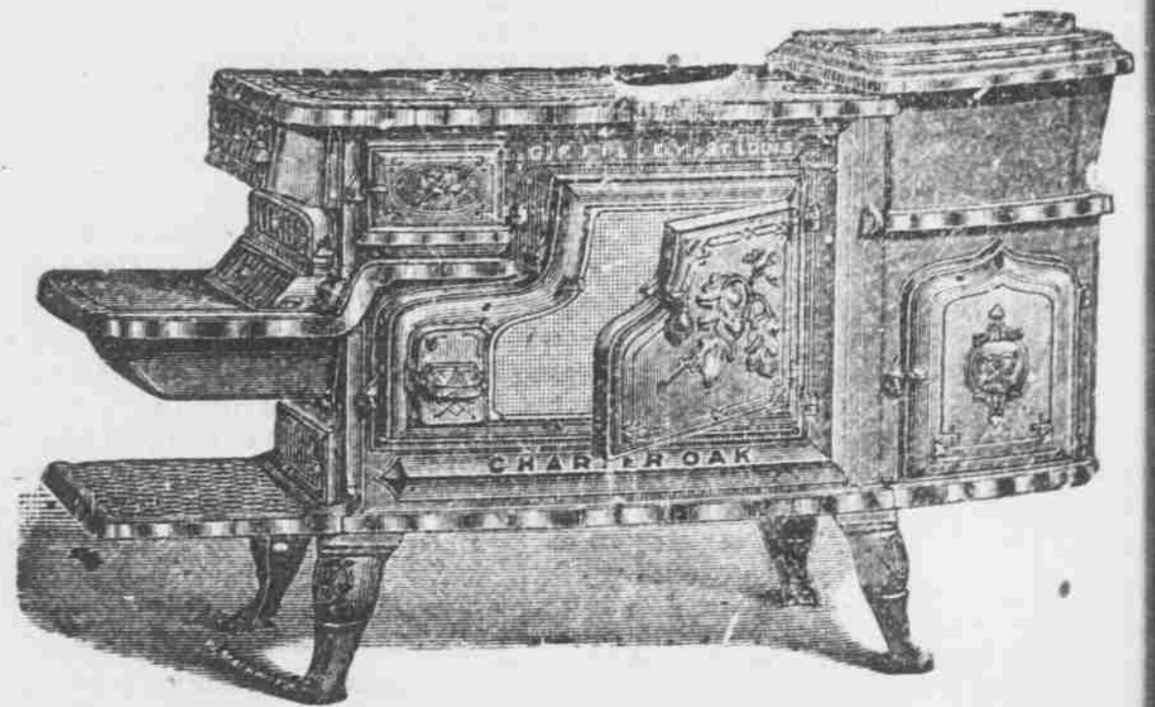
