Please extend to your staff, especially Jennie and Amy, who handled all arrangements flawlessly, our gratitude and appreciation for making the event the success that it was.

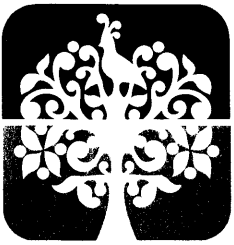
