COMMERCIAL.

WEDNESDAY, JUNE 2, 1899. The steamship Idaho sailed promptly on Friday, the 28th ult., with a full cargo of sugar and other produce, and 40 passengers, bound for San Francisco. The manifest value of her cargo is put down at \$51,963.64.

The British bark Briton, arrived on the 26th ult., 65 days from Melbourne, and brings some 550 tons of coal. The Am bark J W Seaver, from San Francisco for Petropaulof, arrived yesterday in distress, having experienced severe weather.

The schooner Flying Dart sailed on the 29th ult., with 36 tons salt, on a fishing voyage to the North. The schooner Nettie Merrill has been chartered for a voyage to Johnston's or Cornwallis Island and back. She sailed yesterday, and may be expected back here about the 1st of July next.

We notice the sale of 300,000 feet redwood lumber, and 320,000 shingles, ex brig North Star, from Humboldt, on private terms, presumed to be at lower rates than the cargo sold per Legal Tender. Business generally is dull, hence the auction sale at Messrs. F. A. Schaefer & Co., went heavily and low prices were obtained for nearly all kinds of dry goods.

California produce is in full supply, and prices rule low. A small lot of salmon recently imported sold at \$14 per barrel. The exports of sugar, from Jan 1st, to May 31st, have been as follows:

Estimating the sugar on hand in Honolulu at one million pounds, two-thirds of the present crop may be considered as having come to market. The next mail from San Francisco may be looked for by the D C Murray, in all of next week. The Am ship Franklin was to leave San Francisco about May 30th, and will probably touch here for freight and passengers, en route for Hongkong.

The sale at Messrs. Schaefer & Co.'s yesterday reached about \$100,000. The line of goods sold, embraced dress goods, clothing, staple dry goods, spirits, wine and beer. The attendance was good, but the bidding was not animated, and the prices realized were in accordance with the times.

THE HAWAIIAN EVANGELICAL ASSOCIATION.—This Association met at Kawaiahao Church, Monday, the 31st ult., at 10 a. m., and organized by the choice of Rev. M. Kamea, Moderator, and Rev. A. O. Forbes and W. P. Pillop, Scribes. The following gentlemen were present as members of the Association:

CORRESPONDENCE.

WASHINGTON, Dec. 18, 1898. Editor of the Hawaiian Gazette.—Dear Sir, I have just returned from a trip South, where I visited many points highly interesting in association with the late war. The ruins of Richmond are still extensive and sad-looking, though much re-building and improvement are going forward.

But I noticed people more than places. I cared not for mere localities and relics. Many battle grounds are but undistinguishable old fields; and bits of broken shell, and rusty implements of war, picked up on sacred spots, are but old iron to me. It was, perhaps, a little curious to observe long lines of blackened road, where industrious men had been busy burning tires, and twisting rails; but still my chief interest was to observe the marks of the war upon the people: so I went to church, during a Sunday I passed in Richmond.

I went to St. Paul's, and listened to Dr. Mininger, who had formerly been so attentively listened to by me. But I looked more to what I listened. I looked at a church full of ladies, about three-fourths of whom were in mourning. There might have been many recent mourners, but the most of them wore a hard, sad look, as though they had mourned long, and would mourn forevermore. It may, however, be economy that keeps up the continued suit of sable, and perhaps prosperity, by and by, may bring back gay colors and costumes to the churches of the South.

I attended a small country Presbyterian Church, called Mount Zion, near Pendleton, S. C., and of the forty-six persons who commenced on that day, five only were men, and twenty-eight of the women were in deep mourning. How the South mourns! The land mourns. The mothers lament for their children, and will not be comforted. Many a mother has said to me: "I would not have given my son's little finger for all the slaves of America; but he was blown up at Petersburg," or "he lies in the trenches of the Wilderness, and his precious life was lost in vain." The South is in deep mourning. The blackness of desolation covers the land; and what is worse than grief for the dead, the black man—the slave—is lord in the Southern halls. I saw the black Legislature in Columbia. It is very black, with little mitigation of lighter shades: 46 blacks to 16 whites.

THE SOUTH, however, ought to cheer and look up with the beautiful crops of cotton and corn that are now being gathered. I observed along the line of road in South Carolina, the fields white with cotton fluff, now unfolding rapidly on account of the frost. The ladies and gentlemen are picking the cotton, and show a determination to hold on to their home-steads. The cotton will give them the cash to meet all their demands. Another good crop will fill the land with prosperity. Already Southern lands begin to advance in price, and in a short while, there will be a real estate speculative mania in the Southern States.

The ruins of Columbia are great and desolate. The beautiful City of Gardens, that was the pride of the South, is partly a wild for the haunt of the squirrels and quails. Wild animals have increased through all the Southern country. I saw bears in Columbia, caught within five miles of the town, and I was told that hundreds of bears could now be caught in the swamps of the Watercress; whereas to have heard of one there eight years ago, would have awakened great curiosity and interest. The hunters never came home from the plains of Virginia and the battle-fields of the West; and so the bear and deer, the mink, opossum, racoon and squirrel have had long peace, and have extended their lines, and hold high carnival in the Southern backwoods.

The gloom that I have spoken of is more apparent about the large towns, and the low country, than in the interior. The small farmers of the up country are doing as well, or better than before the war. Every man, with every son and daughter helping in the field, is making a better crop, and at less cost. The depots are crowded with 500-B. bales, worth \$190 a-piece. I know a handsome young lady, who, with her own pretty hands, has picked out a bale. She does not weep much over the lost cause. She is bound for a new departure. She has bought her owninery for her wedding with the sweat of a very fair brow, and is going in for raising warriors for some future fight.

I marched along the track of Sherman. It is not hard to find, and you would not lose your way if you wished to take a tramp down to the sea. I heard at one house an amusing story: A party of Sherman's boys in blue entered, and addressing a feeble, simple-minded lady, said, "Where is that watch?" expecting her to bring forth her husband's

LATE FOREIGN NEWS.

Foreign Miscellany. NEW YORK, April 24.—Letters received to-day from Paris, concerning the Cuban question, state that the Spanish Government emphatically deny reports of Spanish successes over the Patriots. The latter are preparing for a more systematic campaign. Things remain quiet in Madrid, pending the arrival of a dispatch of war. One letter announces that a case of rifles and three heavy guns have been safely landed.

HAVANA, April 25.—Advice from Nassau, of the 17th, report active military preparations in progress. The forts are being strengthened and garrisons reinforced, in anticipation of possible complications arising out of the recent Spanish outrages upon British vessels. A demand has been received from Duties for the surrender of the captors of the Comandante, and other alleged enemies of Spain. The demand was refused by the British Governor of New Providence, and referred to London for settlement.

NEW YORK, May 8.—The Spanish Consul had an interview with Marshal Barlow this afternoon, and stated that he had received positive assurances that he will receive each Wednesday proposals to sell to the Government one million of the new issue, in sums not less than \$5,000. LATE INTELLIGENCE.

European News.

MADRID, April 23.—The result of the conference of the ministers comprising the majority of the Cortes that it has left the members more widely divided than before. Serrano has declared that the choice of Montseny for King, or the declaration of a Republic, is the only possible alternative. The Prime has remained silent throughout the proceedings. His conduct has given rise to a wide-spread belief that he would not be unwilling to accept the Presidency of the Spanish Republic. The Herald's London special says the London papers comment very freely on the present state of affairs in Cuba. The Telegraph, a Ministerial organ, of a moderate tone, says that in regard to the independence of Cuba, England is not unopposed, but, at the same time, admits that England's interest can be best subserved by Spain retaining her authority over the Island. The article does not say, however, that any case it shall be the business of England to interfere to prevent Cuban independence, but it maintains that the good opinion of England might prove useful to a quarrel between Spain and America. It is not, however, a Ministerial organ. Mary Lowell as a mad mad implicating England—Spain's best friend unless the latter country offers reparations for the insult. The article then goes on to argue that Cuba and can never willingly attach themselves to the United States.

The London Owl of this evening, speaking of the matter, says that President Grant seems to have gone mad on the subject of Cuba. It thinks England and France would declare war if America attempted to wrest the Island from Spain. The Owl says President Grant longs for a foreign war, knowing, as he does, that the feeling of the United States against America applies in a less degree of France.

New York, May 6.—A letter from Constantinople, says, Col. Eugene O'Reilly, an Englishman, living in Turkey, was arrested in Syria, charged with importing arms and ammunition, under the pretence of a railroad survey, for getting up an insurrection in favor of Egypt, so as to create for the former, a new vice-royalty, west of Palestine, along the Euphrates. The scheme had the approval of the English and French Governments.

LANSBY, May 9.—At the Cortes, yesterday, Prim pronounced an angry harangue, the purpose of which he meditated an attempt against the Liberal regime. He declared that the future would prove his report, and that Gen. Cabrero, the noted Carlist leader, had appeared at Catalonia. The condition of the national finances caused much anxiety; it is estimated that the expenditures will exceed the revenue by twelve millions of pesetas.

New York, April 23.—Herald's special from London says the Post has an article on the Cuban question, and gives currency to the assertion that Grant desires the acquisition of Cuba in order to divert the attention of the American people from internal distractions. It says there would be no doubt as to the issue of the conflict, and thinks the acquisition of Cuba will result in the determination of whether the designs against Cuba will be tolerated, or aid Spain in reclaiming her colony.

The French press has agitated the question much in the same manner. A special meeting of the French Cabinet was held on Wednesday, which resulted in a Special Envoy being sent yesterday, to London, with despatches referring to the present complication of events.

American News.

CHICAGO, April 23.—The Senate, in the executive session, had a lively spat over the nomination of Mr. Sumner to the office of Secretary of the Interior. Mr. Sumner, for Commissioner to select, International claims with Mexico, but finally confirmed it. It was charged that he was a Democrat, and voted in Congress against the measure.

The President has withdrawn the nominations of L. M. Burson, for Chief Justice of Montana; H. Richardson, for District Attorney of Montana; and J. Miller, for Minister to the Sandwich Islands.

The nominations of Mr. Jones, for Belgium, and Mr. Sanford for Spain, were laid on the table, and the President's denouncing these appointments as eminently objectionable, declaring that the Senate must do something for the respectability of the diplomatic service, as strongly as the President.

Mr. Jones, on the ground, he made to compare himself with the President, but it was replied that too many have already been confirmed on that ground.

The Tribune's special says that in the executive session, Messrs. Trayer, Pomroy, and Harlan attempted to defeat the President's Indian policy. They secured a report of the Committee against the proposed treaty, and several Quaker agents. These Senators, with a few others, were promptly on hand at the close of the recess, with the purpose of making a speech through which many were absent; but the design was partly defeated by the return of the absent friends.

The nomination of Richards as Agent for the Delaware, was tabled, other were rejected, and some were reported again.

Wm. A. Davis, Receiver of Public Money at Stockton; Jas. V. Schofield, Consul at Hakodadi; and J. W. Kelly, United States Attorney for California.

WASHINGTON, April 23.—It has been ascertained from an authentic source that only six vessels will be employed on public service in the Cuban waters, the number necessarily limited by the act that Congress made great reductions in the personnel of the navy; but this number is sufficient for all legitimate purposes, no trouble being anticipated in the iron-clads has no other significance than the desire of the Navy Department to save them from decay, which vessels out of commissions are exposed.

CARAGO, April 24.—A Republican special says Minister Hays's resignation having been accepted and Senator Sumner's appointment, the Spanish mission is now vacant. Gen. Sickles will be speedily appointed to fill the vacancy, in accordance with the amended civil service law. A claimant has been selected in the Brazil mission, but nobody yet selected. It is certain that Pills will not be reappointed. Minister Sanford will remain at Brasilia, until he is relieved, as thought likely. Bartlett remains as Minister to Sweden, though a change will probably be made this summer.

A correspondent who has interviewed Senator Sumner on the Alabama claims and the opinions of the British press, says Sumner thinks the assertions of the British press should be accepted with much caution, for the reason that England never likes to be told the truth, particularly when she is in the wrong. He did not express any surprise at the irritation or even alarm which now exists in that country, since the British people have seen the unanimity with which the Senate supported his views and rejected the Johnson-Stanley treaty, which state of facts they will soon have added, despite the shifts of the London Times, the disclaimer of the President. Sumner thinks the difficulty will not lead to war, as he is fully convinced England will pay the amount of our bill in preference to fighting. Hoping for a sensible arrangement, the Senator declares there shall be no yielding on the part of the American people after Mexico has made known their wishes to the English Cabinet.

New York, May 3.—The Herald's Cuba special says the Revolutionists held a Congress, April 13th, at Liberman. Over 300 representatives were present from all parts of the island. Copious resolutions were adopted, declaring that the Revolutionist party is fighting for independence from Spain and annexation to the United States. Gen. Quesada was again elected Generalissimo. The delegates were enthusiastic, sanguine, and determined.

The Express says Marshal Barlow has received reliable information that a steamer left this port last night for Cuba, with 500 men, each provided with a rifle and cartridges. The vessel also took a large quantity of light clothing, and provisions to last a month or six weeks; the Express adds that another expedition is preparing, and the Marshall is investigating the matter.

It is reported that the Spanish have captured several members of the Revolutionary Commission.

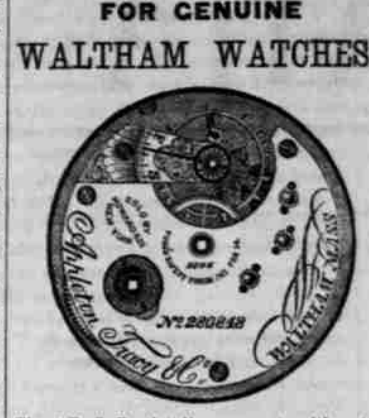
