HAWAIIAN COFFEE.

The San Francisco Grocer of a recent date calls attention to the increasing demand for "Kona coffee," and urges planters here to pay more attention to planting and growing coffee. It may not be aware that formerly the growing of coffee was much more extensively engaged in than now, and that the cultivation of it was abandoned owing to a blight which some thirty years ago devastated the plantations, and nearly put an end to all coffee culture. During the past few years the blight appears to have in a measure disappeared, and a little more coffee has been gathered of late from the few trees scattered through the valleys of Hawaii. Several parties have been endeavoring to secure land suitable for coffee growing, and we trust will be successful, as on their success depends in a great measure the future expansion of this business. There is no doubt but that all the coffee that can be grown here will find a market abroad. There are parties in New York, Boston and other cities of the Eastern United States who annually procure their supplies of "Kona coffee" here, and have it shipped to them, considering it far superior to the best Java or Mocha. Its flavor or aroma is very superior, and no one who has ever drunk coffee made by some of our expert housewives will ever forget its unrivalled deliciousness, which no other coffee possesses in the same degree. But to the remarks of the San Francisco Grocer:

KONA COFFEE.—This article of consumption is a comparatively unknown product in this market; a small amount has been imported from the Hawaiian Islands, where it is grown, but so slight have been receipts up to the present time that it has little figure among the trade. A few facts concerning the coffee may not be amiss, however, as there seems little doubt that planters in the Islands will in the course of a very few years devote much more attention to coffee culture than heretofore. An appropriation of \$10,000 was made by the Legislature of Hawaii to be devoted to the encouragement of coffee raising, and the import duty on foreign coffees was raised to six cents per pound, an increase of three cents.

Although coffee is grown in several of the islands comprising the Hawaiian group, the Kona district on the island of Hawaii has been found the best producing section, on account of most favorable climatic conditions, and it is from this section that the coffee imported into this city from the Islands has come. The bean somewhat resembles the Costa Rica coffee, but the aroma, odor and flavor are entirely different from either that description or any other ever on this market. The writer is informed that in the Islands this coffee is used almost entirely, and strangers, tourists and other visitors who taste it consider that it makes a most delicious beverage.

A number of leading retail grocery houses of this city are handling the coffee with the best of results, and are always ready to take all that can be secured. The misfortune is that but five or six hundred bags have been imported this year, and the major portion of that has gone into consumption.

There can be little doubt that the quality of this coffee will create a stir among consumers as soon as it becomes better known, and that a new industry of profit to the Hawaiian Island planters will develop which will, if properly cultivated, put even the raising of sugar in the shade.

HILO AS A FRUIT PRODUCING DISTRICT.

(From the Hilo Record.)

These islands lying so near to the north Pacific Coast of the great American continent will in time be the place from whence tropical fruits can be most easily and profitably exported for the consumption of those living in the western states and the English possessions. The cultivation of fruit for export has been almost entirely neglected until very lately; bananas have been largely raised on the island of Oahu for export. This has only been on account of the facility of transportation given by the regular steamer communication with the coast from the port of Honolulu. But there has been no opportunity given for getting fruits to a market from any other portion of our group. The time is not far distant when such a demand on the Coast for our fruits will exist that some means for transportation will be provided; and are we doing anything to fill such a demand?

All tropical fruits will be in demand; bananas, grapes, watermelons, figs, oranges, limes, custard apples, coconuts and a great number of other tropical fruits will be wanted, and Hawaii is able to furnish them in any quantity. The districts of Hilo and Puna are some of the finest lands for growing bananas, coconuts, watermelons, oranges and alligator pears. Kona could furnish all the oranges, pineapples and custard apples; Hanakua grows fine oranges and bananas; Kau and Kohala the same; but all these fruits, except the water melon, are fruits that require years from the planting of the seed to their coming into full bearing.

The Chinese bananas require eighteen or to twenty-four months to bear. Our Hawaiian from twelve to eighteen months. The former hold the Coast market now, and it will take time to learn the banana consumer there, that our Hawaiian bananas are a far superior fruit. In this district of Hilo, we have a wide range of land, suitable to banana culture and which is unavailable for cane. Ten thousand bunches could be shipped from here monthly if the business was gone into. Then we have as fine alligator pears raised here as are to be found in any part of the world and it is fruit well adapted to our soil and climate. The American people are just beginning to find out their value. From 1,000 to 2,000 fruit have been picked off a single tree in Hilo.

Again we could raise right here in this district any quantity of the water melons of different varieties, a fruit which in one variety or the other lasts the year a round and a most delicious fruit it is too, and one that would have a ready sale at the Coast if once introduced. It is easily grown and is a great bearer. The large yellow variety commences ripening from December and keeps on till June or July, when the purple variety sets in. A new variety just imported by Mrs. D. H. Hitchcock seems to be a perpetual bearer, but as none have yet ripened we cannot say as to their value.

Then our grape season commences from December and runs well into the summer, a period when the Coast market is destitute of grapes. And how many thousands of acres in Puna and Kona there are lying idle on which the finest grapes can be grown.

The fine variety of the white sugar loaf pineapple does remarkably well in Hilo, a variety which would bring from \$3 to \$6 a dozen at the Coast, while Puna and Kona could furnish all the native pineapples that would be wanted in the market. But it takes two years for a pineapple farm to come into bearing. The custard apple now grows wild in some parts of Kona and is a fruit which will be easily marketed, and one too of which not enough could be raised to satisfy the market after once being introduced. This fruit takes from three to five years to come into full bearing. And so we might go on enumerating a vast variety of other fruits growing on these islands. But it seems to us that we should be taking hold of the matter in earnest and begin the planting of fruits which take so long to mature. We should not let the matter pass out of mind and awake some day when a steamer calls at our door and wants the fruit and we have none to send away.

We would like to see a fruit company started in Hilo and work forthwith commenced in raising these fruits. By the time the company had any quantity to market, there will be a way to get them there. Hilo, be up and doing.

The choir of the second congregation sang the funeral psalm and also the hymns "Days and moments quickly flying" and "Now the laborer's task is o'er." The lid of the coffin was covered with many beautiful floral offerings. The pall bearers were Hons. Cecil Brown and W. D. Alexander, Messrs. Jona. Austin, John H. Soper, E. D. Tenney, Alex. It has been this influence powerfully exerted on the Chicago club that has enabled its captain with new men to make a gallant sport from near the tail end at the beginning of the season to second and third places at the close. At the Third Circuit Court term held at Waiohuni, Fuguda, a Jap, was sentenced to pay a fine of \$20 and be imprisoned at hard labor for eighteen months for breaking into the Naalehu plantation store.

A sailor on board the steamer Kilanea Hon received yesterday a somewhat severe cut on the forehead from a fallen block. It did not, however, hurt him much, as he continued to work soon after he recovered from the shock.

This evening at the Y. M. C. A. Hall, at 7:30 o'clock, Prof. Brigham will deliver another lecture on "Physical Culture" to young men. The well-known ability of the lecturer is certain to attract a large audience. Members of the Athletic Association and baseball clubs are specially invited to attend.

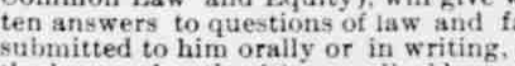

BY AUTHORITY.



AN ACT

TO AUTHORIZE THE INTRODUCTION OF CHINESE AGRICULTURAL LABORERS AND TO AMEND CHAPTER XXVIII. OF THE LAWS OF 1887, ENTITLED "AN ACT TO REGULATE CHINESE IMMIGRATION."

Be it Enacted by the King and the Legislature of the Hawaiian Kingdom:

SECTION 1. That Paragraph 2 of Section 5 of an Act entitled "An Act to Regulate Chinese immigration," approved on the 20th day of December, 1887, being Chapter XXVIII. of the Laws of 1887, be and the same is hereby amended to read as follows:

"2. The Minister of Foreign Affairs, upon the written approval of the Board of Immigration as certified by its Secretary, shall issue, from time to time, special permits for persons of Chinese birth to enter and reside within this Kingdom upon the terms and conditions hereinafter prescribed. Such permits shall issue to persons or corporations engaged in agriculture in this Kingdom for as many Chinese laborers as he or they may, on oath, declare to be necessary for carrying on such several enterprises. Each of such special permits shall be issued in triplicate, one to be held by the Chinese presenting the same, the other two to be disposed of as provided by Section 3 of this Act. Such permits shall be signed by a clerk of the Foreign Office, and numbered consecutively which number shall be preserved in a record of the Foreign Office. Each of such permits shall contain the following conditions:

"First: That the bearer who presents it for entry into the Kingdom shall remain therein for a term not exceeding five years.

"Second: That such bearer shall not engage in any other occupation than that of agricultural labor provided that the term agricultural labor shall be held to include labor in Sugar Mills, Rice Mills and Coffee Mills and all labor incident thereto.

"Third: That if such person shall be found out of employment at any time during such term or engaged in any other employment than that of agricultural laborer or shall be found in this Kingdom after the expiration of such term, he may thereupon be arrested and held in custody until an opportunity occurs to return him to China.

"Fourth: That one-fourth of the money due to such person as compensation for work done shall be retained by the employer each month and forwarded by him to the Board of Immigration, to be by it deposited in the Treasury of the Kingdom as a special deposit, subject to the order of the President of the Board of Immigration, and to be returned by the said Board to such person upon his leaving the Kingdom. Provided, however, that such retention and deposit shall cease, whenever the sum to the credit of any one laborer shall amount to the sum of seventy-five dollars. The said Board shall have the authority to pay the return passage of such person out of such sums so deposited. If such person shall enter into any other employment than that of agricultural labor or shall desert his employer, such money so deposited may be forfeited to the Hawaiian Government.

"Fifth: That the said bearer shall not be entitled to exercise the rights of a Hawaiian citizen as to the term of residence or employment while in the Hawaiian Kingdom, but shall be restricted to the term and employment named in such permit."

SECTION 2. Before issuing the special residence permits as hereinbefore provided, the Minister of Foreign Affairs shall require of the persons or parties applying for the same to execute and deliver a bond to him for the use and benefit of the Hawaiian Government, in the penal sum of seventy-five dollars for each man to be landed under such special residence permits. The said Minister may in his discretion require one or more sureties to said Bond. Said bond shall be conditioned, that the applicant will furnish the man named in such special residence permit with agricultural labor so long as he remains in the Kingdom; that he will at the expiration of the term of service named in the special residence permit surrender the person therein named (except in case of death) to the Board of Immigration or its Agent; that he will forward and pay to the Board of Immigration each month, one-fourth of the money due for compensation for work and services done, until the sum so forwarded shall reach the sum of seventy-five dollars; that in case of desertion he will immediately notify the Inspector of Immigrants of the desertion of the person or persons so deserting, and that he will not be privy to nor assist the person named in such special residence permit from entering into or becoming engaged in any other trade, business or calling than that of agricultural labor as defined by this Act. In case of forfeiture of the Bond, and of the payment of the penalty by the obligor therein named, the amount on

deposit against the laborer named in the Bond, shall be paid over to such obligor.

SECTION 3. Special residence permits shall be issued in blank and the name of the laborer may be inserted at the time of presentation to the Customs officer for entry into the Kingdom or at any time previous thereto and a note of such presentation shall be endorsed on the permits. The duplicates and triplicates of such permits shall be filed in the office of the Board of Immigration and with the Collector of Customs.

SECTION 4. The presentation of such a permit by any person for admission into this Kingdom, shall be held to be a consent by such person to all of its terms, and shall prevent him or any person on his behalf from denying the validity of the same in any manner whatsoever in any Court of Justice.

SECTION 5. Any laborer deserting or leaving or refusing to do the work of his employer shall besides the provisions of sub-division 3 of Section 1 be also subject to the penalties prescribed by law for desertion or refusal to work.

SECTION 6. If at any time a laborer coming under the provisions of this Act desert his employer, such employer shall immediately notify the Inspector of Immigrants of such desertion by mailing a registered letter to him. The Inspector of Immigrants shall thereupon cause a notice of such desertion to be sent to the Sheriff or Deputy Sheriff of every district of the Kingdom. Such Sheriff or Deputy Sheriff shall thereupon post, or cause to be posted, a notice that such Chinese, giving name and description, has deserted from his employer, with amount of reward (if any) offered for his delivery into custody. In the city of Honolulu at least twenty of such notices shall be posted in conspicuous places.

SECTION 7. All expenses paid out or incurred by the desertion and consequent arrest of any laborer shall be paid by such laborer from and out of his wages, and the employer shall be authorized to deduct such expenses if paid by him from his wages.

SECTION 8. Any employer who shall fail to notify the Inspector of Immigrants of the desertion of any one of his laborers, shall be guilty of a misdemeanor and upon conviction thereof shall be fined not less than twenty-five nor more than one hundred dollars.

SECTION 9. Whoever shall, furnish, or give employment, or board, or lodging, or shall hide a runaway laborer one week after notice given as provided in Section 6 of this Act shall be guilty of a misdemeanor, and upon conviction thereof shall be fined not less than twenty-five nor more than one hundred dollars for each offence.

SECTION 10. The Minister of Foreign Affairs shall charge for each special residence permit issued by him under the provisions of this Act, the sum of one dollar, the money realized therefrom to be deposited in the treasury for the use and benefit of the Hawaiian Government.

SECTION 11. Upon the expiration of the term of said residence permit the Minister may, upon due cause shown to him by the person named in such permit, extend the term of such special residence a further term not exceeding five years.

SECTION 12. Upon the arrival of such laborers a registry and description of them shall be prepared in such manner as the Board of Immigration may deem necessary to ensure identification. And the said Board of Immigration is hereby authorized to make any and all such rules and regulations in the premises and as to identification and the same to alter and amend as they may deem necessary for the proper carrying out of the provisions and intentions of this Act. Any such regulations made, altered or amended shall have the effect and force of law after due notice thereof printed and published in a newspaper in Honolulu.

SECTION 13. Any person admitted to the Hawaiian Kingdom under the provisions of this Act, who shall be found in the Kingdom after the expiration of the term allowed by his permit, or who shall transfer such permit to any other person prior to its expiration, or who shall do any other matter or thing contrary to the provisions of this Act, or to the conditions of his special residence permit, or who shall violate any of the rules and regulations issued by the Board of Immigration, according to the provisions of this Act, shall be guilty of a misdemeanor, and upon conviction thereof before any Police or District Magistrate, shall be fined not over two hundred dollars or imprisoned at hard labor not over two months, and after the satisfaction of such sentence shall be held in custody, at his own expense, till an opportunity arises to send him to China, whereupon he shall be thither deported.

SECTION 14. This Act shall take effect and become a law from and after the day of its approval. Provided, however, that should the Hawaiian Government at any time after the approval of this Act enter into a Labor Convention with the Empire of China, that then and in such case the Cabinet may in their discretion, after due notice given by publication in two newspapers printed and published in Honolulu, suspend the provisions and operations of this Act.

Approved this 14th day of November, A. D. 1890.

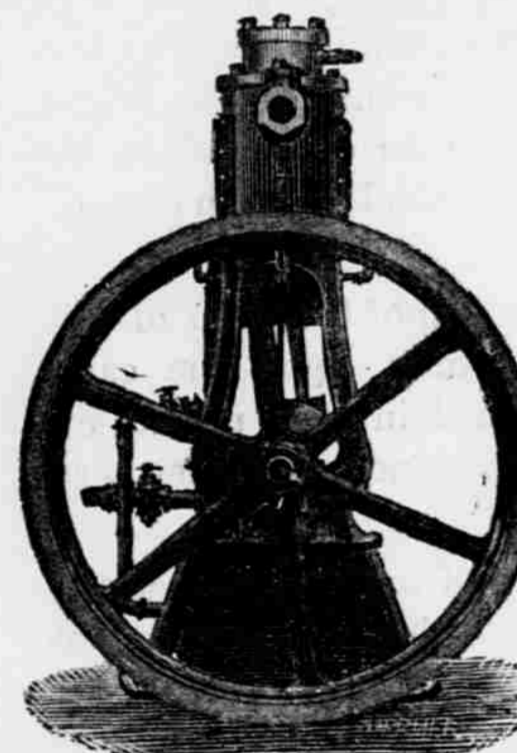
