PILOT LORENZEN

LIBEL

STEAMER CLAVERING

John C. Lorenzen brings libel in admiralty against the British steamship Clavering for salvage in floating the vessel off the reef upon which she struck while endeavoring to make this port recently, claiming that it was through his skill, in connection with the efforts of the various tugs which assisted, that the Clavering was safely relieved from her dangerous position.

Libellant is a pilot of this port. When he heard there was a vessel off port he went out to offer his services. He found the Clavering aground near the spar-buoy. The master of the vessel asked libellant to inform the ship's agents of her condition.

This he did, also informing the tug Counselman, afterwards returning to the grounded vessel where, at the master's request, he boarded her. She was in great peril. He remained aboard and directed all efforts to float her, his own efforts and the efforts of the tugs Counselman, Fearless and the U. S. S. Iroquois proving successful at 3:30 p. m. of the 20th instant.

Libellant asks \$5000 salvage. J. D. Spreckels & Bros. Co. filed libel against the vessel on the 24th instant, as owner of the Fearless and charterer of the Counselman.

The London agents of the steamship Clavering have been communicated with by cable in reference to bonds for the vessel.

WORKERS OUTLINE

PLAN OF ACTION

Following are the resolutions presented to the Republican Committee by Fifth District workers:

Honolulu, Hawaii, July 27th, 1903. To the Republican Territorial Central Committee of the Territory of Hawaii.

Gentlemen:—We, the undersigned Republican voters and workers of the Fifth Representative District, respectfully request your honorable body to consider and pass at your next ensuing meeting the following resolutions, or resolutions similar thereto, or take some other method to carry out their object, namely:

Resolved: First. That the chairman and secretary of this committee be and they are hereby directed to immediately issue a call, requiring each precinct club throughout the Territory to meet on the fourth Friday of August, being the 28th day of August, 1903, at its last place of meeting, at 7:30 o'clock, p. m., or at such time and place as the president of the club may name in a public notice, to be printed in one of more newspapers, or posted in a public place, one week in advance of such meeting, for the purpose of making nominations for the members of the county committee, which committee is hereinafter provided for, to be voted for at the primary, which is hereinafter called, and for the purpose of considering and acting upon any matter of interest to the voters within the county.

Resolved: Second. That said chairman and secretary be and they are hereby directed to immediately issue a call requiring each precinct club to hold a primary election on the first Saturday in September, being the fourth day of September, 1903, from 2 o'clock, p. m., to 8 o'clock, p. m., to elect members of said county committee, such primary to be held under the general rules and regulations of the party; and that said call state the number of delegates to the said county committee to which each precinct is entitled, and fix the time for the meeting of the county committee to nominate county officers.

Resolved: Third. That there be elected a county committee in each county, which shall consist of delegates from the precincts of such county upon the basis of one delegate for every twenty-five voters or fraction of twenty-five votes cast in the precinct for the Republican candidate for representatives receiving the highest number of votes in his precinct at the last preceding general election; Provided that whenever after dividing said Republican vote by 25, there is a remainder of 15 or more, then the precinct is entitled to an additional delegate; but each precinct shall be entitled to at least one delegate to said county committee, although the Republican vote as aforesaid in said precinct shall be below 25.

Resolved: Fourth. That the county committee shall serve until the election of a new county committee. It shall be charged with the general care and supervision of the party during the county campaign, and shall take such measures as it may deem expedient to secure the co-operation of Republican voters with party workers; it shall decide all disputes in said county, subject to appeal to the Territorial Central Committee; and if any precinct club fail to

Array of Prominent Men Testify To Davis' Character As Witnesses In Sumner Case

Hearing in the disbarment proceedings against George A. Davis will conclude this afternoon. At 2 o'clock, in the Supreme Court, argument will be begun, the Attorney General opening and respondent following with an argument which he promises will not take over an hour.

At the close of this morning's session, Mr. Davis remarked: "Whatever time Your Honors think proper for my argument will satisfy me. It will not take me long to argue my case. I don't think the Attorney General has made out a case against me and I don't think Your Honors believe that he has a case. If the Attorney General is to open, I would like the Court to excuse me until, say, 2:30 o'clock; I have my Police Court duties to attend to and would like to be excused while Andrews is making his argument. I don't want to hear him anyhow."

"You will be required to be present during the Attorney General's argument," said the Chief Justice. "Court will take a recess until 2 o'clock, if that will help you any."

"It will help me; I thank Your Honors."

At the opening of the morning's proceedings, Davis went back on the stand to make certain statements in answer to questions from the bench:

Earned His Fee. "I first heard of Magoon's fee of \$4,000 when somebody told me it was in the newspaper. I think I have earned my fee. I insisted at the time Sumner gave me a check for \$2,000 that I be paid in the presence of Judge De Bolt."

"I fully argued this case of Roper against Sumner both before Judge De Bolt and the Supreme Court. I was called before the Supreme Court, which wanted to hear further argument. I then presented an oral argument in the matter."

"Under all circumstances I thought \$10,000 was a fair value for the reef property. I learned that the Oahu railroad had for years been paying Sumner what I considered an exorbitant rental. When Magoon spoke of the property going for what he thought was much below its value, I considered the sum he thought correct far too much."

Maria Davis' Interest. Referring to his connection with the Maria Davis affair, Mr. Davis said: "I was protecting the interests of Maria S. Davis, for, if the money had been divided among the Ellises and the church, as was originally planned, Mrs. Maria S. Davis would not have received a cent. I was also bringing these suits to protect the interests of John K. Sumner."

F. M. Hatch Witness. Respondent called F. M. Hatch to the stand. In answer to questions, witness stated:

"I prepared the deed between the railroad and Sumner. I left the deed with you to be signed. The amount agreed on was \$110,000. You delivered me back the deed properly acknowledged. The deed will show who signed it. I went with you, Highton and Thompson to see the Bishop."

"Did the Bishop sign?" Andrews objected. The deed would speak for itself.

Davis sent to the Registrar's office for the book containing the record of the deed. The book was offered in evidence.

Davis wanted Hatch to refresh his memory, by reference to the record, as to who signed the deed.

"Was anything said about who should sign the deed?"

"It was required that all the apparent heirs should sign. I took the checks to the Bishop for the payment of the money. There was nothing secret about the affair. One check was

payable to the Bishop. The money was delivered to the Bishop. I did not distribute it."

"Did you ever know me to be guilty of a dishonorable act?" Andrews objected to the question. Davis said he had a right to show what his reputation had been. Andrews argued the point. Davis withdrew the question and put it in another way. Andrews again objected. By other questions Davis elicited from witness the following:

Reputation is Good. "Your reputation is good, Mr. Davis, so far as I know."

Cross-examination by Mr. Andrews: "Have you ever heard Mr. Davis' reputation discussed?"

"I don't know as I have; I never heard it attacked."

Andrews moved that the testimony be taken in relation to character be stricken out.

Majority of the Court allowed the testimony to remain.

E. P. Dole Testifies. Edmund P. Dole was called, testifying as follows: "I think your reputation for fair dealing and honesty in this community is very good. My conclusion is based on the following. I have known Mr. Davis well for eight years. His peculiarities have caused him to be widely discussed. While his peculiarities have been censured in these discussions, I have never heard an opinion expressed that he was not an honest and upright lawyer."

"His traits are such that he attracts the attention of the whole community and if he had a reputation for dishonesty I would certainly know it."

Cable Workmen at Fanning Island Narrowly Escaped Ocean Grave

James Greig is today the hero of Fanning Island and it is no wonder that the people of the cable station there stand ready and willing at any moment to stand by him in any emergency should he but hold up his finger to command. Just an inkling of the story that has endeared the young man in the hearts of the cable men and, in fact, the whole population of the island, has come to Honolulu, but never has a word been breathed by George and James Greig, who have been in the city for over a week, waiting for the steamer that will carry them on to Fiji. A Bulletin reporter has repeatedly asked the young men for the story, but not until today was there any success. They invariably showed a hesitancy about speaking of themselves. Today, James Greig was kind enough to give The Bulletin the story of how he saved the cable station men and a number of natives from the fury of the storm, and these are the details in his own words:

"Our home on Fanning Island is about five miles away from the cable station and we were gathered there one Saturday afternoon—I think it was the 4th inst. Mr. Cutbert, superintendent of the station, was visiting us and we were all in the house."

"Naturally, we were in a great state of mind and discussed plans to save the men who were every moment being swept farther away from shore. Finally my brother George turned to me and asked if I would go out with a crew of natives. I acquiesced. In a few minutes, we had our long boat launched and stocked with several days' provisions, for we could not tell how long we might have to be out. We took a compass and everything that was necessary and, bidding farewell, our little party of six, all natives, were soon booming along to the cable station, five miles away. We had succeeded in making ready in less than a half-hour's time."

ATTORNEY DAVIS' SWORN TESTIMONY ON HIS RELATIONS WITH SUMNER

Seldom have the corridors of the Judiciary building echoed more earnest words than were borne in the witness box in the Supreme Court yesterday afternoon and rang from the crowded hall, finding no inattentive ear, holding all who heard, friend or foe, by their very force and eloquence.

Attorney George A. Davis, charged with infidelity to his client, deceit, professional improprieties and fraud, during the afternoon proceedings in the disbarment case against him, took the stand in his own defence and told his story in a manner fearless and unsparring, at times restraining an emotion that threatened to burst its bounds, occasionally reducing the power of his speech to a calmness that conveyed words not less strong, perhaps the sharper for their mild delivery.

Once the court found occasion to suggest mildness on the part of witness and Mr. Davis said that he "would endeavor to be more mild."

Side remarks were occasionally indulged in between Attorney General Andrews and Respondent Davis, but Davis, in this, expressed more by emphasis than sentences and Andrews maintained his good nature throughout.

On numerous occasions Supreme Court Bailiff Sea had to smartly rap for order, as a sprinkling of sensation seekers and court room loungers insisted upon giving tongue in mixed giggles and guffaws every time a particularly earnest assertion was made by the respondent while he was testifying in his own behalf.

Now and then the respectable portico of the spectators, attorneys, business men and others, directly interested and otherwise, indulged in appreciative demonstration at some clever thrust between the Territorial advocates and the attorney defending his professional reputation. In these instances the general smile might also be looked for on the several countenances of the court.

Jones Not Asleep.

A little pantomimic by-play did not pass unnoticed by many, Supreme Court Stenographer J. W. Jones (who wields both the pen and the sword and is undecided which is the mightier) had taken his seat opposite the witness box, while Davis was testifying, with his back to their Honors. Davis much of the time was speaking at the rate of about 150 words a minute. Jones leaned his head against the rail of the jury box. Viewed from the bench he might easily have appeared to be asleep. Associate Justice Perry was gazing at Jones' motionless back and reclining head. His Honor beckoned Supreme Court Clerk Lucas and whispered to him. Lucas looked surprised, at Justice Perry and then at Stenographer Jones, executing a flank movement. Looking over the stenographer's shoulder he saw the rapidly flying pencil of the expert annihilating paper and recording the fast and forceful speech of the eloquent speaker. If there had been an appearance of slumber, the strenuous facts belied it.

When the afternoon session commenced at 1:30 o'clock, John K. Sumner was still on the stand.

"No, I was not to pay Davis \$3000 if he did not get the \$48,025 for me out of the bank," said the old gentleman. **Sumner's Attorney.**

"Who was your attorney in that case?"

Davis objected. Andrews declared the objection absurd. Evidence concerning a document the validity of which was questioned was material. The charge was that the respondent had obtained money under false pretences.

"Magoon & Peters were my attorneys," said Sumner. Davis moved to strike out the evidence.

"The prosecution is making the witness perjure himself by contradicting the documentary evidence he has already acknowledged. He acknowledged his signature," said Davis. **Majority Overruled.**

The Chief Justice announced that a majority of the court overruled the objection.

Sumner, continuing, said: "I told Davis I'd pay him \$1500 for his work. I don't know what his authority was. Maybe he was employed by Magoon."

He told me I couldn't get my \$48,025 unless I paid him \$2500. He said he would garnishee the bank. Until he received his money I would not get mine. I said \$2500 was too much."

"Did he say he would sue you?" "He said he'd hold my money up."

"What did you finally do?" "I thought it best to pay Davis \$2000 and save litigation."

"Did you pay the \$2000?" "I did."

"That's all, Mr. Sumner."

Davis, cross-examining the witness showed him the power of attorney:

Power of Attorney.

"Is that your signature?"

"Yes!"

"What is it?"

"That is for you to get that money I agreed to sign it. It was read to me, but I didn't understand it. I—"

"You understood when I asked you for \$2500."

Chief Justice Frear—"Let the witness answer!"

Davis—"Did not your Honors hear what witness said?"

Associate Justice Perry—"I did not hear."

Witness—"I made no agreement to sign that power other than that you were to get the money. No! I never employed you. Magoon & Peters were my lawyers."

Davis—"I offer this acknowledgment in evidence."

Andrews—"No objection!"

Denies Own Deed.

Davis—"I move that the answer of witness be stricken out. He denies his own deed."

Court denies the motion.

Davis asks that an exception to the ruling be noted.

Davis—"You never had anything to do with me?"

Witness—"No! With Magoon & Peters."

Davis—"Didn't you sign a check for \$2,000 for my services in the presence of Judge De Bolt?"

Witness—"Yes."

On re-direct examination Andrews, showing power of attorney, said:

"This paper was only for Mr. Davis to get the money."

Davis objected. The evidence was incompetent on redirect; also it was going behind the document, which spoke for itself.

Objection overruled. Exception noted.

"The Attorney General can put in any evidence he pleases," said Davis. **Lightfoot's Testimony.**

Attorneys J. Lightfoot and J. A. Magoon followed Sumner on the stand. Lightfoot told how Davis asked him to tell Magoon that he wished him or his firm to assist him in the Sumner case. Later Magoon regularly entered the case as counsel.

Respondent admitted that Magoon would testify to the same things Lightfoot had.

Magoon said he was leading counsel in the case. He objected, calling upon the protection of the Court, to divulging a conversation with Davis about fees.

Nothing to Conceal.

"I don't object, Your Honors," said Davis; "I have nothing to conceal! I was paid for my services in the presence of Judge De Bolt. I'm not afraid of any evidence. My record is clean. If I am beaten in this court I will certainly appeal to the Supreme Court of the United States."

The Court overruled the objection.

Witness told of the discussion of fees in his office. Davis asked \$2,500 and said he had a lien on Sumner's money for his fee. Later Sumner offered \$2,000 and Davis accepted.

No cross-examination.

Davis Sworn.

"I want to be sworn," said Davis, going to the stand.

Respondent told how Wylie Davis had brought him the trust deed to the latter from Sumner. Davis had said the deed was a wrongful instrument and unless it was destroyed he would immediately withdraw from the case. The deed put everything into the hands of Wylie. Davis had said to Wylie: "Why don't you wait until your uncle is dead?" Davis took the deed and put it in his safe. Afterwards Magoon wanted it and Davis gave it to him after tearing off and retaining the signatures of Sumner and Wylie. He filed the signature and of the document as evidence.

In answer to a remark of Andrews, Davis said:

"I am not going to the Supreme Court of the United States with this case, because this Court is not going to disbar me on such evidence as has been presented before it."

Davis said that Wylie Davis had fully interpreted the power of attorney to Sumner before the old man signed it.

When he took Sumner's check for \$48,025 to the bank, to get the money as empowered by Sumner, Davis found that Magoon's O. K. was necessary. Humphreys had served a notice on the bank not to pay the money. Davis asked Magoon to O. K. the check. As Magoon would not, it was useless to see the bank. It was through respondent's work, however, that the money was finally released.

Witness stated that he had controlled the conduct of the various Sumner cases in question and occupied much time in going over documents in the various matters to show the great amount of labor performed. After referring to a mass of papers and explaining his connections with Sumner, Davis said:

"I don't blame Magoon so much for that trust deed as I do Wylie Davis. Wylie Davis attacked me in the Advertiser. He gave an interview about the way he had been treated by his attorney. I tell you, Chief, that Sumner case was enough to send a man to the asylum, step by step, inch by inch. Yes; it was the hardest \$2,000 I ever earned in my life. Between them and the Advertiser it was enough to drive a man to the madhouse, unless he had unusual power of mental resistance."

Davis said his relations with Magoon were friendly throughout.

Trusts Magoon.

"They tell some hard stories about Magoon, but I trust him. He is a man of his word. His word is as good as his bond."

Referring to the different suits, Davis said:

"Whether it was right or wrong to institute these suits I leave for the Court, but I had the letter of Kinney & Bailou saying that Sumner was incompetent."

"If the property had been sold and the money distributed, the sister of Sumner would not have got a cent. I landed \$10,000 safe in the bank for her."

Davis referred to "your deputy, E. C. Peters," addressing Andrews and speaking of Peters' receiving \$2,500 while Magoon's partner in the Sumner case.

Answering questions put by the Chief Justice and Associate Justice Perry, respondent said: "I had a suit drawn up to garnishee the First National Bank upon the promissory note for \$2,000. The papers held in my hand when I asked Sumner for my fee were the suit but were not signed, simply drafted. The money was not then deposited. I did not know but Sumner might get away to Tahiti and should never obtain my fee. I have never received my fee in the Nobrega case, through this man Andrews. I was going to use my lien before Judge De Bolt and if I failed there I would proceed on the garnishee process."

"I surrendered the note with \$1,000 remitted—that was equal to a receipt; the check with my endorsement was the best kind of receipt in law. If he asked for a receipt I gave him one. Magoon says I gave him a receipt. Magoon understood what it was for. I don't know what the old man thinks of it. He swore on the stand that he never employed me at all. Do you believe that? You cannot believe that."

At 4 o'clock court adjourned until this morning.

PROJECTING AWNINGS.

Y. Okamoto, Tai Chang and Ah Kwal appeared in the Police Court this morning charged under the section pertaining to having awnings projecting over the sidewalks under a certain height. Attorney Frank Thompson, who appeared for Okamoto, entered a demurrer against the complaint. He pointed out that the law pertained only to awnings fastened by iron framework. Okamoto's awning had no iron framework. Judge Davis sustained the demurrer and discharged the defendant. The cases of Tai Chang and of Ah Kwal were continued until tomorrow.

Necessity for honest agitation furnishes no excuse for arousing race hatred that leads to anarchy.

Having declared for peace in the Orient, Russia is only shooting up a few of its own citizens to keep its hand in.

The beauties of Kakaako ought to have an impressive effect on the immigrants landing at Honolulu's future Castle Garden.

Japan and Russia announce that they will not go to war this winter, which is one way of commenting on the eventual conflict.

A full fledged kahuna trusty in the police station suggests a trust of final resort when all other methods of apprehending criminals fail.

Given a few more informations Attorney General Andrews will have a lovely collection of what his brothers in the law think of him.

Should Uncle Sam start in buying Islands in the South Pacific, he better fight shy of the place where Bishop Willis is located. There would sore be trouble.

Washington intends that Hawaii shall attend to its own affairs. It certainly will not listen to appeals based on racial prejudice, whatever party or faction they come from.

Teng Yee Lee, the Chinese graduate of Yale refused a landing in San Francisco, was considered a powerful opponent of the exclusion law till he announced his intention to write a book.

If an unkind fate is not pursuing the Brotherhood of Locomotive Engineers with malice of forethought, the deaths in the ranks of leaders furnish material for the superstitious to contemplate.

News of a revolt against the Cuban government is not entirely unexpected. Future advices will tell of what an all-important bearing it has on the anxiety of the Sugar Trust that the Cuban reciprocity treaty shall not fail. Files from market to be supplied.

Again the people begin to appreciate the value of a primary law urgently advocated a year ago, but which did not apparently receive a moment's consideration from its most ardent advocates during the session of the Legislature.

Hawaii's planters will do well to establish a refinery of their own but if they are in their right minds it will not be located in the islands. The Hawaiian refinery if it ever materializes must be erected in one of the great distributing centers—no thousands of miles from market to be supplied.

Gabrielle Bompard, a Parisian murderess whose release was a public scandal in France, has announced her intention to visit the United States on a lecturing tour. Judged from the attention paid this woman by a certain millionaire society will be in readiness to receive her with proper ceremony.

A New York dispatch tells of Long Island communities aroused in their wrath against the ravages of the mosquito. Since the President is taking his summer vacation in that section it is somewhat surprising that these citizens do not appeal to Roosevelt to don his rough rider uniform and lead the hosts to the war in behalf of civilization.

A Russian newspaper excuses the seeming vacillation in dealing with the powers by the statement that in Manchuria three separate authorities are at work and each has its own views and seeks its own way of defending the interests of the state. The Ministry of Foreign Affairs, Ministry of War and Ministry of Finance each make such pronounced declarations as seem best to protect individual operations. The paper adds "While three independent authorities are engaged one can scarcely expect uniformity and consistency in official declarations and actions, and thus are explained many peculiarities in the course of our Chinese affairs." The explanation is interesting if not amusing. One can expect anything of Russia these days.

HONESTY TOWARD FELLOW-MEN.

If the aborigines win against these, well and good.—Advertiser.

This is the central thought, the inspiration of an editorial discussion in the morning press entitled "Honesty vs. Honesty". It immediately gives rise to the query, Are the aborigines naturally corrupt? The whole tenor of the morning paper's discussion points to an affirmative answer on its part.

Just what scope it intends to give the term aborigines is not definitely explained, but the fact is generally accepted that hardly without exception the reading public, the voters in this Territory, take it as covering the Hawaiian-Americans or native Hawaiians as a class; that it includes the Hawaiian Delegate to Congress as well as the Hawaiian Representatives to the Legislature, and the Hawaiian voter. They are equally within the race qualification of aborigines and, in consequence of the failure of the morning paper to recognize or admit any degree of advanced citizenship among the aboriginal people, the class line based on origin of race is distinctly drawn.

The conclusion to which statements of this character lead is not fair; nor does it foster a sentiment that will in any way make for purification of politics or unity a community requiring, above all things, to be led away from racial prejudice. It is a stepping-stone to pathways that degrade and retard. It finds no support in the principles of civilization or the tenets of American faith. Hawaii can never progress if the political activity of its citizens is to be based primarily on the racial origin of its voters or its candidates.

To secure harmony and honesty in political organizations, public or private life, it is first necessary to deal honestly in the estimate of fellow-men. There is nothing in the history of this Territory, and especially in those claiming to speak with authority on the development of the aborigines of these islands, that justifies the branding of these people as a common enemy to reputable government and advanced policies. Hawaiians with splendid opportunities have fallen, it is true. Hawaiians appointed and elected to high office have given way to corrupt influences. But is this any reason why every scion of an aboriginal race should be swept into a general conglomerate heap and charged with motives of enmity for honesty in the walks of public life? Republicans of this Territory do not want harmony without honesty. There is no question about it. And the first demand for honesty is that every man shall be judged by his acts—not prejudged because of his aboriginal ancestry. Harmony never has and never will come from a war of races.

PROMINENT MEN TESTIFY

(Continued from Page 1.)

son, but I have never heard any imputation of your honesty. "On September 19, 1898 (and not 1899, as the firm) were representing Maria S. Davis as next friend of Sumner. At that time I did not consider Sumner compos mentis."

Cross-examination—"Maria Davis never retained us to represent her individually, but to protect the interests of John K. Sumner. We did buy five years' peace for Sumner, which I think should have lasted until his death."

"Yes; my knowledge of Davis' character is limited to the time prior to my departure from the country." Upon Davis asking witness if his firm had received \$1,500 for services in the Sumner cases, Mr. Ballou answered in the affirmative and explained at length the nature of the services rendered.

What De Bolt Says. Judge De Bolt was called. He was the presiding Judge of the First Circuit Court at the trial of Roper vs. Sumner. Didn't know that it was a long, tedious trial. All trials were alike to him.

Davis, on the objection of Andrews to some question alleged to be immaterial, said: "Your Honors will please remember that I am on trial for what to me is my all, my home, my honor and my rights. If I appear at times to be careless of the respect that I owe this Court, the Court will know that I mean no intentional disrespect. I am trying to get through this matter quickly and without unnecessary difficulty. I'm tired of it and I think your Honors are tired of it. I object to no testimony as it may affect me, but I'm anxious to finish the matter. Mr. Attorney General Lorrin Andrews is up again, I see; he's forever bobbing up and down."

Continuing, Judge De Bolt said that he could not say that any particular attorney took a leading part in the case. He thought on a few occasions Davis was a little late. Andrews Objects. Andrews objected to Davis asking Judge De Bolt if he (Davis) had faithfully represented his client in the Roper-Sumner matter.

The Court required the question in another form, to which Judge De Bolt replied: "It appeared to me that you faithfully performed your duty." Speaking of the check given Davis, by Sumner in Judge De Bolt's court, the Judge said: "I did not read the check but I saw Sumner sign a check that purported to be one of \$2000 for your fee." Sumner Didn't Object. "Sumner made no objection to paying you." "I think you did say the court was the proper place to settle the matter of the fee. Throughout the case I can-

not recall that any one attorney made the law points. Perhaps Mr. Magoon confined himself more particularly to the facts.

"The day of the Supreme Court proceedings Mr. Davis said something about his fee. He mentioned no sum less than \$2500. The next morning he said that Sumner had agreed to pay him \$2000 and that he had agreed to accept. I understood that Mr. Davis had a contract with Sumner. I was surprised when I saw the note and when Sumner said that was the contract."

Davis' Work Important. "Judge De Bolt will you swear that I ever got a dollar from Sumner before that case?" asked Davis.

Andrews objected. Judge De Bolt said he considered the amendment of Davis to the petition in the Roper-Sumner matter very important. He testified at length in regard to the case.

Cashier Cooper Called. W. G. Cooper, cashier of the First National Bank, was called. Cooper knew Sumner. Sumner deposited a check for \$48,025 in the bank. A certificate of deposit for \$40,000 was made out by the cashier.

"At whose advice?" asked Davis. "I heard you advise Sumner."

"Did I ask you to prepare a certificate?" "I heard you say it would be a good plan to secure a time deposit certificate. I made it out. It was cancelled because Sumner didn't want it. He had a talk with Magoon. I don't know as Magoon advised against it. I object to saying what amount Sumner has in bank at present. Yes, Davis deposited a check for \$2000."

S. M. Damon Testifies. S. M. Damon, called, said: "I remember you (Davis) presenting a check for \$48,025 at the bank of Bishop & Co. We knew there was a trust deed in existence and refused payment on that account."

"How was that deposit made?" "That's my business. No! I did not tell you that Magoon had deposited the money and that the check needed his O. K."

Stanley on Davis. W. L. Stanley said: "I have heard you (Davis) discussed often. An honest man's reputation for honesty is never discussed. I never heard Mr. Davis' honesty discussed."

Wyllie Davis Again. Andrews called Wyllie Davis in rebuttal. Witness denied respondent's statements in regard to the trust deed. He testified:

"Mr. Davis was after me to speak to my uncle to get him to come into the case; you are refreshing my memory a little bit." Witness stated that he or his mother had never asked Davis to procure any money for Mrs. Davis. Davis had never told witness that he could not bring suit against the bank.

"Sam Damon smiled and refused to pay the check," witness said, referring to the Bishop & Co. incident. Stewart on the Stand. T. McCants Stewart testified that Davis did suggest some amendment to the petition toward the end of the Roper-Sumner trial. He went into details, repeating much already brought out during the case.

Magoon Called Again. J. A. Magoon was called to tell what he knew of the amendment to the petition in Roper-Sumner. The bill was for a new trustee and he did not consider the amendment of Davis necessary, but let it stand.

In view of the fact that Bishop Roper was dying, witness suggested to Peters and Davis that they stipulate that a new trustee be appointed. Lieut. Gen. W. G. Dunham Massey, Colonel of the Fifth Royal Irish Lancers, who presided at the welcome-home dinner to the regiment, in London, recently, had a sobriquet once that can hardly be forgotten yet. For years after 1855 he was known as "Redan Massey," by reason that on a memorable 8th of September this "officer boy," as our friend Mulvaney would have called him, had led an assault of his own upon the Russian outworks at Sebastopol. He was 17, perhaps, then, and his first commission was not a year old.

He was so badly hurt—a ball had smashed his left thigh—that the Russians left him for dead, and when his own people much later on recovered him, he was only just alive. But he lived through a six months' confinement to "a camp stretcher" and the primitive surgery of those days, to command first the Royal Irish Lancers, then, in Roberts' Afghan campaign, a cavalry brigade at Charasia and Sherpur; and, by and by, the garrison of Ceylon. And he is just a C. B. like another, though he has the Legion, and his old University of Dublin gave him his L.L.D.

He is a soldier's son, and a soldier's son-in-law; an Irishman born, with a family place in Tipperary, where he is to be found a good deal oftener than in Pall Mall, and where the "Redan Massey" of the far-off days he brings so near finds his chief delight in the peaceful business of the architect and the horticulturist.

SYNOPSIS OF PRECEDING CHAPTERS.

Graustark and its capital, Edelweiss, are located by a guidebook. The Americans get no trace of the Guggenlockers there. VII.—Lorry sees his charmer driving in a carriage with a beautiful companion of her own sex. He gets a glance of recognition, but the carriage rolls on, leaving the mystery unsolved. Later he receives a note at his hotel signed Sophia Guggenlocker, inviting him to visit her next day. VIII.—In the evening Lorry and Anguish ramble about the grounds of the castle where dwells the court of the Princess of Graustark. They overhear a plot to abduct the princess and resolve to capture the plotters red handed. IX.—Following the conspirators, Lorry finds himself in a room he heard them designate as that of the princess. X.—Lorry tells the princess of the plot. Mutual recognition, she is Miss Guggenlocker. Danno, the guard, is in the abduction plot. He tells Lorry with a terrible blow. Anguish to the rescue. XI.—Lorry quarters in the castle. The princess visits him, but forbids all talk of love. XII.—Graustark is bankrupt and owes the neighboring principedom of Axphain \$30,000,000. The creditor demands cash or the cession of the richest districts of Graustark. XIII.—The Prince of Axphain offers to extend the loan if the princess will marry his son Lorenz. Prince Gabriel of Dawsbergen also bids for the princess' hand with offer of a loan. Yetteve tells Lorry that she belongs to her people and will marry Lorenz. XIV.—Lorry discovered kissing the princess while she is seated on the throne. He quits the castle by royal command. XV.— betrothal of the princess to Lorenz. The Americans recognize Gabriel as chief conspirator in the abduction plot. XVI.—Lorenz toasts the princess lightly in a cafe. Lorry dashes the glass from his hand. Challenge to a duel. Lorenz assassinated. Lorry charged with the crime. XVII.—Princess Yetteve commits Lorry to prison. All Graustark rejoices at the death of Lorenz. XVIII and XIX.—The princess helps Lorry to escape. Disguised as a soldier, she conducts him to a monastery. XX.—Axphain offers Graustark grace on the loan if Lorry is executed before Nov. 20. Yetteve offers a reward for the capture of Lorry. XXI and XXII.—Lorry prevails upon Quinnox, an emissary of the princess, to conduct him secretly to the castle. He will surrender himself to save the realm. The princess spurns the offer of Gabriel.

Aware of her financial troubles and pursuing the advantage that his rival's death had opened to him, Prince Gabriel of Dawsbergen renewed his ardent suit. Scarcely had the body of the murdered prince left the domain before he made his presence marked. CHINESE PIG PENS MUST GO

The Board of Health met yesterday afternoon at 2 o'clock. Mrs. Jennie Kaena and Mrs. L. Amaka's petitions that their husbands be allowed to come to the leper settlement as kokua. As Superintendent McVeigh reported favorably, the petitions were granted.

C. Kopena's petition that he be allowed to remain at the settlement was denied upon the recommendation of Superintendent McVeigh.

Sam Kapiko and Kaluwal also wanted to remain at the settlement as kokua. Superintendent McVeigh reported that both were hard workers and had lived at the settlement for a long time. Their petitions were granted.

Jacob Sims petitioned that he be allowed to stay at the settlement. He stated that as he was placed in a suspect list the settlement was the best place for him. Superintendent McVeigh reported unfavorably on the character of Sims. The petition was consequently denied.

Mrs. H. K. Aylett's petition that she be allowed to take her young child with her to the settlement, was denied.

The Kapiolani Estate offered a piece of land back of Kapiolani Park for the new Insane Asylum either for sale or exchange with government land. The piece is 31 1/2 acres in extent, is covered with algaroba trees and is favored with a fine breeze. Dr. Cooper stated that he had looked at sites near Diamond Head and asked that the Board make a trip to inspect the sites before taking action in the matter.

Chas. Herring was appointed fish and port inspector of Hilo and S. Lilliane assistant fish and food inspector, Hilo. S. Kapu was made fish and food inspector of Lahaina.

The committee appointed to examine certain pig pens on Sheridan street reported that these were filthy and recommended that the Board sustain the action of the city sanitary officer, ordering the owners to remove the pigs within sixty days. The recommendation was put in form of a motion and carried.

Dr. Pratt reported on the tuberculous cattle on C. Bolte's ranch at Heala. He reported to have had seven head killed. Examination showed them all to be affected. Dr. Monsarrat had examined a batch of cattle on Ahumahu ranch and found two head diseased. The examination of the rest of the cattle would take place later. Dr. Pratt reported that the Ahumahu dairy was in excellent condition.

E. G. Keen's request for a six weeks' leave of absence was granted.

A financial report from the Hospital for Incurables was read. It showed an endowment fund of \$73,500 invested in bonds, etc. The new buildings cost \$38,624.25. A balance of \$3,158.70 is kept in the bank for operating expenses. Dr. Cooper and Dr. Mays both reported that they had visited the hospital and found it in excellent condition.

CABLE WORKMEN ESCAPE

together, but the fury of the wind and waves caught the larger boat, which was swept away out of sight.

"The storm was increasing, we were cut of sight of land, the shades of eve were beginning to fall, and the hopes of reaching the whaleboat before long were at a low ebb. It seemed useless to proceed further, and I was on the point of ordering my men to turn back and make for shore before it was too late, when there appeared clearly outlined against the horizon, a white speck which had the appearance of a flag or, perhaps, a sail.

"That settled it. There was no more thought of danger to us. We made directly for the place and our long boat skipped from the crest of one wave to another like some live thing.

"It was a long chase, but before dark we had caught up to the whaleboat and were soon alongside. It was a sorry spectacle. The men were completely exhausted, and all they could do was to smile up at us and thus convey their gratitude. To be the recipient of such eloquent looks as they gave us is worth twice the danger we were in.

"There was just one man in the crew who had any strength whatever left and he was the one who, while lying in the bottom of the boat, had tied a shirt on the end of an oar and held it up in the hope that some passing craft might see it and fly to the rescue. It was the last resort. All hope had been abandoned. Without provisions or water and in a completely exhausted condition, it was only a question of time when the sea would have claimed one and all.

"We were told that the lighter had been picked up and the men taken off. It was impossible to save the craft and so it was set adrift. We first attempted to tow the whaleboat, fearing that the additional weight of the eight men might result disastrously for us. This plan proved to be useless. We kept losing ground and so, as a final resort, we took the men aboard. We then came about and made for home.

"It was not safe to use sail as our boat was laden down with sixteen men, together with provisions and extra oars and sails. We would surely have met with disaster had one of the waves taken us sideways. We therefore trusted to the oars. Five men took a shift of ten minutes and were then relieved by five others, the remainder keeping down under the thwarts in order that the wind might not have any extra surface upon which to exert its influence.

"Thus we worked our way home, reaching the cable station at about 10 o'clock at night. I cannot give you an adequate idea of the reception we got. It was something that one feels but cannot express—something that makes a man thrill all over when he thinks of it. The people remaining at the station were wild with joy and everyone embraced everyone else. Of the men who had gone out in lighter, whaleboat and skiff, not a single one was missing. You can imagine what gladness was mine for some of my own relatives were among the ones saved.

"I shall never forget, the longest day I live, the expressions of thankfulness on the faces of the men in the whaleboat when we came up to them, and the reception we received upon our safe arrival home."

elect its full quota of delegates, or in case of a tie or vacancy it shall elect a delegate from said precinct, who shall serve for the term, or until another election is ordered and decided; and it shall nominate candidates for county offices.

Resolved: Fifth. That the officers of each county committee shall be a chairman, vice chairman, secretary, treasurer and an executive committee to consist of one member from each precinct, to be appointed by the chairman on the nomination of the precinct delegates. The chairman, secretary and treasurer of the county committee shall be ex officio members of the executive committee.

Resolved: Sixth. That these officers shall discharge the duties of their respective offices. They shall serve during the term of the county committee and until their successors are elected.

Resolved: Seventh. That the county committee shall meet at such regular times as it may fix, and at special times upon call of the chairman, or executive committee, or by the chairman upon the written request of seven members of the county committee, or upon the call of the Territorial Central Committee.

Resolved: Eighth. That for special meetings due notice shall be given each member in advance, or notice by postal card shall be mailed to each member by the secretary three days in advance of such meeting. One-third of the entire membership shall constitute a quorum.

Resolved: Ninth. That the executive committee shall elect its own officers, but the treasurer of the county committee shall be the treasurer of the executive committee. It shall carry into effect the orders and resolutions of the county committee; it shall have general supervision of the committee's finances, audit the treasurer's report, and provide for and have the custody of the headquarters of the county committee; have charge of the distribution of county patronage; report at each regular meeting upon all matters previously referred to it for consideration or action, recommend such measures as it may deem expedient for the welfare of the party in the county; and, unless otherwise ordered by the county committee, shall have entire charge of and supervision of the conduct of county campaigns. A majority shall be a quorum for all purposes.

Resolved: Tenth. That appointments to county office shall be recommended, as far as practicable, upon the endorsement of a majority of the executive committee of the precinct club to which the applicant belongs and the executive committee of the county committee.

Resolved: Eleventh. That a proxy may be given by a member of a county committee to a member of any precinct club in the county. No member of the county committee shall hold more than two proxies.

A RUMOR DENIED

There has been a persistent rumor abroad on the streets during the past week, which has it that the Interior and Company intends running to Hilo in competition with the Kinu. Those who spread the report, pointed to the fact that the Waiialeale was making regular runs to Maui, sailing on Monday afternoons.

When seen yesterday, President Kennedy laughed at the rumor, at the same time stating that he had heard the same thing himself, upon his return from Hawaii. However, the rumor emanated from some outside source and not from the office. There was no truth in the rumor.

Speaking of the Waiialeale, Mr. Kennedy said: "The Waiialeale is the only boat that has a license to carry explosives and the trip made each Monday night is for that purpose alone and for the convenience of the Maui people who heretofore have had to wait two and three weeks sometimes before having a chance to get their explosives. The Waiialeale runs to Kaula as of old, making this trip during the middle of the week. She is not competing in any way with the Wilder boats."

Freighter Alaskan.

The Chronicle of July 22 contains the following with reference to the freighter Alaskan:

The big freight steamer Alaskan is expected to arrive today from New York with an 8000-ton cargo for the American-Hawaiian Company. The Minnetonka, under charter to the same line, left Tacoma yesterday for this port en route for New York on her return with a full cargo. The Nevada, of the Honolulu line, with a large cargo of island products, is still in the stream. No report has yet been received of the Minnetonka's arrival at San Diego from New York.
