Should it be deemed necessary from time to time to lengthen the period of quarantine at the detention camps this action will be taken by the Board of Health.

George R. Carter now has complete control over all the freight. He stated yesterday that the merchants were very considerate and offered to do anything the Board asked.

The duties of Prof. Ingalls as disinfecting agent in Chinatown have been increased so that now, immediately a suspicious case is reported he and a corps of assistants ride quickly to the place and attend to the work of disinfecting.

The deputy sheriff of Hamakua was the only man of the prominent Hamakua residents that, at a recent meeting called to discuss Sheriff Andrews' action, refused to sign a petition to the Board of Health asking that such action be not recognized.

At a meeting of the Board of Health yesterday afternoon Minister Mott-Smith asked the Board that they declare unsanitary and destroy a certain cottage of his on Merchant street in the vicinity of the shack from which the Japanese woman and her child were removed from a few days since.

At a meeting of the Board of Health yesterday afternoon E. F. Bishop of Brewer & Co., asked for a special permit to be allowed to land certain machinery at Laupahoehoe. President Wood stated that a bill of health, granted to all outgoing island steamers, was equivalent to a permit to land freight.

A native tried to remove a fine calabash from the sidewalk in front of one of the buildings on Nuuanu street this forenoon but was prevented by one of the Board of Health inspectors. It is understood that a certain person who saw the calabash subsidized the native to get it to another place in Chinatown where it could be kept until the expiration of quarantine.

With Mr. Pain on the one side and Mr. Ballentyne on the other, both subjects of Her Majesty, it is impossible to put any Boer-Briton phase on the street railway controversy.

If the people of the United States desire American principles in Hawaii to wane and become a less potent factor in its political life, the easiest way to accomplish the result is to set the islands to one side on some colonial scheme.

Why should Mr. Hartwell feel very much put out when he learned Col. Sam Parker had told the President that the "unofficial delegate" is nothing but a personal representative of Mr. Dole? Parker told the truth and Hartwell knows it.

When there is public work to be done, streets to be extended and improved, why should the men released from the detention barracks be maintained in idleness? The Board of Public Works has an opportunity to distinguish itself in something besides its usual inactivity.

It is safe to presume that Mr. Dole's personal representative, Hartwell, is using his wide acquaintance and war records to secure an extra session of the Legislature. Mr. Hartwell's influence with the President and friends of the Administration has yet to show anything but a list of failures.

The man or men who have stated that the Bulletin is or ever has been in possession of a list of the property owners in Chinatown and is afraid to publish it, are purveyors of an absolute falsehood. The repetition of such a statement is only necessary to put them individually and severally within the category of willful liars.

W. O. Smith finds it impossible to withhold from meddling in personal politics. Thus he as usual takes upon himself authority not vested in him and thereby reduces his value as a representative of business interests. If the country as a whole has any right to recognition, we would suggest that Mr. Smith hang up the new official slate until the Hawaiian territorial bill is well on its way.

START WORK ON THE ROADS.

The Bulletin's suggestion that the homeless people of Chinatown be given work through the improvement and extension of the streets meets with general favor from the public. There is really no reason why the able bodied men soon to be released from the quarantine barracks should continue a charge upon the charity of the public treasury.

The Legislatures of 1896 and 1898 provided for extension of many streets in Honolulu. Of the number named Vineyard street is the only one completed. Minister Young remarked in effect the other day that when the Legislature acts it is to be taken for granted that the object is a necessary one.

How much more necessary is it now that this street extension in Honolulu be carried on. It is merely a question of whether the government maintain a good portion of the Chinatown population in idleness, or use the same amount of money as a return for labor. In how many cities of the world are hard times tide over by government inaugurating public work that will give employment to the destitute. Here we have a situation where the people must be maintained whether or no. Many are willing to go to the plantations, but it is doubtful policy to allow these people to leave the city.

Having used drastic measures in throwing these people out of home and stopping their usual source of income, the government is equally justified in inaugurating vigorous measures to give them work to tide over the present crisis. The health, wealth and happiness of able bodied men is better maintained through work, though it be on the roads, than by idleness.

KUKUI STREET EXTENSION.

The Advertiser is very much in error when it states that according to the law of the land Fort street of necessity comes next on the list to Vineyard for improvement. The Legislature of 1898 amended the act quoted by the Advertiser striking out that portion which commands that Vineyard and Fort shall receive first attention. If possible all the streets named—Fort, Kukui, Vineyard, Kuakini, Bates, Pensacola, Miliani, Queen and Young—should be extended as directed by the Legislature. When sanitary conditions are considered there is no question that Kukui street extension should take precedence over Fort. If the work on each cannot be carried on simultaneously.

The lane from Fort to Emma, which extension of Kukui is intended to wipe out, is one of the most insanitary sections of the town. The houses are crowded and the lane is ill smelling and dirty from the nuisance committed by those passing through at night. Proper streets through Chinatown are not more necessary to the health of the people than the opening up of this lane as was intended by the action of the Legislature.

THE RAILWAY POW-WOW.

The street railway companies are to be congratulated on timing their pow-wow on the streets to take place during a wait for mail steamers when the public mind is mulling over the unhappy conditions arising from the plague. Even a dog fight is a welcome diversion these days, while Mr. Ballentyne and Mr. Pain have furnished an open air exhibition that is interesting and quite new to this town. The real interest of the public, however, is to gain something permanent from this railway business. For the last three months King street, one of the city's main thoroughfares of business traffic has been in various stages of upheaval that reminds one of the condition of Broadway, New York, where one portion is no sooner put in condition than another part is dug up.

The sewer operations blockaded the streets to a certain extent, but the work was done quickly, and when the pipes were once laid they were down to stay. The people can view such work with benevolent indifference, if not pleasure. But when it comes to desultory raids with pick axe and shovel, first one company digging up the street and then another and neither accomplishing any work that carries any guarantee of permanent tracks and rapid transit, the amusement gets mighty tiresome.

The appeal of the Rapid Transit Company that all work on laying tracks be suspended until the rights of the two companies can be determined by the courts is a reasonable one and shows due respect for the demands of business traffic that no unnecessary barriers be maintained on the streets. When the question of rights is pending and can only be settled by decision of the courts, the government, if it has authority to do anything, is in duty bound to keep the streets of the city free from an embroglio like that now going on.

Who owns the streets anyway? Are they to be turned upside down every three weeks to suit the sweet will of the generals directing the battles of private corporations? Has the public no rights in this matter that demand recognition?

It is about time the government positively called a halt until the corporations have settled their differences either in the court or some side alley.

EXTRA LEGISLATION DOUBTFUL.

There are other pressing matters which would make it highly desirable if the Legislature could be got together soon. Thus the government organ seconds the motion of the Executive to call an extra session of the Legislature. And thus it makes manifest the very point which will unquestionably cause Washington officials to hesitate before granting authority for calling the Legislature in session.

The fact of the matter is Hawaii is not left without a legislative body having authority to act in emergencies like the present. The Council of State has all the authority that is necessary and all that is desirable to exercise at a time when Hawaii's governmental status is in the balance before Congress. It is the "other pressing matters," that appear of vast importance to local official minds but accomplish nothing more than increased complications for friends in Washington, that the national authorities seek to guard against and which had not a little influence in determining the action of the President when the Legislative election was called off.

To act in times of emergency was what the Council of State was organized for, and it has yet to be proved

that this body cannot furnish all the snows of war necessary to deal with the present situation as well as extend appropriations in the various departments. While the Hawaiian bill is pending before Congress, the people of this country should attempt to legislate as little as possible. Power to appropriate money is the only necessity of the present situation and the Council of State has that authority. Calling the Legislature opens a vista of possibilities that offers little more than new complications which will delay the action of Congress in pulling the islands out of their governmental chaos. Aside from appropriations, the only "other pressing matter" that demands attention is the prompt enactment of Hawaii's organic law. The local Legislature in extra session can do mighty little to advance this important work of Congress.

MATTERS IN LITIGATION.

William R. Castle for himself and other defendants to a bill for account of A. S. Cleghorn, administrator, has filed a motion to open default. He alleges that his failure to answer in time was due to an omission committed in his office, also pleads that his time latterly has been partly occupied by services for the Board of Health. It will do no harm to complainant, he sets forth, to grant his motion, while a denial would work injustice to the defendants.

The bill for partnership accounting of William Hilsdell vs I. R. Burns has been set for trial on January 15.

T. M. Harrison vs J. A. Magoon and others was partly heard on demurrer and continued to Friday next by Judge Stanley this morning.

W. C. Achi vs Kaul was argued on demurrer.

Judge Stanley sustained the demurrer and dissolved the injunction, which was to enjoin Kaul from selling certain land at Koolau.

Judge Perry has rendered a decision in the celebrated case of Christley vs Magoon. Mr. Christley brought suit to set aside a deed conveying his property to Mr. Magoon. The case involves property worth \$60,000. The court decides in favor of plaintiff, and will sign a decree accordingly setting aside the deed. Restitution of money received is also to be made to plaintiff.

Hatch and Ed Bolt are attorneys for plaintiff, and Kinney, Ballou & McClanahan and Lorrin Andrews for the defendant.

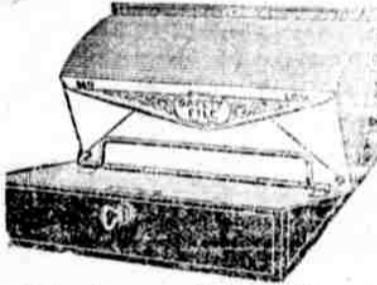
