The receipts of sugar for the past week amounted to 23,043 packages.

The weather at Koloa, last Friday, was very rainy and windy.

The bark Edward May sailed from Liverpool on the 26th of January, for Honolulu.

The Band will give a concert at the Hawaiian Hotel, this evening, (weather permitting).

Mr. John Fraser died of aneurism last Saturday night. His funeral took place yesterday afternoon.

The Guild of the Sons of the Cross, Iolani College Branch, hold a meeting at 7:30 this evening.

The Eureka, W. G. Irwin, Kalakaua and W. H. Meyer, and schooner Anna were advertised for Honolulu, at San Francisco.

The bark C. R. Bishop arrived last Saturday, 132 days from Bremen. She brings an assorted cargo to Messrs. H. Hackfeld & Co.

A telegram, dated Corfu, Jan. 28th, state that a plot against the life of the King of Greece has been discovered. It was to murder him while on a journey.

The bktne Emma Augusta, Capt. Hodson, sailed from Kahului on the 8th inst. for Port Townsend. She will return to the above port with a cargo of lumber for Capt. Hobron.

The schr General Miller arrived at Kahului on the 9th inst., from Lahaina, where she has been discharging her cargo of coals. She will have quick dispatch for San Francisco.

The Weekly Chronicle, of January 19, contains an article headed—"The Humboldt Treaty—Its Workings explained to President Arthur.—How the people of the Pacific Coast have been swindled under its operations."

The schr Claus Spreckels, Capt. Cousins, sailed from Kahului on the 9th inst. for San Francisco. She took away 6342 bags of sugar valued at \$50,581, and the following passengers: John Mangels, R. Taylor, E. Doyle, I. Banman and W. Jess.

At Koloa, Kauai, on the 5th instant, a negro knocked down a man by the name of Little Manila Martin, and cut him frightfully about the head with a knife. The wounded man is in a critical condition. Both men were employed on the Koloa Plantation. The negro is held to await the result of the injuries.

By the Jane A. Falkenburg we have received dates to the 29th January. The principal items of news seems to be the conviction of Guiteau. The case went to the jury on the afternoon of Jan. 25, who retired and were absent not quite ten minutes, when they returned the verdict of "Guilty." A poll of the jury was called, and each answered "Guilty."

1571 packages of sugar are to hand this morning.

The steamer Iwalani is due to-morrow morning from Kau, Kona and Maalaea.

Mr. J. S. Lemon died yesterday. The funeral takes place this afternoon at 3 o'clock, from his late residence.

The various companies of the Honolulu Fire Department are requested to assemble this day at 2 o'clock, in front of the Bell Tower, to attend the funeral of the late J. S. Lemon.

The following vessels have arrived at San Francisco from Honolulu: Jan. 18, W. G. Irwin, 24 days; Kalakaua, 23 days; Eureka, 17 days; schr Anna, 19 days; smr Australia, 7 days; Jan 22, Consuelo, 14 days from Kahului.

An investigation of charges preferred against Dr. Lawlor, in connection with the vaccination of Chinese passengers on shipboard, was being held by the Board of Health at San Francisco, on Jan. 29; the steamer Mary Tatham may have been detained a day or two for that reason, which will account for her non-arrival.

**Wreck of the bark Rainier.**  
EMPIRE CITY, OR., Jan. 28.—The bark Rainier, from Puget Sound to Honolulu was lost on the 5th January, about 200 miles west of Cape Blanco. Capt Wulff was killed when the vessel capsized. The crew were taken off of the wreck by the brig Orient on the 24th, and arrived at Umpqua on 25th January. Captain Wulff lived about an hour after being injured.

**Guiteau to be Hung.**  
WASHINGTON, Jan. 28th.—As an indication of how little weight is attached by the prosecution to the motion of Scoville for a new trial, District Attorney Corkhill remarked to-day before a number of gentlemen that Guiteau will undoubtedly be sentenced and as surely executed not later than the 10th June.

**Search for the Jeannette's Crew.**  
St. PETERSBURG, Jan. 28.—The latest news from Irkutsk states that Engineer Melville has proceeded to the mouth of the Lena to resume the search for Lieutenant-Commander De Long with the greatest energy, aided by the natives. Provisions are plentiful, so the search can be prolonged. The captain of the steamer Lena accompanies him.
