THE STRAY DOG NUISANCE.

It is long since the city and its environs have enjoyed so great an immunity from stray dogs. There is no need at this time to comment upon the tardiness with which steps were taken to abate the nuisance. Suffice it to say that the Marshal in dealing with it in the vigorous manner he is now doing is rendering a public service for which he is to be commended. We only hope that the duty is not one destined to be performed spasmodically, but that the enforcement of dog regulations will henceforth be done with uniformity. The subject is of much greater importance, especially in a warm climate, than may appear on the face of it. Experience has shown that it is usually the stray dogs which are diseased, and the risk of the various diseases to which the canine race are subject being communicated to man is no imaginary one; it is a reality well established on a scientific basis. To say nothing of hydrophobia, which we believe has not yet made its appearance in these Islands, there are other maladies, equally as insidious, more common, and if less to be dreaded, are yet bad enough to be guarded against. For instance, hydatids is the form in which the tapeworm of the dog occurs in man. To quote from a medical authority, "the eggs of the tapeworm escape from the dog and are scattered broadcast. We know not when and where we may swallow them, for a single worm goes on producing eggs by the thousand, and these, owing to their great vitality and small actual size, may be carried long distances by wind and water, and so poison more or less of a whole neighborhood."
Another loathsome disease is mange, which also is "highly contagious, for hardly can a healthy dog lie on the spot where a mangy dog has recently reclined without being affected. The parasites that may drop or crawl from a dog on to the floor where he lies may live there for several days; it is well known that on man they will live for weeks, and although they are not supposed to breed on man, still they excite an irritable disease, which for a time is nearly as intolerable as itch itself."
Ringworm is a variety of mange, and, as is well known, it affects cattle as well as other domestic animals, and the human race.
In the "Nineteenth Century" for August, 1887, is an article describing the extremely complete dog regulations of Bavaria in particular, and of Germany in general. It is futile to hope for anything so complete in this country, but the results are such as should be noted. The regulation came in force in 1876 in Bavaria. Before this time the number of dogs reported as rapid or suspected was over 800 per annum. Now it is about 10 per annum. Before the regulations the number of cases of hydrophobia averaged 26 per annum; now it is only 1/2 per annum, i. e., one in every two years. At the same time the number of dogs still remains at two-thirds of what it used to be. Thus, the hydrophobia cases are only 2 per cent of what they used to be, while the dogs are still 66 per cent; or the hydrophobia decrease has been 33 times as great as the dogs' decrease. So that it is clear that the one-third of the dogs that have disappeared owing to the tax regulations included nearly all the dangerous dogs. Danger to human life in Bavaria from this cause is thus seen to be now infinitesimal. Laws have succeeded in preventing what science, through Pasteur, has so largely been seeking to cure. And what is said of rabies and hydrophobia may also be said of other canine diseases—mutatis mutandis—not to speak of the aesthetic element in the matter, and this is not inconsiderable.

We have broached the subject in order that its full significance may be realized, and that the hand of the law may have the moral support of the public. Now that its importance has been recognized it is to be fervently hoped that it will not relapse into apathy.

SANDWICH ISLANDS HISTORY.
How an American Commercial Firm Suffered at the Hands of the Hawaiian Government.

(Continued from yesterday.)
It does not appear that any compromise was ever proposed to the Belgian company or Ladd & Co. for cancelling the lease. Messrs. Ladd & Co., in carrying out their covenants in the 100-years lease had devoted time and money largely in the most perfect good faith. They had actually secured, as stated above, a valid contract with a rich and highly honorable European syndicate, the head of which was the King of Belgium. That syndicate had progressed so far as to arrange for an immediate shipment to Hawaii of the first installment of agricultural colonists and machinery. They had the fullest confidence that their associates, Ladd & Co., were an American firm of high integrity and of sound commercial character. In the management of their extended business in Hawaii, Messrs. Ladd & Co. had naturally large outstanding accounts for and against their firm, as is usual among business houses. They were indebted to the Government for various purchases of wharf sites and other interests, and also for a considerable sum of borrowed money. They were expecting, through advices from Brinsmade, to receive ere many months, large cash remittances. Some of the money borrowed by them of the Government was to enable them to give effect to the 100-years' lease. They had abundant assets, if not forced on the market. The Koloa plantation alone was subsequently appraised by a sworn Government Appraiser, Mr. De Fiennes, who valued it at \$252,500—a sum far beyond all the liabilities of Ladd & Co.
Suddenly and most unexpectedly the Hawaiian Government demanded of Ladd & Co. the immediate repayment of loans made. Other accounts and claims obtained or due to the Government were presented and payment demanded. Suits were brought by the Government in the Hawaiian Courts, judgments obtained and sales of property forced at auction. The Government Sheriff was directed to sell that splendid Koloa property; he was desired to "bid it in for the Government at about \$5,000," notwithstanding the valuation of the property at \$252,500 by the official appraiser not long before. Of course no one would desire to antagonize that competitor. The private property of the firm and their household effects were seized and sold by the Sheriff at auction; and even the family Bible of Mr. Ladd was sold under the hammer.
A newspaper published in Honolulu contained accounts of the suits, judgments, auction sales and practical bankruptcy of the old house of Ladd & Co. That Hawaiian newspaper with its disastrous story happened to reach Belgium and fall into the hands of the Belgian syndicate. The news of the bankruptcy of Ladd & Co. reached the Belgian company on the morning of the very day they had appointed to pay Mr. Brinsmade a large sum in cash on account of the \$200,000 due to him. Mr. Brinsmade called on the syndicate at the hour and place appointed to receive his money. Instead of money these gentlemen indignantly put up to his face that Hawaiian newspaper with its blighting information. Brinsmade read the news. He told the syndicate he had no idea of the cause of such proceedings—that he left his firm in good standing—that it was all a mystery. In fact he was astounded, and knew not what to say or do. Of course he could not imagine, at that distance, why the Government for whom he had labored so zealously should show such gratitude. But the Belgian syndicate wanted no bankrupt connection. They pointed out to Mr. Brinsmade the official character of the news, and then declined all further dealings with their ruined associates and their 100-years' lease. Thus ended the Belgian contract; also, the firm of William Ladd & Co. of Hawaii.
Unfortunately Mr. Brinsmade. He was six months from the nearest communication with home. He had accomplished the object for which he was sent to Europe by his partner, and under the approval of the Hawaiian King. He had secured from France the recognition of Hawaiian independence, which had greatly exhilarated the King, Ministers and Chiefs, and so had procured for him "their everlasting gratitude." In his whole-hearted generosity he labored to do good to the Hawaiian Government and people as much as for his own firm. He spent his money in their behalf, which it does not appear was ever reimbursed to him. Now, when in sight of the joyful fruition of his long labor, in a moment he finds himself thrown out of the society of Belgian gentlemen, disgraced, dishonored, utterly ruined, and he cannot even imagine the reason why. It is a fact that Mr. Brinsmade had to beg money to pay his board bills and his passage home to Hawaii.
An American gentleman of high commercial standing, now in Honolulu, writes to a friend that one day he accidentally overheard Dr. Judd, who had

been a high Government officer, express himself as follows: "The treatment of Ladd & Co. by the Hawaiian Government could not be justified, except that the safety of the state required it." Rev. Dr. Damon, a resident of 40 years in Honolulu, and a personal friend of the writer, when at the island in 1843, in a conversation I had with him at the Palace Hotel, San Francisco, a few years since, expressed disapproval of the course of the Government pursued against Ladd & Co. Dr. Damon used also the following expression substantially: "The plan of the Government was to strip Ladd & Co. and thus disable them from carrying on a suit for damages." Dr. R. W. Wood, now of Jamaica Plain, on oath before a court in Hawaii, said: "The Government told him that they intended to strip Ladd & Co." The missionaries did not approve of such unrighteous proceeding, but their education and religious preferences kept them passive in secular and political matters. They were indeed good and noble men. Their lives were devoted to the promotion of Christian influence among the natives, and they feared an immigration of European colonists. If they had shown the spirits of their sons—now the leading men of the islands—an honest, energetic, and innocent American firm would not have been so crushingly treated as were those partners in Ladd & Co.
But the partners in the firm soon died impoverished, their heirs being young children. Those heirs have often sought relief from the Hawaiian Government, but powerful influence seemed to prevail against them. Surely such a wrong appeals to every honest kindly heart for redress. Mr. Hooper, one of the firm, moved to San Francisco, Cal., where his name to-day is honored and respected. Just previous to his death he prophesied that "justice would yet be done to his wronged children, and to those of his ruined associates."

That was indeed a solemn covenant, that lease of 100 years to Ladd & Co. It was drawn up in the Kanaka language and in English, most formally, deliberately, and under the sense that it alone could save Hawaii from foreign aggression. The covenant in both languages is signed by Kamehameha III. and by the great chieftainess Kekaulohi, with formal seals attached. Yet it is deliberately declared in after years, by the most influential foreigner ever resident in the islands, that (the violation of that solemn covenant) "the treatment of Ladd & Co. by the Hawaiian Government could not be justified except that the safety of the state required it."

A COWARDLY GRIZZLY MOTHER.

She Deserts Her Cubs When Hotly Pursued by Hunters.

After resting my horse a few minutes I went on, and had not gone far when I saw in the distance three black objects, which, upon examination with my field glass, I took to be buffaloes lying quietly in the grass upon the prairie. As the wind was blowing from me directly toward them I was obliged to make a long detour to get upon the opposite side, when I met one of my Mexican hunters, who had discovered and was going for the same animals I was in pursuit of.

We united our forces and advanced within rifle range, when the animals jumped up, and to our astonishment proved to be a large grizzly bear with two well grown cubs. The instant they discovered us they all started off rapidly, and we after them, at a speed which soon brought us near enough to give shots, but owing to the frantic plunging and surging of our frightened horses, to say nothing of our own perturbation, neither of our shots took effect, and I doubt if even Buffalo Bill, with all his masterly equestrian adroitness, and his skill in rifle shooting, could, under the circumstances, have made much better shots than ours.

As we were obliged to stop and re-charge our long muzzle loading rifles, this gave the bears time to get considerably the start of us. We, however, soon closed the gap, and gave another shot that inflicted a slight flesh wound upon the dam, at which she set up a vociferous growl and plunged ahead, leaving her cubs behind. Giving a hasty direction for the Mexican to attend to the cubs, I pushed on after the old one, which was at this time a good deal in advance, and going at her best speed, while the panic stricken whelps were giving utterance to the most plaintive cries, which were heard by the mother, but she continued on, and my horse put forth his utmost efforts for at least two miles before we came up with her.

In the meantime the cubs continued their incessant cries, at which the dam would occasionally turn round, sit up and look back, but as soon as she saw me coming she resumed her running, and this was repeated several times, until I came near her, and galloped along for some distance by her side, but even this close proximity did not induce her to turn upon me, or to make the slightest demonstration of hostility.

Her sole purpose was to escape, and to effect this she deserted her offspring in the most cowardly manner. When I had satisfied my curiosity regarding her aggressive proclivities I gave her a shot back of the shoulder, which caused her to turn around and walk slowly back with her head down, severely wounded, but another shot in the head brought her to the ground, and after taking off one of her paws, as a trophy, I returned to camp, where I found the Mexican, who had lassoed the two cubs, and driven them before his horse nearly five miles, while they continued their piercing screams all the way. Indeed, they kept up their cries during the entire night, so that the men got but little sleep and obliged us to have them killed the next morning.—Gen. R. B. Marcy in *Outing*.

Spectators at a Bull Fight.

The uncovered seats on the shady side, especially those affected by the youth and students of the town, were closely packed with heads in ranks like the seeds in an ear of maize. The less crowded places on the sunny side were occupied by busy knots of press reporters, by country folks, by a hundred or more of Andalusians, in manner and dress a grotesque caricature of the totero of hard worked artisans seeking in this wild orgie of excitement some respite from the dreary round of labor. The distinguished society of mataderos, butchers, leather dressers, tanners, the myrmidons of the slaughter house and purveyors of the fodder, seethed like a boiling pot, and the hubbub, with the fitful ringing of a bell, sounded like the spasmodic progress of a neighing and kicking horse.

The detestable medley of slang and dialects rose up like the hissing of some coarse and malodorous fry as it simmers over the fire. The chula muttered a coarse oath as she insolently forced her way through the crowd, diffusing a mixed perfume of musk and garlic; and the miserable lout whose natural destiny it was to clean tripe and bladders, being incapacitated by nature for any more worthy function in life, made a speaking trumpet of his hand to hurl a torrent of abuse, flavored with a hot vapor of raw spirits, at the president's box, where it would no doubt reach the ears of some official of the Spanish capital—the governor perhaps, or perhaps the president of the council.—"Leon Roch," by Perez Galdos.

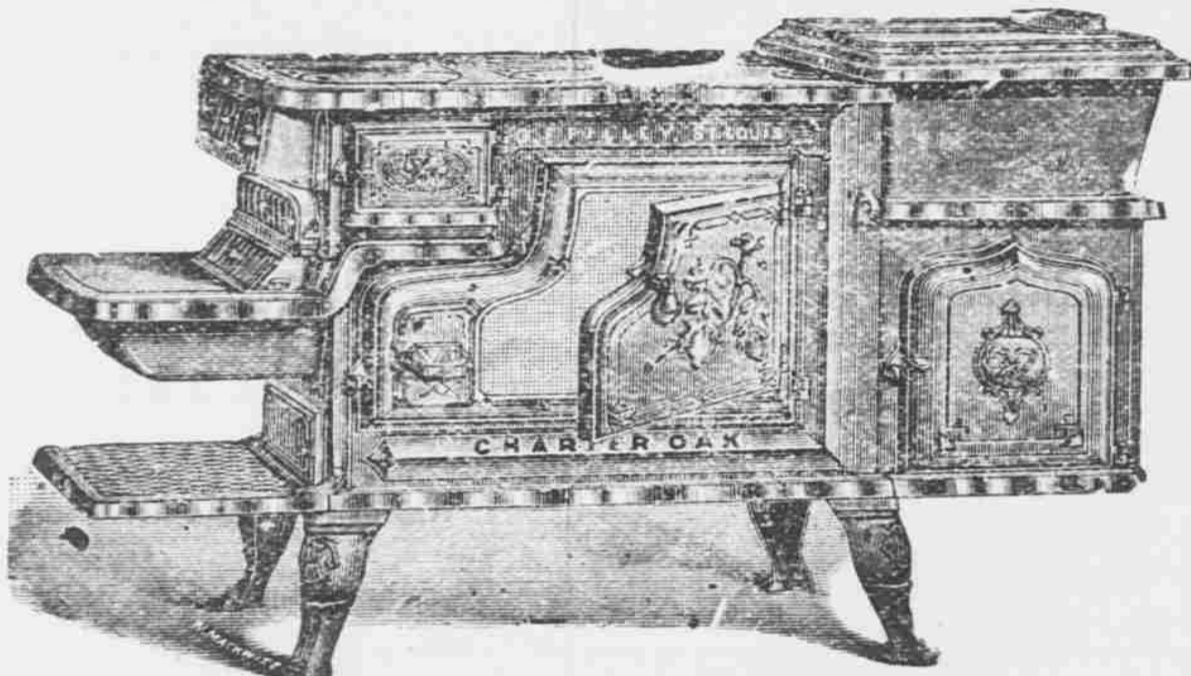
