MOLASSES FOR MULES.

We learn something every day we live and while sceptical at first we soon find that the world is progressing in a most wonderful manner. Who would ever have thought of feeding mules on molasses, except our local republicans who are trying by sweet words to get the stubborn Hawaiians into the fold of the party which represents the absentee sugar barons and the bloated bond holders. And yet we have before us an article from the Louisiana Planter, which we publish to-day and in which is shown how to bribe mules with molasses. The mules get fat on the sticky stuff, and so have local politicians done on the filthy lucre, the sweet promises and the ill-smelling stuff which has been poured out to them by the Thurston gang. The experiment is excellent and should be encouraged as far as four legged mules are concerned. The article reads:

The very short cane crop of 1899 is now developing an active demand for low grade molasses. The low prices at which molasses sold in this country for a number of years, and the fact that considerable quantities of it were thrown away for lack of a market, attracted to this market the attention of the live stock feeders of England, and immense quantities of molasses have recently been sent abroad for horse and cattle feed, our own people seeming to be comparatively ignorant of the great food value of this by-product of our sugar plantations.

The matter has been exhaustively discussed by the Sugar Planters' Association recently and it may be accepted as a fact that molasses is just as good horse and mule and cattle feed in Louisiana as in England, and it were far better to feed it here on the plantations to our horses, mules and cattle, saving the cost of shipment to the city, of barrels and re-shipment to Europe.

As molasses is a liquid food it took a long while for many of our planters to get ready to use it. It was found that the best way to give molasses to live-stock was to give them a free supply of it, always accessible and they would then gauge the quantity to be eaten by their own inclination and no harmful results followed, whereas the animals fatten and become sleek and glossy in appearance, and the general effects are very satisfactory. As this season there will be less than one-half the normal supply of low grade molasses, there will be very little offered for sale, unless our sugar planters should find prices so high as to justify them in selling what they have and buying grain foods to take the place of it. We think that even this, if it were done, should be done with great care, as molasses is a far better stock food than most people appreciate, and its use by our working animals to the extent of five or ten pounds per day per animal can hardly be replaced in excellent results by any other food, excepting oats.

TOPICS OF THE DAY.

When the yellow journals and bogus politicians get ready for a war between Germany and the United States something will drop at the presidential election and the unexpected happen. We trust that there are some sensible people in Uncle Sam's domains.

Lieutenant-Commander Lucien Young has been appointed commandant of the Naval Station in Havana, Cuba, and is also Captain of the Port. Veracity is evidently not wanted as a qualification for promotion in our naval department. But then any old lie is good enough for Cuba.

The war in the Philippines is *pas* "officially." It is a pity that good American soldiers are still finding their graves in those islands from bullets and sickness although the war is no longer "official." It is a funny country we belong to now, and only the Advertiser blames the Hawaiians from hesitating in flocking under the Republican banner of McKinley, the official "warrior" of the White House.

We are pleased to see that the immigration laws of the United States will be extended to the Territory of Hawaii. At the same time we feel sorry for Mr. Thurston's organ which predicted a few days ago that the Washington Government, not "Colonel" Testa's legislature, will settle the labor question in Hawaii. We do not know what "Colonel Testa's legislature" is, but perhaps the sugar barons would prefer it to the immigration laws of the United States.

Honor the Veterans.

At a meeting of the Grand Army of the Republic held last night the preliminary preparations were made for the annual observation of Decoration Day.

Mr. Harold M. Sewall will be asked to deliver the oration and it is expected that the local government will show the usual courtesies due to the memorial day. The program for the procession is as follows, subject to changes:

Chisholm Expires.

Alexander Chisholm, the prominent harness-maker died this morning at the Queen's Hospital, the immediate cause of death being remittent fever. The deceased was taken to the hospital two days ago and was a very sick man when he was admitted. He was a native Pictou in Nova Scotia and was 56 years of age. He had resided here during the past 18 years and was the managing partner of the Manufacturing Harness Co. on the old corner of Fort and King streets. He was a man of great ability in his special branches of the trade and Chisholm "saddles" were always in demand. The funeral will take place at 4 p.m. from the undertaking parlors of Henry Williams.

Bolte's Resolution.

The resolution of Councillor Bolte, having reference to the Court of Claims passed by the Council of State in session, has been brought to the attention of the Attorney General of the United States, as the following communication indicates:

Tempting Trophies

There are on exhibition at the Criterion two beautiful silver cups which will become the property of the owners of the fastest horses in two races on the Kapiolani track. One is inscribed, Criterion Cup, by C. J. McCarthy, for the winner in the 1 1/2 mile running race free for all—even Republicans. The other is presented by Colonel McCarthy on behalf of the Seattle Brewing and Maltng Company which furnishes the town with the celebrated Rainier beer. This cup is for the winner in a harness race and will probably not be set up for competition this year as there is no prospect of any very interesting trotting or pacing event.

The cups are designed in a very artistic manner and their capacity seems ample. It was suggested to the colonel to make a test of the quantity which the cup can hold, but the gallant soldier shook his head, looked fondly at six cases of champagne just arrived and with a Democratic wink said "nit." Hence we are only able to speak of the beauty of the outside of the cups.

Death of Mrs. Joy.

Mrs. Amalia Joy, a well-known Hawaiian lady died suddenly last evening at her residence on Liliha street, aged 44 years. The many friends of the deceased were shocked by learning of the death of Mrs. Joy who had at no time been considered seriously ill.

Mrs. Joy was the oldest daughter of the late Jacob Holck, who was a well known wheelwright in the early fifties in this city. When a young girl she married Michael Joy, who left in his vocation as a whaler and has never been heard of for about twelve years, and one young son remains of the union. Mrs. Joy was a member of the choir of the Catholic Church and took a deep interest in all matters pertaining to the church as well as to the political welfare of Hawaiians. The funeral will occur at 3 p.m. to-day and will be conducted by E. A. Williams from the residence and from the Roman Catholic church for interment at the Catholic cemetery.

The Full Penalty.

William Ester the negro convicted of the killing of Toyo Jackson was sentenced to imprisonment at hard labor for 20 years by Judge Stanley in the Circuit Court this morning. The incidents in connection with the killing of Jackson and stabbing of his companion, Cockett, are still fresh in the minds of the public. Ester was charged with murder but owing perhaps to the eloquence of his attorneys, Messrs Creighton and Straus, and to the fact that the evidence was wholly circumstantial a verdict of manslaughter in the 1st degree was rendered, and the man received the full penalty of the law.

THE DEMOCRATS MOVE.

The Committee of Twenty one Pass Important Resolutions.

The Democratic Committee of 21, at its meeting at Dr. J. S. McGrew's residence on Hotel street last night, adopted the following as its recommendations to a Democratic mass meeting to be held on the evening of June 2d:

Resolved, That this committee recommends to the Democrats of Hawaii the election of a delegate to represent them in the National Democratic Convention, to convene at Kansas City, Missouri, July 4th next.

That for this purpose and for the purpose of perfecting a permanent organization of the Democratic party, the committee recommends that a territorial convention be called to meet in Honolulu Monday evening, June 11th, at 8 o'clock. That this convention shall be composed of 90 delegates apportioned among the several representative districts as now constituted, as follows: First, Second and Sixth Districts, 12 delegates each; Third, Fourth and Fifth Districts, 18 delegates each.

That the Democrats of the other islands be requested to take such steps to be represented in this territorial convention, to be held June 11th, as the time and circumstances will permit. That it is desirable that every island and every district should have its full representative voice in this convention, and to that end delegates from the other islands, where the time and opportunity for formal organization may not be as convenient as on the island of Oahu shall only be required to show such credentials as would usually be required in a mass convention.

That for the purpose of selecting delegates there shall be held in the Fourth and Fifth Districts, constituting the island of Oahu, primary elections in the several precincts on Thursday, June 7th, the polls to be open in each precinct from 5 to 7 o'clock p.m. That at such election every person who by terms of the territorial act is a citizen of the United States and of the territory of Hawaii, or eligible to become such upon the going into effect of that act, and who intends to act with the Democratic party and signs an enrollment to that end, shall be entitled to vote.

That this committee of 21 take immediate steps for the holding on precinct primaries in the several precincts of the Fourth and Fifth Districts, reporting the same with request that they be approved, to a Democratic mass meeting to be held in Honolulu, Saturday evening June 21.

That at the precinct primaries for the Fourth and Fifth Districts there shall be elected the following delegates to the territorial convention: In the 4th district, the 1st, 3rd, 4th, 5th and 6th precincts, 2 delegates each; in the 2nd, 3rd and in the 7th, 1. In the 5th district, 2 delegates from each precinct.

That this committee recommends that an executive committee of 21 be selected whose duties and term of office shall expire at the first territorial convention to be held June 11 next.

The following sub-committees of the committee of 21 were then appointed: To prepare report for the mass meeting—J. M. Camara, E. H. Hart and C. L. Rhodes. On address to the people of Hawaii—E. B. McClanahan, J. E. Bush and J. Effinger. On plan of enrollment—C. J. McCarthy, Jas. Quinn and W. H. Johnson. On finance—C. J. Campbell, W. S. Withers and J. D. Holt. On public meetings and speakers—Frank Brown, J. J. Eagan and J. S. Martin.

The following was also adopted: Resolved, That this committee of 21, appointed by authority of the Democratic mass meeting held in Progress hall Wednesday evening, May 16, on behalf of the Democracy there represented tenders to Mr. C. S. Desky its sincerest thanks and appreciation of his courtesies in offering the use of Progress hall for the holding of that meeting; that this ex-

HOW TO SERVE WINE.

Sweet Wines should be served at cellar temperature, say from 50° to 60°.

Famine's Ravages in India.

BY THE REV. J. E. ABBOTT.

In India three millions of people
are being fed by the government.
The famine area covers a very large
extent of the country. Fifty million
people are involved in the section
where the famine is the worst. On
November 1 there were about four
hundred thousand on government
relief works; on December 20, ac-
cording to Lord Curzon's cable,
three million were receiving relief,
and the number is still increasing.
But three million on relief works
means many more millions who are
fighting with the very last extrem-
ity of want in various degrees of
suffering.

The prompt measures of the gov-
ernment, the generosity of native
and European men of wealth, the
untiring efforts of missionaries, all
have thus far supplemented the re-
sources of the people, so that but
few have as yet starved to death,
but the emaciated bodies of men,
women and children are beginning
to be seen; despairing parents have
been met with offering their chil-
dren for sale, and abandoned chil-
dren have been found. Thousands
are living on the fruit of the cactus
plant, a fruit fit rather for animals
than men.

This condition recalls the famine
of 1897—the crowds of emaciated
people, walking skeletons, fainting
for food and bitterly crying for help;
children whose heads were mere
skin covered skulls, whose bodies
were abnormally swollen from their
ravenous eating of every indigesti-
ble stuff that helped to quiet the
pangs of hunger, and from drinking
large quantities of water for the
temporary relief of hunger's pain,
their legs and arms but skin covered
sticks, just able to hold up their
bodies as they staggered along in
their terrible weakness.

It was under such stress that
childhood came in for its most terri-
ble suffering. This was especially
true of the central provinces, where
neither government nor private help
was able to cope with the emerg-
ency. Parents died of starvation
first, because they denied themselves
for their little ones, their children
lingering on longer, and in their
death becoming a prey to the wolves
and jackals.

Aside from what the government
did, ten thousand such poor, famish-
ing, dying little ones were saved
by missionaries and their agents.
By carloads they were sent to differ-
ent schools, where kind hands
washed their sores—the terrible
sores that famine brings—carefully
fed while their ravenous, unnatural
hunger was upon them, and gradu-
ally brought to life and health
again.

The cause of the present famine
is the absence of rain. In good years
the fertile soil yields two crops, and
on his acre of land a farmer man-
ages to live and support his family,
but his resources are very limited.
A bad year reduces him to extrem-
ity, and a total failure of rain to
starvation.

Next to government, the best or-
ganized agent for saving life and
relieving suffering is the missionary
body. With their native agents,
preachers and teachers working as
they do in the large cities and the
country villages, their operations
cover a very large part of the famine
area.

The district occupied by the Amer-
ican Board in the Bombay Presi-
dency is rapidly becoming one of
the worst centres of the famine, and
cablegrams and letters appealing
for means to help the people are
coming from the missionaries of the
American Board. The secretary of
the Marathi Mission cables from
Ahmednagar, "Sore famine," and in
a letter says: "We are at the begin-
ning of what is likely to be an awful
famine. If you have opportunities
to awaken interest and to lead peo-
ple to send funds please do so."—*N. Y. Herald.*

Siamese W. men.

The following story is told by the
Malay Mail in explanation why the
women of Siam wear short hair:—
About 200 years ago the Burmese,
their life-long enemies, were besieg-
ing their capital city. The fortunes
of war were going badly for the
Siamese, when the women cutting
off their hair, donned male attire
and made such a brave show on the
ramparts that the invaders drew off,
and so short hair remains the fash-
ion to this day. The explanation
that was current in Bangkok twenty
years ago, and even later, was that
the respectable women cut their
hair short to distinguish themselves
from the Aspasia of the capital,
who gloried in their flowing tresses.
But whatever its origin the custom
is a very old one.
