NEUROLOGIST HERE TO COMPLETE SURVEY

Also arriving on yesterday's flight from Guam was Dr. K. V. Mathai from the U. S. Department of Health Education & Welfare. Dr. Mathai is a neurologist on loan to the National Institute of Health Research under the U. S. Public Health Services. He has been in Guam for the last ten months conducting survey of neurological disease, **PARALYTICO**, reportedly 100 times more prevalent in the Mariana Islands than anywhere else in the world. He is visiting Saipan to complete the same survey being carried out by Dr. Torres from Guam.
