A BRIEF HOMILY ON UNION.
How much better would the condition of this country be if there was more unity of purpose and effort in the direction of improvement. Union is strength; dissension is weakness. Union is not a distinguishing feature of the Hawaiian community, dissension is. Exact agreement among the people of any community is too much to expect, and to look for it in a mixed population like ours is quite out of the question. The world has not reached that stage yet, and there is no prospect of its doing so in the near future. If all men were thoughtful and reasonable it would not be hard to secure closer agreement than now exists. Our community is peculiar in being made up of many nationalities, races, and peoples of different languages. It is natural enough, under the circumstances, that there should be divisions into parties and sections. But this should not constitute ground for discussion and antagonism. The whole people—the native of the soil and the foreigner who has made the country his home—have a common interest. Good laws efficiently administered, and the public revenue wisely and economically expended, are for the good of all. There should be no wide divergence of opinion among intelligent men as to what constitutes, in the main, good laws, efficient administration, and wise expenditure. Here then is ground for general agreement. A disposition on the part of the community to union on this broad basis is not very apparent. Proneness to give persons the precedence of principles, and to favor or oppose men rather than measures is more conspicuous. This is not creditable to our intelligence, and until there is a change in this particular we shall hope in vain for any marked improvement in the general management of the country.

THE HAWAIIAN ISLANDS—A SANITARIUM.
The Hawaiian Islands are, during the course of the year, visited by numbers of persons from California and the surrounding States, with a view to "take in" the archipelago that they call the Sandwich Islands. Visits of this nature are for pleasure, but we also have visitors from the Eastern, Middle, and Western States, who come to this "Paradise of the Pacific" in search of health. Old and young alike know full well the balmy and soothing nature of the island atmosphere, second to none in the world. The ozone in the suburbs of Honolulu is inhaled with a freshness that revives the weak and sickly, while the strong and healthy derive an invigorating and strengthening tonic therefrom. In fact, Honolulu is a sanitarium for the Western Hemisphere, as Madeira is for the Old World, or Eastern Hemisphere. For pulmonary affections, the climate cannot be surpassed, but while it possesses all the advantages above stated, and while its praises cannot be too loudly sung, there exist reasons why a certain class of people should not come here. The confirmed and pronounced consumptive, of whom there is little

hope of recovery, cannot expect to be cured by a flying visit to the Islands. Those afflicted with throat or lung diseases, may have their troubles alleviated, or their lives prolonged, and may in many cases, be restored to perfect health, but those who are in an advanced stage of consumption, would probably be better off by remaining at their respective homes, where they would receive the kindly attentions of a dear mother or a loving sister, than risking the sea voyage and landing on the wharf with but a few dollars in their pockets, unknown, uncared for, and probably without any letter of introduction to good society, the young man naturally feels lonesome, deserted, and dejected. At times a Christian friend will take such a one by the hand, and listen to his pitiful tale, and being impressed with the earnestness of the visitor's story, this Christian friend will take the stranger by the hand and lead him to the Y. M. C. A. Secretary Fuller is always ready to hear the sad tale repeated. He promises aid to him who is unfit to work, and through his representations to the Ladies' Stranger's Aid Society and other Benevolent Associations the invalid is well cared for. His first and best home in this city is found in the Queen's Hospital. He there drags on a wearying existence, sometimes failing and sometimes convalescing. His last dollar is gone and he lives on pure charity, the virtue which ranks first and highest among the many of Christian virtues. The winter season sets in, and he (the invalid) dreads returning to his home. It is too late. The cold weather of Montana, Virginia City, Chicago, New York, Boston and the higher latitudes would kill him. And thus he becomes a burden to himself, a tax on the charity of strangers, and ultimately dies far away from those near and dear to him by the ties of relationship, who are best able to comfort and soothe him in his declining and dying hours. All such invalids, in a far-gone, hopeless condition, would do better to stay at home and bear the ills they there have, than come here to those they know nothing of.

HILO NOTES.
The lumber thrown overboard from the barkentine Amelia, was saved, for the most part, in good condition. It was sold at auction last Saturday, just as it lay in piles along the shore, on the Waimaku side of the Bay. Mr. J. A. Scott bid it in for the Hilo Sugar Company, at \$355. Bidders were plentiful, and bidding was lively. The friends of Mr. S. L. Coan will be sorry to learn that his protracted sickness is not likely to end in recovery. His strength is failing, and his friends here are in despair of his life. The barkentine Amelia was a pretty sight as she sailed out of port last Tuesday morning. The wind was fair, and she departed under full sail. The brigantine Hazard is still in port, awaiting cargo. The Salinas is daily expected. She has never been here, but Hilo people will be glad to welcome her, especially as she is commanded by Captain Watson.

KAUAI NOTES.
After the quiet of the past few months, the bustle around the Lihue Mill makes a pleasant change. A constant rumble of bullock carts and snapping of whips, along the highways, show that grinding is well under way, and one cart is followed by another, heavily laden with cane. Cane is hanging up to dry on nearly every native house and the women are busy weaving hats.

Grinding has also commenced at Hanamaulu Mill. The roads are again in excellent condition. Kaula, Dec. 10, 1886.

HAMAKUA NOTES.
Six Japanese, who assaulted the Luna at Paunilo, contributed each \$25.00 to the Hawaiian Treasury. They retaliated by having the Luna arrested, but afterwards withdrew the charge. Several of the principal natives have gone from here to Kohala, to meet the new Governor, who is expected to visit this district in a few days. The steamer Ivy Holmes arrived here from Hilo, on last Monday, with a full cargo of general merchandise for Holme's store, and had a rough time getting it landed, as she could not communicate with the shore for two days. This morning the Captain sent his mate ashore for something to eat. He stated that they had been out of provisions for two days, and that as Captain Cooke was only paid \$8.00 for the round trip, he could not afford to carry much provisions. I understand that Mr. Jas. Lidgate, who has leased the Kawela land from Hon. S. Harker, is now trying to form a Joint Stock Company, with a capital of \$200,000, to plant cane and put up a mill.

There is no finer land on the Islands for cane than Kawela, but it is rather limited in extent. Honokaa, Dec. 9, 1886.

Light showers fell yesterday afternoon, sufficient to dampen the dust, and no more.
The steamer Iwalani from Kau, Maalaea, and Lahaina will be due here to-morrow.
The brig Hazard has gone to Waiakea, to finish discharging. She will wait there for sugar.
A big hole is reported in Nuuanu Valley road, about one mile and a half this side of the Fall.
The regular meeting of the George W. DeLong Post, G. A. R., will be held at 7:30 to-morrow evening.

The Rifles drill in squads on Monday evenings, and in company on Thursday evenings. Any person wishing to witness the drill are liberty to enter the building, and sit anywhere not in the way of the maneuvers, at any time.

HORSE-BREAKING is a necessity, but to undertake to break a horse on Merchant street, in a California brake, will, if continued break somebody's neck. This morning a case in point came before our reporter's notice, and he considerably withholds the driver's name on this occasion, but should it recur, the BULLETIN will come out flatfooted and give the public the benefit thereof.

A GENTLEMAN said, during the fire in the building of the Pacific Navigation Co., the other night, that there must be two more fires soon to complete the belief that one casualty is generally followed by two more of the same nature. Sure enough, two fires, such as they are, have occurred since then—one in the steamer Mokoli last night, and another almost at the same time in Mr. Ramsey's lodging house, on Hotel street. The latter fire was caused by a lamp flaring up igniting a mosquito curtain; but was put out without the assistance of the Fire Department.

INAUGURAL XMAS SALE.
The inaugurating auction sales of Christmas week were held on Saturday night. On Queen street Mr. Lewis J. Levey stood up before the public, including many ladies, and with his accustomed liberal generosity knocked down a variety of wares, "too numerous to mention," to quote a pet phrase of the auctioneers. On Fort street, at the Temple of Fashion, Mr. Lewis, acting for Mr. Lyons, did not exactly hold his immense audience spell-bound, but to the contrary, by his persuasive powers, he caused them to buy, at fair prices, the useful articles he offered.

A CHRISTMAS SLIPPER.
Even Dr. Morgan, the celebrated carriage doctor, Nos. 79 and 81, King street, has a specialty for Christmas. While the doctor was engaged in making an attachment to one of the pedal supports of a horse, this morning, a bystander asked what he was doing. "Doing?" replied Morgan, "Well, I am doing what every man can't do: I am putting a pair of Christmas slippers on this animal. All the tradespeople have something new for the holiday season, so I thought I would introduce a horse-slipper, appropriate to the occasion and suited to the condition of the roads. It is a splendid article, and makes a horse as proud as a peacock."

A SMASH.
W. Richardson, hack-driver for the Pantheon stables, wrecked his carriage on Nuuanu road yesterday. He was coming down the valley, when the shafts broke. Richardson patched the shafts, and started again, only to wind up with a crash that almost completely ruined the carriage, and came near killing the two passengers that were in it. The horse, with the shafts, made for the stables, while the carriage, a heap of ruins, remained on the road until taken to Page's for repairs.

FIRE ON THE MOKOLII.
At about 8 o'clock last evening, the gong at the Bell Tower sounded an alarm of fire. The fire was aboard of the steamer Mokoli, lying at the old Custom House wharf. The Fire Department was quick in response to the call. Number 2 engine, drawn by horses, was the first on the spot and quickly got a stream from the bay. The blaze, which was very slight, was in the paint locker of the steamer, in the forward hatch, near the forecastle. The locker contained nothing but paint, as far as known, and how the fire originated is a mystery. The burning was first discovered by Mr. A. Turner, night watchman on the bark Bowers. He scented the smoke, and notified others of the fire. The hose of Engine Co. No. 2 extinguished the burning in a very short time, and drenched the hold of the vessel to prevent any possibility of the fire rekindling. The damage done was very slight. The freight in the hold was small and of little value.

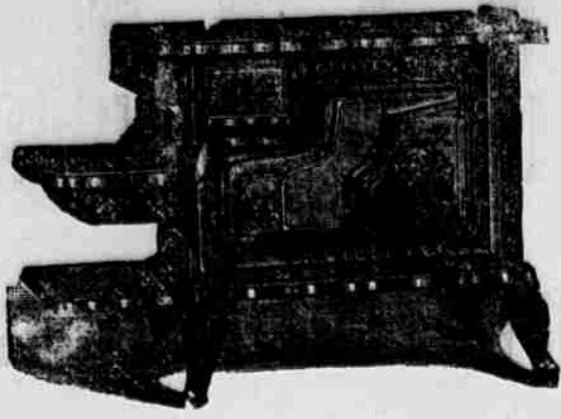

THE PRESIDENT'S REPORT.

THE QUESTION OF THE DAY. (Continued.)

Rev. Dr. A. L. Stone, after some years in California, said, "I had entertained a sort of hope that the manufacture of pure wines and their introduction into general use would crowd out the gross, strong liquors and diminish intemperance. I am now fully convinced that this hope was groundless and delusive. It is in evidence that fully two-thirds of all the wine manufactured is converted by the manufacturers into brandy. It also appears that in the wine growing districts, intemperance is on the increase, extending even to the youth of both sexes." Mr. Nordhoff, in his work on California, makes a similar statement and says in closing, "I advise no settler in the State to make wine. He runs too many risks with children and laborers, even if he himself escapes." U. S. Revenue Commissioner Wells said, "California, with her cheap wines for temperance, in the year 1867 sold fourteen times as much alcoholic stuff as Maine, and more than any other State, New York excepted."

But how about beer? Is it not true, as has been said, that "the brewers of good beer are the friends of the cause of temperance?" Shall we not vote to lower the duties on wine and beer, and to license breweries "in the interests of temperance?" I quote from a statement in a recent number of the Friend: "The report of the statistical bureau of Switzerland for 1884 gives these figures: 'The per capita consumption of malt liquors in Switzerland is about 45 gallons, in Germany, 20; in the United States, 11. At the same time the spirituous liquors consumed in these three countries are: Switzerland, about 9.40 litres; Germany, 8.60 litres; United States, 4.42 litres. Thus we see that while Switzerland consumes four times and Germany nearly twice as much beer per capita as the United States, they use also about twice as much spirits. A German professor, in an article on the increase of insanity, combats the argument that the diminution of the consumption of spirituous liquors. He shows, on the contrary, that in European countries there is a steady increase in the use of both kinds of drink. In Holland the use of spirits has increased thirty per cent. within seventeen years; in Belgium it has doubled itself in the last forty years, and in even that home of wines, France, it has risen from an average of four annual litres per head to seven in the two decades from 1860 to 1880, i. e., an increase of seventy per cent. In Prussia, between 1865 and 1880, the consumption of spirits rose from eight to ten litres per head, while that of beers rose from thirty-seven to eighty-eight litres. Dr. H. I. Bowditch, of Boston, is reported as saying of his advocacy of beer in moderation: 'It was the mistake of my life when I maintained but for a brief period, that beer was beneficial to anybody under any circumstances. I regard it not as merely worthless, but as productive of a most diseased state of the whole system, the worst that it is often not suspected until too late.'"

In 1830, a Beer Act was introduced into England, the object of which was said to be "to wean the people from the stronger liquors, by cheapening beer, by giving them a wholesome beverage." Nearly 40 years later, a very high authority says "This measure, though introduced in 1830 for the avowed purpose of repressing intemperance by counteracting the temptation to the excessive drinking of ardent spirits afforded in public houses, has been abundantly proved, not only to have failed of its benevolent purpose, but to have served throughout the country to multiply and intensify the very evils it was intended to remove." "That free beer diminishes drunkenness may be logic, but it is not fact."

Similar statistics to these have been available for fifty years. Temperance lecturers have declaimed them, preachers have told them, the religious press have published them, temperance societies have scattered them in tracts and leaflets by the million. And yet! men of influence and information to-day start up with all the enthusiasm of discoverers and assert—"There is no way to induce men to drink less gin so sure as to give them a cheaper drink which is at the same time milder. Let us make it easy for our native people here to get beer and wine and they will not ask for anything stronger." "It is not true! A man who craves gin and whiskey will have them at any cost, for a milder drink will not satisfy him. "And no man can touch alcohol at all without fastening upon himself a craving for more. The beer drunkard in the world, his chains are the heaviest and strongest."

Let us keep calm! Sooner or later the truth must assert itself. Alas that an influence cast on the wrong side can never be recalled! For many years during and after the war, there was a great lull in temperance agitation. "While

men slept, the enemy sowed tares." And then in 1873 the Woman's Crusade started and awakened the land. It was not preconcerted, it was not of human device. It was a transient movement lasting but a few months. Its effects are going to grow and grow till alcohol is banished from that fair land. But how? Will woman's prayers and tears avail? We knelt in the snow and mud at many a saloon door and poured out prayers which God indeed heard, but which were often a subject of derision to the drunkard and the drunkard maker. Shall we hold temperance meetings, and conventions, and have processions, and sing, and wave our banners? Yes, we may, but an interest thus among a few, but the traffic, the traffic, that is unmovable! Shall we offer the pledge, and invite men to sign and reform? Yes, indeed! Thousands have been rescued through the pledge, and many thousands after signing have fallen back to their cups again. And still the traffic goes on, and the saloon keeper knows well how to gain fresh recruits. But our hope is with the young. Let us organize bands of hope and young people's societies, and introduce temperance literature into our schools and Sabbath schools. There are certainly omens of hope for the future in these things. Meantime the consumption of liquor increases faster than the population, and a large percentage even of the children we cannot reach at all. Dram shops fester on every corner, the foul temptation takes every guise.
