Spain's Queer Newspaper.
(Boston Herald.)
La Correspondencia of Madrid, Spain, has the largest circulation of any paper published in the world. It is read by it, and, from the universality of its perusal, it is facetiously called the "Spanish night cap," because no one is supposed to have gone to bed without having read it entirely through. And it must be read through, for it is the most extraordinary hodgepodge and olla-podrida ever printed as a newspaper. It is a newspaper rather than paper of opinion. The staff consists of a dozen bright reporters and no editor. The reporters scour the capital and pick up every item of interest, cabinet resignations, accidents to your washerwoman, the illness of the king, the latest earthquake news, the price of eggs, the opening of a new cafe, a Carlist rising in the north, the burglary of a shop, an excursion party's adventures in the mountains, the latest club scandal, the running away of a horse, a convention of wine merchants—everything, in fact, that occurs and can be printed and put in print. This is La Correspondencia.
The reporters bring in their news like so many bees coming home honey-laden. They put their copy, written at the clubs or hastily penciled in memorandum-books on the streets, into a black leather bag at the office. When the composing-room runs out of copy to set, the foreman goes to the black bag and helps himself to a handful of manuscript. It is all set and all printed without any regard to order or typographical display. You read it because you know that in its crowded columns is everything of note occurring at the capital. You read every line, for if you skip at all the very bit of news you want may be the one skipped. The circulation of this paper is rated at 200,000 daily, and on occasion at 300,000. It is the vivid portrait of Madrid life, the doings of the world of Spain are pictured in its pages. Nothing is too small, nothing too great for the reporters of La Correspondencia. It is the ideal newspaper, composed of news pure and simple.

Roller-Skink Photographs.
(New York Cor. Chicago Journal.)
There is a man hindered in his quest of profit in an original branch of the photographic art. He struck the bright idea that instantaneous views of roller skaters, especially fancy poses of disaster, would be funny enough to sell. Do you recall those nonsensical cards showing, in rather rude lithography, the delight of a newly-made father gradually merged into despair as he learns that not twins but triplets have happened to him? That device caught the popular eye so effectively that a profit of \$3,000 was realized by the originator.
I mentioned this to show how reasonable it was that the photographer should calculate on paying on a mortgage on his house by means of his pictures of rink incidents. A hidden corner of an electrically-lighted establishment soon yielded the desired negatives, but when the girls found out that their accidents were likely to be published, they threatened to boycott that rink, and the scene was suppressed. However, I write this paragraph in the confident belief that it will lead other artists to undertake the scheme under favoring conditions. Believe me, no pencil could draw so picturesquely as the camera can reflect the phases of fun and sentimentality to be seen in a skating rink.

Crime in France and Italy.
(Foreign Letter.)
Dr. Bourne's recent work on crime in France and Italy seems to show that in France crimes against the person are increasing somewhat, while those against property are diminishing. In Italy "crimes of the blood" are three times more numerous than in France, and murder is six times more frequent. Assassination is slightly increasing in France. In Italy the number of parricides is about double that in France. In both countries there is a notable diminution in criminal poisoning. Attempts against chastity are much less frequent in Italy, and in France these "crimes against children augmented in frightful proportions." Infanticide is twice as great in France.

The native Hawaiians are a pleasure-loving race. They love sunshine, and are passionately fond of song and dance. Why not encourage the innocent gratification of these natural impulses? They are according to nature. They were born in the race, and are part and parcel of their very being.

Wherefore, we infer that the native race might be elevated morally and socially, and most certainly physically, by encouraging them in outdoor sports and amusements. Let them gratify their natural impulses; but let it be in the light of day, under the eyes of public criticism, and not in the holes and corners, as now, surrounded by the darkness of night and the more profound and impenetrable darkness of vice and infamy.

The conclusion we come to, therefore, is that there is too much leisure time and too few public holidays in this Kingdom. The amusements of the people come properly within the domain of public morals. It is not for us to suggest any plan of popular amusements, however. We fulfill our duty as journalists to point out a grave defect in our social system, and to suggest that there would be infinitely less drunkenness, vice and crime in the community if there were more frequent opportunities for rational public enjoyment like that at Kapiolani Park yesterday.

KAMEHAMEHA DAY.

A Full Report of the Races on the Eleventh of June.

Races, Horses and Riders Described—Scenes and Incidents of the Day.

The races at Kapiolani Park came off as advertised, and were largely attended.

The day was an exceptionally fine one, a gentle breeze from the hills, where light showers hung all day, tempering the heat of the sun. Long before the hour announced as the time of starting, the road to Waikiki was thronged with carriages, people on horseback, and not a few on foot, all with their faces set seaward.

By 10 a. m. the grand stand and the private stands were well filled, and precisely at 10:30 the judges and timers took their places.

Captain Brown rang the signal on the bell repeatedly, but nothing could induce those in charge of the horses entered for the first race to forego the customary delays. The entries as announced in the programme were as follows: GRAZIER'S PLATE—\$100. Running race, 1/4 mile dash, open to all, weight for age.

Of these Ivanhoe and Poni Moi were withdrawn, and of the remaining three Hancock was decidedly the favorite, though on account of the difficulty his jockey had in getting mounted, the horse came near being ruled out of the race.

The result of this race was a surprise to all, and it was agreed that it was one of the best ridden, most satisfactory race of the kind run on this track in some time. Hon. Sam. Parker, the owner, was congratulated on the triumph of Col. Gift. Quite a lot of money changed hands on this event.

The second heat of the trotting race was then run, and won by Fannie in 3:30, Honest John being close behind. Each horse having won a heat, it became necessary to run the third. After a long wait the horses came on the track, and were sent off well together. Fannie gained on Honest John, and at the half-mile pole was six lengths ahead. John broke after passing the half-mile pole, and Fannie came home the winner, nearly shutting out her opponent. Time of this heat, 3:30.

The trotting race being concluded, the judges announced that there would be an intermission of thirty minutes for lunch, and everybody made a rush for where eatables were to be had. Not a few who came in their own carriages brought well-filled hampers with them, and still others bought sandwiches and soda water at the booths, and dined al fresco under the shade of the algebras scattered about.

In the booths themselves a crowd gathered about the tables, and symmetrical pyramids of sandwiches, hecatombs of fowls, and massive hams melted away before them. Mr. Wiseman saw to it that the officials on the judges' stand and the representatives of the press were well cared for, and when the bell sounded to call on the horses for the next event, the haze from thousands of cigars and cigarettes hung in a fragrant veil over the course.

In this race Kittie S. was withdrawn, leaving Jennie B. and Jim Dodd. The latter won the pole, and the two made a fine start, and at first kept well together. Excitement ran high as they neared the finish, and the shouting and cheering was tremendous as the namesake of the proprietor of the Pantheon stables galloped lead Jennie B. under the wire, doing the three-quarters in 1:23. The filly was but a second or two behind, the performance of both horses being very good for Hawaiian 2-year-olds.

Just previous to this race, while the horses were being exercised, one of the trainers persisted in getting on to the track, when he had no business there, and was ordered off by the judges, and forbidden to come on again during the day. The fifth race was as follows: KING'S PLATE—\$150—Trotting race; mile heats; three in five; open to all.

The next race was for the Reciprocity Plate. The following entries were made: RECIPROCITY PLATE—\$200—Running race, 1/4 mile dash. Free for all. Weight for age.

THE "NUMBER CRAZE."

A Railroad Brakeman's Monomania—in the Asylum, "Clean Gene."

Two railroad men were talking over old times. Inquiry was made as to what had become of an old freight brakeman named Jack Taylor.

"Didn't you ever hear about Jack? No? I thought everybody knew what he came to."

"No, but he might as well be. You see, Jack got the number craze. He got 'em bad, too, and—"

"The what?"

"The number craze. You don't know what that is? You eastern railroaders don't seem to know much of anything."

Well, Jack got 'em, his being the third case I ever heard of. Seven or eight years ago they took hold of Jack, and they kept growing worse. In 1879, I believe it was, he first started out to find the number of the year.

Long about the middle of the summer he found it. Then he was happy. But New Year's Day he started hunting for 1880. He looked all summer and all fall. Finally cold weather came, and would you believe it? Jack would sit on the top of the cars in the freezingest weather, looking for a car numbered 1880.

When ever we passed a side track he'd look at the cars like a wild man. He got so crazy over it that he nearly lost his job. Christmas Day he found his car, but New Year's Day he started looking for 1881.

You see, he got to believing that if he didn't find a car numbered the same as the year before the year was out he would die before the next Easter. We couldn't talk it out of him. In 1881 he had good luck, and found the number about July.

"But in 1882 he had no luck at all. Long the last of the year he hunted day and night. Instead of going to bed he would take his lantern and go up and down the tracks in the night, looking at the numbers on the cars. After Christmas he got frantic, and we saved him only by taking an old car and painting the number over for him, and so he went over to the other roads where they didn't know him. When the New Year bells rang out at the end of 1883 Jack was running up and down the tracks like a maniac. He is now in the asylum—harmless, but clean gone. He didn't find a car numbered 1883."

Costa Rica's Coffee Crop.

(Port Limon, Cor. Inter Ocean.) The coffee of Costa Rica is of a superior quality to that of Rio, but here, as in the other States fronting the Caribbean sea, the best grades are shipped to Europe, and only the poorer quality to the United States.

The natives think we have queer tastes in North America to buy their bananas and let their best coffee go to Europe.

It requires four years for a coffee plantation to reach a productive condition, and six years for it to yield a generous crop, but the plants will be a quarter of a century without being replaced, and as the young shoots require protection from the sun the rule is to set out bananas and coffee trees together, the swift growing and broad-leaved banana furnishing shade, and at the same time yielding a revenue until the more slowly growing plant comes to maturity.

The coffee plant resembles the osage orange in appearance, and bears a red berry like the cherry. This is carefully picked from the little trees and placed in water to rot. When it has soaked for a certain time the planter puts it into a crushing machine which grinds off the pulp and leaves the seeds, which are carefully sorted into their proper grades by bright-eyed and sweet-tempered girls. Although Costa Rica has but 300,000 inhabitants, the coffee product last year was 40,505,000 pounds. The quality is said to be the best produced in Central America, and the product greater here in proportion to the number of trees than in any other State, Guatemala being the most formidable rival. Here, among the 300,000 people, are 7,450 plantations, with 23,449,000 trees, while Guatemala has 30,084,000 trees. The product of Costa Rica last season was, however, 40,505,000 pounds, valued at about \$4,000,000, while that of Guatemala, with almost double the area cultivated, was only 38,425,000 pounds, valued at \$4,000,000.

Of this crop 16,500,000 pounds were shipped from Costa Rica to England, 8,280,000 pounds to the United States, and 5,729,000 to France. The finest grades always going to the latter country. California takes about one-half of the shipments to the United States. It costs about 2 cents a pound to raise coffee and prepare it for the market, and it sells for 10 cents a pound in New York. Of this sum about 5 cents a pound goes for freight, commissions, and handling, so that the actual profit is about 5 cents to the planter.

The Beggar Musician.

(The Argonaut.) The Argonaut tells the story of a beggar, who presented himself regularly at a certain coffee house with a clarinet under his arm. "Will you allow me, gentlemen," said he in a humble tone of voice, "to play a tune? I am only an amateur, and if you prefer giving me a trifle, I will spare you the annoyance of listening to me."

Every one felt at once for a few stray coppers, and the musician departed with a profound reverence. This he repeated several evenings in succession. At last, one evening, a young man who had never failed to contribute to the wants of the itinerant musician, asked him in a friendly manner to give him a tune, let it be good or bad; he wanted to hear him.

"But I am afraid, sir, I shall disappoint you."

"Never mind that; give us a tune."

"But I am a very poor player, and I have a very poor instrument."

"No matter for that; I want to hear you."

"Well, sir, since you insist upon it," said the poor man, "I will tell you that I don't play at all. I carry this clarinet merely for the purpose of threatening the people with my performance."
