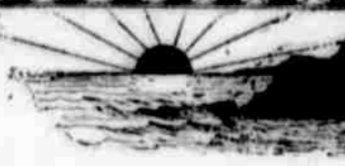

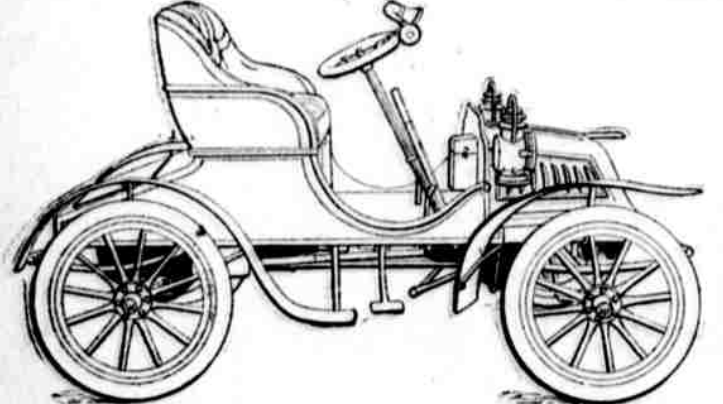

HILO LIQUOR CONFERENCE.
 Under directions from Governor Carter, Sheriff Andrews of Hawaii has held a conference with representatives of liquor houses in Hilo with reference to illicit liquor selling. Governor Carter has announced that the wholesaler is responsible for the prevalence of illicit dealing, and he has taken a stand that licenses of wholesale houses will not be renewed where it appears that the jobber is making sales to unlicensed dealers, says the Hilo Tribune.

PEACE IN FEBRUARY.
 London, Dec. 17.—It has been persistently said in the highest financial circles in London, which are the best means of gaining political information, that the Russo-Japanese war will come to an end in February.
 There was nothing visible on which to base this optimistic view until today's report that King Edward, the Czar, Emperor Francis Joseph and the Kaiser would meet at Copenhagen this month. There may be nothing in it, but the Russian situation is no hopeless in the immediate future, both in its military and internal features, that one wonders whether a good opportunity to make peace such as might be avowed at a conference of that kind would not be seized with gratitude by the Czar.

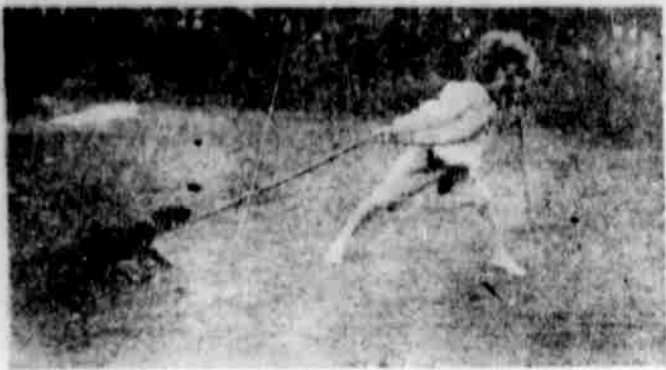

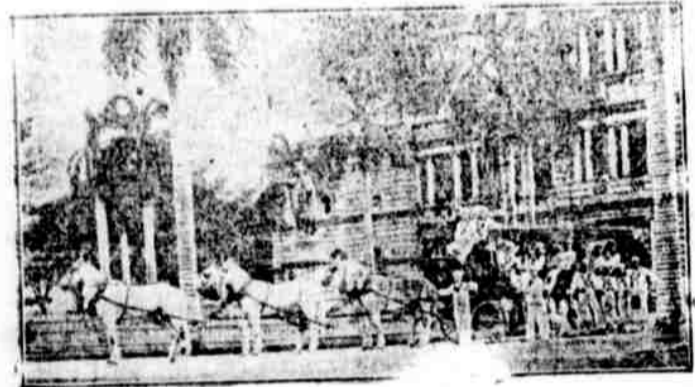

Waikiki Breaks Loose In Celebration But Police Interfere

The new year was celebrated with considerable energy out at Waikiki yesterday. As a matter of fact, the happy day caused the celebration to exceed the rigorous limits which the laws of the Territory provide for, and the clause forbidding the sale of liquor on Sunday was violated all along the line until the police tumbled to what was going on and put a dampness on the festivities.

High Sheriff Henry stated this morning that he was aware of the fact that the places holding hotel licenses at Waikiki were furnishing liquor to all comers yesterday. "The holders of hotel licenses have a right to sell liquor to their bona fide guests," said the High Sheriff in discussing the matter. "But they have no privilege to sell it to any other persons. If they do so they violate the conditions of their licenses, which expressly forbids such sales. With bona fide guests I mean people who have rooms at such places and who actually reside there at the time. It is not sufficient that a man who wants a drink to sign his name on the hotel register. That would be a mere evasion of the law, which the department will not stand for."

"I drove out to Waikiki yesterday and I found that things were running in a way which did not suit me in the least. While I did not stop at any of the places where refreshments are sold, in passing I could easily see that liquor was being sold freely at several places. On returning to town I told Deputy Sheriff Rawlins to go out to Waikiki and look over the situation, and to put a stop to any violation of the law which he might find. I have not as yet had any report from Rawlins and therefore can not say just what he did."

Deputy Sheriff Rawlins was seen soon afterwards. He stated that he had gone to Waikiki on a searching expedition, and incidentally the Deputy Sheriff found a state of affairs which he had not expected.

"I saw a great number of people sitting on the lanais of the place with all kinds of drinks before them. Liquor was being sold quite openly and on going into the bar room I found three or four Chinese boys busily engaged in preparing all kinds of thirst quenchers. The same sort of thing was going on in the other beach resorts. Owing to the occasion I did not want to take any action before I had found out from the High Sheriff if he wanted the places raided or not. On my return

to town I telephoned to the Waikiki Inn, the Moana Hotel and the Hawaiian Hotel Annex saying that if the promiscuous sale of liquor was not stopped within thirty minutes, I would pull the places. That stopped them.

"As far as the selling of liquor on Sunday is concerned, the law is very plain on the subject. As the law is there it should be enforced, and also for the further reason that it would be manifestly unfair to close up places which are paying licenses of \$1000 a year, and let other establishments do as they please. If a chance in the law is wanted it is up to the Legislature, which meets next month. As long as the law is on the books it should be enforced."

She parted with an anchor early in the blow and soon after the second, and last, was ward the shoals near the harbor entrance. Before grounding, however, she succeeded in taking and making her way through the coral reef to the open sea, finally getting out to the open sea.

There, being no inhabitants of Palmyra to fear, save perhaps the coconut crabs, Captain Weisbarth had no especial difficulty in taking possession. Human life has never taken kindly to the wind-swept atolls, and only the land crabs seem to have found them all that God intended they should be. From a position inside the lagoon the different islands and the work of gathering up the coconut cargo was not difficult. The return to Honolulu was made in excellent time for a vessel of the Lavinia's class.

Captain Weisbarth says he does not know where he will go next. He is intimated, however, that he was expecting something to turn up in the direction of Laysan Island.
