

MOST AWFUL WAR IN HISTORY

WAR NEWS BY THE MONGOLIA

BURYING OR CREMATING THE DEAD IMPOSSIBLE AND SANITARY CONDITIONS BECOME TERRIBLE—SHELTERLESS SOLDIERS IN A HORRIBLE PLIGHT AND A GREAT STORM SETTLES OVER MUKDEN IMMEDIATELY AFTER BATTLE.

"I SIMPLY DREAD THE OUTCOME OF THE PRESENT WAR BETWEEN JAPAN AND RUSSIA. IF IT CAN POSSIBLY BE SETTLED WITHOUT ANY EUROPEAN COMPLICATION IT WOULD BE, COMPARATIVELY SPEAKING, ALL RIGHT, BUT I CANNOT SEE HOW THAT CAN BE AVOIDED. I AM ABSOLUTELY CERTAIN THAT SOMEHOW OR OTHER THE POWERS WILL BE INVOLVED AND THEN WILL COME THE MOST AWFUL WAR IN THE HISTORY OF THE WORLD. THIS IS BUT THE BEGINNING."

Coming from persons untried in the fields of war or diplomacy these words might have but little weight, but falling as they did this morning from the lips of the veteran of all living war correspondents, Melton Prior of the Illustrated London News, they possess a worth which is not to be gainsaid.

Melton Prior is returning to London after eight months and a half "at the front." The words are quoted because what people far removed from the scene of warfare consider to be the front is as a matter of fact so far from the scene of actual operations that Prior, in common with dozens of other correspondents is returning utterly disgusted.

That he is a man well qualified to judge of matters martial may be judged from the fact that he has represented his paper in no less than twenty-seven campaigns.

"This was my twenty-seventh," he said plaintively this morning, "and it is the only one in which I have seen nothing at all."

His first appearance on the battlefield was in the Ashantee war of 1873. Then he saw the Carlist rising and in turn, the Herzegovinian, Servian, Turkish, Kafir, Basuto, Zulu and first Boer campaigns. The Egyptian war of 1882 next saw him at the front. The Sudan and Nile expeditions and the Burmese war he saw through, then came revolutions in Venezuela, Brazil and the Argentine. The Jameson raid, the Matabele war and Afridi war were all part of his lot and he went through the last Boer war from start to finish, having been one of the besieged in Ladysmith. Apart from this he has been at every state ceremony of consequence and has attended such epoch marking events as the Berlin conference, and the Delhi durbar. His last active service, before going to Japan, was in Somaliland last year.

"Utterly disgusted, is the only way for me to express myself," he repeated this morning as he leaned over the rail of the S. S. Mongolia and contemplated the green slopes of the mountain. "The Japanese have humbugged me for the past eight months and odd—of course they've humbugged every other correspondent as well, but I am only thinking of my own affairs just now—and I am going home from my last campaign without having seen a shot fired. With the others I was 'marking time' in Tokio for a sickening period. Then at last with eighteen more we were told that we were to be allowed to go to Port Arthur. But we never arrived there. We were taken close enough to hear some firing but that was all. Then we were informed that we were to join Oku's second army. It was simply exasperating. I don't think myself that any of the correspondents sent out have seen any actual fighting unless it may have been at Liaoyang, and that I doubt. At

LEFT HONOLULU VERY SUDDENLY

The rather mysterious disappearance of three well known youths of Honolulu was explained this morning on the arrival of the S. S. Mongolia from the Orient. Robert Talfer, Charles Bohan and R. C. Harris, are the trio that disappeared nearly two months ago.

It appears that the trio tired of business and other prospects in Honolulu, so decided to go out to Shanghai and try their luck in that place. They had heard that other Honolulu people had gone out and were doing well, so they thought they would take a chance. They boarded the Mongolia on rather short notice at Honolulu, and in fact failed, it is understood, to appraise their relatives of their intended departure for foreign parts.

They went ashore at Yokohama and there allowed the steamer to get away for Hongkong without them. The trio were entering for they boarded the S. S. American Maru on her outward trip and went to Shanghai and there left the vessel.

PLANTERS ADVISED TO IMPORT BATS

MANAGER LOWRIE, FORMERLY OF EWA AND HAWAIIAN COMMERCIAL, DISCUSSES A STATEMENT BY PROFESSOR PERKINS THAT BATS WILL NOT THRIVE HERE—ARE A BENEFIT TO PLANTERS IN PORTO RICO.

The Planters' Monthly says: We are in receipt of a communication from Mr. W. J. Lowrie of Central Aguirre, Porto Rico, in reference to the importation of bats into the islands for the purpose of controlling certain of our insect pests, such as the mole cricket.

Mr. Lowrie is favorably remembered as the former manager of our two largest sugar plantations,—Ewa and Hawaiian Commercial and Sugar Co.,—and knowing the conditions under which sugar cane is grown here, is well able to express an opinion upon the subject. Mr. Lowrie says:

"In the Planters' Monthly for June I notice that you have quite an article on the Changa, or Mole Cricket, taken from Bulletin No. 2 of the Porto Rico Agricultural Experiment Station, by O. W. Barrett.

"It is true that here on the south side of the island of Porto Rico there are Changas, but still I have noticed and seen very little damage done by them. Some of the old planters here, Spaniards and Porto Ricans, tell me that they were brought here years ago in cargoes of guano, but I have forgotten the name of the island they came from.

"In this connection, I notice in the Hawaiian Star of June 21, an article

NAKAPAAHU NOMINATED

THE KAUAI HOME RULE CONVENTION PUTS UP TICKET WITH ALLEGED REPUBLICAN LEADER.

KAPAA, Kauai, September 22.—The Home Rule convention was held in the court house, President D. Kalaokalani, presiding. As candidates for Representatives the convention nominated James Moke of Keikaha, S. Mekalia of Waima, J. K. Apolo of Anahola, and D. Kamehameha of Haema. L. Nakapahu was nominated senator.

Among those returning with the Home Rule campaigners from Kauai was D. H. Kahauliello, who attended the convention. Kahauliello says that Kauai is going to vote for Charles Notley for delegate. He declares that there is great enthusiasm for the Home Rule on the Garden Island, and that the proposed law to place a ten year limit on official use of the Hawaiian language is being effectively used against Prince Kuhio.

Kahauliello also says that Maui is strongly Home Rule, and will elect all the Home Rule ticket. He denies the published statement that he opposed F. W. Beckley in the convention there and says that he wanted to nominate Beckley.

Nakapahu, who has been nominated for Home Rule senator from Kauai, recently announced his change from the Home Rule to the Republican party, and signed the Republican party roll.

NOEAU SAILS TOMORROW. The steamer Noeau will not sail until tomorrow for Kauai ports. Her departure was postponed today.

IMPORTANT STEAMER DECISION

MISS GENEVIEVE DOWSETT IS AWARDED DAMAGES IN FULL ON HER CLAIM AGAINST WILDER'S STEAMSHIP COMPANY FOR THE LOSS OF A TRUNK WHICH FELL OVERBOARD WHILE BEING TAKEN ASHORE FROM THE KINAU.

By a decision handed down by Judge Dole this morning in the U. S. District Court in the case of Miss Genevieve Dowsett against the Wilder Steamship Company, the libellant obtains a verdict of \$425, the full amount claimed, and costs, for damage sustained by her on December 10, 1903, through having a trunk of hers, full of wearing apparel lost overboard while it was being taken aboard the Steamer Kinau from the landing at Makana, Maui.

The case, which in itself involves a comparatively small loss, is of the greatest importance as it establishes a precedent on the question of how far the "Vis Major" or "Act of God" is responsible for losses that may be oc-

curring at landings on the Hawaiian Islands. By this decision, at all events the steamship company cannot get off by blaming the accident on the Deity.

A further important point involved is as to the limit of liability, the defendant company claiming that in any event the plaintiff could not claim more than \$100 as it had notices posted in its ticket office and in the Kinau's state rooms stating that it would not be liable for more than this amount. As these notices were not read by Miss Dowsett and as her attention was not specifically called to the matter, the Judge holds that they constituted no part of her contract when she purchased her ticket.

SAN FRANCISCO, September 18.—The Chronicle says: Rev. HE RENOUNCED MANY COUNTRIES

ALEXANDER CRAIG, EGYPTIAN, FINALLY BECOMES A CITIZEN OF THE UNITED STATES.

The swarthy Egyptian, whose desire to become an American citizen necessitated a conference between Judge Dole and Attorney General Andrews the other day, appeared at the U. S. District Court office this morning with his witnesses in order to prove his residence in Uncle Sam's territory for the requisite period. Naturally enough when Frank Hatch came to write down the name of the descendant of the Pharaohs he was prepared to write some name like "Sheik Muley ben Hassan el Gebbas el Khartoum" and he was naturally surprised when the son of the Nile gave his handle as "Alexander Craig."

But it was when the Scottishized Nile-lander came to forswear his allegiance that he had another surprise in store, for as he figured it out, he had to sever his connections not only with the Khedive of Egypt, his former lord, but also with the Sultan of Turkey, the Susezerin of the Khedive and also with King Edward VII of Great Britain and Ireland, and of the Dominions beyond the Seas, Emperor of India, inasmuch as the British have a protectorate over Egypt and apparently intend to keep it. Alex Craig, Egyptian, bit the end of his pen as he thought over the long list of princes and potentates to whom he might possibly owe some fleeting allegiance, but he finally decided that he had struck a heavy enough blow at monarchical institutions for one day and he let it go at that. He took the oath, and there is no joy in Cairo, Constantinople or London today.

CONDITIONS AT PORT ARTHUR

CHEFOO, Sept. 10.—The losses for the past five weeks of the Japanese forces besieging Port Arthur are placed at 30,000. The entire Japanese force now surrounding the Russian stronghold is estimated at 80,000 fighting men.

General Nagi's next assault upon Port Arthur will be directed chiefly against Rihlungshan and Kikwanshan forts, which are the strongest forts on the northeast flank.

This information is derived from an unquestionable authority, who has just finished a visit over the Japanese line, around the forts, and conversed with the Japanese officer, who allowed him to make personal observations. The elevation of Rihlungshan is 350 feet.

Three hundred yards away on the same range is another hill so much lower that Rihlungshan protects it from all bombardment except that from Itzshan and Kikwanshan. This hill is part of a section which the Chinese call Palichuang in the capture of which the Japanese lost many lives. Here the Japanese have strengthened two forts previously mentioned in the dispatches as having been established. This position is the foundation for the Japanese preparations for the next general assault. The work of constructing trenches is advancing rapidly, considering the fire which the diggers are compelled to endure. Preparations for the assault of Kikwanshan are proceeding in a similar fashion, although the Japanese in the nearest battery bearing directly on this fort are somewhat more distant than those at Palichuang are from Rihlungshan.

The range of hills crowned by Kikwanshan and Rihlungshan have irregular slopes, enabling a large force of Japanese to rest securely some distance up the slope. The Japanese have tents pitched, and they are relieved every three days. Food and ammunition and other supplies are brought them at night, only for the reason that the detachments are obliged to cross a level stretch before reaching a place of safety. The Japanese trenches, almost under the noses of the Russians, now are partially constructed. The Russians endeavor constantly level the incline, shelling the projections which afford shelter to the Japanese, who in turn bombard to prevent the Russians from succeeding.

There seems little doubt that the assault on Rihlungshan and Kikwanshan will be the most trying one that the Russians have yet resisted. Everything which ingenuity can suggest is being done by the Japanese to render the attack successful, particular attention being paid to measures which enable the Japanese to retain the forts in the event that they capture them. Among the contrivances to be employed are numerous heavy movable shields which have been constructed at Dalny and which will be used to afford protection. Guns and shields will be moved as closely together as possible through the trenches before the assault is made in order that they may be quickly hauled to the summit when the forts are taken. Two full divisions are available in this vicinity under Generals Oshima and Tuchiya.

The Russians are now using exclusively powder evidently manufactured at Port Arthur. The smoke from the powder enables an instant detection of the source of the fire. The explosive power of the powder is far less than that of smokeless powder, which the Russians seem to have exhausted. The Russian shells are frequently discovered to be old Chinese affairs filed down to fit the Russian guns.

The Japanese plan for the coming assault does not, it is understood, include an assault on Itzshan. The nature of the ground the Japanese have found at severe cost prevents a successful issue. Itzshan, however, will, it is stated, be engaged by artillery from Louisa bay and Shushiyen for the purpose of attracting the fire of Itzshan away from the main attack. The informant quotes an Argentine Colonel who is with the Japanese as saying that the Russian defenses facing the Japanese have been made with a perfection undreamed of. The inner sides of the forts, however, are not so well constructed and are supposedly far weaker.

With Rihlungshan and Kikwanshan captured the Japanese will practically control an entrance along the railway, and they contemplate assaulting other forts from their weaker sides. The Japanese say they are prepared to lose heavily in taking Rihlungshan and Kikwanshan.

These forts, like a majority of the fifty-four forts surrounding Port Arthur, have six-inch steel shields, loopholed with rapid-fire guns at intervals. These guns, according to the informant, and not land mines have proved most disastrous to the Japanese. These shields are impervious to field artillery. Nothing but siege guns will make an impression upon them. The Russians also send strong electric currents through the wire entanglements surrounding the forts.

The press correspondents with the Japanese are two miles from the front, but the hilly ground prevents them from seeing anything. The fighting since August 31st has been unimportant. The Japanese bombard daily in the morning, when the sun assists them in aiming. The Russians reply in the afternoon, when the sun is in their favor.

Correspondents John F. Bass and A. Dinwiddie arrived here today. They do not expect to return to the front. Bennett Burleigh is expected here soon.

BREAKING ALL LU'AU RECORDS

MAUI ENTERTAINED THE GOVERNOR AND PARTY IN LAVISH STYLE—CARTER STAYS WITH EX-JUDGE J. W. KALUA WHILE IN WAILUKU—SENATOR BALDWIN GIVES A DANCE IN HONOR OF THE VISITING EXECUTIVE.

WAILUKU, September 23.—Governor Carter and party are certainly having all the luau and entertainments they can take care of on Maui. At every village that they arrive in their tour of this island, a luau of some kind awaits them. In Hana they were treated royally, being taken care of by the Hana Precinct Club during their stay. Secretary Atkinson and Representative Kellinot arrived in Wailuku today. Kellinot says that almost every lunch and supper was a luau.

The Governor and his party will be taken in hand by the Puunene Precinct Club tomorrow evening. The governor expressed his desire to Hon. H. P. Baldwin, to be present at the next Harvest Home celebration. This Senator Baldwin took to mind, and he arranged to give a dance and entertain the governor in exactly the same style that the Harvest Home celebration was held. A large number of invitations have been issued for a dance and reception.

to the governor and party at the Puunene mill. He will arrive in Wailuku on Sunday, and on Monday noon, a very big spread will be tendered at the residence of J. W. Kalua, where the Governor will stay during his sojourn in Wailuku.

A citizen's mass meeting was held on last Monday night, where different committees were appointed, and the date of the luau changed from Sunday to Monday. The object is having, rich as well as poor to meet the governor. The territorial head will be entertained by the Wailuku citizens in great style. The needs of Maui in the lines of improvements, and more especially Wailuku district, will be presented in due form. When the governor returns to Honolulu he will no doubt say that Maui is surely the land of luau. **Party Loyalty
And Independence**

Certainly as far as The Star is concerned Faxon Bishop will not get the "roast" he appeared to expect because, as he puts it, he "repudiates the whole blooming business" of criticism of some Republican legislative nominees. Certainly no one asked the prospective senator to do otherwise and no one expected that a candidate on the ticket would be found opposing other candidates or even failing to actively support them. "Senator" Bishop would cut a sorry figure if he did other than repudiate criticisms of his fellow candidates. Hence, before he made his announcement, it was generally supposed that he was supporting the whole ticket, and those parts of his most excellent campaign speech which declared his faithfulness to all his colleagues contains only the expected.

It is scarcely conceivable that any intelligent Republican who is not afraid to express himself disagrees with The Star's statements on the day after the convention that the Republicans "did not exercise the best judgment, and it is useless to disguise the fact that the results are a disappointment to many intelligent voters." "Senator Bishop"—it seems proper to give him the title already, so numerous are those who hope most earnestly that he soon will be entitled to it,—very unwisely invites specifications by saying that he has heard no objections except that one candidate is a patrolman and another a musician, and he and other speakers quoted the cases of Lincoln and Garfield, rail-splitter and "canal-driver," who were presidents of the United States. This sounds like good campaign thunder, but the facts are against it. Abraham Lincoln, the great president, was no rail-splitter, nor was James A. Garfield, president of the United States, a canal driver. Between Abe Lincoln, the youth who split rails for a while,—not so long but that there seem to be about as many people treasuring as a relic the wedge he used as the number of rails he split,—between this earnest, toiling youth and the man who succeeded Buchanan as president, there is a gap of years of toil, study and preparation,—albeit everyone must admit that possibly the gap yawns not so widely as that between the trifling dignity of a patrolman and the incomparable importance of a Hawaiian legislator. And President Garfield was no more a "canal driver" than President Lincoln was a rail-splitter. It was the fact that they had risen from such lowly walks of life to the status of presidential possibilities that lent much popularity to their candidacy, for the American people like a man who makes himself. Similarly, the voters of Oahu, seeing a patrolman budding into a lawmaker, may be expected to show their sympathy by votes, even though intervening years of preparation are lacking. Is it not a notorious fact that patrolmen are always men of superior intelligence? As for musicians, is not a violinist Mayor of San Francisco?

Senator Bishop—again the title comes naturally—praises those who, even being themselves not candidates and as such obliged to stand with all other candidates, enthusiastically endorse the whole ticket and insist that it is up to a high standard. That is where again he shows knowledge of political propriety: The candidates who are under fire and are thus defended should work specially hard for him after such an example of good faith. But to the general public, with whom for the time Bishop is not to be classed, for he has become one of the elect and the politically bound, the difference between one who indulges in criticism where it is due, even within his own party, and one who presents his hands for the handcuffs of a party committee and his mouth for the committee's gag, is the difference between an independent American citizen, and a ward politician. The same comparison applies to journals. The prospective senator must know,—indeed a part of his address seems to show that he realized it,—that The Star's protest against the Republican 5th District ticket voiced a public sentiment so strong as to endanger the party. With very few exceptions, of which Bishop, as a man bound by considerations of political good faith must be regarded as one, those who have swallowed whole the Republican ticket for the legislature without making a grimace or immediately calling for an emetic, have done so because there is something in it for them. We do not believe that Faxon Bishop, the business man, would enthuse over the ticket as Faxon Bishop, and candidate, must necessarily do if he would avoid being untrue to his fellow candidates. In any event The Star repeats its hope that the public resentment will not endanger Republican success, and above all it hopes that the tide of dissatisfaction will never reach Faxon Bishop himself.

**Russians Claim
Strategic Victory**

After a lengthy and careful discussion of the battle of Liaoyang the Springfield Republican concludes that the Japanese casualties reached 40,000. It is noticeable that the usual Tokio cables have not been forthcoming, giving the losses, and probably the forces under Oyama met with a blow which staggered the Japanese commanders. The character of the fighting as described by correspondents with Oku, was such as to insure awful losses by the attacking parties. Here is an extract from the London Times correspondent's description of Oku's third ineffectual assault on the Russian positions: "But General Oku was growing desperate. From the position of the 5th division it was evident that the 10th division and General Kuroki were making no headway, so General Oku determined upon a third general assault that night. Just think of it, the third in 24 hours! But all day he had been moving his reserves up into the firing line. At 7 o'clock the whole strength of the Japanese artillery began a rapid fire, in preparation of the whole position, taking it in sections. This continued an hour, and afterward, for the third time, the infantry were hurled against the position. In general the assault was a repetition of all the previous assaults, except in one portion of the line. For the rest, there was gressome evidence the following morning to show how like hares in snares the heroic infantry had struggled into the barbed-wire entanglements to die, how, blundering in the darkness, sections had thrown themselves down 30 yards from the flaring line of muzzles whose flashes marked the goal they were never to win. But the 1st battalion of the 34th regiment, which for 48 hours had been lying in the scrub at the foot of the green glacis of the center hill, broke the rough abatis and entanglements, and, in spite of a flanking fire which swept away group after group, had enough endurance to reach the first trench. What happened there none knew, but in the morning, when we viewed the positions, Russians and Japanese were lying intermingled waist deep in the ditch, while from the parapet to the entanglement, perhaps 150 yards, a thick trail of prostrate khaki told a tale no pen can describe. Everywhere again the assault had failed." These three assaults cost ten thousand men, it is stated, and Oku lost another ten thousand while attacking the Russians as the latter were evacuating Liaoyang, making 20,000 losses for Oku's army alone. In view of such desperate charges and resistance it is not surprising that the London Chronicle describes the self-sacrifice and bravery of the soldiers on both sides as setting a new standard among the nations.

The Russians are claiming that Liaoyang was a strategic victory for them. The Times correspondent says that when it was found that Kuropatkin had withdrawn across the river and that Kuroki, after several days of attempts, had failed to cut off the Russian communications, it was recognized that "General Kuropatkin had defeated Japanese strategy." The failure of Kuroki to intercept retreat appears to be the vital point in the Japanese failure to carry out plans, just as General Orloff's defeat or retirement at a critical point in the Russian plans upset Kuropatkin's hopes of repulsing the enemy and holding his position. The accounts show that Kuroki's army was for several days isolated itself and confronted by a superior Russian force and that Kuroki was in very anxious mood. The Russians have made Orloff

suffer for his repulse, but there has been no word of Japanese dissatisfaction with any of their commanders. It would seem that someone must have blundered. The Japanese had altogether, according to the best figures about 80,000 more men than the Russians and about 200 more field guns. Why should Kuroki, carrying out a vital movement, have found himself isolated and confronted by a superior force of Russians?

Some day a detailed history of this great battle will be written, and it will be of absorbing interest. As far as can be seen now it was a brilliant Japanese tactical victory and an equally brilliant Russian strategic victory. As the Springfield paper already quoted says, if the Japanese losses reached even 30,000 "Marshal Oyama paid a tremendous price for his success in making Kuropatkin retreat."

BIOSCOPE PICTURES ARE BEING USED WITH GOOD EFFECT BY CANADA.

EDITOR STAR: From a late colonial paper we learn that bioscope pictures of scenes in the industrial life of Canada were recently shown for two months at the Palace Theatre, one of the best of the West End theatres in London. It is stated that the Agent-General for Victoria, Mr. Taverner, is endeavoring to make arrangements to advertise his state in the same way. ADMIRAL TERRY SOON TO LEAVE

Admiral Terry is soon to leave his post of naval commandant at Honolulu and retire from active service.

The cable dispatches yesterday announced that Captain H. W. Lyon had been ordered to Honolulu as naval commandant and evidently the orders to be commandant, have just been issued.

The new commandant has not been directed to proceed to Honolulu at once however, and his arrival here will be dependant, so far as is now known, upon the wishes of Admiral Terry. Admiral Terry will retire from active service the latter part of December. He is making arrangements to relinquish his command about the end of November and return home by way of the Far East, accompanied by his family. Captain Lyon will, in all probability, come to Honolulu the early part of November to take over the command of the local station upon the departure of Admiral Terry.

JUSTICE BLOCKED

If more demonstration, than that hitherto supplied as to the weakness of the jury system of Hawaii, were required it was furnished in Judge Gear's court this morning when the finding of a jury to try the Japanese Hayashida on the charge of murder was once more undertaken. The fourteen names in the jury box on Friday were then exhausted and a special venire of thirty-six was drawn at the order of the judge. As this proceeding went on the judge expressed his dissatisfaction with the system and hazarded the remark that nine out of ten of those drawn would not be found to serve on the jury. This morning's events proved that his honor was even short of the mark.

Of the thirty-six names drawn, eleven could not be found for service. Many were away at the coast and others were absent in other parts of the islands, still others have vanished from human ken. This, however, left twenty-five and these twenty-five were in court bright and early, but in less than no time fifteen of these were excused. The reasons for these excusings were varied but cogent. Some were not of age and one was over age. Some were British subjects and others were on the grand jury which originally indicted Hayashida. Still others could not speak English, one was a Federal employe and another was a lawyer, both claiming their exemption, while a modest few got off on the plea that they had no one to attend to their business which was accordingly going to the dogs.

Nothing further having been accomplished at noon, Judge Gear ordered the drawing of another special venire.

BUFFALO EXPECTED ON THURSDAY.

Admiral Terry received a cablegram from Midway yesterday announcing that the naval training ship Buffalo was at Midway en route to Honolulu. Admiral Terry expects her here about Thursday.

At a meeting of the Board of Health of the Territory of Hawaii held September 12th, 1904, the following Rules and Regulations, relative to the inspection of animals, were adopted.

L. E. PINKHAM, President, Board of Health.

Attest: C. CHARLOCK, Secretary, Board of Health.

SUPPRESSION OF DISEASE AMONG ANIMALS.

Section A. When the Governor of the Territory of Hawaii under the authority delegated by Section 1672 Penal Laws of the Territory of Hawaii, shall appoint three competent persons who shall be designated "Board of Inspectors of Animals" and one of the three appointed shall be designated as the Executive Inspector, said Inspectors and Executive Inspector shall be appointed as Agents of the Board of Health.

Section B. The duties of the above said Agents of the Board of Health shall be those defined by Sections 1672, 1673, 1674, 1675, 1679, 1680, and 1682 Penal Laws of the Territory of Hawaii.

Section C. Upon inspections of said animals or birds a certificate, (which certificate shall be made in duplicate and triplicate, the duplicate to be filed with the Secretary of the Board of Health), shall be issued to the owners or consignees of, or agents for said animals or birds by the Agent of the Board of Health making such examination stating the number and condition of said animals or birds, and those found in lawful and healthful condition shall be removed by said owners or consignees of or agents for, and those condemned shall be disposed of according to Section 1674 P. L.

Section D. The compensation of said Agents of the Board of Health shall be solely by fees for above inspections earned individually by each.

Section E. There shall be collected from the owner or consignee of animals inspected under this Act, one dollar per head for all horses, mules and cattle; fifty cents per head for all sheep and goats, ten cents each for every other animal or bird, and when from the nature of the case, the making of such inspection shall be unusually onerous or severe, twenty-five per cent, additional shall be paid to the Inspector.

All fees collected shall belong to the officer making the inspection, and shall be full compensation for his services for such inspection.

Section F. In case said owners or consignees of or agents for shall refuse to pay said fees, said Agent may refuse to deliver said Certificate to said owner or consignee of, or agent for, and decline to permit said animals or birds to be removed from said place of examination.

PLANTERS ADVISED TO IMPORT BATS

on the question of Bats for the Island, and they say that Professor Perkins thinks they will not thrive in Hawaii. I wish to say that here in Porto Rico there are millions of them everywhere. They have enormous caves of bat guano. I, myself, have seen several hundred tons in one cave, and the bats are so thick that I could say there is scarcely an evening that they don't fly all through our house.

"Now, these bats, of course, get their work in at night when the change is after his food, and the chances are, and it is very likely too, that these very bats keep down the pest, and my thought is that as they (the bats) do flourish in Porto Rico, certainly they should flourish in Hawaii, and I think Professor Perkins must be mistaken. I should strongly recommend the Planters' Association to import a lot there.

"Another thing that we have here is a great many little frogs. They, of course, get their work in at night, and between the frogs and bats we haven't many changes."

**CHINESE
COMING IN**

IMMIGRATION COMMISSIONER SARGENT STARTS WEST TO IN-
VESTIGATE LEAKS IN THE EXCLUSION LAW ON THE MEXICAN
BORDER—LARGE NUMBERS OF CHINESE GOING TO MEXICO IN
THE HOPE OF CROSSING THE BORDER.

WASHINGTON, Sept. 15.—One purpose of the inspection trip on which
F. P. Sargent, Commissioner of Immigration, departed is to strengthen the
Chinese exclusion service along the Mexican border. It is reported that
hundreds of Chinese have been entering Mexico of late with the purpose of
stealing across the border into the United States. The scenes of action of
the Chinese for frauds has largely changed from Canada to Mexico. Speak-
ing of this today, Sargent said:

"We are having more trouble along the border in the south than ever be-
fore, and it probably will increase. Instead of going to work in the south-
ern and central parts of Mexico, for which their importation was intended,
the Chinese are congregating along the American line, simply waiting for an
opportunity to get into this country.

"We are having the greatest trouble in Lower California, however, and
we have increased our men there. The peninsula is thronged with Chinese
and these are making their way over the hills and mountains into Tia Juana
and thence north to San Diego. It is hard work locating the culprits in this
sort of territory."

Regarding the conditions as serious, Sargent will visit all of the southern
stations and end his trip up along the Canadian border. Mexico has been
encouraging Chinese immigration and has thus increased the danger for the
United States in that direction.

PREDICTS REPUBLICAN SUCCESS

WASHINGTON, Sept. 8.—A dispatch from New York says: E. H. Harri-
man, president of the Union Pacific railroad, who returned from Europe last
Friday, talked encouragingly Monday of general conditions and the outlook
for business. He said he expected an improvement in industrial affairs.
When asked the recent little rate war on wire nails between the Union
Pacific and the Missouri Pacific indicated that a big traffic war was im-
pending in the west and that serious trouble might follow between the
Harriman and Gould interests, he smiled and said he was not aware of any
trouble. He was also asked if the reduced prices for rails would increase
the demand by the railroads. To this he answered "yes." When asked if
the Union Pacific intended to buy the Alton he said in a jocular way that
he wasn't sure the treasury could stand it.

Regarding business conditions he said:
"I have told people in Europe that neither they nor we appreciate the
situation in America; that the distribution of capital is such that we have
become more conservative; that now there would be less wildcatting and
fewer wildcats. Nowadays the situation is such that we can get correct
information from some responsible source regarding any enterprise. The
most significant thing now is stability."

"Then the boom is over, you think?" he was asked.
"It doesn't seem so to me. I don't mean a boom—I think there is quiet
appreciation in prices going on. There will be a steady demand now, instead
of the rush of two years ago. As for crops, there could not be enough dam-
age now to either cotton or corn to make them less than the average."

As to politics, he said it was going all one way. "No one wants to put
the Republicans out," he remarked.

"How about state politics?"

"I think they are waiting. No, I haven't any particular candidate for gov-
ernor under my wing."

"What is the opinion abroad about American securities?"

"They are a little slow over there. They are following us wholly."

A PORT ARTHUR HORROR

A MILE OF MINES EXPLODED UNDER A JAPANESE ADVANCING
COLUMN DURING A MIDNIGHT ATTACK ON THE GREAT FOR-
TRESS—AN EXPLOSION WHICH STUNNED EVEN THE RUSSIAN
GARRISON WHICH WITNESSED IT.

CHEFOO, Sept. 9, 1:30 a. m.—A Japanese column numbering approx-
imately 700 men, while marching along at night on a road in the valley
between Long Hill and Division Hill, near Port Arthur, met with a frightful
disaster through the explosion of an electric land mine on September 1.
The mine was carefully laid by the Russians three weeks ago. It covered
nearly a mile of available marching space. The explosive was placed at the
bottom. Rocks were placed next and on top of these clay was packed so
carefully that the ground gave the impression of not being disturbed.

The indications of Japanese activity in this vicinity put the Russians on
guard. Near midnight the outposts rushed in and reported that the Japa-
nese were approaching. The Russians withheld their fire for some time.
Suddenly they threw a searchlight up the valley.

The Japanese opened fire with a rifle fire. The Russians continued to
wait until apparently the whole Japanese column was in the danger zone.
Then the mine was exploded.

The force of the explosion knocked a number of Russians down and the
sight of Japanese rifles, water bottles, legs and arms hurtling through the
lighted space in range of the searchlight was an awful spectacle. Some
rocks landed inside the Russian lines.

There was one appalling moment, during which the garrison itself was
stunned—then a deathlike silence. The searchlight coldly lighted up the
road and hillsides, strewn with dead.

The following day the Russians buried the dead, but owing to their dis-
membered and mutilated condition they were unable to accurately estimate
the number killed. A few Japanese escaped.

The foregoing information is contained in a small sheet issued on Sep-
tember 3 by the Port Arthur Nova Kral, a breakage in the press having
made it impossible to issue a full edition. A Chinese arriving here at mid-
night confirms the story to the extent of saying that he heard a report that
many Japanese had been killed by a mine, but he did not learn the details.

On the nights of August 26 and 27 a similar disaster befell the Japanese
near Redoubt No. 3, but no details have been ascertained.

CHIEF OF THEATER ORGANOZED FOR THE FIRST CAMPAIGN BALLY SATURDAY NIGHT.

INTERRUPTED A FUNERAL

NEW YORK, Sept. 2.—Two process-servers rudely interrupted the burial rites at the grave of the mother of F. Augustus Heinze, the Montana copper king, on Thursday in Greenwood cemetery, Brooklyn. Just as the body was being lowered into the grave they appeared among the mourners and demanded to know which one of the men there was F. Augustus Heinze.

The clergyman was repeating the burial service, and for a moment hesitated as the loud voices of the process-servers started every one gathered about the grave. One of the intruders was a law clerk. The other was a six-footer with a megaphone voice. It was he who first broke in upon the solemn ceremonies.

"Are you F. Augustus Heinze?" he demanded, as he broke through the line about the grave, and stood between the copper king and the coffin. In his hand he held a paper.

Mr. Heinze said not a word. He declared afterward that the very audacity of the proceeding robbed him of speech. He beckoned to two of his friends, who took the intruders by the arm and led them aside.

Twenty feet from the grave there was an argument in stage whispers. The intruders were determined to go back to the graveside and serve the subpoena. In tones that were plainly audible to all of the mourners they asserted that Mr. Heinze had been dodging the service of the papers for a long time and that they did not intend that he should give them the slip again.

"We can't help what we are doing," said the law clerk. "We are simply acting under orders and must serve this paper, even if the burial service is interrupted."

One of the family friends beckoned to a cemetery watchman, who escorted the process-server and the law clerk to the street. There he told them that if they dared to come back and raise another disturbance he would have them locked up for disorderly conduct.

Otto C. Heinze, a brother of the copper magnate and a broker at No. 88 Franklin street, intimated yesterday that the two process-servers were instructed to interrupt the burial services by the Standard Oil clique that has been making war on Mr. Heinze for Montana for several years.

RICHEST ORIENTAL CARGO ON RECORD

THE MONGOLIA ARRIVED TODAY WITH CARGO VALUED OVER FIVE MILLION DOLLARS.

With the richest cargo that ever came out of the Orient, the S. S. Mongolia, Captain Parter, arrived off the port last night about 11 o'clock after a very disagreeable trip from Yokohama.
The vessel did not arrive here in time to pass quarantine so laid outside until this morning when she entered and docked at the Haakfield wharf.

The vessel left Yokohama September 17. She experienced rough weather during most of the run, there being head winds and side winds and strong head seas. She is such a big brute though that weather that would ordinarily detain a smaller vessel, makes no difference with her. The Mongolia brought 1,681 tons of cargo for this port and has 2,616 tons for San Francisco. She carries 4,000 bales of silk valued at \$2,000,000, \$1,000,000 in treasure and 30,000 boxes of tea, besides other general cargo. In round figures her cargo and treasure are worth between five and six million dollars. This cargo exceeds the cargo that she brought here on her former homeward trip. Nothing of special interest occurred during the voyage.

The vessel has 100 through passengers and five cabin passengers who stop over at Honolulu, besides a large crowd of steerage passengers for Honolulu and San Francisco. Two babies were born during the trip, to steerage passengers, one a Japanese and the other a Korean woman.
