# HEPBURN SEES GREAT HAWAII FUTURE

## Civic Feds Groping, Westervelt Will Scratch, Two Secret Sessions RICHARDS AND CASTLE WON'T TALK

WANTED—A "good" man to run for Sheriff of Oahu County. Chances of winning out no object. Must be willing to sacrifice all party allegiance. Only Anti-Brown men need apply. Must bring references. No apply in a hurry—please.

Who will volunteer to run for Sheriff on the Civic Federation ticket? The Federation is man-hunting with no eligible in sight. Theodore Richards, W. R. Castle, D. L. Withington et al., of the executive committee of the C. F., are hot-footing it around town today, looking for a sheep for the sacrifice. Rawlins escaped and it is up to the Feds., the executive Feds., to hustle for a substitute.

Yesterday afternoon a secret session was held in the office of W. R. Castle. Castle gave orders that no reporters should be admitted. The Civics, the executive appendices of the Civics, were up a tall piece of timber. They would not have the public behold their confusion. And after the executive committee meeting those present kept their mouths tight shut. Theodore Richards was present. Richards was approached reverently this morning, but he side-stepped to perfection.

"I've nothing to say," he said; "there's nothing up." Richards probably meant there was no candidate up. A little later he was seen in a hack with Frank Atherton. W. R. Castle was closeted in his office all the morning with the door locked. "Keep reporters out," were the official orders issued.

"I positively decline to be interviewed today."

This morning another executive session was held, since no way was seen out of the middle of yesterday. D. L. Withington, also of the executive committee of the C. F., was seen on the street. "I will have nothing to say of the doings of the executive committee," he said. "If the Civic Federation is up a tree, I have no heard it."

And there is to be a meeting, a political meeting, in the sacred halls of the Y. M. C. A. this afternoon. Quite a situation, people are saying, to have a meeting with the object of crushing Brown in the rooms of a religious institution; why not call the meeting to order at the iron works, where steam hammers are handy.

Rev. W. D. Westervelt was hailed this morning. "I'm a member of the Civic Federation," he said, "but, you know, I'm not a member of the executive committee; so I know nothing of what they are trying to do. Yes; the Federation at present seems to be very much up a tree. I am sorry that Rawlins would not accept the nomination on the Federation's ticket, for I think he would make a splendid running. I do not agree with Rep. W. W. Harris in what he is quoted as saying in the morning paper about the Republican party crushing Rawlins if he ran on the Federation's ticket. "I think the Republican party here will crush itself in time if it is going to resort to boss rule. Why, I wouldn't vote for Harris, if he said what he is quoted as saying, on any ticket for any office. I would scratch a ticket on which his name appeared. I'm a Republican, you know that, but I must say I would rather vote for Poepeo for Sheriff than for Brown. I'm very sorry Rawlins won't run. What will the Federation do? But there is a general meeting this afternoon and I guess something will come out at that time."

"All this working of different forces is a good thing for the development of citizenship; it all goes to form the perfect citizen; it is all for the best. A healthy excitement and opposition of ideas is well for the community; each of it all will come good. Only let each be sincere in all that he does. But we must have no bossism. I stand for the right of every American to scratch his ticket if he feels it is right so to do."

Theodore Richards' opposition to Booth for Treasurer, on the score of Pauoa water connections, is considered extremely inconsistent since Richards favors Trent for the office and Trent was one of the commission which valued the Pauoa water at \$140,000. If there are any "watery clouds" about Booth they also envelope Trent. If Pauoa water is a graft then Trent is involved as much as Booth, say the thinking ones.

Curtis Iaukea, speaking of the Civic Federation this forenoon, declared that the institution might accomplish some good were it made up of non-partisan men. Iaukea emphatically stated that he would not run for Sheriff on the Civic Federation ticket. He had refused to run on his own (Democratic) ticket for his own reasons and he would not run at all.

"It seems about up to Theodore Richards himself to run for the Sheriffship," said numerous men today. "Richards is apparently the chief operator of the machine."

A. M. Brown is not fearing the opposition of the Civic Federation. In deed the opinion is quite prevalent that the Federation's opposition, such as it is, will make votes for Brown. It was stated today that, if Governor

## BIG OPEN MEETING OF CIVICS AT Y.M.C.A. TODAY

The cat will be let out of the bag at the Y. M. C. A. this afternoon at 4 o'clock at the meeting (this one will be open to the public) of the Civic Federation.

The executive committee of the Federation has been in session all the morning and it is understood that at the open meeting the ball will be started rolling by President W. R. Castle making a report of the doings in secret session.

This report will include certain recommendations, among which will be the allegation that Brown is not a good man for office. The main idea will be anti-Brown. It is not supposed that any man has been secured to run on the Civic ticket for sheriff. In fact the executive committee of the Federation is likely merely to say that they do not endorse either of the present candidates for sheriff and let it go at that.

It was reported this afternoon that somebody was endeavoring to influence Poepeo to withdraw from the fusion ticket and leave the field to Brown; that a proposition had been made to Poepeo and he was considering it. Rumor had it late today that D. L. Withington or Ed. Towse would be named for sheriff by the Civics, but both of these gentlemen emphatically denied that rumor had on this occasion any truth in it.

## FRANK BERTELMANN AGAIN FOUND NOT GUILTY

Frank C. Bertelmann, charged with impersonating an internal revenue officer, was this forenoon acquitted of his second charge by Judge Dole's jury.

Bertelmann was charged with having charged a Chinese, named Lau Lum Kee, the sum of \$1 for altering his immigration certificate. The defense, conducted by J. W. Cathart and L. M. Straus, this morning put the defendant on the stand, where he told a very plausible story.

Bertelmann said he was canvassing for advertisements for a Chinese-Japanese directory, which he was getting up. He secured an advertisement from Lau Lum Kee and received \$1 for it. In order to get the Chinaman's right name he asked him to show his immigration certificate, where he knew that he would find it. He then wrote out the advertisement in the store, this document being produced in evidence.

The matter was submitted without argument and the jury returned a verdict of not guilty after having been out only about ten minutes. The third case of the four against Bertelmann was set for trial tomorrow morning.

## Would Back Demand Says Congressman Hepburn With The U.S. Navy

"Whether or not the Japanese win the war will not make any difference in the trade of the United States with the Orient. We are bound to have the open door there, and we will have it. That's what the navy is for."

Hon. W. P. Hepburn, Republican Congressman from Iowa, has a steadfast belief in the future of American trade in the far East, and in the above words, spoken to a representative of the Bulletin this morning, the Iowa Congressman told one good and sufficient reason why he believes as he does. According to Mr. Hepburn, the United States will not allow the "closed door" to kill commerce with the Orient, no matter whether Japan wins or loses the great struggle.

Congressman Hepburn, accompanied by his wife, arrived in Honolulu on the transport Sheridan this morning, and is a guest at the home of Roy H. Chamberlain, Collector of Internal Revenue. Mrs. Chamberlain is the daughter of Mr. and Mrs. Hepburn, and the Congressman's visit to the islands is for the purpose of resting and visiting their daughter. He will remain here for a month, joining the Taft party here and going with it on the Philippine tour.

Mr. Hepburn believes in the future of Hawaii, and more especially of Honolulu. When the Panama Canal is

completed, he believes Honolulu will be greatly benefited by the new commerce that will come to this port.

"Undoubtedly," says Mr. Hepburn, "the Panama Canal will result in increased trade for Hawaii and Honolulu particularly. Honolulu is in a position to get the benefits of Oriental trade. It is now a discussed question whether or not the building of the canal will divert trade from the trans-continental railway lines to the new waterway. A great many believe that it will do so. On the other hand, some very close students of transportation are inclined to the belief that the building of the canal will result in such an influx and settlement of people on the Pacific Coast that the railroads will gain instead of lose. At any rate, the canal will be the means of increasing Oriental trade. The United States will be firm in insisting on the open door there if such a thing should become necessary—though I don't think it will."

"What outlook is there for a tariff on coffee?" Mr. Hepburn was asked. "I hardly think such a tariff will be imposed," was the reply. "Why should it be? Hawaii and Porto Rico are the only two parts of the United States where coffee is grown and which would be benefited, and that hardly makes the demand strong

## Wyman To Initiate Federal Institution For Study Of Leprosy

WILL CURE IF CURE IS POSSIBLE

"I have come down here to initiate the Federal institution for the study and treating of leprosy on the island of Molokai," said Surgeon-General Wyman of the United States Marine Hospital Service, shortly before 1 o'clock this afternoon as he stepped out of the elevator with Dr. Cofer to enter the cafe of the Alexander Young Hotel.

Dr. Wyman was hungry and looked it, for he had been moving around the city in a lively manner with the local head of the Hospital Service since his arrival from San Francisco on the U. S. A. transport Sheridan this morning.

"I have met Governor Carter, having called on him this morning, discussing the establishment by the Government of a leprosiarium on Molokai. Our ideas on the proposition seem to be very much the same. The Governor appears to be very much interested in the proposed institution, and, indeed, it will be a splendid thing for these islands."

"At Washington, you know, we have a laboratory devoted to the study of the disease and there we are constantly in touch with all the great scientific advances of the age, keeping constantly informed of progress by leading medical minds all over the world."

"We are in a position to command the very best scientific research. What the Federal Government does is done well."

"With the establishment on Molokai, at the leper settlement, of an institution where the disease can be observed and properly studied by the best men of medicine, under the supervision of the United States government, the lepers will receive the most approved treatment and have the best opportunities, where recovery can be realized, to rid themselves of the disease. On Molokai the malady can be scientifically

observed in all its phases, in every stage and if it is possible to effect a cure, a cure will be discovered under the advantageous circumstances created by the Federal government.

"One thing I would say most emphatically and that is that the government's Molokai institution is not to be a place where lepers from all over the United States are to be sent. No such proposition has ever been considered by us and nothing of the kind will be realized."

"I shall remain here about a week. First of all I must visit the settlement on Molokai. Some Honolulu physicians and members of the Board of Health will be invited to go along. I can say more about the plans when I have visited the settlement. Yes, I may find it necessary to come down here again. I hope so, at any rate, for the islands are delightful."

## CHINESE WON'T BUDGE

### WILL CONTEST EXCLUSION FOR OTHERS THAN LABORERS

IMMIGRATION TREATY OF 1880 IS NOW IN FOR—WILL WORK A BOYCOTT ON THE AMERICANS.

Washington, May 19.—All hope of the success of the pending negotiations of the new Chinese exclusion treaty has for the present been abandoned by the Chinese officials, as a result of the wave of resentment that has swept over China since it became known that it was planned to transfer the negotiations to Peking, and that the Department of Commerce and Labor was insisting upon its own interpretation of the exclusion law. Reports have reached the Chinese Legation of the extent of this feeling throughout the Chinese empire and of the hostility of the Chinese commercial guilds to American goods, which might result, it is asserted, in a general boycott against American products, even were it possible to conclude the exclusion treaty now.

The Chinese Legation here declares that there is no intention of bringing suit in the Supreme Court of the United States in behalf of the Chinese treaty of 1880. All such infringements of that treaty the legation holds to be diplomatic matters entirely, and an appeal will be had, not to the court, but to the State Department. Briefly put, the position of the legation here, which reflects that of the Peking Government, is stated as follows:

"The expiration last December of the exclusion treaty of 1894 leaves in force the treaty of 1880. The legation does not for a moment question the right or the duty of the Department of Commerce and Labor to enforce existing laws. The relations of the United States and China are, however, regulated by treaty and not by laws, and it is to be expected that any violation of existing treaties will be fully compensated for by indemnity. All Chinese excluded from the United States or deported therefrom, in violation of the treaty of 1880, who present claims to their Minister here, naturally expect those claims to receive careful consideration. If they are found to be just they will be presented for settlement through the proper channels."

In the immigration treaty of 1880, article 1 provides that the limitation or suspension of Chinese immigration to the United States shall be reasonable, and shall apply only to Chinese who may go to the United States as laborers, other classes not being included in the limitation.

The first claim for damages reached the Legation today from a Chinese merchant arrested in Seattle and is now being investigated.

## TERRITORY DEMURS

The Territory has filed a demurrer to the \$15,000 suit, brought by the Board of Foreign Missions. The demurrer is on the following grounds:

"That said petition does not set forth facts sufficient to constitute a cause of action in that it is nowhere shown therein that the contract entered into between the American Board of Commissioners of Foreign Missions and the Kingdom of Hawaii has been violated in any manner whatever."

"That it does not appear from such facts as are set forth in said petition, that the petitioners are entitled to the relief prayed for."

"That it nowhere appears in said petition when the cultivation of sound literature and solid science at said institution ceased."

## TRUSTEES AFTER ASHFORD

Respondent in the case of Kaikaina-hoie vs. J. O. Carter et al., trustees' yesterday filed affidavits to rebut the statements on which C. W. Ashford and H. E. Highton secured an injunction preventing the plaintiffs from prosecuting an action for ejectment. The affidavits charge Ashford with deceit and with wilfully delaying settlement of the case. Judge Linsay will hear motion to dissolve injunction on Saturday.

### INSULT TO WOMANHOOD

Albany (N. Y.), May 23.—A bill introduced to legitimize a child born out of wedlock, which caused much comment but little opposition in its passage through the Legislature, was vetoed today by Governor Higgins. The measure is entitled "An Act for the Relief of Adelia Queenie Barker," and recites that she is the offspring of Charles Bell Barker and Adelia Gertrude Strong. Governor Higgins characterized the bill as an "insult to every faithful wife and to womanhood itself."

The "Civic Federationists" are making a fizzle of it, because there is no real sentiment in the community to support their line of action. The people don't believe there is any field for the "Civic Federation" at present because these alleged reformers have not exhausted, nor even tested, the opportunities offered them for work within the political parties.

The politics of the Territory are not teeming with the corruption that leads men to seek an escape from the lower forces that prey. These men who say they don't like the ticket put up by the Republicans in its entirety had ample opportunity to work in the precincts and the primaries of the party. Civic Federation stands before the community today on somewhat the same plane as the small boy with a kite—a few dried leaves rolled together, a little fire at one end and a kite foot at the other.

Take the attack upon the Republican candidate for Sheriff, A. M. Brown. In the first place the "Civic Federation" didn't discover that it didn't approve Brown until he had been nominated. He did not sneak into the convention and steal the nomination. His was the first candidacy declared. The "Civics" said nothing till after it was all over.

Furthermore these misguided gentlemen who meet in secret conclave and declare they are representing all that is good in the community may talk all they please, the people of the County of Oahu, take them by-and-large, don't believe that Candidate Brown is crooked or has been. They want to vote for a man for Treasurer who was appointed by the proper authorities to estimate the value of the same water rights, and having done so found them worth the price.

Thus the "Civic Federation" from its start to the present has shown itself to be founded on prejudice, governed by men who work in secret and therefore in ways that are dark, operated on the Knocker theory, and without a shining example of a good thing gone wrong. It has taken original laziness for an inspiration, imitation for a compass, and after thoughts as an excuse for what can't be otherwise explained.

If the citizens of the County generally take as little original interest in government, in the precinct and primary meetings of the political parties, as the gentlemen who by their frequent committee meetings are known as the "Civic Federation," when this day of this condition arrives then there will be occasion for a real Civic Federation Not till then.

MOSSMAN CASES

NOLLE PROSSID

The calling of the criminal calendar for the term in Judge De Holt's court this morning was interesting in more ways than one. First of all, a number of cases were nolle pro'd and furthermore great difficulty was experienced in setting cases for the immediate future. In the great majority of the cases on hand A. M. Brown and E. A. Douthitt appeared for the defendants and as these gentlemen will be engaged in politics, as candidates for County offices, their cases could not be set.

The bail opened by Deputy Attorney General Peters entering nolle prosequi in all the cases against Harry C. Mossman, the former Deputy Sheriff's clerk. This ends all prosecution against him. Mossman was charged with embezzling Government funds in his custody.

The case of Mary Manu, charged with larceny in the first degree, was continued for the term.

The cases of Ah Tam et al., charged with gambling; J. W. A. Redhouse, charged with larceny in the first degree, and of Manuel Ferreira, charged with larceny in the second degree, were all nolle pro'd.

The case of Henry Vierra, the former clerk of the Water Works Department, charged with embezzlement, was continued for the term.

In the matter of Ah Lum, charged with running a lottery, a bench warrant was issued for the arrest of the defendant. A former bench warrant against him had never been returned.

The cases of John K. Nakoooko and Stephen Umauna, both charged with libel, were called. As J. M. Poepeo, who appears for the defendants, is a candidate for County Sheriff and is campaigning, these cases were set for June 21.

Takada, charged with murder, had C. C. Biting as his attorney. Biting may be unable to try the case on account of illness. The Court stated that another attorney might be appointed in his place. The case was set for June 14.

The cases of Wishimura and Fushimura, charged with bribery, and of Koseki, charged with murder in the first degree, were set for June 16.

The following cases were set for tomorrow. Higaki, selling liquor without a license; Ho Sau San et al., gambling; Isabella Berente, and Jane Dow Luweiko, both selling liquor without a license.

The people of Waimea (Kauai) are preparing for a celebration of the Glorious Fourth that will eclipse anything they ever attempted before or in any community on the Island of Kauai. Some of the interesting items are: free drinks, free board and lodging for all guests from other districts; parade, sports and dance with concert between the dances in the Opera House, and many other items too numerous to mention.—Garden Island.

The Supreme Court this morning adjourned until June 26, after Associate Justice Wilder, who alone appeared on the bench, had handed down decision in the case of J. H. Schnack vs. Mary J. Montana, assumpsit, overruling the bill of exceptions taken by plaintiff.

Owing to the excessive time allowance given the Spray and the Hawaii over the Gladys and La Paloma it is rumored that the two latter boats may withdraw from the race around the island.

## SPORTS

### CROSS COUNTRY AUTOS.

Omaha (Neb.), May 24.—"Old Scout" and "Old Steady," the two automobiles in which Huff and Wigle and Megargel and Stanfield are racing from New York to the Lewis and Clark Exposition at Portland, Ore., will pull out of Omaha Thursday morning at 9 o'clock for the Pacific coast.

The racers are ten days behind schedule, the loss of time being due to heavy rains encountered through Iowa. When the machines reached Omaha they were so covered with mud that they could scarcely move. But from Omaha to the end of the trip the racers expect to lose no more time on account of mud, the country through which they will pass being sandy.

Supplies and other necessities have been shipped to different points on the Union Pacific road through which the racers will pass and these will be taken up when the machines pass the towns. The racers will follow the old overland trail up the Platte valley to Cheyenne and will go over the mountains via the Fremont pass, which is used by the Union Pacific.

### UNIVERSITY ATHLETIC RUBS.

New York, May 22.—There is trouble in sight over the new eligibility rules adopted by Harvard and Yale, which are to the effect that an athlete, who, prior to the age of nineteen, had received cash for his athletic ability, could, after the lapse of two years, be reinstated, at the discretion of the college authorities.

The adoption of this rule is in direct violation of the constitutions of both the intercollegiate associations and the A. A. U. This fact was pointed out by James E. Sullivan, the secretary of the A. A. U. yesterday, and he said that the A. A. U. would await the action of the intercollegiate body before doing anything in the matter. If the intercollegiate association fails to take action in the matter, Mr. Sullivan says that "in the interest of pure amateurism, the A. A. U., which governs amateur sport in this country, would be obliged to go on record, and forcibly, at that."

Mr. Sullivan also said that he regarded the new rule as detrimental to sport, as it would enable a college to whitewash a professional, and he thought that it would in time react very strongly on Harvard and Yale. METROPOLITAN GOLF PLAY. New York, May 24.—Out of eighty-two entries, a field of sixty-four players started in the seventh annual tournament for the Metropolitan Golf Association championship, on the Fox Hill Club's links, on Staten Island today. The qualifying round, which consisted of thirty-six holes, mental play, occupied the entire day.

The medal for the best score was awarded to Byers of the Allegheny Country Club of Pittsburgh. Walter J. Travis of Garden City and Archie Graham, the New Jersey expert, tied with totals of 157 each. Thirty-two qualified for the first round of the match play for the principal prize, and the defeated sixteen tomorrow will play on for a minor trophy. The third and fourth sixteenths will continue for two other cups, so that sixty-four players will be in evidence tomorrow.

### TRAVIS WAS DOWNED.

New York, May 25.—This was a day of unexpected reverses for the most prominent players in the Metropolitan Golf Association's annual championship tournament, which is being played on the links of the Fox Hills Golf Club. In the first round of match play Eben M. Byers of Pittsburgh, who won the medal play round yesterday, was defeated by James M. Rhet of Brooklyn. In the afternoon Walter J. Travis, who is rated as probably the best American amateur golfer, was put out by Jerome D. Travers, by seven up and six to play.

### BASEBALL ON SUNDAY.

New York, May 22.—Magistrate Dooly has dismissed the complaint against Louis Ritter and Malcolm W. Eason of the Brooklyn Baseball Club, who were charged with violating the Sunday law in playing baseball on Sunday, April 23d. A great mass of evidence was taken by the magistrate, the principal witness being Policeman Cohen of Inspector Wiegand's staff. Lawyer Bernard J. York was the representative of the baseball club.

### AMERICAN GOLF WOMEN.

London, May 23.—American women entrants for the ladies' golf championship play which begins at Cromer, Norfolk, May 29th, are creating a sensation by the splendid showing they are making in practice. Today Miss Bishop of Bridgeport, Conn., the American woman champion, lowered the course record for nine holes, going out in thirty-six strokes. ## Books, Bookish People and Things

### ATTACKS ON THE MASONIC ORDER.

A recent book published by E. B. Treat & Co. gives a history of the order that has grown to such influence in the world, and refers to some of the attacks made upon it. The so-called party which arose from personal spite and endeavored to bring a real charge against the Free Masons as a body, went to pieces in the Northern Edge where it originated, and from that day to this the Order has gone on increasing in influence and numbers. Nor are numbers and influence synonymous terms. The influence of the Order comes from the sifting process; a wisdom in leaving out men of immoral or otherwise undesirable character who try to get in because they expect to get the benefit of direct influence.

And one of the great qualities of the Order as an order is the impersonal way it deals with men. Ancient—by the side of other orders—dignified, spurning even ordinary methods of increase, it makes itself felt. No doubt it has unworthy men in its membership, but by some peculiar process it is gradually eliminating such members, and by a careful self-defensive process all its own, it is more than ever guarding itself from the men who shouldn't be in it.

For, while a church or an order should not be judged altogether by the quality of its membership, to a great extent it is and should be. One of the great faults found with the churches of today is the membership in them. And those outside who approve of the high ideals and precepts enjoined, have a perfect right to demand that these principles shall not be trailed in the dust.

Theoretically the Brotherhood of Man is all right, but no man of consideration wants to identify himself practically and socially with men he wouldn't wipe his old shoes on. And some churches are much more particular in practicing what they preach. No doubt some lodges are less particular than others, too; but, as a whole, the Masons maintain a high standard. When they as an Order have only men of character in their membership; men with high aims and a somewhat adequate life, they will approach the high standards of their ethics.

The Masonic Order is not an insurance company. It is not eleemosynary. It was not organized nor is it kept up to keep men from getting their just deserts, or to bolster up those who have something to be ashamed of in their private lives. It does not help criminals to escape. It will not assist any man to carry out petty revenge. It cannot lend its aid to the continuance of personal spite. Had it done any of these things it would not have appealed to the men it has; it would not have gathered to itself as a magnet gathers steel filings, the best intellects and characters of the world.

"Hear Talks." By Wm. Henry Geistweil. Cloth, 354 p.p. Portrait and autographed edition. Winona Pub. Co., Chicago. \$1.00 net. In value to the reader as different from Dr. Johnston's "Scientific Faith" as it is possible for anything to be. "Heart Talks" is well named. It comes from the heart and appeals to the heart and the intellect. The style is simple and frank, always free from cant and clerical bias, and what the author says so kindly and with such sincerity touches responsive depths. "Standing by Another's Needs" is a sweet chapter. "That man is to be pitied who was born on the 'off' side of things; who instinctively takes the opposite side of a subject, whether it is right or wrong; who never smiles only in ridicule, or

when he makes a joke himself, in which case he must laugh to start the other folks going," says our author in the chapter called "The Duty of Being Pleasant." There is a kindly humor throughout which makes the book extremely readable, and when the author tells of three men he knew all of them "snappish," he does it with such kindness that even the men themselves could not be offended. "For the sake of familiar speech let me call them Peter, James and John. Should a copy of this book ever fall into their hands, and two of them discover this chapter they need not feel badly about it; perhaps it will do them good—if old men can learn lessons in that direction." "There is no dignity in coldness, no strength in being gruff, no sense in being snappish; but there is every element of nobility to be manifested in Christian courtesy and pleasantness." Speaking of "official service" or organized pleasantness, Mr. Geistweil says: "You do not seem to shake hands as often as you did," was the remark of one Christian to another, not long ago. "Well," was the astonishing reply, "I am not on the reception committee this year." On one occasion a lady arose in a meeting and said, "I do not want to be visited by persons simply for the reason that they are officially appointed to do that work; I do not care to see them." That was blunt; but every syllable of it was overwhelmingly just and right. One book which acknowledges such imperfections and suggests remedies will do more to help along Faith than a thousand books like that of Dr. Johnston.
