Many Cases Are Decided

Judge Kingsbury Makes Many Wise Decisions.

On Wednesday morning Judge Selden B. Kingsbury of the Circuit Court decided a number of cases that had been taken under advisement and the able manner in which the decisions were rendered showed much careful consideration of the same.

The suit of Virginia E. Sands, an old Hawaiian woman against Henry Kailiehu for the recovery of her lands decided to the latter without consideration was decided in favor of the plaintiff.

The decision in part was as follows: "And the Court finds that the said deed is void and of no effect and that the plaintiff is entitled to the ownership and possession of the said property and to have the cloud removed from and over said property caused by said deed and that the defendants should re-deed the said property to the plaintiff or if they fail so to do within thirty days from the date of the filing of this decision that the clerk of this court act as a commissioner of the court for the purpose of executing a deed of the said property to the said plaintiff."

H. C. & S. Co. v The Territory of Hawaii.

The Hawaiian Commercial and Sugar Company won its suit establishing its right to the fishery lying between Paia and Waiehu and known as the Kahului fishery. This suit was brought by the company some years ago in compliance with a provision of the Organic Act which makes it obligatory upon all parties claiming fishery rights to establish the same by a suit in court.

Kauhimahu v Kauhimahu.

In all of the cases before the court there was probably not a more difficult case to decide than the one in which Mrs. Annie Kauhimahu sought a legal separation from her husband, Moses Kauhimahu, the teacher in the public school at Kahului.

For many years the Kauhimahus lived happily together until a smooth tongued fine looking fellow by the name of Ezera appeared on the scene and won the wife over to a new religion of which he is the head.

Mrs. Kauhimahu deserted her husband and has declined to live with him since but has steadfastly clung to her new religion and the preacher.

Last year Moses Kauhimahu brought suit for a divorce which was granted by Judge Kepoikai. Although an overwhelming number of the people here who know the facts of the case believe the decision of Judge Kepoikai was just and proper the Supreme Court held that the causes for a divorce set up in the complaint were not sufficient grounds for a divorce and reversed the lower court.

In the suit before the court here this week Mrs. Kauhimahu was the complainant. The decision is as follows:

That the defendant has not been guilty of cruelty to the plaintiff. That the defendant did not neglect or fail to support the plaintiff up to the time when a decree of divorce in a suit in which the defendant was the plaintiff and this plaintiff was the defendant, was granted which decree was afterwards reversed by the supreme court.

That since the reversal of said decree the said parties have not spoken together and neither of them has in any manner treated the other as be-

Church Organized

Forty-Three People Become Charter Members.

The Kahului Union Church of which Rev. Theodore A. Waltrip is the pastor, was duly organized on Saturday and Sunday, May 15th and 16th.

The Council for organization was held on Saturday at three o'clock. There was a large attendance, and every church invited, was represented and many individuals were present. Rev. Doremus Scudder, D. D. of Central Union Church was the Moderator, and Rev. Collins G. Burnham of Lahaina, the scribe.

The Council voted to accept the work that the Church had done toward the organization, and a committee was appointed to draw up the program for the following days public exercises.

On Sunday there was a large audience to listen to the exercises in connection with the public recognition of the church. Rev. Dr. Scudder preached an excellent sermon, Rev. Wm. B. Oleson extended the greetings of the Churches of the Islands and of the Hawaiian Board, while Rev. Rowland B. Dodge gave the charge to the Church.

The Pastor, Rev. Theodore A. Waltrip received into membership the forty-three members. These came from a large variety of denominations from Mainland Churches, and there were converts from Buddhism, Shintoism, and Mormonism. Six different races were represented.

Mr. H. B. Weller, sang a solo, "Face to Face" and a quartette composed of Messrs. Weller, Skinner, Chillingworth and Bell sang "On Calvary's Brow."

On Sunday evening Revs. L. B. Kaumeheiwa and D. W. K. White preached in Hawaiian to a large congregation.

The officers of the Church are as follows: Deacons, John Spencer and Edgar J. Walker, Clerk, Thomas D. Skinner, Treasurer, Ferdinand Hons, Executive Committee, Hon. Henry P. ing either husband or wife but have acted as if no relation of marriage existed between them, with the exception that the said defendant did promise the person who furnished a home to the plaintiff to pay reasonable charges therefor and with the exception of the bringing of this suit.

The court finds that the cause of the trouble between this plaintiff and the defendant all grew out of the facts and circumstances connected with the joining of a certain so-called church or religious society by the plaintiff.

That the plaintiff became the convert to this so-called new religion and infatuated with the preacher of said religion, one Ezera.

That she allowed the said preacher Ezera, and those connected with him to obtain undue, improper and wicked influence over her mind and actions so that she gave cause for grave suspicions of infidelity and caused the defendant, her husband, to become very jealous of the said Ezera, and gave him many grounds of suspicion against the said plaintiff on account of her improper conduct and actions with the said Ezera.

Harbor Lines Are Approved

Kahului May Now Have Large Wharf.

Major E. Eveleth Winslow has notified Superintendent J. N. S. Williams of the Kahului Railroad Company of the establishing of the harbor lines of Kahului as recommended by Captain C. W. Otwell of the Corps of Engineers U. S. A. Captain Otwell had a hearing of the matter on April 8th 1908 and on April 22nd, 1909 the Secretary of War approved the lines submitted.

The way is now open for the immediate construction of a wharf of modern facilities for the discharge of vessels up to twelve thousand tons.

As the Legislature failed to appropriate any funds for the building of a wharf at Kahului private parties of all classes should do every thing possible to encourage private enterprise there which has been done to such a great extent by Honorable H. P. Baldwin.

Those of our citizens who hold public office should recognize the improved shipping facilities that the only port of Maui now enjoys as a result of public spirited citizens who have done so much for the deepening and otherwise improving our harbor.

The Wailuku Sugar Co.

Finishes Grinding with Banner Crop.

On Friday of this week the Wailuku Sugar Company completed its grinding for the season with an output of 17,800 tons of sugar or 1,800 above the estimate of the company.

While the year has been a most favorable one in every respect it is said by those who know that the large crop is in a great measure due to the fact that last year Manager Penhallow shut down the mill on two occasions and used the water that was being used for the mill to irrigate the cane when it absolutely required it. While Mr. Penhallow was severely criticised at the time for his action it has been demonstrated that his action was a most wise forethought.

All of the sugar for the season will be bagged within a week and the season closed.

HONOLULU, May 21.—Kahuku Japanese are all on strike, Wai- alua laborers are waiting for a reply to communication. Ewa strike slumbering. The demand of the strikers is for the dismissal of four Japanese employed as assistant chemist, carpenter, electrician and one other.

Court Decisions. In putting the seal of disapproval on the bringing of meritorious law suits Judge Kingsbury is doing much for the good of the community. In several cases lately he has discouraged a class of suits that should never have been brought. This the Judge has done in a most practical way. He simply fixes the fee of the attorney at so small a figure that no attorney would care to take a case and do the work necessary for the fee allowed.

In the Kaunimahu divorce case a most difficult problem was before the court. Mrs. Kaunimahu became converted to a so-called religion and infatuated with a leader of that sect and practically deserted her husband and her home for the preacher and the new religion. She has steadfastly refused to return to her home and does not even speak to her husband when she meets him. The whole community blames her for the broken home and the trouble that has resulted. The allowance of but twenty five dollars for legal services will act as a warning to all attorneys to bring no suits of this class against innocent husbands for erring wives. The allowance of but ten dollars for alimony and that to be paid forty days hence and then a weekly allowance of but three dollars per week will probably have some effect on the minds of erring wives should they contemplate leaving their husbands for better looking preachers.

The order of the court that the first payment of alimony be made forty days hence was a most wise provision. There has never been the slightest reason why the wife should have left her husband and she is now given a chance to return to her home where she properly belongs or if she does not do this but returns to her so-called preacher the court may consider that at some future day in making another order.

The wife testified that it is not her intention to return to her husband and if she had been wise she would have allowed the divorce granted by Judge Kepoikai to stand. As it is now she is not free from her husband with whom she does not intend to live nor is she given such alimony as she sought nor was her attorney paid such an amount as one would naturally desire for the work necessary in a divorce suit.

The above is but an instance of many suits that have been brought and fought out that should never have been contested. Some time ago an illiterate Portuguese by the name of M. S. Nevite of Waihee contested a suit brought by Governor Cleghorn for a claim of two hundred and forty dollars. Nevite lost in the District Court. His attorney appealed to the Circuit Court where the decision of the lower court was sustained. An appeal was taken to the Supreme Court but on the failure of the attorney to perfect the appeal the same was dismissed on motion of Attorney D. H. Case. In this case Nevite paid Three hundred and fifty four dollars and fifty cents as in full of the amount due for the judgement and costs and besides he paid his attorney for work that was of no benefit to him.

Whether the attorneys in these cases or in any of them were responsible for the bringing of the suits we do not know nor is it our purpose to go into that phase of the cases but we do feel that where the court discourages this class of cases attorneys will be less apt to bring such cases and will do more to discourage them than some of them do at the present time.

Haiku Fruit May Sell Controlling Interest to Hawaiian Pineapple Co.

At the annual meeting of the Haiku Fruit & Packing Co. held at Paia plantation office, Wednesday afternoon, the 12th, all the old officers of the company were re-elected.

The important feature of the meeting, however, was the proposition submitted by the Hawaiian Pineapple Co. of Oahu offering to purchase the controlling interest in the Maui company at a high figure,—the consideration to be either cash or shares in the Oahu corporation.

The Haiku shareholders will undoubtedly accept the liberal terms offered for three hundred one of the total six hundred shares.

What is practically a consolidation of the two companies will be of great benefit to both in a financial way. If the deal is successfully carried through—it is stated that the Maui company will run on the same as before without changes in management.

Manager J. C. Dole of the Hawaiian Pineapple Co. was present at the meeting.

There is talk among the shareholders of the Pukalani Dairy and Pineapple Co. of erecting a cannery on their lands at Lilikoi, Makawao, where it has an abundant supply of water.

That another cannery must soon be established in Makawao goes without saying,—not only because the Haiku institution is already

overburdened with the work of canning the products of its own fields and those of its planters (the area of which is continually increasing), but also because the government is soon to open up to homesteaders many acres of pineapple land at Haiku.

The Haiku company has already placed a limit upon the amount of fruit to be accepted from its six planters and has notified the Pukalani Co.—that it can not receive any Pukalani plantation pines after the present season.

The construction of a new cannery in the pineapple district by some capitalist of large means would undoubtedly prove a most lucrative investment.

Some of the best musical talent in Wailuku has been obtained to render solos between the acts. A dance will follow the performance, which will give the young people a chance to further enjoy themselves.

The Catholic Ladies Aid Society is hoping by these means to raise sufficient funds with which to renovate and enlarge the buildings of the St. Anthony's Girls School, which are in need of repairs. The Catholic Sisters, who are in charge of this school, wish to extend their work in educating young girls, but have not been able to do so owing to lack of room. Those who appreciate the good work of the St. Anthony's Girls School are now given an opportunity to assist the school.

Tickets for the performance are now on sale by members of the Society. Reserved seats are being sold at one dollar each and general admission ticket at 50 cents.

BY AUTHORITY.

ORDINANCE NO. 14.

AN ORDINANCE TO AMEND SECTION 18 OF ORDINANCE NUMBER 7, ENTITLED:—"AN ORDINANCE RELATING TO THE REGISTRATION, IDENTIFICATION, USE AND OPERATION OF MOTOR CARS; AND THE EXAMINATION AND QUALIFICATION OF CHAUFFEURS."

Be It Ordained by the Board of Supervisors within and for the County of Maui, Section 1, Section 18 of Ordinance Number 7, is hereby amended so as to read as follows:

"Any person violating, or failing to conform to, any of the provisions in this Ordinance contained shall, upon conviction thereof, be fined in a sum not less than Five (\$5.00) Dollars nor more than One Hundred (\$100.00) Dollars, together with costs of Court, and in event of default of payment of such fine and costs, shall be imprisoned until the same shall have been discharged by operation of the general laws applicable to such cases."

Dr. Currie Offered Brinckerhoff Job.

Honolulu, May 8.—Dr. Donald H. Currie, of the Marine Hospital Service in this city, has been offered the position in charge of the leprosarium on Molokai, according to a well defined report which reached this city yesterday. It is understood that Dr. Brinckerhoff, who holds this position at present but has recently submitted his resignation, will accept a subordinate position in this city in the same branch of the service in which he will handle laboratory work and which will not call for visits to the Settlement.

When asked about the report this morning Dr. Currie stated that he neither cared to affirm nor deny its truth at present, as no final decision had been made. He stated that on Tuesday Dr. Hobdy was expected to arrive by the Mongolia to assume charge of the local quarantine work, which would relieve him of that duty and that after that time he might know something more definite.

Dr. Currie has been in this city for some time and has handled the bacteriological end of the quarantine work, though of late, during the illness of Dr. Moore, he has been in charge of the entire work of the quarantine station. Personally he is very much liked by those who know him, both socially and in a business way.

Senator Warren Blocks Woodruff.

Honolulu, May 8.—The fight between Senator Warren and ex-President Roosevelt is assigned as the cause of the holding up of the appointment of Woodruff as Federal Judge of Hawaii, by those best informed in this city. It is known that the fact that Roosevelt sent in the name of A. L. C. Atkinson for U. S. District Attorney three days after he had publicly announced that he would make no appointment but would leave it to his successor, caused a rupture between Warren and the then occupant of the White House. As the result of this Warren failed to call at the White House when Roosevelt retired from office.

It is also known here that Woodruff is a protégé of Roosevelt's and that the latter had written of him to Governor Frear before he left office. It is believed that Warren is getting back at the ex-President for his breaking of faith in the Atkinson nomination by holding up Woodruff's name. This would be very easy for him to do, as his colleague, Senator Clark, is the chairman of the Judiciary committee of the Senate, to which the nomination would be referred.

In case the Woodruff nomination should be held up it seems likely that another name will be sent in to the Senate, for President Taft has shown already that he does not care to involve himself in any of the fights with Congress which were the shining feature of the past administration. If this is done it is thought that some local man may have a good chance to slip into the Federal job.

It has also been mentioned that the fact that two Federal judges in Missouri are threatened with impeachment might mean that Woodruff himself is having a hand in the holdup, believing that he might obtain one of those positions, which would be better in every way, instead of the place on the local bench.

Those who are familiar with Judge Woodruff's career state that it is doubtful if he expects to remain in this Territory for any length of time even if appointed, but that he is simply taking the position as a stepping stone to something higher, believing that the judicial training here will put him in line for the next vacancy on the mainland.—Star.

Shocking Poster Girl Must Go.

CHICAGO, April 27.—Unless the spicy little lady with the "very little dressing" climbs down from her vantage point on the billboards or has her skirts trimmed a little less diaphanous, she may be "pinched." The Cook County League of Neighborhood Clubs has officially looked the little lady over and found her wanting—wanting both in clothes and respectability. At the league's annual meeting resolutions were adopted describing the spicy person with the diaphanous garments as not only "improper" and "indecent" but "low and licentious and a menace to the morals of the young." The league members think that will hold her for a minute or two.

Furthermore, the league appointed a committee, headed by Mrs. E. M. Henderson of the University of Chicago settlement, which will call on State's Attorney Wayman and point out to him not only the little lady's shortcomings but her short skirts.

The State's Attorney will be asked to get out a squad of his sleuthiest sleuths and chase the little lady down out of that tree to her bathroom, to which point, apparently, she was headed when she stopped to climb up here.

Many Cases Are Decided

(Continued from page 1.)

The Court finds that in the main the said plaintiff is to blame for the trouble, for the disagreements and the separations that have taken place between her and her said husband.

The court finds that the plaintiff and the defendant are husband and wife and that the husband has only such duties to and obligations in the premises as are laid upon the husband for the benefit of the wife, even if the wife is an erring wife.

The Court does not find any sufficient grounds for granting a divorce to the wife in this case from her husband.

The Court finds that the husband should pay the costs of the suit, should also pay to the attorney for the plaintiff an attorneys fee of \$25.00, should pay within forty days from the filing of this decision to the plaintiff for her further support and maintenance the sum of \$10.00 should pay to the plaintiff for her support and maintenance on the Saturday of each week beginning with the 26th day of June next the sum of \$3.00 until further order of the Court.

A. S. Medeiros v Antone Costa Medeiros.

This suit was one for summary possession of a piece of land leased by the plaintiff to the defendant. The plaintiff gave as a cause of action the failure of the defendant to perform his part of the contract and on the same being established to the satisfaction of the court the judge docket for the plaintiff.

D. L. Levi v Makalei.

This was a suit in ejectment to recover two lands occupied by the defendant. The Court found for the plaintiff and awarded damages to the extent of \$1.00.

Territory of Hawaii v Akaboshi.

Akaboshi was before the court on an appeal from a sentence in the District Court for practicing medicine without a license.

The defendant was arrested some months ago for practicing medicine without a license and was advised to plead guilty and sentence was suspended. About the first of this year he was again arrested and when the matter of the first sentence came up he was sentenced on that ground. He offered to give testimony in this case but was not allowed to do so by the court.

The Circuit Court found on appeal "That as a matter of law, under the citation of the said summons the defendant having appeared there should have been a hearing and some evidence should have been presented the court before sentence could be pronounced.

The judgement, action and proceeding was erroneous and is set aside.

Immediately after the rendering of the decisions attorney Case stated that while a case in which he appeared was the first on the docket there was present County Attorney Kaeo of Kanai who had a case which he wished to present and return to Honolulu on the evening boat and therefore gave way for the visiting attorney. Mr. Kaeo presented his case to the court. There was no appearance of the defendant.

Hackfeld and Company sued Ishimaru for the amount of two notes. Attorney D. H. Case represented the plaintiff. The testimony showed that the defendant had gotten insurance to the extent of \$1,000.00 on his Market Street property from Hackfeld and the policy had been delivered but that the defendant, Ishimaru had not paid for the policy as he had agreed to. Later he had executed two notes for the amount of the premium but had failed to pay either the notes or the interest thereon.

Attorney Correa represented the Japanese defendant. The defense was that there was no consideration for the notes. Correa tried to go back of the time of the execution of

the notes and prove the nature of some conversation that took place between the defendant and the agent of Hackfeld who afterward got the notes from the defendant. The Court objected to listening to any such cross examination. Judge Kingsbury criticised Attorney Case for introducing unnecessary evidence but what he said to Mr. Case was a compliment as compared to the rebuke he handed Correa before the case was closed.

Attorney Correa asked permission to leave the room with his client for a few moments and on his return stated that he had rested his case.

As Attorney Correa did not cross examine but one witness and put on no witness whatever it is evident that he intends to take an appeal to the Supreme Court.

Attorney Harrison of Honolulu appeared for a Japanese woman who sought a divorce from her husband on the ground that he had attempted to cut open her head with a hoe at Spreckelsville some two years ago for which offense he had been sentenced to jail for two years at hard labor.

The woman testified that she had lived alone since the trouble with her husband at Aiea and was employed there as a laborer in the field.

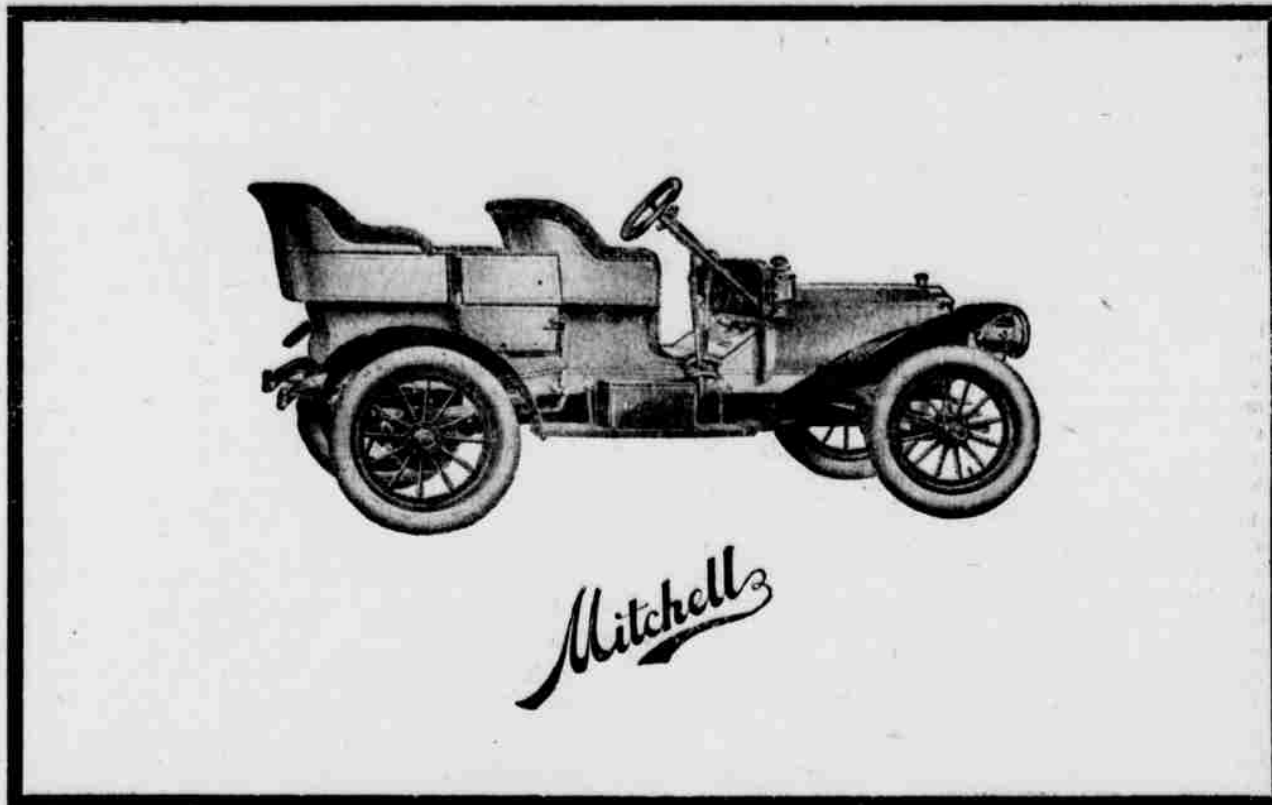

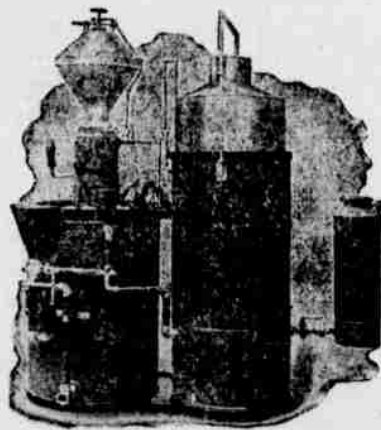
