STILL FUMIGATING VESSELS.

The fumigating plant at the quarantine wharf has been busy today pumping sulphur into the various sailing vessels. The barkentine Archer was fumigated this morning, and the bark Santiago is to be fumigated this afternoon.

CHINA'S NEW CAPTAIN.

Captain Seabury will probably not be in command of the China when she arrives from San Francisco this trip, as he is thought to have gone to Newport News, Va. to take command of the Korea and bring that vessel out to San Francisco.

THE KAILUANI ARRIVES.

The steamer Kailuani arrived yesterday morning from Hawaii ports with sugar. She reports having seen the bark S. C. Allen becalmed off Molokai the day previous. Good weather on Hawaii is reported by the vessel. She took 50 head of cattle to the leper settlement.

MAUNA LOA SAILING POSTPONED.

The Mauna Loa will not sail on her regular run on time today but will depart tomorrow at noon. She has not discharged all of her sugar, as yet. The steamer Noeou is taking freight for Kailua, Napoopoo and Honuapo and may be sent out today to those ports, as there is an unusually heavy consignment of freight for Maui and Hawaii ports.

BEHIND THE SCENES.

Some weeks ago a party of prominent Los Angeles society people were permitted behind the scenes between the acts of one of the Neill performances at the Burbank theatre and became deeply interested in the arranging of the stage settings. Mr. Neill is a most careful and particular man regarding his stage settings and is usually able to produce some marvellous and beautiful results and on that particular evening was concerned so much time in the personal supervision of the arrangement of his "properties," as all things except the scenery used in stage scenes are called, that his society auditors in the wings became quite restless. The wife of a very prominent Eastern millionaire who was among the interested ones then said to him: "Mr. Neill, why are you so particular about your 'properties'?" Why is it necessary to have three potted plants over there instead of two? Why should there be three rows of Chinese lanterns strung across the stage so accurately, instead of two? Why should those slippers be at the right of the fireplace in that last act, instead of in front of it? Considerably annoyed at this onslaught Mr. Neill replied: "Madam, as I have no talent, I must depend upon my properties for success."

CHARGED WITH ROLLING DRUNK.

Kaahue, a female of Hawaiian extraction was before Judge Wilcox Wednesday to answer to a charge of larceny in the second degree. J. Ramos charged her with abstracting \$38 in cash from his clothes, while he had jag on at Ewa. She was committed to the circuit court for trial.

ATTACKS SPENDTHRIFT ACT.

Attorney George A. Davis has made an appeal to the Supreme Court from the decision of Judge Humphreys, refusing to terminate the spendthrift trust of W. A. Hall. The spendthrift trust act is attacked as unconstitutional.

GERMAN POOR WILL SUFFER.

BERLIN, November 16.—All signs indicate that there will be much suffering among the working classes in Germany this Winter. The authorities of this city estimate that there are 35,000 unemployed persons in Berlin, and from all sections of the country come reports of people seeking work. Statistics show that an average of two persons inquired for every vacant job in October, and the number of unemployed has increased since then, several iron furnaces and other establishments having recently discharged men. The various German states have begun investigating the number of unemployed, preparatory to establishing relief works.

The latest experiments with electric locomotives between Berlin and Zossen show the engines have reached a speed of 100 miles an hour. The experiments have been suspended until a heavier track is built.

NEW AUTOMOBILE RECORD.

NEW YORK, November 16.—Henri Fournier, the French automobilist, established a new world's official record for one mile today, covering the distance in 51 4/5 seconds. The record was made on the straightaway course over the Coney Island boulevard, between Prospect Park and the ocean. This is the fastest official time for a mile not run on rails.

PEACHED ON THE HUBBYS.

PENDLETON, Or., November 16.—Papers are prepared, ready for filing, in a suit against a woman in Pendleton who has, it is alleged, written 23 letters to married women here, in which she tells them of actions of their husbands which she affirms she knows to have been committed, of questionable character. She makes a specialty of keeping tabs on married men, while their wives are absent in the mountains or at the seashore, and reports their escapades alleged to have been indulged in during the summer months. One of the men who received a letter

instructed a prominent attorney to commence suit, and also asks that criminal prosecution be commenced against the author of the letters, under a statute that makes such offense punishable with imprisonment in the State Penitentiary. It is understood that proceedings are withheld for the time, but that the papers may be filed within a few days, unless there be a decision to the contrary.

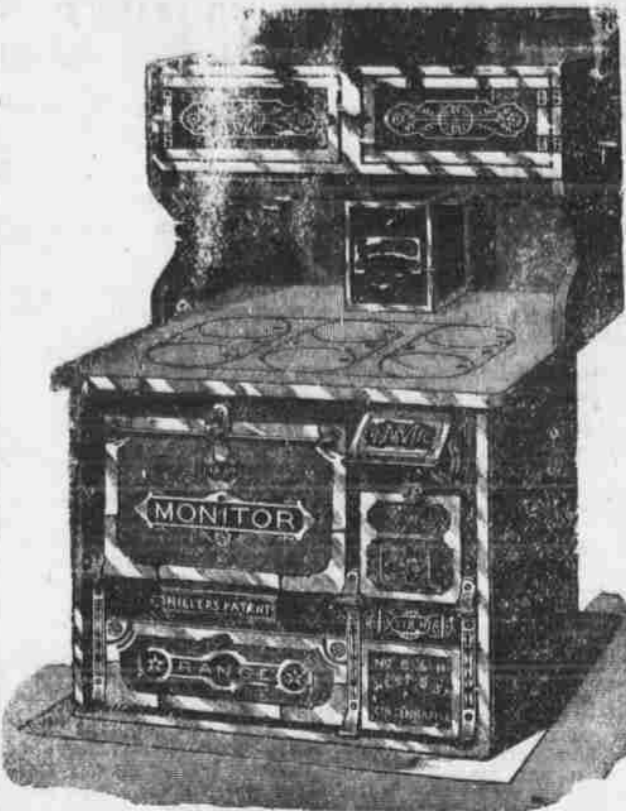

After dinner generous packages of candy were distributed, and then with the same banners, but if possible, more noise, the boys marched back to The Star office, where the coaches, four-in-hand busses, and strong voiced fish horns awaited them.

The appropriate decoration of the busses, and the distribution of horns took but a short time, and then they were off, under adult escort, for a noisy, boyishly boisterous, and enjoyable drive around the city, and out to the football game. They made it manifest wherever they went, and they went everywhere, that they were The Star newsboys. Fish horns and voices left no doubt that they were enjoying themselves. But wherever they went, and throughout the day, they behaved themselves with most becoming orderliness. INDEPENDENCE DAY.

Little Portugal Will Celebrate Its Anniversary.

Sunday is Portuguese Independence Day, held in celebration of the breaking away of that nation from Spanish rule in 1640 through a successful insurrection assisted by the English.

This is the two hundred and sixty-first anniversary and will be celebrated by practically the whole Portuguese community. Tomorrow evening a ball will be given in San Antonio Hall on Vineyard street and on Sunday a reception will be held in Lusitana Hall, Alapai street when speeches commemorative of the deeds of their ancestors will be made.

Portugal was not always under Spanish rule and at one time was the center of maritime affairs falling a victim to the exhausting demands of her colonies on the home country for laborers, soldiers, officers and statesmen. A disastrous war with the Moors in 1578 left the country without a sovereign or an army and the Spanish took advantage of the unprotected condition of their neighbors to usurp the throne which they succeeded in holding for sixty years only.

HONOLULU THANKSGIVING.

Thanksgiving Day was observed very generally in Honolulu. There were appropriate services in all the local churches in the morning and in the afternoon sports of various kinds furnished amusements. The Star newsboys were the guests of the paper at dinner according to custom, and were taken to the football game after they had eaten all the turkey they could hold. THAT EXTRA SESSION.

The opposition to the Governor has given up the cry that the Governor is incompetent to carry on the business of the Territory, having found him very competent indeed, and it now resorts to the extra session fad and the cry of un-American as a means for keeping together an opposition which is disintegrating as surely as 'snows melts off a dyke' according to the Scotch phrase.

The Legislature certainly would not inspire the Governor or any conservative man with confidence. It wasted its time, it quarrelled constantly, it did its best to insult the Governor, it inveighed against the entire business community, it delayed important bills, it passed ridiculous and frivolous bills, and it failed to provide means for the future. The latter course it took because the dominant party in the Legislature thought that it could bulldoze the Governor into an extra session. As the Governor can not be bulldozed, there is pain and grief in the opposition camp.

That this should be so is not to be wondered at. The legislative session was a good much cow. The two sessions cost the Territory over \$90,000, a higher price than had ever been paid before, and one must say the results were considerably worse than they had been before in the history of the Islands. It was a heavy price paid for a very inferior article. The sessions enabled members to make more than their salaries, and by multiplying posts enabled them to provide liberally for hangers-on. Moreover certain kinds of business could be thrown into partisan hands. It was a halcyon time, and the pity of it, from the home ruler point of view, was that it could not last all through the biennial period. Withholding necessary funds was the club which the Legislature used to continue this state of things, which was by no means pleasing to the tax-payers, however pleasing it might be to the Home Rulers and their hangers-on.

If there was one thing which disappointed the Home Rulers more than another it was the results of the income tax. There were the wildest hopes in their ranks that it would not be paid or else that it would be so tied up by litigation that it would be difficult and well nigh impossible to collect. These hopes proved fallacious. Though at first the tax was fought, it eventually was pronounced constitutional, and it proved the easiest tax to collect that we have had. It was a terrible blow to the Home Rulers when the funds rolled in. They had not said so much about an extra session just before the collection of the tax, but the moment they knew it was successful, or was certain to be successful, the howl about the extra session resounded dismally through the air.

The Legislature appropriated certain sums of money for various public works, and for salaries. When the Legislature closed it had managed by its own extravagance to make a big hole in the Treasury, and till November the Treasury was crippled, but it could manage to get along by putting off a certain number of payments, and by borrowing under the law, till the taxes came in. This tide over the main difficulty for the time, and it will now be smooth sailing for a time. The expenditures which have been made are those authorized by the Legislature. There has been no expenditure made not authorized by the Legislature.

The case of the Fire Claims Committee, to which allusion is so constantly made, is a peculiar one. The work was nearly done, and a very small amount would finish it. If the work were not finished it would require probably a new set of men to complete it, and the present staff had the experience which a future staff would not have. It was to the interest of the business community that the question of fire claims should be settled, it was to the interest of many poor people that they should be settled. The sum in question was \$4,000. What extra session favors desired is that that session should be called at an expense of some \$50,000, to vote that \$4,000.

The tax-payers of the country, the men and women who supply the main sinews of the finances do not want any extra session. The Governor is within his legal rights in refusing an extra session. Under these circumstances it is not likely that the Home Rulers will carry their point. Noisy gas blowing does not win political points.

NOT SO GLOOMY.

Yesterday's celebration of Thanksgiving was an entire success. The day was everything that could be wished, and the whole town was en fete. To count the number of dinners, to watch the equipages, to see the full cars, to admire the pretty dresses, certainly did not argue that the Honolulu community was "bust" or anything like near "bust." There was probably more kindness of feeling shown to those whose means were not good, to widows, orphans, and the frankly unfortunate, than has ever been shown on any previous Thanksgiving Day.

That there is stringency in money for speculative purposes is true, but that there is such woful need of cash, such utter depression all over the community as some croakers would make out is not true,

and there can be no better indication than to watch the people at their holiday. Well dressed, well fed, with money in their pockets to pay for amusements, filling the football field, filling the Orpheum, filling the theatre, wandering with well laden lunch baskets in Kapiolani Park, or up Pacific Heights, these people were very evidently far removed from the position which would force them to save every quarter, and upon whom the depression was weighing like a pall and choking the merry laughter of the very children.

We have been through several periods of depression during a generation. When the last of the whaling fleet was lost in the ice up north, twenty-two vessels being crushed and a whole season's catch being destroyed, it looked very black for Honolulu, and money became mighty scarce in Honolulu. The new industry of sugar was undeveloped, and it seemed as if there was nothing but ruin before us. We got over that. We again had a period of stringency when, after reciprocity there came a time when the plantations had to be carried till they could pay, and the croakers again croaked ruin and disaster, but the plantations were carried, and made big returns, and prosperity shone once more upon us. Again in the early nineties there came a period of depression and every one was going to be ruined, but far from that the enterprises which the croakers were sure would go under did nothing of the kind, but boomed up and returned to the investors, like the seed which fell upon good ground, some "thirty fold, some fifty fold and some one hundred fold."

It is the same with us now. If we listen to the croakers we should imagine that we are really up against it, but we will come all right in time. It is not as if we had been booming wild cat mines and impossible investments. We have the finest and most productive of property. This property we shall begin to realize from in the near future. Look at the cane fields of Oahu, Honolulu, and Waiailua on this Island. They are going to yield as fine if not finer returns than Ewa. Look at Olaa on Hawaii, or McBryde on Kauai, they are magnificent properties, well managed, and in the pink of cultivation.

All these are new plantations. It takes time for agricultural and manufacturing enterprises to develop. They bring magnificent returns when they are developed as we have seen in the past, and shall see in the future. Our last year's crop was the largest we ever had, our present crop will exceed anything in our history. As an integral portion of the United States we stand in a better position than we ever have.

There are always politicians who take advantage of a momentary depression to use it for political purposes. This is being done now, but in a very few months we shall see a very different condition of affairs. One of our keenest business men, connected with both the sugar and the mechanical industries of the Territory said the other day, that he expected the situation to ease up very much by the month of March, 1902. That the croakers are not having it all their own way was shown by the attitude of the people yesterday. There was no hooding melancholy, but everything was bright, joyous and showed every sign of a prosperity which has not left us. Let us learn the lessons of the past and keep up good hearts.

When once a cargo of coal takes fire it is a hard thing to put it out. The Roanoke was fortunate in getting into port. Then after the cargo was partially discharged she took fire again. That scientist of whom The Star spoke some days ago, is sadly needed.

Every one will agree with Judge Gear that it is a pity that Jonah Davis, who so brutally cut a boy in the arm, was not so charged that he might have received a stronger sentence. There may have been reasons, however, which would have prevented the heavier charge sticking.

Judge Estee and the jurors upon the condemnation of Pearl Harbor lands took a trip to the scene of litigation on Wednesday. Yesterday they had time to digest what they saw, and today they will be in fine fettle to listen to the lawyers. It is a very important case for all land holders.

The meaning of the annual Thanksgiving day, a thoroughly American day, was carefully impressed upon the public school children in the various schools. As the American holidays come on this plan of teaching the children the true meaning of the celebrations is carefully followed out throughout the schools of the Territory.

It is a pity that the football game of yesterday should have given a display of un-sportsmanlike conduct upon the part of some of the players. The only way in which amateur sport can be kept clean is by sternly repressing their kind of thing. The matter is in the hands of the amateur athletics themselves. If they desire their sport to take ground with sporting events on the mainland, they will support those in authority who put a stop to un-sportsmanlike conduct. If not, their position as sportsmen will seriously deteriorate.

Mexico is slowly but surely exchanging her Spanish caste of civilization for one which is purely American in character.

President Roosevelt promises to visit the Puget Sound country next year, the prospect of hunting elk in the Olympic peninsula having something to do with his desire to come.

QUEEN STREET LAND

THE SUPREME COURT FIXES A
VALUATION.
Pratt's Valuation of \$3 Per Square Foot
is Reduced to \$2.20—Shaw's High
Figures.

The Supreme Court has rendered a
decision in the appeal of James Robin-
son from decision of the Tax Appeal
Court, fixing the value of some Queen
street property, which Assessor Pratt
placed at \$3 per square foot, the total
being \$163,800.

The property in question is on the
makai side of Queen street, between
Fort and Nuuanu and extends to 100
square feet of land. It extends to the
water front and is partly occupied by
stores, partly by offices and a lumber
yard and wharf. It was valued by
Assessor Shaw at \$270,000 and was re-
turned by the owner at \$80,000. The
Supreme Court, in an opinion given by
Perry and concurred in by the other
justices, says:

"The land in question is situated on
the makai side of Queen street between
Fort and Nuuanu streets, and extends
to the water of the harbor. A portion
that facing on Queen street, is occupied
with stores and other business
purposes. The large area in the rear
is used for the storage of lumber and
the remaining portion as a wharf. The
latter is of a sufficient length to accom-
modate a vessel 225 feet long. The
stores are under leases for short terms
and the lumber yard is subject to a
lease for 15 years with one and one-
half years of the term unexpired. The
wharf proper is not leased, the estate
collecting wharfage therefrom from
time to time as it is used. The total
income from the property for the year
1900 was \$3,071, being \$5,340 from rents
and \$2,731 from wharfage.

"The evidence adduced is meagre and
unsatisfactory. The assessors' estimate
of \$3 per square foot is unsupported
by any facts sufficiently proven. There
is no evidence from which we can
ascertain with certainty how much, if
any, the present rental value of the
property exceeds the income derived
therefrom last year or from which a
correct valuation may be intelligently
arrived at by comparison with the
value of neighboring land or of prop-
erty similarly situated. The only testi-
mony tending to show that the valuation
placed by the Tax Appeal Court is too
low, is that of M. P. Robinson, a part
owner, and the only witness on behalf
of the owners. In answer to the ques-
tion 'What do you consider that
wharfage property worth as a whole?'
he testified: 'For taxable purposes, I
should be satisfied to pay taxes on
\$120,000. I would have to get 50 per cent
more than the present rent to make it
that price.'

"The witness evidently was of the
opinion that the property is capable of
producing a larger income than it pro-
duced last year and that to apply in
this case the eight year rental rule
would be manifestly unfair and unjust.
In view of this testimony we reverse
the decision of the Tax Appeal Court
and fix the valuation for the year
1901 at \$20,000.
The value fixed is about \$2.20 per
square foot.

YALE AND PRINCETON

HOW THE GREAT GAME WAS
PLAYED.
The Sons of Eli Were Fit in Their
Training and Matchless in Their
Team Work.

In the Yale-Princeton game aside
from the general excellence of the Yale
team, the feature of the play was to be
found in the entire absence of unfair
tactics. During the game, lasting nearly
two hours, including the intermission
and the time taken out by delays re-
sulting from injuries, two penalties
were imposed, the rival teams being
equally guilty.

The game was won by Yale as a re-
sult of the simplest kind of old-fashion-
ed football, rendered effective by entire
consistency in team play, and a phys-
ical condition which enabled the Sons
of Eli to "last" through a grueling contest.
Princeton, on the other hand, displayed
a tendency to go to pieces at times, and
throughout the game her men required
frequent nursing. Yale played through-
out the 70 minutes of actual time with a
single change. Princeton found it
necessary to call upon seven substitutes
and the introduction of these half-dozen
fresh men enabled her to make a superb
finish of a contest which had been at-
tached uphill. Yale's goal line was
never in danger. Indeed, the Princeton
players never reached a point nearer
Yale's goal than the 30-yard line. Yale
scored two touchdowns, one in each
half and each of these scores was con-
verted clearly into a goal by Olet.
Yale's touchdowns came as a result of
a superbly developed system of line-
plunging. The famous tackle back for-
mations in all their variations netted
the greatest gains. Yale's backs, as-
sisted by as sprightly a set of forwards
as could be asked for, found holes in
the Princeton line which enabled them
to make gains when they once found
their pace, and touchdowns were in-
evitable with the magnificent team
work displayed by Yale. Yale's first
touchdown was made after about 15
minutes of play. A fumble by Princeton
at the center of the field gave Yale
her chance, and, seizing the ball on
Princeton's 50-yard line, the Yale men
in 10 plays forced the ball over for the
first score.

Yale required about 20 minutes of play
in the second half to score the second
touchdown. This score, like its pre-
decessor, came as a result of straight foot-
ball, made possible by great strength
and superior team play. Honors were
evenly divided as to kicking. DeSaulles
the little Yale quarterback, holding his
own amazingly well with Dewitt. In
the handling of kicks, Princeton ex-
celled a trifle. In the matter of scrim-
mages, however, Yale's play was im-
pressively cleaner. Princeton time and
again losing the ball on deplorable fumbles.
Throughout the game the play
was largely in Princeton's territory.
From the kick-off at the game Yale
did not let up until the first touchdown
had been made. Then she resorted to
the kicking game, and the scrimmages
were confined to the middle of the field.
So, too, in the second half the New
Haven boys clung to the ball amazingly
and confined the play to the Tigers'
territory until another six points and
was added to the Yale score.

When the score was 12 to 9 against
them, the Princetonians disclosed that
"never-say-die" spirit which so often
has won great victories in the past and
gave a superb exhibition of "last-ditch"
fighting. Unquestionably beaten, and
with seven-eighths of the team sub-
stitutes, the heroes of Old Nassau went
at it and fairly lifted the Yale men
from their feet. Then it was for the
first time in the second half that the
Princeton men forced the play into
Yale's territory, and for the last 15
minutes of the game Yale was decidedly
on the defensive. Barn-door holes were
torn in the hitherto invincible Yale line,
and amazing distances were gained by
the New Jersey men. Their braces had
come too late, however, and time was
called for the last of the game.

MUST SPEAK ENGLISH

DOCTORS HAVE TO KNOW THE LANGUAGE.

Board of Health's Rat Committee Makes Its Report—Poison and Traps To Be Generally Used.

The Board of Health on Wednesday adopted a rule that all examinations of physicians must be in the English language. This means that no licenses will hereafter be issued to doctors in the islands except to those who can understand English. The rule was opposed by Attorney General Dole and E. A. Mott-Smith, but the three doctors on the board, Drs. Slocum, Cooper and Moore, voted them down.

In behalf of the committee appointed to report on the rat crusade Dr. Cooper made a report as follows: "Rats being the principal agency for the transmission of plague and our exposed situation in relation to other countries that are infected, making it necessary to take every precaution for the preservation of our commerce and internal well being, your committee on the crusade against rats, consisting of Dr. Pratt and myself and by courtesy Dr. L. H. Cofer, of the United States Marine Hospital Service, whose labors and advice have been most valuable, beg to report, that after much labor at last tangible arrangements have been made for the protection of commerce by the united action and guarantee of funds by those most directly interested in shipping, and also ways and means have been provided for warfare on the rodents in the business and residence portions of the city.

"By the short sightedness of the late legislature to provide for emergencies of this nature only \$10,000 was allotted for the biennial period, to protect the interests of these islands and that sum to be specifically used for fumigation. "As it cost in a recent epidemic over \$800,000, exclusive of fire claims, it can be easily seen that this department is more than handicapped to do good work, by such a paltry sum.

"It is proposed to put the wharves in such a permanent condition as to render fumigation an easy matter and render our shipping interests safe and with a practically clean bill of health. It is proposed also to engage a few good men for work in the more thickly populated districts to distribute rat poison and instruct in the placing of traps, setting and care of traps and such other work as may arise in that line.

"It is also hoped to procure a 12 horse power engine with a sulphur fan which can be placed on a truck making it thus easy for transportation, to be used when necessary for fumigation.

"The Board of Health will furnish free rat poison to all applying for it and every one able to purchase their own traps are expected to do so and thus aid the Board in this crusade. Traps will be furnished to the indigent, it is useless to expect favorable results unless there is concerted action by the entire community."

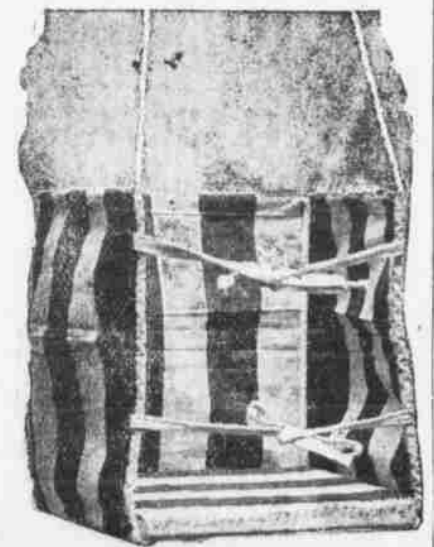
