## YOUNG MEN DID IT.

They Saved the Union in the Irrepressible Conflict.  
Young men and women, before you go forth to-day to decorate the soldiers' graves, please stop and consider who they were. Old men? No, a thousand times no; young as you are now, for the most part. Old men don't go to war. Your flag was saved untarnished and your country preserved undivided by young men about your own ages. Did you ever think of that? I do not wonder; I do not blame you for speaking of the "old soldiers' graves," because many of the dear old comrades whose funerals you have witnessed were old men when they died. Now and then the Grand Army of the Republic marches out to the cemetery with muffled drum and arms reversed to bury a comrade to whom death is the very best friend—for he was old and wrinkled and gray with years and infirmities. But remember that only a very small proportion of the soldiers whose deeds of glory we commemorate to-day, and whose graves we garnish with the fairest flowers in the land, ever felt the touch of age before they felt the hand of death on their pale brows.  
For the most part our heroes were only boys. Six hundred thousand of them died during the war, 100,000 in battle, 100,000 in rebel prisons, 400,000 in hospitals or at their mother's side, the young and beautiful martyrs of the Union! To be sure there were a few, a very few old men in the army, and of course some of these perished in the great conflict; but where there was one such, there were 50 boys under 20 years of age. The probable average age of the boys in blue was 22, more under than over that age, so that nearly all who fell in the war perished in their youth and beauty. Of 12,462 who starved to death for the flag at Andersonville, not 10,000 were old enough to vote. Of 6643 killed and wounded at Gettysburg, and of 11,030 killed and wounded at Chancellorsville, the majority had not seen their 20th year. Those therefore who died during the war were either lads or for the most part very young men.  
But what of the million who died since 1865? A vast majority of them never saw their 35th year! With a few exceptions they died in the vigor of their young manhood. They gave their years for you and me as truly as if they had perished in the fierce and raging turmoil of the battle. Do not think of them as old men, whom death would have claimed long ere this if war had never burst upon us with all its horrors. From this time on, the three parting shots will echo only above veterans of full age, and by and by over our venerable, gray-haired men, for our average age (of the million Union soldiers yet surviving) is about 51 or 52 years—rather under that, over that. Many of us are already very old, and all of us are aging fast, but we never think of the comrades gone before but as young men, "in the morn and liquid dew of youth," the bravest and strongest young men the world ever saw.—Private Dalsell of Ohio.

## THE CODE OF PEACE.

Worthy Effort of Sir Charles Russell at the Behring Sea Tribunal.  
Sir Charles Russell concluded his argument in behalf of the British case before the Behring sea tribunal of arbitration at Paris Wednesday. He said that this was the first occasion upon which a nation had claimed property in a free swimming animal. The contention, Sir Charles declared, was untenable, and its advancement was derogatory to the principle of freedom of the seas. It was an extravagant and unfounded pretension that international law sanctioned the seizure and condemnation of the vessels of a friendly power. Existing international laws were an effective and noble instrument to serve the just purposes of mankind in the adjudication of their rights. He appealed to the tribunal to declare that it could not make law. Sir Charles in his peroration dwelt upon the importance of the arbitration here submitted to by the two great powers, one representing old world civilization, great in extent of dominion and greater in long enduring traditions of liberty, the other a young but stalwart member of the family of nations, great also in territory and almost boundless in the resources, genius and enterprize of its people, and possessing enormous powers for good in the future of the human race. Their presence as friendly litigants is a fact of great moral significance, and their submission to arbitration is a victory for peace, as the award will be, if it leaves the principles of international law untouched.  
At the close of Sir Charles Russell's address the president of the court, Baron de Courcel, spoke in complimentary language of the ability and eloquence which Sir Charles had displayed in his protracted argument. Ex-Archbishop-General Sir Richard Webster followed Sir Charles Russell in behalf of the British case.—Exchange.

BY AUTHORITY.

ACT 40.

An Act to Increase the Facilities to Depositors and Providing for Term Deposits in the Hawaiian Postal Savings Bank.

BE IT ENACTED by the Executive and Advisory Councils of the Provisional Government of the Hawaiian Islands:

SECTION 1. The Postmaster-General, as Manager of the Postal Savings Bank, with the consent and approval of the Minister of Finance, may issue to any person Term Deposit Certificates in the name of the Hawaiian Postal Savings Bank for deposits of not less than Five Hundred Dollars nor more than Five Thousand Dollars.

SECTION 2. The amounts so deposited shall draw interest at a rate not to exceed six per cent. per annum to be computed in accordance with the law regulating the Bank. Such deposits shall not in the aggregate exceed \$150,000 at any one time.

SECTION 3. The term for which any deposit shall be received under this Act shall not exceed twelve months.

SECTION 4. The form of the said certificates shall be as follows, and shall contain the conditions hereinafter set forth:

HAWAIIAN POSTAL SAVINGS BANK CERTIFICATE. No. .... Honolulu, 1893. Received from ... Dollars on Deposit, payable in ... months, and will bear interest from ... at the rate of ... per cent. per annum, and in accordance with the conditions printed hereon.

Present this Certificate at the Postal Savings Bank at the expiration of the term stated herein. Interest will cease at that date. Holders at a distance may endorse this Certificate and send by mail to the Postal Savings Bank, when it will be paid.

With reference to the letter in this issue on the financial exhibit, it is known, incidentally, that the Minister of Finance is collecting statements of outstanding claims against the different departments.

Harper's Weekly clearly sees the point in the Nordhoff incident here. It was not the little inaccuracies afterward frankly acknowledged which Mr. Nordhoff committed, but the broad facts of the situation which he stated that brought down on his head the wrath of the P. G.

One of the strange sequels of the recent labor troubles in Australia is a movement to start a colony of disappointed people from that country in Paraguay. The strikes were maintained to their failure by a minority

of the working people and caused untold suffering and loss. If the participants therein are to be the emigrants to Paraguay exclusively, the movement might prove a great boon to Australia. In the meantime able writers in the Sydney papers are warning sensible people against making the hazardous move to Paraguay, where Anglo-Saxon political development would be hampered at every step by the hordes of half-civilized people who are the present inhabitants.

Among other articles that the P. G. is anxious to dispose of, to turn a ready if not an honest penny for the support of its vagrant myrmidons, are inventoried "two gilded chairs specified as thrones." Waiving whatever prospect there may be of the restoration of the monarchy by the United States, it would be an outrage to barter away the thrones of Hawaii as second-hand chattels. As historic relics alone these articles are worth vastly more than their intrinsic value.

ASIATIC EQUALITY.

By the steamer Miike Maru a short visit was paid to Honolulu by one of the editors of the Japanese Government's organ in Tokio. In an interview with the editor of this paper he was very eager to learn how Hawaiian public opinion regarded the Japanese claim for the franchise in this country. He said that in Japan the feeling was very strong among both officials and people that the voting privilege should be accorded to Japanese in the Hawaiian Islands.

The Financial Exhibit.

The U. S. gunboat Adams had an interesting boat drill in the harbor this morning.

A concert by the Hawaiian band is being given at the Queen's Hospital this afternoon.

Mr. A. M. Hewett is laid up with la grippe, and not partial paralysis, as previously reported.

A. T. Atkinson, Inspector-General of Schools, left on the steamer W. G. Hall this morning to inspect the Kona schools.

A boatboy the other day caught three dozen fine big mullet with a hook near the U. S. S. Boston. He stayed there from early morning till after noon.

The Bishop of Panopolis has not left for Maui as reported by two journals. The reverend gentleman was present at the closing exercises of St. Louis College yesterday.

The Hawaii Baseball Association has attended to the complaint of several attending the baseball games, and covered the entire front of the baseball stand with wire netting.

Mr. C. B. Dwight, lately discharged by the Minister of Interior, from the position of assistant road supervisor, has been created a luna for overseeing the construction of sidewalks.

A recent arrival from the Coast was stopped on Fort street by a fellow passenger and asked how he was getting along. "Oh, fine," he replied, "got a position in the army and \$1.25 already without doing anything."

The furniture sale at the old Arlington dining rooms, which was to have taken place this morning, has been postponed until to-morrow (Saturday), at 10 o'clock, when Jas. F. Morgan will be prepared to give his friends all the bargains they want.

Forty tons, think of it, is the weight of the merchandise to be auctioned off by Jas. F. Morgan, on Wednesday, July 12th. These are new goods belonging to the assigned estate of McKevett & Co., Melbourne, and must be sold without reserve.

Paauki was sentenced to pay a fine of \$500 a year ago for indulging in che fa, and not having the "ready" he was imprisoned at hard labor. Under a provision of the Penal Code Paauki was released this morning, it appearing to Foster and Carter, J.J., that he has no property.

The Hawaiian Dramatic Co. had a very successful rehearsal this morning, with Prof. Berger and the orchestra. There will be a dozen new songs presented in the course of the play at the Opera House to-morrow evening. It will be a performance well worthy of a full house.

A number of people who wanted to take passage on the S. S. Peru this afternoon were asked at the Custom House whether they had paid their taxes, before passports would be given them. Dr. M. L. Miner, who had only been in the country a little over two months, was told by Collector of Customs Castle that he had to see the Tax Assessor before a passport would be given him.

Rev. O. P. Emerson left on the steamer W. G. Hall this morning for the church found at Lahaina. Another meeting of the members of the Protestant church is to be held to-morrow, when another vote will be taken. If Rev. Pali's opponents carry the day and that reverend gentleman persist in refusing to surrender the church, the congregation will carry the matter into court.

Long Branch Re-opening. Long Branch was fairly patronized last night. The Hawaiian band played until it was time to leave by two special cars at 10:30. Dancing was engaged in desultorily. Several bathing parties dispersed in the waves. There was general admiration of the enlarged and improved accommodations. Mr. Sherwood may expect a rush next moonlight season. He is prepared to receive a hundred every evening. There is a spacious veranda off the ballroom, overlooking the beach, where people who do not care to bathe can sit and enjoy the sight, sound and savor of the wild sea waves.

The Lost Lamorna. In a previous issue of the BULLETIN it was reported that 25 percent, and a few days later, 40 percent had been paid for re-insurance on the bark Lamorna which left Newcastle, N. S. W., on February 24th for Honolulu. In a recent issue the S. F. Chronicle says that 80 percent premium has been paid for re-insurance on the cargo of the Lamorna. This item will set right the few who may have read the morning paper of Wednesday, which said that only 25 percent was paid.

FOUND DEAD AT EWA.

Daniel Henley Dies in the Night Supposedly from Heart Disease.

At 6:30 o'clock this morning a telephone message was received at the Police Station from Ewa, stating that Daniel Henley, who kept a little store at Kalanooa, Ewa, had been found dead by Mrs. Kapu and another native. Mrs. Kapu had gone to the store this morning when she found the door locked, and, as it was customary with Henley to open the store early, she wondered what was the matter with him. Later she went around to the rear and peeping through the window saw Henley lying on the floor.

Deputy-Sheriff Wond was notified of the fact and he soon arrived on the scene. The door was first opened and Henley was examined and found to be dead. The Deputy-Sheriff empaneled a jury and a coroner's inquest was held, but the verdict is not yet reported.

It is believed that the old man came to his death through heart disease, as he was afflicted with that ailment. Only last Saturday Dr. McKibbin had attended on him.

Daniel Henley was an old kamaaina, having been a resident here of over twenty years. In the year 1876 he was a bartender at the Empire Saloon for Mr. Jas. Olds. For the last four or five years he has been off and on a resident of Kalanooa, Ewa. Many a weary traveler has he supplied with refreshments at his hostelry. Henley was between 60 and 65 years of age, and was of Irish origin. He was married twice and twice divorced, both his wives surviving him. The old man was very popular at Ewa.

They Rob the Fishermen's Hooks—One Robber Caught. Native fishermen who go out fishing with hooks have been complaining of the depredation made by sharks on their hooks. No sooner would they hook a fish than a shark would dart at the struggling captive and nip it off the hook.

The stamping ground of the fishermen is in the vicinity of the U. S. warships Boston and Adams, where they say an abundance of fish hang around to catch victuals thrown overboard from the vessels. Yesterday, while the men were fishing in the rear of the Boston no less than six good-sized fishes were snapped from the hooks by the sharks.

Early this morning the fishermen went out as usual, notwithstanding the shark's known predilections for the fish taking their bait. One fisherman caught a fish (awa) and was pulling it in when a shark made a dart for it. Somehow or other the fish got loose and the hook was imbedded in the shark's mouth. The man gave a jerk and turned the monster over on his back, when it lay as if dead. It was pulled alongside the boat and the men managed to tie a rope to the struggling big fish's tail, planting another and larger hook in its mouth. The shark was towed to the Fishmarket, where it was found to measure eight feet from tip to tip. It was pretty lively when an attempt was made to cut it open. Japanese and Chinese purchased the carcass. The fishermen state there is any number of these sharks that live on smaller fish in the harbor, and especially near the Boston.

ARRIVAL OF THE PERU.

An Object of Interest from Having Been Built at San Francisco.

The P. M. S. S. Peru, Ward commander, was telephoned early this morning and docked at the Pacific Mail wharf. As this was the first visit of the liner to this port, many people took the advantage and inspected the new steamer through-out. The Peru was built by the Union Iron Works, San Francisco, in 1892, all her machinery also being built on the Coast. She is not as long nor as large as the O. & O. liners. Her draught coming over the bar was twenty feet. Her cabin accommodations are nice and cozy, and taking all in all she is a comfortable traveling boat.

In the forward part of the steamer the Chinese crew were offering canaries and other varieties of birds for sale, although a notice was posted up on the spar deck prohibiting the employees on the steamer from indulging in any speculation. The prices were too steep, anyway, and very few birds were sold.

The Peru had only two Chinese and three Japanese storage passengers, and 130 tons of freight for this port. She will leave again at 5 o'clock this evening for the Coast.

COURT CHRONICLE.

Matters Before Both Circuit Judges at Chambers.

In the bankruptcy case of D. M. Crowley, Judge Whiting granted the motion of bankrupt to allow him to retain articles in his house valued at \$112.

Judge Whiting appointed F. H. Hayselden administrator of the estate of W. J. Roche, deceased, under \$200 bonds.

The matter of the estate of James Gay was continued, after hearing two witnesses, until next Monday.

Judge Cooper is hearing the Banning estate matter to-day, in the room formerly occupied by the Attorney-General. Hon. S. M. Damon was on the stand this afternoon. Mrs. Banning and her son are present. Kinney for petition to revoke order of executor's discharge; Hatch for respondent.

The matter of Celestine Johnson's petition for attorney's fee, costs and alimony was continued from Thursday until Monday next.

DESERTER GETS A WETTING.

Seaman Burns Fagged in Trying to Swim Ashore from His Vessel.

Richard Burns, a young sailor on the British bark Rotterdam lying in the stream, slipped overboard with all his clothes on but minus boots, this morning. Special Pete O'Sullivan found the young lad in an exhausted condition clinging to one of the piles of the Pacific Mail dock at 5:30 o'clock, and with the assistance of a boat managed to land him safely. Burns stated that the captain had treated him meanly. He had made arrangements with the skipper to work his passage here, but on arrival he was compelled to sign articles and continue the voyage. This he would not agree to, hence his attempt to escape. Burns was escorted to the Police Station where his clothing was dried. He is still confined, awaiting action of the captain.

Y. M. C. A.

At the monthly meeting of the Y. M. C. A. last night reports were received from the different committees. A suggestion in the report of the new General Secretary, Mr. Corbett, that 75 or 100 books suitable for boys were needed in the library, was immediately responded to by Mr. H. Waterhouse, who offered to buy the books if someone else paid the freight from New York. Mr. T. R. Walker at once volunteered to pay the freight, so the lads will have their books. It was decided to maintain the work at Bethel hall, where services are held for non-church-going classes. Rev. O. P. Emerson called attention to the mission at Emma hall to be conducted by Mr. John H. Wise, the returned Hawaiian student at Oberlin, among his countrymen.

Two More British Cruisers.

Information received by United States naval authorities is to the effect that the British Admiralty is drawing up designs for two monster cruisers, which will not only be the largest warships in the world, but the fastest. They will be known as the "Terrible" and "Powerful." Each ship will have a length of over 500 feet and a beam of about 70 feet. Engines will be placed aboard each craft capable of developing 30,000-horse power. A speed of 25 knots per hour is aimed at. With these engines the two ships will be abreast in engine capacity of the new Cunard greyhounds "Campania" and "Lucaania." Their length will be less than the Cunard ships, but each of the cruisers will possess a displacement greater than either of the liners. Save for torpedo boats the speed of 25 knots per hour aimed at will place the "Terrible" and "Powerful" ahead of all speeds now attained by any vessel afloat. The cruisers are to carry an armor protection and will carry large and powerful rapid-fire batteries.—E.

TO SAVE THE HARTFORD.

The Famous Flagship of Farragut to be Fitted for Service.

A Valjejo despatch of June 18 says: The historic old warship Hartford, now lying in rotten row at the Mare Island Navy Yard, where for many years she has been the toy of the tide, is about to be taken cognizance of and put in commission in accordance with Congressional legislation. By a recent Act of Congress the Hartford and Kearsarge are to be retained on the active list of the warships of the American navy, regardless of all expense or the 10 percent repair law, which prohibits the repair of any ship of war where the aggregate cost of repairs shall exceed 10 percent of their original cost.

Before placing the Hartford in commission she will be stripped of her old-style batteries and fittings, her engines will be repaired and new boilers will be put in the fire-room. The old battery will be replaced by a corresponding battery of modern high-power guns, it being the intention of the Navy Department to equip her with six-inch rifles for the main battery, supported by a sufficient battery of four-inch rapid-fire rifles. The ship will be totally dismantled, and her sail-carrying capacity reduced from her former heavy rig to a rig similar to that of the cruiser Chicago.

The recommissioning of the Hartford is due directly to the efforts of the old naval officers who fought on her at the battles of Mobile bay, Forts Jackson and St. Philip, and who deemed it unjust to let the Hartford rot away in ignominious idleness while the Kearsarge was doing active duty on the home station.

FOUND DEAD AT EWA.

Daniel Henley Dies in the Night Supposedly from Heart Disease.

At 6:30 o'clock this morning a telephone message was received at the Police Station from Ewa, stating that Daniel Henley, who kept a little store at Kalanooa, Ewa, had been found dead by Mrs. Kapu and another native. Mrs. Kapu had gone to the store this morning when she found the door locked, and, as it was customary with Henley to open the store early, she wondered what was the matter with him. Later she went around to the rear and peeping through the window saw Henley lying on the floor.

Deputy-Sheriff Wond was notified of the fact and he soon arrived on the scene. The door was first opened and Henley was examined and found to be dead. The Deputy-Sheriff empaneled a jury and a coroner's inquest was held, but the verdict is not yet reported.

It is believed that the old man came to his death through heart disease, as he was afflicted with that ailment. Only last Saturday Dr. McKibbin had attended on him.

Daniel Henley was an old kamaaina, having been a resident here of over twenty years. In the year 1876 he was a bartender at the Empire Saloon for Mr. Jas. Olds. For the last four or five years he has been off and on a resident of Kalanooa, Ewa. Many a weary traveler has he supplied with refreshments at his hostelry. Henley was between 60 and 65 years of age, and was of Irish origin. He was married twice and twice divorced, both his wives surviving him. The old man was very popular at Ewa.

ARRIVAL OF THE PERU.

An Object of Interest from Having Been Built at San Francisco.

The P. M. S. S. Peru, Ward commander, was telephoned early this morning and docked at the Pacific Mail wharf. As this was the first visit of the liner to this port, many people took the advantage and inspected the new steamer through-out. The Peru was built by the Union Iron Works, San Francisco, in 1892, all her machinery also being built on the Coast. She is not as long nor as large as the O. & O. liners. Her draught coming over the bar was twenty feet. Her cabin accommodations are nice and cozy, and taking all in all she is a comfortable traveling boat.

In the forward part of the steamer the Chinese crew were offering canaries and other varieties of birds for sale, although a notice was posted up on the spar deck prohibiting the employees on the steamer from indulging in any speculation. The prices were too steep, anyway, and very few birds were sold.

The Peru had only two Chinese and three Japanese storage passengers, and 130 tons of freight for this port. She will leave again at 5 o'clock this evening for the Coast.

COURT CHRONICLE.

Matters Before Both Circuit Judges at Chambers.

In the bankruptcy case of D. M. Crowley, Judge Whiting granted the motion of bankrupt to allow him to retain articles in his house valued at \$112.

Judge Whiting appointed F. H. Hayselden administrator of the estate of W. J. Roche, deceased, under \$200 bonds.

The matter of the estate of James Gay was continued, after hearing two witnesses, until next Monday.

Judge Cooper is hearing the Banning estate matter to-day, in the room formerly occupied by the Attorney-General. Hon. S. M. Damon was on the stand this afternoon. Mrs. Banning and her son are present. Kinney for petition to revoke order of executor's discharge; Hatch for respondent.

The matter of Celestine Johnson's petition for attorney's fee, costs and alimony was continued from Thursday until Monday next.

DESERTER GETS A WETTING.

Seaman Burns Fagged in Trying to Swim Ashore from His Vessel.

Richard Burns, a young sailor on the British bark Rotterdam lying in the stream, slipped overboard with all his clothes on but minus boots, this morning. Special Pete O'Sullivan found the young lad in an exhausted condition clinging to one of the piles of the Pacific Mail dock at 5:30 o'clock, and with the assistance of a boat managed to land him safely. Burns stated that the captain had treated him meanly. He had made arrangements with the skipper to work his passage here, but on arrival he was compelled to sign articles and continue the voyage. This he would not agree to, hence his attempt to escape. Burns was escorted to the Police Station where his clothing was dried. He is still confined, awaiting action of the captain.

A suggestion in the report of the new General Secretary, Mr. Corbett, that 75 or 100 books suitable for boys were needed in the library, was immediately responded to by Mr. H. Waterhouse, who offered to buy the books if someone else paid the freight from New York. Mr. T. R. Walker at once volunteered to pay the freight, so the lads will have their books. It was decided to maintain the work at Bethel hall, where services are held for non-church-going classes. Rev. O. P. Emerson called attention to the mission at Emma hall to be conducted by Mr. John H. Wise, the returned Hawaiian student at Oberlin, among his countrymen.

Two More British Cruisers.

Information received by United States naval authorities is to the effect that the British Admiralty is drawing up designs for two monster cruisers, which will not only be the largest warships in the world, but the fastest. They will be known as the "Terrible" and "Powerful." Each ship will have a length of over 500 feet and a beam of about 70 feet. Engines will be placed aboard each craft capable of developing 30,000-horse power. A speed of 25 knots per hour is aimed at. With these engines the two ships will be abreast in engine capacity of the new Cunard greyhounds "Campania" and "Lucaania." Their length will be less than the Cunard ships, but each of the cruisers will possess a displacement greater than either of the liners. Save for torpedo boats the speed of 25 knots per hour aimed at will place the "Terrible" and "Powerful" ahead of all speeds now attained by any vessel afloat. The cruisers are to carry an armor protection and will carry large and powerful rapid-fire batteries.—E.

**BEATING OF THE VALKYRIE.**

Still She is Considered a Fit Competitor for the American Cup.

The Royal Thames club regatta, one of the most eventful contests of the yachting year, took place in England last week. Interest in the race was centered in Lord Dunraven's new yacht, the Valkyrie, which was viewed and studied with the greatest interest. The Prince of Wales's cutter won the race, and the prince expressed himself highly satisfied with the performance of his boat, which was one of the three Scotch cutters recently built on the Clyde for this season's racing. The Valkyrie was second, the Ivarna third, and the Calluna fourth.

About a third of the way home on the return course the Valkyrie's top-sail was smashed. At the time of the accident she was but one length behind the Britannia. Some of the judges say that the accident prevented the Valkyrie from winning; others say it was the Britannia's race from the start. The victory of the Prince of Wales has evoked great enthusiasm among yachtsmen. The Sportsman says of the Britannia: "She is undeniably the better boat of the two and she fairly thrashed her adversary after some of the smartest jockeying ever seen."

The Daily Telegraph and Sporting Life of London agree that the Britannia fairly outsailed the Valkyrie in the race Thursday. The Times thinks that the two yachts were "marvelously well matched." "Although the Britannia is the longer," it says, "and therefore ought to be the faster of the two, there is really little difference between them. As a challenger for the America's cup the Valkyrie showed herself to be satisfactory in the highest degree. On a 50-mile course, free from tidal influences, she will probably prove 15 to 20 minutes faster than the Ivarna, which is the best trial boat in the country."—Springfield Republican.

**A Letter of Gen. Armstrong.**

[Kate Field in Her Washington.]

Distinguishing himself by a magnificent charge at Gettysburg, he asked to be transferred to a colored regiment and was placed in command of the 5th United States colored volunteers. Promoted to a brigadier-generalship, Armstrong commanded a colored brigade at Hilton Head in the last days of the war and suffered a thousand tortures from inaction. He belonged to the church militant. He was a born fighter and was only happy in the thick of the fray. Writing to his "dear chum," Archibald Hopkins, who also shouldered a musket, the irrepressible Armstrong bewailed his fate on May 19, 1864:

I am most miserable. No disappointment in love, no crushing sorrow could so prostrate me as to feel that I am idling and loafing on these sands while my old comrades and others are struggling so nobly in Virginia. I cannot tell you of the bitterness of soul I feel. I care for nothing—I am good for nothing. My philosophy fails me. I am fully aware of the nobility of my present position. The freedom of the slave is the hope of the nation; but O, that I had been there! No hope of service here, and I can hardly endure the same. Earth is hell to me. I would sacrifice rank, pay, everything for a musket and a place in the line of the army of the Potomac. Blessed be the noble fellows who have fought in this last great struggle. \* \* \* Farewell to all my soldierly aspirations! I have no need of them now. \* \* \* I would rather grind a hand-organ for the edification of the mule teams of the army of the Potomac than review a dress parade down here. The Lamentations of Samuel the unfortunate are ended. See him waste on a sand-bank the golden hours that belong to God and country! \* \* \* God only is great, and any service of his is good enough for mortals. The fact is, I am savagely jealous! Ever yours,
