STRANGE COMBINATIONS.

Family Relationships That Beat the Fourteen-Fifteen Puzzle.

The strangest combination resulting from the marriage of relatives that we have ever heard of is that in the family of Lewis Osborne, who has recently removed to Pomona from Selma, Fresno county, Mr. Osborne tells us that he has been ten years trying to unravel the perplexities of relationship that his second marriage has caused.

Given this simple statement, and a number of peculiar family relationships may be deduced. For example, Mr. Osborne is a grandchild of his wife. Mrs. Blake, being Osborne's mother, is grandmother to Osborne's son. The latter, however, being a son of the wife of Mrs. Blake's father-in-law, is therefore a brother to his grandmother and granduncle to his grandmother's sister, the daughter who married Mrs. Blake's brother-in-law. He also is her nephew, as the son of her brother. Osborne is the younger Mrs. Blake's grandfather as well as her brother. Thus her nephew, Osborne's son, becomes uncle to his aunt, being a son of her grandmother. The series of relationships may be likewise traced almost indefinitely. The family are happy and contented, and live as pleasantly as though the peculiar family ties were not present.—Pomona Progress.

That "White Trash."

The phrase "poor white trash" which occurs in an editorial of this morning's Advertiser reminds one of the phrase "mean whites" so extensively used by the planters of the South before the war. The newly coined phrase of the local organ of a discontented oligarchy comes from a source where cognomens are placed in a necessary order of inversion just now. For "trash," read "Independent."

The organ and its party have managed to harness a number of "whites" badly in want of fodder, and they look, and are probably looked upon by the occupants of the missionary state-coach as a cheap kind of mule; but a time is near at hand when a rude awakening, jostling and rumbering of the coach is going to shake up the editor and his pupils. G. and annexation" is ominous and the consequent disappointment and not-know-which-way-to-turn predicament may be pleaded in extenuation of the present season of tearing hair and using bad language.

When will the Advertiser learn that honesty of purpose lives eternal, while dishonesty of purpose lives only for a while, as in the present case and method of annexation. 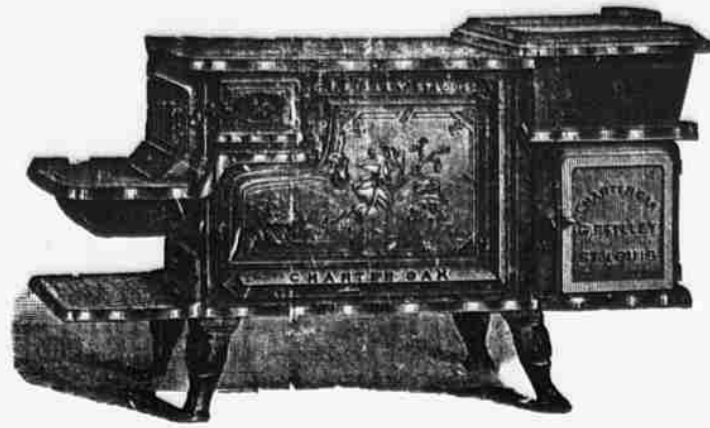

tionists, attended by between 600 and 800 people, in which no mention was made of detroning the Queen or organizing a revolutionary government. At the same time, that is at 2 p. m., a mass meeting was held by natives and others, which adopted the following resolutions, and quietly dispersed before 3 p. m.:

Resolved, That the assurance of Her Majesty contained in this day's proclamation is accepted by the people as a satisfactory guarantee that the Government does not, and will not, seek any modification of the Constitution by any other means than those provided in the organic law.

Resolved, That accepting this assurance the citizens here assembled will give their cordial support to the administration and endorse them in sustaining that policy.

#### LANDING OF THE TROOPS.

"At 4 p. m. the troops and a battery of Gatling guns from the Boston were landed, a part being left at the United States Consulate, another part at the United States Legation, and the main body between the Palace and the Government building. The town at that time, and in fact at all times, had been, and continued to be, in profound peace and quiet, excepting the commission of a murderous assault upon a native policeman, which, however, fortunately did not result in loss of life.

"Mr. Parker and Mr. Peterson report further proceedings as follows: 'On Tuesday afternoon, January 17th, at 2 o'clock, Mr. Parker and Mr. Peterson again called upon Mr. Stevens at his residence in Nuuanu valley to learn if possible the truth of the statement made publicly by the leading members of the so-called Committee of Safety, to the effect that Mr. Stevens had promised that, if a proclamation declaring a Provisional Government was issued, he (Stevens), on behalf of his Government, would immediately recognize such government and support it with the United States forces at his command. Mr. Peterson asked Mr. Stevens what action would be taken by him (Stevens) in case the insurgents attacked her Majesty's Government and the Government called upon him for assistance.

"Mr. Stevens replied that in that case he could not come to the assistance of the Government. Mr. Peterson then asked Mr. Stevens what his action would be in case her Majesty's Government should treat the insurgents as rebels and attack them and arrest them. Mr. Stevens replied that in that case he should feel it his duty to interfere with the force at his command. Mr. Stevens further said he had made up his mind that if any number of what he considered responsible citizens should ask his assistance in establishing a Provisional Government he should grant that assistance and should recognize them as such and support them. Mr. Stevens during this conversation was lying on a sofa in his private office and spoke with difficulty as if in a weak and exhausted state. At 2:30 o'clock Mr. Parker and Mr. Peterson left Mr. Stevens and proceeded to the Station house, the headquarters of her Majesty's Cabinet and Government.

#### CORRESPONDENCE WITH STEVENS.

"Besides this conversation the Minister of Foreign Affairs sent the following to the American Minister: DEPARTMENT OF FOREIGN AFFAIRS, HONOLULU, January 16, 1893.

Sir:—I have the honor to inform your Excellency that the troops from the United States ship, Boston, were landed in this port at 5 o'clock this evening, without the request or knowledge of Her Majesty's Government. As the situation is one that does not call for interference on the part of the United States Government, my colleagues and myself would most respectfully request of your Excellency the authority upon which this action was taken. I would also add that any protection that may have been considered necessary for the American legation or for American interests in the city would have been cheerfully furnished by Her Majesty's government. With the highest respect, I have the honor to remain your Excellency's obedient servant.

SAMUEL PARKER,  
Minister of Foreign Affairs.  
To His Excellency John L. Stevens, United States Envoy Extraordinary and Minister Plenipotentiary, Honolulu.

"To this his Excellency sent the following reply:

UNITED STATES LEGATION,  
HONOLULU, January 17, 1893.

Sir:—Yours of yesterday regarding the landing of the United States naval forces in Honolulu, was duly received and its import considered. In whatever the United States diplomatic representatives have done or may do at this critical hour of Hawaiian affairs, we shall be guided by the kindest feeling and views for all the parties concerned, and by the warmest sentiments for the Hawaiian people and the persons of all nationalities. Most sincerely yours,  
JOHN L. STEVENS.

To Hon. Samuel Parker, Minister of Foreign Affairs.

"The statement of the Foreign Minister was absolutely correct. The Marshal of the kingdom had 400 able-bodied men, fully armed, assembled at the station house, in view of the attitude of the United States Minister and the commander of the Boston the Queen and Cabinet were advised to disband them and surrender the prison, station house and barracks, which was done.

"On Tuesday afternoon, before the foregoing events took place, the Queen and Cabinet issued a protest, which was served on Mr. Dole and service acknowledged by him.

"Subsequent events are easily summarized. The Provisional Government declared martial law, and armed among others the vagrant and criminal element in the population, proscribed free speech and discussion, suppressed native newspapers and established a practical censor-

ship of the newspapers published in English, permitting only such statements as might be favorable to appear, and disbursed large sums of public money without authority of law. This state of things was only possible by the armed support of the United States troops ashore and the guns of the United States war-ship Boston trained on the town. The usurpation of authority would not have lasted an hour without such armed support and encouragement by the United States Minister.

"As a logical sequence to these events, the lawless and criminal foreign element, armed by the usurpers, and paid to terrorize the natives and the law-abiding citizens, now displayed a mutinous spirit, and the Provisional Government was compelled to call upon the American Minister to assume a protectorate and disband its armed force, which was accomplished on February 1st. This fact alone demonstrates that the so-called Provisional Government has no strength of its own, either to preserve the peace or enforce obedience to its edicts. It has neither the moral nor the physical support of the masses of the Hawaiian people, who protest with their Queen against a continuance of its usurpation and pray for the restoration of their constitutional government and sovereignty.

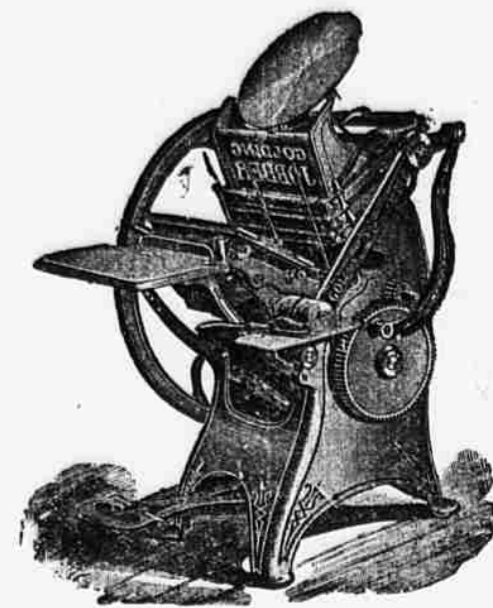
