## WAILUKU OBSERVES MEMORIAL DAY

The Dead Is Remembered and Living Issues Are Not Forgotten.

Local patriotic societies held memorial day exercises at the Wailuku Cemetery, and a large turnout of citizens assembled there for the celebration. Precisely at 3 o'clock in the afternoon the organizations fell in line, and the procession marched to the little cemetery on the bluff overlooking the valley of Wailuku.

Those in line were a cordon of the police under Deputy Sheriff Crowell, Company I, First Infantry, N. G. H., Captain W. E. Bal, commanding; members of the local fire company in their striking red uniforms; the women of the Nawaieha Court of Calanthe, and the Knights of Haleakala Lodge, K. of P., under Jos. F. Welch, C. C. The procession formed on High street, debouched on Vineyard and marched to the cemetery under a cloudless sky, and in the glare of a scorching afternoon sun. There, as prearranged, after prayer and songs rendered by a quartet of men and by ladies of the Nawaieha Court speeches were delivered appropriate for the occasion.

W. F. Crockett, Wailuku's silver-tongued orator, delivered an address, referring to Memorial Day as a day observed all over the United States to keep green the memory of the brave men who gave their lives to the cause of their country that the nation might be better, and that wrong might be righted. Although we are assembled here among the graves of the dead, yet their memory liveth, and they also live, and in our own time we shall follow them to that mysterious land beyond where the glories of an eternal life await the good and the just.

Mr. W. E. Saffery followed, speaking in Hawaiian, and spoke of the dead who are remembered as not forgotten but only gone before.

Judge Kingsbury was then introduced as a veteran of the civil war, who, more than all else present knew the meaning of memorial day celebration.

The Judge made a simple address referring to those present as having come to decorate the graves of members of their own families, which was appropriate for the occasion, and he, who had come a stranger to these beautiful "isles of Eden lying in dark purple spheres of seas" had also a near member of his family buried here, in William Goodness, a veteran of the civil war.

It is the custom and the law of the land to celebrate this day in the memory of the men who fell in the great civil war. The men who knew what the sacrifices of war meant. The prison life that had to be borne, the sufferings and the labors unflinchingly borne to uphold a just government. The men who felt the thrill of patriotism that ran through a great army and linked us all together as brothers of one family. Of that great army, he, who lies yonder, is the only dead member and I am its only living member here to celebrate this day among the grass covered graves of the dead.

We, who are here, are of many races, and I hear you speak in your beautiful Hawaiian language, but we all understand another language, that of love, which makes of us all one nation under the stars.

Yee Kui, pastor of the local Chinese Protestant Church, followed with a short address in Chinese for the benefit of Chinese Americans present, at the conclusion of which

a squad from Company "I" went over and fired three volleys above the grave of William Goodness. The units of organization again got into line and left the cemetery to disperse at their respective places of gathering.

At the Wailuku Union Church Sunday evening, Rev. Rowland B. Dodge preached a sermon on Memorial Day. In part he said his earliest impressions of the day were of a few veterans marching silently along sunny lanes under blooming apple trees to the little cemetery, there to decorate the graves of the slain. That was in the country. In the cities there would be a display of flags, a parade of the military with bands, and singing and speeches. In the cemeteries the graves would be decorated with flowers, with roses, and with carnations.

In that war brother fought against brother, and families suffered terribly. The hardships and sufferings borne are something we cannot know. The men who went to that war on each side fought for what they believed to be right. Men by thousands gave all they had to go to war. The men from the South went barefooted in the snows to the North fighting for their cause, with their homes burning behind them, and thousands and tens of thousands of men were slain in single battles.

Referring to immigration, he decried the way the great Hamburg German Steamship companies were dumping into the country, immigrants consisting of the off-scourings of Southern Europe. With these things taking place let us ask ourselves, did the men who fought for a free nation sacrifice their lives to provide an asylum for such? The press of the nation and the public schools are a great power for uplifting the nation. Our free public schools however, are filled with the children of the ignorant who are getting its benefit for nothing, and it is nothing but right that they be made to pay something for it. And the question is, is it right that the ignorant share alike with the college graduate, the free and the worst of human elements, the thinking and the unthinking, the right to rule the country? Did we fight for a free nation for them?

It is said if the civil war had not compelled the nation to protect liquor dealers for the money to be wrung in taxes from them, the cause of temperance would have prevailed before this against licensed saloon.

In countries where socialism is preached like Germany, there is not that awful state of thing we have in America, which is called white slave traffic, where the rich accumulate vast wealth and the poor in the slums are the dregs of humanity. In those countries at least the purity of the home and the privacy of the family are safe.

The late Chief Justice Brewer said in one of his addresses that if the rule of Christ prevailed, there would be no necessity of the fierce struggle of race against race, and of capital against labor.

He closed his highly instructive sermon with reading Lincoln's Gettysburg address.

Lieut. Henry O'Sullivan of the Territorial Secretary's office arrived on the Mauna Loa from Hawaii Monday evening. He is around to register Hawaiian born Japanese.

## Races and Racing

Getting Ready for the Coming Fourth of July.

Everything is in readiness at the Kahului race track, for the big celebration on July 4th. There are at present eight or ten horses in training, and some good racing is assured. Louis Warren's horses will arrive this morning and will be taken in hand to be trained for the July meet. The executive of the racing association have decided to erect bleachers to accommodate the crowds. Kahului track will be filled to the brim with spectators from all over the Hawaiian group. A special meeting of the Maui Racing Association has been called for tonight, at which several matters of importance will be discussed. The date of closing entries will be set for June 25th. This has practically been decided upon by the executive, and will not be changed unless some valid reason is offered.

Rumor has it that the picnic at Sunnyside will be abandoned this 4th of July, and that the only counter attraction on the Fourth will be a tennis tournament at Paia. This will therefore enable quite a number of up-country people to take in the races at Kahului, and inasmuch as a good day's sport is promised, there will be no occasion for regret. The members of the Maui Racing Association appreciate the action of the up-country officials in dispensing with the Fourth of July picnic at Sunnyside, and have made suggestions looking towards some kind of a celebration at Makawao on say New Year's day. This would give all the people of Maui an opportunity to have two good days of sport during the year about six months apart. It would also mean cooperation with each other to make both affairs successful.

Wm. E. Bal has been selected as clerk of the course, and he has appointed Frank Sommerfeld as his assistant. This simply means that with these two men handling things one race will follow another without much waiting in between. The Wailuku County Band will be in attendance at the races and will enliven the occasion with selected instrumental music.

## Hana News Items.

HANA, May 31.—Seven cases of assault and battery were tried before the district magistrate during the month of May, being the largest number heard before the local court for the offence in many years. Six of them were for assaulting police officers in the performance of their duties, all of which were the result of a luau held to celebrate the completion of the road at Kowali, where the guests had looked at the glass when it was red a little longer than what was good for them. The offenders plead guilty and paid fines in all amounting to \$100.

The people of Hana celebrated Memorial Day at the Hana Church, and had a pig and poi lunch at the close.

Prohibition clubs are being organized in several places in the district, and the leaders hope for a bright future and the final victory of the cause. Women of Hana are listing names and forming a prohibition club of their own.

As a result of the completion of the wagon road to Kipahulu, and of the fine road to Nahiku, enterprising Japanese now have four hacks for hire in this district.

## The Kula Pipe Line

Slow Delivery of Piping Causes Delay.

According to Contractor Landgraf the work of laying, and connecting the piping for the Kula Water Works is going forward as rapidly as is possible under the circumstances. Over six miles of piping have been connected to date, consisting entirely of five-inch and six-inch mains, and the work could go ahead much faster but for the delay in getting the piping delivered on the line, and the delivery appears to be a much more slower work than what is thought of.

Contractor Landgraf says if the piping could be delivered more rapidly on the line he could put on a few more gangs of men and the work of connecting could go ahead simultaneously in several places which will greatly hasten the day when the pure waters from the Koolau side of the Haleakala mountain could be delivered to the thirsty people of dry Kula.

It would take only seventeen days' work to connect up all the piping now delivered on the line, so Mr. Landgraf thinks, and rather than go ahead and finish up the work in sight he employs but two gangs of men, all that he could profitably use for the time until a greater quantity of piping is delivered on the ground.

Owing to the nature of the ground along the line the hauling of piping has been very slow work and Contractor Landgraf thinks the government will have to give him an extension of time, as under the circumstances he will not be in a position to complete the work within the estimated time, and can hardly be expected until all the piping shall have been delivered for the workmen to connect and lay in position.

The contractor when seen appeared to be in a very cheerful mood, and does not appear to entertain the last fear of his work on the pipe line a losing proposition. He is perfectly confident of completing the work within the time limit set in his bid, if the piping were only delivered in sufficient quantities to justify him putting on a few more gangs of men, which he would do if there was more piping in sight. With six miles of the heaviest piping connected fully one-third of the work is completed, and all of it within only two months of the time when the contractor began work, which is certainly a very good showing. So the mountain of difficulties which the contractor is supposed to have gotten into by offering to do the work at a figure about one-half of his competitors appear to be of no very great shakes after all.

## New Roadway for Kahului.

The roadway to the new steamboat wharf at Kahului, which will be built by the County of Maui and a part by the Superintendent of Public Works is a little over one thousand feet in length. The portion to be built by the Territory, bids for the construction of which are being asked for, will be about 176 feet in length, extending from high water mark to the bulkhead, and is estimated will cost about \$600. The portion to be built by the County of Maui will be about 850 feet in length and will include a concrete culvert and much filling. The roadway will be sixty feet in width, and will cost the County in the neighborhood of \$5000. As the roadway is needed, it is up to the County officers to get busy and begin work rightaway.

Pineapple juice dispensed at Atlantic City was received very favorably and took from the start.

The Portuguese cruiser San Gabriel sails for the south today.

DAYTON, Ohio, June 3.—The Wright brothers will enter their flying machines for the races between New York and Chicago, and between New York and St. Louis in the competition for the big prizes recently offered.

ST. LOUIS, June 3.—Governor Folk has announced himself a candidate for the Presidency in 1912. The state democratic organization has pledged itself to support him.

NEW YORK, June 3.—William J. Connors was yesterday retired from the chairmanship of the state democratic committee, and John A. Dix was elected to succeed him.

August Belmont Jr. fell from his polo pony in a practice game at Meadow Brook and broke his wrist.

WASHINGTON, June 3.—Andrews, director of the Mint, will succeed North as Assistant Secretary of the Treasury.

LONDON, June 3.—Peary and King George had a meeting yesterday.

LOS ANGELES, June 3.—Papke has cancelled the fight with Flynn.

NEW YORK, June 3.—Refined sugar dropped ten points.

HONOLULU, June 2.—Arguments at the meeting of the Merchants' Association yesterday were rather in favor of the interstate commerce regulations being applied here. Mr. Br F. Dillingham advocated its adoption here while Mr. McLain spoke against.

Banquet to the captain and officers of the Portuguese cruiser San Gabriel tendered by Mr. Canavaro, the Portuguese Consul-General, was a brilliant social affair.

The Rapid Transit will soon have double power for street car traction.

Tom Quinn will be arrested for running over an Hawaiian a week ago, and perhaps will lose his license to run motor cars.

WASHINGTON, June 2.—Republican party leaders have agreed in caucus to support an amendment to the Federal postal saving's bank bill, whereby amounts deposited must be divided in the following manner: 65 per cent. to be deposited in local banks; 30 per cent. to be invested in bonds; and 5 per cent. to be kept in reserve.

SEATTLE, June 2.—A gold strike, richer than the Klondyke, has been reported from Iditarod, Alaska, and the rush to the new fabulously rich gold diggings has begun. Steamships for several trips ahead are crowded with people anxious to reach the new gold fields.

HONOLULU, June 1.—The grand jury will report to the Federal Court that there is absolutely no grounds for complaint from Russians. The Yacht Hawaii sailed for the coast yesterday.

The Territorial Commission which investigated the landings throughout the islands is ready to report. It is said the report will be in favor of the small shippers.

There is a rumor that Kubio has cabled that he will not be here for the prohibition plebiscite.

WASHINGTON, June 1.—Determined efforts will be made by the government to enjoin the Western Traffic Association from raising freight rates.

SAN FRANCISCO, June 1.—At a meeting of the supervisors last night, a license for the Jeffries-Johnson fight was granted. Nolan will handle Johnson.

NEW YORK, June 1.—Pulitzer's papers, the New York World and the St. Louis Post Dispatch, will offer a cash prize of \$30,000 for a flight from New York to St. Louis. The New York Times has offered \$25,000 for a flight from New York to Chicago.

### Some Maui Politics.

Politics are quiet on Maui, but little political activity in evidence. Politicians are content to let prohibitionists occupy the public eye, but the quiet is misleading, for when the politician is not in evidence as a rule he is busy in his shirt sleeves, mapping out plans and laying wires against the time when the public must hear from him.

Over in Hana, W. P. Haia has everything well in hand for a re-nomination and reelection to succeed himself as district supervisor. For the House J. W. Kawaakoa and W. H. Drummond are aspirants for the republican nomination, and G. W. Kauimakaole is seeking to run on the opposition ticket.

In the Makawao district, Hon. E. B. Carley, the man who got the Kula Pipe line will get the republican nomination for the House if he wants it, A. J. Gomes of Paia will also seek the nomination as the Portuguese representative on there-publican ticket, and there will probably be a three-cornered contest between himself, A. Garcia of Wailuku and Mr. A. Furtado of Lahaina for the honor.

The aspirants for the House from Wailuku district are G. W. Maxwell, M. P. Waiwaiolo, Sam Keliinui and W. E. K. Maikai. All four are good men, and whoever gets the nomination will be satisfactory. Mr. Keliinui is perhaps the most progressive of the quartett, but political conventions have their own ideas as to the most desirable qualities to have in a man to go on a blanket ticket.

In Lahaina the aspirants for the House are Ed. Waiaholo and Chas. K. Makekau, with Ed. Waiaholo well in the lead for the nomination.

For the Senate it seems to be a case of the place seeking the man with no one particularly anxious to aspire for it. Hon. W. J. Coelho went around the County recently to renew acquaintances and incidentally seek renomination to succeed himself, but whether successful or otherwise is unknown.

### Wailuku Sugar Co. Finishes Grinding.

The Wailuku Sugar Company finished grinding this season's crop, Monday evening, May 30. The output is just barely short of seventeen thousand tons, which is several hundreds less than the crop for last year, and is fully a thousand tons greater than the estimated crop for the year. Mr. H. B. Penhallow, manager, is to be congratulated for the good showing he has made.

### Dago Red Tabooed.

The matter of fixing a standard for the quality of drinks served over the bar by licensed liquor dealers has had the attention of the Maui board of license commissioners lately, and liquor dealers have received notice from the board that imitation drinks which usually passed as compounds, or what is picturesquely called "dago red" will no longer be allowed.

The order given by the commissioners will not affect liquor houses selling only straight stuff. Already Peter Joseph of Kula, Maui, has withdrawn his application for a renewal of his saloon license, but whether as a result of the order or on account of the agitation for prohibition is not known, but nevertheless, it means one saloon less for Maui and a corresponding gain in the anti-saloon movement.

The orders of the License Commissioners were embodied in a letter which D. C. Lindsay, the secretary of the Board, sent to every liquor dealer on Maui, and are as follows:

Dear Sir: I beg to notify you that at a meeting of the Board of License Commissioners for the County of Maui, held this a. m. the following resolution was adopted:

"Resolved, that from and after the 1st day of July, 1910, no compound or imitation spirituous liquors or any liquors marked Misbranded or Type shall be sold with-

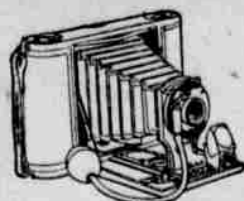

**Promotion for Rev. Canon Ault.**

According to reports from Honolulu Bishop Restarick has selected Rev. Cannon Ault, rector of the church of the Good Shepherd, Wailuku, to succeed Rev. W. H. Bliss, of St. Andrew's, Honolulu, who goes to Spokane, Washington, and has offered the position to Rev. Cannon Ault. He is a "down easter" by birth, but practically grew up in the west and comes highly recommended and especially fitted for the work he would have to take up should the changes proposed as planned by Bishop Restarick take effect.

The Rev. Canon Ault went on a flying trip to Honolulu by the Claudine. He will return Saturday morning and will be accompanied by the Rev. Mr. Short of Honolulu and Mr. D. D. Wallace of Kona. Both of these gentlemen will assist in the services at the Church of the Good Shepherd on Sunday morning, at 7 a. m. and 11 a. m.

**Sam Kaiapa Passes Away.**

After an illness of about two months, Sam Kaiapa, aged about fifty-five, died at the Malulani Hospital, Tuesday afternoon, from blood poisoning. He was from Haunala, Oahu, and was formerly pastor of the Hawaiian Protestant Church at Anahola, Kauai.

For several years he was a resident of Peahi, Makawao district, and was later lured huna for the Paia section of Makawao until after the elections of 1908, since which time he has been quietly living in Wailuku. He leaves a wife and daughter.

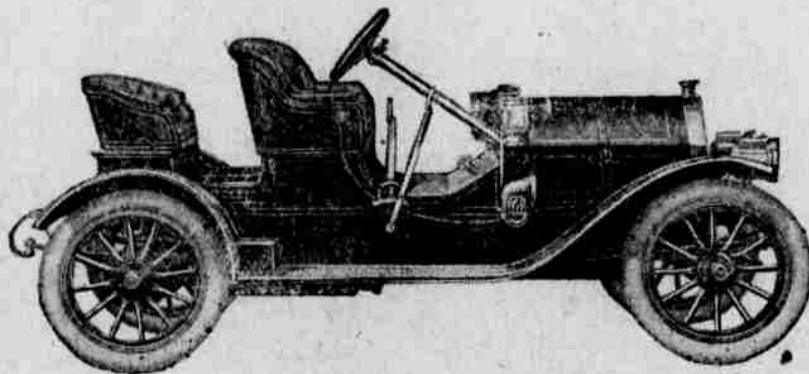

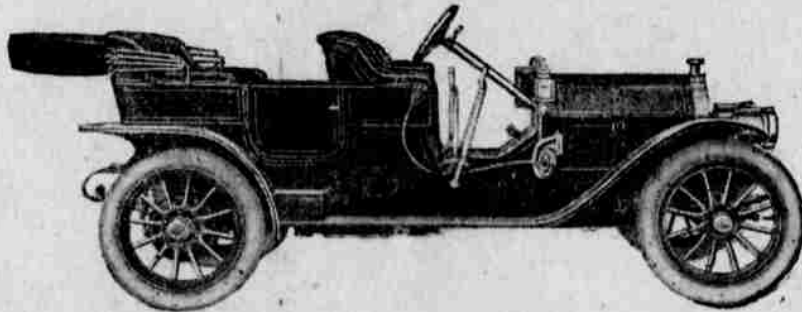

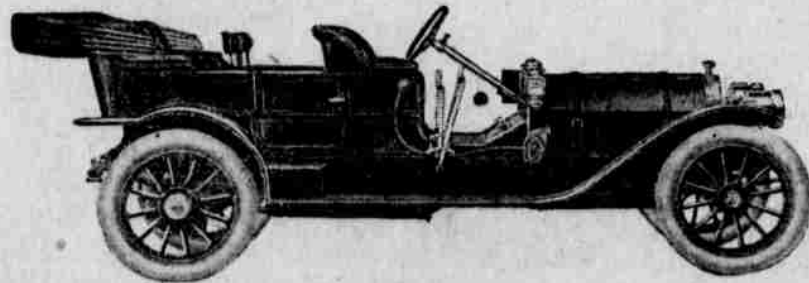
