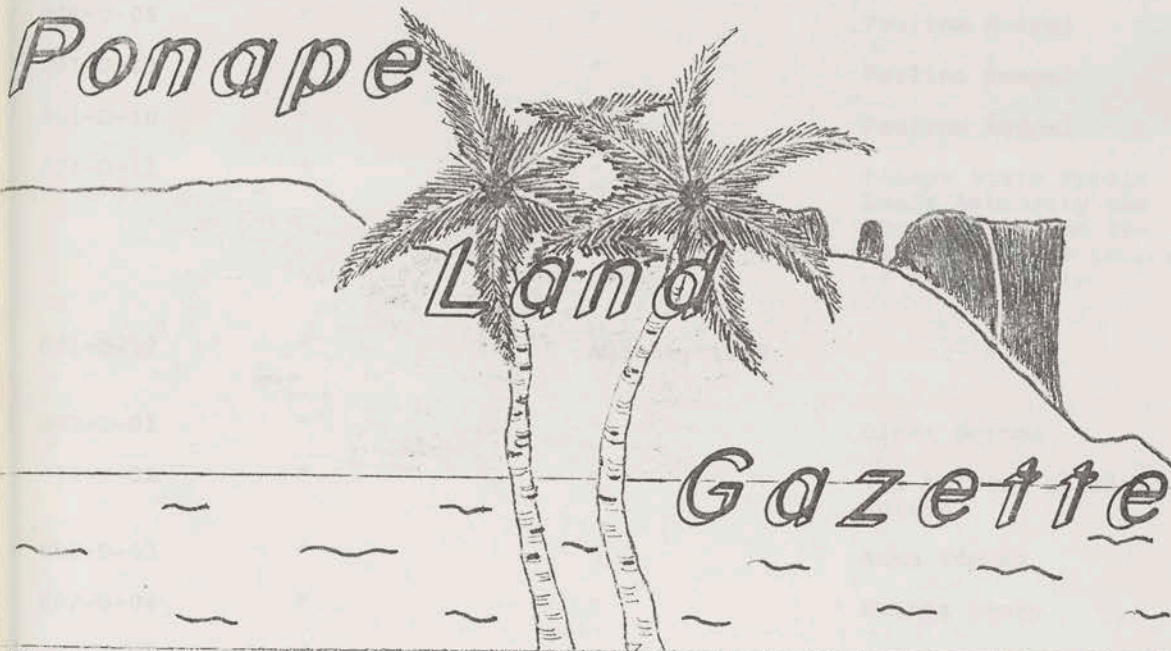

FORMAL HEARING PROCEEDING

Instituted and completed Formal Hearing Proceedings to a total of fifty-eight (58) additional land cases situating in the Municipalities of Uh, Madolenihmw; Kitti, and Net, Island of Ponape.

PRELIMINARY HEARING

Instituted and completed Preliminary Hearings to twenty-four (24) additional land claims on the Island of Ponape.

MWOMWOHDEN KARONGORONG:

REGISTRATION OF INSTRUMENTS

Registered a total of ninety-six (96) additional legal instruments and plats affecting land ownership; uses, and boundaries.

APPEAL TO HIGH COURT

1. Fifteen (15) additional Civil Action Cases have been filed with the High Court. These involves appeals brought against the Commission's determinations to land cases which the Commission have entertained and adjudicated.

2. Three Civil Actions have been closed in Court and the results are as follows:

A. Civil Action 21-79, Court affirmed the Commission's adjudication.

B. Civil Action 3-80, Case dismissed and the Commission's initial decision stands.

C. Civil Action 47-80, This is a referral case to Court for adjudication and accordingly, Court adjudicated the issues involved. In this case, the Commission did not render decision and proceeded in referring the case to Court.
