To-day is the Chinese New Year.

The small pox is on the decrease in Sydney.

Polynesia Encampment No. 1, meets this evening, at 7:30.

4,363 letters went to San Francisco yesterday by the City of New York.

300 packages of sugar and 250 bags of paddy were received yesterday.

The steamer Mary Tatham brought 10 Chinese for this port; she has 100 on board for China.

The inhabitants of Jamestown, Melbourne, were shook up by a severe earthquake on January 30th.

Great alarm is felt in Norfolk, Eng., at the increasing destruction among cattle caused by the rinderpest.

A lamp bursted in a house on Maunakea street last night, but the fire was extinguished without any much damage.

A telegram, dated London, Jan. 28th, states that Chili has decided upon the terms on which it will conclude a treaty of peace with Peru.

The following passengers from San Francisco, ex Kalakaua, arrived yesterday: Chas. L. Beal, Mrs. Augusta Hartine, Mrs. Tannatt.

A shocking accident has occurred at Bucharest, the capital of Roumania. A circus which was performing caught fire and a number of men and horses were burnt to death.

A large fire occurred at West Eyreton, Christchurch, N. Z., on Jan. 29th, by which a farmer named Henry Simpson lost his family, consisting of 7 persons, who were burnt to death in the house.

The City of New York arrived from Auckland yesterday. She left Sydney on 26th January, and was detained at sea on Feb. 8th from 2:30 p. m. until 6 p. m. of the following day to effect certain repairs to the engine.

A fire occurred in the oil warehouses of Mr. Perry, at Bristol, Eng., on Nov. 30th. 3000 barrels of petroleum were sacrificed. Ten tons of ledgers and books, belonging to the late West of England Bank, were also destroyed.
