THE DISPENSARY SYSTEM

LETTER ON THE SUBJECT FROM SOUTH CAROLINA.

Original Organizer of System Would Interest Hawaiian Legislature—Sends Data.

D. H. Traxler, the organizer of the present dispensary system of South Carolina, has written a friend in Honolulu of the present working of the system, enclosing also considerable data for the use of the legislature in the case that body may desire to take up the question at its approaching session. A large amount of valuable information on the subject came from Mr. Traxler in 1896, and was embodied in the report of the liquor commission to the legislature at that time. Mr. Traxler is an enthusiast on the subject, and in his letter states that he would willingly leave his extensive business interests for a time to assist the friends of the system in Hawaii. He says: "At least 15,000 or 20,000 majority in the state still think the dispensary is the correct thing and we are well pleased with it. The enclosed reports will speak for themselves. I feel a deep interest in the scheme, and think the law the solution of the liquor problem. I believe every country should have hold of it, for we are bound to have liquor in some shape or way, and this is the only way to manage it in a respectable and equitable manner. Should your country ever need my assistance in this respect, I feel such an interest in it that I would willingly leave business long enough to go to your experience to start them off."

A report for the months of September, October and November shows sales throughout the State to have been \$555,285.29. A unique feature of the system is shown in this report in that \$68,855.27 of the profits went into the school fund, which would seem to indicate that in the run of a year the school department would realize nearly \$300,000 from this source. It may be said that a distasteful reflection is cast on the character of the State when the profits of the dram shop, but the people of the State accept it on the principle that if a man must drink the whole community and not a few men should receive the benefit of the gross and not profits of each dispensary in the State during the eleven months ending November 30 last, has been issued. The gross sales for the period indicated amounted to the enormous sum of \$2,421,840.22, nearly two and a half millions of dollars. On this the State's profit was \$176,612.18, and the net profits, divided equally between the towns and cities of the State, covering also the beer dispensaries, reach \$298,164.29, making the total net profit for the eleven months on the State's big liquor business \$477,659.81.

From the ten dispensaries in Charleston county the net profits to that county and city are \$12,305.26. Columbia has four dispensaries exclusive of the net profits of \$22,738.79. Greenville with its two dispensaries nets the city and county the sum of \$10,130.42, and Spartanburg's two dispensaries net the city and county \$11,822.21.

It should be borne in mind that all these figures refer only to the eleven months ending November 30, and do not include the heavy holiday business done during the month of December.

HAWAIIAN AGRICULTURAL.
The annual meeting of the stockholders of Hawaiian Agricultural Company was held this morning at the office of C. Brewer & Company. The following officers were re-elected for the year: C. M. The meeting adjourned until tomorrow afternoon to receive the reports of the officers.

PAPA DOES HIS HOT FOOT

WILL HAVE PEOPLE TO CHANT FOR HIM.

Trench Has Been Made Smaller So Papa Cannot Avoid Stepping on Warm Spots.

The chanters have been engaged to chant; the stones have been heated to burn; the crowd has bought tickets to come; and Papa Ita is pleased. At 4 o'clock this afternoon on Beretania and South streets, the old Tahitian hot stone walker will do a hot-foot over the pile of lava rocks, in the presence of the astonished multitude. All ages are expected to be present. School children will be on hand in large numbers as this is really intended as a special matinee for the little ones, a special rate having been given.

The process of heating the rocks was begun at 4 o'clock this morning. The wood was packed in much closer than for the recent exhibition and as the material is not so dry, it will burn longer and produce a more lasting heat. The trench in which the stones are placed has been narrowed by nearly three feet and several feet have been added to the length. There can now be no chance for skeptics, declare the managers, to claim that Papa Ita hugs the Waikiki side when the fire is Ewa-ward.

Papa visited the trench this morning and was satisfied, and pleased. It was hot and there would be no chance of his falling to find plenty of warm stones. As an embellishment upon the old man's performance, his managers engaged several men to chant for the stone walker. This will prove an interesting addition to the ceremony and will be more characteristic than would the band.

The canvas fence enclosure has been moved twenty feet toward the trench, making the ground much smaller but affording better protection from the wind. Seats will be provided for the women.

COURT HAS A BROWN DAY

ACCOUNTS AND INVENTORIES IN ESTATES.

Cecil Brown Submits Numerous Papers—Two Decisions by the Supreme Court—Insurance Case.

This day has termed "Cecil Brown day" in the Circuit Court. The president of the First National Bank this morning submerged the clerks in work for a time, filing his reports on various estates. The first and probably the most important, was in the Roth estate, of which Mr. Brown is trustee. He reported that during the year the receipts had been \$15,198.35 and expenditures \$2,431.94.

In the matter of W. H. Cummings, Mr. Brown filed an inventory showing his net worth to be worth \$500. Cummings died in Japan a year ago. He was road supervisor for many years and contracted leprosy.

In the matter of the estate of Godfrey Rhodes, Mr. Brown reported in his statement that \$2,726 had been received and \$1,085.01 expended.

Mr. Brown stated that in the estate of the late K. Kanoa \$3,978.85 had been realized and \$744.60 paid out. No money had come into his hand, as under an arrangement of deceased all went to certain natives in the way of allowances.

In the matter of the estate of the late George Manson, Lily J. Manson was issued letters of administration. The property is valued at \$4,000. The bond, which is for \$300, is endorsed by F. L. Alderson. There are two heirs, the wife and one child.

In the Merricourt insurance case the Supreme Court yesterday filed a ruling denying a new trial. This means that the Norwalk Insurance Company will have to pay the face value of their policies on property burned in Kalihi together with interest for about two years.

In the case of the Puna Sugar Company vs. the Republic of Hawaii, the Supreme Court rendered a decision in favor of the company. This was a submission matter. There is a Hawaiian law against cutting trees within 250 feet of a public road, where such road runs through a forest. The Puna Sugar Company claimed that this law was unconstitutional as it deprived them of their property without remuneration. The court sustains this view.

W. R. Sims, administrator of the estate of the late Katie Ellen Sims, has filed an inventory showing the property to be worth \$6,106.

SHIP BUILDING BOOM

FOUR NEW VESSELS FOR HIND, ROLPH & CO.

The Steel Barkentine Hawaii Ready to Start Here on Her Maiden Voyage This Way.

SAN FRANCISCO, January 16.—Never, perhaps in the history of the Pacific coast has there been such a lively movement in shipbuilding. Every yard from here to Washington is running full blast, and if a man wants a ship built, he must wait his turn.

Hind, Rolph & Company are now having four vessels built. A barkentine with a capacity of 1,965,000 feet of lumber, similar in build to the lost William Carson, is in course of construction at Bendixen's yard in Humboldt. George E. Hitchings at Gray's Harbor is building for the same firm a four-masted schooner with a capacity of 900,000 feet; Hay & Wright at Oakland have a sister vessel on the ways, and W. A. Barle of the same place is building a barkentine with a capacity of 1,350,000 feet of lumber. This makes six new vessels. Hind, Rolph & Company have built within a year. The steel barkentine Hawaii is at Newcastle, N. S. W., ready to start on her maiden voyage to Honolulu, and the four-masted schooner Kailua is due at Newcastle on her first voyage from this coast.

The steam schooner Aeme was launched yesterday from Dickey's yard on Oakland creek and towed over to Mission street wharf No. 1 where she will receive her machinery. She was built for A. W. Boudie, and two more of the same model are to be turned out for the same firm. The Aeme is 162 feet in length, 34 beam and 19 feet in depth of hold.

Captain John Pederson, formerly master of the bark McNear, is manager of the four-masted schooner and one barkentine being built by C. G. White at Everett, Wash. They are for the Australian trade, and the first schooner, the Ottilia Pederson, named for the Captain's wife, will be launched about the middle of next month.

The yards of Hall Bros., at Port Blakeley, Hay & Wright, Dickey & Barle at Alameda, Bendixen at Eureka, Turner at Benicia—in fact, every yard on the coast is filled with as much work as can be turned out this year, and all the way is for the same purpose. About the water front, if a man make public the announcement that he is to build a ship, before night every share in the vessel can be sold. Floating property is said now to be the best paying in the world.

ENGINES COME TOGETHER

A HEAD ON COLLISION NEAR HALAWA.

Engineer Trulock, of Freight Train 5, is Badly Hurt—Engines Damaged, Some One Blundered.

Engineer Trulock, of freight train Number 5, is lying at the hospital in a rather bad condition on account of an accident on the railroad yesterday. His hip is dislocated, he is badly bruised about the breast and shoulders and there are fears that he may be injured internally. Dr. Cooper is attending him.

The engineer was hurt in a collision which might have proved serious to several lives and considerable property. It occurred near Halawa. The freight train left Honolulu on schedule for Kahuku. When near Halawa she was suddenly met by the work train, under full speed. Before there was time for either engineer to check his iron horse the two engines came together, one of them jumping the track. Both were badly damaged and will have to undergo extensive repairs in the shops.

When a collision suddenly became imminent the men on the work engine jumped out and succeeded in landing safely. Engineer Santos, of the work train, came near plunging in to the ditch at that point but was not hurt. Trulock waited to carefully reverse his lever and did not jump until the crash came. He then was half thrown off the engine, striking against the cab and landing heavily upon the ground.

The bumpers on many of the cars were badly damaged and some of them will have to be renewed. A wrecking train was sent out as promptly as possible and in a very short time cleared the track. The first passenger train from Pearl City was delayed but a few minutes and later trains came straight through without interruption.

An investigation is being made to determine the cause of the accident. The freight train being on schedule will probably agur against the officers of the work train.

INSPECTORS ARRIVE.
Captains Whitney and Lehnors, inspectors of hulls and boilers, arrived here today on the transport Grant and will begin work at once. They will inspect all the island vessels and if any are found deficient, cause them to be brought up to the legal requirements. The officers and engineers of the vessels are to be examined and given certificates, and no one without a certificate will be allowed to serve hereafter. The licenses given to the vessels after inspection will state the number of passengers they are allowed to carry.

WONDERFUL CANE FROM OAHU

PLANTATION.

Four Sticks That Measure a Hundred Feet Grown Without Use of Fertilizer.

Four sticks of sugar cane that average 25 feet in length were brought to Honolulu this morning from Waipahu. They were grown on Oahu plantation. The sticks are record-breakers for length and thickness and as there are about two hundred acres with similar growing cane, Oahu promises to have a record yield.

The four canes are in Hackfeld and company's stock, where many people saw them this morning. They are the result of 18 months' growth on soil that was not fertilized at all. This makes a remarkable showing for Oahu plantation and one of which the owners and agents are naturally proud.

Those who have seen the field in which the phenomenal cane is growing say that it looks like 15 tons to the acre. This would be the record for the islands. Oahu and Ewa have both gone up as high as 14 tons to the acre.

WHY SO MANY DRUNKS?

JANUARY'S ODD CRIMINAL RECORD.

The Past Seven Days a Record Breaker in Arrests for Being Drunk in Honolulu.

"Strange how the police calendar seems to have been affected by the temperance crusade," said a police court attendant this morning, as he looked over the docket for the day. "Of course temperance speeches don't cause boozing, but it's a fact nevertheless that there have been more drunks arrested lately than for months past."

There were fourteen charges of drunkenness this morning, which is a very unusual number for the middle of the week, and a high average for Monday. A few comparisons were made of the number of arrests of great distinction of a week, selected at random and the odd fact was brought out that the past seven days lead all the others!

There have been 59 arrests for drunkenness in Honolulu since last Thursday which, with an exception, is over twice the number of any other week. The figures were gathered, selections of periods being made at random. The following table shows the queer record which the month of January is piling up in police annals and which will make it a month of great distinction if it is kept up to the end:

Thus will the statistics of the future seem to show in the middle of January, 1901, Honolulu was passing through a series of Bacchanalian celebrations, instead of being the scene of great popular demonstrations, led by an orator of worldwide reputation, in behalf of strict temperance. It is a case where figures seem to lie. There is Francis Murphy's list of a thousand blue ribbon wearers on the one hand, and there is on the other hand the stern record of the number of times Judge Wilcox's ready tongue has had to say "Two dollars and costs."

REMARKABLE SUICIDE.
Albert Hermanson, an employe of Macfarlane & Company hanged himself yesterday afternoon at his home on Queen street, in a remarkable manner. His head was so close to the ground in the noose he made for himself that most of his weight must have been on the ground while he strangled, but his termination kept up to the end. The dead man had been drinking very heavily, was very despondent, and his wife's illness added to his sorrows. The coroner's jury today decided that death was due to strangulation, but did not say that the case was one of suicide.

POLICE AND MILITARY

ORDER FROM THE DEPARTMENT OF CALIFORNIA.

Behavior of Soldiers on Shore Leave in Honolulu—Transport Grant and Warrent Meet Unexpectedly.

Before allowing giving the soldiers on the transport Grant shore leave this morning just after the vessel arrived, Captain M. Baker, quartermaster in charge, read to them an order just issued by adjutant general Babcock, of the Department of California, regarding their behavior on shore in Honolulu. The order from the California headquarters was the result of complaints about the misconduct of enlisted men during their stay in this city. It is as follows:

"Several acts of trespass on private grounds, damage to front gardens some miles out of town and even in the town, indecent and disorderly conduct by volunteer soldiers, while on shore leave in Honolulu, from transports stopping there en route to Manila, have been brought to the notice of the department commander. The civil authorities at Honolulu are very indignant. They do not interfere unless the disturbance or disorder of the soldiers becomes flagrant and never interfere if the military authorities are on the spot to make the arrest but having made the arrest they very properly insist upon taking the offender to the station house for investigation, etc., and it is in this effort that conflict between the police and patrol rounding up the men have heretofore narrowly been averted."

"The department commander directs that you take such steps as will prevent any indecent and disorderly conduct in Honolulu on the part of the troops on the transport Grant and that if you send patrols to the city of Honolulu you instruct them as to their proper duty toward the civil authorities."

Captain Baker supplemented the reading of this order with some remarks of his own, regarding the manner in which the men should conduct themselves on shore here. The Captain said he wanted them all to have a good time, but hoped that they could do it without getting drunk and making trouble, or in any way conducting themselves in a manner unworthy of their American uniforms. The soldiers were given shore leave until 10 o'clock tonight.

The Grant has only 84 privates on board. They are casuals belonging to many different organizations in the Philippines. The rest of those on board are wives and other relations of officers at the front, clerks and surgeons. There are 15 assistants and 9 surgeons and 9 clerks for the Philippine commission on board.

Captain Bruziere is the sailing master of the Grant this time, having been promoted from the position of chief petty officer. The retirement of Captain Schiller, just before the Grant left San Francisco on the 16th, word was received that the appointment of captain Bruziere was to be permanent instead of temporary as was first reported.

Captain Baker, the quartermaster of the Grant, has been through the war many times since the transport service began. He is one of the experts in the steamship quartermaster business now, and has been in it long enough to make the acquaintance of most of the army officers who have been traveling to and fro. The meeting of the Warrent and Grant in Honolulu was quite unexpected and the officers on board both had welcome opportunities to make calls today.

The Warrent leaves this afternoon and the Grant tomorrow at noon for the former for San Francisco and the latter for Manila.

ELABORATE BALL PLANS

Much Rivalry Over Selection of the Princess.

Another meeting of the lady managers of the Mask Ball was held this morning at Dr. Sloggett's office in the Progress block. Considerable speculation and even rivalry is felt over the appointment of the princess. While the selection of his partner rests with the Prince of the Carnival, Prince J. Tarn McGrew feels very modest and has asked the ladies to aid him in the matter. One of Honolulu's sweetest daughters who is described as "tall, dark and handsome, with black lustrous eyes" is mysteriously hinted at by the committee, as the most probably successful candidate.

An important decision was reached when it was agreed not to remove the masks until shortly before midnight. The exact time is at the discretion of the master of ceremonies. The floor committee has not been selected as yet.

Mrs. John S. Walker and Mrs. Tenney have decided to have a large tent erected at the entrance of the drill shed for the convenience of the gentlemen who will be permitted to smoke there. Bull rushes will be on the floor.

The boxes will be constructed especially to order. Mrs. Wilder has taken the first box and as others are subscribed for they will be constructed, the intention being not to have any more boxes built than there are holders. The cost will be from \$25 to \$50 each. There will also be a balcony built on one side of the hall, capable of seating 250 spectators while a double row of chairs will be placed on the dancing floor for the convenience of the maskers. Edwin Paris has taken personal direction of the "dishing of the floor, while J. A. Gilman has donated the floor.

The band will be placed in a balcony over the center of the dancing floor suspended from the ceiling.

EDITOR NORRIE'S CLAIM

DANISH GOVERNMENT TAKES IT IN HAND.

Secretary of State Asks Governor for Particulars of the Editor's Case, Other Letters.

The Secretary of State has taken up the claim for Mr. Norrie, editor of the Independent, against the Republic of Hawaii for imprisonment during the revolution of 1898. This matter has been brought urgently to the attention of the State Department by the Danish minister at Washington. By yesterday's mail there was a request from the department to Governor Dole for expert information as to Mr. Norrie's connection with the revolution and other data.

A letter from the Treasury Department to Governor Dole asked for information in regard to the bonded indebtedness of the Territory, which was assumed by the central government at the time of annexation. Mr. Gage wishes to know just when the various issues are due or may be taken up.

Secretary Hitchcock, of the Interior, wrote in reply to several questions regarding lands. In general he referred to his letter of December as an answer to all.

At today's meeting of the Executive Thomas Clark was granted a light wine and beer license at Wahee, Maui.

Mr. McCandless presented a map belonging to the Territory, showing the proposed street extensions around Liliha and King and the extension of Kukul street, it is expected that Kukul street will at once be extended through to Liliha. It will connect with King near the junction of the two thoroughfares.

Mr. Taylor complained that, either the electric or telephone company, in extending lines around Thomas square has cut and otherwise mutilated trees. As there seemed to be no law covering the matter, no action was taken.

The balance of the time was taken up in discussing a project of produce fairs, with prizes for the best vegetables and fruits exhibited. In the minds of some of the officials such institutions would prove of considerable value in that they would be an incentive to extraordinary effort in growing the best of everything. Mr. Taylor exhibited before the meeting three strawberries of immense size grown by W. M. Giffard on his place in Makiki. At the project is one of some size, and is surrounded by more or less difficulty, time was taken to consider it.

THE GOVERNOR'S REPORT.

A Convenient Compendium of Useful Territorial Information.

The copies of the report of the Governor of the Territory of Hawaii to the Secretary of the Interior have been received from Washington. It was printed at the Government Printing office and is a bound pamphlet of about thirty pages. It is illustrated with half-tone engravings of the Capitol, Coconut Island of Hilo, an Hawaiian Woman, an Hawaiian Child, an Hawaiian School Boy, Kaulai Schoolhouse, an Hawaiian fisherman, and a map of the group.

The governor treats of population, revenue, land system, agricultural development, forests, railroad and street car enterprises, commerce, condition of the natives, public buildings, education, undeveloped resources, and legislation.

The report is a compendium in convenient form of a great deal of useful information regarding the territory.

VANDERBILT WEDDING.

WORK ON BOSTON DEFENDER.

Lawson's Yacht to Have Oregon Pine Boom.

BOSTON, January 15.—A fine stick of Oregon pine, 112 feet long, has been towed to Lawley's yacht yard and handed at the spar shop. In a finished state it will be the main boom of the Lawson yacht. Workmen at once began to prepare it for trimming. The sailmakers have finished two jib topsails and have cut a stay sail.

Crowninshield returned from his trip to New York and said he had been to see Secretary Odell of the New York Yacht Club to secure an exact copy of the regulations governing the trial cup races. He said that he found that boats would not have to be designed at 85 feet 4 inches water line, but that they could be built up to ninety feet water line, but that all excess of that measurement would have to be paid for with time allowance.

Crowninshield said that the yacht's crew would probably number thirty-five; with an increase of ten during the racing, if it were found necessary. He understood that the Herrschhoff boat would have a racing crew of fifty-five men.

SHAMROCK'S KEEL RUN.

GLASGOW, January 15.—The keel of the Shamrock II, challenger for the America's cup, was run while Denny's was closed on New Year's Day. Since that time a score of the side frames have been set up to port and starboard.

TWO BROTHERS IN DISTRESS.

SAN FRANCISCO, January 19.—The ship Two Brothers, bound from Tacoma for the Hawaiian Islands, had to put in here last Tuesday night in distress. She was caught in the gale that caused so much damage, but apparently escaped unhurt. However, on December 23, when 350 miles southwest of San Francisco, in a calm she sprang a leak. Soon the water was pouring in at the rate of eighteen inches an hour and all hands had to take to the pumps. The Two Brothers was then put before the wind and under easy sail. San Francisco was reached. Her cargo will be discharged and the vessel will go on the drydock for an overhauling. In the days of the Civil War the Two Brothers was a clipper. Now she is considered an "old timer," but seaworthy.

STEAMER FOR HAWAII TRADE.

SAN FRANCISCO, January 18.—The steamer California will be released today from the transport service by the Government and turned over to the American-Hawaii Steamship Company. The vessel docked yesterday at Harbison-street wharf and began discharging the 1500 packages of winter clothing which had been sent for use of the troops in China, which is not now needed. The California is to be fitted with a steel propeller before the vessel leaves port again.

BARKENTINE PFLUGER.

WASHINGTON, January 9.—Representative Kahn today introduced a bill giving American registry to the barkentine J. P. Pfluger of San Francisco.

THE W. H. DIMOND.

SAN FRANCISCO, January 12.—The barkentine W. H. Dimond has arrived from Honolulu, after a passage of nineteen days, with 19,323 bags of sugar.

THE SONOMA.

SAN FRANCISCO, January 12.—A large number of mechanics are at work on the several decks of the new steamer Sonoma, putting the vessel in shape to leave for Australia on the 23d. All the furnishings originally placed in the steamer have been temporarily removed, and when the workmen have completed minor alterations, will be replaced.

MANY OVERDUE VESSELS.

SAN FRANCISCO, January 15.—Word was received this evening that the British ship Cape Wrath, from Calcutta for Portland, had been sighted off Astoria. This is one of the overdue fleet on which there has been so much speculation in England. She has been a puzzle to the English overdue market, and the rate of reinsurance has been kept dancing. Two days ago the rate was up to 55 per cent, and tonight, before the news of her reappearance came it had fallen to 40 per cent. This they said, was very unusual in reinsurance, and there was no apparent reason for the slump.

There are still three ships bound for Portland on which high rates of reinsurance are being paid and from which nothing has been heard since they sailed. These are the Andra, from Santa Romalia, 75 per cent reinsurance; Bertha, from Wei-Hel-Wel, 70 per cent and the Otto Gildermeiter, 70 per cent. The reinsurance gamblers are making certain that the Andra is gone. The British ship Castle Rock, 80 days out from Hongkong for British Columbia is beginning to attract the attention of the reinsurance gamblers. The rate on her is now 35 per cent.

ALGOA ARRIVES.

SAN FRANCISCO, January 12.—The big tramp steamer Algoa under charter to the Government, arrived today in ballast from Manila. She made the voyage in forty-three days and from Nagasaki in twenty-eight days.

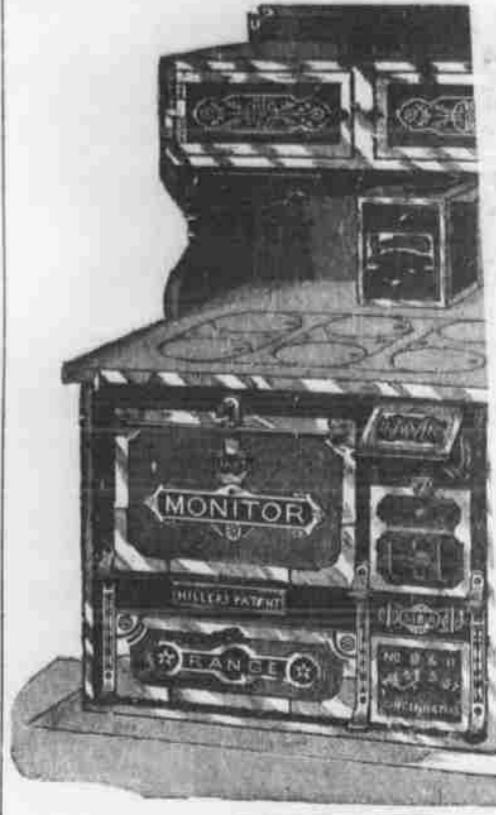

THE STANFORD ROW.

The position of Stanford as a University has been completely undermined by recent events.

Whether in dealing with difficulties such as have occurred in that institution there has been shown the utmost lack of tact, and President Jordan has picked the bubble of a reputation which many men have thought for a long time was an inflated one, or not, opinions may differ. It is easy work managing a ship when all is smooth sailing, but it is when a ship is on a lee shore, and things look blue to everybody that true seamanship comes in. If President Jordan is such a one, he will be remembered when he is remembered at all, as a fine yachtsman whose nerve gave out when a storm came on, and who preferred the flesh pots of an easy salary under the domination of a prejudiced woman, to the honorable distinction of resignation when his place really became untenable.

But there is another view which may be taken, and which doubtless many will take. President Jordan may have thought that by opportune yielding in a matter where many believed that academic courtesy and not the principle of academic freedom was involved, he might save the University with its rich endowment to a future of usefulness through academic freedom. If the Ross incident had been alone, it is probable the immutability of the University would have triumphed over the fleeting interest in the incident, and Dr. Ross and his manner of leading the University would have been forgotten. But the Ross incident did not stand alone. The principle of freedom was too vitally involved and there were too many men in the faculty devoted to that principle. The result cannot fail to be disastrous to the University and to the reputation of President Jordan.

Certainly the friends of President Jordan, and they are legion, will hope that it may be shown that he did not sacrifice the principle of academic freedom through any unworthy weakness; but that his error was in hoping that both the University and the principle might be preserved.

In the Territory of Hawaii we have considerable interest in Stanford University, because we have many graduates from that institution in our midst, some of our young men and women are there for educational purposes, and more have been planning to go.

It is evident that there is an utter misconception as to what a university should be in the minds which dominate Stanford. If Stanford had announced at the outset that it was to be a gargled university, that only certain lines of thought would be allowed there it would have taken its place along side institutions of a similar kind. Instead of being a university it would be a college. There is no reason why any one should not found a college, and tie it up indefinitely to certain peculiar views. We have Baptist Colleges, Jesuit Colleges, Episcopal Colleges and so forth. Every one of these has its right to express any particularism and exploit its own. But a university is a totally different affair. The various chairs in the university are to expound the truth as far as in them lies, without regard to religious, or any other kind of views.

A university, as a rule, gets reputation for some specialty. Some have the reputation for many specialties. Thus men can go to one for the study of Eastern languages, to another for the most excellent mathematical training, to another for the most thorough classical course, to another for the most enlightened views upon sociology and so forth. But the men who talk upon these subjects are untrammelled. Their very freedom makes them able to make the mark which the institution benefits by.

Requests to places of learning should be left without any string. If the string is kept in the hand of the donor the institution had better struggle on without the money. Well conducted, working honestly for free thought, the university however poor will eventually rise. It is some times wise to avoid the flesh pots of Egypt.

Leland Stanford Jr. University was raised as a monument to the dead son of an extremely successful and wonderfully wealthy man. It did seem at the time of its foundation that it was a magnificent bequest. It was as far as money was concerned, but great mental elevation and education are at times utterly opposed to accumulated wealth, and to the methods by which it has been obtained. As far as one can judge, Mrs. Stanford holds the faculty of the university from President Jordan down to the janitors with a nose round their necks and objects to any criticism upon the methods by which wealth is obtained and, in fact would like to set up a set of economics of her own. But the men who have been attracted to this Western Catalpaque of a dead millionaire's son, under the impression that it is a university are not disposed to give up their liberty of thought and worship the golden calf. It is a satisfactory to see so much chivalry for the ideal, as has been shown at Stanford, and it is a lesson

against the acquisition of wealth when it comes into conflict with the more plenary of intellect and culture. Wealth does not buy all.

THE HOUR AND THE MAN.

The South African question is far more than the South African question. If such a statement can be made. As far as the paramount power is concerned it must maintain that power or its prestige, and its effectiveness as a colonizing power is lost, at all events for that portion of the world, and as a fact would be lost in other portions of the world. Great Britain can do no more, and no less than it is doing as far as general policy is concerned.

The misery of the war, as at present conducted, is that it is breeding up a condition of hatred which it will take years to eradicate, but such hatred can be eradicated, as witness the intense hatred of the Celt against the Sussanah, a deeper race hatred and with more reason for hatred than ever there is between Boer and Britain.

The news from South Africa, as received by this mail is meager, and private letters do not piece it out much. The Boer raid is certainly going on, but it is also evident that the dyed in the wool raiders, men who have been living at free quarters upon the country like De Wet and Styn's troops are not very much in a feeling of fellowship with those who join them in Cape Colony. This is a natural result of swashbuckling. The central idea, which first aroused the man to go a raiding has long been lost sight of and the idea that is successful to a booting is developed.

Whatever view a person may take, whether pro-Boer, or anti-Boer, all must unite in deploring the present condition of affairs in South Africa. How it is to be remedied is one of those problems which will be almost insoluble, but no human problem has yet proved insoluble, and there is no doubt down in South Africa now the man, who will prove himself the man when his hour strikes. The hour and the man have been believed in from time immemorial, and they can be believed in today.

Wireless Telegraphy does not seem to be able to get upon a commercial basis. When it does do that The Star will make a sweeping bow. The question is, When?

The statement that Oklahoma and Indian Territory are to be made into a state may explain why the Cherokees have decided to move into Mexico. As a state their political power would not be effective and they prefer to go to a more primitive country.

If Hilo likes to foul its own nest of its own making, it is its business, but no one outside of Hilo's grand jury would have dared to have called it "a modern Sodom." In point of fact one is utterly doubtful whether the gentlemen who used the phrase really knew the full meaning of the words. They probably meant "a modern Gammorrah." The latter city was not quite so evil as the former.

The pure water problem is one which is exercising the main cities on the mainland, and they have to deal with conditions far harder than any we have to contend with in this Territory. Perhaps if the wrangling municipal cranks would unite their brains and consider this question instead of worrying over bylaws and ordinances, it might turn out satisfactorily for the general public after all.

The "opium" judgment of the Judge of the First Circuit Court, will have far reaching results. The possession of opium was regarded by statute as a serious breach of the law and was punished accordingly. If the First Circuit Judge is correct in his ruling opium may be smoked under the noses of the Supreme Court and there will never be a one to say nay. There will be joy untold among the denizens of the new Chinatown, if the decision of the First Circuit Court is upheld.

Jerniah Curtin, from whom the Star obtained an interesting interview, is a man of world wide renown. It is he who introduced Henryk Sienkiewicz to the English reading public, and has provided through his graphic translation of the gifted Polish author, so much for the mental entertainment and elevation of the English speaking world. One of the advantages of living on the world's cross roads is that one has the opportunity of seeing and talking with men of wide world celebrity. There are probably few places on earth where there is such a chance for meeting so varied a number of celebrities as here. Suva is another place—but it is hard to meet them, and in the great centers, however great the individual may be, he quickly disappears in the crowd.

Squatters don't seem to be having much of a good time. The Oiaa people, who trusted to poor legal advice, put in time and work only to lose the fruits of their labor in the end. One cannot but feel sorry for some of the Oiaa squatters who were most thoroughly deceived, and they have not the satisfaction of getting after their deceivers as the flat does after the bunco man when the police get hold of him. The Oiaa squatters can contemplate with pride that their subscription helped towards a soft billet. It is the only pride they can take now. The Honolulu squatters will have to go too, but they have the satisfaction of knowing that they subscribed nothing towards Washington trips and have lived rent free for a couple of years. They are in. The Oiaa men are out.

SAMUELS' STRANGE CASE

THE DEAD SAILOR KILLED BY ARSENIC.

Mystery Multiplied About the Supposed J. Thaanman—His Baggage Apparently Lost.

Arsenic poison killed the sailor Thaanman or Samuels, who was found dead in the Sailors' Home. The end of the inquest over his remains leaves unsolved the question of how he took it, while the evidence brought forward shows several leads, which it is impossible to follow, that might reveal a suicide, or a darker tragedy.

Nothing has been found of the dead man's baggage. The only person who could shed any light on the question of what it has gone on to Australia on the Miowera. He was the man's cabin mate on the journey here from Victoria and he carried the deceased's baggage to a back at the wharf here.

Those who traveled on the Miowera say that the dead man had some baggage. The witness Stout declares that he saw the roommate and Thaanman go to a back together, the other man carrying Thaanman's bag for him and placing it in the back. This man was a through passenger and he was far out at sea by the time the dead body was found in the Sailors' Home. Owing to the fact that the Home does not keep a register, the identity of the dead man has not been certainly established, but inquiries among the passengers leave no doubt that he was Thaanman. Thaanman was the only sailor on the passenger list of the steamer and his description tallies with that of the dead man. Moreover, while all the others that arrived here on the steamer have been accounted for, Thaanman cannot be found.

Captain Bray of the Sailors' Home has a large bag which he says may have belonged to the dead man, but he does not know. It may be the property of some other sailor. As long as the manager of the home would not say that it was the property of the deceased, the police refused to interfere with it, and it has not been opened. If it is not called for until the legal period during which it has to be kept has expired, then, when the case has been long forgotten, it may be opened and its contents may be such as would solve the questions which the coroner's jury could not settle today.

Dr. Shorey made his report to the jury today. He said that arsenic had caused the death of the sailor. Small quantities of that poison had been found in some of the organs, and the condition of the blood was indicative of arsenic poisonings. The blood did not coagulate but remained liquid, as in cases of arsenic poisoning. The dead man's heart was diseased, and this hastened death. The man, however, died in great agony. This was shown, Dr. Shorey said, by the position of the body when found.

There is no evidence that Thaanman, or Samuels, had any arsenic, and the question of how he got it and when and where he took it, will never be answered. The condition of his stomach showed that the poison was taken before he had dinner last Sunday night. This is regarded as evidence that he did not commit suicide, as suicides do not generally eat dinner after they have taken their fatal dose. He avowed intention to go to his brother in Hilo and his preparations to do so, are also cited as showing that he did not intend to kill himself.

The dead man's movements have not been traced, beyond the fact that he went to the Sailors' Home and retired, was heard groaning in the night and was found dead on Monday morning. In rendering their verdict the jurors took occasion to call attention to the failure of the Sailors' Home to register. Had the deceased been registered, as the law requires in most countries, his identity could have been established.

The jurors found that "owing to the failure of the management of the Sailors' Home to register his name, the true name of the deceased was unknown. His death was declared to have occurred at Honolulu on the 29th of January, 1901, from arsenic poisoning and heart disease. The verdict says nothing about how or when the poison was taken. The jurors were M. Neumann, W. L. Eaton, L. R. Mossman, H. Cook, C. Tobin and E. H. Faine.

There is no arsenic in the pills that were found on the person of the deceased. One theory that would account for his taking the stuff is that he tried some other medicine for heart disease. If his baggage could be found, such medicine might be discovered.

VICTIM OF PETTICOAT POLITICS.

Captain Hall Incurred Women's Dislike at Peking.

WASHINGTON, January 14.—A letter received here from a naval officer indicates that Captain Hall, accused of cowardice at Peking, is a victim of petticoat diplomacy. Captain Hall was in command of the marines from July 5, when Captain Moyer was wounded, until the siege of Peking ended.

"I believe the charges," said the naval officer, "grew out of the fact that the marines would not take off their hats to the wife of the First Secretary. There was one soldier on duty, a non-commissioned officer and I riveted against the First secretary and his wife and justly in my opinion."

"It seems that the Chinese steward of Mr. Conger told our marines that there had been a row between Mrs. Conger and the wife of the First Secretary because Mrs. Conger wanted to send the marines on the wall some of the canned goods which the marines had themselves captured and turned into the general store in the British Legation. Mrs. First Secretary refused to send anything, and so, according to the Chinese steward, the ladies stopped speaking to one another."

"Our marines thus got the impression that Mrs. Conger was their friend and that the wife of the First Secretary was not, and the marines used to stand at attention when Mrs. Conger passed in at the Legation gate, while they did not when the First Secretary's wife entered."

"One day during the siege, as the wife of the Secretary passed through the Legation gate from the British Legation and the marines did not stand at attention, she took them to task, calling them 'bums and rascals' and saying that they were not fit to be soldiers."

"Passing into the Legation grounds and seeing Captain Hall asleep in a chair she awakened him by calling, 'Captain Hall, your men do not salute me. They are bums.'"

"Captain Hall said: 'I am sorry, madam, that they are not polite, but that is a matter I cannot control' or words to that effect. She then said, 'They are loafers.' 'No,' said Captain Hall, 'no one here has any time to loaf.'"

GARNER BELIEVED DEAD

MAN WHO THOUGHT MONKEYS TALKED.

Was In Africa Prosecuting His Investigations on That Subject—Was Stricken With Jungle Fever.

BOSTON, January 12.—Friends of explorer Robert L. Garner, the famous explorer, scientist and author, are anxious over his possible fate in the wilds of Africa. Grave fears as to the possibility of his death are entertained. Among those concerned over the professor are the Rev. E. E. Hale, Professor Putnam of Harvard, Professor Furber and S. A. Merrill of the Mechanics' National Bank.

Professor Garner called from New York about July 19, 1900, en route to Africa. His avowed object was to make further study of the monkey language, and the interest and approbation of many eminent scholars and scientists, including the four men above mentioned, were enlisted in his object. On August 1st he arrived in Lisbon. Among those concerned over the professor are the Rev. E. E. Hale, Professor Putnam of Harvard, Professor Furber and S. A. Merrill of the Mechanics' National Bank.

Professor Garner called from New York about July 19, 1900, en route to Africa. His avowed object was to make further study of the monkey language, and the interest and approbation of many eminent scholars and scientists, including the four men above mentioned, were enlisted in his object. On August 1st he arrived in Lisbon. Among those concerned over the professor are the Rev. E. E. Hale, Professor Putnam of Harvard, Professor Furber and S. A. Merrill of the Mechanics' National Bank.

While in this place, on the eve of his departure for the interior, he suddenly was stricken with jungle fever, although his two previous expeditions to the same place had, in his own judgment made him immune. The exorbitant rates levied upon him for transportation and the money already laid out upon his really inadequate equipment, had by this time made him almost penniless and when his funds entirely failed his faithless hirelings fled, leaving him to fight the grim specter alone.

On November 27th he wrote urgent letter to Messrs. Hale, Putnam, Furber and Merrill, apprising them of his exhausted financial and physical condition and urging that aid be immediately sent to him. These were the last letters from him and none of the letters were received until the 1st of December. Efforts at once were made to cable money to him, but cable communication could not be had with any bank in the vicinity of the place from where the letters had been posted. All efforts to locate him also failed. On last Tuesday S. A. Merrill of the Mechanics' National Bank was informed that all efforts to communicate with Garner had proven futile. Mr. Merrill then sent a cable to San Thome in the hope of discovering Garner's whereabouts. No reply to this message has been received. Messages sent yesterday also have failed to elicit any response and Mr. Merrill, who has been one of the most sanguine, at last has given up all hopes.

COURT INSPECTOR HERE

WILL LOOK INTO AFFAIRS OF ESTATE'S COURT.

William H. Moyer, Next to Head Examiner, Arrives from Washington. What He Will Do Here.

William H. Moyer, next to the head and senior of the older examiners in the Department of Justice, arrived here in the transport Grant this morning and is quartered at the Hawaiian hotel. His business here is to thoroughly look into and report on Judge Estee's court arrangements. He was a bit disappointed that the district judge was away but will await his return.

Mr. Moyer's relation to his Department corresponds to that of Mr. Thomas to the Internal Revenue and Mr. Robinson to the Post Office. He is to see that all United States courts are in proper shape, to look into the work of the various officers and examiners, accounts. Every detail of the court will be carefully inquired into and a report returned to the head office in Washington. In completing his work Mr. Moyer will probably have to visit Hilo, Maui and Kauai. It will remain with him to determine how many court houses there shall be in the group. In the matter, however, he will be guided largely by the recommendations or suggestions of Judge Estee.

Mr. Moyer is a native of Pennsylvania, tall and robust. He was first appointed to the Department in 1895 under the Cleveland administration. The appointment was renewed a year later under Mr. McKinley, and since that time he has risen rapidly to the second place on the staff. His duties call him to every part of the United States.

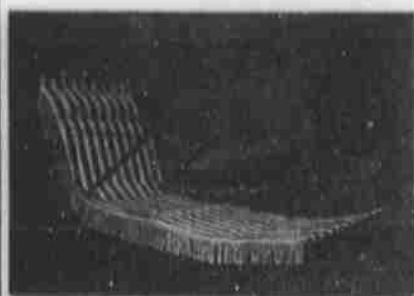

A BIG FOREST RESERVE

GOVERNMENT CONSERVING THE WATER SUPPLY.

Five Million Acres of Forest Taken Over in Arizona by the Government. What it Means.

PHOENIX, (A. T.), January 12.—A special dispatch to the Phoenix Republican from Washington says: The San Francisco mountain forest reserve of Northern Arizona, which was divided into alternating sections, has been solidified. An agreement has been reached by the government and the individual owners by which the Government acquires title to all this land in lieu of other lands exchanged therefor. This makes the formation of a reserve of nearly 2,000,000 acres and guarantees adequate protection to the magnificent forest and the conservation of the waters that feed the Verde and Salt rivers. The value of this action to the people of the Southern valley, especially the Salt River valley, cannot be overestimated. The reserve occupies an important water divide and the Government plans to take immediate steps to protect the enormous water supply. This Federal action will encourage the establishment of great industries affected by water supply, and will give an impetus to a local movement looking to the construction of a great reservoir in the Tonto basin for regulating the water supply.

The creation of the reserve is due to the efforts of W. J. Murphy and other representatives from Phoenix, who spent many weeks in Washington in an effort to unify the conflicting interests of the cattle and sheepmen, who have come together in bloody wars in Arizona because of the forest problem. Secretary Hitchcock of the Department of the Interior affixed his signature to the agreement today. Under his subsequent ruling Arizona's total reserve embraces nearly 5,000,000 acres.

JUDICIARY FOR HAWAII.
WASHINGTON, January 12.—Senator Warren of Wyoming today introduced a bill amending the Act establishing a government for Hawaii by providing for a district court in Hawaii, the District Judge, the District Attorney and the Marshal to be appointed by the President and to hold office for six years. In addition to the ordinary jurisdiction of a District Court the amendment provides that it shall have jurisdiction in all cases cognizable in a Circuit Court of the United States.

UP TO THE COURT.
WASHINGTON, January 9.—The House Committee on Insular Affairs has decided to postpone consideration of all questions relating to our new possessions until after the Supreme Court renders its decision upon the question as to whether the Constitution follows the flag, as it is considered useless meanwhile to attempt any legislation for the islands. It is hoped that the decision may be handed down before this Congress expires, March 4th.

THE ARMY SMUGGLERS.
The Case of the Grant Officers in San Francisco.

SAN FRANCISCO, January 16.—In dismissing the cases of Dr. Holmes and E. Milthrop, who were arrested for smuggling silk, from the transport Grant on January 24, United States Commissioner Heacock held that the evidence offered was not sufficient for conviction. Milthrop admitted his guilt, but contended that he had been ordered by Dr. Holmes, his superior officer, to carry the silk off the steamer without paying duty. He was caught with it under his overcoat.

Dr. Holmes suggested that the customs officials were lax in their duty and often made a distinction in the rank of the officer attempting to smuggle. Those of high rank were permitted to do as much as they pleased and those lower down the scale held to pay duty. This the customs officers denied. There have been a number of arrests and seizures at the transport dock within the last two months by the customs inspectors, but no convictions. The District Attorney believes the seizures of too small consequence to warrant prosecution, while Collector Spear contends that examples must be made of the small smugglers as a warning to the more ambitious.

CLOSE OF MURPHY MEETINGS.
Francis Murphy concluded his first series of meetings at Central Union Church last night. Many signed the pledge. Among those who spoke besides Mr. Murphy were Rev. W. M. Knead, Rev. G. L. Pearson, Rev. A. E. Cory, H. E. Coleman, Captain Wood, Franklin Austin, Miss Adams, A. J. Coates, Mr. Pierce and others. J. K. Kaula the Independent Party leader took the pledge. Mr. Murphy is authority for the statement that over 1,000 people signed the pledge during his campaign in Honolulu. This evening Mr. Murphy will speak at Camp McKinley. On Sunday morning he will speak at Oahu prison, and at 3:30 p. m., he will be tendered a reception at the Y. M. C. A. hall. His plans are to sail on the Sonoma for the Colonies.

Loosen Decision to George Baker at Oakland.

OAKLAND, January 11.—The Bellanca Club sustained its reputation for good fights again tonight by bringing off three excellent contests. The fighters were evenly matched and there were no knockouts, but it was not the fault of the contestants, for each fought to win.

Interest centered in the last contest, a fifteen round bout between Tommy Cox of Australia and George Baker at 126 pounds. Cox was the aggressor and started to beat the fight in a few rounds. He kept leading for Baker's jaw and fighting him to the ropes for the first five rounds, but after he had bumped into Baker's long left a few times in straight punches and uppercuts and found out that the jaw was not to be reached, he changed his tactics and played for the wind and the kidneys.

Baker knew he had a hard game and played it carefully, exercising all the generalship for which he is noted. He fought almost entirely on the defensive, waiting for an opportunity which did not come, although in the eleventh and twelfth rounds Cox was saved by the gong.

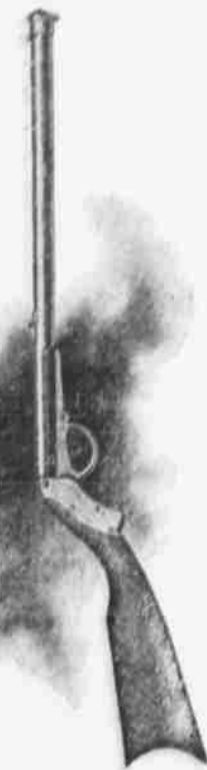
