## Held By The Enemy

The Combination of Kahului and Paia  
Too Strong for Wailuku.

Not content with their troubles at home, the married men of Maui, (at least some of them) essayed to go out on the diamond and show the young sprouts how the great national pastime should be played. Right here their troubles began to multiply.

Bravely did those stars of former days march forward to the plate with club in hand, and as bravely did many of them march back again. The fielding? There was no fielding. When the ball was hit, a new one was brought into play, till some small boy recovered the sphere. The crowd in the grandstand was cheering wildly, and the poor deluded wretches out their sweating and squirming believed they were cheering for them. It was the hook they were calling for, and finally the hook arrived after five innings of agony.

The Wailuku contingent resent the application of the hook because they were on the small end of the score, and they are still looking for more. The scene of the next meeting between these two teams will probably be in Kahului, where the public is supposed to be more long suffering.

The umpire, not content with the rules laid down by the National league, applied some rules of his own to the game, which were read to the players, and which no doubt had a very disconcerting effect on them. Below are the rules of the umpire:

Special Rules to Govern the Baseball Game of Married Men. Kahului vs. Wailuku.

Rule 1. No decisions of the audience will be allowed, without the sanction of the Umpire, neither before nor after the game.

Rule 2. All protests against the Umpire's decision must be made in writing on paper, same to be published in three issues of the MAUI NEWS, with three months intervals between each issue in order not to delay matters.

Rule 3. The Judge who must be chosen by the Umpire will decide all protests according to rule, rule to be furnished by the Club at the expense of the party entering such protest.

Rule 4. All remarks derogatory to any player's peace of mind, will be promptly resented, they have troubles enough at home.

Rule 5. Any player that desires some one else to run bases for him, may do so, providing his substitute weighs 100 pound heavier than himself, this will assist the speed of the game.

Rule 6. All moneys thrown to players for brilliant plays will be taken care of by the Umpire, who thanks the public spirited gentlemen in advance. Higher than \$10 throws will be considered gambling, and returned to the guilty sinner.

Rule 7. Any single man that may be caught fraudulently playing in either of the married men's teams, will be prosecuted and married and may the Lord have mercy on his soul.

Rule 8. No more than 5 Physicians will be allowed to attend the dead and wounded during the game. The Physicians fees will be paid from gate receipts, after the asso-

## Baseball Sunday

The Wailuku's Defeated the Paia and  
the Stars Beat Kahului.

The new baseball league got fairly started last Sunday, and now we shall see a revived interest in the sport on Maui. Paia came down fully expecting an easy victory over the Wailukus, after they had succeeded in getting away with the Stars so easily the previous Sunday.

They reckoned without their host, however, as Wailuku wanted that game also, and they immediately set to work putting it on ice, in the very first inning. The way the Wailuku team batted was a revelation to the Paia pitcher, and he soon retired. After six innings had been played, the score stood 11 to 3 in favor of Wailuku, and the management decided it was a good place to try substitutes. These substitutes floundered around the outfield in the seventh inning almost as badly as the married men, and the Paia's succeeded in getting five runners across the rubber before the side was retired. This was the last flash, as they were easily disposed of in the two succeeding innings, the final score being 15 to 11. The game was rather loosely played on both sides, but this was partly due to the hard hitting. Both teams stung the ball hard when they connected at all.

At Kahului, the Stars and Kahului had a battle royal, the game seesawing throughout eight innings. The Stars got six runs in the very first inning. The Kahuluis came right back and in three innings had piled up twelve runs. Then the fighting spirit of the Stars asserted itself, and while they held Kahului they crawled up till they had scored the tying run in the eighth. The rest was easy, the final score being 14 to 12 in favor of the Stars.

Next Sunday the Stars and Wailukus play at Wailuku and the Paia's and Kahuluis at Kahului. The game between the Stars and Wailukus will be worth seeing as both teams are extremely desirous of winning this game. The Wailuku team is fast, and will be coming all the time, as they are mostly young players. On the other hand the Stars are mostly old experienced players, who will be more apt to profit by the mistakes of their opponents, and who will fight just as hard in the last inning as in the first.

The Paia team is a strong aggregation and Kahului will have to buck up if it expects to win this game.

Next Sunday all automobiles will be expected to enter the grounds, and will not be allowed to stand on the railroad property as has been the habit heretofore. The admission fee of twenty-five cents which is being charged to the grounds is barely enough to cover the expenses of running the games, and it seems as though everyone who wishes to see baseball should be willing to pay this, and not act the piker and try to get something for nothing.

## Honolulu News.

HONOLULU, Oct. 13.—The government upholds the Philadelphia firm which secured the Hilo contracts.

The Hawaiian Dredging Company has landed the contract for dredging the Kahului harbor. The price was 56 cents per cubic yard. The commissioners have signed the belt road contracts with Lord & Young.

No more pink teas and receptions will be held at the military posts here.

Word has been received that after October pineapples and bananas will be included in the California quarantine, when they are packed in Hilo grass. Chairman Judd says more care should be taken in packing.

HONOLULU, Oct. 12.—The Harbor Commissioners oppose preferential rights to Reed's Bay lots on the ground that they may be needed for government wharves.

The Civic Federation's protest over the belt road contract was knocked out by Swanzy and James Dole. On an opinion by the Assistant Attorney-General, the contracts will be signed.

The Harbor Commissioners are preparing to start wharves on Maui, Hawaii and Kauai.

Captain Matson is said to be planning for a five day liner for the Honolulu run.

## Revolution In China.

PEKIN, Oct. 13.—An actual revolution is going on in China. The revolutionists have occupied Su Ting Fu, where 300 Manhus were killed. They have also captured many towns along the Yang Tse river, and destroyed the railroad. The government acknowledges the seriousness of the outbreak and has ordered out two army divisions. Revolutionists have established a republic in the captured province, with Dr. Um Yhe San as president, and Sen Yu as the president of the assembly. The assembly has confiscated all government money in the banks. New money of the republic is being issued. All foreigners are safe.

NEW YORK, Oct. 13.—So great was the demand for seats at the first World's championship baseball games that the crowd stormed headquarters after waiting in line all night.

SALEM, Ore., Oct. 13.—Taft has promised that the old battleship Oregon shall be the first to pass through the Panama Canal.

SAN FRANCISCO, Oct. 13.—The cause of woman suffrage is leading by 1,400 votes.

## Italian Army Landed.

ROME, Oct. 12.—It is officially announced that the entire Italian army has landed unopposed. The Turks have retired back of the city, where the Turkish commander is attempting to reorganize his troops. It is rumored that Great Britain has stepped in to check Germany's Mediterranean ambition. It is partly due to their protest that Italy refused Germany a foothold.

BERLIN, Oct. 12.—It is declared here that Turkey and Italy have concluded an armistice.

HANKOW, China, Oct. 12.—Wu Chang has been captured by the rebels after an all night battle. Foreigners were not molested.

LOS ANGELES, Oct. 12.—The trial of J. B. McNamara began yesterday, on the charge of causing the death of machinist Hagerty, by dynamiting the Times building.

SAN FRANCISCO, Oct. 12.—Latest returns make it look as though woman suffrage had won in this state.

COUNCIL BLUFFS, Oct. 12.—In an address here Archbishop Ireland declared the referendum and recall were weapons of mobocracy.

## Chamber Of Commerce

Meets and Recommends Kihei For a  
Steamer Landing.

The Maui Chamber of Commerce met Thursday afternoon, and listened to the views of the inter-island captains as expressed in a letter from that company, in which the captains favor Kihei, and giving their reasons therefore.

After a general discussion on the subject a resolution was offered by Mr. Aiken recommending that the harbor commission spend the money somewhere on Maalaea Bay. This resolution was strenuously opposed by Dr. Raymond and others on the ground that Kihei was what the majority wanted and they should not be afraid to so recommend in any resolution to be forwarded to the commission.

The resolution as finally adopted reads as follows:

WHEREAS an adequate and safe steamer landing is urgently needed on the Southwest Coast of the Island of Maui, and;

WHEREAS the Legislature of 1911 appropriated the sum of \$9,000.00 to be expended for that purpose;

NOW THEREFORE BE IT RESOLVED that the Maui Chamber of Commerce do address a communication to the Harbor Commissioners asking that no time be lost in determining upon a suitable location for a steamer wharf along the shores of Maalaea Bay, at Kihei or thereabout and that the money appropriated, namely \$9,000.00, be expended on the construction of approaches, and warehouse, and the shore end of a steamer wharf, which can be used as a boat landing, until such time as sufficient appropriations can be secured to complete the project.

The location of the said approaches, warehouse, etc., to be left entirely to the discretion of the Board of Harbor Commissioners. Provided only that the said wharf be located entirely on Government land.

## Conditions At Tripoli

On the Eve of Its Occupation By  
Italian Soldiers.

A long special dispatch from Tripoli describes picturesquely the appearance of the city "on the eve of Italian occupation." The native population, it appears, is taking the course of events with stolid indifference, although the foreign population has largely fled and most of the business section of the city is closed up in view of the danger of serious damage from bombardment. The dispatch says:

"The landscape is serene. One sees a party of big Turks lolling on the ramparts half hidden by the shade of thick palms. They have hoisted a red flag, which flaunts with a half-hearted air of defiance over the red fortifications. Close by the flag is a guardian sentinel, while behind the parapets one sees a group of soldiers watching from the summit of the castle. They are not worried or nervous. Their air is one of the profound indifference. Gendarmes idle in the doorways, observing with characteristic oriental carelessness the passing of little groups of frightened foreign traders, their arms filled with parcels. Women with infants in their arms are at the heels of the men.

"Patrols of soldiers pass gravely along the nearly deserted streets. The shops are closed and the windows barred. Hundreds of houses have been vacated. Terror has seized the inhabitants. All the terraces are empty except that at the Italian consulate, which is occupied by correspondents. Above the hospital conducted by Italian nuns waves a red cross flag. A bold monk, distinguished by his long, flowing beard, has climbed to the top of the bell tower on the Italian monastery and hoisted the German flag.

"The few remaining Italians await impatiently the first firing. The local batteries are deserted. At sea a flock of frightened sailing boats is scurrying out of the harbor.

"This evening the coffee houses in the Arab quarter are opening, and the priests appearing on the small balconies of the minarets, invited the people to prayer. Crowds of Arabs gathered at different points and read the posted notices in Turkish, which says:

"The Italian government made an unjust demand on Turkey, asking her to give up Tripoli. The Turkish Cabinet, together with the parliament, is preparing a definite answer to give to Italy. Meanwhile, adjure the population to remain quiet and respect the Italians."

got underneath and lifted the planks clean up, tearing out all the fastenings. The wharf was also very rocky, and it was thought by the folks living around there that it would not last much longer. The sea calmed down at the latter end of the week, and this saved the situation. At the same time, it is thought that if there is much more weather like that which has just passed there will be very little of the wharf left.—Bulletin.

This is the kind of stuff that scares tourists from coming to Maui. The sea was as smooth as a mill pond at McGregor's the day Mr. Berndt landed at Lahaina, and there is absolutely no danger of the wharf at McGregor's being carried away. The fact of a few planks been loosened does not signify that the entire structure is in danger.

## The Postal Savings Bank.

WITH the opening of the postal savings banks throughout the country the first of the year, the United States put into effect a system that almost all other countries have found practicable.

Now that the postal banks have had a trial in forty-eight towns throughout the country, and have proven their usefulness, it seems remarkable that interests persistently opposed to them could have halted for any length of time a project in which the rank and file of the American people were directly interested. Great Britain has had postal banks since 1861, Canada since 1868, France since 1882, and Italy, Austria-Hungary, Belgium, Russia, Japan, the Netherlands, Sweden, Egypt and other countries have long enjoyed this kind of government protection of saving deposits. The Gold Coast of Africa has \$100,000 in deposits. Tunis more than \$1,000,000, the Dutch East Indies \$2,000,000, Formosa nearly \$1,000,000 and Egypt nearly \$2,000,000. There are 11,000,000 postal bank depositors in the United Kingdom, 5,000,000 in France, 5,000,000 in Italy, 2,000,000 in Belgium and 1,700,000 in Russia. In Japan, where the highest interest is paid, there are 8,000,000 depositors and \$46,000,000 in deposits. The total of these deposits in Great Britain has reached \$781,794,533, showing the sustained popularity of the system.

In regard to the prospect in America, it is pleasant to note that private banking interests no longer display general antagonism to the postal bank like that which was manifested before the law authorizing that project had been enacted. Sober thought apparently has been convincing that well-established banking institutions have nothing to fear in the competition of the government. Opinion seems to be that the low interest to be paid on deposits in postal banks will not attract many persons away from the old reliable institutions where higher rates are available. On the other hand the poorer classes, especially immigrants have found in the postal bank that which they believed to be essential.

The Chamber of Commerce went on record as being unanimous in favor of a steamer landing at Kihei. This shows the spirit of Maui. At the last meeting opinions differed as to where this landing should be, but when expert testimony was introduced to show that Kihei was the logical place for a steamer landing, and it was for the best interests of Maui, all opposition vanished. If Honolulu would only take a leaf out of Maui's book, and unite for the public welfare instead of each faction standing out for their own selfish ends, or some fancied political gain, how much more would our wishes be considered at Washington.

Kahului will be a busy place when the dredging crews get to work. The breakwater is being pushed along rapidly, and when the harbor is dredged out, ships will be able to lay at anchor in all sorts of weather.

All the sports on Maui are busy helping Eben Low shoot goats over on Kahoolawe. Eben should keep a few of the most tractable goats and train them for aids on the Honolulu Board of Supervisors.

The Loan Fund Commissioners for the County of Honolulu are determined to have their golden boulevard. They have signed up with Lord & Young.

The Territorial Board of Health is over on Hawaii this week stirring things up over there. On a tour of education, presumably.

The horse had acquired the habit of unhooking his stable door, so the door had recently been fastened by a padlock which on the night of the fire barred the outlet so securely as to prevent the animal's escape from death. The cause of the disaster is unknown. The stallion is valued at \$1,800.

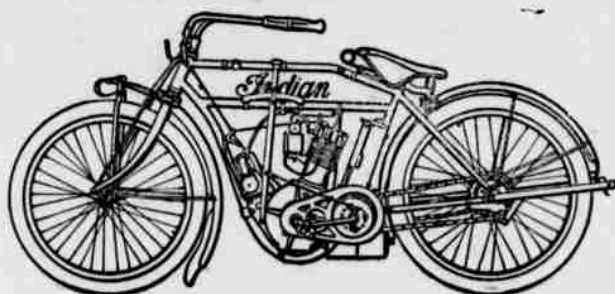

## TELEGRAPHIC NEWS

### Italians Still Winning.

LONDON, Oct. 11.—Italy has won another naval victory. Cruisers fought destroyers yesterday and sunk three. The engagement took place in the Ionian Sea.

TRIPOLI, Oct. 11.—Italy has landed an army of 3,000 men at Toubrouk. The battleships are covering the advance by shelling.

ROME, Oct. 11.—The Italian government will reopen communications with Turkey within a week.

PEKIN, Oct. 11.—The province of Hepah is in revolt. The imperialists are joining the rebels.

SEATTLE, Oct. 10.—The sound steamer Perdita has been burned to the waters edge. The passengers escaped by jumping into the water.

DENVER, Oct. 10.—Many lives, and \$5,000,000 worth of property has been destroyed by floods.

SAN FRANCISCO, Oct. 11.—Eugene Love, formerly in charge of the post canteen in Honolulu, has been arrested here for embezzlement.

### Turks Want Peace.

BERLIN, Oct. 10.—Turkey has sent a note to all the powers, asking if it is not time to interfere in the interests of peace.

TRIPOLI, Oct. 10.—The Italians have ordered slavery stopped. Turks and Arabs are surrendering.

SAN FRANCISCO, Oct. 10.—A \$3,000,000 shortage has been discovered at the Mare Island navy yard.

CITY OF MEXICO, Oct. 9.—Three hundred Federals routed 1500 rebels after an all night fight.

LISBON, Oct. 9.—The royalist forces have been defeated by the army of the republic.

SAN FRANCISCO, Oct. 10.—The steamer City of Panama has been damaged in a storm. The passengers were in panic.

NEW YORK, Oct. 9.—Cornelius Bliss, Secretary of the Interior under Cleveland, is dead of heart failure.

### News From the War.

LUCKNOW, Oct. 8.—A great council of Moslems is being held here. They will appeal to England to interfere on behalf of Turkey.

ROME, Oct. 9.—Now that Tripoli has been captured, a proclamation will be issued doing away with slavery. The Greek government has closed Corinth Canal. Ambassador Rockling is urging Russia to intervene in the interests of peace. Turkey will make reasonable concessions.

LONDON, Oct. 9.—It is reported here that two Turkish torpedo boats have been sunk.

SAN FRANCISCO, Oct. 9.—Riots have broken out here in connection with the strike.

DURANGO, Col., Oct. 8.—The worst flood in years are raging in Northwest Colorado. Many lives have been lost.

### Tripoli Has Fallen.

TRIPOLI, Oct. 7.—The Italian flag was raised over the citadel yesterday. Admiral Banadolino has been proclaimed governor.

CONSTANTINOPLE, Oct. 7.—Turkey will appeal to the Christian parliaments of the world, and to the peace societies against Italy as being unworthy to hold a place among the nations. A British steamer with contraband has been captured.

SAN FRANCISCO, Oct. 7.—Strike breakers are arriving. All is quiet.

MEMPHIS, Oct. 7.—Strike breakers arriving here have themselves gone on strike. Many of them have been shipped back to Chicago.

BERLIN, Oct. 7.—A Frenchman hoisted the French flag over Fort Agdair, Morocco, and saluted it. This led to a report that Morocco was under a French protectorate.

LA CROSSE, Oct. 7.—The Hatfield dam at Black River Falls burst, destroying a dozen houses.

### Honolulu News.

HONOLULU, Oct. 11.—The governor will await the return of J. P. Cooke before making an aggressive fight against the boll worm. Arrangements are being made for wireless communication between Tahiti and Hawaii.

The civic federation will take up the belt road contracts today. Mrs. Cederloff testified yesterday, that she saw McMahon shoot her husband.

HONOLULU, Oct. 10.—Stenographer McKinley of the Honolulu Iron Works became lost on the mountains back of Honolulu Sunday. He was found Monday by the police.

Dr. McGrew fell on the lanai of his home and was seriously injured. His thigh is injured. Camillo Perreira, formerly editor of a Portuguese newspaper in Honolulu, died at the Queen's hospital this morning.

HONOLULU, Oct. 9.—City Engineer Gere defends his estimate of road costs.

Lord & Young will not give bonds till after the settlement of the Wilson suit.

The beet sugar experiments on Lanai has been abandoned. Virginia Ayers has mysteriously disappeared. It believed she has been taken to Hilo by a Hawaiian.

HONOLULU, Oct. 7.—The civic federation has taken up the matter of the belt road.

A party went through the city yesterday on a tour of inspection. They had their eyes opened as regards the sanitary conditions.

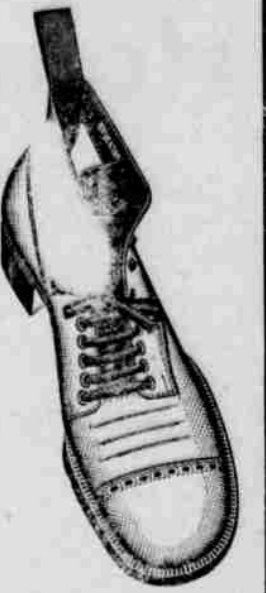

## Germany

### Surprised

#### France Has a Fighting Navy That Is Ready.

One of the most unpleasant surprises the jingoes of Germany have had for years was the fact revealed by the recent French naval review at Toulon that thanks to the wonderful activity of M. Delcasse, the French navy is ready for war at a moment's notice, and that even without the hoped-for assistance of England, France would be able to keep open all the important ports of the country.

With the assurance of the English Prime Minister, that France could rely on England in case of a German attack, the now famous "coup d'Agadir" appears to everybody here to have been the most stupid attempt of bluff that German diplomacy has ever tried. And having exhausted their vocabulary in abusing England, nearly all the newspapers of the country are now telling the government in plain words that it never had the faintest chance of success.

The attitude of the German people is pacificatory. First of all the socialists do not want war and, thanks to the influence among the young men of the country, the government would have found serious difficulty in mobilizing an army for a war in which Germany was the aggressor.

Secondly, Germany is not loved in Europe and, in case of a war, she would not dare withdraw her troops from the Russian and Austrian frontier, nor even from the German Polish provinces. Even Belgium at the informal request of France put her formidable fortresses at Liege, Namur and Ostende in a state of active defense and made every preparation for the reception of a British fleet in the event of an outbreak of hostilities.

When it is remembered that the Germans have lost by depreciation in stocks on the Berlin Bourse since the "Panther" was sent to Agadir, more money than the profits of German traders in Morocco in twenty years, it is small wonder that the government feels exceedingly uncomfortable and realizes that even as an attempt to influence the coming elections, the Morocco venture has been an absolute and crushing failure.

## The Latest In Sports

What the Wrestlers, Boxers and Base Ball Artists Are Doing.

On Aug. 4 the Athletics for the second time this season had fought their way to first place, the difference being that this time they held it. During September their lead increased steadily, and they entered the last week of the race practically eased up.

In all but one department the Athletics are a better ball club now than they were a year ago. The outfield, while it is not a wonderful trio by a long shot, is a shade more reliable than that which bumped the Cubs last year.

There are two or three sets of outfielders in the big leagues that rate higher than Lard, Oldring and Murphy, but Mack's strength always has been in his infields.

There is no quartet in the game today that combines with baseball such intelligence as that of McInnis, Collins, Barry and Baker. The four are wonderfully fast and accurate fielders and possess great throwing arms. The infield was fast in 1910, but it is speedier this season. Last year Harry Davis was on first, but last July was replaced by McInnis. For all his youth and inexperience McInnis is a big improvement over Davis. Right now "Stuff" looks the equal of any first baseman in the American league, barring Hal Chase. First station last year was the only comparatively weak one, but it is now well covered.

It is only in the pitching department that Mack seems to have fallen off from last year. Neither Coombs nor Bender has shown the wonderful form of a year ago. Morgan and Plank performed in fine style all season. The catching department has been well looked after by Ira Thomas.

The Athletics are made up of young men who like to play ball. There isn't a lazy player on the team. From the moment the Mack's men put on their uniforms they display energy. In practice they show ginger and speed, while in championship games they never say die. Even though opponents are weak, the champions do not let up. They seem to enjoy the task of fattening their batting averages, and they revel in difficult plays. On the bench they talk baseball, and when mistakes are made there's no ill feeling. Great plays prompt enthusiasm and words of praise, while Mack at all times is the king pin. Lack of jealousy and friction is one of the reasons for the success of the Athletics. Take the case of Harry Davis, for instance. The veteran has been supplanted at first base by young McInnis, yet the latter has no more ardent supporter than Davis, who is always helping the youngster.

Mack's quiet disposition coupled with firmness, has worked wonders. He knows baseball and how to handle players. His motto is "Play ball," and he never varies it. Umpires are let alone and adverse decisions do not upset the team. In developing the Athletics Mack has tried to strengthen every department, and results thus attained would seem to indicate that he hasn't lost a trick.

Kid McCoy "came back" in the wind-up at Brown's A. C., when he stopped Kid Ely of Brooklyn in less than a round. But he did not escape an exciting adventure despite his hollow victory over Ely. At the unsatisfactory termination of the star event, to soothe the disappointment of the fans, Bob Fitzsimmons, who sat by the ringside, clambered through the ropes to engage in a little friendly spat with the illus-

trious Kid, Bob carefully took off his coat, carefully rolled up his sleeves, carefully adjusted the gloves and as carefully squared off to McCoy. But in the flush of his recent victory the Kid set sail at old Bob a trifle too roughly to satisfy the latter. A jab or two ruffled the former ring marvel and Fitz tore into the Kid like a ton of wildcats. Love taps were forgotten and the pair slammed and poked away in desperate earnest. When the well-meant joke became too serious the oldtimers were pulled apart, though under protest.
