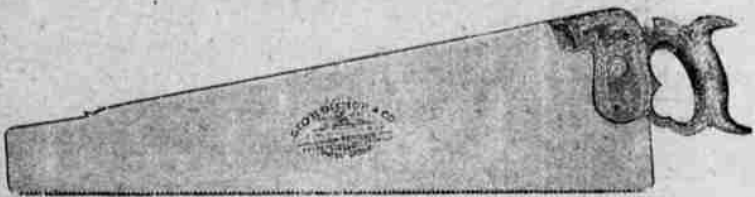

A MEMORIAL

From the Hawaiian Patriotic League Asking for Restoration of Constitutional Government.

To HON. SENATOR SHELBY M. CULLUM, SENATOR JOHN T. MORGAN, REPRESENTATIVE ROBERT R. HITT, SANFORD B. DOLE AND WALTER F. FEAR, United States Commissioners.

Sirs:—The undersigned, being delegates of the Hawaiian Patriotic League, an organization which is composed of native Hawaiian people from all the Districts of the Hawaiian Islands, assembled in a convention held in the city of Honolulu, Island of Oahu, Hawaiian Islands, on the 12th of September, A. D. 1898, hereby respectfully submit to your honorable Commission the following resolutions:

RESOLUTIONS.

WHEREAS, On the 17th day of January, A. D. 1893, our beloved Queen, LILIUOKALANI, noted a protest against the acts of the representatives of the United States of America, in form as follows:

"I, LILIUOKALANI, by the grace of God and under the Constitution of the Hawaiian Kingdom, Queen, do hereby solemnly protest against any and all acts done against myself and the Constitutional Government of the Hawaiian Kingdom by certain persons claiming to have established a Provisional Government of and for this Kingdom.

"That I yield to the superior force of the United States of America, whose Minister Plenipotentiary, His Excellency John L. Stevens, has caused United States troops to be landed at Honolulu and declared that he would support the said Provisional Government.

"Now, to avoid any collision of armed forces and perhaps the loss of life, I do, under this protest, and impelled by said force, yield my authority until such time as the Government of the United States shall, upon the facts being presented to it, undo the acts of its representatives and re-instate me in the authority which I claim as the Constitutional Sovereign of the Hawaiian Kingdom;" and

WHEREAS, The receipt of said protest was acknowledged by Sanford B. Dole, chairman of the Executive Council of the Provisional Government, by endorsement thereon; and

WHEREAS, Grover Cleveland, President of the United States, after a careful review of the facts, stated in a message to Congress, dated the 18th day of December, 1893, as follows:

"As I apprehend the situation, we are brought face to face with the following conditions: The lawful Government of Hawaii was overthrown without the drawing of a sword or the firing of a shot by a process, every step of which, it may be safely asserted, is directly traceable to and dependent for its success upon the agency of the United States acting through its diplomatic and naval representatives;" and

WHEREAS, The so-called Republic of Hawaii, by its Executive and Senate, formulated a treaty to secure the annexation of Hawaii to the United States, and said treaty having failed of ratification by the Senate of the United States, and by such failure to ratify having become void and of no effect as to Hawaii, because of the terms of Article 32 of the Constitution of the Republic of Hawaii, which reads:

"The President, with the approval of the Cabinet, is hereby expressly authorized and empowered to make a Treaty of Political or Commercial Union between the Republic of Hawaii and the United States of America, subject to the ratification of the Senate;" and

WHEREAS, The Senate and House of Representatives of the United States have passed a Joint Resolution for the annexation of the Hawaiian Islands, and such Joint Resolution has not been passed upon by the people of Hawaii nor by their Representatives in Legislature assembled; and

WHEREAS, By memorial the people of Hawaii have protested against the consummation of an invasion of their political rights, and have fervently appealed to the President, the Congress and the People of the United States to refrain from further participating in the wrongful annexation of Hawaii; and

WHEREAS, The Declaration of American Independence expresses that Governments derive their just powers from the consent of the governed; therefore, be it

Resolved, That as the representatives of a large and influential body of native Hawaiians, we solemnly pray that the Constitutional Government of the 16th day of January, A. D. 1893, be restored, under the protection of the United States of America.

And your petitioners will ever pray, etc.

[Signed by the officers and all the Delegates, and presented last Tuesday afternoon, the 12th instant.]

HE IS PREMATURE.

F. W. Beckley of Hilo has signed his name to a letter published in the Advertiser this morning, in which he advocates that better conduct of our judiciary system should be adopted, and that the machinery of justice and liberty should no longer be "hampered by a small minority yet clinging to a dying language, such as the Hawaiian." There can be no doubt of it. No "foreigner" would ever try to befool his own nest in the language of this Mr. Beckley who signs his name to the following paragraph:

"Fully ninety percent of the aborigines and their descendants speak and understand the English language and to subject the people any longer to the mercy of a magistrate whose speech, method of trial and records are in a language formed and conceived in a feudal age, conveying the idea with the natives of the divine supremacy of kings is a big error. This is an infringement upon the rights and the liberties of the people in a now free country for the very language which the magistrate uses prevents him from fully realizing the broader and fuller sense and spirit of true republicanism, equality and justice."

The writer of the letter signed by F. W. Beckley has evidently been in trouble with some Hawaiian magistrate, who administered the law as he found it on our statutes, and not according to the Beckley ideas of "republicanism, equality and justice." The statement that ninety percent of aborigines speak and understand English is simply absurd and shows that Mr. Beckley doesn't even know his own countrymen. The older generation of the Hawaiians as a rule do not speak English, even if a number of them partly understand it. The majority of the younger generation prefer, we are justified in saying, to use the language of their forefathers to that which they are taught in the public and private schools. We see proofs to that effect daily when Hawaiians appear in the District Court of Honolulu and give evidence in their own language. The Hawaiian language may some day belong to the "dead languages," but we think that Mr. Beckley is premature, unpatriotic and arrogant in taking upon his youthful shoulders the task of the "undertaker," in burying his mother tongue. He will hardly yet get a judgeship, even if he does kick at the Hawaiian magistrates by airing his superior knowledge and education in the organ of the planters.

Resolutions of Respect.

The following is the full text of the resolutions adopted by the Bar yesterday on the death of Hon. Antone Rosa, and which were crowded out of yesterday's report:

"Whereas, It has pleased the Almighty to remove by death Antone Rosa, a member of the Bar of this Court;

"Resolved, That in the untimely death of Antone Rosa, this community has lost a faithful citizen, and the Bar a brilliant, as well as a valuable member;

"Resolved, That the Bar hereby express to the family of the deceased its sincere and heartfelt sympathy with them in their bereavement;

"Resolved, That the Court instruct the Clerk to spread these resolutions upon the records of the Court."

TOPICS OF THE DAY.

Chief Justices of States and Territories of the United States seem always willing to say a good word for those members of the Bar who desire to go to Hawaii. The C. J. of these islands takes a different view when kamaaina practitioners leave for a higher tribunal. He has little good to say and that reluctantly is said and he simply covers the evil which he would like to say by quoting the old saying *De Mortuis Nisi Bonum*.

When one calmly reflects upon the sacrifices a man has to make of his self-respect to hold office in a country controlled by politicians, and the masses, it seems surprising that any honorable man should ever consent to act the role of a patriot and discharge his proper duty to his fellow citizens instead of permitting the mob and newspaperdom to control affairs. A case immediately in point is that of Secretary Alger whose resignation is required by the Molochs as a sacrifice to the petty political Baal. His reply to the ungenerous and ungrateful ghoul is manly and dignified, and we suggest it as a model for President Dole to use when the Advertiser attacks him in reference to the Maine Fund contribution.

"I do not intend to order an investigation of the wholesale charges of mismanagement of the war, but propose to stand on my record. If the President or Congress desires these charges investigated I would be delighted to have the administration of the War Department made the subject of the most searching inquiry.

"If any one can be found who can perform the duties better than I have I am willing to give way to him, but not until the unjust, brutal and untrue criticisms have ceased. I will not retire under fire. It is at least ungracious for the press of the country to attack me when I have given all my time and what ability I possess to bring the war to a successful conclusion. Orders have been promptly sent to correct all abuses, and I can no more be held responsible for the failure to execute these orders than the commanding officer can be for the remissness of his subordinates.

"If any one is to blame for not supplying the soldiers with rations and taking the proper sanitary precautions it is the commanding officers in the field. Complaints of all sorts from private individuals have been made, which were investigated and proved to be unfounded. There have been charges made against the Surgeon General, the Commissary and Quartermaster General's departments which are equally untrue. Three harderworked or more competent officers cannot be found in service than these men."

A Hawaiian Display.

Mr. Allan Herbert, whose interest in the development of our agricultural, horticultural and floricultural industries is well-known, has been made an honorary member of California's Boards of Agriculture and Trade; and through him the Hawaiian Board of Agriculture has been invited to place a permanent exhibit of Island industries with those of California's resources.

Mr. Herbert will be pleased to forward to J. A. Filcher, Secretary of the State Board of Trade at San Francisco, samples of coffee or other purely Hawaiian products for exhibition. These should be securely placed in exhibition glass jars and properly labelled with the name and address of the exhibitor, the place where the product was grown, and the name of the local agent. There will be no expense attached to the exhibit.

The Californians will also be pleased if Hawaii will place an exhibit in connection with theirs at the Paris Exhibition of 1900 as an annex to the American Exhibits. There are many things which we can show of a nature to attract at any rate the rich tourist and the capitalist.

And as the wish of this Hawaiian organization has been barred out by your Commissioners through Mr. Sanford B. Dole himself who told Mr. J. W. Bipiakane (a member of this Committee) this morning, that four Commissioners have decided not to receive our Committee and other Committees who are bearing a memorial of this nature.

And as Mr. Sanford B. Dole being a party of those who committed the crime of destroying the Independence of our beloved country to the U. S. of A. without a title, so we ask Your Commissioners through You the Chairman if it be possible that Your Commissioners have taken such steps not to listen the voice of the native Hawaiians.

The Mauna Loa will sail to-morrow morning on her usual route. Judge Stanley and J. M. Ost are booked to leave by her.

The Hawaiians are becoming "civilized." Two arrests for highway robberies were made yesterday. The victims were of course Asiatics.

Archie Mahaulu, tax assessor and collector of the district, has been appointed agent of the Oahu R. R. at Waialua. He is just the man for the position.

Under a private agreement as to time allowance the yacht race has been decided in favor of the Liawaii with the Marion second and Bonnie Dundee third.

Monster Hotels for London.

There are at the present moment no fewer than four hotels of the very largest size in process of erection in London. Of these the nearest completion is the well-known Claridge's once a collection of old private houses, but now a very large and lofty square building of red brick and terra cotta, which has been rising the last three years on the old but greatly extended site in Brock Street. There is a light iron balcony on each floor which will be convenient as well as ornamental. It will probably be opened during the coming season. The Hotel Grand Central is the terminus of the new railway in the Marylebone Road. It will not rival the towers and spires of the Midland at St. Pancras, but will be a plain, massive red-brick building, with buff terra-cotta dressings, and the only break will be a low clock tower over the principal entrance. It bids fair to be the largest hotel in London, and as it is nearly ready for roofing, and so many workmen are employed on it, it may be opened by the end of the present year. The Carlton, on the site of the old Opera House in the Haymarket, although the smallest, will be by far the handsomest of the new hotels. Being built of stone with a cupola and loggia similar to the new theatre of which it forms a part, the whole building will be one of the finest in town, and worthy of the important site it occupies. It will probably be completed in about another year. The Hotel Russell, of red brick and buff terra-cotta, occupies nearly half the east side of Russell Square, Bloomsbury. It is of great size, and the least advanced only one or two floors being built, so it is not likely to be ready before the end of next year. Its proximity to the Northern stations should make it a convenience to travellers using those lines, while at the same time it will be out of hearing of the noise of the trains.—*Glasgow Mail.*

The Celestial Editor.

The Referee of India gives the following specimen of the politeness of editors of Chinese newspapers. Most men who write to any great extent for the press, it remarks, have had some of their contributions returned as "unsuitable to our columns," or declined, with or without thanks, as the case may be. But it has fallen to the lot of very few would-be contributors to receive a letter from the editor, along with their rejected manuscript, couched in anything like the following terms: "Illustrious Brother of the Sun and Moon.—Behold thy servant prostrate before thy feet. I kowtow to thee, and beg that of thy graciousness thou mayest grant that I may speak and live. Thy honored manuscript has deigned to cast the light of its august countenance upon us. With raptures we have perused it. By the bones of my ancestors, never have I encountered such with such pathos, such lofty thought! With fear and trembling I return your writing. Were I to publish the treasure you send me, the Emperor would order that it should be made the standard, and that none be published except such as equalled it. Knowing literature as I do, and that it would be impossible in ten thousand years to equal what you have done, I send your writing back. Ten thousand times I crave your pardon. Behold my head is at your feet. Do what you will.—Your servant's servant,—the Editor."

WASHINGTON, Sept. 7.—Secretary Alger and General Corbin had a three-hours' conference with the President to-day. After the conference General Alger was asked if there was to be an investigation of any part of the conduct of the War Department.

"There will not," he said. "There is nothing to investigate. If I permit an investigation I admit there is something to investigate. I am not doing that. If necessary, I would be willing to have the searchlight turned upon the department, but it is not necessary."

A MEMORIAL

From the Hawaiian Patriotic League Asking for Restoration of Constitutional Government.

To HON. SENATOR SHELBY M. CULLUM, SENATOR JOHN T. MORGAN, REPRESENTATIVE ROBERT R. HITT, SANFORD B. DOLE AND WALTER F. FREAR, United States Commissioners.

Sirs:—The undersigned, being delegates of the Hawaiian Patriotic League, an organization which is composed of native Hawaiian people from all the Districts of the Hawaiian Islands, assembled in a convention held in the city of Honolulu, Island of Oahu, Hawaiian Islands, on the 12th of September, A. D. 1898, hereby respectfully submit to your honorable Commission the following resolutions:

RESOLUTIONS.

WHEREAS, On the 17th day of January, A. D. 1893, our beloved Queen, LILIUOKALANI, noted a protest against the acts of the representatives of the United States of America, in form as follows:

"I, LILIUOKALANI, by the grace of God and under the Constitution of the Hawaiian Kingdom, Queen, do hereby solemnly protest against any and all acts done against myself and the Constitutional Government of the Hawaiian Kingdom by certain persons claiming to have established a Provisional Government of and for this Kingdom.

"That I yield to the superior force of the United States of America, whose Minister Plenipotentiary, His Excellency John L. Stevens, has caused United States troops to be landed at Honolulu and declared that he would support the said Provisional Government.

"Now, to avoid any collision of armed forces and perhaps the loss of life, I do, under this protest, and impelled by said force, yield my authority until such time as the Government of the United States shall, upon the facts being presented to it, undo the acts of its representatives and re-instate me in the authority which I claim as the Constitutional Sovereign of the Hawaiian Kingdom;" and

WHEREAS, The receipt of said protest was acknowledged by Sanford B. Dole, chairman of the Executive Council of the Provisional Government, by endorsement thereon; and

WHEREAS, Grover Cleveland, President of the United States, after a careful review of the facts, stated in a message to Congress, dated the 18th day of December, 1893, as follows:

"As I apprehend the situation, we are brought face to face with the following conditions: The lawful Government of Hawaii was overthrown without the drawing of a sword or the firing of a shot by a process, every step of which, it may be safely asserted, is directly traceable to and dependent for its success upon the agency of the United States acting through its diplomatic and naval representatives;" and

WHEREAS, The so-called Republic of Hawaii, by its Executive and Senate, formulated a treaty to secure the annexation of Hawaii to the United States, and said treaty having failed of ratification by the Senate of the United States, and by such failure to ratify having become void and of no effect as to Hawaii, because of the terms of Article 32 of the Constitution of the Republic of Hawaii, which reads:

"The President, with the approval of the Cabinet, is hereby expressly authorized and empowered to make a Treaty of Political or Commercial Union between the Republic of Hawaii and the United States of America, subject to the ratification of the Senate;" and

WHEREAS, The Senate and House of Representatives of the United States have passed a Joint Resolution for the annexation of the Hawaiian Islands, and such Joint Resolution has not been passed upon by the people of Hawaii nor by their Representatives in Legislature assembled; and

WHEREAS, By memorial the people of Hawaii have protested against the consummation of an invasion of their political rights, and have fervently appealed to the President, the Congress and the People of the United States to refrain from further participating in the wrongful annexation of Hawaii; and

WHEREAS, The Declaration of American Independence expresses that Governments derive their just powers from the consent of the governed; therefore, be it

Resolved, That as the representatives of a large and influential body of native Hawaiians, we solemnly pray that the Constitutional Government of the 16th day of January, A. D. 1893, be restored, under the protection of the United States of America.

And your petitioners will ever pray, etc.

[Signed by the officers and all the Delegates, and presented last Tuesday afternoon, the 12th instant.]

HE IS PREMATURE.

F. W. Beckley of Hilo has signed his name to a letter published in the Advertiser this morning, in which he advocates that better conduct of our judiciary system should be adopted, and that the machinery of justice and liberty should no longer be "hampered by a small minority yet clinging to a dying language, such as the Hawaiian." There can be no doubt of it. No "foreigner" would ever try to befool his own nest in the language of this Mr. Beckley who signs his name to the following paragraph:

"Fully ninety percent of the aborigines and their descendants speak and understand the English language and to subject the people any longer to the mercy of a magistrate whose speech, method of trial and records are in a language formed and conceived in a feudal age, conveying the idea with the natives of the divine supremacy of kings is a big error. This is an infringement upon the rights and the liberties of the people in a now free country for the very language which the magistrate uses prevents him from fully realizing the broader and fuller sense and spirit of true republicanism, equality and justice."

The writer of the letter signed by F. W. Beckley has evidently been in trouble with some Hawaiian magistrate, who administered the law as he found it on our statutes, and not according to the Beckley ideas of "republicanism, equality and justice." The statement that ninety percent of aborigines speak and understand English is simply absurd and shows that Mr. Beckley doesn't even know his own countrymen. The older generation of the Hawaiians as a rule do not speak English, even if a number of them partly understand it. The majority of the younger generation prefer, we are justified in saying, to use the language of their forefathers to that which they are taught in the public and private schools. We see proofs to that effect daily when Hawaiians appear in the District Court of Honolulu and give evidence in their own language. The Hawaiian language may some day belong to the "dead languages," but we think that Mr. Beckley is premature, unpatriotic and arrogant in taking upon his youthful shoulders the task of the "undertaker," in burying his mother tongue. He will hardly yet get a judgeship, even if he does kick at the Hawaiian magistrates by airing his superior knowledge and education in the organ of the planters.

Resolutions of Respect.

The following is the full text of the resolutions adopted by the Bar yesterday on the death of Hon. Antone Rosa, and which were crowded out of yesterday's report:

"Whereas, It has pleased the Almighty to remove by death Antone Rosa, a member of the Bar of this Court;

"Resolved, That in the untimely death of Antone Rosa, this community has lost a faithful citizen, and the Bar a brilliant, as well as a valuable member;

"Resolved, That the Bar hereby express to the family of the deceased its sincere and heartfelt sympathy with them in their bereavement;

"Resolved, That the Court instruct the Clerk to spread these resolutions upon the records of the Court."

TOPICS OF THE DAY.

Chief Justices of States and Territories of the United States seem always willing to say a good word for those members of the Bar who desire to go to Hawaii. The C. J. of these islands takes a different view when kamaaina practitioners leave for a higher tribunal. He has little good to say and that reluctantly is said and he simply covers the evil which he would like to say by quoting the old saying *De Mortuis Nisi Bonum*.

When one calmly reflects upon the sacrifices a man has to make of his self-respect to hold office in a country controlled by politicians, and the masses, it seems surprising that any honorable man should ever consent to act the role of a patriot and discharge his proper duty to his fellow citizens instead of permitting the mob and newspaperdom to control affairs. A case immediately in point is that of Secretary Alger whose resignation is required by the Molochs as a sacrifice to the petty political Baal. His reply to the ungenerous and ungrateful ghouls is manly and dignified, and we suggest it as a model for President Dole to use when the Advertiser attacks him in reference to the Maine Fund contribution.

"I do not intend to order an investigation of the wholesale charges of mismanagement of the war, but propose to stand on my record. If the President or Congress desires these charges investigated I would be delighted to have the administration of the War Department made the subject of the most searching inquiry."

"If any one can be found who can perform the duties better than I have I am willing to give way to him, but not until the unjust, brutal and untrue criticisms have ceased. I will not retire under fire. It is at least ungracious for the press of the country to attack me when I have given all my time and what ability I possess to bring the war to a successful conclusion. Orders have been promptly sent to correct all abuses, and I can no more be held responsible for the failure to execute these orders than the commanding officer can be for the remissness of his subordinates."

"If any one is to blame for not supplying the soldiers with rations and taking the proper sanitary precautions it is the commanding officers in the field. Complaints of all sorts from private individuals have been made, which were investigated and proved to be unfounded. There have been charges made against the Surgeon General, the Commissary and Quartermaster General's departments which are equally untrue. Three harderworked or more competent officers cannot be found in service than these men."

A Hawaiian Display.

Mr. Allan Herbert, whose interest in the development of our agricultural, horticultural and floricultural industries is well-known, has been made an honorary member of California's Boards of Agriculture and Trade; and through him the Hawaiian Board of Agriculture has been invited to place a permanent exhibit of Island industries with those of California's resources.

Mr. Herbert will be pleased to forward to J. A. Filcher, Secretary of the State Board of Trade at San Francisco, samples of coffee or other purely Hawaiian products for exhibition. These should be securely placed in exhibition glass jars and properly labelled with the name and address of the exhibitor, the place where the product was grown, and the name of the local agent. There will be no expense attached to the exhibit.

The Californians will also be pleased if Hawaii will place an exhibit in connection with theirs at the Paris Exhibition of 1900 as an annex to the American Exhibits. There are many things which we can show of a nature to attract at any rate the rich tourist and the capitalist.

Bipiikane (a member of this Committee) this morning, that four Commissioners have decided not to receive our Committee and other Committees who are bearing a memorial of this nature.

And as Mr. Sanford B. Dole being a party of those who committed the crime of destroying the Independence of our beloved country to the U. S. of A. without a title, so we ask Your Commissioners through You the Chairman if it be possible that Your Commissioners have taken such steps not to listen the voice of the native Hawaiians.

Of these the nearest completion is the well-known Claridge's once a collection of old private houses, but now a very large and lofty square building of red brick and terra cotta, which has been rising the last three years on the old but greatly extended site in Brock Street. There is a light iron balcony on each floor which will be convenient as well as ornamental. It will probably be opened during the coming season. The Hotel Grand Central is the terminus of the new railway in the Marylebone Road. It will not rival the towers and spires of the Midland at St. Pancras, but will be a plain, massive red-brick building, with buff terra-cotta dressings, and the only break will be a low clock tower over the principal entrance. It bids fair to be the largest hotel in London, and as it is nearly ready for roofing, and so many workmen are employed on it, it may be opened by the end of the present year. The Carlton, on the site of the old Opera House in the Haymarket, although the smallest, will be by far the handsomest of the new hotels. Being built of stone with a cupola and loggia similar to the new theatre of which it forms a part, the whole building will be one of the finest in town, and worthy of the important site it occupies. It will probably be completed in about another year. The Hotel Russel, of red brick and buff terra-cotta, occupies nearly half the east side of Russell Square, Bloomsbury. It is of great size, and the least advanced only one or two floors being built, so it is not likely to be ready before the end of next year. Its proximity to the Northern stations should make it a convenience to travellers using those lines, while at the same time it will be out of hearing of the noise of the trains.—*Glasgow Mail.*

The Celestial Editor.

The Referee of India gives the following specimen of the politeness of editors of Chinese newspapers. Most men who write to any great extent for the press, it remarks, have had some of their contributions returned as "unsuitable to our columns," or declined, with or without thanks, as the case may be. But it has fallen to the lot of very few would-be contributors to receive a letter from the editor, along with their rejected manuscript, couched in anything like the following terms: "Illustrious Brother of the Sun and Moon.—Behold thy servant prostrate before thy feet. I kowtow to thee, and beg that of thy graciousness thou mayest grant that I may speak and live. Thy honored manuscript has deigned to cast the light of its august countenance upon us. With raptures we have perused it. By the bones of my ancestors, never have I encountered such with such pathos, such lofty thought! With fear and trembling I return your writing. Were I to publish the treasure you send me, the Emperor would order that it should be made the standard, and that none be published except such as equalled it. Knowing literature as I do, and that it would be impossible in ten thousand years to equal what you have done, I send your writing back. Ten thousand times I crave your pardon. Behold my head is at your feet. Do what you will.—Your servant's servant,—the Editor."

WASHINGTON, Sept. 7.—Secretary Alger and General Corbin had a three-hours' conference with the President to-day. After the conference General Alger was asked if there was to be an investigation of any part of the conduct of the War Department. "There will not," he said. "There is nothing to investigate. If I permit an investigation I admit there is something to investigate. I am not doing that. If necessary, I would be willing to have the searchlight turned upon the department, but it is not necessary."
