WOMEN ASKING FOR A VOTE

MANY MEETINGS AND ALL ARE UNANIMOUS

If the women's organizations of the city, which held meetings this morning, were given entire charge of the situation, it is safe to say that Hawaii would be clean of whiskey, and the festive jag would depart hence forever. The reporter, scurrying from one meeting place to the other, was impressed by two things: First, the extreme earnestness of the ladies in attendance at the various conferences, and second, the businesslike and intelligent manner of handling the matters up for discussion.

As a rule, the business of the morning was thoroughly understood, the ladies having, apparently, threshed out the subject before. At each meeting the program was much the same. The purpose of the gathering was explained by the presiding officer, and some one made a motion varying very little from the following words: "That this society (or club, as the case might be) petition the Congress of the United States that the women of Hawaii be permitted to vote, in the proposed special election, on the question of prohibition in the Hawaiian Islands." There was a motion to pass this motion, a prompt second and a vote on show of hands. Except in a single instance, the vote was unanimous—the lady in the one

case stating that she was a prohibitionist, but believed in leaving politics to the men.

The first meeting held was that of the W. C. T. U. in the parlor of Central Union church, about 50 ladies being present. Mrs. Doremus Scudder presided. As above indicated, the business was stated and the motion passed unanimously.

This meeting was followed by one of the Woman's Board of Missions in the Sunday School room of the church, at which Mrs. Scudder also presided. Mrs. Gulick moved the adoption of the standard motion, and, as in the other meeting, it passed unanimously. About fifty ladies were also present at this meeting.

The Woman's Board retiring, the Woman's Society opened up for business in the same place, Mrs. W. C. Hobby presided. She made an extended explanation of the situation and urged the adoption of the general motion. The vote was unanimous.

The next meeting was on the lanai of the Hawaiian hotel. It was of the Free Kindergarten & Children's Aid Association, and was attended by about twenty officers and members. Mrs. L. L. McCandless presided, and

ROBERTSON TAKES PLACE AS FEDERAL JUDGE

Alexander G. M. Robertson was sworn in as second judge of the United States District Court for Hawaii by the first judge, Hon. Sanford B. Dole, in presence of a large concourse of judges, attorneys, jurors, Federal officials and the public, at 10 o'clock this morning.

Marshal E. R. Hendry made the opening proclamation immediately upon the entrance of Judge Dole.

Clerk A. E. Murphy read President Taft's commission of Judge Robertson.

Judge Dole then administered the oath of office to the second judge, and calling him to the bench welcomed him with a handshake.

It was a great disappointment, Judge Dole said, when Judge Woodruff resigned as he had entered on his duties with earnestness, and was a man fond of hard work and whose personal character was such as made it a pleasure to work with him. There was a period of anxiety as to whom his successor should be, the position requiring experience, integrity and legal training.

Pacific Mail S. S. Manchuria this morning at 10 o'clock docked at the Hackfeld dock from San Francisco with 235 packages of mail, 115 cabin, 7 second class and 5 Asiatic passengers, and 247 tons of freight for Honolulu. She sails for the Orient at 5 p. m.

Major and Mrs. H. L. Hawthorne, U. S. A., are for Yokohama. Colonel and Mrs. J. G. Harbord go to Hongkong. Paymaster and Mrs. J. F. Hatch, U. S. N., are for Yokohama. H. E. Law and Mr. and Mrs. Robert Dollar of San Francisco, are going to Shanghai. Dollar is the president of the famous Dollar S. S. Co. Honolulu passengers include W. D. Baldwin and family, Mr. and Mrs. E. E. Cole and Miss Josephine Cornwell.

Freight for Honolulu includes 178 packages merchandise, 10 cases champagne, 92 packages iron and hardware, 11 automobiles, 129 packages paint, 199 cases soap, 29 packages groceries, 109 cases macaroni, 56 packages express matter, 6 packages arms and ammunition, 21 cases automobile parts, 23 cases dry goods, 50 cases cigarettes, 2 pianos, and 3 flasks quicksilver. Cargo for the Orient is mostly cotton and 225 bars of silver bullion valued at \$132,812.19, for Hongkong.

TOURIST SUNDAY LIVELIEST YET

Seven hundred and sixty round-the-world tourists ashore from the Clarc cruiser Cleveland made yesterday the liveliest Sunday on record. The weather permitted all possible pleasures; every auto was engaged; hacks were busy, even worn-out Oriental vehicles; the curio stores, flower shops, cigar stands and fruit stalls all did an unusually good business.

The Promotion Committee's headquarters, which Secretary H. P. Wood on purpose kept open, staying away from church to accommodate the tourists was about the only open place which did not take in money.

Eager, fresh and well supplied with cash, the 430 women, 24 men and six children of the big party, flew about Honolulu, up and down the railway line, all over the electric car system, in and out of shops and stores, enjoying themselves immensely. The liveliness was exceeded only by that of Saturday evening when they raided many of the stores, seeming particularly after Hawaiian jewelry, postal cards, views, books and other souvenirs, useful and ornamental.

This is the first stop in their long journey and their purses were full and their hearts were glad. They realized that they might never come this way again and they made the most of the visit.

Churches, clubs, stores, parks, hotels, beach resorts and vehicles all felt the presence of the tourists, and an enormous crowd crammed the Alakea wharf at the departure of the Cleveland for Yokohama at 5 p. m.

One man's note book, just before embarking for Yokohama, showed: Auto, \$60.00; lunches, \$7.80; postals, \$2.25; views, \$3.00; cigars, 95c; wine, \$15.00; coat-of-arms and other Hawaiian souvenir jewelry, \$32.50; curios, \$23.50; tips, \$1.50; miscellaneous, \$17.50. He was out with a party of four others, three ladies and a gentleman. On the other hand there were individual expenditures that did not exceed \$5 during the stay in port. At an average, however, Honolulu did a good business.

GLAVIS ADMITS BALLINGER IS NOT CORRUPT

WASHINGTON, D. C., February 14.—Discharged Forester Glavis, under cross examination in the investigation by the Congressional committee of alleged irregularities and fraud in the Department of the Interior, charges Secretary Ballinger and Dennett with official misconduct, but admits that he found no corruption.

NEW YORK, February 14.—Secretary Haike of the American Sugar Refining Company, who claimed immunity from prosecution for sugar weighing frauds, on the ground that he testified before the grand jury and that such testimony could not be used against him, will be criminally prosecuted with others, immunity being denied.

THE DRINK QUESTION AND THE LOCAL WATER PROBLEM

EDITOR STAR:—There are worse things than good liquor, and one of them is the water which we daily draw from the mains of the Honolulu Water System. If anyone has statistics showing the number of sicknesses and deaths due to the consumption of this commodity which we cannot very well get along without, I wish he would bring them to the notice of the public through the medium of your columns.

In some parts in India and other tropical countries it is not safe to drink water. Whiskey and soda, which is safer, is substituted. In those countries it is not possible to get good water, and Prohibition would be almost an impossibility. I was informed by a physician the other day that it was not safe to use the gravity water which is being supplied to a large portion of the people of Honolulu. As a matter of fact the Officials of the Board of Health occasionally publish notices in the newspapers advising the people to boil and filter the water before using. They ought also to advise dusting down with a feather duster after the morning bath. In Honolulu it is possible to get abundance of good water. If complaint is made to the Water Works Office, the Head of that Department is ever ready with an array of figures showing lack of funds; and so it has been for years past. It seems to me that someone is blundering.

If the Prohibition Agitators would win over a large number of votes in the coming contest, I would suggest that they pledge themselves to work as vigorously for pure and wholesome water, and they will get the votes for Prohibition and the people of Honolulu will not go dry for want of a liquid worth drinking.

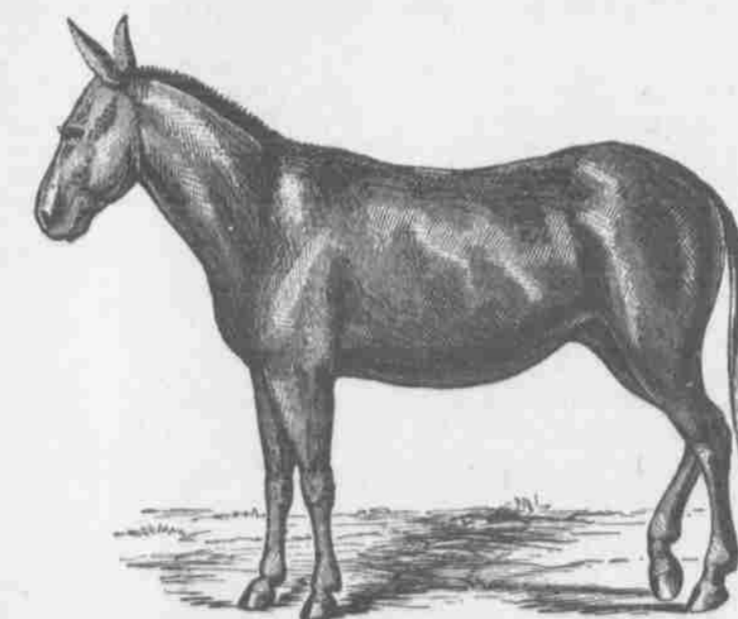

CIRCULATE IT AMONG HAWAIIANS.

The Social Science Club would do well to have Mr. Thurston's address on the liquor problem translated into Hawaiian and thoroughly circulated, so that a copy will find its way into the hands of every voter. It is bound to be a very effective document, and its historical review of the subject shows in very striking manner the fact that the appeal now being made to Hawaiian voters to free them from the liquor evil is only an appeal to do something which they would have done for themselves a couple of generations ago if allowed. It is only an appeal to them to do what their greatest leaders have tried to do and have been prevented from doing by outside influence.

Eliminating the unfortunate suggestion that the home rule issue was merely a herring drawn across the trail,—a proposition not brought forth in good faith,—this sketch should be of great campaign value. Perhaps it may be regarded as a characteristic of its author that he holds his own conclusions so positively that he finds it hard to appreciate or recognize the sincerity of those who differ with him,—a fact which often greatly weakens his opportunities for convincing argument.

By all means let the women vote in the special election on the liquor issue if they want to. Their votes are not needed,—the present qualified voters of the Territory are, we think, fully prepared to approve the Curtis anti-saloon bill by a very large majority indeed. It may be doubted whether a request for woman suffrage is a wise move on the part of those making it, for it introduces a difficult new issue. But if the women want to vote on the question,—and it surely appears very strongly that they do,—they should be given the right.

ARE NOT PROHIBITION BILLS.

The Curtis and Clark bills, pending in Washington and about to be submitted to the voters of Hawaii, are generally referred to as prohibition bills but as a matter of fact they are anti-saloon bills. The question of whether Prohibition prohibits is not involved in their consideration, for they are not designed to attempt Prohibition. Their immediate effect would be to close all the saloons in the islands and to stop all sales of liquor here. From the strictly commercial point of view, the objection to this is that it would turn over to San Francisco merchants a considerable wholesale business now done here. The force of this objection must be admitted, but it is the price to be paid for advantages so great that they are worth far more than the price.

REFUSE LIQUOR ADS.—EMPLOYEES MAGAZINE TAKES FIRM STAND

Managers of the railroads which are publishing employees' magazines have taken a stand against whiskey and beer advertisements appearing in these publications as detrimental to their readers.

The Santa Fe, Rock Island, Erie and Illinois Central roads print monthly magazines which go to each employee of the road with the latter's monthly pay checks. These magazines are printed in the interest of employees and to establish a bond between the men on the line. Advertising for these publications is solicited from various sources with the idea of making them self supporting.

Recently several manufacturers of whiskies and owners of breweries have made efforts to get space in these employees' magazines to advertise their various brands. In each case the managers of the railroads have declined to accept the advertisements at any rate.—The Editor and Publisher.

BY AUTHORITY

BILL NO. 29.

AN ORDINANCE PROVIDING FOR THE INSPECTION OF MILK AND DAIRIES AND DAIRY COWS, AND REGULATING THE SALE OF MILK, AND PROHIBITING AND PUNISHING THE DISPOSITION OF UNWHOLESOME, IMPURE OR ADULTERATED MILK IN THE CITY AND COUNTY OF HONOLULU.

Be it ordained by the People of the City and County of Honolulu:

SECTION 1. No milk producer or milk vendor shall after this Ordinance becomes operative, either himself or through his agents, servants or employees, offer or expose for sale or sell or deliver for sale, use or consumption within the City and County of Honolulu, any milk without first having obtained from the Board of Supervisors of the City and County of Honolulu a permit so to do as hereinafter provided:

SECTION 2. To procure such a permit, the applicant therefor shall present to the Board of Supervisors a written application, and shall state therein the name and business and residence addresses of the applicant, the source or sources from which said applicant obtains or will obtain supplies of milk, the number of cows in the possession of said applicant, the daily average quantity of milk produced, and the daily average quantity of milk disposed of by said applicant, and the manner and character of such disposition. He shall within four months after the filing of such application furnish a certificate from a veterinary surgeon showing that all such cows are free from tuberculosis. The Board of Supervisors shall provide for the testing of cows and the furnishing of such certificate without charge to the applicant. Such application shall be made to the Board of Supervisors upon printed blanks to be furnished by said Board for such purpose. Such application shall further state the specific brand or business name, if any, under which said milk is to be sold, exchanged or distributed.

SECTION 3. If the Board of Supervisors, upon such application, shall determine that the statements therein made are true and satisfactory, it shall be the duty of the Board of Supervisors to direct the City and County Clerk, to issue and said City and County Clerk shall thereupon issue to said applicant a permit to sell, expose or offer for sale, exchange, deliver or distribute milk within the City and County of Honolulu.

SECTION 4. One such permit shall be required for each place of production, general sale or storage of milk. Such permits shall be issued only in the names of the owners of the supply of milk thus on storage or for sale, and shall for the purpose of this Ordinance be conclusive evidence of such ownership. No such permit shall be sold or assigned or transferred. Such permit shall be subject at a times to revocation by said Board of Supervisors in its discretion upon sufficient cause therefor shown; provided, however, that no permit shall be revoked until after a hearing given by the Board of Supervisors in the matter of the revocation of such permit after (5) five days' notice in writing has been served on the owner of such permit, which notice shall state the ground of complaint against such owner, and the time and place of such hearing; and provided further, that no permit shall be revoked by said Board of Supervisors for the first offence without the unanimous consent of all the members of said Board.

At least once each year every person or persons, firm or corporation holding such permit shall register with the City and County Clerk his or their name and permit number, and shall make a written statement to said Board of Supervisors containing all the information required to be given by applicants for permits in their written applications for permits as hereinbefore provided; and all applications for permits and all such written statements required as aforesaid shall be registered in a register to be kept by the City and County Clerk for that purpose.

SECTION 5. No person or persons, firm or corporation shall sell or expose for sale or exchange or deliver or distribute, within the limits of the City and County of Honolulu, milk from any wagon or vehicle, unless such wagon or vehicle shall have exposed on both sides thereof the permit number of the person or persons, firm or corporation selling or offering or exposing for sale, or distributing or delivering or exchanging such milk. Such permit number shall be

printed on said wagon or vehicle in Arabic numerals not less than three (3) inches in height, and shall be placed on said wagon or vehicle under the direction of a duly appointed milk inspector, and in case milk is sold from cans or vessels (not carried in any wagon or vehicle), then the permit number as aforesaid shall be put in a conspicuous place on such can or vessel immediately below the opening thereof, so as to be plainly visible on superficial inspection; or if such milk is sold or exposed or offered for sale, delivery, distribution or exchange within a store or house, or on the sidewalk of any street in the City and County of Honolulu, then such permit number shall also be constantly exposed in some conspicuous manner at the place where such milk is sold or kept, so as to be plainly visible.

SECTION 6. It shall be unlawful for any person or persons, firm or corporation, by themselves or by their agents, servants or employees, in the City and County of Honolulu to render or manufacture, sell, offer for sale or exchange, deliver, distribute, or have in his, their or its possession with intent to sell, expose or offer for sale or exchange, or distribute for human consumption, any impure, adulterated, unhealthful or unwholesome milk, or any milk from which the cream has been skimmed or separated unless the same is specifically and openly stated to be skimmed milk.

SECTION 7. Milk shall be deemed to be impure, adulterated, unhealthful and unwholesome within the meaning of this ordinance under the following stated conditions, viz:

1st—Milk containing less than eight and one-half per centum (8½%) of milk solids, excluding milk fat

2nd—Milk containing less than three per centum (3 per cent.) of milk fat.

3rd—Milk drawn from cows within fifteen days before or within five days after parturition.

4th—Milk drawn from cows fed on any unhealthful or unwholesome feed.

5th—Milk drawn from cows kept in an unhealthy or unsanitary condition, or from cows affected with any form of infectious, contagious or transmissible disease, or milk which contains more than one million bacteria per cubic centimeter.

6th—Milk from which any part of the cream has been removed, and milk which immediately upon being drawn from the cow shall not have been cooled by submerging the vessel in which the milk is contained in cool water to a depth equal to that of said milk in the vessel, or else cooled by a process of aeration, and kept in a cool place at a temperature of not higher than seventy-seven degrees (77 deg.) Fahrenheit until removed for delivery thereof.

7th—Milk which has been diluted with water or with any other fluid, or to which has been added or into which has been introduced any foreign substance whatever.

8th—Milk drawn from cows or by milkers that are themselves in a condition of filth or uncleanness.

9th—Milk which is shown by analysis to contain any substance or substances of any character whatsoever not natural or normal constituents of milk, or to have been deprived either wholly or in part of any constituent naturally or normally contained in milk.

10th—Milk containing any preservative or antiseptic.

SECTION 8. It shall be unlawful for any person or persons, firm or corporation to have or carry on any wagon or vehicle upon or from which milk or cream is being or is brought, carried, stored, deposited, sold, exchanged, delivered or distributed, or offered or exposed for sale or distribution as food for any human being, any swill, garbage, refuse or any decaying or fermenting, putrefying, foul unwholesome, noxious or filthy matter, or any cans or receptacles containing any material or substance with which cream or milk might be diluted, adulterated or rendered impure, unwholesome or unhealthful.

SECTION 9. The Board of Supervisors of the City and County of Honolulu shall appoint one or more milk inspectors as may be necessary to carry into effect the provisions of this ordinance. The salaries of such inspectors shall be fixed by the Board of Supervisors. Said inspectors shall have all the powers and shall perform all of the duties provided in this ordinance, and shall have such other powers and perform such other duties as may be hereafter prescribed by the Board of Supervisors.

SECTION 10. It shall be the duty of the City and County Physician to exercise practical supervision in respect to such milk inspectors, and said milk inspectors shall be subject to the direction at all times of said City and County Physician. Said milk inspectors shall make weekly reports to the said City and County Physician of their official doings.

SECTION 11. In order to carry out the purposes and provisions of

this ordinance the City and County Physician, the milk inspector or inspectors and any other duly authorized officers of the City and County of Honolulu, and any member of the health and sanitation committee of the Board of Supervisors, shall have the right at any and all times to enter upon or into the premises of any producer or vendor or distributor of milk authorized under the provisions of this Ordinance, and any refusal on the part of such producer or vendor or distributor to allow such entry and such inspection as may be required by such City and County Physician, milk inspector or other officers, may be punished by the revocation of the permit of such producer, vendor or distributor by the said Board of Supervisors. And it shall be unlawful for any person or persons, firm or corporation to obstruct or interfere with the City and County Physician, a milk inspector or any other duly authorized officer or employee of the said City and County of Honolulu in the performance of any of the duties required by this Ordinance.

SECTION 12. It shall be the duty of the milk inspector or inspectors to inspect from time to time all dairies and other milk establishments in the City and County of Honolulu, for the purpose of satisfying himself or themselves that the provisions and requirements of this Ordinance are being observed and obeyed.

SECTION 13. The City and County Physician, the milk inspector or inspectors and other officers of the City and County as hereinbefore described shall have the right to enter and have free access, egress and ingress to all places where milk is stored or kept for sale, and to all wagons, carriages or other vehicles, railroad cars, steamboats, or conveyances of every kind used for the carrying or transportation or delivery of milk for the purpose of consumption in the City and County of Honolulu.

SECTION 14. The City and County Physician and the milk inspector or inspectors shall have the right at any time to take samples of milk from any person, persons or concern selling or exposing for sale or exchanging or delivering or distributing milk in the City and County of Honolulu not exceeding one quart for each sample, such sample to be taken in full view and in the presence of the person from whom said sample is taken, and shall then and there furnish to the person from whom such milk is taken one-half of such sample sealed, and shall retain and seal the other half of said sample. Such sample so retained shall have written thereon an identification number, the date of the taking of the sample and the name of the person by whom it was taken, and a memorandum thereof shall be made by the person taking such sample in a book to be kept for that purpose, showing the name of the owner or driver from whom taken, the date when the same was taken and the number of the dealer's permit.

SECTION 15. Nothing herein contained shall be construed to prevent the use, sale or manufacture of what is known as condensed milk, or what is known as buttermilk, or what is known as sour milk, provided the same are made, compounded or prepared from pure, clean, fresh, wholesome and unadulterated milk within the meaning of this Ordinance, and are in sound and wholesome condition; and provided also that in the case of condensed milk the proportion of milk solids shall be not less than twenty-eight per cent. (28 per cent.), of which not less than twenty-seven and one-half per cent. (27½ per cent.) shall be milk fat.

SECTION 16. Pure skimmed milk shall be permitted for sale or delivery, provided that the cans or vessels containing it shall be distinctly labeled "Skimmed Milk" in letters one and one-half inches high.

SECTION 17. Any person who shall violate any of the provisions of this ordinance shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine of not less than five dollars (\$5.00) and not more than one hundred dollars (\$100.00), or by imprisonment for a term of not exceeding three months, or by both such fine and imprisonment.

SECTION 18. This Ordinance shall take effect thirty days after the date of its approval.

ROBBERS OF SOLDIERS ON THE SHERIDAN

A gang of four sharpers in the habit of round-tripping between Frisco and Manila, via Honolulu, for purposes of fleeing soldiers in transit at card and dice games, is feeling the heavy hand of martial law, with perhaps one exception.

Sometime ago The Star exclusively reported the fact that the Army transport service was watching for these men and men of their ilk. Now the transport officials of the Sheridan have at least three of the party in the brig or ship's prison.

Yesterday an attempt was made to get the men ashore, three of them being stowaways. Word was passed by the leader of the gang to a friend in the ship, through the door of the brig, and a call for legal help went ashore. Attorney Leon Straus drew up papers in a habeas corpus proceeding and, like the faithful legal representative he is, did all in his power to get the men landed, but he could not get the papers signed, the transport people not allowing him nor his representatives to have communication with the prisoners.

A man alleged to be one of the four managed to skip the ship and the office's of the transport were this morning looking for him. The principals of the game, however, are held aboard the transport.

They have for sometime been traveling between San Francisco and Manila via Honolulu, making money at gambling with the soldiers. They would make enough money on down trip to go home on a passenger liner, and then have plenty to spare, when they could not safely stow on the transports.

One stowaway sharper had \$400 on him when he was discovered and searched between San Francisco and this port. The money was taken from him. The three now aboard will be taken to Manila and returned thence to San Francisco, forced to work their way, and under martial law, sleeping in the brig.

PARIS TO SHINE FOR ROOSEVELT

President Taft Declares That Business Methods Must Conform To The Law.

SEARCHING FOR SHIPWRECKED.

French South Polar Expedition Ran Short of Fuel and Was Pinched By Icebergs.

(Associated Press Morning Service.) PARIS, February 14.—President Fallieres has announced that a national fete will be given in honor of Theodore Roosevelt when the former President of the United States visits Paris on his way back to the United States from Africa. The fete plans include the decoration and illumination of the Champs-Elysees, a great military parade and other features.

WILL CARRY OUT PLEDGES.

NEW YORK, February 13.—If the enforcement of the law be inconsistent with present methods of business, then it does not speak well for present business methods. If such be actually the case, business methods must be changed so as to conform to the law. This is the answer which President Taft made last night to the cry of panic raised by the Wall Street interests. The speech was delivered at the Lincoln dinner given by the Republican Club. In his speech the President strongly defended the administration. He insisted that pledges made during the last campaign will be carried out as rapidly as possible and that before the end of his term all of the promises will be redeemed.

THE ANTARCTIC EXPLORERS.

PUNTA ARENAS, Chile, February 14. The French antarctic exploration party, aboard the ship Porquoi Pas, of which Charcot is the commander, reached here from the south yesterday, having given up the effort to reach the South Pole. Charcot states that the expedition failed through the giving out of the supply of fuel and the fact that the ship had been seriously damaged by icebergs. The crew were exhausted in their effort to maintain the dash south. The expedition returns with data and specimens of the greatest scientific value.

MARINE CASUALTIES.

VALPARAISO, February 14.—The Chilean cruiser Minister Zenteno and five other steamers have been sent to the rescue of the eighty-eight passengers as yet unrescued of the British steamer Lima, which foundered on Saturday in the Strait of Magellan. The fate of these passengers is unknown, but it is hoped that some of them have been able to make land somewhere along the coast.

SANTIAGO, Chile, February 13.—The British steamer Lima, Capt. Jacobs commander, foundered in the Strait of Magellan yesterday, fifty passengers losing their lives. Two hundred and five of the passengers and crew were rescued.

The Lima, which was of 3115 tons burden, was bound from Liverpool for Callao.

WASHINGTON, February 12.—Eight government vessels are now out searching for the naval tug Nana which is missing en route from here to Boston. It is feared that the Nana may have become disabled in a storm.

DR. COOK TRAVELING.

VALVIDIA, Chile, February 14.—Doctor Cook, the Arctic explorer, and his wife arrived here yesterday as passengers on the steamer Aris from the north. Cook would give out no statement to the press and showed every desire to avoid publicity. He appears to be in bad health.

JURY LOCKED UP.

PORTLAND, Oregon, February 13.—The Hermann jury, after being out for twelve hours, was last night locked up for the night.

PARIS, February 14.—A new trade treaty, which will bring about reciprocity between France and Canada, has been promulgated.

Inquiry in the City Hall this morning brought forth a few opinions, as indicated below, anent the proposition of women voting here to determine the prohibition question.

Mayor Fern stated that he is in favor of women voting on all matters; favoring woman suffrage for Hawaii. He believes that the women of this Territory would better petition Congress for suffrage than merely to ask for the privilege to vote on the liquor question.

"If Congress will grant a vote by the women on the prohibition matter," said the Mayor, "it will grant suffrage, and I do not think the special privilege of balloting on the subject of prohibition would be granted. The women of Hawaii had better ask for suffrage, out and out. Personally, I am in favor of women voting, not only on liquor, but on everything."

Clerk E. Buffandeau is against the ladies voting. "If they do, they are sure to win," he declares.

Clerks Van Giesen and Fernandez, in the City Clerk's office are also opposed to the idea, believing that if the women are allowed to vote on the liquor question, they should be allowed to vote in general elections on all questions.

Acting City Attorney Milverton believes the gentler sex should by all means be allowed to vote on the liquor question, for he declares they, above others, should have something to say in this vital matter. He has ideas, as to the relative merits of prohibition and proper regulation, realizing that prohibition does not necessarily prevent.

H. Terrance Lake, in the City Attorney's office, emphatically announced that he thinks women should be allowed to vote on all such questions affecting the home life of the community.

Miss Mary Ah Chuck, City Attorney's stenographer, stated that she wanted the women to vote on prohibition and she would vote as often as she could against saloons.

Auditor Bicknell believes women should not vote on one matter unless they are to vote on all matters, and his office staff agrees with him unannouncedly.

Sheriff Jarrett does not wish to be interviewed in the premises; Judge Andrade says he will think the matter over; Deputy Sheriff Rose believes if women vote on the liquor question they should vote on all other questions, his statement being much the same as Bicknell's and some others above quoted.

V. L. Stevenson has seen the votes of women do good work in Australia and is of opinion that they should vote on all questions, if on one. License Inspector Fennell, through the nature of his position, does not wish to be quoted.

Judge Robertson was the man selected it was a great relief to him. Paying a tribute to his father as a judge of logical mind, whose administration of justice gave complete satisfaction to the people of Hawaii, Judge Dole said he felt that Judge Robertson had inherited the qualities of his father. He congratulated the community and the officers of the court on the appointment.

District Attorney Breckons, on moving that the commission and oath be spread on the records, said in the course of remarks that a few weeks ago he was opposed to such Federal appointments from among residents. He took a different view now and on behalf of the marshal's, the clerk's and his own office he extended a most hearty welcome to Judge Robertson. They had come in contact with him—sometimes disastrously for them—and they recognized his fine qualities for the position. He was afraid of being turned down in any proposition he made to the Bar Association, but would ask its president, Mr. Kinney, to speak for it.

Mr. Kinney remarked on the frequent changes of judges in that court and the Territorial courts. He had taken issue with the Attorney General's department on the matter of representing the bar on such occasions, but he was pleased to take his place as president of the Bar Association and welcome Judge Robertson on behalf of every member of the bar. Especially was he pleased to be present at the culmination of the efforts of the Bar Association to see Judge Robertson where he was. They knew he would make good. He had been tested in every way. They welcomed him to the office and pledged him their hearty support.

Judge Humphreys introduced himself as president, secretary, treasurer and sole member of the independent bar association. Quoting Justice Field on the importance of the judicial office, he said the wisdom, upright character and learning of Alexander G. M. Robertson qualified him for the position. More than that he was a kind, hearty, patient and courteous gentleman. It was rare that a judge had enjoyed his experience—his connection with mercantile life, his political activity and wide career at the bar. Some might think it the duty of members of the bar to fool a jury, but they could assure Judge Robertson of kindly, disinterested and courteous cooperation.

Judge Robertson thanked Judge Dole and the gentlemen of the bar for their kindly expressions. They often heard the bench praised by the bar, but did not often hear the bench praising the bar. It was with pleasure that he repeated the opinion of a United States Senator, heard the other day, that the bar of Hawaii was far above the average and that he had told the Attorney General so. For more than a quarter of a century

the Hawaiian bar had maintained the front and cordially welcomed the high standard.
