MANMOTH SUGAR DEAL

NEARLY A HALF OF ONOMEA SOLD FOR \$860,000.

Brewer & Co. and Castle & Cooke the Sellers—Edward Pollitz the Buyer—George R. Carter the Broker.

Four thousand eight hundred shares of Onomea Sugar Company stock changed hands yesterday at 137 1/2. C. Brewer and Castle & Cooke were the sellers. Edward Pollitz was the buyer. The deal was made by George R. Carter.

It took the brokers' breath away when it was reported on the Exchange this morning, but presence of mind was retained to inquire if there was any more to be had at that price. The transaction is an evidence of the growing demand in San Francisco for island sugar stocks. Mr. Pollitz buys to sell again in San Francisco and the certificates of stock will be made out in blocks of suitable size for that purpose. The transaction involves no change of management or ownership. Brewer & Co. and Castle & Cooke each own an equal interest in the plantation and alternated each year in the agency, Castle & Cooke being the agents this year. Each corporation sold an equal amount of stock. The two together still own a controlling interest and will not dispose of more stock at any price. They will continue to alternate in the agency.

The plantation has always proved profitable to its owners. Mr. Pollitz came here to look for good sugar stock to put on the San Francisco market to meet the demand that has grown up there and which has been greatly stimulated by the Hawaiian Commercial deal recently made. He began negotiations through George R. Carter for this Onomea stock. The deal was completed yesterday before Mr. Pollitz sailed on the Coptic.

The sellers are satisfied with the sale they have made. The buyer feels he has a good thing. Except for the Hawaiian Commercial deal this is the biggest deal of the kind in island sugar stocks that has ever been made. It is the biggest deal ever made in the islands. It amounts to \$860,000 and is a cash transaction.

Part of this will be spent in paying their passage thither; the remainder in Spanish testaments, tracts and song books.

TWO MORE NEW STEAMERS

WARRIMOO AND MIOWERA TO BE DISPLACED.

Will Give Way to the Rimutaka and Tongariro, Each of 4,000 Tons and Modern Model.

With the tremendous activity and development of steamship lines between the Pacific coast and the Orient which the war has precipitated, the traffic between the coast and Australia has also received an impetus. While the increase has not been as spectacular nor of the kind to appeal to the imagination as that which the vision of Oriental wealth and riches has brought about, it is substantial and is being met in a substantial manner.

Word now comes through the most authentic sources that two steamships of the Canadian-Australia line are to be replaced by larger and better vessels. These two are the Warrimoo and the Miowera. They are to be replaced by the Rimutaka and the Tongariro, each vessel of 4,000 tons, modern in model and in equipment, and both belonging to the New Zealand Shipping Company. They have large refrigerator capacity so that it is evident there is an intention to push the fresh meat and provision trade of the colonies into this new channel.

The New Zealand shipping papers, while not giving the plans in detail, speak of the change as an assured fact. The Honolulu agents of the line, T. H. Davies & Co., while they have received no direct advices on the subject were not surprised when told of the information in the matter which had been received.

THESEPIANS LEAVING.

The Garonne, sailing at 2 p. m. on Monday, will take back to Seattle most of the people who have formed the Orpheum caste since its opening in December. Several others connected with the old U and I company will also leave by the excursion steamer.

APPEALS MAKING.

In the suits of Colonel Soper and Hopper and others for the Waialua stock sold at San Francisco, appeals are being made out by the plaintiffs from the decisions of Judge Perry sustaining the demurrers of Mr. Dillingham and the plantation. They will likely be filed tomorrow.

A REVIVALIST.

The Rev. C. H. Yatman, a prominent evangelist of the Methodist Episcopal church, who conducted a series of meetings in this city a few years ago, will arrive in Honolulu March 1st. He will remain about two weeks and will conduct revival services in the Methodist church. Mr. Yatman is an excellent preacher and will doubtless do a successful work in this city. Many in the city will be pleased to renew his acquaintance.

CLEARING THE STREET.

Fred Harrison will at last clear the sidewalk on the Fort street end of the Judd block. Two planks will be taken off the entire length of the walk, and the bricks and lumber will be moved from the corner.

THE COLD.

Two cold nights have followed one another. At the junction of Nuuanu and Pauoa valley the thermometer registered 62 degrees yesterday morning at 6 o'clock, and 59 degrees this morning. Further up the valley it was 61 and 58 at 4 a. m. It has been a regular cold snap and blankets and cosies are much in requisition.

AT THE WHARF.

The St. Francis was taking sugar from two island steamers in naval row this morning. It is probable she will sail about February 1st for New York. The Harry Morse found a berth awaiting her on her arrival this morning at the Mail wharf. She is the first collier for a long while that has been so lucky.

TAGALO LOVE SONGS.

A peculiarity of the Tagalo love songs is that they contain an allusion to kissing, written out of the American soldiers in Manila to a friend in Honolulu. This is explained by the fact that osculation is held in less favor among the Malays than in some other races. Their songs are set, not only to music, but to dances.

TEAM FOR WAIALUA.

HAWAIIAN SUGAR IS SAFE

NOTHING TO FEAR FROM BEETS OR CUBA.

Results of the Investigations of the Department of Agriculture Through L. A. Knapp, Special Commissioner.

"The Hawaiian sugar interests have nothing to fear. You have the finest conditions here for cane sugar there are in the world. Physical conditions are better in many respects than they are even in Cuba. While the industrial and social conditions are such there as will for many years more then offset her proximity to market. And long before those conditions are overcome the construction of the Nicaragua canal will have brought you close to your market by doing away with the long continental haul by rail.

"The Philippines are distant from market, and they, too, have to contend with social and industrial conditions that cannot be materially bettered for a long time, and their physical conditions are no better, if as good as are yours."

It was in this way that S. A. Knapp the special commissioner of the department of agriculture, and himself an experienced Louisiana sugar planter, summed up the results of his investigations and observations on the sugar question. He was sent to Japan, China and the Philippines several months ago and is returning on the Coptic.

"I was sent," he said, "with instructions to buy anything in the way of rice or sugar seed, material or plants, that I thought would be of advantage to these industries in the United States, and to report on conditions and outlook. Perhaps the scope of my work was a little broader than that, but so far as the public is concerned that is the pit of it. My observations have led me to this conclusion: The sugar and the Philippines, where conditions are suited to it, can hold its own against the beet sugar industry where conditions are suited to it. Louisiana, as a great sugar producing factor, is doomed. Our short season and our danger from frost put us out of the race with more favorable regions. You have here perhaps the most favorable conditions in the world.

"In the Philippines there are large areas of land suitable for sugar. Physical conditions there are good, but not better than, if as good as yours. While the distant market must always be a handicap, the methods there are crude and unscientific. To begin with cultivation, their methods are primitive and rude, so that the crops of cane are relatively small. Their methods of manufacture are crude. Small ox mills that do not get out half the juice of a modern mill, practically no processes of clarification beyond a little time to neutralize the acid in the juice are used. The boiling is done in pans usually with a metal bottom and wooden sides. From the pans it goes into earthenware jars or crocks by the use of a wooden ladle, 150 pounds, called Pilones. These have a small hole in the bottom which is covered with a bamboo mat. The molasses drains off through this. The result is that the top third of the sugar in the Pilones has the quality of a very poor article of brown sugar. The middle third is sticky and dirty, while the bottom third has the color and consistency of tar. The price that can be got for this stuff is from a third to a half of what it ought to bring."

Improvements that are said to be needed.

While the government is considering the large needs of the water front, there are many who are anxious that it shall not neglect the smaller ones. Among these are counted improvements at the boat landing. It is suggested that there should be steps on the extreme makai end of the landing. Another thing needed is a water tap. There is no fresh water attainable at the landing either for drinking purposes or to keep the landing clean and the adjacent street free from dust. There ought also to be better lights.

IN HONOR OF THE KAISER

A RECEPTION BY CONSUL J. F. HACKFELD.

Diplomatic Corps and Gentlemen of the City Coast William II, Who is Forty Today.

Consul J. F. Hackfeld today received the diplomatic corps and gentlemen of the city in honor of the birth anniversary of the German emperor. The reception began about 12 and closed at 1 p. m. At the time the German flag flew from the tall staff and the Hawaiian band played on the grounds in front of the consulate.

In the private office of Mr. Hackfeld a light lunch was served. It consisted chiefly of salads, delicacies, etc. In the light refreshments champagne was dominated. There were also lighter drinks. Special Agent Sewall was among the first arrivals. The greeting between the American and German officials was most cordial. The minister remained for about twenty minutes and when he retired was escorted as far as the front door by the consul.

British Commissioner Kenny was an early caller. He offered his congratulations, tipped a bumper to William II, chatted a few minutes and then retired.

He was followed by the French commissioner, Mons. Vossion, who gave and received a cordial greeting.

Among the consular representatives to pay their respects were: Wm. Hayward, consul for the United States; F. A. Schaefer, Italy; H. Rendes, Spain; H. Focke, Belgium; the new Chinese consul, Vice Consul Goo Kim and Second Vice Consul Wong Kwai, China; H. W. Schmidt, Norway and Sweden. Several American army officers called. These included Colonel Ruhlen, Captain Lydig, Major Langitt and others.

The government was represented by Minister Cooper and Minister King.

MY LADY'S PIN MONEY.

The word pin money is not much used nowadays, and when it is, it is apt to be used loosely. It is often employed to mean an allowance by a father or a husband for a daughter's or wife's extra expenses. But its proper significance is a woman's allowance for all her personal outlay, whatever it may be. The origin of the term is somewhat singular. Long after the invention of pins, in the fourteenth century, the maker was permitted to sell them openly the first and second of January only, when the court and the town ladies crowded to the shops to buy them, having been provided by their fathers and husbands with money for the purpose. After pins had become plentiful and cheap, women spent their money on other things, but pin money remained in vogue. The opinion, often expressed, that pins were invented in France during the reign of Francis I, and introduced into England by Catherine Howard, the fifth wife of Henry VIII, is erroneous. In 1347, 200 years before the death of Francis, 12,000 pins were delivered from the English wardrobe for the use of Princess Joan, and fifty-three years later the Duchess d'Orleans purchased of Jehan le Breconmier, a pinmaker of Paris, several thousand long and short pins.

CABLE WILL SURELY COME

MR. SCRYMSEUR URGES A LITTLE PATIENCE.

Hawaii Will Soon be Connected With the Mainland in One Way or the Other—Impressions.

"I have enjoyed myself immensely during my short stay in Honolulu, and am charmed with your beautiful city," said J. A. Scrymser, the big cable promoter just before the Coptic left the Pacific Mail wharf yesterday afternoon. "I have seen the splendid Pali and found it well worth the drive."

"As for the cable prospects, I can say little of interest at present. This is a big scheme we propose, one that will cost a good deal of money. To link America with Hawaii, the Philippines and the Orient, and give a safe and complete service will cost very nearly \$20,000,000. Our part of it is in shape, however, and we are now merely waiting for action by the governments. Had the United States promptly sanctioned the franchise of Hawaii, and given us the rights we required, a start would, in all human probability, have already been made, and Hawaii might now be connected with the mainland."

"I am no more able than you to say what may be done. As is well known the subject of a government cable is being discussed in the cabinets to have endorsement in the cabinets. If such a project be carried out it may effect if not altogether change our plans."

"I am pleased to know that your people have confidence in what you call the Scrymser company. There is one point in our favor. We have never had a failure of an enterprise. Nearly 15,000 miles of cable have been laid by us and all of it is in successful operation."

"There is nothing to do here but to wait. I am sure the cable will come and quickly, but in what way we can foresee. It all rests with the authorities at Washington."

MYSTERIOUS RUMORS.

Japanese Say Russia Threatens Their Fleet.

Shortly after the conclusion of the Japanese-China war it was rumored, says the Chuo, that certain Russian high military officers, seeing that Japan was intending to make naval and military extensions on a large scale, held a meeting and passed a resolution to the effect that the Japanese navy should, if necessary, be destroyed as soon as possible. According to the latest telegrams from Europe, it appears that the staff officers of the Russian navy recently found it necessary, in the execution of Russia's far eastern policy, to do away with the Japanese navy, and decided to carry the proposal into practice as soon as possible. The Japanese paper adds that though it is impossible to at once believe the truth of the telegrams, it would not be altogether wrong to suppose that such a plan should have been contemplated by the Russians. In any case it is advisable that the Japanese generally should pay strict attention to the movements of Russia.

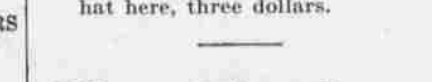

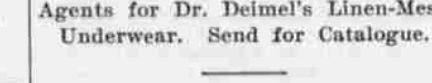

SOME RIVAL CLAIMANTS

EX-QUEEN LILIUOKALANI FINDS A RIVAL.

The Crown Land Claims To Be Met by Counter Claims from Other Hawaiian Heirs.

There are fresh claimants for the crown lands, according to the Washington Post. It is quite easy to see whose pen is again at work. The following is part of an article upon the subject which lays forth the claims of Mrs. Pratt to the property. The vagueness about the rulers of Hawaii is a clever touch, but the writer was better informed than he pretends to be.

What is known as the crown lands first came to be considered as such in the reign of King Kamehameha III, who died about seventy years ago, says the Washington Post. He was reckoned as one of the wisest as well as the wealthiest and best of the Hawaiian monarchs. The lands which he owned as his private estate, embracing thousands of acres throughout the various islands, were left by the terms of his will in such manner as to have the income devoted toward the support and dignity of the throne. It is claimed that no provision was made for their sale, and that nothing but the revenue derived from them was to be used by the reigning monarch. With this condition of affairs, and the throne of Hawaii having ceased to exist, the heirs of King Kamehameha III assert that the property should revert to them. Especial stress is placed upon the fact that the lands of Kamehameha III were his own private property and did not fall to him as King or become in any way a part of the possession of the crown, and the use of these lands was all that was left to succeeding rulers.

After King Kamehameha III came King Kamehameha IV, King Kamehameha V and a number of other Kings with long and unpronounceable names, the last one of his family having been King Lunalilo, who was a descendant of the fifth Kamehameha and who died in 1874. With him all that branch of the family of King Kamehameha III became extinct, a number of rulers having from time to time been seated on the throne, but they left no issue. The ancestry of Princess Keekaunani and Princess Kaohelahani then dates back to the house of Keoua, of which King Kamehameha III was a descendant, to Kalouluamale, the half brother Kamehameha I, who was grandfather of Kamehameha III, and from him the line descends directly to Mrs. Pratt and Mrs. Wilcox, whose husband's Hawaiian name is Wilikoki. After his return from abroad, where he received his education, he became possessed with a desire to have an American name and accepted the one which most resembled his Hawaiian cognomen. These two women have prepared extensive charts showing their genealogy and their relationship to King Kamehameha III and proving all other branches of the family extinct and other heirs dead.

The claims of Liliuokalani to the crown lands are not based upon any relationship or kinship to the Kamehamehas, but rather upon the assertion that the crown lands actually belong to the throne, or were the property of the ruling monarch, instead, as contended by Mrs. Pratt and Mrs. Wilcox, that only the use or revenue of these lands could go to the throne and that the property itself remained in the heirs of King Kamehameha III. Upon the death of King Lunalilo, the last of the line of royal blood, Kalakaua, the brother of Liliuokalani, was chosen King in February, 1874. When King Kalakaua died his sister, Liliuokalani, was made Queen.

As long as there was a throne in Hawaii the descendants of Kamehameha made no efforts to secure possession of the lands which they now claim, for the reason that they recognized that the use of these lands was to be devoted for the benefit of the reigning monarch, whoever he might be, upon the throne. It is only now, when the revenues of the lands cannot be devoted to such purposes from the fact that the throne has ceased to exist, that they come forward and assert their claims.

NEW CHINESE ARMIES.

A Peking telegram says: It is reported that the generalissimo Jung Lu, who has been busy lately organizing the armies of the north on a modern basis of discipline, etc., has telegraphed to Generals Sung Ching at Shankai-kuan, and Yuan Shih-kai at Hsiaochau to come to a conference at Peking. The latter official has already arrived at the capital and the former is expected in a few days.

There were "jollifications" in all of the rooms until 11:00 o'clock.

NEW WARSHIPS.

The first warship to arrive in Japan this year, says the Miyako, will be the cruiser Chitose, built at San Francisco. She is expected to arrive at Yokosuka in the course of the next month. The second will be the cruiser Kasagi, also built in the United States. This cruiser will probably arrive in the beginning of April. Following the Kasagi will come the cruisers Asama and Tokiwa and the torpedo destroyers Murakumo, Shinonome, Yagiri, Ikazuchi and Shiranui.

The further details of the reported wreck off Kohala are anxiously awaited by those interested in shipping. The probability is that the vessel was overturned far from here and drifted to the spot where she was found. It will be one more Ocean mystery unraveled, for according to report the name of the vessel ought to be discovered.

Another Hotspur in the field after the crown lands, will cause the ex-Queen some trouble in putting forward her claims. It reminds one of the days of the later Roman Republic, when Rome was filled with claimants for the estates of various monarchies. The claimants had all the fun of the litigation and the Republic inherited the estates.

The views of S. A. Knapp upon our sugar prospects are very satisfactory. He shows that the Islands have a wonderful chance before them, and that it will take years before any rivals will be in a like condition to what we are in now. The investments made by and through Mr. Pollitz tend in the same direction, because it shows that capitalists on the mainland believe in our future. That the Islands were fertile and that we possessed exceptional advantages has always been realized by our own residents, but people on the mainland were afraid of us on account of lack of government stability. This having been assured by annexation, capital is ready to come in. For the future there will be nothing like the trouble we have had in the past for capital for our enterprises.

IN THE PHILIPPINES.

The situation in the Philippines has considerable light thrown upon it by the passengers who passed through on the Celtic yesterday. Many of these had been actively engaged in administrative work in and around Manila, and others had been keen and interested observers of the people and of the events.

It is pretty plain that the Spaniards still resident in Manila are doing their utmost to keep up a feeling of friction between the Americans and the Filipinos. This is not to be wondered at. The majority of them are Spanish officers and soldiers out of a job. They do not know what their future may be. They are bitterly discontented with their own country and with the foreigners who have displaced them. Naturally they are ripe for any mischief, and see their way to doing it by causing friction between the Americans and the Filipinos, and trying to keep up distrust between the two parties.

Then again the priests have good cause, according to their point of view, to keep the pot simmering. They are hated by the Filipinos, but as long as the Spaniards were in the ascendant they could retain their wealth, and make large gains out of the forced labor of the inhabitants. The enormous wealth of the religious bodies and of individual priests in the Philippines has been the cause of much of the trouble in the past, and has done much to make the Spanish rule, which was bad enough in all conscience, still more hated. That these should join with the discontented soldiery in making mischief is very natural and brings about the state of things that Correspondent Healy described in his interview published in yesterday's Star.

The special dispatch received from Mr. Seymour seems to indicate, on the other hand, that Aguinaldo is willing to drop all opposition and to lay down his arms. This is also the desire of the conservative and property holding portion of the Filipinos, and undoubtedly that of the very large Chinese element. These classes dread the ruff-raff of the Filipino soldiery getting the upper hand. Because that would mean not more exorbitant taxation, but the destruction of property and the looting of valuables, with a very considerable chance of loss of life.

The Filipino leaders are unable to keep their troops in order. Their discipline is a mere misnomer, and the men come and go as they like. The only thing that keeps them together is their hatred of the Spaniard. Let the Spaniard be removed, let the United States troops be withdrawn, and the jarring elements among the Filipinos will be flying at one another's throats. These returning officers and men will carry a great weight in the United States. Their opinions delivered orally will have more influence than reams of correspondents' letters; they have seen and they have carefully considered the conditions. The question of the Philippines is the most burning question of the day in the United States. Upon the fate of the Philippines pivots the whole of the treaty, practically. The result of what may happen there is

looked for with anxiety by every great power.

CABLE LINES.

The interviews with Mr. Scrymser, published yesterday, show that the cable matter, at the present time, lies entirely in the hands of Congress, and that no initiative of any kind can be taken until Congress acts. There is and we have become inured to waiting for many things. However, for our comfort, it may be quoted that everything comes to him that waits.

In cable matters Mr. Scrymser is one of the most important, if not the most important man in the United States. He is at the head of and has interests in corporations which have control of thousands of miles of cables and of wire. His view that the prospects of the Hawaiian cable are hopeful may be taken as an extremely careful statement of the case, and may be translated as more than hopeful. Indeed a cable to the Islands is now a military and naval necessity, and the whole matter hinges upon who is to lay it, whether a corporation or the United States government. If it is to be a private corporation, Mr. Scrymser and his colleagues stand ready to do the work on certain terms.

The cable project has had hard work done for it in the east by Mr. Scrymser and at this end by his representative, Judge Hartwell. These gentlemen have striven for a long time to make satisfactory terms, but there has ever been a fear here that a valuable franchise might be given, for which better terms could be obtained, and within the last year or so annexation was so imminent that the consent of the American government was considered necessary.

PAY SCHOOLS.

The question of select schools partly supported by the government is one which has been battled over many a time and oft. The standpoint of The Star in the matter is that if people want select schools they should pay for them. The government has no right to make class distinctions. In the eye of the Board of Education every child should be equal.

The law allows the establishment of pay schools, but it gives the Board of Education discretion in the matter. The Board has for a long time set its face against anything of the kind, although it has allowed two pay schools to be continued under its auspices. One in Honolulu and one in Hilo, but they are the relics of a bygone age.

That people desire to keep their children away from the mass of children of all nationalities is very true, but if they want to do so they should pay for it out of their own pockets and not expect the tax payers to foot the bills, for pay schools, especially in small districts, are very expensive, and a free school must be supported in the same locality as well. The pay school does not take the place of the free school. The Board of Education is to be congratulated upon its firm position. It will be still more to be congratulated when the present anomaly of pay schools in Honolulu and Hilo is swept away. The probability is that the first territorial legislature will do what former legislatures have failed to do.

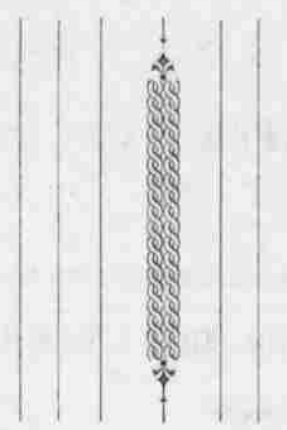

DAMAGES OF AN ATTORNEY

CLIENT SAYS HER LAWYER WAS CARELESS.

She Thinks He Should Pay—Mrs. Oids vs. J. A. Magoon—Kukaiua Case in Supreme Court.

Mrs. A. N. A. Oids has entered a suit against J. Alfred Magoon for \$1,000, on three different counts, alleged to be due as damages for carelessness in examining the title of one Ching Quan Chow to certain property in Kukui street.

According to the complaint the Chinaman claimed an interest in the said property, and Mr. Magoon was employed to examine his title. The lawyer reported that the title was clear, whereupon plaintiff purchased the lot. This was in 1888. Since then it has become evident that Ching Quan Chow's title was no good whatever.

The second count refers to an undivided half interest in certain premises in Kukui street, and the third to a lot claimed by the Chinaman through A. Chick. Together \$1,000 was paid out and \$4,500 is claimed as damages.

Judge Stanley this morning consented to discharge T. Richards Robinson from further responsibility as assignee of the estate of Chu Sam, a bankrupt, as soon as the sum of \$382.88 is distributed among the creditors and their receipts taken therefor.

The appeal matter of Charles Notley vs. Kukaiua Plantation Company is before the supreme court today. On the bench are Chief Justice Judd, Justice Whiting and F. M. Hatch, Esq. Hartwell, Thurston and Carter for the plaintiff; Kinney, Ballou and McNahan for defendant. Mr. Hartwell read the bill of exceptions and charge of the court. This afternoon he is arguing.

Judge Perry today heard a small civil case that in some way reached the circuit court. The matter was taken under advisement.

FALLIBILITY OF INSTINCT.

A correspondent of the Scientific American gives another instance of the fallibility of instinct. A friend, he says, placed three small empty vials in an open box on a shelf, in an upright position, in close contact, and they were uncorked. A short time afterward it was a matter of surprise to find that they had been appropriated by a female mud wasp. She had placed a goodly number of spiders in the center vial, doubtless intended to serve as food for her future brood; and then proceeded to deposit her eggs in those on either side. She next closed tightly the mouths of all three receptacles with a hard lime cement. Having finished her work, she doubtless then went on her way, satisfied that all had been done for her offspring that a thoughtful mother could do. But just think of the sensation of the little wasps when they come into existence, for while starving in their sealed cages, they can plainly see through the impenetrable glass walls, the bountiful supply of food which was provided for their use.

MUSICALE AT PUUPUEO

MR. AND MRS. COOPER AGAIN ENTERTAIN.

The Amateur Orchestra Given an Opportunity to Carry Out One of Its Most Admirable Designs.

Minister and Mrs. Cooper entertained again handsomely at Puupueo last evening. It took the form of a musicale and gave the Amateur orchestra an opportunity to carry out one of Wray Taylor's admirable designs in its organization, that of being the exponent and vehicle of introduction to Honolulu music lovers of some of the newer work of the world's great living composers. Of the seven selections the orchestra rendered five of them which were never before given here by band or orchestra. These were: Gavotte, "Captivating," by Tobani; Overture, "The Venus," by Bizet; Waltzes, "The Daughter of Love," Benner; Operatic Selection, "Queen of the Isle," Isenman; and Scottische, "Pansy Caprice," Walker. All of them were well rendered and excellently received. Mr. and Mrs. Cooper, Wray Taylor and the Amateur orchestra have put the community under heavy obligations in a musical way.

The other numbers on the program were familiar, but sterling selections, March from "Athalie," Mendelssohn, and the "Liberty Bell" March, Sousa. Puupueo was shown in another phase of its beauty and admirable location by last night's gracious hospitality. The moon was at its full. The air had in it a touch of autumn. Between the two Mauna valley with its precipitous heights on either side wore a suggestion of Switzerland.

The spacious house was brilliantly lighted. Mr. and Mrs. Cooper welcomed the guests in the large reception room. The great court was fragrant and bright with flowers and potted plants.

Following the orchestral program, there were refreshments and dancing. It was a delightful affair.

PORTUGAL'S NAVY.

The trials of two small Portuguese cruisers, the San Gabriel and San Raphael, will, writes the Lisbon correspondent of the London Mail, take place at an early date at Havre, where they are building.

Great efforts are being made to strengthen the Portuguese navy, which has of late years fallen into a sad state of decline. A French engineer was lately engaged to organize the Lisbon dockyard, and sums of money (which the country cannot afford) are being spent on new ships, while the unfortunate Portuguese bondholders look in vain for interest on their money.

Portugal owns one small and ancient ironclad, the Vasco da Gama, built in 1875, on the Thames, which represented her at the jubilee review.

Two large cruisers are building at Elswick and Lisbon. These are, the Carlos I and the Amelia. With another cruiser built in Italy in 1896, they represent the serviceable Portuguese navy.

There are six old cruisers, mostly of wood, twenty-two gunboats and a flotilla of river gunboats resting on the Zambesi. Twelve torpedo boats and a motly collection of old transports also bring up in the rear.

The plans are prepared for two new ironclads of small size, but whether they will ever be built is doubtful.

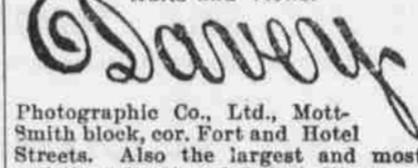
