## ON TRACK OF THIEF

MARSHAL HENDRY AND INSPECTOR HARE GONE TO HAWAII TO GET MAN WHO ROBBED MAIL.

United States Postal Inspector F. J. Hare and United States Marshal E. R. Hendry, accompanied by a secret service man, left in the U. S. Kinau at 12:35 this afternoon for Kawaihae to take charge of the matter of the robbery of the mail when occurred supposedly between Kawaihae and Kamuela a week ago yesterday.

They will probably return at the end of this week with the man alleged to have taken from the registered pouch two packages of coin, one containing \$1,000 and the other containing \$2,500.

U. S. Marshal Hendry reached the Kinau wharf shortly before noon today, but learned that the Kinau would not sail until 12:30 on account of having to wait for the San Francisco mail for Hawaii from the P. M. S. S. Korea. The presence of Hare and Hendry and the secret service man naturally led to the conclusion that trouble was brewing for somebody. Inspector Hare stated that there was nothing doing, nor would he say what business

## BIG DAMAGE SUIT COMMENCED TODAY

WIDOW WANTS \$25,000 FOR DEATH OF HER HUSBAND—WAIALUA AGRICULTURAL CO. DEFENDANT

The accident at Waialua, on November 22, by which two men were killed and a number of others injured through a car loaded with rock getting away on a steep grade on what is known as the Halemano Railway Hill, and jumping off the end of a high trestle, had resulted in a suit for damages for \$25,000 being filed this morning, while it is understood that others are to follow.

Carolina Vierra, widow of Joao Vierra, one of the men killed, is the plaintiff to the suit, which has been filed through J. Lightfoot and Enos Vincent, attorneys, and the defendant is the Waialua Agricultural Company. The complaint charges that through the negligence of the defendant proper precaution were not taken in carrying on the work, and that defective brakes, might have been obtained by more care on the company's part. The case is filed in the Circuit Court and will come up before Judge De Bolt.

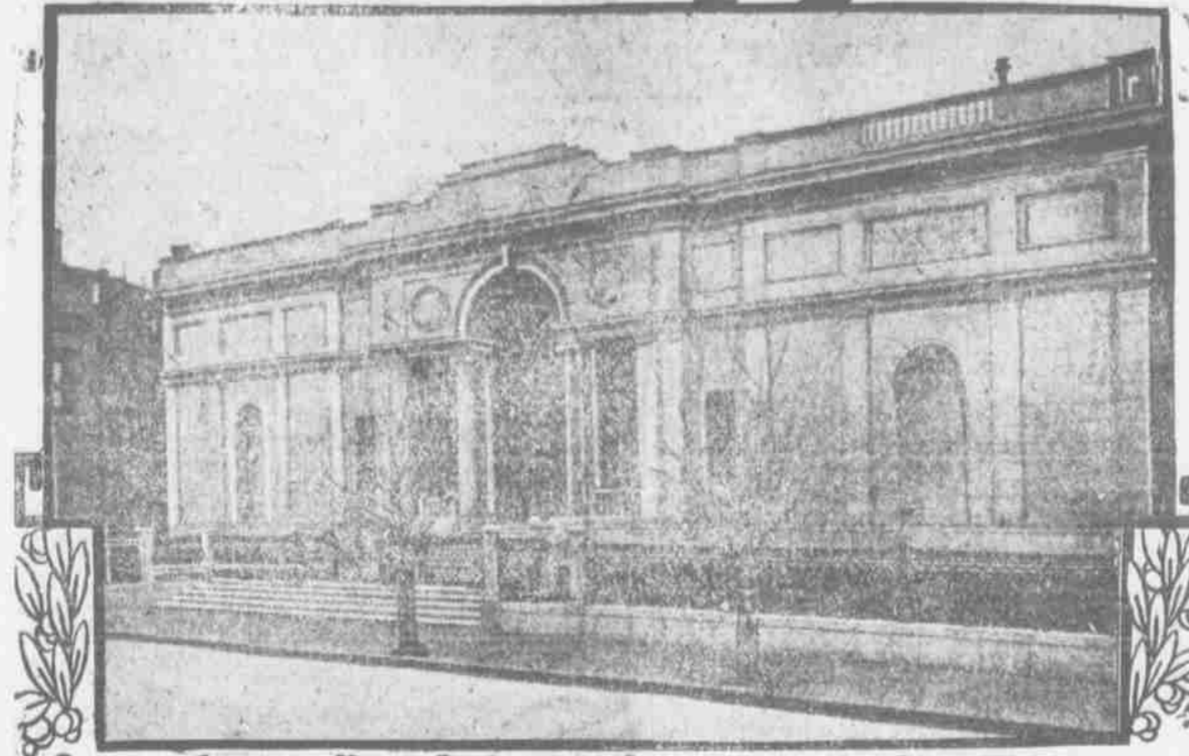

## BREAKING BAR DETAINED KOREA

KEPT INSIDE OVERNIGHT IN SAN FRANCISCO BAY—ROUGH WEATHER FOR THREE DAYS.

Pacific Mail S. S. Korea, Captain Sandberg, docked at the Hackfield wharf at 11:30 o'clock this morning from San Francisco with 83 cabin passengers for this city, through passengers for the Orient numbering 102 in the cabin, 42 European stowage and 699 Asiatics. She brought 5,000 tons of general cargo for Honolulu and included in her through freight are 1,058 bars of silver valued at about \$600,000.

Rough weather was experienced for the first three days out. She left her wharf at San Francisco on time at 1 o'clock in the afternoon of December 10, but owing to the roughness of the bar did not get outside until 6 o'clock the next morning, thus losing 17 hours. She had practice as soon as she entered this harbor, seven days having expired, allowing for the difference in time, from her departure from the San Francisco wharf. She sails for the Orient at 10 o'clock tomorrow morning.

## MATTER SETTLED

TOKYO, Dec. 7.—There is reason to believe that the entire question of the emigration of Japanese to America has been satisfactorily settled, at least for the present, after a series of conferences, which have been held between United States Ambassador O'Brien and Minister of Foreign Affairs Hayashi. It is understood that at their last meeting the representatives of the Japanese government outlined a plan by which it was agreed to limit emigration to students and commercial men having known means of support, and to entirely prevent Japanese laborers from going to America. This agreement will entail the closest supervision on the part of the Japanese authorities.

## LOOKS GOOD FOR HARBOR

PRESIDENT MORGAN RECEIVES IMPORTANT CABLE FROM H. P. WOOD REGARDING STATION.

At the time that Secretary Wood of the Chamber of Commerce left for Washington, he carried with him as much information as he possibly could get relative to Pearl Harbor. A few days after he had gone the Chamber of Commerce held an executive meeting and decided that Woods should have more data relative to the coral formation of the inner harbor and outer harbor than he had at present, and as a result of the meeting President Morgan cabled him asking how necessary it was to have the information.

The cable in answer to the one sent the other day arrived this morning, and is as follows: "Borings strongly advised. Will have the assistance of Captain Otwell's department and also Navy Department—Wood."

"The Chamber had done everything possible to get all the information that was needed, and at the present time everything was ready to start the work," said Mr. Morgan this morning. Superintendent Campbell of the Department of Public Works has offered to us the use of all the drills, machinery, etc., that they have and will give us any help that is necessary. The work of boring will be done under the direction of the U. S. Engineers and the Navy Department, and as soon as it is completed the report will be forwarded on to Washington to be placed before Congress.

"At least twenty-five borings will be taken, and I expect the work to be started in two or three days. The only thing that we are waiting for now is the authorization from Washington for Capt. Otwell and the Navy to go ahead. I think by the tone of Wood's cable that we have a good chance of getting the appropriation this session of Congress, and I, as well as every one else, sincerely hope we will get it."

## PROBATE CASE.

The final accounts of Ho Yee, administrator of the estate of Goo Shee, were this morning approved by Judge De Bolt. The administrator credits himself with \$90.75, and charges himself with 2900.

Judgment was today entered against John G. Rothwell in favor of W. C. Peacock in sum of \$25,000 in accordance with the finding of the Supreme Court sustaining Judge De Bolt's decision.

Martha K. Ross has brought action for divorce from Fred Rosa on grounds of desertion and failure to support.

SMALL ALIMONY GRANTED.

## G. DAVIS RAISES POINT IN CASE

DECLARES THAT HIGH SHERIFF HENEY HAS NO RIGHT TO CUSTODY OF HIS CLIENT.

George A. Davis, attorney for John Marks, charged with cattle stealing, raised a novel point in Judge Lindsay's court this morning when the case was called for trial, which resulted in the jury's being dismissed until 2 o'clock this afternoon in order to give time to attorneys to look up some points in the matter.

Marks was convicted and sentenced to five years in prison a week or more ago for horse stealing, but pending a hearing on the 27th on a writ of habeas corpus granted by Judge Dole of the United States District Court, the prisoner was admitted to bail and placed in the custody of the United States marshal. This morning he was brought into court by High Sheriff Henry, and Davis held that he was wrongfully in the custody of the sheriff and that while the marshal was responsible for him the Territory has no means of producing his body in court or elsewhere.

Attorneys Cathcart and Prosser for the prosecution argued that the custody of the United States did not relieve the prisoner of liability under the Territorial laws. Judge Lindsay however was willing to have light on the subject and the matter was continued.

The Sheridan was taken out of dock yesterday to make room for the cruisers which have to be repaired at Mare Island.

EDITOR HAWAIIAN STAR:—The session of Congress now opening offers both special encouragement and unusual obstacles to obtaining extensive legislation affecting Hawaii. The encouraging features are the large estimates for Hawaiian appropriations submitted to Congress by the departments, and also the growing friendly interest in Hawaii which has been greatly stimulated by the visit of the Congressional party.

The particular obstacles that confront us are the facts that the antepresidential session is always a talk-much-and-do-little session, and the greater hindrance of the sudden and widespread business depression; the latter has already cut heavily into the Treasury receipts, and is bound to create a strong sentiment in Congress toward the scaling down of governmental expenditures. Even the time honored argument, that it would relieve the stringency to expend the Treasury surplus, cannot be invoked at this time, since that surplus is practically all on deposit in national banks and through them is already in use in the channels of trade.

But in spite of obstacles, it is my purpose to make the results of this session exceed those of the last one, as each has shown an increase over the preceding session for the past three years.

The outlook for Pearl Harbor improvements which is to be our main work for this year, is on the whole very encouraging. Through the change in the attitude of the General Board of the Navy, we have at least secured an official estimate of two millions of dollars for a dry dock, of which a half million is asked to be appropriated this year. The President's recommendation that Pearl Harbor be opened is very gratifying, although he has not specifically advised the beginning of naval station work there as it was hoped, from a Cabinet official's statement, that he would do.

The apathy of the Secretary of the Navy toward Pearl Harbor has at least developed into a direct statement in opposition to its present improvement. In a recent conversation with a member of Congress, the Secretary said that he deemed it inadvisable to begin construction work at Pearl Harbor at this time; he added that in his opinion, a new station in southern California would be of more importance to the navy than would one at Pearl Harbor. This indicates clearly that if we succeed in getting an appropriation for Pearl Harbor, it will not be with the aid of the Secretary of the Navy, but rather in the face of his opposition.

It is practically certain that the inclusion of the Pearl Harbor item in the official estimates is due to the

firm attitude taken by Admiral Dewey and the General Board in emphasizing the immediate importance of that work, and to the favorable attitude of the President.

My secretary has for the past three months followed this subject up with the Naval Board and has on three occasions been asked by a subcommittee of the board to confer with them on particular features of the project. Another personal conversation had with Admiral Dewey within the last week indicates that he does not share the views of the Secretary of the Navy in regard to Pearl Harbor; on the contrary developments of the past year have brought the Admiral of the Navy to regard the development of Pearl Harbor as one of the most important features of the naval programme.

The Secretary of War has approved the whole of General MacKenzie's estimates for Hawaiian fortifications, and over a million dollars are submitted under the various heads. It is of course too early to determine what attitude the House committee will assume toward this large estimate.

The time whistle blows at 1:30 p. m. which is the same as Greenwich, 0 hours, 0 minutes. The Sun and Moon are for local time for the whole group.

## U. S. DEPARTMENT OF AGRICULTURE—WEATHER BUREAU.

The following data, covering a period of 32 years, have been compiled from the Weather Bureau records at Honolulu, T. H. They are issued to show the conditions that have prevailed, during the month in question, for the above period of years, but must not be construed as a forecast of the weather conditions for the coming month.

Month, November, for 32 years.

TEMPERATURE (1876-1906).

Mean or normal temperature, 74°. The warmest month was that of 1896, with an average of 76°.

The coldest month was that of 1893, with an average of 73°.

The highest temperature was 86° on the 17th, 1892; 17th, 1893; 24th, 1897; 25th and 26th, 1902.

PRECIPITATION (1877-1894, 1904-6).

Average for the month, 4.52 inches. Average number of days with .01 of an inch or more, 14.

The greatest monthly precipitation recorded in any 24 consecutive hours was 5.22 inches on the 30th, 1880.

RELATIVE HUMIDITY.\*

Average, 9 a. m., 71 pct.; 3 a. m., 70 pct.; average, 9 p. m., 89 pct., (1893-1903); 8 p. m., 74 pct., (1904-6).

CLOUDS AND WEATHER (1890-1906)

Average number of clear days, 10; partly cloudy days, 14; cloudy days, 6.

The prevailing winds are from the NE. (1875-1904, 1904-6).

The average hourly velocity of the winds is 8.0 miles (1904-6).

The highest velocity of the wind was 28 miles from the NE. on the 17th, 1904; 15th, 1905 (1904-6).

## OWNERS OF SEWALL STILL HAVE HOPES

AMERICAN FOUR-MASTER, LONG OVERDUE, MAY HAVE BEEN DRIVEN FAR OUT OF COURSE.

PHILADELPHIA, Dec. 6.—The American four-masted bark Arthur Sewall, long overdue from this port for Seattle, is not the only square-rigged vessel about whose safety much uneasiness is felt in shipping circles. The bark Adolf Ohrlig, Captain Ross, left New York on April 10, a week later than the Sewall, bound for San Francisco, and since then nothing has been heard of the vessel.

Reports reached here yesterday from the Pacific coast which tell of terrific storms in the neighborhood of Cape Horn. One vessel, the French bark Rochambeau, from Rochester, Eng., reported that she was off Cape Horn 60 days unable to proceed owing to a succession of westerly gales. On June 29 this bark encountered a hurricane.

The knowledge that the American clipper ships Atlas and Kenilworth, both bound for San Francisco, were compelled to put into Rio Janeiro, damaged by storms, leads maritime men to believe that the Sewall encountered the same gales and was blown far out of her course. The Atlas was more than 200 days out before tidings of her were received. The Kenilworth was out more than a year before she sought refuge at Rio Janeiro. Both vessels lost sails. They are believed to be still at Rio Janeiro.

The American schooner William Nottingham left New York on March 3 for Seattle and was not heard from until she put into Melbourne on September 4 for new gear and sails. The British ship Dynamene, which left Leth on January 17 for San Francisco, was supposed to have been lost on September 19 in distress. The Italian ship Elisa, from Tyne April 23, was long overdue at San Francisco, and was supposed to have foundered until word was received of her arrival at Melbourne in distress last September.

The fact that so many sailing vessels had to seek harbor causes owners and agents of the Arthur Sewall to believe that this bark, which is constructed of steel, weathered the storms, but was blown far out of her course. The Sewall has enough food on board to last fifteen months if necessary.

## HOLIDAY DINNER KILL SUGAR KING

HENRY O. HAVEMEYER SUC-  
CUMBS TO ACUTE INDIGESTION  
AT COUNTRY MANSION.

NEW YORK, Dec. 4.—Henry O. Havemeyer, president of the American Sugar Refining Company, better known as the Sugar Trust, and one of the country's richest men, died at his country home, Merrivale, near Commack, Long Island at 3 o'clock this afternoon from an attack of acute indigestion.

A desperate effort was made to save the life of the sugar magnate by the use of oxygen. At the final hour one of the automobiles from Merrivale was sent into Northport, six miles away, to secure a supply, and the trip there and back was made in twelve minutes, but Mr. Havemeyer was already beyond aid. He died surrounded by most of the members of his family.

Mr. Havemeyer's illness dated from Thanksgiving Day, when, after a hearty meal with his family, he started for a tramp over the Merrivale estate with his son Horace in search of English pheasants. One of the game birds gave him a hard chase and he was compelled to run a considerable distance before bringing it down. That night he collapsed from the exertion, and the next day his illness became alarming.

## An Earnest Plea For Postal Banks

An earnest plea for the establishment of postal savings banks and extension of the parcels post service is made in the annual report of Postmaster General Meyer, received in the last mail. More up-to-date business methods and better bookkeeping, supervised by a permanent official corresponding to the general superintendent of a great manufacturing corporation, also are declared necessary for the good of the service.

The report shows the total receipts of the department for the fiscal year ending June 30, 1907, to have been \$183,585,000, with expenditures of \$190,238,288, showing a deficiency of \$6,653,282. The deficiency is little more than half that of 1907, which was \$11,411,779.

After arguing the encouragement to thrift that would be encouraged by postal savings banks, the Postmaster General calls attention to the benefits to be derived in the way of increased circulation of currency if the Government by postal savings banks, were to provide "a place of deposit free from any possibility of doubt or suspicion for vast sums of money which might otherwise be hoarded and kept out of circulation through ignorance or lack of confidence."

He recommends that all money order postoffices be designated postal savings banks, to receive deposits of a minimum of \$1, such deposits to be limited to \$500, and the draw interest at 2 per cent., the money to be exempt from "demand, seizure or detention under legal processes against the depositor." That the money deposited in the postal savings banks may return to the channels of trade, authority is asked to place it in the national banks which are Government depositories in the States where the money is deposited in the postoffices.

Attention is called to the fact that postal savings banks "would encourage the foreign settler to deposit his earnings in this country, because after he has accumulated a few hundred dollars he will not be content to receive merely 2 per cent. interest, but will possibly seek to purchase a home, and the moment he acquires real property here he becomes a more conservative citizen, is actively interested in the affairs of the nation and at the same time places himself and his dependents beyond the likelihood of becoming public charges. Should, however, his earnings remain in the postal savings banks the fact that he has an interest in the Government and something at stake will tend to make a more desirable citizen."

## Peonage System In The South

Peonage among colored people in the South always has existed to a greater or less extent, and several prosecutions have been instituted on that account, but it has remained for the Austro-Hungarian and Italian governments, through the state department of justice to develop the fact that many foreigners who have been brought over to the maintain by the representatives of the immigration agents are today white slaves. Others are kept in a chain gang, not for criminal offenses, but for alleged debt.

The records of the state department as well as those of the department of justice, it is claimed, are filled with instances of this kind, and complaints have been investigated from Florida, Mississippi, and several other states. Indictments have been found in two or three instances and there may be more to come, although extraordinary influence is used to hush the matter up for fear that the tide of immigration will be turned away from the Southern states.

It seems like a page from Dickens' stories of "Fleet Prison" to read what is being done in states like Mississippi, where there is an infamous law providing that an agricultural laborer, who fails to fulfill the strict letter of his contract may be held to service, and if he persistently refuses to work out his indebtedness may be convicted by summary process and sent to the chain gang.

There are Italian immigrants, who have not been in country long enough to speak English who are the working in the chain gang in Mississippi charged with no more criminal offense than failure to fulfill the terms of a contract written in the English language, explained to them by an interpreter, and which they have signed with a cross.

An archaic machinery which was designed to keep negroes at work has been turned against these foreigners. The courts are in the hands of natives. The jury are all white men living in the vicinity, and all in sympathy with the planter or lumberman who seeks to coerce his laborers. Italians and Hungarians and other Europeans are generally ignorant of English entirely or so nearly so that they cannot understand the proceedings.

## Congress Wants No Interference

A dispatch from Washington dated December 15, stated that there was little chance of any financial legislation during the present short session of Congress. From statements made by leaders in both houses it appears that the law-makers are afraid to meddle in the money situation. But if it is decided to enact legislation in regard to national finances the law-makers want no interference from the President and unmistakable hints have been dropped to that effect. Any financial or currency legislation will be shaped and rounded into form by Congress and not by the administration. Anything like an attempt to force through any currency measure under the guise that it is supported by the administration will result, it is declared, in the utter and dismal failure of that bill. The leaders will give respectful attention to the recommendations of the White House and the Secretary of the Treasury, but will not consent to conferences which put them in the position of following the leadership of the White House.

It is pointed out that the necessity for currency legislation does not arise from any great popular demand like that for railroad rate legislation, when the leaders were whipped into line for what the administration wanted.

"RANK FAKE" SAYS PLANTATION MAN HAD NOTHING TO DO WITH SECURING HINDOOS AND SAYS HAS NEVER SEEN ONE

H. G. Boswell, chief engineer of the Ewa Plantation mill, arrived this morning from the Coast on the Korea. He immediately set about denying statements published in the Vancouver and other coast city papers, some of which have been reprinted here, to the effect that his business in Vancouver was to arrange for the securing of a lot of the surplus Hindoo laborers of Western Canada for use in the islands, representative.

Mr. Boswell stated to The Star emphatically that he had not so much as thought of such a thing during his whole stay in Vancouver, where he was visiting relatives and spending a month's vacation. He states that he was not interviewed, not so far as he knows ever talked to a reporter while he was away. The story, he says must have been made up out of whole cloth, and his name secured from the hotel register in Vancouver where he stopped for a day or two. He was styled "assistant manager," by the papers, whereas he says that he registered simply his name and address at the hotel and discussed his occupation with nobody.

"I was dumfounded almost," said Mr. Boswell, "when I read a long piece in a San Francisco paper about the matter after I had heard of it, and had no opportunity of correcting it then. I was away on a vacation and for no other purpose. I scarcely know what a Hindoo looks like, and the idea of using them in Hawaii never entered my head."

THIS IS THE "FAKE." SAN FRANCISCO, Dec. 8.—Realizing at last that they have proved failures as substitutes for other varieties of labor in the Northwest, the swarms of Hindoos who tried to settle in Van-couver, Oregon and California are preparing to emigrate again to some more congenial and sympathetic land. Under the leadership of Feliash Din, who is the nabob here, the 300 who form the San Francisco colony will leave soon for Hawaii, and the island of Oahu, where they hope to land, probably will at once acquire a race problem of its own. The plantation hands there are now almost exclusively Japanese, and these will fight to prevent the invaders driving them from their work.

H. G. Boswell, manager of a sugar plantation which occupies the greater portion of the plain of Ewa, on the western half of the island, is responsible for the prospective heira of the turbulent wanderers, who have stirred wrath and determined opposition everywhere on the western continent. He arrived in Vancouver several weeks ago, and after gathering all the unemployed he could find there came to San Francisco yesterday and at once communicated with Feliash Din, who lives at 1823 Eddy street, the largest center of the colony here.

Boswell may have to charter a steamer to take his Indian laborers to their new home. Vancouver is crowded with Hindoos, who are being turned out of the railroad camps in hundreds. At this work they proved utterly incapable. The frosty weather in the north completely paralyzed their energies.

Work in the construction camps began at 10 o'clock in the morning and often at noon, because the gaunt, quiet men born and reared in the sultry Indian clime refused to rise before the sun had warmed the atmosphere.

In consequence they have been displaced, and the hordes facing starvation in British Columbia gladly accepted Boswell's offer to take them to his plantation.

In San Francisco the Hindoo abandoned hard labor to become peddlers. They have been hawkers of rugs and cheap jewelry in the suburban and country districts. But in this also they seemed to have failed, and Feliash Din, when he called upon Boswell at the St. Francis yesterday afternoon, promised the plantation manager that the whole colony would go to Hawaii if the members were wanted. It is warmer there, more like the climate of India, the Hindu chief said, and his brethren can work better.

## HYDE WOULD GIVE BACK A MILLION

OFFERS TO RESTORE FUNDS IF SUITS AGAINST HIM ARE DROPPED—NOW LIVING IN PARIS.

NEW YORK, December 2.—James Hazen Hyde, who was compelled to sell control of the Equitable Life Assurance Society to Thomas F. Ryan in 1905 following disclosures of his mismanagement of the company, has offered to make restitution to the company of various sums, aggregating approximately \$1,000,000, provided all suits against him, including those brought by the Attorney General on behalf of the State of New York, be withdrawn.

Up to the present time Mr. Hyde's offer has not been accepted.

The offers were made on behalf of Mr. Hyde through his attorney, Samuel Untermyer.

Mr. Hyde left this country in the fall of 1905, after he had appeared as a witness before the legislative insurance investigation conducted by Chas. E. Hughes. Before leaving he sold his magnificent country place at Bay Shore, L. I., his horses and carriages his private car and nearly everything he could convert into cash. He went to Paris, where he has since lived in princely style.

For the 502 shares which represented the stock control of the Equitable and carried it with not only the domination of that immense company, but the Mercantile Trust Company, the Equitable Trust Company and several other important financial institutions. Mr. Ryan paid Mr. Hyde \$2,500,000. The fees of his lawyers and the other expenses of his long campaign to retain control of the Equitable amounted to approximately \$500,000.

If his offer of \$1,000,000 is accepted he will have but \$1,000,000 left of the money he got from Mr. Ryan for parting with one of the most valuable corporate properties in the country. This of course does not represent all of Mr. Hyde's wealth, as he is believed to have several millions invested in other properties.

Some few of the other fifty directors of the Equitable under the old regime have made offers of settlement but for trivial amounts compared with the sum offered by Mr. Hyde.

## OPPOSE PLAN TO INCREASE TAXES

JAPANESE BUSINESS MEN SEE A DANGER IN CONTINUED ADVANCE—MAY IMPAIR CREDIT.

TOKIO, Dec. 4.—There is little doubt that the business men of Japan are distinctly opposed to an increase of taxation for the purpose of carrying out unproductive post-bellum enterprises. Barons Shibusawa and Sonoda and other leaders frankly say that the strain of the special efforts made on account of the war cannot continue, as it would condemn the country to a perpetual war footing financially. This would be likely to impair Japan's credit in the eyes of foreign nations and check the growth of the country's financial resources. It would be better, they say, to prolong the period for military and naval increments.

**FRUIT GROWERS WANT OPEN DOOR**

**PETITION CONGRESS TO REPEAL EXCLUSION ACT AND ADMIT CHINESE—MAKE STRONG PLEA.**

MARYSVILLE, Dec. 4.—The California fruit growers in convention here today memorialized congress for speedy action in repealing the Chinese exclusion act. The growers contend that long trial and earnest efforts have proved the impossibility of inducing reliable white labor to engage in the primary processes of production in orchard, vineyard, asparagus, sugar beet, onion, celery and other great industries in which tens of millions of dollars are invested.

The memorial says that Chinese exclusion has depleted the Chinese labor market and that the extension of the exclusion policy to the Japanese leaves these imperiled industries exposed to enormous losses and threatened ultimate extinction. The opposition to Asiatic labor, it is declared, is found in the cities, due largely to the efforts of agitators who are themselves of alien descent, will not at any wage do the work done by the Asiatics. The memorial concludes:

"We affirm that there is absolutely no evidence that the states in the west ever suffered industrial or economic injury from the presence of the Chinese here prior to the exclusion law. We reject the theory of assimilation, holding that when nonassimilating labor engages in this noncompetitive work it relieves us of the strain upon our racial and national standards, which strain threatens the subversion of those standards in the task of as-

**LAUNCH BOOM FOR SENATOR KNOX**

**CONGRESSMEN OF PENNSYLVANIA SUPPORT THE EX-WITTOURNEY GENERAL.**

WASHINGTON, December 4.—The boom of Senator Philander C. Knox of Pennsylvania for the Presidency was formally launched at a notable banquet in this city to-night, when the Pennsylvania Republican Congressional delegation placed itself squarely on record in favor of the Pennsylvania Senator as President Roosevelt's successor. The occasion was a dinner given by former Representative Joseph C. Sibley of Pennsylvania to the Pennsylvania delegation in Congress.

Knox's candidacy was hailed most enthusiastically by his colleagues in Congress. Representative Burke of Pennsylvania was the first speaker, and his remarks evoked frequent applause. Burke reviewed Knox's public career and pointed out how intimately he was identified with and responsible for the success of many of the great policies that have aided in making the administration of President Roosevelt notable. He also read abstracts from letters written by the President, warmly commending Knox for the part he played in the enforcement of the anti-trust laws.

At the conclusion of Burke's speech Representative John Dalzell of the Pittsburg district made a motion that it be declared the sense of the delegation that Knox should be nominated for President, which was carried with cheers.

When Senator Knox arose to respond the warmth of his reception attested the earnestness of the Pennsylvanians in their intention to urge his nomination. Knox's declaration that the suggestion of his candidacy must rest upon his public career and the wishes of the Republicans of Pennsylvania was heartily applauded.

**WANTS NEW ADMINISTRATOR.**

J. K. Kaelikini, through his attorney, C. F. Peterson, yesterday argued a motion for the appointment of a new administrator of the estate of A. Kauli, deceased, to succeed Albert Waterhouse, the present administrator. Judge De Bolt declined to grant the motion and Waterhouse will continue in charge of the estate.

Attorney Peterson argued that Mr. Waterhouse declined to consider the claims amounting to some \$3000 against the estate, and that as he wished to close up his trusteeship the first of the year, he should be replaced immediately in order that a person who would take up the pending claims might be appointed.

The memorial was adopted by the unanimous vote of the convention, and amid cheers John P. Irish opened the campaign for the repeal of the exclusion act by delivering a ringing speech in which he scored San Francisco and unionism for bringing about conditions "of vast injury to the fruit interests and other industries in the interior of the state."

**DEATH ANSWERS DABNERS PRAYER**

**OFT REPEATED WISH OF AGED FATHER OF GAS PIPE THUG IS GRANTED.**

SAN FRANCISCO, Nov. 30.—The daily prayer of William Dabner, father of Louis Dabner, the gaspipe murderer, that he might die before his son went to the gallows has been answered. He is dead in a hospital.

In the year that has elapsed since the murderer's father induced the confederate of John Siemsen to confess in the hope that he would be leniently dealt with, the old man had grieved broken hearted. At the end he spoke of the son who is in San Quentin prison awaiting execution.

"Thank God, I die before my poor boy," he murmured when he realized he was about to die.

The sentence of death imposed on his son was a terrible shock to the father. It was he who wanted the boy to confess and he always held himself to blame for the death sentence.

Though every effort was made to get his mind off this thought they failed, and the man became almost a monomaniac. That this hastened the end for him is the opinion of his physician and family. Toward the last the dying man said:

"I don't know what to do. I got the boy to plead guilty all the way through thinking that his youth, previous character and the complete domination Siemsen had over him would at least save his life. I am responsible for the fate the courts have sentenced him to."

Two weeks ago the collapse came and Dabner was brought to San Francisco from his home in Petaluma and placed in the care of physicians. His case was hopeless from the first, the doctors said. There was no vitality to combat the cancer that his worry had brought upon him and aggravated daily. Four days ago the family was told that death must come within a few days and the two brothers and two sisters, with their mother, came to San Francisco and remained with Mr. Dabner to the last.

**PRINCE SALMON IN LUCK.**

SAN FRANCISCO, Dec. 12.—Prince A. P. A. Salmon of Tahiti is in luck. When the cases against him were called in Police Judge Cabanis' court yesterday morning Attorney R. P. Troy, representing the Imperial hotel, asked that the case be dismissed, as the prince's indebtedness, amounting to \$98, had been liquidated by a friend. The order was made, and the case in which he is charged with defrauding the Thomas renting company out of \$185 for automobile hire was continued to December 14. It was intimated that the same friend would pay that debt also.

**THE PRISON.**

(Sunday, Dec. 15, 1907.)  
Mr. Ager's address to the prisoners on "Opportunity and Environment" was so simple and direct—so entirely practical that we felt sure the very most ignorant among them could follow his trend. It seems to us that in speaking to men in prison, directness and plainness in presenting a subject is a vital importance in order to reach them spiritually and mentally; for, it must not be forgotten that, in almost every case, their susceptibilities have been dulled and made dormant, as to any true idea of life and right living. Every prison therefore ought to force a reformatory and a help to the man imprisoned. He should come out from his sentence, longer or shorter, a new man resolved on beginning a new life, acceptable to his Heavenly Father and so, to his fellow-men.

That is the way it all looks to us.

**ANXIOUS EYES ON THE RESTORER**

**JAPANESE ANXIOUS TO ENLIST IN CREW OF VESSEL HOPING TO GAIN A LANDING.**

When last the cableship Restorer went from Honolulu to Vancouver, twenty Japanese members of the crew left her and sought their fortunes ashore. She is now preparing to leave on December 28 again for the Canadian port to go on drydock for a cleaning and, if a Japanese crew is taken, the same trick may be played by them upon reaching the coast.

It would appear that some Japanese see in the Restorer a good chance for free passage to the mainland with all its glittering possibilities.

Japanese emigrants to Canada are obliged to have passports to Hawaii from Japan before they can enter Canada from Hawaii and they are, besides, required each to show \$25 to save them from being classed as paupers and excluded; also they must pass a medical examination, but in the case of sailors they find it easy to land and it is possible for those who have no passports from Japan to Hawaii and who have no money to make a landing as sailors and forget to go back to the ship.

Since the last trip of the Restorer to Vancouver, however, the Canadian Pacific port authorities are wiser and another Japanese crew of the Restorer may not be able to affect a landing.

Recently, as published in this paper, the United States took notice of a similar state of affairs in regard to Japanese landing in the United States without passports and without money and shipping commissioners and others were instructed to keep tab on all Japanese signing as sailors and to be sure that they were sailors. The Canadian government is following suit. A genuine sailor may not have any trouble in getting ashore; the trouble is likely to come to him who passes himself as a sailor without any right or experience.

Both sides of the field were just black with a mass of yelling and shouting humanity, and I will never forget the scene at the finish of the game."

"People went mad, hats and canes were thrown in the air, and it was one time that I was glad that I was alive. I went to the Opera in New York and it will be a long time before the scene will be banished from my mind. I never saw such women and such jewels, they were simply gorgeous. Mrs. Vanderbilt told me that the amount of jewels worn represented a fortune amounting to nearly ten million dollars. I have heard of such things before but I never realized that it was so."

"The stores are wonderful in New York, and they are so crowded that I do not understand how any one is able to buy anything. I rode in the subway, the elevated and the street cars, they were so delightful, and I enjoyed every minute of it."

"The tunnel under the East river was completed, but I did not have a chance to see it. I went all over some of the large hotels in New York and I never saw such palaces."

"The New Plaza is, in my opinion, the best in New York, but New Yorkers all say that it will never take the place of the Waldorf. I have only one fault to find with my whole trip, and that is it ended too soon. I am glad to be home again with my children, but I hope that it won't be long before I will be able to make another trip."

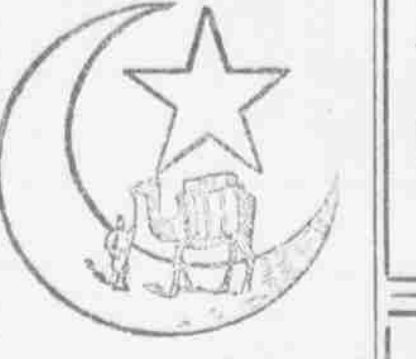
