Supreme Court of the Hawaiian Islands.

CHARLES NOTLEY vs. THOMAS H. DAVIES.

Before Justice G. W. Chapman.

On the 27th day of June 1883 the parties

On the 25th day of June 1883 the parties herein agreed in writing to submit certain disputes between them to the arbitration of P. Bickerton, Cecil Brown and F. M. Hatch...

On the 27th July a majority of the arbitrators made an award which was delivered to the Court, and on the 22nd of October, the Court was moved to make the award to be entered up as a judgment of Court.

The award was made in accordance with the terms of the submission. Mr. Dolé, in behalf of the defendants, objects and moves that the award be set aside on the ground that the award has not been made in accordance with the terms of the submission.

The Court, after hearing the parties, has decided in favor of the award, and the same is hereby affirmed.

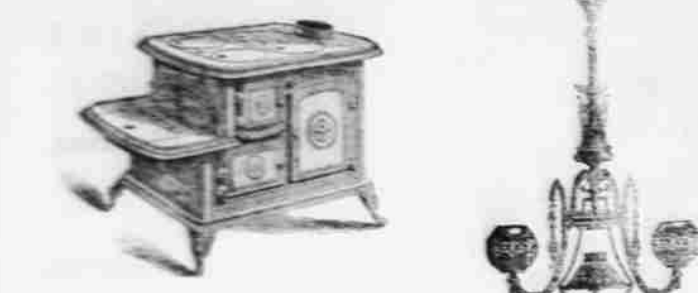
