MAKING GOOD PROGRESS.

While diplomatic measures are always veiled in profound secrecy, and properly so, there is much evidence that the new treaty which Mr. Alexander may take to Washington will secure the favor of the President. In deed, we have it on good authority, that the existence of the new measure is due to the American Secretary of State, who pointed out to Minister Thurston that a treaty of annexation, with certain labor and suffrage adjuncts which did not appear in the first document, would find acceptance with the powers that be. If this turns out to be the case, as we believe it will, annexation cannot be long delayed. Indeed, apart from all the circumstances which go to show that Mr. Cleveland is willing to agree and advise the Senate to agree to this particular treaty, it is difficult to see how the United States can take any other mode than annexation to settle the Hawaiian difficulty. A protectorate might be tried, but as the New York Sun points out, that would be annexation under another name. The one fact is patent that America, if she refused the tender of this group, could not justly prohibit its proffer to some other power; and nobody knows better than Uncle Sam what European domination here would mean to his western coast. This is a case where the United States cannot afford to let the chance of annexation pass. Even if Uncle Sam thinks Hawaii a leak he must eat leeks or run the risk of having to eat something else by and by which will be very much less to his taste.

MERELY A BIT OF HUMOR.

And so it was all a joke. That, at least, is Creighton's laughing apology for the Blount inscription. "The cane was presented by me in a joking way," explains the subtle humorist of the Royal cause, "and received by Colonel Spreckels in the same spirit." How contagiously funny the whole thing was the Queen's jester hardly finds words to say, for fear, no doubt, of bursting the waist bands of Minister Blount and others whose names were made to add point and sparkle to the humor of the jocund event. "Don't think for a moment that I was serious," Creighton might have added. "I was merely parading in my cap and bells." The Royalist Joe Miller further says: "When the news of the 'Murder Society' and the list of doomed men first reached this town it was treated by all the 'victims' as a very good joke. In this spirit four of the prescribed individuals thought that in order to perpetuate the joke and immortalize the stupidity" of the writer who proclaimed to the world "that respectable gentlemen would become assassins because of political differences it would be a good idea to present a cane to Colonel Spreckels by which he would remember the very lame efforts made to terrorize him and prevent him from asserting his ideas and following out the dictates of his conscience." Hear! hear! So then all this fierce invective we have been having in the Bulletin and Holoman against that "Murder Society" is part of the fun? Mr. Creighton's lugubrious remarks to Mr. Spreckels and the ex-Sugar King's white-eyed distress because the good old times when he could walk the streets of Honolulu without fear of assassination were no more—all this was mere persiflage and sport. "I have met the Annexation Club members," said Mr. Spreckels loftily to the assembled donors of the cane "and told them to put their threats into effect, but they have not done so." Still another side splitter! And Bush, too, took part in this screaming farce when he severely denounced the annexationists as men who "dare to threaten to assassinate." Well, well! Humor like this would be quite worthy of Punch. What a pity that the United States Minister, who was made to figure in the scheme of caccination, should fall so far short of a proper appreciation of it. That must be the one distressful memory about the whole carnival of wit. Mem: We imagine the misuse of Mr. Blount's name will turn out to be no joke. Why didn't they cast pearls before Claus Spreckels instead of a cane?

RECOURSE TO FALSEHOOD.

Flounder as they may, the commentators only get deeper in the mire. The Bulletin has the assurance to say this: While it may have been injudicious to have placed the full list on the case, instead of merely the names of the subscribers to the gift, yet the inscription did not indicate that the cane was presented by all those whose names were engraved. Neither the word "by" nor "from," usual in such cases, was employed. Contrast this statement with the words in the inscription which preceded the list of names: "In recognition, from your fellow-citizens disinterested to die." Next but one: ONE of the most revolting features of the flagrant misuse of Mr. Blount's name by Spreckels' Royalist friends, is the fact that it was made by men to whom the Minister has been invariably kind and hospitable. Scarcely a day has passed without seeing some of these people in his doorway. They have been received by him, in spite of their persistent calling, with unwearied courtesy, and their claims upon his time have been granted a measure of consideration which they had every reason to be thankful for. No gentleman could go much farther than Mr. Blount has done to make them feel at home under his roof—and yet this insult! Esop's viper which the husbandman warmed at his hearth was embodied gratitude beside these Royalist serpents who stung the hand that had been so often held out to them in social frankness and confidence.

CHARLES CREIGHTON says that the cane inscription was all a joke. So it was! Charles ought to stand some where near the American legation and hear the hearty hahaha of Mr. Blount. DIGNIFIED, wasn't it, for "Liliuokalani R." to head the guffaw list of Creighton's "jokers."

NEWS FROM THE COAST.

A SHIP ARRIVES WITH LATE DISPATCHES.

Ominous Outlook in Paris—Terrible Effects of a Cyclone—President Cleveland Ill.

The schooner Transit arrived from the coast this morning bringing with her copies of the Examiner of July 7th and 8th. We give below a full abstract of their important contents:

BAD NEWS FROM PARIS.

Ominous Signs of a Gathering Revolution in France. PARIS, July 8, 4 A. M.—There have been repeated conflicts during the night between stubborn mobs on the one hand and the military on the other. The number of wounded was large on both sides. The Place de la Republique presented an appearance which boded ill. A sullen throng gazed through the windows of the Bourse de Travail (Labor Exchange) at the soldiers who occupied it. The Place and Boulevard Magenta were black with people, the crowd numbering not less than 10,000. The boulevard, as far as one could see, was filled with men. The soldiers were still in the barracks.

ERECTING BARRICADES.

Five barricades formed of overturned cabs and omnibuses were erected during the evening at various points in the neighborhood of the Place de la Republique. The most important were in the Place de la Bastille, Rue de Belleville and Boulevard Menilmontant. In the Place de la Bastille an omnibus was burned. The police, backed by cavalry, carried the barricades without difficulty in every case, but used sabers freely. Many revolver shots were fired, and several prisoners had butcher knives. The number of wounded can only be guessed at. The people do not care how many policemen are wounded and the police take care to suppress news of such cases as much as possible. The municipal guards behaved more roughly than they have done yet. They clubbed refractory rioters with muskets and on the Quai de Valmy, by the canal, they charged with fixed bayonets.

OMINOUS MUTTERINGS.

Fears That Paris is on the Eve of Another Revolution.

PARIS, July 7.—The trouble started by a young woman of light morals at a public ball in limited costume has increased so that no man can measure its gravity. Many cans of petroleum were found at a barricade in the Avenue de la Republique Thursday night. The purpose for which they were placed there is evident. Their bearers would not have hesitated to burn Paris. Some of the cans were brought by women, and the city is reminded that "petroleuses" still exist. It is not surprising that many timid people think the city is to see another bloody revolution. After the exhibition of force in the Latin Quarter it was to be expected that disturbances would break out elsewhere as Socialists had mixed in disorderly demonstrations since Monday, but it

TAX OFFICE NOTICE.

THE ROYAL WEDDING.

Marriage of the Duke of York and the Princess May. London, July 6.—The marriage of the Duke of York and Princess May took place to-day. The city was gaily decorated and the streets jammed for hours by a loyal but not enthusiastic throng. The Queen rode in the wedding procession and was heartily cheered. She was escorted by the Life Guards, the Royal Horse artillery, the Central Indian Horse and the Bombay Lancers. At the chapel the service began with a chorale. The responses of the Duke of York were loud and distinct, plainly heard throughout the chapel. Princess May responded in a voice scarcely above a whisper. After the ritual had been said the Archbishop spoke a few words of counsel. He said that one prayer should be that no element of wisdom, charity or righteousness be lacking in their lives. The Queen was the first to congratulate the royal couple. Then the young peoples' parents kissed the bride and felicitated the bridegroom. The return procession was very splendid.

A DEADLY CYCLONE.

Terrible Loss of Life and Property by an Iowa Storm. FORT DODGE, Ia., July 7.—Seventy-four people are dead and one hundred injured as the result of a cyclone which started at Quincy and ended with awful results at Pomeroy last night. At the latter place forty are dead, over a hundred injured and five blocks of residences destroyed. Two hundred families are homeless. An immense amount of damage was done to crops and the path of the storm is strewn with the carcasses of animals.

TELEGRAPHIC NOTES.

Guy de Maupassant is dead. Julia Marlowe, the actress, has married. George Sarlow is recovering from his wounds. A new trial has been granted ex-Cashier Flood. Railroads are cutting down their World's Fair rates. Silver men deny that they will filibuster in the senate. The friends of silver in Congress are confident of success. The West Point cadets will encamp for ten days at the World's Fair. Ex-Governor Evans has been elected President of the Denver road. Dr. Guzman the Nicaraguan minister to Washington has been recalled. The Commissioners report that the Pacific bank at San Francisco is solvent. The Supervisors of Riverside County (Cal.), have passed a prohibition ordinance. Bishop McDonnell, of Brooklyn, has refused to let Dr. McGlynn say mass in his diocese. Justice Blatchford of the Supreme Court of the United States died of paralysis on July 7th. U. S. Naval officers are agitating for a station in the South Pacific. Secretary Herbert is favorable. Admiral Gherardi's voyage from San Francisco to New York cost the Government \$100,000 for coal. President Cleveland is ill of rheumatism at Buzzard's bay where Mrs. Cleveland is about to be confined. The murderer of the Ray sisters near Cairo, Ill., if caught by the mob in pursuit of him will be burned at the stake. President Cleveland's physician denies that he is seriously ill. He denies a prevalent story of a cancerous growth in his patient's mouth.

WORLD'S FAIR LETTER

More interesting incidents were crowded into last week than into any similar number of days in the history of the great Exposition. The Princess Eulalia snatched every possible moment to enjoy the feast prepared, and was the center of attraction wherever she appeared. Nebraska, Indiana and Massachusetts dedicated their beautiful buildings to the pride of their sons and daughters, and to the pleasure of thousands upon thousands not natives of those States, while governors, military men and State officials seemed almost omnipresent. "German day" was a fete day of almost national importance, coming also upon the anniversary of the accession of young Emperor William to the throne, and the attendance upon that Thursday was over 196,000. The new terminal station in the grounds was used for the first time and proved to be all that was expected of that beautiful and useful building.

Notwithstanding the fact that nearly everything in the Government building was brought here from Washington, yet its contents appear to have a strong attraction to the average visitor. The gem of the entire building is the rotunda. Its mural decorations are among the finest to be seen upon the grounds, as immediately beneath the dome are views of various cities of the United States, representing familiar spots. Below this are large allegorical pictures, which artists affirm are not equaled in this country, with a possible exception at Washington. In the center of the rotunda is a section of a mammoth red-wood tree, called the "General Noble." This tree was originally three hundred feet high, with a circumference at the base of nearly eighty-five feet and a diameter of twenty-six feet. The mere cost of transportation and setting up of this section was \$10,475.87, and a steady stream of visitors pours in and out the opening at the base.

In the Postoffice Department the transition from the crude and clumsy methods of handling and transporting the mail to the present wonderfully expedient treatment, is shown in the dog team and horse pannier method contrasted with the complete post office on wheels. An old-time Rocky Mountain mail stage-coach is seen, bearing still the marks of bullets in dangerous encounters with the Indians. Presidents Garfield and Arthur, General Sherman and other notables have ridden over the mountains upon its leathern springs, and General Howard only succeeded in recapturing it from the Indians after a bloody struggle.

The Patent Office shows modern and ancient plows used in Japan, Java, Mexico, China and other countries, strangely contrasting with the beautiful specimen of an American plow of light construction and handsomely nicked. A thousand and one intricate machines are in glass cases, showing how perfection was reached by ingenious inventors through years of study and patient work.

In the War Department machines are briskly running, turning rifle and gun stocks, filling cartridges, boring barrels, etc., while all about the room are dummy figures dressed in the uniform of the officers and men in every department of the service. Many of them are so lifelike as to deceive even the very cleverest of our artists. Horses and army mules, attached to the various vehicles in use in the army, are patted and stroked as if indeed they were living specimens. Here also are weapons taken from different battlefields, and torn, shattered and penetrated with bullets, many of them showing the leaden missiles still embedded in the piece. A submarine torpedo, twenty-five feet long, and controlled by electricity, is an object of wonderment to many; and the many curious questions as to this somewhat experimental destructive in modern warfare. But perhaps the objects that attract the most attention are the two missiles which center around the firing upon Fort Sumter, the identical ball which was first fired into the fort, as well as the one that was returned. A nation's history turned upon these two cold pieces of metal, and veteran and civilian view with noticeable reverence these tangible evidences of "the shot that was heard around the world."

A large crowd is always gathered around a polar scene, representing that gallant American explorer, General Greely, and his comrades, Lockwood and Brainard, unfurling the Stars and Stripes at their nearest point to the North Pole. The Eskimo driver, with his sledge and dogs, are seen, while in the distance the hut of the exploring party is described. White crags and glistening snow are all about them, and the visitor is almost deceived into believing that the scene he is gazing upon is actually real. This is one of the largest "set pieces" in the entire Exposition, and is a marvel of reality.

The Smithsonian Institute has also sent its choicest treasures, the birds and animals being not only triumphs in the art of taxidermy, but also some of the rarest specimens that the world produces. From the tiny microscopic insect of the air to the rapidly disappearing buffalo, all are viewed with interest and pleasure.

The attendance in the park in the evening is not appreciably less than during the day, though the buildings are comparatively deserted, the visitors evidently preferring to drink in the beauties of the scene without. An adequate description of the magnificence of the illuminations, especially when the pyrotechnic display is added, is almost impossible, and the writers for the local papers have wrestled in vain with the subject to do it justice.

It is, indeed, the idealizing of the real to a marvelous degree, science and art having combined to make a Paradise of earth.

TELEPHONIC JOURNALISM.

The Alleged Editor in Buda-Pest Who Spouts the News to His Subscribers

BUDA-PEST, July 1.—The capital of Hungary, where I am now spending a few days, has distinguished itself among the cities of the globe by establishing a telephonic newspaper, which has now been in existence some months, and is extending its plans and hopes. The *Oriental Review* of this city for April 30 gives a long account of what this novel enterprise has done and may do, which I am sure will interest my readers. The whole city of 500,000 people—as large as Boston (and, I may add, quite as handsome and better served with street railways), is divided into eight sections for the purposes of this telephonic editor, and each of the sections has one conducting wire. The apparatus in each house occupies a space of about five inches square and has two tubes, so that two members of the family can get the news at once. The whole cost of putting it in is \$6, and each subscriber pays a rate of sixty cents a month for the special newspaper service.

The news collector does his work in the night, as elsewhere, and at 9 A. M. he takes his post in the central station and begins to tell his story "in a telegraphic style, summary and precise, avoiding everything superfluous." At the end of five minutes, fearing lest some of his subscribers might not have heard everything, he repeats his budget of news, word for word—mostly concerning some events and news of Hungary. At 10 o'clock he issues another edition, this time of foreign news. At 11 o'clock he lets us know that the Hungarian Parliament is in session, and may mention what is being debated. But word may also come of a riot, and by noon the alarmed subscriber may hear that the populace have attacked the police and have been fired upon; this, we will say, causes stocks to fall 5 per cent. Immediately the wise subscriber rushes to his own telephone and gives his broker an order to buy. At 2 o'clock the central editor rings furiously and reports a violent debate in Parliament, which leads to a change of the Ministry. At 3 o'clock there is a fire in a building of which the subscriber is part owner—and so it goes on.

"All this news," says my author, "is related in a sonorous voice, easily understood—and, as there is only one wire, the subscriber is not vexed with the hubbub of twenty voices trying to use the same wire at once. Still, it is a little fatiguing to get your news in such slices instead of having it all in your hand at once. So (I continue to quote), at 6 o'clock he can take a rest (that is, the subscriber can), and madame, his wife, comes forward to hear the report of a lecture at the Academy; perhaps the repetition, with all due emphasis, of a new poem. At 7 o'clock the young ladies listen to a concert through the *Telephonic Gazette*; they can distinguish wonderfully well the touching pathos of the violin-cello, the pearly staccatos of the violin, the sweet melodies of the flute, and the enchanting voice of the prima donna. What could be more delightful and convenient?"

All this, I am assured, is daily going on in Buda-Pest. Nay, more, "by the aid of a single wire of the State telegraph line, our central station has been connected simultaneously with the telephone stations of Vienna, Graz, Brunn, and Trieste; and in all those cities the voice of the *Gazette's* editor has been heard—clear, sonorous and with every shade of intonation.—F. B. Sanborn in the *Boston Daily Advertiser*.

KNOX HAD SAND.

A Gambler Who Gave His Life to Save His Wife and Baby.

A company of ranchmen sat about the railroad station in Pomona the other afternoon waiting for the belated overland train for Los Angeles. Every man in the party knew the others, and there being an hour or two to wait, story telling of the early days on the border and in Arizona and California came natural. Stories of old times, when Indians were bad and the white pioneers knew what bravery meant, were related. John Wilson of El Monte told the most absorbing story of the hour:

"Talk about sand in a man, gentlemen! I am telling you that it takes sand of the genuine article in any man to try and stand off single-handed forty or fifty Apaches, when he knows just how the scrap will end, and that the end will be his own death. But that was just the kind of sand that was in Felix Knox when he was killed by the Apaches. You see Knox was an all-round gambler such as the tenderfoot from the East scorns so much and knows so little about, but he had a heart in him bigger than any tenderfoot's head. Well, it was in the spring of '79, Knox, with his wife and baby and a Mexican driver, was coming

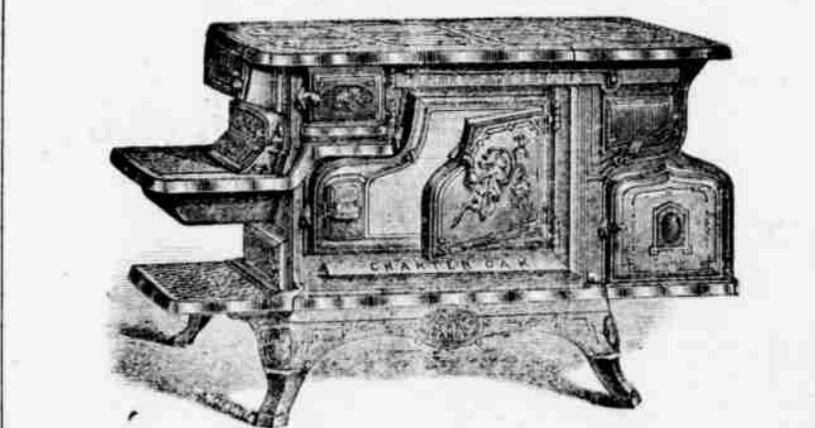

LEPROSY BY VACCINATION

CAN IT BE COMMUNICATED BY THIS MEANS?

Arm-to-Arm Vaccination Has Been Long Out of Date in Honolulu—The Vaccine Farm.

In a recent conversation between one of the leading physicians of this city and a representative of the Star the subject of the communicability of leprosy by means of vaccination formed the principal topic, which incidentally led to mention of the prospects of the vaccine farm. From information obtained from various sources it may safely be asserted there was more or less carelessness in vaccinating years ago, at a time when arm-to-arm vaccination had to be resorted to owing to difficulty in obtaining bovine virus, and in isolated instances from the unscrupulous character of some of the so-called Government physicians who cared more for the dollar fee than for the health of their patients and would vaccinate with any kind of virus, so long as they got the fee. But it is to the credit of the medical profession in these islands that instances of this kind have been very rare.

That leprosy can be communicated by means of vaccination there can be but little doubt in the light of recent medical reports from India and other places where the disease exists, and also from the recorded experiences of physicians here, but authenticated instances are extremely rare. In nine cases out of ten where vaccination is given as the cause of leprosy a full investigation will show that the dread disease was communicated by other means or inherited. The following extract from a paper on this subject, written by a physician of high repute and many years' experience with the disease, will prove interesting reading:

VACCINATION IN HONOLULU.

With us here in Hawaii, the first desideratum in vaccination is absolute surgical cleanliness of instrument and virus, freedom from all possibility or suspicion of syphilis, leprosy, or any such thing. The next desideratum is activity or availability of virus—virus that will take. The very last consideration is speed of operation.

When I explain that this order of motives and of painstaking is made necessary by the fact that our community is made up of exceedingly heterogeneous elements, and that leprosy and syphilis are not unknown to us as at all times prevalent disorders, do not misunderstand me to say that we are plague-stricken with these diseases.

THE NEW HOTEL.

It Has Space, Shade, Quiet, Elegance, Good Cheer and a Fine View.

To those who know how ample and convenient is the party house on upper Naunau street, how large and beautiful its grounds and how wide and generous its view, the announcement of Mr. Friemann that he has opened it as a hotel will be hailed with satisfaction. If there are any who have not yet made personal acquaintance with the charming spot they should not fail in doing so, particularly as Mr. Friemann is willing to take them there and back in his hotel carriage. The new hotel will be called "The Portland," after the city in which its manager made so fine a success as a restaurateur. Speaking of the Portland it is well to add that the staff of the hotel will be drawn from there, a French chef and a corps of white waiters being now on their way. We have reason to believe from this fact that the menu of Mr. Friemann's table will soon make his resort famous and popular with all lovers of good cheer. Conducted as it will be, "The Portland" is bound to score a fine success.

FIFTY THOUSAND DOLLARS.

E. C. Crick Sues Marshal Hitchcock for That Amount.

E. C. Crick, by his attorneys, A. P. Peterson and Charles Creighton, has brought suit against Marshal Hitchcock for the sum of \$50,000 "for damages resulting to him in that the defendant falsely and maliciously, and without reasonable or probable cause, appeared before the District Magistrate of said Honolulu on to-wit, the 23d day of June, 1893, and charged the plaintiff with having committed the felony of conspiracy, etc." Service of summons was returned yesterday.

District Court Notes.

Dr. Gilbert Foote, charged with furious and heedless driving, was found not guilty.

James Pickett, for assault and battery on a native, was fined \$10.

W. H. Lentz plead guilty to being drunk and was fined \$6.

The opium case of Ah Kui went over till to-morrow, and Moolita, for assault and battery, will be tried on Monday. The cases against Kalaula and Ah Hoy were dismissed by the prosecution.

Committed for Perjury.

The preliminary examination of Pon Giu alias Pan Chau, on a charge of perjury committed in the trial of the Provisional Government vs. Yee Nui, resulted in the commitment of the defendant for trial at the Circuit Court. Bail was fixed at \$250, by consent of counsel.

CLOSING DAYS OF SCHOOL.

EXERCISES AT TWO LOCAL INSTITUTIONS.

Commencement Programs of Iolani College and the Royal School Carried Out.

The school year at Iolani college came to an end yesterday with interesting exercises. A fine program of music and recitations was carried out and many of the lads distinguished themselves in declamation. Prizes were awarded as follows:

First class—First in examination, Wong C. Ah Fook; school work, Geo. W. Clark; conduct, Kong Yin Tet. Second class—Examination, Alex. May; school work and conduct, Harry Ah Heen; arithmetic, Sam Lin.

ARRIVAL OF THE TRANSIT AND THE LADSTOCK.

Steamer Kinau Leaves for Hawaii—Iwalani From Kauai—C. R. Bishop From Windward.

The American schooner Transit, Captain Jorgenson, docked at Brewer's wharf at 11 o'clock this morning, thirty days from San Francisco. The captain reports an excellent voyage and pleasant weather all the way. The Transit brings a miscellaneous cargo of merchandise for local merchants.

The British bark Ladstock, Captain Williams, docked at Brewer's at 9 o'clock this morning, 119 days from Liverpool. The captain reports sighting an iceberg off Cape Horn, but save this single incident, nothing special is logged. The Ladstock comes consigned to T. H. Davies & Co. with a cargo of general merchandise.

The Hawaiian bark Mauna Ala left San Francisco two days before the departure of the schooner Transit, and the bark R. P. Rithet was expected to leave on the day following.

The bark Andrew Welch is completing her cargo of sugar at the O. R. & L. Co. dock.

A hand pump has been erected on the esplanade near Likieke wharf, and sea water is now used for sprinkling purposes in the market and of the city.

The steamer Warrimoo to-night. The steamer Kinau took a lot of freight and passengers windward this afternoon.

The W. H. Tabot is taking sugar from the Iwalani.

CHARGED WITH ROBBERY.

Three Chinese, named Chong Mui, Wong Chow and J. L. Xavier, were arrested this morning and charged with robbing the trunk of a Chinese woman of \$120 in cash and a lot of jewelry. These men are "informers," and the Chinese woman says the robbery was committed about the time the police were searching the premises for opium. The testimony in the case bids fair to be quite interesting.

from Silver City to Clifton, down in Arizona.
