ERUPTION NEAR MAUNA LOA'S TOP

The Honolulu Star-Bulletin yesterday afternoon published the following special wireless from the island of Hawaii concerning the outbreak on Mauna Loa:

Hilo, Hawaii, May 22—Mauna Loa has broken out in eruption again.

At 11 o'clock last night, 7000 feet up the lofty mountain, a lava flow broke out on the Kahuku side and is already three miles down the slope.

The flow is cutting a path between the flows of 1868 and 1887, and making its way toward Kau, the lava traveling in a southwest direction.

Last night newspapers could be read in Kau and Kona by the reflection on the sky.

Prof. T. A. Jaggard, director of the observatory at Kilauea, and Prof. H. O. Wood, his assistant, went over to Kau early today to locate the height of the outbreak. They will establish headquarters at Waiohinu.

All indications point to the first explosion higher up being a vast jet of steam and smoke released when the mountain side lower down broke open. There is no sign of activity from higher up now. All interest centers in the outbreak at the 7000 foot level.

Two flows are now reported, the lava stream having forked. It is coming at the rate of one mile an hour and should reach the government road by dark tonight. It will strike the road about four or five miles on the Kona side of the Kahuku ranch gate.

Waimea Men Drill

Companies L and M Fourth Infantry, Waimea, stole a march on the official program Sunday and had a battalion drill of their own. They went over to Kekaha where there was plenty of room for maneuvers and, with Captain Crowell acting as major, went through many battalion movements. The idea, as explained by Captains Crowell and Oliver, was to "practice up" before the regular battalion drill comes on.

Before the drill the baseball teams of Companies L and M went to it for eight lively innings, the former winning by a score of 9 to 4.

June 11 Boosters

Secretary Raymond C. Brown, of the Honolulu Chamber of Commerce, and Arthur Wall, of the Hawaii Promotion Committee, arrived on Kauai Friday morning for the purpose of interesting local people in the events of June 10-12, the idea being to line-up as many people as possible for the excursion to Honolulu at that time. The gentlemen went first to the Waimea side of the island, interviewing most of the prominent people, and the following day (Saturday) made a like trip to Hanalei. Encouragement was met with at every hand and the visitors left feeling certain that both excursion steamers will be filled to the guard rails.

A Military Paper

The Advertiser (Honolulu) of last Sunday contained several pages of interesting data and pictures of National Guard regiments and the U. S. army posts. Among other features is a writeup of the Fourth Infantry (Kauai) by Miss Ommanney, with pictures of officers of the regiment and also of luau scenes at the Lawai beach house.

SPALDING'S CUP AGAIN OFFERED

A writer in the Honolulu Advertiser is authority for the statement that Colonel Spalding, of Kealia, will put up the fine racing cup won by one of his horses on the track some years ago, to be competed for again. The paper says:

Word comes from Colonel Spalding, Kealia, Kauai, that he would be glad to offer a trophy in his possession, known as the President's Cup, for competition at a meeting held under the auspices of the Hawaii Polo & Racing Association. The President's Cup was won by Duke of Norfolk, June 11, 1896, in a mile and a half race run at Kapiolani Park, in 2:46 2-5. The cup was presented by Judge Widemann when president of the Hawaii Jockey Club. Col Spalding suggests that the cup be given annually for a mile and a half race for Hawaiian-breds, in addition to a purse, the cup to pass from winning to winner of the race only when the previous best time be beaten.

C. J. Spalding, than whom there is no better lover or keener judge of the thoroughbred in these islands, writes that he values the trophy greatly, and that he wouldn't take \$1000 for it. Also he objects to the cup becoming "a Jockey Club ornament," or to have it won in a single race. "It represents," writes the staunch old sportsman, "the triumph of a horse raised by me, and on the old time track the time made by him is not bad." He concludes, characteristically: "You may have faster runner than the Duke in Hawaii today, but you have no better horse." Duke of Norfolk was by Kealia out of Rosita, the pedigrees of both of which animals Col. Spalding has for 20 generations.

Military observers believe that the Turks cannot hold their positions much longer in Mesopotamia and must fall back for safety.

The food shortage in Great Britain is now alarming. Farmers are warned that they must abandon their prejudices and employ woman labor in the fields where necessary.

Germans Lose Positions

The Germans lose their footholds at Douaumont. The French drive them from their coveted positions which they have held for months.

Down In Mexico

Washington—A Carranza chief has sought to bull-doze Major Howze. He demanded that the American cavalry surrender property taken from the Villa bandits and retreat towards the border at once. Both ultimatums were promptly refused.

The war department has notified Colonel Sibley and Major Langhorne that their campaign is ended and orders them to return.

Berlin—The Austrians are sweeping the Italians off their feet everywhere in the southern zone of warfare the Teutons are driving the Italians back. The Italians seem unable to stem the wave. The Germans are making gains in the Tyrol.

Washington—President Wilson is satisfied with the new army bill. He tells Senator Chamberlain that the measure in general is good.

The students of the Kauai High and Grammar School are to give a play on Saturday evening, June 10th. Arrangements are being made for special stage settings, and a creditable performance may be expected. Already the cast has shown real talent and is fast developing.

The proceeds of the play will be used for the benefit of the High School library, playground, etc. It is not the aim to raise a large sum of money, but to give an evening of wholesome entertainment at a reasonable price, and to interest the people of Kauai in the work of the school. This is the first time the High School has asked for support, and it hopes to give an equivalent in entertainment for every dollar invested.

Mr. Milliken To Leave

Rev. C. D. Milliken has accepted a call to a church at Piedmont, across the Bay from San Francisco, and will shortly leave for his new post. People of Kauai [particularly of the Waimea section] will regret to learn of this, as Mr. Milliken had come to be regarded as an important factor in local community activities.

The Matson steamer Hilonian arrived at Port Allen Saturday morning, bringing 760 tons of Coast freight for merchants in the neighborhood. She sailed again at noon yesterday for Kahului, taking 29,500 bags of sugar, 5,025 cases of pineapples and 47 sacks of copra.

The Lihue Union Sunda School enjoyed one of their occasional picnic outings on Friday afternoon last, with the usual attractions in the way of children's games, refreshments, etc., much to the satisfaction and delight of the youngsters and their parents, many of whom were in attendance.

HARVARD STUDENTS HEAD COLLEGES IN "PREPAREDNESS" MOVEMENT—UNIVERSITY STUDENTS DRILLING OUTDOORS FOR FIRST TIME.

Harvard University was among the first of the colleges to form a company of students into a semi-military body. Since its incorporation the members have devoted much of their spare time drilling and going through maneuvers, preparing for any emergency in which their training and knowledge may be of service. Hitherto, the students have been compelled to go through their exercises indoors, but now drill on the campus. This photo shows them in their first drill held outdoors. Many of the colleges throughout the United States have organized similar "preparedness" corps and the movement is taking fast hold not only of universities but also of public and private schools.

CIVIC MEET SURE TO BE A SUCCESS

In Hilo next September there will be an exhibition of live stock that will open the eyes of the anchors of these islands. The cattle, horses and mules that will be stalled at the county fair, which is to be held on Kuhio wharf, will be the best ever gathered in the Hawaiian Islands.

Besides the cattle there will be exhibits of other animals, birds, fruit, vegetables and a thousand and one articles that will astound those people who imagine that everything has to be imported from the mainland. Even babies will be "benched" and the proud mothers will be on hand to take issue with everyone who thinks that her mite is not the best in the show.

The Second Hawaii County Fair is to be held in Hilo on September 22-23, and it promises to be even a greater success than the fair of 1914. Everything points to a big exhibition and everyone in the county seems to be impressed with the importance of the fair. Exhibits are coming in from nearly every section of the county and some wonderful products in the way of vegetables, fruits and live stock are promised. The school exhibits will also be fine as the teachers and pupils are working hard on that section right now.

Dr. H. B. Elliot, chairman of the fair committee, feels even more sanguine than ever about the success of the fair. The promise of exhibits and the manner in which prizes are coming in, point to the show being even better than the first one.

Director William McKay of the Fifth Civic Convention is leaving no grass growing under his feet and he is working on several propositions in connection with the convention and they will be announced in due course.

The convention is bound to be a huge success. All the invitations sent out to the various civic organizations of the territory have been accepted and that means that a big crowd of delegates will attend the convention. That two special steamers will be required to bring the Kanai, Oahu and Maui people to Hilo seems certain. All the visitors will have the time of their lives in the way of entertainments at the expense of the Hilo people and the Big Island hopes to see everyone who possibly can make the trip in Hilo next September.

KAUAI JAPANESE HAS MISFORTUNE

Under peculiar and pathetic circumstances Yoshigoro Matsunaga, a very sick Japanese from Kauai, lost \$120 yesterday just as he went aboard the Seattle Maru, intending to return to his home country.

Matsunaga himself was penniless; the money was the remnant of \$200 which had been raised by his friends in Kauai for the expense of his journey and medical treatment, the other portion going for his steamship fare, poll tax and incidentals preliminary to the journey.

He had been accompanied from Kauai by an intimate friend, Nakagawa, who attended to his personal needs and business arrangements, and carried the funds. When the two were on the pier and Nakagawa was making payment of the tax money a Filipino hovered near, and accompanied them aboard the vessel. When the time approached for Nakagawa's departure and he prepared to hand the remaining \$120 over to the sick man he discovered that his purse had disappeared.

A volunteer Japanese detective was summoned and the suspected Filipino was searched, but without success, for his pockets likewise were empty.

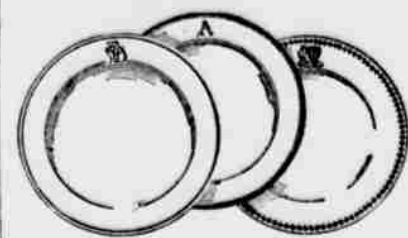

ISLANDS AFFAIRS IN WASHINGTON

(Special Washington correspondence of THE GARDEN ISLAND.)

Washington, D. C., May 4—The Senate Committee on Commerce has decided to include in the rivers and harbors bill an item appropriating \$100,000 to build the west breakwater in Kahului harbor, Maui. A cost limit of \$250,000 is provided, this being the estimated cost of the completed project. It is believed that the item will be opposed when the bill comes back to the House, but probably will be retained in the measure as it finally becomes a law.

Friends of the Nawiliwili harbor project do not anticipate obtaining an appropriation in the present bill. The fact that it is an entirely new project and involves an expenditure of over a million dollars operates against the project.

HONOLULU HARBOR

The Acting Secretary of the Treasury to-day transmitted a letter to the Speaker of the House urging the appropriation of \$32,000, for removing and re-erecting the wharf at the Honolulu quarantine station. In calling attention to the matter, the assistant secretary states that the War Department has a contract for dredging in Honolulu harbor which includes that portion of the harbor in the neighborhood of the quarantine station wharf, and if there should be undue delay in the removal of the wharf, the holder of the dredging contract may have a claim against the Government for damages.

STUART AND SHAFROTH

Judge Stuart has again sent his resignation to Senator Shafroth and the Senator, for the second time, has declined to send the resignation to the President. Senator Shafroth does not care to be mixed up in Hawaiian controversies and, therefore, if Judge Stuart's resignation reaches the President, it will have to be through some other agency.

NATIONAL PARK BILL

The Senate Committee on Pacific Islands has reported favorably to the Senate on the bill, which has passed the House, providing for the establishment of a National Park in Hawaii, and it is believed that the measure will pass the Senate at an early day.

ROOSEVELT BOOST REACHES KAUAI

By a mail last week Kauai was flooded with a pamphlet bearing the legend "Lest we forget his record," with a picture of Mr. Roosevelt beneath. The pamphlet itself is stamped "Compliments of George R. Carter", although it appears to have been mailed at Boston, Mass. It contains newspaper clippings bearing upon the presidential history of Roosevelt and the following, which it characterizes as "31 notable achievements of Theodore Roosevelt's administration"

1. Negotiating twenty-four treaties of general arbitration.
2. Navy nearly doubled in tonnage and greatly increased in efficiency.
3. Bringing about the settlement of the Russo-Japanese War by the Treaty of Portsmouth.
4. Battle-ship fleet sent around the world.
5. Avoiding the pitfalls created by Pacific Coast prejudice against Japanese immigration.
6. State militia brought into coordination with army.
7. Keeping the door of China open to American commerce.
8. Reorganization of the Consular service.

The June 11 Program

As we understand the matter the idea behind the program to be held on at Honolulu June 10-12 is to revive in a measure the past glory of Kamehameha Day.

There are doubtless those among us who feel that we have enough holidays as it is. But as a matter of fact, have we? Do we give enough time to fairs and programs that are essentially for the amusement and entertainment of the public? Perhaps we do not, and if we did we would add much to our own pleasure in living and entertainment the enjoyment experienced by the visitor to our shores.

If we are correctly informed, there is nothing in this move to reintroduce the sports and festivities of the former "June 11" that would detract from the February carnival which has been so successfully built up at Honolulu. If such there was we would hesitate with our hesitations; but we can plainly see that there is room and occasion and opportunity for both.

All old residents will remember the time distinctly when "June 11", as it was called, was the greatest holiday occasion of the year. At Honolulu it was given over largely to horse racing—the sport of Kings; which throngs of people from the islands attended and enjoyed. It was the experience of years that the weather at that period was ideal for outdoor sports, and favorable circumstances generally seemed to surround the day.

Restore "June 11"? Why, surely. For many decades it has been the one distinctly Hawaiian holiday, and we want to see its just glory returned to it.

We hope that Kauai people will bear in mind this effort to reconstitute the interest that formerly clung to Kamehameha Day, and will help to limit the two excursion steamers that will leave our ports for the June 10-12 program in the city.

Larger Hotel Needed

If there ever was a place in need of larger hotel accommodations, that place is Waimea, Kauai, Territory of Hawaii.

There is a very excellent little hotel there now. It is so good, in fact, that it is full of boarders all the time and there is on an average a room for only six transients. Every steamer "swamps" the hotel, and even over-Sunday callers from other Kauai towns start Manager "Dick" Oliver off around the place in search of bunks at private houses for his overflow of customers.

Only a few mornings ago several passengers landed at Nawiliwili and went overland to Waimea. Arriving there at about 4 o'clock in the morning, tired and wanting good, soft beds most of all else in this world, they found the place already filled to its capacity. There wasn't a room nor a bed nor a cot nor even a sofa to be had for love nor money. Manager Oliver fished up some mattresses from somewhere and finally accommodated his tired guests on the floor of the verandah, with its dampness, cold morning air and mosquitoes.

This is a serious matter and something should be done to remedy it. It is giving Kauai almost as black an eye as the nickel-in-the-slot scheme of the local telephone company. Waimea should have a new and greatly enlarged hotel, and it cannot come too soon.

The Waste Of Homesteads

One of the ever present problems in Hawaii is that surrounding the ultimate disposal of the government lands—lands belonging to the people. Year after year these lands have dwindled. Until a few years ago most of the land taken up by homesteaders quickly passed into the hands of one of the sugar plantations, if the land was cane land, and under present conditions only cane land is of any permanent agricultural value outside of the Kona district. Recently a law has been placed in the Organic Act which prohibits the sale of any homestead land to anyone already holding more than eighty acres of land. Yet this clause has not prevented certain men on the island of Oahu from securing many valuable tracts of land, nor others from acquiring land which they desire and are willing to pay for.

There are a number of thinking men in the Territory who believe that it might be better for the Territory to hold the land it has now, except in special cases where there is a good chance for small farming to be made a success, and lease this land to the sugar plantations at such a price that it will bring into the treasury of the Territory a continuous revenue, which could be spent upon permanent public improvements. In this way all the people would derive some benefit from these lands.

At the present there seems little opportunity for the small farmer to make more than a living, even if he be able to keep out of debt. There are already a considerable number of homestead farms growing fine crops of weeds on this island. It is a waste of land, a waste of revenue and a waste of effort to open more homesteads without some guarantee that they will be actually farmed successfully by the farmers themselves. This renting to sugar plantations, which do all the work, is not homesteading.—Hilo Tribune.

THE FOURTH INFANTRY can undoubtedly be depended upon to make a great day of July Fourth in Lihue. It seems to us, however, that military features and sports will leave a notable blank in the program. Without the reading of the Declaration of Independence, the singing of a few national hymns and one good, patriotic address it will not seem fully up to the mark of a Fourth of July celebration. It seems to us that the day should be given all the frills that properly belong to it.

THE HONOLULU PAPERS are publishing more or less boastfully tables indicating the very large dividends which may be paid by the plantations this year. We question the wisdom of this, coming as it does on the heels of a campaign for tariff in order that the sugar business might exist at all. Dividends to be paid this year will come as the direct result of the war, a cause which is temporary at best; and to our mind the least said about them in the public prints the better.

LORD CASEMENT now claims that he was insane when he shipped arms into Ireland with which to start a revolution. Napoleon, we assume, had a streak of the same thing when he started out to kill a few of his country's neighbors.

IF THE REPORT be true that Hughes will not accept the nomination unless given the unanimous endorsement of the convention, Roosevelt is already practically nominated as the Republican standard bearer in the coming election.

THE BATTALION parades and inspections planned by Colonel Broadbent will give the Kauai public a chance to witness maneuvers by larger bodies of our citizen soldiery. This is a step toward the regimental review which will take place July Fourth.

FORD CARS are reputed to be able to stand some pretty tough roads, but it is no joke to say that Henry Ford will find the road of politics impossible going.

THE FOURTH INFANTRY will require a United States flag and regimental colors. This is a tip for the ladies of Kauai.

IT WOULD APPEAR that the Root boom has climbed the tree and fizzled out at the top.

NO MAN'S JUDGMENT about the safety of Nuuanu dam is worth a shriveled fig. Anyhow, the question is not properly up for argument. The reservoir behind the dam is the sore point. A large reservoir should never have been built in Nuuanu valley and should be done away with as quickly as possible. Numerous small reservoirs might serve the purpose and prove safe; but any large reservoir project, if absolutely necessary, should be located at the Koolau side of the Pali, the water being piped through from there to Honolulu.

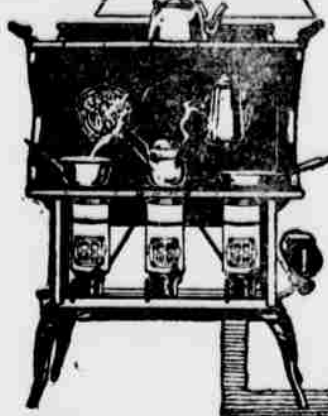

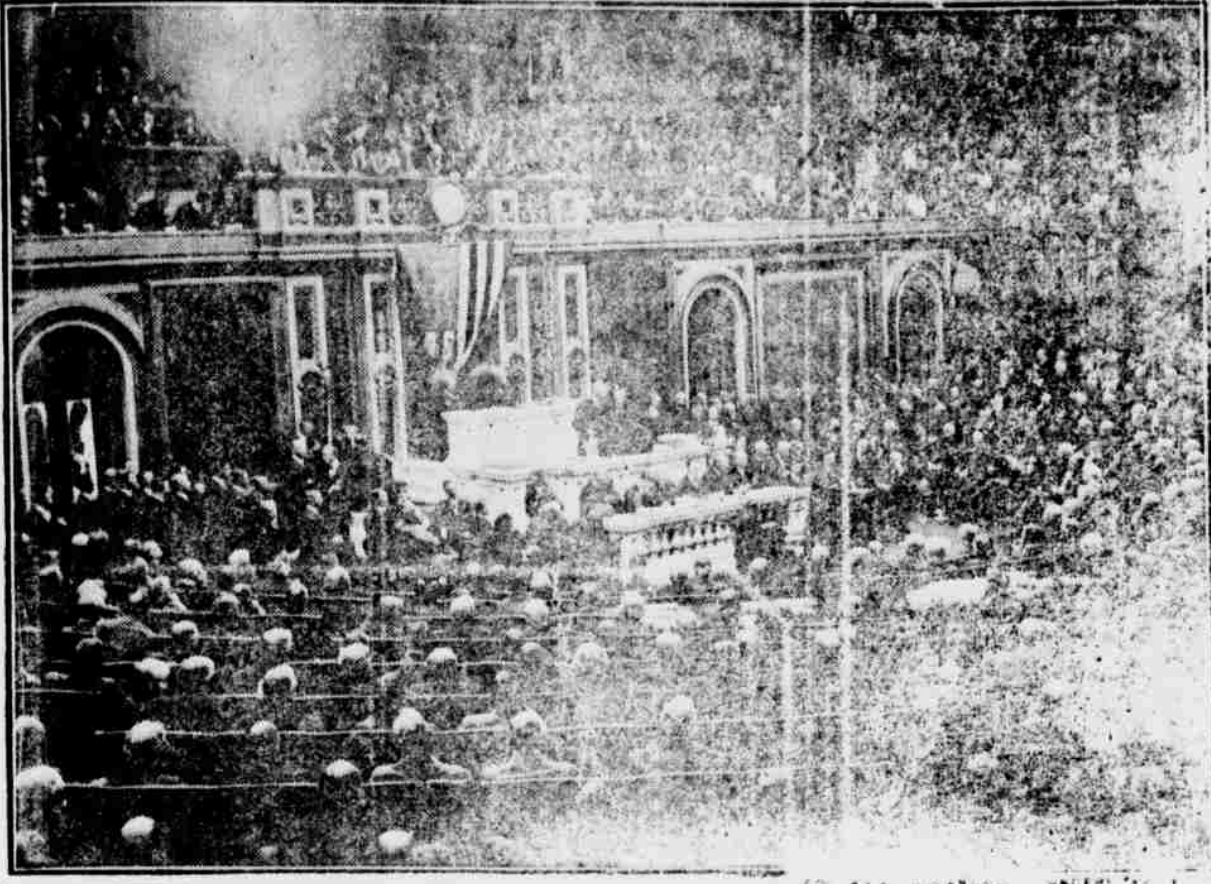

Brandeis Has One Majority

Washington—The Judiciary Committee favors Brandeis for the Supreme court. The Boston lawyer, who has been appointed to the supreme bench by President Wilson, has one vote majority for confirmation.

Santo Domingo To Be Quieted

Washington—The troubles in Santo Domingo will be subdued. Admiral Caperton has been instructed to so distribute his sailors and marines as to secure complete quiet.

Suffrage For Filipino Women

The amendment proposed by Representative Mann, granting suffrage to Filipino women, has passed the House.

Mining Properties Looted

El Paso—American and other foreign owned mining properties in Cuatroce have been looted.

Vessels Sunk At Sea

London—Lloyd's agency announced last night that the Greek steamer Anastasios Coroneos, French steamer Languedoc and Italian bark Erminia have been sunk at sea.

Monday Afternoon

London—German and Russian warships are believed to be battling in the Baltic Sea. Heavy cannonading at sea is heard at points along the Swedish coast, according to despatches from Sweden today.

A Copenhagen despatch says that the German steamship Worms, bound from Sweden for Germany, is reported to have been sunk. The Swedish steamer Rosalind struck a mine near Stockholm and sunk. No casualties resulted.

Verdun Fighting Continues

Paris—The Verdun battle goes into its fourth month and its intensity seems to increase. In the region around Dead Man's Hill the fighting is now something awful.

The French have captured several blockhouses from the Germans in Avocourt and trenches in the outskirts of Vaux. The Germans have been repulsed.

Austrians Still Progressing

Berlin—The Austrians have met with further successes on the Italian lines. They have made further progress in Tyrol, carrying Armentera peak and occupying additional villages; and in the past few days have captured more than 3,000 Italians.

The U. S. and Britain

Washington—The United States stands firm on the matter of interruption of the mails at sea. A new note to Britain on the subject has been completed and is now before the President for revision.

Lynch Not To Die

Ambassador Walter Hines Page cabled from London today that the death sentence of Jerry Lynch had been commuted to ten years in prison.

German Artillery Active

Berlin—German artillery is very active on several fronts. Official reports tell of nine enemy machines shot down in the last two days.

Companies Would Dodge Taxes

Honolulu—Sixteen sugar companies have decided to contest their Territorial assessments for taxes. Letters received by the department protest against valuations totalling over sixteen millions dollars. Proceedings will likely begin next month. All but one case will be determined by the tax appeal court.

Honolulu—Civil Engineer James T. Taylor defends the Nuuanu dam from attack. He says it is perfectly safe.

Russians Relieve Bagdad

London—By a remarkable dash along the Turkish front, an army of the famous Cossacks of the Czar's army has reached and joined forces with the British detachment south of Bagdad.

The military is surprised at this news, but delighted. The Russian reinforcements are in such numbers that the situation at Bagdad is changed, and the people of the ancient city are fleeing from the oncoming Slavs. Bagdad is garrisoned by 20,000 Turks, which is inadequate force to stop Russians.

The regret of the British is that this dash of the Russians did not happen earlier and the fall of Kutel-Amara would not have occurred.

Moving Toward Constantinople

Military authorities believe that the Russian army operating against Trebizond will reach the Bosphorus at the end of May. The Turks are being slowly cut off from their line of communication with Constantinople.

Roosevelt Campaign Started

New York—The Republicans start the Roosevelt campaign. Public pulse will be sounded regarding the Colonel.

Bandits Attack Americans

Headquarters U. S. Army in Mexico—Attacked by bandits, thirteen troopers of the 7th Cavalry fought a skirmish near the town of Temoachic. One American was seriously wounded. The bandits were dispersed by the troopers.

Columbia Park Boys Killed

San Francisco—Three Columbia Park boys were killed in an auto accident yesterday.

Miss Spring-Rice Charged

Chicago—Sensational charges have been made against Angela Spring-Rice, sister of Ambassador Sir Cecil Spring-Rice, the charges being brought out at a meeting of Sinn Fein sympathizers here yesterday. The speaker said that Miss Spring-Rice had aided the Sinn Fein in getting arms into Ireland.

Britisher Under False Flag

Berlin—Despatches from Melinborg declare that the British submarine which sunk the German steamer Traver flew the German flag to decoy the steamer from the protection of Swedish waters.

Storm In Oklahoma

Dennison, Texas—It is found that nine were killed and over thirty injured in the hurricane which struck Kemp Saturday evening. Roofs of houses were lifted and other freak work was accomplished by the fierce gale. Rescue work is being carried out systematically and sufferers relieved.

Germans Capture Prisoners

London—Berlin reports the capture of 1300 prisoners and the repulse of the Russian attack made against their lines in the Dvinsk region. Gains are also announced in the Caucasus.

Japanese Consul Talks

Honolulu—The Japanese consul addressed his people last night on the subject of world peace after the war is over, with particular reference to the Pacific ocean.

Italians Sustain Defeat In Tyrol

Vienna—Italy's defeat in the Tyrol seems to be complete. Austrians take 13,000 prisoners and large number of guns and howitzers.

Thames Air Raid

Berlin—German sea-planes raid the Thames. Berlin reports all returned safely. London contradicts and reports one shot down.

Cyclone Wipes Out Town

Dennison, Tex—Oklahoma town wiped out when cyclone hits it. Call for help has been received from Kemp, a little town reported to have been wiped out by cyclone early last night. Only meagre reports received. Eighteen are known to be dead, and many injured. Relief train with doctors sent to stricken district.

Mediators Must Not Meddle

Paris—Mediators are warned not to meddle in the war just now. Le Temps declares that neither Pope Benedict nor President Wilson would be welcome at present by Allies. Pope based his ideas on German falsehoods. A Paris publication, in apparent special article, says Entente will accept only its own terms when end comes.

Germans Driven Back At Verdun

London—Germans driven back at Verdun. Have big losses. Many battles gain French some ground in Champagne.

Merchant Marine Planned

Germans plan for merchant marine. Government will help replace lost ships as soon as war has ended.

Swiss Nervous

Paris—Swiss are ready to defend their borders. Switzerland is nervous for fear Germans will thrust through Switzerland to attack France.

Scott-Oregon Agreement

Washington—Carranza is now ready to tell Lansing just how he feels. New note is on the way in which the Scott-Oregon agreement is ratified.

Americans are withdrawing from advance posts, and 6th Cavalry is transferred from Columbus to Big Bend district, being due or each Marathon sometime tomorrow.

Greek Collier Sunk

Toulon—Twenty seven members of the Greek collier, which was sunk by an Austrian submarine, reached port yesterday.

Coffers Well Stocked

Washington—The U. S. Treasury Department is ahead \$90,000,000. Frustrated income frauds and evasions alone net \$8,380,185.

Honolulu—The Coastwise law is not inviolable. Administration shipping bill exempts Islands from some restrictions. Geographical recognition is given. Foreign built ships get their American registry. Better vacation plan is launched by Honolulu Women's clubs. Will have vacation work for school children beginning this year. Mrs. T. Moore will be in charge.

Saturday Afternoon

Chicago—Boom for Gen. Leonard Wood for president is strongly supported by friends of military man in advance of meeting of republicans early in June. Gen. Wood's friends are creditably reported as planning to present his name to national convention as a republican compromise candidate. Supporters claim he is acceptable to Col. Roosevelt.

Army Bill Gets House Approval

Washington—The army bill nears completion. By overwhelming vote lower house adopts important legislation, giving the U. S. army a peace strength of 211,000 and militia to be widely federalized.

British Coast Raided

London—The English coast was again raided by German planes. Six were killed and 136 hurt, when sea planes dropped bombs in several counties.

Britain delays action in Jerry Lynch's case.

Verdun Quiet

Paris—Very quiet on Verdun front today. Germans attempted to cross the Yser north of Ypres but were repulsed by British. They repeatedly attempt but with same result and great loss.

Exports To China Forbidden

Japan forbids shipments of arms to China. Action taken on account of efforts of Germans to ship guns to India.

To Conserve Cash

Shanghai—Yuan Shih Kai issued mandate to government banks ordering them to discontinue paying out cash for notes.

Honolulu—Twenty one new school houses will be asked for soon. Henry W. Kinney preparing recommendations to various boards of supervisors.

Stocks stronger. Oahu shares again gain a full point in a day and other securities hold strong.

Saturday, May 20

Sugar, 6.02.

Honolulu—The financial stress of the city of Honolulu may be relieved soon. The increase in tax values promises to give the municipality funds in the near future. When the city receives its share of the money from the Territory the first thing to be done will be the liquidation of registered warrants against the city and county. This will require a very large sum.

More Dividends Coming

Six plantations have just announced dividends, the total to be paid out being \$657,802. The plantations are Hawaiian Sugar [Makaweli], Kahuku, McBryde, Faia, Hutchinson and Paauhau. The organization of the Queen Victoria war relief movement in Honolulu is now complete.

Roosevelt In Ford's Town

Detroit—Roosevelt delivered his speech on Americanism here last night and made a big hit. One woman made a spectacular offer of her two sons to the cause of preparedness, and Roosevelt replied that if the mothers of the land would do the same war would be impossible.

The Drop In Sugar

Honolulu—The drop in the quotation on sugar from 6.46 to 6.02 was occasioned by Porto Rican sales, which forced the market down. The effect on the mainland market was instantaneous and gave Honolulu's Wall street a severe jolt.

Honolulu will have a Red Cross tag day.

Needs Oil For Navy

Washington—Secretary Daniels has requested the President to set aside a certain portion of the oil field of California, it being required by the navy for its future oil supply. It is feared that a measure now pending in Congress would bar the possibility of acquiring any such property easily in future.

Italians Licked By Austrians

London—Italy yields large areas of her front to Austria. After continued bombardment of their front by enemy forces the Italians abandon two valleys and evacuate other points.

The reverse was unattended by any serious losses.

Another Balkan Campaign

The troops of Franz Joseph are now reported to be preparing for another offensive campaign in the Balkans where troops are arriving.

Troops To Remain In Mexico

Washington—American troops will not be withdrawn from Mexico. The Sibley-Langhorne expedition will remain in its present position indefinitely.

Tokio—General Shung Ki, friend and intimate of Dr. Sun Yat Sen, liberator of China, is shot by an assassin in the French quarter.

Honolulu—Chinese republicans of Honolulu are shocked at the killing of Shung Ki. Woodan pays high tribute to dead revolutionist and says he was one of noblest figures in China. As the result of the assassination the French authorities have redoubled their guard over the safety of Sun Yat Sen, both day and night.

Italians Check Austrians

London—Italy hits back hard and the Austrians are checked. Latins and Austrians are now engaged in most sanguinary conflict of the war. Everywhere in foothills of the Alps Victor Emanuel hurls the enemy back. Massed attacks by forces of Franz Joseph are countered with terrific thrusts and artillery fire that crushed legions.

President Intervenes For Lynch

Washington—The President leaves theater which he was attending to use his influence to prevent the execution of Joseph Lynch, tried and convicted of taking part in the Irish rebellions. Lynch was former president of the Phi Kappa Society in New York. He was a naturalized citizen and when the news reached Senator Okorman he and the president cabled friends in Ireland and London to try to prevent execution of the Irish-American.
