MABINI IS DEAD

HE WAS BRIGHTEST MAN OF FILIPINO FORCES—WAS TAKEN TO MANILA FROM GUAM LAST FEBRUARY, AFTER TAKING OATH OF ALLEGIANCE—WAS A RIVAL OF AGUINALDO FOR LEADERSHIP.

Associated Press Cable to the Star. MANILA, P. I., May 14.—Mabini, who was the foreign minister of the Filipino Government, is dead.

He was one of the last of the insurgents to take the oath of allegiance to the United States Government. During the latter part of February, he in company with his brother and another Filipino leader, was brought to Manila from Guam where they had been confined as prisoners of war, since their capture over a year previous.

Mabini realized that the struggle against the United States was useless and he took the oath, and has resided near Manila ever since.

Although he did not attain the prominence that Aguinaldo did in the Filipino Government, Mabini was recognized as the brains of the Insurrection.

He was at Hongkong at the time that Admiral Dewey started with the American fleet to Manila to attack the Spanish vessels in April, 1898. The Filipino Junta was undecided for a time, as to whether Aguinaldo or Mabini should be sent to Manila with the Americans, but Aguinaldo was finally sent.

Mabini was a half-cast Filipino and Chinese, and was one of the ablest of the men who engineered the insurrection against the American Government.

VALPARAISO QUIET.

MONUMENT TO DEWEY.

Associated Press Cable to the Star. SAN FRANCISCO, May 14.—President Roosevelt today unveiled the monument erected in Union Square, in honor of the victory of Admiral Dewey in Manila Bay. The unveiling was witnessed by a crowd of people filling the entire square. It was erected under the supervision of a citizens' committee of San Franciscans and occupies a central position in San Francisco's most centrally located park. Admiral Dewey was invited to attend the unveiling, but replied that his official duties made it impossible for him to make the trip to the coast.

The President will next visit Berkeley and the Mare Island naval station.

WOULD BE A KYBOSH ON RACING

THE HOUSE PROVISION ON THE PARK APPROPRIATION PROHIBITING THE CHARGE FOR ADMITTANCE TO ANY PART OF THE PARK, IT IS FEARED WILL ENDANGER THE JUNE ELEVENTH RACES.

The House provision that no charge shall be made for admission to Kapiolani Park, under the appropriation for the park commission, has created a stir among members of the Jockey Club. "It would simply put the club out of business," say the members, "and there would be an end of racing."

Under the present system the club has a lease of the track during three months of the year, according to an old agreement with the monarchy when the lands were made into a park. The club charges admission every racing day and the attendance is always large, but the club is nevertheless considerably in debt, and members are called upon to pay assessments for purses. There is large expense connected with training of horses, offering purses, etc., and the gate receipts do not make up the deficit.

Representative Henry Vida, who is the author of the amendment to prevent charging admission, is a member of the Jockey Club, but says that he thinks the club ought to get a new track and that it would be more successful if it did so.

In the Senate there is a disposition to strike out or amend the House provision. The senators may approve the provision made, with an amendment allowing the charging of admission on one or two days a year only and it is thought that this would be accepted in conference.

Polo would be affected as well as racing, until the Polo clubs are able to secure grounds of their own, as the Inter-Island polo tournament was held at Kapiolani Park last year, and an admittance fee was charged. But in spite of large gate receipts the members had to assess themselves liberally in order to meet the expenses of the tournament—so liberally in fact as to put out of the question the idea of a polo tournament without gate receipts.

AFTER THE BRIBERS

GRAND JURY BEGINS ITS INVESTIGATIONS OF THE EFFORTS MADE PUBLIC BY THE ATTORNEY GENERAL'S DEPARTMENT TO CORRUPTLY PROTECT CHINESE GAMBLING.

The Grand Jury resumed sessions this morning, with the Chinese gamblers' bribery matter as the most interesting subject of investigation. Attorney General Andrews was in attendance and A. P. Taylor and John T. Baker, the other two witnesses to the offer of bribery made to Deputy Peters, were subpoenaed.

In addition to the charges against Kung Tai the Grand Jury may investigate the matter of alleged bribe money used in the past. In the conversations between Peters and Kung Tai mention was made of a large fund used formerly to secure protection of the gambling joints, and efforts are being made by the Attorney General to secure evidence on this point.

The question of the power of the Grand Jury to delve into legislative secrets is also being discussed. In at least one case, it is known that members of the legislature and others are anxious to have a Grand Jury inquisition into certain reports of crookedness, and a little quiet digging has been done in the matter. The legislators claim they have legal privileges superior to those of the Grand jurors.

LAYSAN'S ONLY NATIVE CHILD

THE ONLY BABY EVER BORN ON LAYSAN ISLAND ARRIVED FROM THERE YESTERDAY ON THE SCHOONER J. H. LUNSMANN—BAYAN'S SCIENTIFIC WORK ON THAT LONELY SPOT—SCHLEMMER'S PLAYS.

The first child ever born on Laysan Island, the only native of that lonely islet, arrived in Honolulu yesterday morning on the schooner J. H. Lunsmann.

This creature of the unique nativity is the pretty little girl baby of Captain and Mrs. Max Schlemmer who have been the sovereigns of that outpost of the Territory of Hawaii for about two years. The little Laysan Island babe was born March 24, 1903. She will probably never see her native place again, for though Captain Schlemmer is going back to Laysan on the next trip of the Lunsmann, leaving here according to the present schedule, May 26. Mrs. Schlemmer and the children are not going back. Captain Schlemmer has bought the old Singer place in Kalihi and the family will make their home there, and Laysan Island, it is expected, will be abandoned as a guano field within a year or two, so there will be no opportunity for the little one to go back ever, if she wanted to.

Because of the approaching exhaustion of the guano deposits of that island, and the consequent result that very soon there will be no opportunity to go there, unless a vessel be chartered specially for the trip, the Bishop Museum dispatched W. A. Bryan thither by the last voyage of the Lunsmann, to make a study of the natural history of the island, its birds and fishes, its geology and botany. Captain Schlemmer reports that Bryan is working away there enthusiastically and effectively.

Until the arrival at Laysan of the J. H. Lunsmann on her last trip, there had been no vessel touch there for seven months. Among the incidents of this period was the capture of a large shark which had two live turtles in its stomach, one of them weighing a little over forty pounds and the other weighing a little over fifty pounds. BIG MOVEMENT OF SUGAR TODAY

NEARLY 7,000 TONS STARTS FOR SAN FRANCISCO THIS MORNING. THREE VESSELS DEPART.

There was quite a good sized movement of sugar today. The ship Benjamin F. Packard got away about 10 o'clock for San Francisco with 2,300 tons of sugar from Castle and Cooke. A little later, the bark Kalulani sailed for San Francisco with 45,313 bags of sugar. She took a number of passengers.

At 11:30 a. m. the barkentine W. H. Dimond sailed for San Francisco with 10,156 bags of sugar and some miscellaneous cargo. The Dimond took passengers.

This morning the steamer Helene arrived from Hamakua ports with 12,088 bags of sugar. She began discharging into the bark Nuuanu. The Nuuanu will take 1650 tons of sugar for New York from C. Brewer and Company. She is expected to get under way a week from Saturday.

The bark Andrew Welch is loading at the Railway wharf. She will take 1,600 tons of sugar for San Francisco. The bark will sail next Tuesday.

The ship Fort George will begin taking sugar in a few days, for Delaware Breakwater.

The ship George Curtis has not finished discharging her general cargo. She is at Brewer wharf.

The S. S. Nebraskan will sail for Kahului tomorrow afternoon to take a partial load of sugar. She will return next week and finish her load, sailing for San Francisco May 22. She will take about 5,500 tons of sugar.

The ship Edward Sewall is expected to come into the harbor the end of the week and begin taking sugar the first of next week, for Delaware Breakwater.

SUPERVISORS FIX SALARIES.

The Senate at the afternoon session yesterday, laid the Senate bill making appropriations for current expenses for two years on the table. The two bills for the six and eighteen months appropriations for current expenses were tabled to await the action of the House.

The eighteen months' salaries appropriation measure was taken up. Senator Brown moved the insertion of the items for courts to be a charge upon the counties. There was considerable debate on the proposition and it was finally decided that the salaries of the courts must be fixed by the supervisors.

On motion of Senator McCandless the salary of the Superintendent of Public Instruction was increased to \$6,750 for the period. The same Senator had an item of \$2,475 for the pay of kindergarten teachers inserted. The bill then passed second reading, and an adjournment was taken.

The S. S. Coptic is due tomorrow afternoon from the Orient. She will probably sail Saturday morning for San Francisco.

MAIL THIS AFTERNOON.

The S. S. Doric is expected this afternoon from San Francisco with three days later mail and news files. She left San Francisco May 8. She will sail for the Orient some time tomorrow.

TOOK SARGENT TO PEARL HARBOR

COMMISSIONER GENERAL LEFT THIS MORNING ACCOMPANIED BY SOME WELL KNOWN PEOPLE

Commissioner General of Immigration Sargent was the guest of honor this morning on a special trip to Pearl Harbor. General Sargent and party left on the government tug Eleu from Brewers' Wharf this morning shortly after 9 o'clock.

The party goes to Pearl Harbor where General Sargent will be shown the dredger at work and the nature of the work at that point will be explained. After stopping at the entrance some time, the tug will go inside the harbor. She will go down the east loch toward Ewa plantation, and may go around Ford buoys to make that part of the harbor, it is possible that the Ford Island trip may not be made.

The party will be landed at the Peninsula and there take a special train and be conveyed to the Sinal farm. The party will return to Honolulu on the train this afternoon. In the party were General Sargent, Mr. Donahue his secretary and W. O. Smith, B. F. Dillingham, Walter Dillingham, A. L. C. Atkinson, Henry E. Cooper, E. E. Paxton, L. E. Pinkham, A. Gartley, Mars-ton Campbell and Dr. Cofer.

Considerable interest is taken in the trip, as the Eleu will be the first vessel of any size besides the steamer J. A. Cummins, to cross the Pearl Harbor bar since the dredging was completed. The tug is drawing 12 feet.

JAMES F. NEILL'S FUTURE PLANS

POPULAR ACTOR TAKES MASTER'S DEGREE AND LEAVES FOR EUROPE.

SAVANNAH, Ga., May 2.—Probably the largest Masonic meeting held in Savannah for years was that of Clinton Lodge last night. Nearly 200 Master Masons were on hand. There were four active worshipful masters and sixteen past masters in the hall. James F. Neill had crossed the continent to join the lodge of which his father had been a member. The elder Mr. Neill joined the Masons in 1868 and was a member for 32 years. J. F. Neill took his three degrees in one week's time, which is very remarkable.

He leaves tomorrow with his brother for New York, whence they will sail for Europe. They will visit London, Paris, and spend some time in Liverpool with relatives. They will be absent about two months and will return to America in time to start off their new company, which will open in Los Angeles, Cal., the middle of July. Mr. Neill is one of the most popular actors and successful managers in the country.

SAILING HOUR CHANGED.

SAN FRANCISCO, May 5.—The hour of departure for the vessels of the Oceanic Steamship line is to be changed. In the past the steamers running to Australia sailed at 10 a. m., and the Alameda for Honolulu and the Mariposa for Tahiti departed at 2 p. m. In the future the Australian boats will leave the dock at 2 p. m., and the Alameda and Mariposa at 11 a. m.

PART OF QUARANTINE WHARF.

Commissioner General of Immigration Sargent effected arrangements yesterday whereby he will take over temporarily a portion of the Channel wharf for use as an immigration station for this port, until the regular station shall have been constructed. A portion of the Channel wharf is now used for quarantine purposes by the Marine Hospital authorities. A large portion of the wharf will be used by the immigration authorities. Commissioner General Sargent says that the immigrants are not to be sent to the quarantine island as formerly, but will be detained at the new station. The quarters on the wharf will probably be ready to receive the immigrants due on the Coptic tomorrow.

NEW LINE IN OPERATION.

SAN FRANCISCO, May 5.—Two of the big steamers of the China Commercial Steamship Company are en route to this Coast from Hong Kong. The Atholl left there nearly a month ago to call at Japanese ports and Manzanillo before coming here, and the Ching Wo left Hongkong on April 25th with instructions to follow the same route. Both will bring considerable freight, and large quantities have already been secured for the return trip to China.

FANNING ISLAND'S POSITION.

SAN FRANCISCO, May 5.—Civil Engineer Werry, who was sent by the Canadian Government to determine the exact position of Fanning Island, in connection with the establishment there of a station of the British-Australian cable, because the little island was said

to have been erroneously charted, has found that the latitude was 26 sec. too far north. The longitude as shown by the admiralty chart is correct.

BASEBALL PARK.

At a meeting of the trustees of the baseball park yesterday afternoon the contract for grading the grounds and building the fence was let to J. W. Sprinston. Lucas Bros made the lowest bid for building the grand stand, \$5,300. The contract will be awarded to them but some changes will be made in the plans so as to reduce the cost. The bid of Allan Dunn for the score card privilege was accepted, he offering twenty-five per cent of the advertising receipts in connection with it. He also offered to furnish a score board on the grounds if he were allowed advertising privileges in connection with it. No action was taken on this until the general question of advertising on the grounds is taken up. Ulysses Harris was given the chair privilege at Punahou for \$20.

BROUGHT OIL FROM THE COAST.

The S. S. Whittier arrived yesterday afternoon from San Francisco via Kahului, with 12,000 barrels of oil for the Union Oil Company. She towed the barkentine Fullerton to Kahului and left her there yesterday morning and then came on to this port. The Fullerton had 15,000 barrels of fuel oil.

TO AID BOOM OF MAYOR HARRISON

Chicago Weekly Published In Interest of Executive's Ambitions For Nomination.

CHICAGO, Ill., May 2.—Mayor Harrison's Presidential boom now has a political organization behind it. Number 1, volume 1, of the Chicago Democrat, a weekly, made its appearance today. While nothing is directly said in the initial issue advocating the Mayor's candidacy, the words "Harrison for President" can be read between every line. Frequently recurring paragraphs urge the necessity of Illinois Democrats uniting to make themselves effective in the campaign for the big nomination. Possibly the liveliest original contribution in the sheet is an effusion by Dr. H. S. Taylor, poet laureate of the City Hall, entitled, "Harrison's Luck." Its subject matter consists of a discussion of that theme by several sons of Erin. The poem ends with the assertion that Harrison's luck is located in his head—"If all ay yez byes had his brains and his pluck, ye would get, wid his virtue, a part of his luck."
 Copies of the paper will be distributed tomorrow at a meeting of the Chicago Democratic Club, the new organization of the Harrison Democracy.

A RECEIVER FOR CASPAR WHITNEY

Failure To Pay a Doctor's Bill Results in Involuntary Insolvency For Editor of Outing.

NEW YORK, May 2.—Because he has not paid a doctor's bill, the business affairs of Caspar Whitney, sporting writer, editor of Outing and clubman, were placed in the hands of a receiver today in the City Court. The judgment upon which a receiver was appointed was in favor of Dr. Charles McBurney, the surgeon who operated upon President McKinley. It was given in November, 1901, and amounts to \$576.36. Max S. Levine of the Bowery Bank building is the receiver. Whitney adjudged in contempt of court several months after judgment against him was given for having expended \$500, which, it was said, he received from a publishing firm; but the contempt proceedings were reversed on a legal technicality and the receivership was substituted. He is a member of the Larchmont Yacht and Racquet clubs, the Century Association and several other social organizations. His income is said to be \$8000 a year.

USED A COFFIN FOR A HIDING PLACE

Bookmaker, Pursued by Officers, Puts Incriminating Papers In With a Corpse.

CHICAGO, May 2.—A coffin containing a body was the place selected by a bookmaker to hide the evidence of his guilt when pursued by detectives. Running out of Halpun's saloon, at 873 Milwaukee avenue, where he operated his hand book, with two detectives connected with Chief of Police O'Neill's office close at his heels, the fugitive dashed into an undertaking establishment and ran into the rear room. In his excitement the man raised the lid of a coffin, scattered a number of papers about the body therein, and then reclosed the lid. A few moments later, when the detectives followed, they found their fugitive in the room and placed him under arrest. He denied emphatically that he was guilty of operating a hand book, and demanded to be searched for evidence. His demand was complied with, but despite the closest search the police could find no evidence. They were about to leave the establishment when Detective Hughes noticed that the coffin standing in the center of the room had been disturbed. The detectives raised the lid and found lying about the corpse several papers which, upon investigation, were found to contain records of races being run at different tracks throughout the country. The prisoner admitted his guilt, and Justice Severson fined him \$25 and costs.

MAY MEAN ANOTHER SESSION

FAILURE TO PASS APPROPRIATIONS WILL CAUSE CONFUSION UNDER THE COUNTY GOVERNMENT ACT WHILE THE RATE OF WORK SO FAR INDICATES THAT THE WORK CANNOT BE FINISHED.

Some of the legislators have been figuring up the rate of work so far in the special session with a view to estimating how long it will take to finish the work of the session. The calculations all come out over sixty days, and a serious situation will develop if it is decided that the session must end in sixty days, in the event of a failure to make the appropriations.
 The Organic Act provides that if the legislature does not make appropriations the Governor may act under the appropriation bills of the last session, but in the present case this would be impossible, as with the county bill going into effect the appropriation bills of two years ago are quite inapplicable after next January. "The necessary way out," said Vice-Speaker Knudsen of the House, "will be an extra session. I believe that the present session will have to end in sixty days, under the Organic Act, and the resulting confusion, if appropriations are not passed, will probably force another session. At the present rate of work the sixty days will not be long enough, and the situation is certainly a serious one."
 The fate of the so-called "emergency appropriations" bill during the regular session furnishes an example of how well the two houses work together and how long action takes. The bill was introduced early in the regular session, as an emergency proposition, to relieve conditions existing in the Public Works, Judiciary, Public Lands, Attorney General's and Public Instruction departments, also in the Board of Health, but it was never sent to the Governor. Conferences between the two Houses were held and the house finally tabled its conference committee report, disagreeing over an item inserted by the Senate. The name of "emergency bill" appears to have been a misnomer.
 The same bill was passed by the Senate this session, being Senate bill number 3, but the fact that it is supposed to be an emergency bill, to pay existing debts and help out departments which are running on credit does not seem to make any difference.
 Efforts have been made among members of the House to get the twenty Republicans, so-called, together in caucus for the purpose of agreeing upon a plan of action and hurrying matters along, for the good of the party, but without success so far.

GERMS OF SMALL-POX.

BOSTON, April 28.—The announcement of the discovery of the cause of small-pox was made today by Dr. Councilman of the Harvard Medical School, at a meeting of the Boston Society of Medical Science. The announcement is the outcome of the investigations conducted by Dr. Councilman, Dr. George Burgess Mowbray and Dr. Walter Remsen Brinckerhoff, with the co-operation of the Boston Board of Health, during the recent epidemic of the disease in this city. It has been determined that small-pox is caused by a micro-organism representative of the lowest form of animal life. This fact serves to show a relation between small-pox and such diseases as malaria, and to distinguish it from many other infectious diseases caused by bacteria.

THE SONOMA AT "FRISCO"

HEAD SEA AND STRONG WINDS DELAY HER PASSAGE FROM HERE—HER RECORD CARGO.

SAN FRANCISCO, May 5.—A head sea and strong winds caused a delay in the arrival of the Oceanic liner Sonoma from Sydney yesterday, the run from Honolulu occupying 5 days and 16 hours. Although expected early in the day, as usual, the steamer did not reach port until after 4 o'clock, and the time intervening before the departure of the afternoon overland train upon which the English mails were scheduled to depart, was so brief that special permission was given by Quarantine Officer Cumming for the Spreckels tugboat Relief to meet the Sonoma in quarantine grounds and take off the through mail, amounting to 257 bags, which was then hurried to Oakland in time to catch the 6 o'clock train. A total of 428 bags of mail was brought by the liner, and she reached her slip at Pacific street wharf at 6 o'clock.

A record cargo was brought by the Sonoma, the freight amounting to 1840 tons, or more than has ever been brought through from the Antipodes by any of the three big steamers of the Spreckels line. The number of passengers was also unusually large, and the statement was made by some of them that the trip had been remarkably enjoyable, entertainments and concerts being of frequent occurrence. The whole number of over 200 passengers signed a testimonial to Captain Herriman, expressing appreciation of his interest in their welfare and entertainment, and expressing the same sentiments toward Purser G. A. Hodson, Chief Steward Hackett, Chief Officer Coughan and Chief Engineer Archie Little.

The outward trip of the Sonoma from this port broke the record for actual steaming time to Sydney, the distance being covered in 19 days, 6 hours and 20 minutes. On the return trip a big gale followed the steamer between Sydney and Auckland, but except for this and the head winds and sets after leaving Honolulu the weather was fine. No sickness or accidents marred the voyage.

The large cargo of the Sonoma contained 754 pieces of timber, 292 ingots of tin, 19 cages and boxes of birds and animals, 39 bundles of skins, from Sydney; 2498 bales of wool, 15 casks of pelts and 416 ingots of zinc, from Auckland; 4 packages of coin from Pago-Pago, and 562 bags of sugar, 46 bags of coffee, 852 bunches of bananas and 34 boxes of coin from Honolulu.

PRINCESS SUES KING.

Associated Press, Morning Service. BRUSSELS, May 13.—The Countess de Lonyaya has sued her father, King Leopold, for three million dollars, her share in her mother's estate.

The scandal arising from the revival of the old family quarrel between King Leopold of Belgium and his daughter the Countess de Lonyaya, formerly Crown Princess Stephanie, widow of Arch Duke Rudolph of Austria, and now wife of Count de Lonyaya, will have to be aired in the courts through the bringing of this suit. When King Leopold's wife died at Spa, Belgium, the Countess hurried to her mother's bier, but King Leopold ordered her to leave the country.

Crown Princess Stephanie married de Lonyaya three years ago. The Countess was a diplomat of high standing but King Leopold bitterly opposed the marriage. The Austrian Emperor favored the match and the two aged monarchs have since had epistolary quarrels concerning it. Franz Josef sheltered Stephanie and may possibly be abetting her present suit. It has been known for some time that the Countess was financially embarrassed. As a widow the former Crown Princess enjoyed an income of \$125,000 and had a free residence in the Austrian palace, but on her marriage to the Count this income was reduced four-fifths and she was no longer furnished with free lodgings, splendid carriages and servants. Her husband could not furnish her with all these things as he has been badly handled by his creditors ever since their marriage. The Countess is now said to be deeply in debt to certain royal Austrians who have loaned her money.

Queen Marie Henrietta of Belgium died last September after a most unhappy life. She died of a broken heart King Leopold has an unsavory reputation as a monarch. He is rich beyond the dreams of avarice, having made his millions by developing the Congo Free State, and some say in robbing the natives of life and property. He is said to be possessed of fifteen millions. King Leopold locked his daughter Louise in a mad house to prevent her from inheriting the wealth of his sister Carlotta, once Empress of Mexico, who has been slowly dying for years. He intends to get that great fortune, and from the suit filed above it seems that he also wishes to have the large estate left by his wife, the late queen.

FRAUDS IN HAYTIEN SECURITIES.

Associated Press, Morning Service. PORT AU PRINCE May 13.—Frauds in Haytien government securities have been unearthed. The amount involved is \$2,000,000.

TWO YEARS SENTENCE.

John Lua was found guilty of larceny in the first degree this morning, by a jury in Judge Robinson's court, and the court sentenced him to two years' hard labor.

TO REMOVE WRIGHT.

A motion was filed in the circuit court yesterday to remove William H. Wright executor of the estate of John Wright. The motion was by Anna S. Wright, whose affidavit in support of the motion says that Wright has left the Territory and does not intend to return. She asks that F. Wunderberg be appointed executor.

THE CHAMBER OF COMMERCE

REGULAR MEETING THIS MORNING ADDRESSED BY COMMISSIONER SARGENT.

The regular monthly meeting of the Chamber of Commerce was held yesterday morning. President C. M. Cooke, presiding. Those present were E. D. Tenney, J. T. Crowley, E. R. Stackhouse, W. M. Giffard, W. Photenhauer, T. Clive Davies, A. B. Wood, F. J. Lowrey, A. J. Campbell, Col. W. F. Allen, F. A. Schaefer, W. E. Waity, S. B. Rose, W. P. Dennison, George Robertson, James G. Spencer, C. M. Cooke, H. A. Parmelee and Fred L. Waldron. In the first degree yesterday, by a P. J. Lowrey presented a memorial resolution on the death of William Waterhouse Dimond, who was a member of the Chamber, which was adopted, and will be engrossed and sent to the family.

E. D. Tenney for the legislative committee made an oral report in which he said that there were several matters in connection with the appropriations which the committee was watching. He felt it was pretty certain that the appropriation for the extension of the wharves and the improvement of the harbor, in which the Chamber of Commerce was particularly interested would be made.

A letter was read from T. Clive Davies, chairman of the Executive committee of the Shippers' wharf committee, enclosing \$1500 as a part of the 10 cents a ton tax on imports, to be used by the Chamber of Commerce "for the benefit of the community."

A resolution offered by James G. Spencer was adopted directing the treasurer to turn over to the Tourist Committee this and all other money received by the Chamber from the same source. A number of letters were read, among them one from the Providence R. L. High School asking for exhibits of island products for the school museum, which was referred to the Tourist committee.

The Chamber of Commerce of Brisbane, Queensland asked for an exchange of official and other publications. It was referred to the Secretary of the Territory.

Secretary James G. Spencer stated that he had been informed this morning that the item of \$20,000 for advertising the territory which was defeated yesterday in the House was not altogether dead. A resolution urging the passage of the item was presented, and adopted.

Commissioner of Immigration F. P. Sargent was present by invitation. President Cooke introduced him to the Chamber in a pleasant little speech. Mr. Sargent made a short address and was heartily applauded. At the close of the meeting the members of the Chamber were introduced to him personally by President Cooke.

Dr. Arthur Irwin, government physician on Hawaii, asked for a nine-months vacation in order that he might visit Europe. It was granted and his brother Dr. Fred Irwin appointed to act in his place.

A vacation was granted also to Dr. Sandow of Kaula who intends to make a six months trip to Germany. A Dr. McLain who is coming on the Sonoma will fill his place if he passes a satisfactory examination. Dr. Atcherly of South Kohala repeated his request for an increase on salary to \$100 per month. He asked also that the board allow him back salary at that rate from February, which could not be done for want of an appropriation.

A communication was received from Dr. Stow of Hilo asking for an assistant to Fish Inspector Herring to take care of the Waialea market. A native is willing to do the work for nothing. Rules for government hospitals as submitted by Dr. Mays were adopted. The hospitals are to be under the management of the trustees subject to approval by the board, and the money appropriated is also subject to the same body.

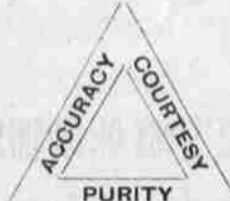

CHILLINGWORTH AND KUMALAE

KUMALAE ATTACKS ONE COMMITTEE AND CHILLINGWORTH STARTS AFTER ANOTHER.

The afternoon session of the House yesterday began with a discussion between Kumalae and Chillingworth, over a remark made in the morning by the former, to the effect that a head of a department had said that he would award public contracts as he pleased, without regard to conditions which the legislature might place in the appropriation bills. Chillingworth demanded to know the name of the man who had made such a statement, but Kumalae refused to state who it was. Chillingworth was vigorous in denouncing the statement and branded it as untrue and Kumalae in his reply began an attack on the Health and Education committee, of which Chillingworth is chairman.

Chillingworth interrupted with a point of order, saying that the rules did not allow members to attack committees. "For certain reasons I have refrained from attacking the Chinese fund committee, of which Mr. Kumalae was chairman," said Chillingworth. "It spent \$175,—" Here Kumalae interrupted again and Speaker Beckley took a hand, calling for order. The item of \$10,000 for advertising the Territory was inserted on motion of Keilini, by the following vote: Ayes—Andrade, Aylett, Chillingworth, Gandah, Hala, Harris, Kalama, Keilini, Knudsen, Lewis, Nakaleka, Pali, Vida and Wright, 14. Noes—Damiana, Fernandez, Kaili, Kanibo, Kou, Kumalae, Long, Olli, Pale, Purdy, 11. The bill passed third reading, and after passing the emergency bill on second reading the House adjourned.

TROUBLES OF THE LEPERS

FIRST MEETING OF THE NEW BOARD OF HEALTH DISCLOSES MANY.

The palat supply of the leper settlement, deporting kokua who are not needed and improving the morais of the lepers were subjects which occupied much of the time of yesterday's meeting of the Board of Health. Superintendent McVeigh presented the names of the twelve kokua who he thought were no longer needed. Some were disorderly characters and all were living at the settlement without being of any service. He was authorized to deport them. The palat trouble was the old story of the failure of Judge Kalua to get shipments to the settlement on time. Dr. Pratt told of wireless message sent to Kalua and a letter was received from Kalua stating that he had only received one message and that the weather was then too stormy to make the shipment. McVeigh said that it was not stormy at Molokai and Dr. Pratt produced a return from the operator of the wireless company showing the delivery of both messages sent to Kalua, by telephone to the lao saloon. Kalua's contract has only one month more to run, and no action was taken by the board.

Superintendent McVeigh submitted a report on unlawful cohabitation among the lepers. He said that many of the guilty parties desired to marry but could not do so on account of having husbands or wives outside the settlement. He recommended that the attorney general bring suits for divorce for such people, alleging leprosy as grounds and said that when such divorces were secured the parties at the settlement would marry. The matter was referred to the Attorney General and S. K. Ka-ne.

A report was received from Dr. Moore on the Goto remedy. Dr. Moore said that it had palliative effects and that the lepers wanted it, and he recommended that a supply be secured. At the same time the doctor did not consider it advisable to use the remedy any more than necessary, saying that it was a proprietary compound and its ingredients were not all known. He recommended that in future its effects be carefully watched by the settlement physician. The report was tabled to await legislative action on appropriations.

ENLARGING BRITISH EMPIRE.

Associated Press, Morning Service. LONDON, May 13.—British military operations have added one hundred thousand square miles to northern Nigeria. Great Britain gained her first foothold in Nigeria in 1882, when she issued a charter to a company that took over the trading there. Since that time she has been gradually pushing her way inland from the coast. In 1895 Great Britain bumped up against a portion of Nigeria controlled by the Sultan of Sokoto. This ruler had force enough to keep the British from stepping over his borders at that time and so the latter consented to a simple alliance with him.

ALLEN—At his residence, Richard street, Honolulu, Hawaii, April 13, 1903, of a sudden attack of heart failure, Samuel Clesson Allen, a native of New Salem, Massachusetts, aged 71 years, 11 months and 27 days, and a resident of Hawaii since December 1850. At the time of his death he was senior member of the firm of Allen & Robinson, President of the Oahu Railway Company and largely interested in many other enterprises. Christley Lane, Honolulu, May 13, 1903, Ida Rodriguez aged 18 years. The funeral was held the same day, the interment being in the Catholic Cemetery. JOE HANNA DEAD. SAN FRANCISCO, May 13.—Joseph Hanna, a well-known newspaper reporter who had done the winter-front detail for the past fifteen years, died in Corte Madera yesterday. Mr. Hanna had been ill for some time. The immediate cause of death was from a hemorrhage of the stomach. He was fifty years of age, and leaves a wife and four children. Every shipmaster plying between San Francisco and Hawaii knew Joe Hanna.

The pupils of the central Union Bible school are requested to meet for rehearsal for the Children's Day service at the church, on Friday afternoon immediately after school.

Andrew Brown and Joseph A. Gilman have been commissioned by Superintendent Cooper as members of the Honolulu Fire Commissioners. Brown succeeds himself and Gilman succeeds Auditor Fisher.

Franz Abt's operetta "The Water Fairies" will be given al fresco this evening at the Kamehameha School for Girls for the benefit of the Kailuan Home. Tickets are for sale at Wall, Nichols Co., and at Thrums', fifty cents.

It is now announced that all the preliminaries to extending the Rapid Transit line out to Kaimuki have been completed. The grading of the roadbed will be proceeded with, but the laying of the tracks will await the completion of the down town construction now in progress.

The Hobron Drug Co., hold another "Gift Day" sale on the 21st. They propose to give away a fine pair of nickel plated scissors with a fifty cent purchase of drug store goods. On one pair to each customer as the scissors would sell for about the price of the fifty cent purchase required. Miss Dorothy E. Wisdom, representing the "Morning American" of Creston, Ia., and "The Westward Progress" of Minneapolis, Minn., arrived in the city by the Peking, and will remain here until May 23, when she will resume her voyage to the Orient. Miss Wisdom is engaged in "writing up" the islands.

PASSED BIG APPROPRIATION

FINALLY FINISHES EIGHTEEN MONTHS APPROPRIATION BILL AND ADJOURNS UNTIL MONDAY.

The eighteen months appropriation bill got through the Senate this morning. Only Senator McCandless voted against the final passage of the measure. Before the vote was finally taken on the bill however some changes were made in the measure. Senator Dickey tried in several instances to have reductions made, especially with the heads of departments but as there was a disposition to keep up the scale of salaries, he abandoned the fight and eventually left the Senate before the session was closed for the day.

When the eighteen months appropriation measure was brought up, Senator Dickey, seconded by Senator Achi started to hammer down salaries by moving that the salary of the Attorney General be reduced from \$8750 to \$5,400 for the period. This motion was lost and was amended to pass it as \$6,300 but the item finally carried as the bill. Items of \$2,700 for two clerks, \$2200 for civil engineer, \$2700 for registrar and \$2,250 for stenographer, for the land department under the Torrens Land Act, were inserted in the bill.

The salary of the bookkeeper of the Public Works Department was reduced from \$3600 to \$3,150, while that of the gunpowder and gasoline keeper at Honolulu was raised from \$2250 to \$2,700. A motion to raise the salary of the secretary of the Board of Education to \$3,600 was lost.

An item of \$360 was inserted as pay for the rangers of the sixth land district.

Another item calling for \$900 for the pay of messengers and clerk to the de-

partment of Agriculture, Forestry and Horticulture, was inserted in the bill.

A motion was made to reduce the salary of the chief health officer to \$3,000 but the motion was lost.

The salary of the secretary of the Board of Health was reduced from \$3,000 to \$2,000.

The salary of the deputy auditor was cut from \$4,500 to \$4,050. The measure was then passed third reading.

Owing to the fact that Senator Jaenbergh was ill and some of the other members desired to be absent, the Senate took an adjournment until Monday morning at 10 o'clock.

THE OVERDUE STAMP TAXES

COLLECTOR CHAMBERLAIN RECEIVES AN ORDER REGARDING PAYMENT OF LEGAL PENALTY.

Collector Chamberlain has received from the Treasury Department a ruling with regard to the payment of the stamp tax on documents where the payment has become delinquent. The new instructions are as follows:

"It having come to the notice of this office that in some instances Collectors of Internal Revenue are continuing to sell stamps for documents presented for stamping after the twelve months from date of issue without payment of the penalty of \$10 as prescribed by the act of June 13, 1898, your attention is specially called to Treasury Decision No. 644 dated March 25, 1903, under which the following course should be pursued in all such cases:

"When documents are presented for stamping after the twelve months limit it has expired Collectors will refuse to furnish stamps for such documents unless the penalty of \$10 is paid. If the penalty is paid the Collector will make application to this office for the necessary stamps, which he will affix to the document and then validate the instrument, reporting the amount of the stamps sold on form 23, with a footnote stating that stamps were affixed and reporting the amount of penalty collected on Form 58 of the Assessment list.

"Collectors are still authorized to affix stamps and validate instruments without payment of penalty when presented for stamping within twelve months from date of issue, under such provisions as are set forth in section 13 of the War-revenue Act."

It is provided that in cases where the parties do not want to pay the penalty the taxes shall be collected and the amount reported with a note stating the non-payment.
