

Attempted Murder and Suicide

Wednesday evening the people of Kahului were startled with the report that a murder and a suicide had taken place within the town limits of that peaceful little burg. Later the matter simmered down to an attempted murder closely followed by the suicide of the black-hearted brute in the case. As the Frenchman had if the matter occurred because of the woman at the bottom of it.

It seems that Sato, formerly a trusted employee of Onishi, the well known Japanese merchant of Kahului, were on intimate terms with Ochika, a comely Japanese woman and with a widow, and had had some differences with her, of the kind the worldly wise would describe as a lover's quarrel and this had preyed on the mind of Sato to such an extent, that he neglected the interests of his employer so much so, that about two months ago he was let out because of hard times. At which time it appears Ochika became weary of his attentions, and curtly advised him to keep away from her, an injunction he refused to observe. To escape the annoyance of his undesired attentions Ochika proposed to remove to Honolulu, a bit of information she indiscreetly imparted to some of her confidential friends.

When Sato became aware of her intention he came to upbraid and to plead with her not to forsake him, but she gave him no comfort and it became plain to him that she was going to leave him.

Apparently he brooded over the situation,—no job and the woman he loved about to abandon him—and with the help of a plentiful supply of saki, he worked himself into a fit of desperation and resolved to go forth and end all.

Arming himself with a big cane knife he hastened to Ochika's quarters at the hour he knew the woman would be alone. Ochika was sitting down partaking of her evening meal at 4:30 p. m. when Sato walked into her presence, and without a word aimed a murderous stroke with the heavy knife at her head. The hour was well chosen for his devilish deed, the neighborhood, near the Spreckels' Park, was deserted, and there was no one nearby to interfere with his purpose. The woman screamed for help while Sato struck at her with his big heavy knife again and again but there was no one nearby stout hearted enough to come to her help. She threw her bare arms about her head to ward off the stinging blows, and the silent evidence of intensity of her struggles for life are the twenty cuts she received on her person, principally about her head, neck, shoulder and arms.

At last she managed to break away from the desperate thug, and still screaming covered with bleeding wounds she escaped and found shelter in a nearby house, and the murderer probably thinking he had accomplished his purpose, coolly walked out into the public road and hastened towards the town.

Still holding the big cane knife, now spotted with blood, with blood on his clothes and a look of desperation in his eyes, some of his countrymen on noting his appearances told officer Kauwenaole that Sato must have committed an evil deed. That officer promptly arrested Sato and disarmed him, and also asked what he had done. Sato

County Bond Issue

The Democratic County Committee held a meeting April 18th last and appointed a sub-committee consisting of Messrs. H. C. Mossman, T. B. Lyons, M. K. Keohokalole, P. Cockett and Dr. Raymond to start a campaign favoring the issuing of County bonds for public improvements as set forth in the proclamation made by the County board of supervisors.

The Democratic Committee also sent an invitation to the Republican County Committee to join hands with them on the issue. This proposition was submitted to a special meeting of the Republican executive committee held Monday last, but the Republican committee declined to be invited and passed a resolution quoting the precedent established at a former plebiscite, when political organizations refrained from making capital of the issue, and took the position that the Republican committee "will leave the question entirely and unconditionally to the good judgment of the voters free from all party consideration or party obligation as republicans or otherwise."

Wednesday afternoon the democratic sub-committee met and outlined a plan of action calling for the sending out of campaign speakers who will bring the merits of the matter at issue before the voters. The names of several well known orators are mentioned as likely to take the stump for the cause.

Officer Kauwenaole hurried him over to the little lock-up and telephoned to Sheriff Crowell at Wailuku of what had taken place, and the prisoner was safe in custody. They found Ochika was being attended to by friends and the doctor proceeded to give her the needed medical attention preparatory to removing her to the hospital. Officer Kauwenaole then returned to the lock-up to look after his prisoner. Arriving there the officer found that Sato had twisted a strip torn from a blanket around his neck had fastened the other end to the door and by throwing his body backward had nicely strangled himself to death. The officer undid the noose, let the body down and sent a hurry up call for Dr. Young, who promptly responded, but found the prisoner was beyond help as life was extinct.

The woman Ochika was removed to the Malulani hospital, and the physician stated that while the wounds were frightful they are not dangerous and if there are no complications she will recover.

After her wounds were dressed and she had been made as comfortable as the conditions would allow, she enquired what had become of her lover and would-be assassin, Sato. When told that Sato was dead, she stifled a cry of anguish that rose to her lips.

WASHINGTON, Apr. 29.—Mediators called in effort to bring peaceful settlement of the difficulties in Mexico, are seeking to include the Carranza-Huerta troubles.

It is reported here that Spain is anxious that the Mexican Minister of the Interior shall urge all governments to join forces for national defenses.

The First Cavalry now at Yellowstone has been ordered to proceed to Calixto.

Coast News.

WASHINGTON, Apr. 30.—Secretary Bryan has asked the aid of Spain in saving the life of Dr. Edward Ryan, an American, held prisoner in Mexico to be shot as a spy, unless Huerta yields to reason.

Rebels are mobilizing an army of 12,000 men to attack Tampico. Villa will lead in person.

A rebel artillery chief refuses to join against the Americans.

The daughter of President Wilson will be married in the blue room of the White House.

GALVESTON, Apr. 30.—Non-American refugees who were brought here in ships, claim it was against their will, and express desire to return to Mexico.

One million rounds of ammunition en route to the Constitution-alists were stopped by Americans and returned to the manufacturers.

DENVER, Apr. 30.—Union leaders are willing to lay down arms of the mine guards, and will give up their weapons.

CHICAGO, Apr. 29.—The United States Court of Appeals yesterday granted new trials to Tveitmo, Houlihan and Bernhardt. Trial set for May 16.

SAN FRANCISCO, Apr. 29.—Sam Parker left by the Manchuria yesterday. Will be followed on the 7th by Shingle and Kuhio.

DULUTH, Apr. 29.—The steamer Noble has been lost on Lake Superior. Several other craft reported missing.

WALSENBERG, Apr. 29.—While the militia are seeking a peaceful end to the civil war here, fire was opened up from darkness, and one officer wearing a red cross badge was killed. The white flag of truce was disregarded by the strikers. Leaders have been asked to give up weapons and refused. The unexpected resumption of hostilities in darkness resulted in the recalling of the troops to the scene where actual warfare now prevails.

TAMPICO, Apr. 29.—Rebels have been attacking Tampico for the last four days but without serious loss.

LONDON, Apr. 29.—Sir Edward Carden shows disposition to submit mooted question of Home Rule to the people of Ulster. It is a most important concession according to Asquith.

VERA CRUZ, Apr. 29.—The United States Naval forces under Fletcher today formally turned over the government of Vera Cruz to the Army forces under command of Funston. Special ceremony will mark the change to Army rule. Fletcher yesterday opened the doors of the Dungeon, and released a number of men once prominent in political affairs in Mexico. They were blind in some instances, and bereft of reason in others, and most of them are fit only for the hospitals.

Wailuku In Old Times

The following article clipped from the Advertiser of fifty years ago, is of much interest to Mauians:

In ancient times, Wailuku and the neighboring valleys, which are watered by streams from these mountains, were undoubtedly densely peopled, the evidences of which fact still remain. Of late years, however, the population has been gradually decreasing, although no portion of the island is better adapted to support a large population, and afford it ample means of industry, in cultivating taro, bananas, and sweet potatoes, required for other parts of Maui, where taro is raised, as well as for the Honolulu market. Not only these products do well here, but sugar-cane also grows with very little care, and yields remarkably heavy crops. Without infringing on the land devoted to other staples no less than four hundred acres can be irrigated and planted with cane at Wailuku.

To take advantage of this opening for a sugar mill, about eighteen months ago, several gentlemen residing in Honolulu, purchased the landing belonging to the late king, commenced planting, and ordered a first class mill from Boston, which has arrived, and is now in progress of erection. The buildings, which are also being erected, are of stone, and located on the south bank of the Wailuku River where a steep descent gives superior advantages for a mill site. The mill will be driven by water, of which the river supplies an abundance. During our visit the wheel, which is a large and powerful and overshoot wheel with an iron frame was being erected by Mr. Robert Andrews. Mr. E. Bailey is the general manager of the plantation, and Mr. N. W. Tallant has charge of the field operations. About one hundred and forty acres belonging to the plantation are planted and growing; besides about one hundred acres belonging to the foreigners residing in the village. The mill, it is now thought, will be ready to commence grinding in July, or about twenty months after the first steps were taken to start the plantation. At present everything looks favorable, not only for the growing crops but for the entire success of the enterprise.

The day that we spent in Wailuku chanced to be that of the examination of the English there. The scholars, who were all natives, or half-castes assembled at the stone church and went through with their exercises with all the credit that could be expected in a village school of the kind. A somewhat novel exhibition closed the performances, which took some if not all of the spectators by surprise. The examination exercises were concluded, when suddenly an effigy was hoisted into the air with block and tackle, amid the shouts and hurrahs of the audience. From its appearance one was at a loss at first to guess whom it was intended for, though it bore a striking resemblance to Brother Jonathan. All doubt was soon removed, when the whole school rose and commenced singing "John Brown's Body Lies Mouldering In the Grave," with an enthusiasm which showed that they appreciated fun. When they came to the verse, "We'll hang Jeff Davis on a palmetto tree," a gun was fired at the effigy, the

ball passing through its body. The hurraing and deafening applause that followed this tragic execution of the arch-rebel, showed that at least the juveniles of Wailuku were Union boys of the right stamp, "sound on the goose." The incident served to remove the taint of secession, which the hoisting of Captain Gibson's flag in the valley three years ago, cast on the Wailukuans.

THEN AND NOW.

When we visited this district three years ago, there was not a sign of plantation, when now we see four in various stages of completeness,—the Waikapu, Wailuku, Waihee and Waiehu. The people (mostly natives) occupying the valleys, were then engaged in raising taro in the flats, which perhaps yielded a crop worth ten thousand dollars. Now nearly a thousand acres are waving with cane, which will produce at least one thousand tons of sugar annually, worth to the Kingdom one hundred thousand dollars, and this yield may be doubled in a few years. All this income will be expended from year to year in paying laborers and mechanics, erecting mills, stores, and villas which will act so much to the wealth and beauty of the country. Blacksmiths, carpenters and other artisans are locating in the neighborhood, and find constant employment, and already over one hundred foreigners are on the assessment tax rolls of these districts.

PROTECTION WILL COME AGAIN.

WILL Protection come again? Protectionists believe that "the greatest friend of truth is time." They expect Protection principles to vindicate themselves. They expect that the present period of Free Trade, like the Free-Trade period of 1893-'97 will be sufficient to inform the people of the undesirable consequences of departing from safe, sound, practical lines and embarking upon economic experiment based wholly upon theory. Protectionists believe that those who have been persuaded that a Protective Tariff is a fraud and a robbery of the consumer will naturally demand speedy relief from the alleged "burdens" of Protective Tariff laws, and they will not be satisfied with pretexts or excuses for the failure of the party in power to bring about a lower cost of living without at the same time diminishing the receipts and the profits of all gainful enterprises and occupations, whether of the forge, the factory, the forest, the fishery or the farm.

To maintain at their present level the spendable incomes of the masses, acquired under Protection, and also to increase the purchasing power of such incomes by reducing the cost of living, while assuring to all labor and production an undiminished increment and reward to the farmer maximum prices at the farm, and to the wage earner minimum prices for what he has to buy of the farmer's products; to the factory worker no less wages than before, but to the consumer a lower cost of the factory product; it is to such a contradictory scheme, to so incongruous and impossible a result, that the party of Free-Trade has committed itself. Of course, it will fail. It will not lower the price of the necessities of life except as it shall reduce the ability to pay. But reduced ability to pay is not what they want. They have been assured that it is perfectly feasible, through lower Tariff duties and increased foreign competition, to lower the price of commodities without lowering the price of labor. They want to be shown. Nothing of the kind is possible. Events will prove it. "The greatest friend of truth is time." Protection will come again.

Mr. V. L. Stevenson, editor and manager of the MAUI NEWS, for nearly two years, has severed his connection with the paper and will hereafter reside in Honolulu. 

PROCLAMATION.

ISSUED BY THE BOARD OF SUPERVISORS WITHIN AND FOR THE COUNTY OF MAUI, under and in pursuance of the Provisions of Act 117, Session Laws of 1913, of the Territory of Hawaii, entitled "An Act To Enable Any County, Or City and County, To Issue Bonds;" and calling for an election on the question of the issuance by said County of Maui of County Bonds, in the aggregate sum of \$119,000.00, such proposed Bonds to draw interest at the rate of five per cent per annum, interest payable semi-annually the term thereof to be 15 years, and the proceeds thereof to be used for the purposes hereinbelow, in this Proclamation, specified.

WHEREAS, Section 5, of Act 117, of the Session Laws of 1913, of the Territory of Hawaii, entitled "An Act To Enable Any County Or City and County To Issue Bonds," provides that:

"SECTION 5. When the board of supervisors of any county shall deem it advisable to issue bonds under the powers granted by this Act, it shall issue a proclamation calling such election at least 60 days before the date fixed therefor. Such proclamation shall set forth the amount, rate of interest, and term of the proposed bond issue; and also a detailed statement of the uses to which it is proposed to put the proceeds of such bonds, and the date of the election. A printed copy of such proclamation shall be posted in a conspicuous place in each election precinct of said county," and

WHEREAS, the Board of Supervisors Within and For said County of Maui deem it advisable that, under the provisions of said Act 117, of the Session Laws of 1913, of the Territory of Hawaii, bonds of said County of Maui be issued in the aggregate amount, at the rate of interest, for the term, and for the specific uses and purposes enumerated and set forth in this Proclamation.

NOW THEREFORE, in compliance with said law, and all other laws authorizing them so to do, Proclamation is made and notice given by the Board of Supervisors within and for the County of Maui, Territory of Hawaii, that a special election will be held throughout said County of Maui, on Saturday, the 27th day of June, 1914, between the hours of eight o'clock A. M., and five o'clock P. M., of said day, for the purpose of voting for or against the issuance, by the County of Maui, of County Bonds, in the aggregate amount, at the rate of interest, for the term, and for the purposes hereinbelow designated:

The amount of said bonds, in the aggregate, shall be \$119,000.00.

The rate of interest per annum of said bonds shall be 5%. Interest payable semi-annually.

The term of said bonds shall be 15 years; and

The proceeds derived from the sale of said bonds shall be used for the purposes, and in the proportions, named in the following detailed statement, to-wit:

ITEMS FOR PLEBISCITE.

1. IMPROVEMENT MAKAWAO WATER WORKS.....\$ 56,500

Plebiscite Campaign Underway

The following communications and resolutions are indications of the attitude of the people of the County of Maui on the bond issue question:

Wailuku, Maui, April 20, 1914.
To the Chairman of the Republican County Committee for and within the County of Maui, T. H.

Sir:—At a special meeting of the Democratic County Committee for and within the County of Maui, Territory of Hawaii, held on the 18th day of April, 1914, I was instructed by the said committee to notify your committee that the said Democratic County Committee had appointed H. C. Mossman, Esq., T. B. Lyons, Esq., Morris K. Keohokalole, Esq., J. H. Raymond, Esq., and Patrick Cockett, Esq., as a committee to meet and confer with a like committee selected from your committee, or from among the members of the Republican party in said County, upon certain important matters pertaining to the approaching special election to be held throughout said County, on Saturday, the 27th day of June, 1914, on the question of the issuance by said County of Maui of County Bonds, in the aggregate sum of \$119,000, for certain public improvements, and particularly as to the plans and details of a campaign to be carried on therefor. I was also instructed by said Democratic County Committee to respectfully request of your committee early action in this matter, so that, should your committee appoint such a committee, a meeting might be arranged between the two committees within the next ten days, or sooner if possible.

Sir:—I am instructed by our committee to reply to your letter of April 20th last, in which you invite the Republican County Committee to join your committee in making a campaign favoring the issuance of County Bonds by this County in the aggregate sum of \$119,000, for certain public improvements, and I am advised to say that the proposed bond issue under the laws of the Territory is a purely non-partisan matter, and for that reason the precedent established at a former plebiscite, when both political parties refrained from making political capital of the same will be faithfully observed by the Republican County Committee in this instance, and that this Committee will not, in any manner, use its party organization to induce voters to line up one way or the other, whether for or against the issue, but will leave the question entirely and unconditionally to the good judgment of the voters free from all party considerations or party obligations as republicans or otherwise.

RESOLUTION.

WHEREAS, the Organic Act contains a provision for the issuance of County Bonds, in pursuance of which the Legislature of this Territory during the Session of 1913, passed an Enabling Act, No. 117 Session Laws, empowering the Board of Supervisors of the counties of this Territory to take the initiative in such cases by issuing a pro-

clamation etc.;

AND WHEREAS, the Board of Supervisors of the County of Maui in accordance with the said law issued a proclamation on the...day of April for a plebiscite to be held or voted upon by the voters of this county on the 27th day of June, A. D. 1914, the said plebiscite being for the purpose of issuing bonds in the sum of \$119,000, for the purpose of the following improvements within the County of Maui, viz:

1. Improvement of Makawao Water Works..... \$ 56,500 00
 2. Improvement of Wailuku Water Works..... 13,500 00
 3. Construction of Re-inforced Bridges on the Maui Belt Road in the Hana District..... 22,000 00
 4. Construction of Section of Belt Road from Kihei through Wai-ohuli-Keokea Home-stands..... 12,000 00
 5. Completion Belt Road from Kaiue to Kahakuloa..... Flat..... 5,000 00
 6. Construction of Women's Ward and Cottages at Kula Farm and Sanitarium..... 10,000 00
- Total..... \$119,000 00

AND WHEREAS, there is no provision in said law for defraying the necessary expenses incidental to the conducting of a campaign of education, (which this committee deems necessary owing to the fact that this is the first attempt at taking advantage of the said law) the burden of expense must rest upon the citizens;

AND WHEREAS, this committee realizing that an organization only can assume such a burden as is necessary to properly present the subject to the citizen voters in such form as to insure its fullest comprehension and appreciation by the said voters, and being actuated only by a sense of patriotism, and devoid of any political ambition whatsoever; this committee in the spirit of its sacred duty to the body politic and in support of the Republican Legislature and the Republican Board of Supervisors of this county who are alone responsible for the said law, volunteered to co-operate with the Republican County Committee and together work to the end that the said law might be without prejudice to either party, properly presented to the said voters of the county;

AND WHEREAS, the said County Committee of the Republican Party declined to act with this committee for divers reasons, therefore;

BE IT RESOLVED, that this committee do hereby constitute itself a committee of promotion, to act without political bias or prejudice; to invite all citizens irrespective of creed or political affiliation to act with it in conducting a campaign of education in re the said plebiscite; to ascertain the correctness of the published statement of Senator H. A. Baldwin that four of the items of the said plebiscite were not needed, but were inserted therein by the Board of Supervisors as a political sop to catch votes; to pledge our sincere and hearty support to the said Board of Supervisors and applaud them for their courage and devotion to their sworn duty to enact such legislation as will insure the people of much needed improvements and promote prosperity in our community;

AND BE IT FURTHER RESOLVED, that this committee believes that political organizations if actuated by a desire to serve all of the people instead of some of the people at all times, can be honest and can be of great public benefit if the leaders so desire.

CITY OF MEXICO, Apr. 29.—Archives of the British Embassy will today be turned over to the Brazilian Minister by Sir Lionel Carden.

Bishops in Mexico have issued instructions to all clergymen to preach against invasion of Mexico by American forces.

DENVER, Apr. 28.—Colorado citizens have volunteered to resist strikers. There is much fighting going on. Two were killed and three wounded yesterday.

ECCLES, Apr. 28.—Deadly gas killed 190 men here yesterday. An explosion of coal dust formed the gas.

WASHINGTON, Apr. 27.—Diplomats think that the proposed mediation of the South American Republics in the Mexican matter will do no good. Huerta announces that he accepts Wilson's statement.

Foreigners in Mexico City are now not being molested and arrangements have been made for them to leave. The rebels and federals are fighting in Tampico. At Laredo ten are dead and twenty wounded, as result of clash on the border.

DENVER, Apr. 27.—Three towns are attacked by strikers with machine guns. Louisville is in flames and two men were killed when guards and strikers met.

WASHINGTON, Apr. 27.—President Wilson applies to Rockefeller to put an end to the strike in Colorado. The war department has been requested to send troops to Trinidad.

General Funston will command the marines at Vera Cruz. The marines have been detached from the Navy.

VERA CRUZ, Apr. 27.—Huerta has taken control of the Tehuantepec railroad.

TOKIO, Apr. 27.—Japan has decided to exhibit at the Panama Fair next year.

WASHINGTON, Apr. 26.—The Ambassador from Brazil and the Ministers of Argentina and Chili yesterday offered to serve as mediators in the difficulty between the United States and Mexico. Huerta accepts the proposition. A mob has been storming the American Consulate at Mazatlan.

TORREON, Apr. 26.—Villa requests the United States to hold Vera Cruz until he can advance on the City of Mexico.

Wailuku Gymnasium Growing

The Alexander House Gymnasium, popularly known as "The Gym" is becoming more and more the centre of athletics of all kinds in Wailuku. The presentation this past week of the Wall and Dougherty bowling trophy has attracted a very unusual amount of attention. The cup is on display in the window of the Maui cafe at the corner of Market and Main streets. Groups of boys and men have been stopping in front of that window admiring the trophy ever since it was placed on exhibit about a week ago. No handsomer prize was ever held out to Maui bowlers, and the Gym members are conjecturing already how large a handicap will be allowed in the two years contest about to be pulled off.

It is understood that the records of the last big tournament at the Gym will be used by the Committee in determining the handicap for the Wall-Dougherty trophy. This is certainly a fair way of settling the matter of handicap, which is always difficult to adjust to the satisfaction of everyone. Presumably everyone worked hard on the last cup, and

the score will be a fair one by which to judge. The present trophy is valued at about \$175, so that the winner of this one, will have a prize worth keeping.

The Gym membership has been materially strengthened the last week in consequence of the arrival of the trophy, for according to the rules that govern the Gymnasium, no person can bowl for a trophy unless he is a member in good standing.

Careful inquiry was made as to the night of the Fourth, and no entertainment of any kind had been scheduled. The Gym Committee then decided to have a dance at the Gymnasium on that night. The managing of the affair was placed in the hands of the Athletic Committee to arrange all details.

The roof of the Gym has been painted with grapolotum. Two coats were used on all seams, three coats on the window casings, and one coat over the entire roof. E. H. Wilkins was awarded the contract, and the job has been done most carefully to the satisfaction of the Committee.
