Meheula Indicted

NO DESIGNS AT PRESENT

COL. YOUNGHUSBAND'S EXPEDITION INTO THIBET AROUSES INQUIRY AND SUSPICION AS TO BRITAIN'S ULTIMATE DESIGNS ON THAT COUNTRY—OFFICIAL DENIAL OF ANY PRESENT DESIGNS.

LONDON, November 30.—It has been officially announced, in view of rumors growing out of Col. Younghusband's expedition into Thibet, that Great Britain has no present designs on Thibet.

Defeated Government Leaves Santo Domingo

FORMER PRESIDENT AND SECRETARY OF STATE SAIL FROM THE LAND WHERE THEIR ENEMIES HAVE PREVAILED—DESTINATION OF FORMER RULERS IS UNKNOWN—ELECTION IN JANUARY.

PUERTO PLATA, November 30.—President Morales and Secretary of State Alfon have sailed from San Domingo where they sought refuge on a German warship just before the capitulation to the Jimenez revolutionists. The elections under the new government will occur in January.

COLORADO MINING STRIKE BROKEN.

DENVER, Colo., November 30.—Many miners are resuming work in the northern district. The presence of the state troops has served to prevent the threatened violence against mining property. The strike is now thoroughly broken in the northern district.

CUTTING WAGES IN MASSACHUSETTS.

BOSTON, Mass., November 30.—An average cut of ten per cent in the wages of 75,000 textile workers has been announced by various factories in the state. The cut will go into effect tomorrow, the first of December.

ANOTHER DREYFUS REPORT.

PARIS, November 30.—The commission appointed to report on the question of reopening the Dreyfus matter and revising the judgment of the courts in the past will soon submit its conclusions in the matter.

AMERICAN DETECTIVES ACCOMPANY LOUBET.

PARIS, November 30.—American detectives who are widely acquainted with anarchists on both sides of the Atlantic, will accompany President Loubet on his visit to Italy, as a measure of precaution for his safety.

WILL NOT ENTER POLITICS.

NEW YORK, November 30.—The central organization of the Federated trades has decided not to enter politics at this time. It is supposed that the scandals that have arisen in connection with walking delegates such as Sam Parks, have had some influence in determining the organization to arrive at this conclusion.

POLICE AND PEOPLE IN CONFLICT.

LONDON, November 30.—Constant conflicts between the troops and police on the one side and the people on the other, continue in the Russian districts of Armenia.

FEDERAL GRAND JURY'S STORY

Legislative graft was handled without gloves by the Federal Grand Jury. In its report to Judge Dole this morning, Solomon Meheula, clerk of the House, was indicted for destruction of public documents. A number of House vouchers, seven of which were in favor of Meheula, are missing altogether and the jury found two bills against Meheula. Another indictment is against James H. Hakuole, cashier of the Internal revenue office, for embezzlement. There were twenty-two other indictments, mostly against Japanese, for perjury, peonage, adultery, bigamy, and importation of women for immoral purposes.

On receiving the report Judge Dole thanked the jury for the work done and made a few remarks about it. "Your report has informed me more fully than I knew before," he said, "of the work of your body and of the important character of the work my predecessor called to your attention at the beginning of the term. I wish to thank you for what appears to me to be very thorough and exhaustive investigation of matters of great importance to this Territory which refer very closely to two important parts of the laws for

public protection, first the protection of women and of the public morals and second the protection of tax payers against wastefulness and unlawful taking of public funds entrusted to officials." Judge Dole concluded by saying that the report appeared to him to be of great value to the Territory and to the authorities of other courts, which might take action such as the federal grand jury has not power to take.

The report in full is as follows: Honorable Sanford B. Dole, Judge of the United States District Court for the Territory of Hawaii.

Sir:—The Grand Jury, empaneled, sworn and charged by the late Honorable Morris M. Estee on the 12th day of October, 1903, having concluded its duties, begs to submit herewith the following report:

The Grand Jury has had before it for deliberation 24 cases, which have had thorough investigation, and in all of which, after careful consideration, true bills of indictment have been found and returned to your Honorable Court. A list of these cases is hereto attached and made a part of this report.

With the exception of four cases, two of which related to violations of the Postal Laws, and one each of which related to violations of the Customs Laws

LAW TAKES ITS COURSE

James H. Hakuole, cashier of the Internal Revenue Office, who was indicted by the Federal grand jury this morning for embezzlement, is said to have been found \$164 short in his accounts, when Collector Chamberlain returned from the mainland last week. On resuming direct charge of the office, Chamberlain had the books and cash checked, with the result that Hakuole was immediately asked to make an accounting and was removed from his position.

The shortage is said to have all occurred during the past month. It is also said that Hakuole made good after being removed and when he found that prosecution was likely, but this does not stop the inevitable procedure of the federal offices. Unlike what has often been experienced by defaulters in the Hawaiian government in the past, Uncle Sam's employes report everything to the proper source and the law takes its course.

The matter was at once reported by Breckons to the grand jury and the jury sent for the books of the Internal Revenue Office and had as witnesses Collector Chamberlain, and Deputies Couzens and Drake. When asked regarding the matter today Chamberlain said he would rather that there had been no prosecution, but that he had no option but to report what had occurred. The grand jury voted an indictment and Hakuole was placed under arrest this morning.

Hakuole is a well known Hawaiian. He was formerly interpreter of Japanese in both the Federal and Territorial courts and before that was in the customs service in the same capacity. He was educated in Japan and has a very thorough knowledge of the language, as spoken and written in the universities and among the higher classes of Japan, though in the Tanbara case many complaints were made by friends of the defendant as to his rendition of some of the lower class expressions which go to make up the dialect of most of the Jap coolies in Hawaii.

UP TO THE TERRITORY.

The Federal grand jury's report, the House vouchers and the tabulated list of them, will be turned over by Judge Dole to Governor Carter, who will in turn present them to the Territorial grand jury. The result may be indictments under the laws of the Territory against some of the grafters of the last session.

The Federal jury practically found that there were cases in which indictments should be brought, but said that there was no federal law covering the cases.

APPOINTMENTS ANNOUNCED.

The appointment of Dr. Cooper as President of the Board of Health and of W. A. Wall as Territorial Surveyor have been announced.

CABLED TO ROOSEVELT.

Governor Carter has cabled to President Roosevelt the recommendation of A. L. C. Atkinson for Secretary of the Territory.

Atkinson Secretary

REPUBLICAN EXECUTIVE COMMITTEE UNANIMOUSLY RECOMMENDS HIM AND HIS APPOINTMENT IS THEREFORE PRACTICALLY CERTAIN—HAS STATED HIS WILLINGNESS TO ACCEPT THE POSITION.

A. L. C. Atkinson was unanimously endorsed, with three cheers thrown in, for the position of Secretary of the Territory yesterday, by the Republican Territorial Executive Committee. It is understood that he has stated his willingness to take the position and he is therefore very likely to be the choice.

Atkinson was Carter's choice for the position, as well as the choice of the committee, but has all along declared his preference for remaining with his law practice. He will, however, take up the office just vacated by Carter if offered the appointment.

It is expected that President Roosevelt will follow Carter's recommendation in the matter of an appointment, and Carter will send Atkinson's name when he received notice of the action taken yesterday. The appointment of the new secretary will therefore probably be made very soon.

Heavy Sea Washed Out Railroad Track

HEAVY SURF DOES MUCH DAMAGE TO THE RAILROAD TRACK BETWEEN KOOLAULOA AND WAIANAE POINT—TRACK INUNDATED IN NUMBER OF PLACES—FORCE OF MEN BUSY MAKING REPAIRS.

The prevailing southerly and westerly weather that has lasted now for a week has caused the sea to be very rough on the western side of the island. Reports from down the road give an accounts of the track being washed out.

The railroad track between Koolauloa and Waianae Point appears to have suffered greatly from the inundations by the sea. The track was undermined and either washed out or caved in at a number of places along that section of the railroad track. This accident occurred yesterday. The railroad company had the work train and an ample force of men on hand, however, to repair the damage and there were practically no delays in the train schedules.

GOODBYE.

Exit Executive Council. Governor Carter will hold one consultation with the heads of departments and will outline his policy, but the Council as a regular weekly meeting will be relegated to the lumber room. Mr. Carter will have consultations with each head individually, either weekly or more frequently, and where the interests of two departments are concerned will have both heads in consultation, but the Council as a Council will cease to be.

The Council had no legal standing and that some of the members who attended fully realized. The excuse for its existence was that it gave an opportunity for all heads of departments to know what was going on. But the result was that there was a considerable waste of time. Land questions were discussed which purely lay between the governor and the land office. The details of these things took up time, which some of the department heads might have put to very much better purpose than simply sitting and listening. So with the liquor licenses. Two heads, the Treasurer and the Attorney General, were directly interested in these and could have discussed them with the Governor, but there was no reason why any other department heads should take any part in the matter. The Governor, the Treasurer and the Attorney General are directly responsible for these matters, the other heads of departments have absolutely no responsibility for them. Yet the discussion of licenses pro and con took up a great deal of time.

It is curious to watch the gradual decadence of the old Council. In 1900 it started out with three meetings a week, later it came down to two, and finally to one. It has ever been a source of friction with the public because the meetings were not open to the press, and it has justly been argued that what is done in secret will very frequently not bear the light of day. In doing away with the Executive Council Governor Carter has made a popular move, which is sometimes wise and sometimes not, but he has done something which is far more important, he has expedited the business of the Territorial departments. Governor Carter has come in with the intention of carrying on the administration on a thoroughly business basis. He will cultivate simplicity and will set all his officials an example of hard work and untiring energy. Governor Carter begins well.

NATIONAL EDUCATION.

The report of the Commissioner of Education, Dr. Harris, for the last fiscal year shows a steady growth. The total number of pupils enrolled in the public elementary schools throughout the country was 15,925,887, an increase of 215,493 as compared with the preceding year. The average daily attendance for the year was 10,999,273 or 69 per cent of the number enrolled. This is stated to be the largest average attendance as compared with the enrollment ever reported. It must be remembered that in many parts of the country school attendance is not compulsory. Where it is the average is much higher. For instance in our own Territory, where there is compulsory attendance the average is much higher. The average attendance for the whole islands at last report was 88 per cent. On the Island of Hawaii it was 87 per cent, on Maui, Molokai and Lanai 90 per cent, on Oahu 85 per cent, and on Kauai and Niihau 89 per cent. These percentages are higher than almost any place on the mainland, but then school attendance in the Territory has always stood high, especially among the Hawaiian population.

The average number of days each pupil attended school in the United States was 100, which is twenty-two days in excess of the highest hitherto. For the first time in the educational history of the United States the average school taxes reached 145 days, that is 145 teaching days. In some places, however, the schools were open but sixty days, notably in parts of Arizona. With us the teaching term lasts 190 days, while in the East the teaching term in several exceeds 200 days. Saturdays and Sundays are excluded from the count of course.

The figures given above refer to the enrollment in the elementary public schools. If to those figures the statistics of private elementary and secondary schools, business schools, private kindergartens, orphanages, schools for defectives, and so forth, there is a total of 18,080,840 pupils receiving instruction in educational institutions in some portion of the year. This total represents an increase of over 300,000 with the corresponding number for the previous year. This of course is out of a population of 80,000,000 roughly speaking.

It is interesting to see what the numbers in this Territory are. The enrollment in our public schools on June 30, the end of the fiscal year was 13,793 against 13,189 in 1902, an increase of 604. The enrollment of private schools, elementary and secondary, private kindergartens, orphanages, &c., was 4622 against 4329 in 1902, an increase of 293. This gives a total enrollment of 18,415 pupils as against 17,518 pupils on June 30, 1902, or a total gain of 897 pupils during the year. The gain in this Territory, then, has been greater in proportion than the gain for the whole United States, indeed it has been twice as much in proportion, and this certainly should be very satisfactory to our authorities and to the citizens of the Territory. It shows that our school officials are alive.

Another interesting feature of Dr. Harris' report is that which attempts to give some notion of the average amount of schooling which each individual has received at different times. According to an estimate in the report the total average amount of schooling received by each inhabitant of the United States in 1800 did not exceed eighty-two days. By 1840 the average had risen to 208 days, and as the result of the great interest in education in the succeeding decade, largely owing to the influence of Horace Mann and his disciples in New England, an influence which was felt throughout the country the average rose to 420 days in 1850. Twenty years later in 1870 the average had risen to 672 days and it continued to advance until it reached 1032 days in the last fiscal period. Of this total 930 days were furnished by the public school system.

In the Territory of Hawaii where according to law a child must attend school during a period of ten years, and where the school terms are uniform throughout the country, if a child never missed a day's schooling it would be possible to have 1900 days schooling during the school period. That ideal can never be reached. But the average of last year would give 1672 days schooling to each individual. This of course is very high. It must be remembered, however, that unlike the schools of the counties on the mainland, many of which are open during only sixty or ninety days annually, our schools are open for the full school term, and have been so since their establishment over fifty years ago. Very few places have such a record as this.

One interesting fact disclosed by Dr. Harris' report is that the recent marked increase in the average amount of schooling per inhabitant has been largely due to the increase in the number, size and population of the cities in the south, owing to the influence of the railroad and manufacturing towns. Another very interesting fact is that the school statistics of this Territory compare very favorably with the general statistics of the whole country.

A remarkably heavy increase in the official statistics, amounted to \$2,000,000 in circulation is recorded for 1903. This represents an increase the month of October. The money in of over \$22,700,000 for the month, and circulation on November 1, according of over \$91,300,000 as compared with the

corresponding date last year. The most noteworthy increases for the twelve months were one of over \$38,800,000 in gold certificates and another of over \$41,700,000 in national bank notes. The decreases were of small amount, except in the case of Treasury notes of 1890, which fell off over \$8,900,000, or over one-third. The circulation per capita came within a cent of reaching the thirty-dollar point (\$29.99) showing an increase of 24 cents for the month, and of 63 cents as compared with November 1 of last year.

It is reported that of the eighty or more beet and cane sugar factories of Spain, all except two or three have just been merged in a sugar trust. The former finance minister, Lopez Fuiguerer, has been elected chairman of the board of directors. The best-sugar industry of Spain, although comparatively young, is already far more important than the cane sugar industry. The two together produce almost 100,000 metric tons annually, some of which is exported.

Of course the United States will not recognize the government of Jiminez in San Domingo. The revolutionists have fired on the American flag and have avowed they will not pay damages to an American steamship company. The government of Jiminez is not likely to last long.

After all the fine dinners and luncheons that Bryan has been indulging in during his European tour, he will find it hard to come down to hot cakes, corn fed pork and hominy. It is to be feared his digestion will be ruined.

The Postoffice scandals, so the President promises, will bring retribution to all connected with them. If our Grand Jury is as successful with the investigation of the Hawaiian Legislature scandals we shall be keeping well in touch with the American ideal. It is time some of our people should recognize that there are ideals.

Emperor William of Germany seems to be a very sick man. Since his father died of a throat affection, it is very natural that there should be grave fears about the present emperor, whose throat is also affected. The emperor is by far the strongest personality among the European rulers, and he has done much for his country. No loss is irreparable, no man is indispensable. The hour always produces the man. But should anything untoward happen to the Emperor it would be a very serious matter for Germany just at present.

Levy, the celebrated cornet player, who died the other day in Chicago, passed through Honolulu many years ago. He played at Kawaiahaeo church, which was the only large assembly hall in those days and was impartially used for religious services, state ceremonies from taking the oath of a King to funerals, concerts and even political meetings.

The Japanese hack license clause which appears in the county act, was tacked on after the bill had been passed. It was one of those little legislative tricks which were constantly crop-

ping up during the last and the previous session. The Japanese are going to test the section and in all probability they will win their case. Many lawyers consider the section unconstitutional. This fact however will not vitiate the county act as such. The Courts hold that sections may be declared void without vitiating the whole law. It is well however that the bill goes to lawyers.

The retirement of Lord Roberts as Commander-in-Chief of the British Army will bring forward Lord Kitchener to the post in every likelihood. Roberts though an excellent general and strict disciplinarian is not the hard handed man which Kitchener is, and has found social influence and age equally against him. Kitchener like Wellington is a man of iron—the latter was called the Iron Duke—and would be able to cope with the influence of "pull" as we call it on this side of the Atlantic. It is said that King Edward is very desirous of army reorganization. Of course there are other men, trained under Kitchener, who may prove as good as he is.

The Kohala ditch is once more in the air, and justly so. There is nothing that a Territory should be more careful of than the giving of franchises or the granting of exclusive contracts. They have been a curse in many parts of the mainland. Governor Carter's idea of operating this as a Territorial affair is a very sensible one, the only question is can it be carried out on such lines. It is very much better to have public benefits in public lands. The profits then accrue to the citizens of the Territory and not go into the pockets of a few shareholders.

MANY JAPANESE CLAIMING BRIDES

FOURTEEN JAPANESE WOMEN HELD UP FROM THE CHINA—THEIR HUSBANDS HAVE BEEN CLAIMING THEM EVER SINCE—SEVERAL MARRIAGES CONDUCTED AT THE IMMIGRATION OFFICE TODAY.

This has been a busy day at the Immigration Office. Husbands have been seeking their wives and marriages have been going on all the morning. All of the women claimed arrived on the S. S. China and were held up until their spouses came to claim them.

Fourteen women and two men were held up from the China. The husbands of the various women have been appearing at the immigration office ever since the departure of the vessel, to claim their wives. This morning several marriages occurred at the immigration office. Ordinarily one Japanese minister performs all of the marriages. But today, as there seemed likely to be a heavy number of people matrimonially inclined, an additional pastor was requested by several of the couples. The ceremonies were all performed as soon as the husbands had satisfied the immigration officials that the women were entitled to land and that the husbands of their brides were really who they claimed to be.

The Japanese man who was found swimming in the water away from the S. S. China last Thursday was declared a stowaway and refused a landing. He will be deported on the Gaelic Wednesday.

On the recommendation of Immigration Inspector F. M. Bechtel, the immigration department has waived any report concerning the possible alien inmates of jails or hospitals on the Island of Molokai. The regulation makes the steamship companies that bring an alien immigration to America, liable for the keep of the alien, provided he or she had a disease before landing, which subsequently caused the party to become a public charge after landing. The steamship company is not liable, however, for the keep of any alien who becomes a criminal within the limit specified by the law.

NEVADA WILL SKIP HONOLULU

The American-Hawaiian Steamer Will Sail Directly From Kahului on Return to San Francisco.

The S. S. Nevadan will not sail directly from Honolulu for San Francisco on her return trip to the Coast. The steamer is due tomorrow morning from San Francisco. She will leave Honolulu Wednesday afternoon for Kahului and arrive at that port Thursday morning of this week. She will take whatever freight is on hand at that port and sail directly for San Francisco. She will start December 18 on her return trip to Honolulu. No return freight at Honolulu is the cause of her not returning to Honolulu from Kahului this week.

The ship George Curtis is now alongside the Oceanic wharf waiting for sugar ballast for San Francisco. She will take the sugar cargo from the steamer Mauna Loa which is due tomorrow morning from Hawaii and Maui ports. The Curtis will not depart for the Coast, however, until after the arrival of the steamer Niihau from Punaluu. The Niihau sails today for various Maui and Hawaii ports. She will probably not return before the first of next week, as the weather is likely to be rough. She will endeavor to bring Punaluu sugar for the Curtis. The German bark Solide is taking on ballast at the Railway wharf. She is waiting for orders. She will be ready for sea in a day or so.

The barkentine S. N. Castle departs today for San Francisco with a small cargo of sugar for ballast.

The bark Gerard C. Tobey has hauled over to the Sorenson wharf to take on ballast. Her destination has not been positively settled. She may be sent to San Francisco.

JAPS AND CHINKS PLAYING POKER

Great American Game Has Fascinated Orientals From Usual Methods of Gambling—Many in Police Court.

The Great American Game appears to have captivated the residents of the Oriental quarter. If the record in Judge Lindsay's court be any indication the fascinations of paikow, pakapio and fan tan are on the wane and draw-poker is now claiming disciples.

The police court record this morning showed the largest number and variety of defendants that has been arraigned in months. There were no less than 73 cases. Out of this number 56 were for gambling. Sixteen of the gambling defendants were charged with playing draw-poker. It is not often that any defendants for poker playing are in the police court. The Oriental seems to have been seduced, however, by the game.

The Chinese were not the only ones who had been guilty of the offence of poker playing. Even the Japs succumbed and were caught. Three different resorts on Hotel street were raided. The majority of the defendants forfeited bail. Others who did appear were fined \$3 and costs.

MITCHELL'S MISTAKE.

Mr. John Mitchell is a level-headed man, but he got himself very badly tangled in his speech before the National Civic Federation. He said that though a man might have a legal, he had no moral right to work where he pleases. He has both rights, and in them the state is bound to protect him. But even if it be admitted that he has no moral right, the legal right of itself is sufficient to insure him the protection of the law.—Indianapolis News.

WHY THE IRISHMAN FAILED.

An Irishman in Australia who had hunted long for gold and found little complained bitterly that he was not born a fool. Many who were his friends, "that are born fools, aye, and was fools before that," were rich, he said. "An' why? Because the born fool goes diggin' in places no sensible man wud look at—an', by jiminy, the gould's there!"

MR. BALFOUR.

Mr. Balfour, prime minister of Great Britain, is one of the mildest of men. Even on his favorite golf links at North Berwyck or St. Andrews the strongest explosive that has ever come from his lips is said to be "Dear me!" Arriving after dark at a large railway station one day Mr. Balfour set his traveling bag down on a bench while he went to make a purchase at a bookstall. On returning to the bench he took up his bag and made the unpleasant discovery that during his absence the bottom had been cut out and the contents adroitly abstracted. "Dear me!" exclaimed the statesman, with a melancholy smile, "it is evident that there is something radically wrong about this bag."

SAVED HIS ARM.

Gen. Hunter of the British army had his arm badly wounded at Omdarman, and the surgeons decided upon amputation to save his life, fearing mortification. "Very well," said the wounded officer, quietly, "but understand, if you take off my arm I shall blow out my brains as soon as I can get hold of a pistol." Knowing the general's iron determination, the surgeons consulted again, and Hunter still has his arm, though it is of little use.

and the Internal Revenue Laws, the investigations of this Grand Jury have been mainly along two special lines. The first of these may be called the "Peonage and Importing of Women Cases."

PEONAGE CASES

This Grand Jury was specifically charged by the late Honorable Morris M. Bates as to its duties relative to offenses arising under Sections 5526 and 5527 of the Revised Statutes of the United States, known as the "peonage" statutes, and Section 2 of the Act of March 3, 1882, relating to the importing of women into the United States for the purposes of prostitution. Many witnesses have been examined by this Jury, with the result that its findings were reached only after a searching inquiry into the complex social conditions and requirements of the heterogeneous population of the Territory. This Grand Jury believes, Honorable Sir, that in all large communities there are as radical differences in ethical standards as exist in Hawaii, and that Sections 5526 and 5527 of the Revised Statutes and various similar provisions of the Statutes of the United States are fully as applicable to almost every eastern city of the United States as to this Territory. The several bills of indictment which were returned to your Honorable Court under these statutes were found by this Grand Jury in the belief that any woman living in the United States of any social status whatsoever has the right to demand and receive the full protection of the law, and that any person who assaults in any way in restricting that right, is answerable under the laws of the United States and the laws of all humanity.

MISSING VOUCHERS

The indefatigable industry of the United States District Attorney, Robert W. Breckons, Esq., in securing witnesses and bringing evidence before this Grand Jury has been of invaluable assistance in enabling the Jury to reach its conclusions, and the Jury desires to congratulate this Honorable Court upon having such an efficient and unprejudiced Attorney.

This Grand Jury desires to express its appreciation of the services rendered by the U. S. Marshal E. R. Hendry.

Upon the adjournment of the Territorial Legislature for the session of 1923, the Secretary of the Territory was unable to fully comply with the provision of the Organic Act, which makes it his duty to record and preserve all of the laws and proceedings of the Legislature and transmit within thirty days copies of the same to the Secretary of the Interior of the United States. Owing to the fact that there were never deposited in his office the Vouchers of the House of Representatives, showing an expenditure by that body of a sum of over \$50,000.00 during the regular and special sessions. After deliberation, this Grand Jury decided to investigate this matter and subpoenas were therefore issued to every member of the House of Representatives and to the Clerk of the House, to appear before it. Clerk Solomon Meheula produced vouchers which had been drawn on the Treasury amounting to over \$50,000.00. Upon checking these vouchers, it was found that 29 warrants had been drawn, amounting to \$1999.95, which had no corresponding vouchers. Seven of these warrants were in favor of Clerk Meheula. A list of these vouchers, showing the date of drawing, number, amount, and purpose for which drawn, has been prepared and is presented herewith as a part of this report. The list is arranged so as to show in columns the name of the person to whom the warrants were made payable and the aggregate amount received.

PLENTY OF LAW

Honorable sir, a self-respecting community has supreme contempt for one of its own number who, while temporarily invested with disbursing power, stoops to slip his hand into the community till, and to balance the accounts, lumbers up the cash book with glittering phraseology concerning patent fictitious services, and that community very emphatically, and properly so, classes such an act along with that of the hangman but successful forger who raises a check. The Penal Code amply covers such acts. After a careful study of the vouchers surrendered to it, and a rigid and repeated questioning of witnesses brought before it, this Grand Jury is of the unanimous opinion that during the last session of the Legislature the Treasury of this Territory was in several instances knowingly looted by the drawing of warrants against vouchers signed and approved by a chairman of committee for services never performed; that in certain instances, also, vouchers were

PREPARING TO INVADE THIBET

KARACHIA, (British India), November 16.—The Viceroy, Lord Curzon, and party, escorted by four battle-ships, sailed today on a tour of the Persian Gulf.

The expedition, commanded by Colonel Younghusband, which is being prepared in India to support the British mission to Thibet, starts in a few days. It has been ordered to occupy the Chumbi valley, the key to Thibet, and to advance on Gyangtz, an important center 150 miles from Lhasa. The object of the mission is to discuss with the Thibetan authorities their non-observance of treaties and consequent injury to the trade of India and Thibet.

The Dalai Lama treated the mission offensively and sent subordinates, who refused to receive the British unless the latter retired from Khambalong into Indian territory. Colonel Younghusband refused to do so, fortified the camp occupied by the mission and then himself returned to report to the Viceroy. The result is that the former has been granted a considerable force to support the British demands.

A settlement of the matter is improbable. The Lhasa Government

declares it is determined to fight. It is distributing quantities of rifles and is telling the people to prepare for war. The soldiers throughout the country have been warned to be in readiness.

It is reported in India that the Thibetans expect Russian support against the invasion. A Russian embassy who formerly was in the Chinese customs line and has acquired great influence over the lama and priests, who claim to have discovered by divination that the present year is propitious for war. The Government of Nepal, a state on the frontier of Thibet, has warned the people of Thibet against the Russians and has given notice that Nepal will not assist the Thibetans against the British.

Thibet is made up largely of tablelands ranging from 10,000 to 17,000 feet above sea level. Its area exceeds 300,000 square miles, but much of this vast region is unproductive and abandoned to wild animals. Between Thibet and India lie the high Himalayas. No exact census of the region is possible, but the population is known to exceed a million. In Southern Thibet the climate is delightful in summer, but severe in winter.

In many parts agriculture flourishes. The chief industries are connected with wool, the great and inexhaustible staple of the country. Iron mines are worked by the natives and precious stones abound.

The country is subject to China, but the church and state are intertwined, the lamae dividing authority with the appointees from Peking. The Dalai Lama exercises almost absolute authority in his dominion. Over 80,000 priests are supported by the Government. Buddhism is the prevailing religion.

The natives live in a semi-barbarous state and plague keeps the population down. The army is poorly equipped and armed, and inefficient, but imbued with a strong anti-English sentiment. The population of Lhasa is about 100,000, but a migratory element is constantly passing through the town.

SOUTH AFRICA GREAT MARKET

BRITISH REPORT SHOWS A RAPID INCREASE IN TRADE WITH THE LAND WON BY THE BOER WAR.

LONDON, November 17.—The Board of Trade today issued an interesting blue book, containing the report of Henry Birch-nough a writer on statistical and political subjects, who was sent to South Africa as a special commissioner to inquire into the present condition and prospects of British trade in that country.

In his report Commissioner Birch-nough lays stress on the magnitude of the South African market which, he says, has increased 250 per cent in the last ten years, the greatest increase, however, having been shown in the last two years. The annual value of this trade now exceeds \$25,000,000, and the commissioner says that the rapidity with which South Africa has come to the front as a great market for the exploitation of British manufacturers is almost startling.

Commissioner Birch-nough points out that a decade ago British exports to South Africa were under \$45,000,000, while during the last year they exceeded \$130,000,000. In 1923 South Africa stood sixth in the list of Great Britain's customers, but last year it was beaten only by India. The Commissioner predicts that South Africa will this year be the largest buyer in the world of the products and manufacturers of the mother country.

These facts, the Commissioner says, will make South Africa one of the greatest factors in commercial and industrial expansion. The present depression in mining and in general trade he considers to be only temporary.

While there is a strong sentiment in favor of British goods, British manufacturers, especially those in the engineering trade, show a decided lack of vigor and enterprise. Their most serious competitors are the manufacturers of the United States and Germany. Commissioner Birch-nough points out that competition from the United States is materially aided by the low freight rates at which competing British vessels carry American cargoes. German competition is not formidable except in the case of electrical machinery.

The Board of Trade Commissioner summarizes the causes of successful foreign competition, naming among them the superiority of some of the natural resources of foreign countries, the greater exercise of ingenuity and inventiveness, of closer study of the requirements of those with whom they deal, greater alertness and less conservatism, the superiority of some of their business methods, their closer adherence to contract dates of delivery, the adoption of standardization, and the better finish and make-up of their goods, as well as the fact that their products are dumped from protected home markets. Other considerations pointed out by the commissioner are the greater liberality in terms of sale and the presence at the mines of American engineers who are favorably disposed to American machinery.

BOUND AND SET ADRIFT IN BOAT

AN ALASKA PROSPECTOR FLOATS OUT TO SEA AFTER BEING SHOT AT BY KARLUK INDIANS.

SEATTLE, November 17. — Bound hand and foot, Joseph Moore, an Alaskan prospector at Cape Karluk, was placed in a boat by Indians and set adrift and as the craft floated out to sea the would-be murderers fired a number of shots at it. Manager particulars of the diabolical deed were received tonight from passengers on the Copper river steamboat Santa Anna. The shots were wild, but they served to attract the attention of some men in a steam launch, who picked up the boat.

INJURY TO CHARLES DOLE.

Polo Player Badly Hurt By Fall From Horse.

Charles Dole, the well known polo player, met with a serious accident Saturday while riding horseback in Koolau. In company with Mr. Derby, both of whom are of the late firm of Kinsey, McLaughlan & Cooper, Mr. Dole was going to F. M. Swany's place on the other side of the island.

The young men started to race on their polo ponies. Derby got the lead. He heard a noise behind and turning his head saw Dole lying on the ground, the polo pony also prostrate. Dole had evidently been thrown and struck on his head. The young man was unconscious. He was removed to the residence of Edgar Henriques in Nuuanu Valley. Drs. Cooper and McDonald attended Dole.

Young Dole was unconscious until late Saturday evening. He is in a semi-conscious state during all of yesterday. Concussion of the brain appears to be the cause of his condition. The skull was not fractured. He was better this morning.

FIRE CLAIMS DECIDED. Judge Dole on Saturday heard and decided the case of W. F. MacLennan, United States Treasury Agent, who disbursed the fire claims fund, against Tong On Kee and M. S. Grinbaum & Company. The suit was one of several brought by MacLennan to determine the ownership of fire claims awards. The real issue was between the two defendants, the plaintiff withdrawing after the issue was raised. Melania Indicted

approved and warrants drawn for services for which there were gross and flagrant charges, and the proceedings, therefore, under the Penal Laws of the Territory would secure convictions.

This Grand Jury is aware, Honorable Sir, that it has no power to find indictments for violations of Territorial Laws and it therefore most respectfully requests this Honorable Court to permit such information concerning these vouchers as is in the possession of this Honorable Court, together with a list of the vouchers such as is made a part of this report, to be transmitted to the Attorney General of this Territory, with the request that the Territorial Grand Jury investigate this matter.

This Grand Jury is of the unanimous opinion that, as an example of an unbusinesslike and negligent manner of authorizing the expenditure of \$50,000.00 of the public funds, the methods followed during the last session of the Territorial Legislature stand unique; as an example of the possibilities and opportunities for systematic grafting they are monumental. From the testimony of witnesses before it, the Grand Jury learned that the following method was supposed to be pursued to secure payment for services rendered or material furnished: The person performing service would present a bill for such services to the chairman of the committee for which services were performed, approved by the chairman of the committee the bill was then approved by the chairman of the Committee on Accounts, and presented to the Clerk of the House, who would thereupon draw a warrant for the amount specified in the bill. The approved bill or voucher was then supposed to be filed in a stub book provided for that purpose. In no instance did this Grand Jury learn either that any other than the chairman of a committee examined a bill, or that any record of bills approved was kept, nor was there any evidence brought before it to show that the vouchers and accounts were ever audited. Had there been such auditing, this Grand Jury is of the opinion that it would not have found, as was the case, many vouchers without a mark of approval by chairman of committees or receipt by the person to whose favor warrants were drawn by the Clerk of the House.

UP TO THE TERRITORY

Honorable Sir, this Grand Jury was astonished at the spectacle presented by a body of men, selected by the electors of this Territory to perform neither legislative nor executive but administrative functions, granting the right to an individual not a member of that body to authorize the payment out of the Public Treasury of \$50,000.00 and in no way providing for the proper recording of financial transactions or of auditing the accounts thereof, or of finally depositing such accounts with a public officer. And this Grand Jury is of the unanimous opinion that the honor of the Territory and its representatives, and the economic management of its finances, demands the enactment of such a law or laws as shall properly regulate and control the expenditures by future legislatures.

According to the testimony of the vouchers, this Grand Jury finds that during the session of the Legislature warrants were issued to J. H. Wise amounting to \$1472.75, for which there are vouchers. Up to and including March 30th, Mr. Wise had drawn \$295.75, or at the rate of over \$10 per day. During the month of April Mr. Wise drew \$787. On the 4th of April Mr. Wise drew in four vouchers \$129.50. On the 11th of April, six vouchers were issued to Mr. Wise numbering 306, 312, 313, 314, 315 and 316, for the following services: "Clerk Agricultural Committee, \$30.00;" "Clerk House Bill No. 115, \$5.00;" "Clerk Chinese Fund, \$5.00;" "Services Education Committee, \$20.00;" "Services Police Committee, \$20.00;" "Clerk Public Expenditure Committee, \$20.00;" a total of \$129.50. On the 16th Mr. Wise drew \$139.50, although on the 16th he had drawn \$163.50 for "translating."

ENOCH JOHNSON

From the vouchers and witnesses examined, this Grand Jury finds that Enoch Johnson was employed from time to time and that during the session warrants for which there are vouchers were issued to him amounting to \$1258.25. According to voucher 382 Mr. Johnson received from "Pauoa Water," \$50 and from Pahoia Water \$100, a total of \$150.00. And yet from the testimony in the matter, this Grand Jury is of the opinion that the extent of Mr. Johnson's services to each committee was a visit to the Springs, a possible total attendance of ten hours upon the committee, and the drawing up of a short report. On April 25th, two vouchers were issued to Mr. Johnson, No. 473 entitled "Chinese Fund" for \$115.50, No. 502, subdivided as follows: Drawing report Chinese fund... \$ 50.00 Typewriting, 30 folios, 25cts... 22.50 Services Clerk Chinese Fund... 150.00 Legal Opinion... 30.00 \$312.50

From considerable testimony heard bearing on this voucher, including that of a majority of the members of the committee on the "Chinese Fund" and that of Mr. Johnson himself, this Grand Jury is of the opinion that the report was drawn up by two members of the committee, although Mr. Johnson's approved voucher for that service was \$50; that the extent of Mr. Johnson's typewriting was less than one page of the report, although his charge for that service was for 30 folios, \$22.50, even though the report itself contains but 30 folios; that the extent to which Mr. Johnson served the committee as clerk was one meeting, during which time he waited for two hours in the

visitor's room, while the committee held its meeting in an adjoining room, although Mr. Johnson's approved voucher for that service is \$130.00; that Mr. Johnson's legal opinion, for which he received \$80.00, was never rendered to the majority of the committee, or to the two members who drew up the committee report. Representative Kumalae signed the declaration upon the voucher that the services were rendered.

CHARLES WILCOX

According to the vouchers, from April 25th to June 2, Charles Wilcox was given warrants amounting to \$401.25, for the following services: Clerical services, compensation for arranging papers... \$ 20.00 Comparing bills... 30.25 Revising and comparing House Bills... 25.50 Comparing and revising... 19.00 Correcting and revising bills... 37.50 Aiding and assisting Clerk in preparing Journal... 25.00 Comparing Journal and arranging papers... 45.00 12 days comparing Journal of House... 84.00 5 days comparing Journal of session... 35.00 2 days comparing Journal of session... 14.00 \$401.25

Computing from three specific vouchers, the compensation for comparing and revising was at the rate of \$7 per day. During this period, according to the House Journal, there were a possible thirty-one days of session. At the rate of \$7 per day, Mr. Wilcox was paid for 57 days and a half. During the same period, Mr. Wilcox also drew \$46.75 for typewriting and \$30 for four days services as clerk of the Fire Claims Committee.

During all this time, J. P. Makinai was Assistant Clerk of the House of Representatives for the session at a salary of \$5 per day and drew his pay as such. During the session he also drew \$258 for translations, \$290 for services to the County Committee, \$263 for services to the Committee on Accounts and \$116.25 for overtime and extra work as assistant clerk. Makinai's total warrants for which vouchers were found was \$1754.00, or at the rate of \$14.61 for the sessions, per day.

BIRBE INCLUDED

According to the House calendar, from April 1st to April 18th inclusive, there were 16 days. Yet from the vouchers, T. H. Moresman drew warrants for 18 days service to the Committee of Public Lands and Internal Improvements at \$6 per day five and one half days service as Clerk to the Judiciary Committee, at \$5 per day, and in six warrants at \$150.50 for three days services to the special committee on Charles Wilcox at \$5 per day, or \$150.50 for a total of 26 1/2 days, out of a possible sixteen days. It is the opinion of this Grand Jury that the rates for such "services" were excessive.

After a careful examination of the accounts, this Grand Jury is of the opinion that charges like \$46.90 for "Express Rapid Transit," \$90.00 for "Services Rapid Transit & Land Company," for which warrants were issued to H. C. Birbe, Jr., are excessive; and it is of the opinion that the taxpayers of this Territory are entitled to itemized statements of "services" rendered by W. R. Sims, for instance, who, on the presentation of thirteen vouchers, drew warrants amounting to \$709.45; of the services rendered by M. K. Nakama, who of which amounted to \$249.00, under the title of "Translating and Typewriting;" of the "services" rendered by F. J. Te-

ta, who is given 18 warrants, amounting to \$854.25; of the "services" rendered by W. H. Coney, who, with eleven vouchers, under the title of "Typewriting and Proof-reading," was given warrants amounting to \$425.76, and who, under the title of "Report Rapid Transit," "Hawaii Electric," "Chinese Fund"—all comprised in one voucher—drew \$115.50; and of the "services" rendered by John K. Prendergast, who, with sixteen warrants, drew \$667.50 and of the "services" rendered by George Markham, who drew a warrant for \$15 on the strength of a voucher entitled "Services and Attorney Investigating Tanks at Iwilei," and a warrant for \$28.00, entitled "Services as Clerk and Attorney in Investigating Iwilei Tanks."

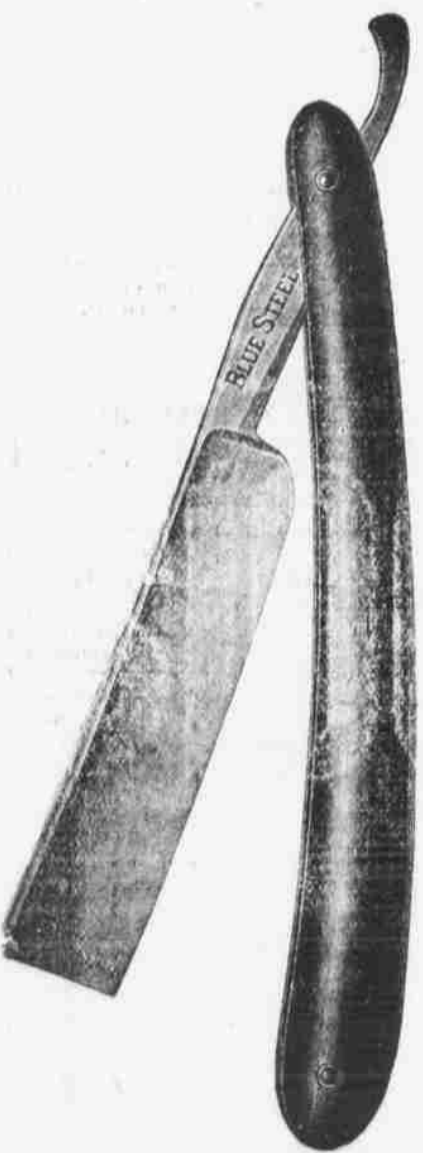

MACARTHUR TO PEARL HARBOR GOES WITH ADMIRAL TERRY ON IROQUOIS TO INSPECT THE SITE FOR NAVY YARD TODAY.

Admiral Terry, General MacArthur, Colonel West and Captain Rodman, U. S. N. went to Pearl Harbor this morning on the U. S. S. Iroquois for the purpose of making an official inspection of the locks and places of interest about Pearl Harbor.

The vessel was commanded by Captain Rodman. She got away shortly after 10 o'clock this morning. Admiral Terry and Captain Rodman will show to General MacArthur the site for the proposed Naval Yard at Pearl Harbor and also explain the plans of the government regarding the harbor. The trip is one of special importance for it will enable General MacArthur to obtain an idea of the site of the Navy Yard and the necessity of the government fortifying the island of Oahu in such a manner as to protect the Navy Yard and make Oahu impregnable. General MacArthur will no doubt have this matter in mind when he makes his report regarding the fortifying of the island to the War Department. The party is expected to return to Honolulu at 4 o'clock this afternoon.

Tomorrow morning General MacArthur, Admiral Terry, Colonel West and possibly other representatives from the army and navy will drive around the island. This trip will be an official one for General MacArthur. The party will occupy several days making the drive.

On last Saturday General MacArthur inspected Camp McKinley.

YOUNG DOLE IS CRITICALLY ILL

IS NOT CONSIDERED OUT OF DANGER BY THE PHYSICIANS—CHANCES FOR HIS RECOVERY

There has been no marked change in the condition of Charles Dole, during the last twenty-four hours. The injured young man is still in a critical condition. The chances are favorable however for his recovering from the injury he sustained Saturday by being thrown from his horse.

A consultation was held yesterday by Drs. Cooper, McDonald and Wood. The physicians appreciated that the condition of the patient was serious nevertheless, the general symptoms were considered by them to be favorably indicative for recovery.

Both the temperature and pulse of the injured man are about normal today. It is in a comatose state today, he would be apt to be unconscious but things have not appeared to be clear to his mind. One favorable symptom was found however in the fact that there has been no paralysis of either the arms or limbs. This fact indicates that the injured man has not suffered a severe cerebral hemorrhage. Had a severe cerebral hemorrhage occurred a paralysis of the limbs would have resulted. The injured man is not out of danger by any means yet. He is very critically ill but the chances of recovery are favorable. He is still at the residence of Mr. Henriques up Nuunuu valley.

MANY STEAMERS ARE LAYING UP

IWALANI JOINS NOEAU, HANAIEI AND WAIALEALE — HANAIEI GETS BOTTOM SCRAPED.

A great many island steamers are now laying up. The present time is the calm before the storm however, for the sugar season will soon set in and with it will come busy times again on the water front.

The steamer Iwailani which returned yesterday from Hawaii ports will be laid up indefinitely. The steamer Noeau has been laying up for some weeks and the steamer Waialeale has also been out of commission receiving a general overhauling. Either the Noeau or the Waialeale will soon go back into commission. The steamer Niihau goes out on the runs of those three boats today but this plan will not be maintained permanently.

The steamer Hanalei which has been over in the stream for months, went on the marine railway last week to receive her overhauling. She will not however go into commission yet.

The steamer Claudine is still receiving an overhauling at the Bishop wharf. She will not go back on her Maui run until about the first of the year.

The steamer Kaulani is laying up indefinitely.

Reports from Kaimuki by the steamer W. G. Hall Sunday give the following amount of sugar on hand at various Kaimuki plantations: Diamond W. 300 bags, McBryde 1250 bags, H. M. 450 bags and L. P., 1250 bags, total 3,250 bags.
