The Special Operations Group shall expedite the filing and processing of applications of qualified occupants of land in Tondo Foreshore Lands, including Barrio Fugoso and Barrio Magsaysay and the so-called Magsaysay Village, with the end in view of issuing Orders of Award or Certificates of Occupancy, as the case maybe.

The Chairman shall organize the Special Operations Group into effective working units by assigning the work to be performed by each member of the Group, subject however to the approval of the Deputy Governor for Administration, who shall exercise direct control and supervision over the said Group;

The field teams are directed to conduct information drive for expeditious accomplishment and submission of applications and shall also process the same in accordance with existing laws and regulations before they are forwarded to the Central Office for final processing. The Team Leaders are hereby authorized to administer oath to applicants on matters of verification and investigation. In the performance of their duties, all members of the team shall wear name-plates for identification purposes.

Subject to availability of funds, the complement of the three (3) teams re-organized under this Order shall be allowed one (1) unit per diem plus transportation allowance not exceeding ₱2.50 per day inclusive of Saturdays, as an exemption to Memorandum Circular No. 13, dated August 1, 1966. Central Office personnel of the Group is hereby authorized to render overtime work with meal and transportation allowance.

The Department Manager for Administrative Services is hereby directed to provide supplies, materials and office equipment needed by the Group. All departments and divisions of the Land Authority are hereby directed to extend all assistance to the group in order that it may accomplish its assigned tasks.

This Order revokes Special Orders Nos. 152, 172 and 271, all Series of 1970, and all other orders, circulars and/or memoranda inconsistent herewith are hereby revoked, superseded and/or modified as the case maybe.

This Order shall take effect immediately.
