DOG HAD BOARDER'S PET

HOW C. ROSE REMOVED A CANINE.

Claimed the Dog Had Annoyed Various Sick People—Defendant Fined Fifty Dollars by Judge Wilcox.

The tale of a dog was told in Judge Wilcox's court this morning, and it gave an opportunity for an internal boarding house row to be aired. Charles Rose was the defendant in a case of malicious injury, W. T. Bray being the complaining witness. The parties in the case lived at the same house on Haalelea Lane, and though neighbors, they were far from being good friends. As a matter of fact, the entente cordiale was decidedly strained. The ill feeling between the men was probably occasioned by a small pet dog belonging to Bray, and when Rose proceeded to remove the cause of the domestic strife by drowning the dog in the bathtub, Bray became furious, and sought satisfaction in the court. He got it to the extent of \$50, the amount of the fine levied upon his enemy.

When the case was called, T. McCants Stewart, the attorney for the defendant, announced that they would enter a plea of guilty with the understanding that they could place some witnesses upon the stand in order to show extenuating circumstances. Mr. Stewart admitted that though his client had not shown much consideration for the feelings of either the dog or the owner there had been great provocation for the summary action that Mr. Rose had taken. It was then that the rather original method of trying the case, as if the defendant had not pleaded guilty, was witnessed.

F. E. Clark was the first witness for the defence. He said that he had lived at the same house with the defendant and was acquainted with the dog. Instead of the animal being worth \$200, as claimed by Bray, the witness regarded it as an ordinary cur dog. Bray had caused the animal to become a great nuisance by throwing articles for the animal to fetch at late hours of the night. There were several sick people about the house, but this appeared to make no difference to Bray. M. J. Bissel testified to the annoying character of the dog. In fact, it had been a source of much feeling among other people about the house, who especially resented the action of the owner in washing the animal in the same bathtub that boarders had to use. The dog had disturbed the wife of the witness while she was sick, and on that occasion he had remonstrated with Mr. Bray about the animal. There were, moreover, other reasons why the animal was disagreeable about the premises, although she was quite a small dog.

Charles Rose testified that the dog had prevented him from sleeping a number of nights while he was sick, and although he had complained to Bray twice, the latter had still persisted in causing the animal to bark and raise a disturbance late at night. The same night that Mr. Bissel complained the witness threatened to kill the dog as soon as he got over his illness. The opportunity for revenge came on July 8, when, in a moment of canine credulity, the hated dog followed Mr. Rose into the bathroom. Mr. Rose lost no time in giving the dog a bath which would be remembered, for he promptly drowned the animal.

J. W. Rowell, C. L. Spriggs and Mr. Hendricks appeared as dog character witnesses. Two of them had lived at the same house with Mr. Bray, and they announced that the deceased pet had a fine reputation for amiability and lovable disposition. In fact, Mr. Spriggs said that although it was an ugly cur dog, won the love of all the boarders. The court fined the defendant \$50.

CONSUL MOET.
Henri Moet, who has been the French Consul here for several months, left yesterday by the Alameda for the Coast and thence to Paris before going to his new post of consular duty at Galveston, Texas. Mr. Moet has made many friends during his stay here.

MCDONALD LEFT BILLS.
High Sheriff Brown stated this morning that he believed McDonald, the missing census enumerator, had left the Islands. According to the investigations of the authorities, McDonald left a number of debts behind, and it is supposed that these were the cause for his strange disappearance. He owes one man in Wailua \$70, and to another in Pearl City is due \$150. There are also other bills it is claimed. The creditors also say that McDonald has probably taken French leave.

NO SPRECKELS SUBSIDY

NEW SOUTH WALES GOVERNMENT REFUSES.

Will Not Contribute to the Line of New Boats Because British Vessels Are Barred Out.

SYDNEY, July 2.—An important step was taken yesterday by the Postmaster General after consultation with the Premier. It was that the New Zealand Government should be informed that it was not intended at present to contribute anything towards the proposed subsidy to the Spreckels line of boats between Sydney and San Francisco. The history of this matter is a peculiar and complicated one. For years the passenger traffic and mail service from Sydney via Auckland to San Francisco has been conducted by the Union Steamship Company of New Zealand, in conjunction with the Oceanic Steamship Company of San Francisco, which is another name for the Spreckels firm. The Spreckels is a huge Californian corporation, with large interests in shipping, railway and sugar enterprises. It has, too, enormous sugar interests in the Hawaiian Islands, of which Honolulu is the center.

By an arrangement with the Spreckels, the Union Steamship Company of New Zealand maintained the service for many years, with only the subsidy which they receive from the governments of New Zealand and New South Wales. The government of the United States refused to contribute anything. The subsidy, however, was not a large one, and did not require this colony to pay more than \$4,000 or \$5,000 a year as its share. Of the boats that were engaged in the trade, Spreckels provided two, the Alameda and the Mariposa, and the Union Steamship Company one, the Monowai, which was afterwards replaced by the new boat, Monna. This trade was to some extent cut into by the Vancouver line, which was carried in the face of great difficulties until the boats were taken over by the New Zealand Shipping Company. Now a monthly service is kept in existence, and mails pass all the way under the British flag. Connecting at Vancouver with the Canadian-Pacific Railway, they are run through Canada on the train known as the Imperial Limited, in about 100 hours, and then shipped direct across to Liverpool. New South Wales comes in to the Vancouver line a subsidy of \$10,000 a year, the Queensland Government a small amount, the Fiji Government something, and the Canadian Government a larger amount than the rest combined. This service is now on a substantial footing, and has helped materially to foster and increase the trade relations between this country and Canada.

A few years ago the United States Government, which had previously set its face dead against mail subsidies, decided to enter upon a policy of encouraging shipbuilding in America by heavy payments, though hedged around with conditions which absolutely prohibited any but American firms from competing. The Spreckels obtained a subsidy for their two boats, and determined to renounce the whole mail service, with three steamers of larger build and greater speed, and secure the subsidy which the United States Government was offering. Accordingly three steamers were placed in hand. One of them is now almost ready for sea. They were all to have been completed months ago, but owing to strikes in the yards of the Cramps at Philadelphia, where they were being built, the work was much delayed.

Not satisfied, however, with the subsidy that they are to receive from the United States Government the Spreckels are asking New Zealand and New South Wales to contribute an additional subsidy of \$20,000 a year in support of the new line. The Union Steamship Company, which hitherto, has shared the service with the Spreckels, is not to be allowed to participate in the new scheme, so that it will, if present arrangements are concluded, drop out of the service, after having assisted to maintain it for many years.

The matter is being taken up quite warmly in New Zealand. The feeling, judging by expressions of opinion in the press there, appears to be growing against any local subsidy to the company. The head of the firm of Spreckels intends to visit New Zealand and Australia towards the end of the year in order to bring pressure to bear on the government of this colony and of New Zealand, with a view to securing an annual subsidy. There seems, indeed, to be a disposition to offer inducements with the object of attracting an improved class of boats to the Vancouver line, so as to insure more frequent and more rapid passages than are possible at present.

GERMAN WARSHIP COMING

THE CRUISER GEIER TO COAL HERE.

Has Been Ordered to Proceed From Acapulco, Mexico, to China—Was at Havana During War.

The German residents are looking forward to the arrival of one of the cruisers from the German South Pacific fleet. She is the Geier, and will coal here on her way to China. The exact date of the arrival of the war-ship is not known, but she is expected within a week.

Information of the coming of the vessel was secured from the last newspapers. The dispatches announced that the cruiser had been ordered to proceed at once to China to reinforce the fleet of that nation. In view of the recent warlike utterances of the Kaiser concerning the murder of his Minister by the Boxers in Peking, it is very probable that the Geier will be called upon to take part in some severe fighting. This will not be the first time that Captain Peters, her commander, has been close to the smell of powder recently. During the Spanish war the Geier was sent to the Cuban coast to look after German interests there, and for a while she was an object of considerable speculation among the American newspaper correspondents. A number of Germans were taken by the Geier from Havana to Mexican ports while the war was in progress, and fears were entertained of the bombardment of Havana. Since then the vessel has been serving most of the time with the South Pacific squadron of the German nation. When the orders were issued for her to engage the Geier was at Acapulco, Mexico. Inasmuch as it will not require more than eight to ten days for the vessel to coal and reach here, she ought to be reported within a few days. How long the ship will remain in Honolulu is not known by the German Consul General. No time will be lost, however, in coaling her and continuing to the destination. The German people here will entertain the officers of the ship, but owing to the rather short visit which she is expected to make, there will probably not be any elaborate entertainment given.

ARRAIGNED FOR MURDER.
Arimoto Appears Before Judge Wilcox This Morning.

The case against the Japanese, Arimoto, charged with killing a countryman at Kahuku last March, was called in Judge Wilcox's court this morning. The defendant was arraigned on a charge of murder, and the case is not known by the police. The prosecution of the case was continued until Monday morning, when the defendant would be given counsel and he could plead.

George Davis offered to act as counsel for the defendant if the court desired to conduct the examination today. The attorney said that he would act as the defendant's attorney only during the conduct of the case today. The court declined the offer, stating that the case had already been set for pleading, and they would attend to it at the proper time.

BIGGER THAN THE PHELPS.
New Vessel Which Captain Graham Will Command.

Captain Graham of the big ship Erling M. Phelps, leaving today for San Francisco with the largest cargo of sugar ever taken from here by one vessel, will probably be the master of an even larger new vessel than the Phelps in the near future.

Shipbuilder Sewall of Maine, the owner of the Phelps, who is a new vessel building more large windjammers all the time, and he has strong faith in their increasing value for many years in spite of the fact that round the Horn freight steamer lines are being established, and the ships propelled by steam seem to be cutting so deeply into the business that has been left to the wind vessels.

Captain Graham is another of the masters who stood against the crimps, and he has succeeded in getting a crew without their aid.

The Phelps has been newly painted, and she lies now, low in the water, is a most beautiful sight.

LEFT HIS HORSE UNHITCHED.
Kisnima, a Japanese, was before Judge Wilcox this morning to answer to a charge of having violated section 356 of the penal law by leaving his horse unhitched in the public street. The defendant claimed that he had been called suddenly into a house to aid a sick friend and, as the latter was nearly dying, he feared to waste any time so left the horse unhitched. The court thought Kisnima should not have been so hasty in the regard of mercy, and fined him \$5 and costs.

MORE INSURANCE SUITS.
New Zealand and Royal Companies Made Defendants.

Six suits for insurance, growing out of the New Zealand and Royal companies to pay for loss caused by the burning of Chinatown during the plague, were filed in the Circuit Court today. Three are against the former company, and the balance against the Royal people. Ho Chan et al. want \$1,500 from the New Zealand company. Ah and Robert F. Lange claim \$1,000 from the same company, while Ching Ying asks for \$1,500. In the suits against the Royal Company the damages aggregate \$2,600. The plaintiffs in these cases are D. L. Akwai and Gow Ching and Ida E. Lamb. The cases were set for November 5.

RAPID TRANSIT PLANS

COMPLETE SYSTEM PROMISED IN A YEAR.

Company Will Run Ten Minute Cars During the Day and Twenty Minute Cars at Night.

The Honolulu Rapid Transit and Land Company in its prospectus just issued has made the first official announcement of its status, plans and expectations since the company was organized.

It is announced that of the \$700,000 capital, \$250,000 has been put up and \$50,000 of the capital stock is in the treasury to be issued in the future. The estimates of "cost of construction and equipment including site, buildings, and machinery is placed at \$600,000, \$300,000 of which will be provided by the issue of stock (\$250,000 having already been issued and paid) and \$300,000 by the issue and sale of 6 per cent, 20-year gold coupon bonds, with the privilege of redemption after ten years, secured by a first mortgage on all of the Company's franchises and property, at present owned and to be acquired. This issue will be known as Series "A," and is part of an authorized possible issue of \$300,000. The remaining \$300,000, if issued, to be used to purchase the franchise and property of other corporations, having objects altogether, or in part, similar to the objects of this Company, or to extend the tracks and equipment of the Company.

The Company is the owner of a very desirable power-house site containing upwards of two acres, for which Thirty-three Thousand Dollars (\$33,000) has been paid, and upon which the car-barn and boiler rooms and offices are now being erected, all the necessary foundations, of a most substantial character, having been completed.

After an exhaustive examination of the different street railway systems in use in the United States, the Directors determined to install an overhead electric system.

The Company has purchased, at an expense of upwards of \$200,000 and has in transit, the following material and equipment:

Three 340-h. p. tandem, compound condensing engines, of the Corliss type, with the necessary auxiliaries, including condensers and Green's fuel economizer. Three 300 Kilowatt generators, direct connected to engines. Three 250-h. p. Babcock & Wilcox water tube boilers. Thirty-five cars of the most approved design, with cross seats and centre aisle, having a seating capacity of from thirty-two to forty passengers each, included in these are eight duplex convertible cars. Three thousand tons of eighty-five lb. girder rails with the necessary channel plates, tie-rods, bolts, spikes and copper bands. This will lay twenty-three miles of track. Cables and poles for ten miles of the road bed and overhead structures.

The material includes 700,000 bricks and steel trusses for the car-barn, power-house and office quarters, and other material consisting of tools and electrical appliances to be used in construction.

Constructing of the road bed will begin during the early part of September, next, and it is expected that the entire mileage of at least twenty miles will be in operation within a year from the present time. The system will extend through the business parts of the City, reaching all the suburban districts toward the North, East and West, the South being towards the water front. Construction throughout will be of a high class.

The entire system, consisting of six different routes, will be operated on a ten-minute headway service from 6 o'clock a. m. to 8 o'clock p. m., and from 8 o'clock a. m. to 11 o'clock p. m. on a twenty-minute headway.

"The climate of the Hawaiian Islands," adds the prospectus, "on account of its enervating character, is such as induces traffic. If the opportunity to ride is given, advantage is invariably taken of it, consequently taking the population at thirty-five thousand it is equal to any city of double that population in the United States, for railway traffic purposes."

STRIKE AT KAUAI ENDED.
Japanese Returned to Work at Former Wages.

The steamer James Makee arrived early this morning from Kapaa, with two cabin and 21 deck passengers. All of the trouble on Kauai has quieted down and the laborers are back at work. The Japanese went on a strike several days ago demanding an advance from \$17 to \$20 a month. This was refused and the men remained idle for a short time. They finally decided to accept the former schedule. The ship experienced fine weather throughout the entire trip. The passengers were Mrs. T. Jackson and Mrs. Unama.

M'KINLEY AND ROOSEVELT

HAWAII REPUBLICANS TO RATIFY THE NOMINATIONS.

Plans for a Monster Demonstration on the Return of the Delegates From the Philadelphia Convention.

The special committee on reception to the Republican delegates to Philadelphia have practically completed arrangements for an all day time of it next Thursday, although the main features will occur at evening. It is the intention of the committee to have the city elaborately decorated, and to that end all Republicans are urged to hang out their banners and string their bunting.

That night there will be a torch light procession, followed by a ratification meeting at the Drill Shed. At the latter place some big speeches will be made. It has been suggested to the committee that there be a huge bonfire on Punch-bowl.

At the ratification meeting at the Drill Shed, George W. Smith will preside. Governor Dole is down on the list as one of the speakers.

The three returning delegates, Judge A. N. Kepoikal, Sam Parker and Charles B. Wilson are expected to make addresses.

If National Committeeman H. M. Sewall returns with the delegates, he, also, will be put on the program for a speech. Others who will be on the program are Enoch Johnson, J. H. Boyd, T. McCants Stewart and others.

HARRY LEE SHIPPED OUT
PUT ABOARD ALAMEDA AND SENT TO COAST.
Relative of Spanish War Leader Closes an Uncomely Career in Honolulu—Confessed He Lied.

Harry Lee, a young man who has been gathering a reputation about town for some months, was "shipped out" of the country by the police yesterday afternoon. With Lee it was a case of go to jail for vagrancy or return to the Mainland. Some creditors rather preferred to collect before he went away, but learned from the police that their claims were not worth the breath to be wasted in a trip to the water front and back. So they all agreed that Lee should go, and that their blessings should go with him. There was trouble during the day over his departure in a way other than embargement and debt, and Orpheum chorus girls. It seems that Lee told Detective Dick Bowers that while he was an inspector in old Chinatown early in January, he broke open the safe of a Celestial, took out \$4,300 and gave it to Attorney Strauss and another gentleman. Yesterday one of the parties of the second part heard the story and got mad. His first move was to accuse Lee. The latter, finding himself cornered, went off into a sort of a trance, and when he recovered admitted that he had lied.

"Everybody jollies Captain Bowers," he said, "so I thought I'd also give him a pipe dream."

The interviewer informed Lee that if he ever used his name in other "pipe dreams" his face would very soon thereafter look like ten cents worth of cat meat. Before leaving Lee filed an affidavit to the effect that his statement to Bowers was wholly false.

This man Lee claimed to be a nephew of General Robert E. Lee, and a close relative of General Fish and Lee. A Virginian in town affirms that he is of good family, but does not substantiate the General Lee connection. During his stay here Lee was in constant pillage, some of his dealings being very discreditable. Only a few days ago he was charged with embezzling funds of the Hawaiian Electric Company. This incident brought his local career to a focus and an unhappy end.

WILL FEAST DELEGATION

DEMOCRATS ARRANGING FOR A LUAU.

Representatives to Kansas City to be Given Poi and Roast Pork—Meeting of Last Night.

The Democratic Central Committee decided last night to give a luau to the delegation to Kansas City upon the return of the party to Honolulu. It is not known when the members will arrive. They expected to catch the Kilo on July 19, but J. D. Holt wrote a friend here that that vessel was crowded with passengers. The luau will be quite an extensive affair. In reply to a question Colonel McCarthy said, however, that the feast would not be thrown open to the electorates of the group, but that it would be an "invitation" affair. "The function will not be a vote catching institution," the chairman of the Central Committee added. "Its only purpose will be to extend the glad hand to the returning delegates, and to assure them that their work has been approved."

The resignation of C. L. Rhodes from the office of secretary and as a member of the Central Committee was accepted, and John Wise was elected secretary in his place.

The Republicans will receive their delegation to Philadelphia next Thursday evening. Should the Democratic delegation also arrive by the Kilo on that date, the luau will take place the next evening.

Governor Dole, through Wray Taylor, has notified the leaders of the Independent party that recommendations for inspectors and judges of election are now in order. That party, as well as the Republicans and Democrats, will be given representation.

FOR A NEW CHURCH.
Another One to Propound the Gospel as Read by Kekipi.

Several Honolulu musicians are going to Wailua tonight to assist in the concert in the native church there. Among the number are W. J. Coelho and members of the Quintet club. The funds from the concert will go toward building a new church in Kohala, Hawaii, in which the Kekipi doctrine will be expounded.

This Kekipi doctrine or religion is a new creation. Kekipi was a Congregational minister of some note, a few years ago he evolved a new religion, remembering that of the faith curers of the Mainland, and left his old church to expound it. Naturally, he met with success, for the natives take to anything of that kind without much reserve. Several churches are now established, and the Kekipi faith seems likely to become quite a factor in religious life of the Islands.

BIG TREE CONDEMNED.
One of the great trees near the Ewa market corner of the capital grounds will be cut down. This was decided upon by Superintendent McCamless yesterday. The tree to come out is the big one in the middle of a trio, and it is condemned in order that the other two may have room to spread. Of late years the trees have grown so large that their branches are now interwoven.

LABOR DAY PARADE.
The various trades unions of the city will have a meeting in a few days to arrange for a big parade for Labor Day in September. It is proposed to have business floats in the parade, several other striking features. At night will be some speech-making and probably a dance. Mr. Dugan, head of last year's committee, will be on Kaula in September, so he has declined to serve as chairman. The chairman of the committee will likely be selected from the force of boiler-makers at the Honolulu Iron Works.

THE YACHT NORNA.

Commodore Weaver's Swell Craft to Become a Trader.

News comes from Sydney of the seizure and sale of Commodore Weaver's fine yacht, the Norna. This boat was here last year, and after divers experiences left for New Zealand. Bert Peterson was a passenger by her at the time, to his sorrow. The following from a Sydney paper of June 29, is the sequel to the tale of the Norna:

"The leading members of the tea trade and a number of merchants, numbering about fifty, were the guests of Messrs. Gerber, Michaut & Co. on board the yacht Norna, of Elizabeth Bay, yesterday. After partaking of a substantial luncheon, the toast of "The Queen" was enthusiastically drunk, followed by that of "The Firm," which was responded to by Mr. Gerber. Other toasts included "The Norna," "The Tea Trade," "The Selling Brokers," and "The Press." The company then inspected the smart little craft, which elicited expressions of admiration on all hands. The Norna is, we understand, about to be stripped of her tasteful furnishings and fittings for the more commonplace requirements of trade with the islands in the service of her present owners. The Norna has seen some highly interesting service along the coasts of America and in the east, and after a life of adventure and luxury she is now destined to raise her white wings in the humble capacity of an island trader."

WAR IN CHINA.

A List of Dates of All the Principal Happenings.

Feb. 26—Reported that Chinese in Shantung intend to arm and attack German forces sent to interior to protect railway construction.

April 1—Shantung insurgents, "Boxers," have entered Chihli.

April 25—Fighting reported between Chinese troops and Boxers near Pao-tungfu in Chihli Province.

May 6—Welshel Boundary Commissioners attacked by Chinese insurgents.

May 17—News received that Boxers or Hwo mob killed 13 native Catholics, destroyed a village at Tshishin, 70 miles from Peking.

May 24—Force of 70 cavalry killed by Boxers in Chihli Province.

May 25—China promises the Powers to adopt measures for suppression of rebels.

May 29—Reported from Tientsin Boxers have burned station at Bullino, 29 miles from Peking, and killed several Chinese employees.

Sept. 22—22 men landed from Japanese gunboat Atago at Tientsin.

Railway between Tientsin and Peking cut.

Powers decide to send troops to Peking.

May 30—Foreign contingents being landed at Tientsin.

June 4—Reported Boxers have captured Tunchow on the Peking-Tientsin railway.

Rev. Messrs. Robinson and Norman murdered by Boxers at Yung-ching.

Communication between Peking and Tientsin stopped.

June 10—Allied force under Admiral Seymour leaves Tientsin for Peking.

June 11—Sixty British dispatched to protect Mr. Kinder at Ketsushan Station.

June 13—Death reported Mr. Sugiyama, Clerk, Japanese Legation, murdered by Imperial troops at Peking.

Rebels enter Tientsin, burn down Roman Catholic church.

June 17—Taku forts began firing on allied squadrons; engagement ensued; forts taken and occupied.

June 18—Li Hung Chang, having been summoned to the North, left Hongkong today.

June 23—Allied force relieves Tientsin.

Foreign Ministers have joined Seymour eight miles out of Tientsin.

June 25—Reported Admiral Seymour has returned to Tientsin, having had 62 killed, 313 wounded.

June 28—German Minister Baron von Ketteler killed in Peking.

HARVESTED AT NIGHT.

The farmers have done rapid work in cutting wheat this week. The grain was in fine condition, but was liable to damage by wind. On the big Gordon ranch, in Elkholm township, three sets of men were engaged, each working eight hours and using the same binders. At night lanterns were hung on the horses and the work went on the twenty-four hours round. Many farmers followed this plan.—Kansas City Star.

THE CIVIC FEDERATION, INDEPENDENT OF MUNICIPAL ORGANIZATION, The Federation Has Defined Objects Which do Not Depend on the Creation of a City Government.

George Carter, who is a member of the committee of five to organize a local civic federation, is not strongly in favor of municipal organization. He has not inquired into the question very closely, but if it will result in an increase of taxation his sentiments will be against such measure. It will have no bearing, however, upon his connection with the federation. "At the present time," he said, "the rate of taxation is high enough in this place. Under our new government we lose the customs duties and revenue from the postal department, while the cost of maintaining the Government has not been lessened much. As the result of this it may be found necessary to increase the present rate of taxation, which is unusually high. The assessor values property here at its real value, not at half, as in other places. The result is that any increase of the rate would be felt more than if the method in the States were in vogue. The civic federation, which is being discussed, has for its objects the improvement of Honolulu by giving better harbor facilities, better roads, better lighting, and the addition of such improvements as will help and beautify the place. The question whether these can be better secured with Honolulu a municipality is a point upon which I am not positive. It is possible that the incorporation of the place will not be necessary, for they can be secured through our present system of government. I am cordially in favor of doing everything which will benefit this place, but I cannot see how municipal organization will affect the civic federation."

JAPAN'S POSITION, Mr. Abe's Mission Here is to Correct Wrong Impressions, YOKOHAMA, July 6.—Since the annexation of Hawaii by the United States, the position of the Japanese settlers or contract laborers has not been a very enviable one. By the 15th of June last they became free laborers with the consequence that the degree of control necessary for the maintenance of good order among them, became somewhat relaxed. Still the Japanese immigration companies, of which the Hiroshima Immigration Company is the most prosperous, important and well-organized, contrived to bring the pressure of their position to bear upon them to insure harmony between the Hawaiian planters and the laborers. Whether the companies were supported in the matter by the Tokyo Government, it is unnecessary to inquire, when it is remembered that Japan's yearly profit from this source is considerable. Prompted as the authorities are by a strong desire to promote the commerce in every possible direction, they are prepared to discontinue the undertaking, however profitable, if the conditions are not as the Government wish them to be. Also, they have decided not to send emigrants, except through the organized companies. Mr. Abe, secretary of the Foreign Office, will leave for Hawaii tomorrow, with a view to removing the wrong impression formed by the planters about the Government's policy regarding the Hawaiian immigration.

ARMSTRONG INSTITUTE, At the meeting of the Armstrong Institute held yesterday afternoon it was decided to merge the organization in that of the Teachers' Association. This will be done in time for the meeting next summer.

THE MOLOKAI PARTY, The Mikahala party got away at 9 o'clock sharp last night for Molokai, taking the Board of Health and parts to the Settlement. Jack McVeigh and Dr. Garvin looked after the guests of the board, and David Naholewa took care of the big native contingent. At 9 o'clock Dr. Emerson, carrying a big valise, arrived on the wharf. That settled it; the vessel left at once. The big party crowded the decks, but indications are that there was good weather for the trip. The Mikahala will return to port tonight.

TALL LIGHTNING ROD, Bavaria boasts that it has the longest lightning conductor in the world. It rises some yards above the top of the meteorological station on the Zugspitze, the highest point in the German empire, and runs down the side of the mountain to Hollenthal, where there is running water all the year around. The length of the rod is five and one-half kilometers, nearly three miles and a half.—Indianapolis News.

TOO CONSERVATIVE, Tom Johnson regards Bryan as "too conservative." This also is the feeling among the younger school of American economists, who believe in the public ownership of public service businesses. They say Bryan is too much of an old-school Democrat to take readily and enthusiastically to this idea.—Springfield Republican.

AN ANNUAL VISIT.

The visit of the Board of Health to Molokai is the great event of the year among the people of the settlement. It is talked about for weeks before it takes place, and forms subject matter for conversation for more weeks after it has passed into history. For life at the settlement, though it is easy, though there is no competition in labor, though the necessity for working for the daily bread does not exist, still is very dull, and the visit of today makes a pleasant break in a monotonous existence.

The visit moreover, brings the people of the settlement into touch with those who are in authority over them. It is true that an official of the Board frequently goes to the settlement, but he is regarded as a go-between, and the people wish to see the men themselves and detail personally any grievances that they may have.

Living the isolated lives that these people do, it stands to reason that they must have grievances, real or fancied. If these can be aired from time to time before people who have authority to right them the malcontents are satisfied for a time, and then can devote themselves to the amusement of finding out fresh ones, which is a healthy mental exercise.

That everything is done for the people of the settlement that can be done, is agreed upon by all who visit the place. In no country in the world is so much care shown for the unfortunates of this class. In the East they are simply ostracized and driven from the city limits having to beg by the wayside for an existence. Kalaupapa is a most healthy situation. The climate is among the most pleasant upon the Islands. The place has many natural advantages which have been utilized for the benefit of the inhabitants. There is an ample water supply which is brought to the houses. There are a couple of deep valleys which supply ferns and greenery dear to the native heart. Taro can be cultivated, fish can be caught in a boat, and with nets supplied out of public funds. The Board of Health has erected a large number of houses. There is a hospital and there are devoted Sisters of Charity, who tend the sick and encourage the unhappy.

It all sounds well; it is well; but never the less, however pleasant in surroundings, however great the care bestowed upon the inhabitants, he is a prison. Those who enter it are as dead to the world as if the grave had closed over them. They need all the care and kindness that the people of this Territory can bestow on them. They are public wards, and however great the expense, and it is undoubtedly great, we must never grudge it to them.

A FISH STORY.

When the Legislature meets there will be many important things to be done, and undoubtedly political spirit will run high. Thus many reforms and much practical legislation will probably be lost sight of in the war of partisan strife. But however strong partisan strife may be the question of filling the stomachs of either side appeals to all. If a soldier, as the Duke of Wellington said, marches on his belly, certainly the politician requires that organ full, before he can take an intelligent view of public affairs.

This being allowed it is our bounden duty to protect with care every source of food we have. Situated as we are we have no countless herds of cattle to depend upon, except by cold storage from California and the refrigerating west. Mutton used to come to us from New Zealand, but that supply has ceased. Poultry is out of all price for any people. Remains "Fish!"

Certainly from our position we should be classed among the "ichthyophages" and we certainly are not. We have fish swarming around our shores, and we take no advantage of the wealth that is within our grasp. Fortunately the Federal Government will force us to take care of our fisheries.

What care we take of them may be gathered from the following statement which is authentic. A gentleman examined a seine at Pearl Harbor the other day. It was upwards of three hundred feet long. The meshes were not more than a quarter of an inch wide. That should have been enough to capture any of the finny tribe worth catching, but this was by no means sufficient for the enterprising Japanese in charge. He had a brilliant idea and he duly carried it out. He lined his seine from end to end with mosquito netting. The fish that escaped from such surroundings must be very small indeed. This nefarious catching of fish is detrimental to the welfare of every man, woman and child on the Islands. We ought to have an abundant fish supply, but we certainly will not have it if we allow the small fry to be slaughtered in this manner. In the case above cited the seine was full of tiny fish, small crabs which were abso-

lutely of no use and were allowed to simply dry up in the seine as it lay on the beach. Such wastefulness is very reprehensible and the authorities should keep a sharp look out against its continued recurrence.

We have, unfortunately, no law in reference to the size of the meshes of a net. We ought to have, and the next Legislature no matter how busy it may be in constructing municipalities, will have to attend to that. In any other country meshes of a quarter of an inch wide would be illegal to start with, but when these small meshes are reinforced by mosquito netting the method of fishing becomes fairly criminal. In the United States and in Europe the nets would be confiscated and the owners fined. Of course, as there is no law on the subject here, nothing can be done, but there will have to be a law.

We have protected our fishing very slightly. This probably is due to the peculiar fishing rights of individuals. But now that the fisheries will be thrown open to the public, and the private rights will cease, we need a complete series of legislative enactments which will protect the fish from such wholesale slaughter as has been described above.

A tug in regular business will do away with the necessity of a government tug. The business of towing vessels should be in private hands and the government should have no responsibility in the matter.

There seems to have been some confusion of orders with regard to the Alameda yesterday, and the steerage passengers had to wait a long time before getting ashore. It is hard enough to have to be a steerage passenger, and they should be given all opportunity possible for a run out of the ship.

The Democrats evidently want a paper without paying for it. If the National Committee will dive into its sack, or Hearst will put up the cash, the Democrats will cheerfully subscribe a nickel or two for a copy now and then, but when it comes to a case of dig, No thank you. It does not argue very much for the enthusiasm of the party.

When Mr. Meyer was in charge of the leper settlement no coin was allowed to leave the settlement. All remittances were made by post office order, which of course passed through his hands as he was postmaster. Any money that came from the settlement to him was thoroughly cleaned in some disinfecting fluid. If the strict rule made by Mr. Meyer has been relaxed it is very reprehensible. But the question is has it been relaxed.

There should be no difficulty about establishing a rural mail delivery in most of the districts where such will be required. In former times when everything had to be done on horseback there would have been considerable difficulty, but now with wagon roads in almost every part of the Islands, there really ought to be no difficulty in getting the service. In populous districts like Kohala, Hamakua, Hilo, Walluku, Makawao and so forth, it will prove a real boon to have a house to house delivery.

The addition of four saloons to the regular list of fourteen ought to supply the drinkers with all the means of assuaging their thirst. Up to the present Honolulu has been very fortunate in her saloon keepers. There is no town on the mainland where such places are kept so respectably as here. The men in charge conduct them on careful lines, and though there is drunkenness there is not that offensive disorder which can be seen in many parts of San Francisco or New York. The dive is an unknown quantity here, and long may it be so.

It turns out that the members of the registration boards are not all of one political stripe. A member of the Maul board is an Independent. The fact is that in appointing the boards the Governor had no partisan ideas, but was purely actuated by the desire of getting good and experienced men who would do the work honestly and impartially. And when the work is completed it will be found to have been carried out on such lines. Fortunately we are not a naturally corrupt community, politically, yet, whatever we may become by careful education.

The closing of the school taught in Hawaiian on Niihau marks the final end of a system of education which was practically dead long ago. When Mr. Atkinson became Inspector General of Schools in 1887, the double system of schools existed: there were schools taught in Hawaiian and schools taught in English. The result was detrimental to progress. Through his efforts most of these schools were converted into English schools, but on his retirement three were still left. The last fell yesterday, and now English is not only taught, but is the medium of teaching from one end of the group to the other.

The California oil schemes are kittle cattle to deal with, as a good many people in San Francisco and elsewhere have found to their cost. We have enough schemes of our own which have not turned out as well as they should have done to make any of our investors mighty careful as to where they put their money. Moreover, if anyone has spare capital there are plenty of investments close at hand which are to be picked up at a cheap rate and which are perfectly safe. The only reason that the stocks are low now is that the money market here is stringent. Better develop the Territory than throw money into the laps of California speculators.

"Shanghai'd" is the word that he frequently uses in describing the situation. In his opinion Lewis & Turk are very bad, and he will say so tomorrow night.

"No; I don't think they will stick a machete in my opu nor cut my queue off," answered McComb to another question. "Lewis & Turk don't do business that way. They might hire somebody to do me up. That is their style. In spite of all, however, I intend to do my duty. I have enough evidence in hand to make my fight. The sailors tell me their troubles. They know I am their friend, and they tell me the truth. The stories I have heard from them would and should shock this town. People do not know what is going on in their midst. Let them come down to the Joyful News and I will tell them a few things."

CAPTAIN MEHRTENS DEAD

END CAME UNEXPECTEDLY THIS MORNING.

Died Alone, While His Friend Was Down Town, of Hemorrhage of the Lungs—A Former Policeman.

Captain John A. Mehrtens, at one time senior captain of the Honolulu police and one of the original promoters of the Coyne-Mehrtens Furniture Company, died unexpectedly this morning of hemorrhage of the lungs.

He was alone in his house in the lane opposite the Chinese church on Emma street when the end came. Attorney Charles Creighton had sat up all night with him, and when he left this morning Mr. Mehrtens was apparently much better and in good spirits. When Creighton and a friend returned to the house a few hours later the patient was dead.

Ed. A. Williams is making the funeral arrangements. The funeral will occur some time tomorrow, probably in the afternoon. Deceased was a member of several lodges, and these will take charge.

Captain Mehrtens was a native of California, and had been in the Islands about twenty-three years. He was an upholsterer by trade, and as such made a good deal of money. He was on the police force at the time of the overthrow in 1893 and figured prominently in the events of that time. Subsequently he was connected with the furniture house of Hopp & Company and still later assisted in launching the Coyne-Mehrtens Furniture Company at Fort and Bereitania streets.

Deceased was taken with hemorrhage two days ago, but was not considered to be in a dangerous condition. He had not been strong for some time, however, and that probably hastened the end.

Captain Mehrtens leaves a wife and four small children.

GETS ALIMONY AND COSTS

The petition of Nina L. Flint for temporary alimony and attorney's fee from her husband, Harry W. Flint, was thrashed out in Judge Humphreys' court this morning. Petitioner wanted \$50 for her lawyer and \$50 a month for the support of herself and child. The court granted the lawyer's fee and gave the woman judgment for \$10 a week. The case is a lateral issue of a divorce libel now pending. Flint is the harbor policeman. He was married to the petitioner, then Mrs. Gardner, something over a year ago.

The petition of Thomas Murray and wife for the adoption of Malaka, a little native child claimed by two men, is being heard in Judge Humphreys' court. At 12 o'clock adjourned was taken to 2 p. m., and the matter will likely be determined before the day is over.

The case of J. A. Gilman vs. S. N. Castle Estate, suit to recover nearly \$3,600 alleged to be due the estate of the late John Phillips, has been settled out of court.

Judge Humphreys has signed an order authorizing W. O. Smith to withdraw in his own name the sum of \$53.50 in the Postal Savings Bank to the credit of Mrs. Elizabeth Hart and children. Mr. Smith is trustee for the owners of the money. The court instructs that the money be reinvested for the benefit of the wards.

Judge Silliman is expected home early in August in time for the opening of the Circuit term.

The following persons today signed petitions for naturalization: Peter M. Lucas, French, of Honolulu; Henry Cobb Adams, British, of Kaneohe; Judge George Clark, Scotch, of Kailua, Hawaii.

SCALDED TO DEATH.

A horrible death of scalding occurred in Nuuanu Valley last night, as a result of which a Chinese girl named Chin Law, aged 27 months, is dead. In some unaccountable way the child either crawled or fell into a tub of hot water, and was burned over the whole body. After ten hours of the most excruciating agony, she died this morning.

The accident and death occurred at the store at the corner of Wylie street and Nuuanu Valley. Dr. G. K. Sims of the United States Hospital, near by, volunteered his services and afforded as much relief as was possible under the pitiful circumstances.

PAOLO VALLEY. The remaining six people from the tubercles at the head of Paolo Valley, there seven died within so short a time, have been removed temporarily to the home of Pauahi, in another part of the Valley. They will go soon to Hawaii.

IN PRISON FOR CONTEMPT

THE UNEXPECTED FATE OF A WITNESS.

Threatened to Injure a Woman Who Testified Against Manuel Phillips, Who Was Found Guilty.

There was quite an exciting time in Judge Wilcox' court shortly before noon today as the result of the trial of Manuel Phillips, a hack driver, charged with violating section 100 of the Penal Code of 1897. The incident closed by J. Williams, one of the witnesses, being sentenced to serve twenty-four hours for contempt of court.

It was charged against Phillips that he had induced Julia Naone, a native girl, to meet Williams for immoral purposes at or near Waikiki several nights ago. The woman gave testimony against the defendant, and the court noticed the commotion and inquired the cause, and upon learning sent for Williams.

When the man was brought before him, Judge Wilcox proceeded to give him a lecture upon his action toward the witness.

"You must understand this, Williams," said the Court, "even if you are a cook on a vessel, and no doubt think yourself to be a man of much consequence, you cannot come into this court and attempt to act any way you please. You will have to conduct yourself properly. What did you mean by threatening this girl?"

Williams disclaimed any such intention, and denied positively that he had addressed her. Other people had heard the remarks, however, and they so informed the Court.

"Well," remarked the Court, "I will sentence you to twenty-four hours down stairs in jail for contempt of court."

Williams was promptly led away by Officer Hanrahan, who worked up the evidence against Phillips. The Naone woman was arrested several days ago and charged with stealing a gold watch and \$120 from a male companion, but he refused to prosecute her.

VERY REMARKABLE WOMAN

EMPERESS DOWAGER'S ROMANTIC CAREER.

Rose From the Harem to be the Despot
of Three Hundred Million People—
Her Life.

The Dowager Empress Tze Hsi An, who has fomented the present uprising of the Boxers, is the subject of a special chapter in Miss E. R. Scidmore's "China: The Long-Lived Empire," which the Century Company is publishing at this month with remarkable timeliness. Says Miss Scidmore: The eastern empress, the less assertive and forceful of the regents, died in 1881, and then Tze Hsi An, only one in a palace full of concubines 20 years before, began her real reign, became sole and undisputed ruler of more than three hundred millions of people, usurper of the oldest throne and autocrat of the largest empire of one people on earth, tyrant over one-fifth of the human race and one-tenth of the area of the world—a dizzy pinnacle for one of the sex despised by Buddha and Lao-tze and Confucius, in the land where woman is held in least esteem. Dowager queens and empresses have been court problems and national difficulties in all time, but the end of the century has seen them become the special concern of the greatest of eastern and western empires. A conference of young emperors, with the masterful one of Germany as chief adviser, might have spared Kwangsu his freedom. There have been empresses regent before in China, but never, by their own wish, for comparison with this masterful Manchu, Tze Hsi An, the most remarkable woman sovereign and the most unbridled female despot the world has known. She rose from the harem's ranks, uneducated, ignorant of public affairs; but by sheer ability, by her own wish, and shrewdness, she attained the supreme power. Here is the greatest of personal triumphs, her strength of mind and force of character and dominant personality having won every step; centuries of precedent and all the shackles of Oriental custom were thrown away by her masterful strategy and remorseless will. Her enemies have fallen away, sickened and died, and scattered as chaff; no one has opposed her will and survived; no plot or intrigue has availed against her; no conspirator has found her unarmed or off her guard; and hers has been a charmed, relentless, terrible life.

A BRITISH PROTECTORATE.
King George of Tonga, Seeks a New Relation.

NUKUALOFA, Tonga, June 2.—A British protectorate over the Tonga Islands was proclaimed May 19. The following is the proclamation: "Whereas, His Majesty the King of Tonga, has been pleased to sign an agreement dated May 2, 1900, and a treaty, dated May 1, 1900, whereby he has agreed that his relations with foreign powers shall be conducted under the sole advice of Her Britannic Majesty's Government, and that Her Majesty shall protect His Majesty's dominions from external hostile attacks, it is hereby proclaimed that a protectorate by the name of the British Majesty has been established accordingly, and all persons concerned are commanded to take notice of this establishment. "BASIL THOMPSON, "H. B. M. Envoy Extraordinary to H. M. the King of Tonga. The King's commandment May 25. Among those present were Hon. R. J. Seddon, premier of the New Zealand Government, who with his wife and family and a large party of guests, was on a visit here.

PLAGUE DYING OUT.
SYDNEY, July 2.—There were no fresh cases of plague yesterday, nor deaths. Not even a suspicious illness was reported to the Health Department. According to last night's health report there was practically no change in the condition of patients, who, with one or two exceptions, are doing well.

PLAGUE IN BRISBANE.
BRISBANE, July 1.—A young man named Doherty, lately from Townsville, was taken ill yesterday and removed to the hospital. His symptoms were suspicious, and the patient was isolated. Dr. Bancroft declared it to be a case of true plague. The sufferer was removed to the quarantine. A woman named Roach, a widow, residing in Bowen street, was discovered to be suffering from plague today, and was removed to quarantine. There are eight contacts.

OLDEST GOLF CLUB.
The Royal Blackheath Golf Club is the oldest golf club in England, and it also claims to be the oldest golf club in the world. It was founded by James I in 1608. For two or three centuries before that time golf had been a popular game in Scotland, but there is no record of any club having been established prior to the Blackheath Club. In 1457 the Scottish parliament passed an act enjoining that "fute ball and golfe be utterly cryll downe, and nocht usit." A similar act was passed in May, 1491. The Royal and Ancient Golf Club at St. Andrews is one of the most famous in the kingdom. It was instituted in 1754. A silver cup having been played for in the May of that year. In 1834 William IV became patron of the club, and approved of its being in future styled "The Royal and Ancient Golf Club of St. Andrews," and presented a gold medal to be played for annually.—Collier's Week-ly.

WOMEN FOR HARVEST FIELDS.
It will take nearly all the men, women, boys and girls of Ellis county to harvest the 147,076 acres of wheat that is ripening. Most of the farmers have their entire acreage in wheat, and to harvest it the wives and children of farmers go into the fields and work with the men. Eighteen women of Hays City have engaged to go into the harvest fields. They will earn from \$1.50 to \$2 a day, and many a young woman will appear in church this fall with new frocks that were bought with money earned driving a header box.—Kansas City Star.

AUSTRALIA 16 TO 1.
SYDNEY, July 2.—W. G. Gocher, secretary of the Free Silver League of Queensland, has received the following letter from W. J. Bryan, the American Presidential candidate: "My Dear Sir: I am just in receipt of your favor of April 11, inclosing resolutions passed by your league. I beg to thank you for the sentiments therein expressed, and am gratified to know that the fight which I have undertaken is making for the restoration of bimetalism and for the maintenance of the principle of free government is being observed and applauded in Australia. I will see that the resolutions are published. Very truly yours, "W. J. BRYAN."

INDIANS THREATEN WAR

BOUNDARY SURVEY PARTY IS ATTACKED.

Kluckwan Indians in Alaska Seek Retaliation for the Conviction of Their Tribesmen—Serious Trouble Feared.

SEATTLE, July 11.—According to late northern advices a party of English surveyors engaged in locating a boundary line at the head of Lynn Canal have met with resistance from the Kluckwan Indians. It is known that the Indians warned the party to desist, and that the warning was disregarded. A second and peremptory demand has probably resulted in a clash between Indians and whites. An unofficial statement which emanated from Haine's Mission has it that the whites have been met with armed resistance. The trouble arose originally, it is understood, over the conviction of six of Haine's Mission Indians for the murder of the Horton party near the mission last year. Jim, a ringleader, was sentenced to hang and the others got from twenty to fifty years each. The Indian murderers are members of the Kluckwan tribe, and it is claimed this is in retaliation. There seems to be no doubt but that the matter will result in an open fight. A feeling of distrust was noticed by the surveying party when their operations carried them in the vicinity of the Indian territory. Passing parties of braves were more than usually haughty and distant. At first the Indians were much interested to know what it was all about. They were informed that the men were engaged in marking the line between the domains of the "Boston men" and the "King George men." The action of the surveyors moved the boundary line several miles nearer tide water and cut the encampment of the Kluckwans closer to the bay. The Indians held a council of war and determined to resist. A delegation of braves visited the head surveyor and peremptorily told him to get out. He refused. Later reports have it that shots were exchanged between the Indians and whites, and serious trouble is anticipated.

SUGAR IN PARAGUAY.
The manufacture of sugar and production of cane on a small scale sufficient for local consumption may, perhaps, become a fairly profitable business in Paraguay, but there is no prospect of its becoming at any time an article of export. A sugar factory here called the "Empresa Azucarea," which was inaugurated in September, 1898, cannot be said, according to our Consul at Asuncion, to have fulfilled expectations during the past year. This, however, is probably due to heavy interest paid by the company on loans, and to the fact that the Government has not, as was expected, taken steps to protect the native industry by imposing a higher duty on imported sugar. The crop of 1899 amounted to some 325 tons, of which only one-half was disposed of up to the end of the year. The price of imported sugar in Asuncion is about \$6 per arroba (25 pounds), and for the home-made article is 90 per arroba.—Sugar.

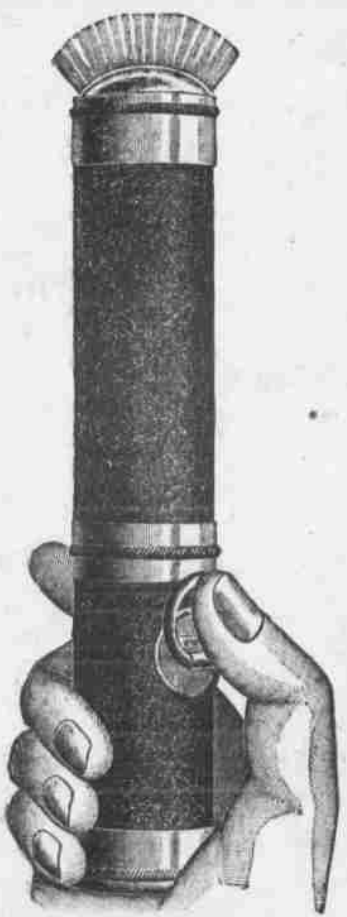

Judge Clark of North Kona, Hawaii, is in town. He will return by the Mauna Loa on Tuesday.

The paying teller at the First American bank was busy today settling with the Postal bank depositors.

The Pacific Land and Improvement Company is the latest corporation. The stockholders are principally Chinese.

The usual matinee concerts will be given at Emma Square this afternoon, and Makee Island tomorrow afternoon. David Noone has charge of the band today, in place of Professor Berger, who went to Molokai with the Board of Health.

The Republican Reception Committee has a notice in this evening, requesting business houses to decorate on Thursday, July 26.

Mrs. William H. Hoogs and Mrs. Frank L. Hoogs, and their children, have gone to Makaha Valley to spend three or four weeks.

The vault for the land office is almost completed. It was a very necessary adjunct to the office as there are very many valuable papers to take care of. The Hawaiian Hardware Co., Ltd., have a very full and complete stock of goods pertaining to their line. Prices will compare favorably with all competitors.

Tonga which has just come under the protection of the British government, was one of the groups of Polynesia included in Kalakaua's "Primacy of the Pacific" policy.

Sealed tenders will be received by the Commissioner of Agriculture up to 12 o'clock noon of July 26, 1900, for the erection of a picket fence around the grounds of the Government nursery, King street.

The renovation of the offices of the Board of Education is nearly complete. The floors were all painted with a second coat today, and things will get into their normal condition by the beginning of next week.

The summer term of the Normal School is doing good work. A fortnight's lessons in agriculture have been added to the course. The pupils are also to be instructed in weaving lauhala fiber.

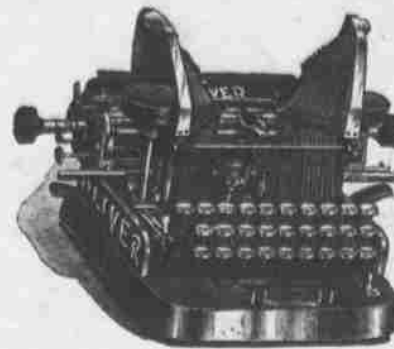
