THE CALENDAR BEING CLEARED

Judge Robinson Jogging Along In Deciding Lawsuits.

AN ATTORNEY'S CLIENT OVERREACHES HIMSELF

JUDGE EDINGS WILL NOT HAVE A JURY AT OCTOBER TERM OF THE THIRD CIRCUIT COURT.

Judge Robinson heard and decided four cases this forenoon.

Judgment was given for plaintiff in the assumpsit suit of Wong Chow et al. vs. Chok Sol Pow et al., for \$167.05 balance on a note, plaintiffs being allowed an attorney's fee of \$100 besides costs of court. Mr. Stanley for defendants noted an appeal. Mr. Douthitt appeared for plaintiffs.

J. M. Vivas obtained judgment against A. F. Franca for an attorney's fee of \$190. Mr. Creighton noted an appeal for defendant. Attorney Vivas offered to act for Franca in a lawsuit for \$50, but when his client tried to put him off with \$20 he sued for \$100.

Judgment by default was given in favor of M. D. Vivas against H. L. Evans and Yokomizo, action of damages for \$66.50 for breaking down and taking away a stone wall 133 feet long and five feet high at the corner of Waiatale road and Sixth avenue. Vivas for plaintiff, who had appealed from judgment for defendants by District Magistrate Dickey. A suit identical with this one in every particular except that the plaintiff was A. Marquess, went also against Evans and his Japanese partner.

Hattie S. Lewis vs. James J. Byrne et al. was continued until Monday.

In the case of Thomas Morrissey vs. H. P. Halola judgment was rendered yesterday for the return of a horse or \$150 instead and \$75 damages for detention.

Matt Smith & Matthewman move for judgment and execution in W. W. Dimond & Co. vs. Orpheum Co., also for taxation of costs in that case and the cases of Lewers & Cooke vs. Joe Corea and Lewers & Cooke vs. D. B. Kaubine.

George H. Huddy, guardian of Iokapa Kale, a minor, has filed an inventory showing property of the ward at Kailhi worth \$3,500 and free of debt except \$64.20 taxes.

William Schneider is given ten days more in which to file his bill of exceptions to verdict and sentence for assault with weapon.

Judge Edings will not have a jury called at the October term of the Third Circuit Court to open on Wednesday next. He will only try cases in which jury is now or may be waived at term. There are 8 jury criminal, 19 jury civil, 3 jury waived, 9 chambers, 5 probate and 5 divorce cases, a total of 52, on the calendar.

DOINGS OF SENATORS

The Senatorial Commission went out to D. P. R. Iesenberg's home in Waiatale this morning and returned to town shortly before the noon hour.

This afternoon at 3:30 o'clock the Senators will leave the hotel for Camp McKinley in company with Major Davis, commandant, and Capt. McK. Williamson, quartermaster, there to inspect the proposed site for the permanent barracks and to have a look at the present post.

Tomorrow afternoon, the Senatorial party will be entertained by Mr. and Mrs. S. M. Damon at their Moanalua home and in the evening, they will be present at the luau at the DeFries home.

SEA SWARMS WITH FISH.

Fishing seems to be on the boom in these waters at present, according to the reports of the pursers of the Inter-Island steamers. Yesterday the officers of several boats returning from Kauai brought reports of some splendid hauls which had been made in the waters near that island. Today Purser Simerson of the Mauna Loa reports that the waters near Hawaii are swarming with fish. The men of the steamer used a net and by means of it caught a larger number of opelu and other fish than has ever been caught on the steamer before.

REGISTER EARLY.

MR. DAMON'S VIEWS

Hon. Samuel M. Damon, Minister of Finance under the monarchy and the Republic, was asked this morning by a Bulletin reporter for his views on the situation with reference to the Treasurer from his standpoint of official experience as well as a large interest in all matters relative to the welfare of the Territory.

"The unpleasant situation that has arisen with reference to Mr. Wright's conduct in the Treasury," Mr. Damon proceeded to reply, "has called forth a great deal of feeling on the part of the community, and much of this feeling has been directed against Hawaiians holding important offices and positions of financial trust under the government."

BOYD'S MAIL DELAYED

Charles Crozier, who returned in the China, accounts for the failure of Superintendent Boyd to return as expected in the China because of his failure to receive his mail. Mr. Crozier saw Mr. Boyd in San Francisco and at the dock when the China sailed. Boyd had seen a dispatch in the paper regarding B. H. Wright's troubles and was very much put out about it. He had not received his mail, however, from the steamer that arrived the night before on account of having moved from an Oakland hotel to San Francisco. Supt. Boyd's mail by the previous steamer, the Ventura, did not reach him till two days after the arrival of the ship.

WILCOX REPLIES

Editor Evening Bulletin:—I wish to deny the statement made by the editor of the P. C. Advertiser in his paper of this date, that I was dismissed from the employ of the Board of Health for cause.

This statement is a malicious, wilful straight out and out lie, and the editor of the P. C. A. knows it.

The Board of Health now in office has never yet given me or the public any reason for its action. It had none to give. The Board simply vented its spite on me, after the manner of Chinese despots who punish relatives for the doings of another, because I happened to be a brother of the "Delegated."

This, I believe, is American politics patterned after Chinese methods.

HOME RULE MASS MEETING.

At the meeting of the Home Rule party in Waverley Hall last night a resolution was adopted calling for a torchlight procession and mass meeting in Emma Square tomorrow night. A committee of five was appointed and the members are hard at work today making preparations. It is stated that this political demonstration will be one of the finest of its kind ever witnessed here.

A call was issued from the Home Rule headquarters today to all the precinct club chairmen to be present at a meeting to be held in this city one day next week for the purpose of laying out the plans of campaign.

PLANTS FREE OF DUTY.

Collector of the Port Stackable has received instructions from Washington that all plants, shrubs, seeds, etc., for the Experiment Station, are hereafter to be admitted into the Territory free of duty.

The steamship China left for the Orient at noon today with several passengers from this port, most of them "lay-overs" from other steamers. Three vessels were closely watched by the police but their watchfulness was unrequited.

In the Federal Court before Commissioner Gill this morning, Asaah, the Japanese from Waimanalo, charged with illicit distilling, was bound over to the Grand Jury for trial.

Johann Most, who has served terms in the prisons of Austria, Germany, England, and the United States, declares the latter to be the worst in the world.

"Realizing this feeling and from my previous connection with the Treasury, I am led to think that the trouble in connection with Mr. Wright dates farther back than this particular case, and that much of this difficulty might have been avoided by a closer inspection by the authorities and especially by the Auditor."

"I am quite aware that the Governor has stated that Mr. Austin was my appointee. I am quite aware and hold myself in readiness to bear my share of this responsibility, for he was appointed upon my recommendation. But it is hardly fair to go so far back as the original appointment of Mr. Austin."

"What is needed in public as well as in private business is the constant and

unremitting attention to detail of all financial institutions. It is neither fair to the executive nor just to the subordinate to permit unrestricted conduct of money affairs without personal inquiry."

"Had Mr. Austin thoroughly, or had the executive and the auditing department thoroughly investigated, as was their duty under the Act, the entire working of the Treasury, this lamentable condition would never have arisen."

"To lay the blame upon Mr. Wright because he is a Hawaiian is more than unjust and unfair. That one Hawaiian or ten Hawaiians have gone wrong, it is an improper inference to draw that the race as a whole are incapable of being trusted. I have known Hawaiians and have been associated with them all my life, and among them I

have found many men and women of irreproachable honor and character, and since this occurrence in the Treasury I have personal knowledge that among Hawaiians it has caused a feeling of grief and sadness that one of their number should have forfeited the good name of their race by abusing his public trust."

"The Hawaiian is here and is to remain here for many a long year to come, and it is our bounden duty to strengthen, support and encourage him in every reasonable way."

"I think it would be a misfortune, as it has been in the past, to make light of defalcations because committed by Hawaiians. A just balance should be meted out to every person, of whatever color or race, who has the handling of public funds. To discourage

the rising generation from seeking honorable position because one or more of their number has gone wrong would tend to injure not only them but the community. We are here living and must live together and it is our bounden duty to support every branch of the community without distinction."

"That there are fit men who can be appointed to the position recently vacated by Mr. Wright I have no doubt and when the opportunity arises for names to be put forward I sincerely hope that the Hawaiian will be considered on his merits."

"We must not forget that in the defalcations that have been made in public trusts the Hawaiian is a long way from being in the majority. When he is guilty, because he is a Hawaiian makes him conspicuous."

AUDITOR AUSTIN SUSPENDED PENDING INQUIRIES

Governor Dole returned to his office, after his departure mentioned below, this afternoon and again went to the Attorney General's office. While he was in there a Bulletin reporter saw Auditor Austin at the counter in the public rooms of the Audit Office and asked him if there were any new developments.

"I am still here, as you left me this morning," was the reply.

"And doing the business?" was then asked.

"Yes," said Mr. Austin.

When Governor Dole went back to his own office, the questioning statement was made to him:

"An official notice has been given out for publication, that Mr. Austin is suspended. He is still in the office and says he is doing the business."

"Yes," responded the Governor; "but any warrants he may sign will be useless."

Asked "force would be used to oust the suspended official, Governor Dole replied with a trace of impatience: "You must not ask me such things. The situation is being considered."

Assistant Attorney General E. A. Douthitt was met going into the Governor's office and, answering a query, said in effect that something would be said shortly.

Herbert C. Austin, Auditor of the Territory, still held his office up till noon today, in spite of a demand for his surrender made upon him by Governor Dole. As might have been surmised by readers of the Bulletin, from suffry paragraphs appearing lately in its columns, Auditor Austin has been on the defensive to hold his position since the discovery of a defalcation in the Public Works department.

There is little to be added to the self-explanatory correspondence printed below for making the Auditor's situation clear in all save his defense, as to which he will not speak since the matter was early placed in the hands of his attorney.

At the office opening hour this morning a Bulletin reporter waited at the Audit office for expected developments. Nothing occurred before noon. Mr. Austin was in the office all forenoon.

Governor Dole arrived at the executive office in the opposite end of the building soon after 9 o'clock, wearing riding boots and spurs, and in a short time visited the Attorney General's office adjoining the Auditor's. Then the Governor, still booted and spurred, left the building and was absent the rest of the morning.

Mr. Austin, answering a question, said no physical resistance was meant. An officer had only to touch his shoulder to constitute "violence."

Attorney General Dole said, after the Governor left, that no action of his department would be taken this morning. "It is entirely under the direction of the Governor," he added.

Following is the correspondence in the matter:
Auditing Department, Territory of Hawaii,
Honolulu, September, 1902.
Hon. Sanford B. Dole, Governor of the Territory of Hawaii, Honolulu, Hawaii.

Mr. Herbert C. Austin, Auditor of the Territory of Hawaii.

Sir:—Whereas, I, Sanford B. Dole, Governor of said Territory, have requested your resignation as Auditor;

And, whereas, you have asked me for a written statement of my reasons for requesting your resignation, and for written charges or specifications of official misconduct;

Now, therefore, I, Sanford B. Dole, Governor of said Territory, hereby present the following reasons for requesting said resignation, and the following charges or specifications upon which said request is founded:

I. That in the latter part of August, 1902, you applied to and requested C. F. Chillingworth, Deputy High Sheriff of said Territory, to loan you for your personal use the sum of two hundred and fifty dollars of the public funds collected as fines and costs by the said Chillingworth in his official capacity aforesaid.

II. That on or about the second day of September, 1902, you applied to and requested the said Chillingworth to loan you for your personal use the sum of two hundred dollars from public funds collected as fines and costs by the said Chillingworth in his official capacity aforesaid.

III. That on or about the 6th day of July, 1902, you passed a check for upwards of seventeen hundred dollars, drawn by yourself in favor of Henry C. Hapai, Registrar of Public Accounts of the Territory of Hawaii, said check being drawn on the First Bank of Hilo, you having no funds, and knowing that you had no funds, in said bank to pay said check or any part thereof, and the same being drawn and issued by you to obtain money thereon for your own personal use in your individual capacity.

IV. That on or about the 6th day of July, 1902, you procured from one William Vannatta, a public accountant residing in Hilo, the sum of two hundred and fifty-five dollars, giving therefor your check upon a bank in the city of Honolulu, well knowing at the time that you had no funds in said bank to cover the payment of same; and that the said William Vannatta, as Public Accountant, did return to the Treasurer of the Territory said check for two hundred and fifty-five dollars as a part of the government funds, and upon the presentation of said check for payment it was dishonored.

V. That while holding office as Auditor of said Territory you have procured money from B. H. Wright, Chief Clerk of the Department of Public Works, knowing that said Wright had no means of his own and no money to lend except public money in his official custody, you borrowing at one time from the said Wright as aforesaid the sum of seven hundred and fifty dollars, for your own personal use, knowing that the same was taken from public funds.

VI. That you have from time to time given checks to creditors in payment of your personal debts, knowing that you did not have funds on deposit to honor said checks, and that said checks when presented would be dishonored, and were dishonored.

VII. That you have, to a great extent, (Continued on Page 5.)

I deem it my duty to thus advise you of my views upon this matter, arrived at as the result of much consideration, and supported by the advice of counsel, in order that you may possibly be deterred from an act which, if attempted, might lead to violence, and other unhappy consequences.

PRINCE FOR TREASURER

At a meeting of the executive committee of the Democratic party held at 12 noon today, it was decided to request Governor Dole to appoint Prince David Kawana-nakoa as Treasurer of the Territory of Hawaii. A resolution to this effect was adopted and Hon. S. M. Damon was appointed a committee of one to call on Governor Dole and present the request of the Democratic party. The name of F. W. Macfarlane was mentioned extensively in the Capitol and Government building circles this morning as the probable successor to Wm. H. Wright. At all events, nothing has been decided yet and Secretary Cooper is still in full charge.

WOULD GROW GINSENG

Wray Taylor has collected specimens of thirty-two different kinds of Hawaiian wood from all over the Islands and expects to have more soon. These are planned into pieces about 6 x 4 inches and 1-4 of an inch thick. Mr. Taylor is making this collection for Gifford Pinchot, head of the forestry department at Washington, who is expected to pass through here very soon on his way to the Philippines.

The Commissioner of Agriculture and Forestry is now talking of starting the raising of ginseng in the Islands. A shipment of the roots of this plant is already on the way here. Experiments will be made at the nursery in Nuuanu valley. The firm from which the roots were sent writes that ginseng does very well in certain parts of Florida where the climate is very similar to that of the Islands.

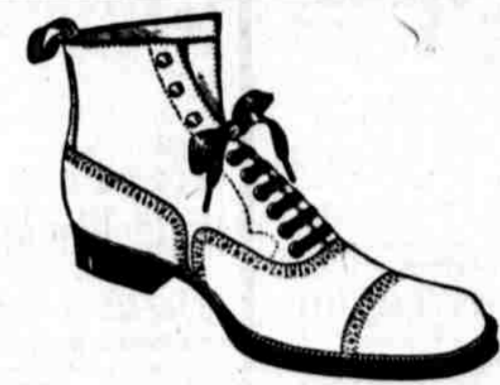
By the last steamer from Kauai, S. W. Wilcox sent a durian fruit to Mr. Taylor. It was one of five fruits from a tree on the Wilcox premises at Li-lue. The durian tree is a native of the Malay peninsula and is very rare indeed.

CANDIDATES IN WAVERLEY HALL

There were, counting delegates and all, in the neighborhood of two hundred people at the meeting of the Home Rulers in Waverley Hall last night, held for the purpose of hearing the candidates for the House of Representatives express their opinions. Senator Kalaoukalanani was in the chair.

There was considerable of a flutter previous to the calling to order of the meeting on account of the stand which had been taken by Mossman, Oili, Damiano and Kou, who stated during the afternoon that they would not run on the Fifth District ticket with Monwar, the Chinaman chosen by the delegation. However, it was noticed that all the candidates with the exception of Mossman, the man who got the highest vote, were in their places at the proper time, and it was learned that they had decided after careful consideration to come back into the fold.

Mossman, however, was obdurate and stood his ground, notwithstanding the advice of the leaders of the party. He stood outside in the hallway all through the meeting and angrily denounced to his friends the action of the Fifth District Committee in putting Monwar on the ticket. He has been given ten days during which to reconsider his determination, and if he does not return by that time, J. K. Paole, the next highest man on the list at yesterday's voting, will be substituted in his place.

The first speaker of the evening was Col. C. J. McCarthy, who stated in the outset that he wished it understood he was a Democrat through and through and would be such forever. However, as the principles of the Democratic and Home Rule parties were identical, he felt absolutely no hesitancy about running on the ticket of the latter. There was one thing certain, if he was so fortunate or unfortunate as to be elected to the House, he would do all in his power for the interests of the native Hawaiians.

L. K. Kentwell said the Home Rule party was the party of the people. The Republican party was one that gave promises but never fulfilled them. There were hard times here now and this state of affairs would continue as long as Governor Dole remained in power here. To show the interest the people took in the campaign, there were 87 delegates out of the 90 present at the convention. County and municipal government was what was wanted. The people did not want Dole to collect any more of the people's money to have it disposed of as recent events had disclosed. If there were a Home Rule Governor in office, and this thing had taken place, the papers of the city would be denouncing him in round terms in their columns, but since it was Dole, nothing was being said.

Ng Monwar was the next speaker, his remarks being interpreted by Delegate Wilcox, who stated that the candidate was not a common Chinaman. He was no less than a cousin of Minister Wu Ting Fang and was a citizen of the United States. Monwar denounced Mossman and a "district magistrate from Koolau," calling the latter a snake for talking against him, a man who as a Home Ruler, stood on a par with any other Home Ruler.

Next followed Oili, Joe Aea, Kaona, Naaha and Damien, all of whom spoke an allegiance to the Home Rule party and the welfare of the people. Damien stated that the Board of Health was just like a second Governor in the Territory.

Kupihua made a very good speech, favoring country and municipal government, the control of the liquor settlement by the Federal Government, the giving of liquor licenses to American citizens who wanted them and the turning over of Kailih camp to the natives.

Kou stated that God would look after the welfare of the islands, and then quoted from Scripture to prove his contention. John Holt made his maiden speech and did well. He thanked the people for the honor they had conferred upon him and stated that, as they would hear from him again, he would not say much at that time.

Delegate Wilcox said that although the Republican candidates had pledged themselves to county and municipal government, not one of them would vote for it. They had proved false to their declarations before. They would do so again.

Cayless made the longest speech of the evening. He spoke of the recent disclosures in the Capitol building and said that the Republicans were laying the blame on the Home Rulers. Indeed, he would not be at all surprised if, before the campaign was over, they would be blaming the Home Rulers for Dole. The speaker further stated that all manner of complaints had been laid before the Senatorial Commission respecting the Republican administration, but not one word of complaint had been breathed against the native Hawaiians and the Home Ruler.

Senator Kalaoukalanani closed the meeting with a short speech.

Senatorial Commission FINISHES ITS WORK In Territory of Hawaii

The Senatorial Commission opened its last session in Hawaii on the lanai of the Hawaiian hotel at a little after 2:30 o'clock yesterday afternoon, there being in attendance a very large number of substantial people of the city.

Fitch on Conditions.
The first witness before the Commission was Col. Thomas Fitch who when he was asked his age, answered: "Sixty-four I am sorry to say." This short dialogue then took place between Senator Mitchell and Col. Fitch.

Mitchell—Col. Fitch, you were a long time ago a member of Congress from Nevada, were you not?
Fitch—Yes, sir, I was.

Mitchell—I remember, you and I had a fight on the floor.
Fitch—Yes, sir; and you got the best of it.

Col. Fitch then read a lengthy paper on conditions in the Territory of Hawaii which, when he had completed reading it, was received by the Commission with thanks.

Alexander on Lands.

Prof. Alexander read a very long document on the land laws of the Territory, intimating that in some instances, changes might be desirable. When he reached the portion of his paper touching on the leases of land by the government, Senator Mitchell asked witness if it was not possible for anything up to a hundred thousand acres to be secured by any person who might be in position. The reason of this question was because of the statement on the part of the witness that there was a greater tendency in the United States than here for land to go to the few. Prof. Alexander stated that he did not believe any one could secure in the Territory of Hawaii the amount of land which had just been mentioned. Senator Mitchell answered that such testimony had been placed before the Commission at the morning session. There was a limit to the time of leases but not to area.

Yond Represents Young Business Men.

P. M. Pond, real estate agent, appeared before the Commission with a petition from young business men of the city, nearly a hundred of whose names were attached. At the conclusion of the reading of the petition, witness stated that the document had only been drawn up on the evening before so that it had not been generally circulated. He hoped before the Commission should leave for home he would be able to present a large number of additional names. (It might be stated here that Mr. Pond was very busy during yesterday afternoon passing around copies of the petition for signature. Great success was met with.) The petition reads as follows:

To the Honorable Members of the Commission of Inquiry upon Hawaiian Affairs Appointed by the United States Senate.

Gentlemen:—We the undersigned American citizens of the respective terms of residence in Hawaii, and occupations set opposite our names, respectfully represent that we view with satisfaction your inquiries into the condition and needs of Hawaii and sincerely pledge our support to every measure calculated to establish in Hawaii those great principles of justice and right of which the American nation is the chief exponent.

Condition Critical.

Our condition today is critical. Our people have been harassed by the plague and many of them impoverished by the fires necessary and incident to its extinction. Our own government has been deprived of half of its revenues, and our banks and financial institutions laid under heavy contribution by the monthly shipment to the Mainland of \$100,000 or more of gold collected at our custom houses. Our chief industry is suffering from the low price of sugar and the scarcity of field labor, and the entire community, regardless of vocation or social position feels the resulting financial stringency. Our mortgage indebtedness has reached an unprecedented figure, and is still increasing.

In this unhappy condition we have sought diligently for relief in a better adjustment to our conditions. Our entire industrial and political situation is being subjected to the most searching and anxious scrutiny that nothing

be done to augment our difficulties or nothing omitted that might relieve them.

Assistance From Congress.
We ask through you for assistance from Congress. And though our isolated position in the tropics compels us to ask some modification of American laws to meet our special burdens and requirements, we are convinced that such adaptation of national statutes to the special needs of outlying territories is reasonable and necessary.

Three Measures.
We respectfully request your support of the following measures:

1. A measure providing for the payment by the United States Government of the awards of the Court of Fire Claims.
2. Such a provision by Congress for the local expenditure of the customs receipts as shall check that constant drain upon our resources.
3. A law to permit the admission of a reasonable number of Chinese field laborers under such proper restrictions as shall limit them to agricultural labor on the plantations, and effectually bar them from the arts and trades.

Chinese Labor.

In support of this last request we submit the following:
So far as Hawaii is concerned the admission of such labor will afford the only foundation upon which a prosperous and adequate industrial system in this tropical country can be based. Such Chinese labor will not be a competitor of the American can or beet sugar producer supported by tariff, but will rather replace some of the Dutch and German sugar by Hawaiian sugar, made by American capital, in American mills, with American mill labor, and transported to market in American bottoms.

We submit, therefore, that in thus modifying the application of the Federal law to meet the precise requirements of Hawaii you will be following in a wise and liberal manner the national policy of protection and development of newly acquired domain. The benefits of our liberal treatment will accrue in our case not merely to our entire Hawaiian citizenship, but also to the merchant, manufacturer and laborer on the Mainland of whom we shall be able in the future to make even larger purchases than in the past.

D. Kalaoukalanani Jr. Presents Petitions.

The next witness to appear before the Commission was D. Kalaoukalanani Jr., private secretary to Delegate R. W. Wilcox. He had with him four bundles of petitions from natives all over the Islands. The first bundle was a plea for county and municipal government with 968 signatures of voters. The second was a petition for the control of the leper settlement at Kalaupapa by the Federal government and had 796 names attached. The third was a petition from 815 voters of Honolulu against the practice on the part of the government of depriving the people of government land for the benefit of the Rapid Transit Co. and the fourth was a petition signed by 993 voters to the effect that the public lands be set apart to be used as homesteads for the people. There was one more petition signed by D. Kalaoukalanani and three others, protesting against the action of Territorial officials in taking land away from the people and giving it to private enterprises.

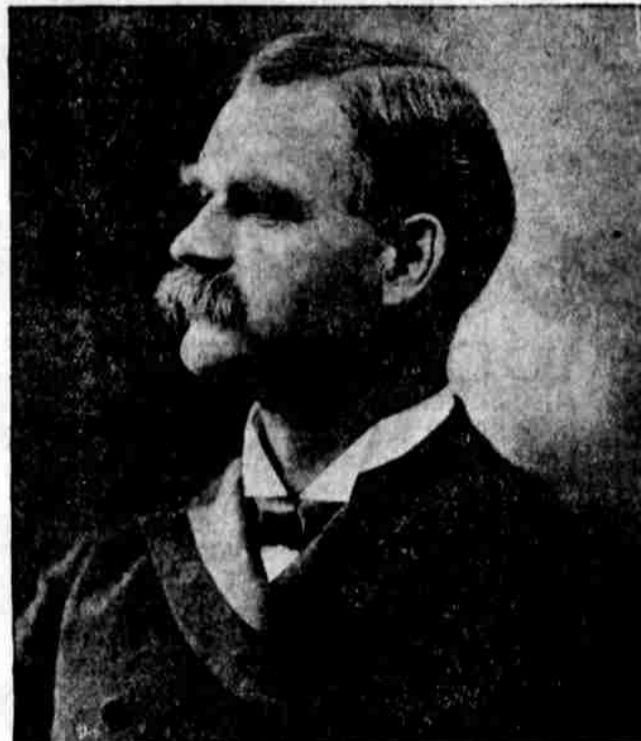

From Hon. S. M. Damon's interview it appears that Governor Dole has held or tried to hold Mr. Damon responsible for Auditor Austin. The Bulletin is unable to fathom the attitude of the Governor.

FACTIONALISM vs. MANHOOD.

It is very unfortunate for Governor Dole and for the Republican party that any newspaper purporting to represent or bespeak the Governor's views on the defalcation of Treasurer Wright has taken up the question from a factional or political standpoint. It is particularly unfortunate for Mr. Dole because by maintaining that the appointment of Mr. Wright to the treasurer-ship was forced upon him, he has put himself or allowed his friends to put him on the defensive. Those who presume to speak for the Governor have thus put him in the position of making excuses for the appointment of Mr. Wright or rather his promotion from the position of Registrar of Public Accounts held under a Treasurer whom Mr. Dole selected at the inauguration of the Territorial government. As Registrar, Mr. Wright handled and was personally responsible for thousands of dollars of public funds. The Bulletin prefers to believe that Mr. Dole at least had full confidence in Mr. Wright's personal honesty. Otherwise he would have protested against his appointment to any position in the Finance Department. While at variance with the Governor on many phases of public administration the Bulletin will not believe he would sign his name to the commission of a public officer whose personal honesty he doubted. It has yet to be seen what possible advantage is to be gained by the Governor by taking the Wright matter up from a political standpoint as he not only signed Mr. Wright's commission as Treasurer, but did so after Wright had been endorsed by the Republican organization and Republican members of the Legislature. Furthermore, Mr. Dole in his charges brought against Auditor Austin has himself indicated his conviction as to an important phase of present official responsibility when he says in his signed statement to Mr. Austin: "VII. That you have, to a great extent, neglected to audit the accounts of Territorial officials throughout the Territory, as by law you were required to do; and by reason and in consequence of your transactions and conduct aforesaid you have so compromised yourself as to incapacitate you for the faithful and efficient auditing of public accounts; and by reason and in consequence of your neglect aforesaid to properly audit public accounts, and of your non-attendance in office aforesaid, a grave defalcation has occurred in the Department of Public Works, and the confidence of the Territorial administration in the correctness of public accounts throughout the Territory has been impaired."

Auditor Austin certainly was not forced upon the Governor. He has been credited with being one of Governor Dole's personal selections. And from the Governor's own version of the administration of his appointee, a proper regard for the duties of auditor would have prevented irregularities in the Finance as well as the Public Works department. If the situation is to be gauged from a factional standpoint, Dole and anti-Dole, the men who are now shifting responsibility merely discredit themselves in the esteem of thoughtful business men.

Of all things, this is no time for factionalism of any character. The Territory is facing an election and the duty

of every honest citizen is to summon all the decency and virtue of which he is possessed that the party and the administration may recover from the blow of a character that shakes men's confidence in human nature to say nothing of public officials with or without bond. The administration cannot escape responsibility by whining. It must go forward vigorously, honestly, fearlessly and in so doing it will have the support of the Bulletin, the party, the community irrespective of faction or previous condition of servitude. If wrongs have been committed, and they certainly have been, right them. Be men.

Washington, Sept. 18.—There is grave fear in official circles in Washington that China is once more on the verge of a serious uprising. It may even exceed in proportions that of 1900. China has taken steps to put down the disturbance, but whether they are adequate remains to be seen. This information was contained in mail advices received at the State Department today from Minister Conger. These letters were all dated last month.

The troubles appear to arise principally from extortionate taxation, combined with resentment against the presence of missionaries, thus justifying the judgment of the Department of State, which pointed out to the Powers that the demand for excessive indemnities would result in serious internal troubles in China.

Mr. Conger's first advice bears date of August 6 from Peking, and he reports serious anti-foreign riots near Chengtu, in the province of Sze Chuen, in which a number of native Christians had been massacred and chapels destroyed. Mr. Conger appears to have acted with energy upon the telegraphic complaints from Dr. Canright, an American medical missionary at Chengtu, not only addressing the Chinese Foreign Office by letter, but calling there in person to impress upon the officials the importance of an immediate and effective action, and finally succeeding in causing the removal of the local Chinese officials who had failed to repress the riots and preserve life and property.

Mr. Conger incloses with his report the communication that passed between himself, Dr. Canright and the Foreign Office.

Tutuila, Sept. 2.—The southeasterly trade winds have been blowing with exceptional velocity during the past few months and the climate has been much cooler than for many years past.

The Samoans made no provision for warmer clothing and the result has proved fatal in many cases. There has been a serious percentage of deaths from pneumonia. Dr. Spear, United States Navy, and his staff have been kept busy attending the natives. Over 1000 natives have been vaccinated by the doctor in Tutuila.

In German Samoa vaccination has been made compulsory, and every man, woman and child can be seen with a white badge on the upper part of the arm.

SENATOR BARD DYING.

Los Angeles, Sept. 18.—The outcome of United States Senator Thomas B. Bard's illness is still in doubt. At 12 o'clock tonight a summing up of the patient's progress for the previous twenty-four hours gave considerable encouragement and at the same time revealed two more or less discouraging conditions. From a pulse so abnormally high that its continuance became a fearful strain upon the physical and nervous system the patient's heart action has subsided to such an extent as to provoke apprehension; and the stomach, the easy condition of which has contributed so much to the favorable progress of the case, is exhibiting symptoms of distress. The latter condition is baffling when it is considered that for nine days the patient has had no nourishment other than liquid and predigested foods.

Late tonight Dr. Taggart stated that he would keep two nurses with the Senator throughout the night, in view of the possibility of a sudden collapse of the heart.

MAKES ATLANTIC RECORD. New York, Sept. 16.—Rear Admiral Lord Charles Beresford, M. P., C. B., of the British Navy, arrived here today on the steamer Kronprinz Wilhelm, to spend two or three weeks with friends. He said today, in answer to a question: "When you ask me about the shipping combine, I must confess that we are a little frightened. Not at the probabilities, however, but at the possibilities of such a combination of interests. It is ridiculous to talk of England forming a rival combination. We can't compare with your railways, and it is well known that it is the through rate that pays. England would not establish a bounty or subsidy on her ships, for, if she did, you could put up \$1,000,000 to every thousand of ours. Then, again, you have 80,000,000 people here and unlimited means."

GREAT BRITAIN IS MAD RUSSIA MUST ACCOUNT FOR LESSAR'S ACTION HE WANTS NO BRITISH IN MANCHURIA - UNCLE SAM NOT ACTING "AT PRES- ENT." London, Sept. 13.—The Russo-British relations will not be improved by the latest Muscovite movement in Manchuria. If M. Paul Lessar, the Russian Minister to China, has ventured—as Peking advices assert—to select British-born members of the Chinese Imperial Customs Service for exclusion from the vast segment of the Chinese empire still occupied by Russian troops he is guilty of a gross breach of international courtesy, but has made the crowning blunder of a muddled career at Peking. At the British Foreign Office strict silence is observed regarding the reported affront, and most of the leading organs of public opinion are all equally reticent. There is no disposition to find imaginary grievances and any logical explanation of M. Lessar's action, should reports of it prove well-founded, would be accepted by Lord Lansdowne, who holds with Salisbury that there is room enough in Asia for both Britain and Russia. But if the Lessar incident has been correctly stated, the British Government will be compelled to take sweeping action to enforce British-Chinese rights under the long standing agreement as to the customs management between Peking and London. Attention is called here to the cabled announcement that for the present at least the United States will treat the affair as one in which it is not directly concerned. As this morning's Post observes: "In the definition of Washington's attitude toward the latest reported phase of the Chinese question there is a significant limitation in the words 'For the present.' We may take it that Mr. Roosevelt and his brilliant advisor, Mr. Hay, do not fail to understand thoroughly the trend of Russian policy. 'Mr. Hay has done more than any other politician now in office to establish the open-door principle enunciated by Lord Salisbury, and it is inconceivable that he or any other responsible American statesman would tolerate an indirect attempt by any power to render nugatory the splendid results achieved for the freedom of commerce in the Far East.' If M. Lessar has directed the expulsion from Manchuria of British born imperial customs employees Lord Lansdowne will call upon the Chinese Government to retain them. While there is a technical right in the Russian Government to exclude all Chinese customs officials so long as Russian occupation continues, this right is based upon the promise that occupation is not to be permanent. It is limited also by the agreement of the Powers that the Chinese are to control their own customs and postal service throughout the empire, both as respects organization and administration. M. Lessar's program seems to ignore this promise and agreement.

HOW F. W. McCHESNEY MET WITH HIS DEATH

Purser Simerson of the Mauna Loa gives the following details of the death of F. W. McChesney in Kona on Tuesday afternoon last.

On the day of the accident Mr. McChesney had gone on a plantation train to Kainaliu. Returning from this point he was riding on the cab of the engine together with the engineer.

After riding a little way, the deceased complained that he felt too warm, being so close to the boiler, and stepped out on the rear platform of the engine.

On the cane car, which was in front of the engine, was a Japanese laborer, whose business it was to warn the engineer whenever there were cattle ahead on the track.

The Japanese then got off his car and chased the cattle off the track. The engineer looked out from the maula side of the engine while McChesney looked out from the maula side.

When the cattle had left the track McChesney told the engineer to go ahead and the engine was started accordingly. One of the cows suddenly ran back on the track, however, and was struck full force by the car ahead of the engine.

Dr. G. Malony, the government physician of North Kona, found the following to be the condition of the injuries received: A compound, complicated fracture of the lower third of the right high. Frames of all the ribs on the right side from the second to the seventh with symptoms of internal hemorrhage.

longs to the Estate of Bernice P. Bishop. That the same is under lease (as your petitioners believe it to be) to the Territorial government at an annual rental of about \$400.

Your petitioners are residing in said "Camp" as tenants of the Territorial government at the rate of \$1.50 rent per month for each and every room.

And whereas, the said Estate of Bernice P. Bishop is holding under lease certain lands belonging to the Territory of Hawaii, we therefore respectfully request it to exchange such Territorial government lands now held by said Estate of Bernice P. Bishop, for the above "Kalihi Camp," as a government reservation, to be given as homesteads to your petitioners.

Beckley on Waianae Lands.

Fred Beckley, representative of the Home Rule party at the last Legislature, presented a petition dealing with the disposition of public lands at Waianae.

Markham Before Commission.

George Markham read the following memorial to the Commission: Hon. John Mitchell, J. A. Burton and A. G. Foster, Sub-Committee of Senate Committee on Pacific Islands and Porto Rico.

Sirs:—Complaining of Governor Dole's attitude toward the Hawaiian people and in support of the charge that he is not in harmony with intelligent self-government by the people of the Territory, it is respectfully submitted that at the last session of the Legislature, instead of suggesting to said Legislature matters that might be considered for the advancement of the material interests of the Territory and proper legislation that should be enacted, constantly opposed and thwarted such results and held defiantly aloof from the Legislature and its committees. Instead of assisting the Legislature by recommendation and mutual conference, as is customary elsewhere, he arrogantly declined the overtures made to him, leaving the Hawaiian in the novel position of legislating for the first time, to their own devices with an implied and even an actual threat that the errors and delinquencies on their part or measures that might not meet his approval would not only be condemned and visited with arbitrary veto, but be taken advantage of for the purpose of creating the belief in the minds of members of Congress, the Chief Executive of the United States and their American fellow-citizens generally that the Hawaiians were incapable of self government and unworthy even of the franchise which had been given them.

In support of this and for the sake of brevity, curtailing the general attitude of the Governor, generally understood, though difficult specifically to point out, one instance is hereby offered which, it is respectfully suggested, is indicative of the general course maintained by the Executive towards a Legislature making its first effort in the line of public service, as to which I will make an oral statement. Respectfully,
 GEORGE MARKHAM, People vs. Executive.

His memorial completed, the witness went on to tell of the feeling of antagonism on the part of the people toward Governor Dole. A grave mistake had been made by the appointing power in placing the present incumbent in the Governor's seat for he had been associated with the movement toward the overthrow of the monarchy. It was impossible for the Hawaiians to work in harmony with such a man and now the people were looking toward the United States to place the power in their hands and not in the hands of a man who was not in touch with the people.

Nothing To Do With Legislature.

Witness then referred to the ousting of Cooper from the floor of the House at the last session of the Legislature and made the statement that the action of placing Cooper there was nothing else in the world than to intimidate the representatives of the people. A committee of Home Rulers had called on the Governor at his home a short time afterwards for the purpose of conferring and of formulating some plans by means of which the Executive and the Legislature could work together. Dole would have nothing to do with this kind of a proposition, telling the Home Rulers to go on and make their own laws. His officers had been interfered with and he cared to have nothing whatever to do with the Legislature.

Witness stated that a change was absolutely necessary if the interests of the people were to be conserved. He was in favor of having appointed a Governor who had absolutely no local affiliations whatever and was in no way identified with the country. He was in favor of having such a man as Taft, Wood or Admiral Miller as Governor. This would result in conciliation. As

CABLE IS SHIPPED

London, Sept. 18.—The submarine telegraph cable which is to join the United States and Hawaii, as the first link in the system to the Philippines, has been completed and is now on board the cable steamer Silverton, lying in the Thames preparatory to sailing September 29 for San Francisco, whence the vessel will immediately begin laying the cable to Honolulu. The Silverton is expected to reach San Francisco early in December. The cable is wound around three enormous spools, each thirty feet in diameter. Its total length is 2413 miles. The strands are one to three inches thick. The total weight of the cable is 10,000 tons.

Vice President Ward of the Commercial Pacific Cable Company, who sails for New York on the steamer Celtic tomorrow, said today: "The shipment of the cable gives assurance that the United States may look forward to being in telegraphic touch with Honolulu by the end of this year. The manufacture of the three remaining sections to the Philippines is progressing at the rate of fifty miles a day, and I am confident they will be finished by March and laid during next summer. Two cable steamers, the Colonial and the Anglia, will lay the line beyond Hawaii. I would like to see the entire project consummated by next Fourth of July."

"Pending the arrival of the Silverton work will be pushed on the underground cable approaches at San Francisco and Honolulu, each seven miles long. It will take the Silverton two weeks to unwind her spools between San Francisco and Honolulu. The service will begin immediately thereafter."

It was now there was no possibility of such a consummation. People Afraid to Testify. Asked as to the sentiment of the natives toward the United States, witness stated that it was of a most cordial nature. The Hawaiians had submitted peacefully to the United States and now that Hawaii was a part of that great country, it was no more than natural that the people should appeal to it now in time of trouble in order that the people might enjoy the privileges now denied them. There were many who could tell the Commission the exact state of affairs in Hawaii but they were afraid to come before the Senators and testify on account of what their interests might suffer.

Federal Control. Witness recommended the control of the leper settlement by the Federal government, stating that the poor unfortunates there would then have some show of being cured for the very best of doctors would be sent here and experiments would be carried on looking toward a cure for leprosy. The people at Kalaupapa were not being properly treated by the local government. Markham also recommended the control of the public lands by the Federal government and the importation of a certain number of Chinese to work on the plantations and on the plantations alone.

Not Sworn To.

At this point Senator Burton arose and called for Attorney General Dole to whom he showed the statement of Jas. G. Spencer with reference to the tenancy at will in re the property at the corner of Nuanu and Beretania streets. Dole had handed this paper in himself. It was not sworn to and Mr. Spencer himself was not present. Dole said he was at a loss to know why a statement of so important a character had not been sworn to. He would have Mr. Spencer sworn to at once but Senator Mitchell stated that the Commission was about to adjourn and there was no more time to hear any else. Senator Bureau added that Dole's statement might or might not go on the record.

Mitchell Gives Thanks. Senator Mitchell then closed the work of the Senatorial Commission in the Islands with the following short address: "We are now at the end of our investigations here. To the Federal and Territorial officials, the witnesses on this and the other islands which we visited, and the people generally—men and women—of all the islands, we extend our thanks for the very courteous treatment accorded to us, the cordial welcome given us upon our arrival and the universal cordial treatment. This, of course, includes the press, as it always does. We extend to all our sincere thanks and will now adjourn to meet on the deck of the steamer Sierra."

WHERE ARE WE AT ?

Editor Evening Bulletin:—I suppose one ought not to be surprised at anything these days. So "et tu" Bulletin has undergone a change of heart and lost confidence in "branching out upon any new form of government" because of the recent developments in connection with the guardianship of public funds.

To my mind, the defalcations which have been brought to light furnishes the strongest kind of proof in favor of the change, not so much by reason of the acts themselves (for they are not uncommon in other places) but on account of the system permitting of such occurrences without requiring of its officials proper and sufficient bonds. This is not the only reason. The more important one is that, the startling development was made during the course of investigation before the Senate Committee yesterday that, the local administration had also placed itself in the same position with the defaulters, by appropriating to its use private funds which it had assumed the custody of.
