APRIL TERM OF THE FEDERAL COURT

Only Fourteen Grand Jurors are Able to Qualify.

SPECIAL SUMMONS ORDERED TO FILE VACANCIES
Trial Jury Is Excused Until Monday, April 15—Grand Jury Will Be Completed Tomorrow.

The April term of the United States District Court convened this morning at 10 o'clock with Judge Este, on the bench. Being the first time in the history of Hawaii when a United States Grand Jury was to be impaneled, the court room was crowded with spectators. All the leading members of the bar were present, and Judges Humphreys and Gear, sat on either side of the presiding judge.

Chief Clerk Maling, Deputy Clerk Handy, United States Attorney Bagd, United States Marshal Ray, Deputy Marshal W. R. Hendry and Court Stenographer Reynolds were all at their stations. Among the visitors were Rev. W. M. Kincaid, Rev. W. D. Westervelt, Rev. Azbill. The charge of Judge Este to the United States Grand Jury was the feature looked forward to with interest. In this, however, the spectators were disappointed owing to the fact that a sufficient number of Grand Jury men failed to qualify. A special venire of seven additional grand jurors was ordered by Judge Este, returnable tomorrow morning at 10 o'clock, when it is expected the required number will be obtained. Out of the twenty-three summoned, only fourteen qualified this morning. The minimum number constituting a Federal Grand Jury is sixteen. Those who qualified were: J. J. Egan, Edwin Thomas, Chas. Phillips, John B. Olliver, J. E. Anderson, P. H. Burnette, F. R. Vida, Jas. L. Torbet, M. M. Kohn, J. W. Podmore, C. B. Ripley, E. E. Richards, J. G. M. Sheldon and James Nott Jr.

Chas. Bellina and A. L. Morris were absent and attachments were ordered served on both, returnable tomorrow morning. John Buckley and A. McIntosh were absent from the court and absent from the Territory, hence their names were thrown out. Ed. Hapai was excused because he holds the office of clerk of the court at Hilo. W. C. E. Brown was excused because he is an officer of the Federal Court. J. G. Spencer was excused, because he had served on the Territorial Grand Jury in March, and had passed on all the subjects covered in the charge made by Judge Humphreys. A. J. Estrella and Sam Lederer were excused on certificates of illness from their physicians.

Each of the qualified Grand Jurors answered in the affirmative the questions: Are you a citizen of the United States? Can you read and write English?

With the order for a special summons of seven other grand jurors, the fourteen jurors were excused until tomorrow morning at 10 o'clock.

The trial jury was then called. L. C. Ables was absent, and attachment was ordered for him, returnable next Monday at 10 o'clock.

A. E. Wall was also absent, but he had left an excuse with Attorney Baird, which saved him from attachment. H. M. Mist was excused not being a citizen. Mr. Scrimgeour, the accountant, urged pressure of business as an excuse of the Legislature in expediting the books of the Auditor and

was excused for two weeks. H. Deakin was excused for a like period on similar excuse. O. G. Traphagen was excused until next Monday at 10 o'clock. Mr. Henriques, having a case in Judge Eding's court was excused for two weeks.

The trial jury was then excused in a body until next Monday morning at 10 o'clock.

On motion of Paul Neumann, Enoch Johnson was admitted to practice law in the United States Court. On motion of C. C. Biting, E. W. Estep of Honolulu was also admitted.

J. Silva, a Portuguese, was admitted to citizenship.

Kinney, Ballou & McClanahan, attorneys for the Walluku Sugar Company, have filed notice of appeal from the decision of Judge Humphreys denying an injunction in the "tunnel" case against the Hawaiian Commercial & Sugar Co.

Robert W. Cathcart, executor of the estate of James Dodd, has filed a motion by his attorney, J. W. Davidson, asking permission to deposit with the clerk of the court all monies, vouchers and title deeds in the estate.

S. K. Mahoe and D. K. Wallehua have renewed their licenses to practice law in the lower courts of the Territory.

Check Public Work

Owing to the state of the treasury public works will be ordered stopped in a great measure.

Rock crushing at the Asylum road plant and work at the portable crusher on Kalili road will be stopped this afternoon. There is no money to pay for the continuance of operations and this shut down is compulsory. It means that two-thirds of the Road Department work, in progress last week is abandoned today. For the time being the Makiki crusher will continue and road improvement in the Makiki district carried on.

This action was decided on at the meeting of the Executive Council today and was made necessary by the lack of funds in the Treasury.

Hutchinson, a colored lady, lately from Alabama, for the benefit of a home for colored children at Spreckelsville. T. S. Douglass, well known here and for many years in the employ of W. G. Iryin & Co., wounded himself in the head this morning with a revolver. Soon after the shot was fired Douglass was taken to the Queen's Hospital where he received medical attendance.

Makawao Easter Vacation

Walluku, April 6.—Makawao Seminary, Miss Alexander principal, closed for the Easter vacation last Thursday. Walluku, April 6.—Easter services will be held at both the Roman Catholic and Anglican churches in Walluku tomorrow morning. High mass will be held at the Catholic church while Rev. Wm. Auld will conduct communion services at the Church of the Good Shepherd after the morning service at 11 o'clock.

Co. "H" Uniforms.

Walluku, April 6.—Goo Lip, the Lahaina tailor, promises that he will have ready next week the new khaki uniforms for officers and enlisted men of Company I at Walluku, and the company will then be almost fully equipped excepting the guns, but the latter are on the way from America.

CLOSETED TOGETHER.

Delegate Robert W. Wilcox called on Governor Dole at the Capitol this forenoon and held a long interview.

Dual Language Bill for Courts is Also Passed.

After the opening ceremonies of the House this morning Aylett introduced a petition asking that \$13,000 be appropriated for road improvements in Manoa.

Makainal reported concerning the petition for the widening of Halawa bridge in Halawa, advising that \$2000 be inserted for the improvement asked.

The Committee on Public Lands reported on Haahoo's resolution asking that certain appropriations be inserted for Hilo road improvements. They stated that Ewaliko, when he had asked for \$350,000 for road improvements, had covered all the ground, and advised that Haahoo's resolution be tabled to be considered with Ewaliko's motion Adopted.

The Committee on Miscellany reported concerning a petition asking for the abolishment of all personal taxes, repealing of Board of Health laws, establishing the eight hour day, giving all public work to American citizens, and allowing to lawyers only half their fees if they were unsuccessful. The first four prayers were tabled to be considered with the various bills dealing with the same subject, now pending in the House. The other prayer was rejected. The report was adopted.

The Senate messages were now read. Senate bill 29, relating to licensed doctors, passed first reading.

House bill 32, relating to a great seal for the Territory, was heard from, and was found to have been sunk on a committee rock. A substitute bill was transmitted to the House and passed its first reading.

House bill 15, relative to the amendment of Section 814 of Chapter 59 of the Civil Laws, passed its third reading.

House bill 2, relating to an emergency fund, followed the same course, in a slightly amended form. Makekau moved to pass the bill as amended. The result was ayes 24, noes 1.

Prendergast gave notice of another franchise bill for Pain's Tramway.

Beckley introduced a bill to give the Standard Telephone Company a franchise. The bill passed its first reading.

Monsarrat introduced a bill repealing some of the laws relating to the manufacture of liquors. Passed first reading.

Emmeluth reported for the majority against the petition of merchants for the rejecting of the attachment exemption bill. They stated that they thought the bill should pass. The bill was now raised from the table and considered with the report.

Kumalae stated that if the bill was passed that credit would be damaged. The bill was finally laid over until Thursday.

The Committee on Judiciary reported concerning the sale of alcohol. They advised that House bill 19, relating to the subject, be passed. Tabled to be considered with the bill.

Prendergast's bill 69, to provide for "damages for wrongful death," came up for third reading. Dickey moved to amend the title so that the bill would be acceptable. The amendment was carried and the bill laid over until tomorrow.

House bill 70, providing for the use of English and Hawaiian in Circuit Courts, came up for third reading. The result was ayes 26, noes 0.

The House then took a recess until 2 o'clock.

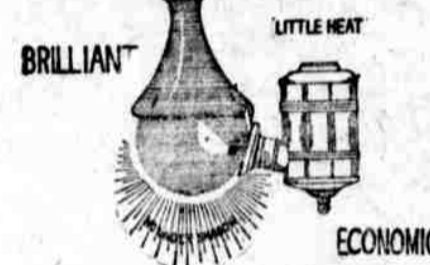

HOUSE DOES WORK IN SHORT ORDER

At the Short Session Held Last Saturday Afternoon.

VERY LITTLE DEBATE AT ALL WAS ALLOWED

Queen Liliuokalani Substitute Pension Bill Passes First Reading—Senate Extortion Bill Passes Second Reading.

When the House convened Saturday afternoon, House bill 70, providing for the use of English or Hawaiian in Circuit Courts, came up for second reading. The Representatives seemed in no mood to allow debate, so they started in with a rush, shutting off Dickey by moving the previous question and passing it on its second reading.

House bill 73, repealing sections of the Civil Laws, relating to Olan Reservation, passed its second reading and was laid over until Monday.

House bill 74, relating to auditing public accounts, passed second reading and was laid over until Monday.

House bill 72, amending section 837 of the Civil Laws of 1897, passed second reading.

House bill 66, repealing certain sections of the Sessions Laws of 1892 passed second reading.

Dickey asked if this was the last day of the session. Akina informed him that there were twenty-two more days, but this day was the first one on which the House ever got down to work.

House bill 77, amending certain sections of the Session Laws of 1892, was referred to the Judiciary Committee.

House bill 49, relating to Queen Liliuokalani's pension, came up for second reading.

Emmeluth's substitute bill setting aside \$150,000 in a lump sum was also read. The bill passed its first reading and was ordered printed.

House bill 57, relating to vacancy in the office of Circuit Judges came up for second reading. The Judiciary Committee report advising that the bill pass, was read. The report was adopted and the bill laid over until Monday.

House bill 71, regulating gambling, was referred to the Public Lands Committee.

Senate bill 36, relating to the appointment of bailiffs for certain courts passed its second reading.

Dickey claimed that passing a bill on its second reading without referring it to a committee, was out of order. The chair ruled against him.

Robertson wished to amend the bill by striking out the section fixing the bailiffs' salaries. The motion was lost and the bill passed its second reading.

Senate bill 33, protecting laborers from extortion, passed its second reading and was laid over until Monday.

Kekaula introduced a resolution asking \$6700 for schoolhouses, etc., in Kau. Referred to Committee on Education. He also asked for \$5000 for road improvements in North Kohala. The resolution was tabled.

The House then adjourned amid a storm of objections and challenges against the vote.

TUNNEL CASE SETTLED

JUDGE HUMPHREYS DENIES INJUNCTION PRAYED FOR

Tavish Family Sues for \$2000 for Ejectment from Their Home on Liliha Street in a Storm.

In the "tunnel" case of the Walluku Sugar Company vs. the Hawaiian Commercial & Sugar Co., Judge Humphreys made an oral decision Saturday denying the injunction prayed for.

Petition for judgment for the sum of \$219.65, has been filed by F. M. Brooks attorney for Yung Bow, vs. Leong Sam and the Oahu Sugar Co. garnishee. The suit is for goods sold.

Petition to sell real estate was filed by John Cassidy, guardian of M. A. Robertson, an insane person, Saturday morning.

Notice to place cause on the calendar of the Supreme Court has been filed in the case of James J. Byrne vs. P. J. Yoder on exception from the Circuit Court.

Oliver Tavish and Maggie Tavish, by

Attorney J. M. Davidson, have filed a petition in Circuit Court against Lilia (W) asking \$2000 as damages for forcible ejectment. The petition alleges that on March 14, defendant entered the house of the plaintiffs on Liliha street and forcibly put the family into the street, to their great loss, mental distress and anguish.

In the divorce suit of Sam Moe vs. Chong Quon, a temporary injunction by Judge Humphreys, restraining the defendant from interfering with the plaintiff in any manner whatever.

CHICAGO POST SOLD.

Chicago, March 30.—The Chicago Evening Post was today sold by H. H. Kohlman to a company headed by J. C. Shaffer of Evanston, who will be president and publisher of the paper. Samuel T. Clover, for several years managing editor of the paper, will be its editor.

The publication, which will be known hereafter as "The Chicago Post" will appear each day in an entirely different form. The pages will be reduced one-half from the present size but increased in number from eight to sixteen.

The Chicago Post, it is announced, will make a feature of financial news, but will "present" all the news of value to its readers and will continue to take special interest in the literary, educational, reformatory and social life of Chicago. The paper will be strongly Republican in politics.

OREGON LUMBER RATES.

Tacoma, Wash., March 30.—A meeting of the board of directors of the Pacific Coast Lumber Manufacturers' Association, together with representatives of the Oregon Lumbermen's Association and Southwestern Washington Lumbermen's Association, was held here yesterday.

The most important action taken was the decision to advance the price of lumber for Eastern shipments \$1 per thousand, owing to the high price of logs prevailing at present.

The rules governing the grading of lumber for the rail trade were adopted, and those for cargoes were deferred until the next meeting.

Stettin, March 30.—The twin-screw steamer Cron Prinz William, of 15,000 tons register, belonging to the North-German Lloyd Steamship Company, was launched here this morning in the presence of Crown Prince Frederick William.

New York, March 30.—District Attorney Philbin said last that ex-Senator David B. Hill had been retained by him to present the arguments for the prosecution when the Mollieux case is laid before the Court of Appeals.

The little tug Leslie Baldwin made connections with the coral reef at Kahului on Thursday last and smashed her propeller. The extra propeller taken over on the little vessel has been put on and she is again ready for service. Governor Dole has had published the report of President Raymond of the Board of Health stating that the death of the Japanese woman in the Japanese hospital over a week ago was a sporadic case of plague. The Board of Health has taken all the necessary precautions to the satisfaction of the Federal quarantine authorities and there is no prospect of further spread or interference with commerce or passenger traffic.

Will Do Business With Ocean Bottom. The little schooner Moikihana has been chartered by Young & Wheeler and will be put into the sand business, which at the present time is a very lucrative one. She is at present being repaired at the old quarantine wharf, and will be ready in a few days for work. Sand will be procured in a rather novel way. Where heretofore the sand used in building has been taken from the beaches, the new firm will dredge for it with a pump. In this way better sand will be obtained and an inexhaustible supply of it is in sight. Most of the sand will come from the neighborhood of the Pearl River bar. At the present time sand is selling at the rate of from two to two and a half dollars a cubic yard, according to the quality, and it is hard to get at the price. EASTER SERVICES IN MANY CHURCHES

Catholic Cathedral Was Crowded from Morn- Till Evening.

**HER MAJESTY ATTENDS
 ST. ANDREW'S CATHEDRAL**

Special Musical Program at Central
 Union—Methodists Give Easter
 Concert—Rev. Azbill at
 Christian Church.

Although the weather was threaten-
 ing on Easter morn, the skies cleared
 at the church hour and crowds upon
 crowds of people—church members and
 otherwise—poured forth to the various
 churches of the city. Ladies and chil-
 dren were gaily bedecked for the occa-
 sion and the men all gave an extra
 brush to their clothes, hats and shoes.
 The services at the various churches
 over, the people went to their homes
 and then emerged again in large num-
 bers at the Easter band concert on the
 Capitol grounds in the afternoon.

Central Union.
 Central Union church was crowded
 to its utmost capacity yesterday both
 morning and evening. Chairs were
 placed in every aisle and even the ves-
 tibule was crowded to overflowing. The
 music was of an especially fine order
 and held the attention of the large and
 fashionable audience throughout the
 entire service. The pieces rendered by
 the choir were Handel's "Lift Up Your
 Heads, Oh Ye Gates;" Bach's "As It
 Began to Dawn," and "Beethoven's
 "Hallelujah" from "Mount of Olives."
 Mrs. A. H. Otis did the solo work in
 the morning, and displayed the remark-
 able range and culture of her voice to
 good effect. In the evening, a special
 praise service was held. The soloists
 were Prof. A. B. Ingalls, Miss Toia E.
 Barber, Mr. Harold Mott-Smith, Mrs.
 J. T. McDonald, Miss Della E. Gris-
 wood and Miss E. A. Halstead. In the
 morning, the Rev. W. M. Kincaid
 preached on the subject "Man's Lien
 On Immortal Life."

St. Andrew's Cathedral.
 St. Andrew's Cathedral Sunday
 morning was clothed in decorations be-
 fitting the season. The tall pillars
 were wound about with flowers, and
 greens and upon the platform was a
 profusion of potted tropical plants. As
 at the Christian church, there was a
 large cross of ferns and white flowers
 on the pulpit stand. The services of
 the Second Congregation were opened
 with the carol "Oh, the Golden Glow-
 ing Morn," by the choir. Next came
 Tallis' Festival Response and the
 Easter anthem "Christ Our Passover,"
 and then the choir and organ gave Max
 Vogrich's Te Deum in F major and the
 Jubilate in B flat, by Dr. Stewart. Rev.
 Alex. Mackintosh addressed his con-
 gregation, taking as his text the fol-
 lowing: "That I may know Him, and
 the power of His sufferings being made
 conformable to His death." At the con-
 clusion came the anthem "At That
 Wondrous Easter Dawn," sung by Mrs.
 C. B. Cooper with organ and piano ac-
 companyment and Jeffrey's carol, "Tell
 the Story of the Risen," by the choir.
 After this regular service, the celebra-
 tion of the Holy Communion was held.
 In the evening at 7:30 o'clock the sur-
 prised choir sang a magnificent Nunc
 Dimittis, as well as a number of special
 Easter hymns.

The Bishop's congregation held a
 choral service, the surprised choir giv-
 ing procession and recessional hymns.
 Rev. V. H. Kiteat, assisted by the
 Bishop and Rev. Mr. Glover, conducted
 the services. Queen Liliuokalani
 was among the communicants at the
 early service. At 11 o'clock, there was
 morning prayer, fully choral. Rev. V.
 H. Kiteat intoned, and the Rev. M. Glo-
 ver read the lesson. The sermon was
 preached by the Bishop. In the after-
 noon, there was a service in Hawaiian.

Methodist.
 Like all the other churches of the
 city, the Methodist Episcopal was ap-
 propriately decorated for the occasion.
 Flowers and palms were most effective-
 ly arranged. The program of music
 was a good one. The organ voluntary
 was Haydn's "Gloria" from the First
 Mass and the anthem was Leslie's
 "Resurrection." The offertory, Rod-
 ney's "Calvary," was sung by H. C.
 Chamberlain. The sermon was by the
 pastor, Rev. G. L. Pearson, who chose
 as his theme: "Christ the First
 Fruits." In the evening there was a
 Sunday school Easter concert. In-
 cluded in the program was a short ad-
 dress by the pastor.

Christian.
 Easter services were held in the
 Christian church on Alakea street Sun-
 day morning, Rev. A. E. Cory was to

have preached the sermon but was pre-
 vented from so doing by illness. Rev.
 W. K. Azbill occupied the pulpit, mak-
 ing a few impromptu remarks on "The
 Accusations Against Christ," the sub-
 ject chosen by Mr. Cory. The principal
 feature in the artistic decorations was
 a cross of ferns and white oleanders,
 placed in a prominent position on the
 pulpit. In the evening, the Rev. A. E.
 Cory delivered an Easter sermon en-
 titled "The Savior of Men."

Kawaiahao.
 At Kawaiahao, the services were at-
 tended by a large number of natives
 and visitors from other churches. The
 pulpit was beautifully decorated for
 the occasion by Mrs. Carrie Robinson
 who has charge of that branch of the
 work in the native church. The decora-
 tion was most excellently done. The
 main pieces were large potted palms
 and flowing bowls of palm flowers as
 well as maiden hair, and a liberal
 sprinkling of lilies and other flowers.
 The service was short. Ten new mem-
 bers were admitted into the church and
 in the neighborhood of fifteen babies
 were baptized by the Rev. H. H. Par-
 ker, who conducted the services. After
 this part of the services, Holy Com-
 munion was held. In the evening, the
 Rev. W. D. Westervelt preached on
 the subject: "Go Your Way; Make It
 as Sure as You Can."

Catholic Cathedral.
 The largest crowd that has been
 seen at a church here in a good many
 years, attended the Catholic Cathedral
 yesterday. The large sanctuary was
 crowded far beyond the doors, the
 throngs extending clear to the car-
 tracks on Fort street, and filling the
 court mauka of the church. The cathed-
 ral was kept open all night for the
 sake of allowing worshippers to come
 early and secure seats. Some were
 known to enter the church as early as
 4 o'clock, so that by the time for the
 Pontifical High Mass, it was impos-
 sible to get anywhere near the cathedral.
 The music was of a high order. The
 mass by Peters was ably rendered by a
 quartet. Miss Alice Campbell sang
 better than ever before, and the crowds
 outside the church were fully satisfied
 in having heard the music. The pro-
 gram was, "Great is the Lord," by
 Heffy; "Jubilata Deo," by Bamback;
 "Alleluia," by Dunham and "Christ the
 Lord is Risen."

St. Clement's Chapel.
 The services at St. Clement's chapel,
 Makiki, were conducted by the Rev.
 John Usborne. The chapel was very
 prettily decorated and the services par-
 ticipated in by a large audience. After
 the usual services communion was held.

THEY COMMEMORATED SHILOH
 The members of George W. De Long
 Post, G. A. R., held a camp fire Sat-
 urday evening at Waverly hall, in ce-
 lebration of the 35th anniversary of the
 battle of Shiloh. The meeting was at-
 tended by five veterans who took part
 in the great battle. They were: Thos.
 Carey, J. T. Copeland, C. H. Dickey,
 John Francis and Wm. McCandless. R.
 W. L. Eaton, Post Commander, pre-
 sided.

The refreshments were of a character
 to remind the veterans of the fare in
 the field in the 60's. Black coffee, pork
 and beans and ginger ale and sassafras
 tea were provided in abundance. Stor-
 ies of the war were flying right and
 left and the camp fires were not
 smothered until after midnight.

FUNERAL OF MRS. RICHARDSON
 Funeral services for Mrs. John Rich-
 ardson were held at St. Andrew's
 Cathedral yesterday afternoon. The
 Episcopal service was read by Rev. V.
 H. Kiteat. The pupils of St. Andrew's
 Priory sang a song entitled "When
 our heads are bowed with woe."
 The casket was covered with beauti-
 ful floral offerings and draped with
 the Hawaiian flag. Among those pres-
 ent was Queen Liliuokalani.
 The pall bearers were: Robert W.
 Wilcox, S. E. Kaine, D. Kalanokalani,
 R. H. Makekau, Wm. White, S. Now-
 len, E. B. Friel and S. F. Chilling-
 worth. Interment was made at Ka-
 waihaeo cemetery.

PRINCETON-HARVARD DEBATE.
 Princeton, N. J. March 30.—The fol-
 lowing question for the Princeton-Har-
 vard debate to be held here on May 10,
 has been submitted by the Princeton
 inter-collegiate debating commission:
 "Resolved, That Congress was just-
 ified in imposing the terms embodied
 in the Platt amendment to the army
 appropriation bill as condition pre-
 cedent to leaving the government and
 control of Cuba and its people (the con-
 dition with regard to the title to the
 Isle of Pines being excepted)."

Transport Lawton Around the World Is in Quarantine In an Indian Canoe

Shortly before 2 o'clock yesterday the transport Lawton from Nagasaki anchored off the harbor. She carried for eight hundred tons of coal and to land two cases of small-pox. One of the cases is convalescent and the other case broke out ten days before the vessel reached here since which time no others have developed.

The troops aboard the Lawton are the entire 39th Infantry which was in China. Being a small vessel her accommodations are taxed to the utmost. The principal officers aboard are General J. M. Bell, Colonel McGregor of the Ninth Cavalry and Colonel Hayes of the Fourth Cavalry. General Bell is a Pennsylvanian. He entered the army in 1862 as a member of the 88th Ohio Volunteers and subsequently received a commission in the cavalry of his own State, retiring from active service in 1865 as captain. At the organization of the 7th U. S. Cavalry in 1866, he entered the regular service as second lieutenant and during thirty-two years actual service, was promoted until he became Major of the First Cavalry.

A recent issue of the Washington Star contains the following regarding Gen. Bell: He was brevetted as first lieutenant and captain for gallant services in the battles of the Wilderness, Virginia; brevetted a major for gallantry at Ream's Station and lieutenant colonel for service in action against the Indians in Montana in 1877.

Colonel Bell has served with distinction throughout all the period covered by the greatest of our Indian wars from 1856 to 1890. At the outbreak of the war with Spain, Major Bell sailed in command of a squadron of his regiment to Cuba and was commended for his gallant services in the first fight, where he served under General Young at Las Guasimas, being one of the first officers to fall grievously wounded by a Spanish bullet. He was made a brigadier general of volunteers during the Spanish war. He is now on his way home from the Philippines and will be assigned to the command of one of the new cavalry regiments.

FUNERAL OF DR. McKIBBIN.

Wailuku, April 6.—The funeral of the late Dr. Robert McKibbin was held on Thursday at Makawao cemetery above Kalauni, Rev. Wm. Ault officiating. There were many beautiful floral offerings from friends of deceased. Friends for miles around attended the funeral. Miss Lucy Peabody from Honolulu was present at his death bed. The pall bearers were: Louis von Tempky, W. O. Alken, Dr. McConkey, Frank Woods, Chas. Copp and Dowdle. There will be a meeting of the Buckeye Club this evening at 7:30 o'clock at the home of Rev. W. D. Westervelt on Kinau street.

Repairs to the stem of the Walaleale are being made. The steamer Maui is discharging her sugar into the Himalaya. The schooner John G. North will leave Hanalei for the Coast on Wednesday. The steamer Claudine from Maui ports arrived last evening with many passengers and a big load of sugar. The W G Hall brought 523 bags of sugar for Hacked & Co which goes into the railroad storehouse. The steamers Noeau, Walaleale, Niihau and Keaouhu are now laid up as a result of the strike of the mates. The bark Albert will tow over to Kaanani tomorrow to load sugar. It is probable that the Fearless will take her over. The schooner Allen A. made the run from Hilo to Mahukona in six hours recently beating the best previous steamer time and making a record. There were 75,350 bags of sugar ready for shipment on Kauai yesterday. It was distributed as follows: Kilauea, 20,000; Kapaa, 19,000; Han, 3,000; Lihue, 2,400; Koloa, 6,000; McBryde, 4,200; Mak, 16,800; G. & R., 600; K. S. M., 3,000; V. K., 200; Diamond W. cleaned out.
