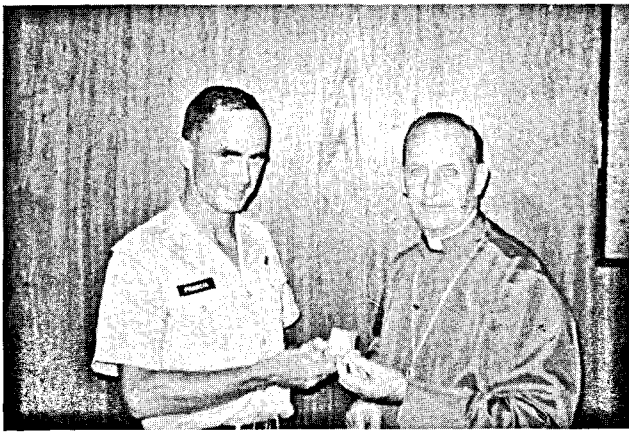

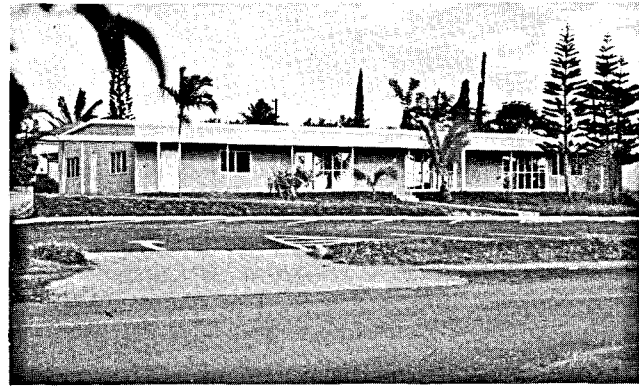

The new parish house has 11 classrooms, two bathrooms, a nursery, kitchen and parish hall. It was built by Rothwell Construction Company at a cost of \$57,000.

Participating in the dedication ceremony was the Reverend Howard Kishpaugh, Vicar of the Church, the Bishop's Committee and members of the parish.

We rejoice that this building, so badly needed, has been completed, since it will fill a great need not only for this congregation, but for the community.

Announces Engagement

The Venerable William A. Hio, missionary in charge of our work on Okinawa, has announced his engagement to Miss Miriam Akemi Yamakawa, a woman missionary in Okinawa. They will be married on September 26th in Honolulu, by the Bishop, before going to General Convention. She will be a delegate to the Triennial Meeting of the Episcopal Churchwomen.

Our people in Hawaii will remember Miss Yamakawa as a speaker from Okinawa, when General Convention was held in Honolulu in 1955. She received her Master's Degree at Cornell University in 1961 and attended the General Convention in Detroit, following her study at Cornell.

The Reverend Stanley M. Adams, who is a graduate of The Church Divinity School of the Pacific, has been assigned Vicar in charge of St. Alban's congregation which meets in the Iolani School Chapel each Sunday.

He will also be in charge of a chapel being established in Waikiki at the Reef Tower Hotel, to be known as the Episcopal Church Chapel in Waikiki. Communion services will be held each Sunday to provide an opportunity for many island visitors to make their communions.

Calls For Support

The Right Reverend Arthur Lichtenberger, our Presiding Bishop, has called upon the nation's Episcopalians to actively support the civil rights legislation recently enacted by Congress. He has said, "The gravity of the present situation in American race relations demands far more than the silence of passive compliance. We must commit ourselves without reservations to the full support of civil rights." He termed the passage of the bill "a major step in advancing the equal application of rights guaranteed citizens by the Constitution."

New Building for Good Shepherd Church

Monday, July 13th, at 4:30 p.m., the Bishop assisted the Reverend Roger M. Melrose in the ground-breaking service for the construction of new \$27,000 classrooms on the church grounds, which will include ten classrooms, an apartment for the caretaker, and new lavatory facilities.

Six old buildings on the property were removed in order to make way for this much needed building.

Devoted Layman Called By Death

Mr. Sung-tao Lee, who has been Administrative Assistant for the Church's work in Taiwan, and recently in full charge of the work, after the departure of Bishop Gilson to Okinawa, was called by death on August 7th, in Taipei, Taiwan, following a heart attack.

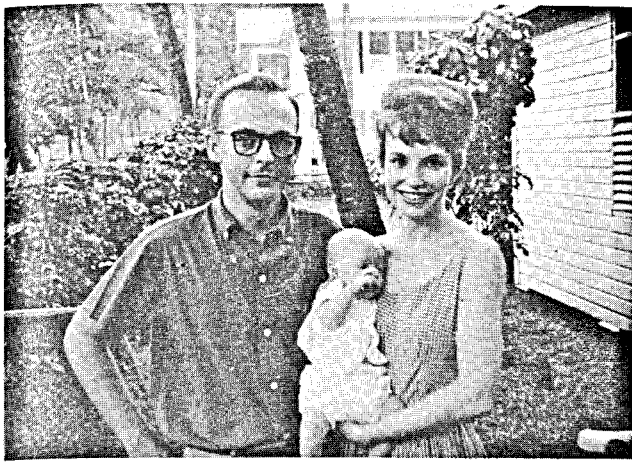

To Succeed Bishop Bayne

The Right Reverend Ralph S. Dean, Anglican Bishop of Cariboo (British Columbia), will succeed the Right Reverend Stephen F. Bayne, Jr., as Executive Officer of the worldwide Anglican Communion. The appointment was made by the Communion's 18 archbishops and metropolitans. It will become effective when Bishop Bayne returns to the United States to direct the work of the Overseas Department of the Episcopal Church's National Council.

Bishop Dean, 51, will be the second to serve in this London-based post, one of the highest administrative positions within the 44-million member Anglican Communion. The office was established in 1958 by the Anglican Congress. Bishop Bayne, then Episcopal Bishop of Olympia, was named first Anglican Executive Officer.

With the birth of a document called "Mutual Responsibility and Interdependence in the Body of Christ," the brain-child of the Anglican Communion's 18 national church leaders, the Anglican Church's missionary emphasis has shifted from autonomous to cooperative church development. The task of implementing the "mutual responsibility" document to further Christianity throughout the world encompasses Bishop Dean's philosophy.

New Site For St. Michael's Church, Lihue, Kauai

Through the leadership of the Venerable Charles T. Crane, Archdeacon of Kauai and Rector of All Saints Church, Kapaa, a congregation was started at Lihue, where they have been meeting in the public school.

Now, under his guidance, and the work of the men and women of the mission, a 57,536 sq. ft. site has been purchased at a cost of \$38,000. They plan to erect a building on the new site in the not too distant future.

Return From a Year's Study

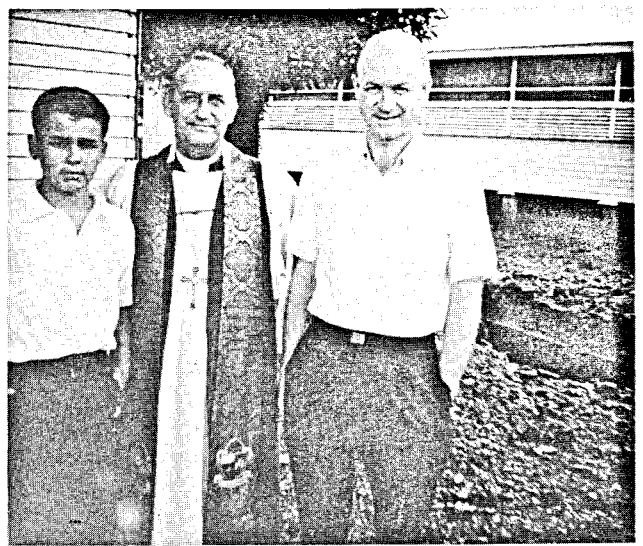

In Memoriam

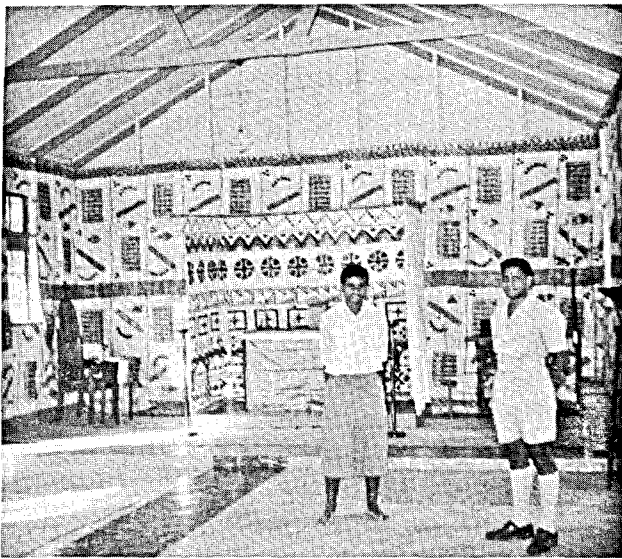
Colonel Thomas Roswell Aaron, retired Army officer, died on July 11th. He was the husband of our hostess at the Armed Forces Center and Diocesan House and was always a great help to her and to the men who frequent the Center.

He was a former commanding officer of Fort Armstrong and Sand Island and a long-time teacher at Kamehameha Schools, where he was a teacher of mathematics since 1951. He served with the 27th Wolfhound Regiment in Siberia during World War I. He was a graduate of West Point Military Academy.

He married Margaret LaMothe, daughter of the late John D. LaMothe, Episcopal Bishop of Hawaii in 1922.

The Aarons have lived at the Armed Forces Center since 1954.

Leads Mutual Responsibility Discussions

The Reverend Canon Charles Howard Perry, Canon to the Ordinary of Northern California, was in Honolulu with his wife and two daughters from August 14th to the 31st, to conduct conferences with clergy and laity on "Mutual Responsibility," which will be the main topic of discussion at the General Convention in Detroit, October 11-23, 1964.

What are the implications of "Mutual Responsibility?" A primary and major objective in the Mutual Responsibility document's intentions is the overcoming of parochialism and clericalism, those ecclesiastical sins which produce lay apathy and introversion in the Body of Christ.

The Diocese of Delaware has given some very clear instructions for the clergy and laity to bring about a greater understanding of what our role as Christians should be. The Vestry and mission committee should accept their role as the spiritual leaders of the parish, giving emphasis to our part as stewards, church attendance and the application of Christian principles to social problems of our day. This obviously implies that the vicar or rector must set the first example by making his own convictions and practices clear and encouraging vestrymen to follow his leadership, for example, in the matter of tithing.

The ministry of lay leaders should be broadened by further training at the hands of clergy to include pastoral calling and the education of other lay people. We should lose no opportunity to work toward the achievement of the clearly stated diocesan goal of giving away as much money as we spend on ourselves.

As one of the principal responsibilities, the clergy should constantly devote themselves to the training of lay Christians for their ministries beyond the eternal life of the Church, principally in and through their regular occupations, but also through the many voluntary agencies that exist for social service in every community.

We are indebted to the Reverend Claude F. Du Teil, Rector of St. Christopher's Church, Kailua, Oahu, who as Chairman for the Diocesan Program of Mutual Responsibility, has done such a splendid work in organizing the conferences for Canon Perry on all islands.

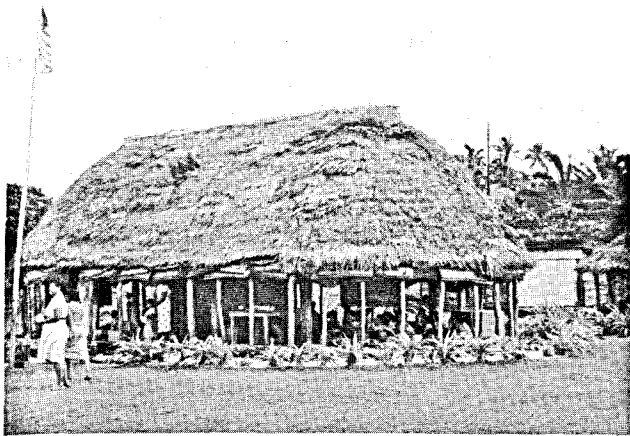
Ordained In Long Beach

Your Minister Has Problems
