TO FRIENDS ABROAD.

The Republic of Hawaii was assaulted early this month by placemen of the old regime of the throne. The intention was to oust the present Government and restore Liliuokalani. The revolt was very promptly suppressed. Attorney Chas. L. Carter, a volunteer was killed, an army officer was wounded and a number of rebels lost their lives. But two of their bodies were found and buried.

The insurgents were encouraged to rise by the belief that the President of the United States was friendly to them. Mr. Cleveland had said in a letter to the ex-Queen's Commission last summer that he could do nothing for their cause. Nevertheless some of the disgruntled had thought the ex-ruler had private assurance from the White House. After the monarchy was put aside in 1893 Mr. Cleveland thought at one time to restore it.

This Republic wants the friendship and political support and moral aid of every American. The new government is entitled to all this. Under the banner of annexation the Republic of Hawaii is seeking closer political union with the United States. Both countries will be vastly benefited. The United States needs an outpost in the Pacific. This is an American colony about which should fold the mantle of the mother land.

Our friends are asked to accept our statement that the Americans, Britishers, Germans and other pioneers are battling only for enlightenment, for liberty, for honest government. Locally, victory is achieved. Abroad our maligners are busy. It is abroad that we would spread the truth.

ALL of the people who go up by the Australia today will be interviewed. Is it saying too much to suggest that they deliver to questioners the unclothed truth about the islands?

THE Military Commission adopts the statutory requirement of two witnesses to an overt act. Visitors capable of passing an opinion declare they never saw prisoners getting fairer trials.

IT is understood now that the acquittal of two men by the Military Commission was due to the fact that they were guilty of a lesser degree of offending than charged in the indictment.

BETWEEN Marshal Hitchcock and Capt. Robert Parker there stands a young man whose record for the month is the pride of his friends. Arthur M. Brown, the deputy marshal, is the individual.

MARSHAL HITCHCOCK places the tabu on the stronger drinks and has a safety valve attachment for the beer barrels. With all his impetuosity the "holy terror" is endowed with a caution that manifests itself in working out vexatious problems.

THE white flagship looks nice. She is a fine water fort and Americans are immensely pleased with her. She is more than welcome to the port. But, as previously remarked, her task of protecting non-combatant Yankees is a light one. The launch would do for that duty.

AN apology is made to Major Geo. McLeod for omission of his name from the battalion roster in the first edition of the War Book. The Major was at his post from first to last and was cool and unerring under most trying circumstances.

WHO is the correspondent of the San Francisco Post? He should be hunted out and punished the same as any enemy of the Commonwealth. The Post and its prevaricator are a well-met pair. The paper speaks of the leading men of Hawaii as being "no better than robbers."

Timely Topics.

January 28, 1895.

A copy of the Honolulu Japanese Harikari on our desk contains the somewhat startling intelligence that the Japanese laborers who left one of the adjacent plantations at the beginning of the recent trouble did so with the intention of taking up arms against the Government. In commenting upon the subject the Harikari says editorially, that as the country in no way belonged to the subjects of the Japanese Empire they showed a decided inclination toward the idea in desiring to take part in the fight. We can hardly credit the story and are rather inclined to the opinion that it savors of an American campaign document. But assuming that there is at least a semblance of truth in the statement, the Government has a stronger foe than it has yet had to combat; stronger at least from a numerical point of view, and different from the last in the sense that the people are more scattered and their munitions of war as well as their methods of warfare would be different. This result aimed at would not be the same because it would probably be their intention to assume control of the territory in the name of their Emperor. In such a case the Government would have among its allies citizens of every other nationality residing here. Every one knows that two years ago there was a great deal of talk about the intentions of Japan and a great deal of speculation as to the outcome of the trouble if the Japanese flag should be hoisted over the islands. Japan had no intention then of interfering in the affairs of Hawaii and probably has less intention today. In the first place the location is against it, and outside of the laborers and a couple of hundred merchants Japan has no particular interests here. To read newspapers and to listen to the utterances of some people one would suppose Hawaii to be a very rich golden nugget rather than a "pear ripe for plucking" and that every government in the universe was ready to lay hands upon it. When Hawaii loses its sovereignty it will be through a treaty with the Government which the people, through their representatives, may select. In the United States opinions are divided as to the advisability of the scheme; England does not consider the matter at all because it recognizes America's claim owing to its geographical position as well as the interests represented; Japan couldn't take the islands if it wanted because both England and the United States would each have, metaphorically speaking, chips on their shoulders that would have to be knocked off. Its success in the war with China might tempt it to seek other worlds to conquer, but if the Japanese look in the cause of their success they would find that it was owing simply to intercourse with more enlightened, and accepting instructions in warfare from more progressive people. It is hardly possible they would care to engage in a war with the races who have "shown them the way." Hawaii will retain its independence until the American eagle can be persuaded to take it under its wing. It may be a long time yet. The Alaska business was not settled in a day and every one who reads knows the outcome of the San Domingo business. So far as the people here are concerned there are fewer obstacles in the way of annexation today than there were six months ago, six months hence there will be still less. The wrinkles on the brow of the country are being gradually smoothed out, the principal objections exist in the United States and until a majority of the Senate can see the wisdom of adding to the already large territory of the United States annexation will not be an assured fact.

PROCLAMATION

EXECUTIVE BUILDING.

HONOLULU, H. I., JAN. 7, 1895.

The right of WRIT OF HABEAS CORPUS is hereby suspended and MARTIAL LAW is instituted and established throughout the Island of Oahu to continue until further notice, during which time, however, the Courts will continue in session and conduct ordinary business as usual, except as aforesaid.

The Popular Millinery House.

NATIONAL CANE SHREDDER.

Patented under the laws of the Italian Republic.

One of these Shredders has recently been installed at the mill of the Paahau Plantation Company, Hamakua, Hawaii, and Mr. Andrew Moore, the manager, writes concerning it:

PAUAHAI PLANTATION CO., HAWAII, JAN. 10, 1895. WM. G. IRWIN & CO., LTD., HONOLULU: GENTLEMEN—The mill has been running during the past two weeks, with the National Cane Shredder lately installed, giving the most satisfactory results. Our mill consists of three sets of two rollers, 32 in. dia. by 72 in. long, the shredder disc being 5 ft. 7 in. long, driven by an automatic engine 11 in. dia. cylinder by 14 in. stroke.

The Hattison cane being milled is as hard as it is possible for cane to be, having been subjected to a severe drought during the whole period of its growth, and growing on land with a trade wind exposure. Our experience with the Shredder, particularly with above cane, proves it to be just what our mills required, the shredded cane being better prepared to have its juice extracted than formerly after passing through the first mill. The first mill is now allowed to open 9-10 in. instead of 1/2 in. as formerly, so that the trash now leaves the first mill, better ground than it formerly did the second, and this without the old time grinding, choking, and straining of the machinery.

Behind the first and second mills we apply hot water, the quantity for the past 12 days, as per statement attached, has averaged 35 per cent. on the total juice from the cane. The trash from the first mill is cut up much finer than before the Shredder was applied, much of it resembling saw dust, it contains as per statement 29 per cent. of moisture and makes good fuel, the juice from the last mill stands 5 degrees Brix, so that the moisture in the trash is 5 per cent. sugar solution. The Boilers make steam much easier than before, now care has to be taken to keep them from blowing off, whereas before great care was necessary to keep the steam from going too low when the Pan was on.

By the use of the Shredder we have dispensed with six men, formerly necessary to distribute the cane on the carrier, feed the first mill, and throw back the long pieces.
