WAILUKU SHORT OF HOUSES AND LAHAINA ALSO

Subject is Called to Attention of Chamber of Commerce and Will be Considered at Later Meeting.

Maui has its housing problem just as has Honolulu and as have the cities of the mainland, the shortage being felt most acutely in Wailuku and in Lahaina. There are waiting lists of families who desire homes but have been and are unable to secure them. The subject was informally discussed at the meeting of the Chamber of Commerce yesterday afternoon and is to be taken up again next month when the president of the chamber has returned from the mainland.

It was J. Garcia, cashier of the Bank of Maui, who called the attention of the chamber to the fact that Wailuku has a housing problem of its own and Vice-President, A. W. Collins, who occupied the chair in the absence of President Penhallow, said Wailuku was not alone, that Lahaina was similarly affected.

The real estate department of the Bank of Maui has a waiting list of more than a dozen families who are seeking homes, Garcia said. He said that most property which might be used for building expansion is owned by Wailuku Plantation and that the policy of the plantation has been to exchange for taro land which carries water rights, not to sell. He carried that the company in all such exchanges had shown a spirit of eminent fairness. But, continued Garcia, lands carrying water rights have grown scarcer and scarcer until they are now very difficult to obtain and the difficulty tends to make the same difficulty for securing the residential property.

Tracts which are available for residential purposes after subdivision are needed if Wailuku is to expand, he said. Conditions here are different from in the plantation camps and towns where the companies can build houses as needed for employees on the plantation land. Wailuku is not composed of plantation company employees to any such extent. He suggested that at a subsequent meeting there should be a more full discussion and perhaps a committee then named to devise ways and means.

Mr. Collins said the point was timely and well raised and that Wailuku is not alone, that Lahaina is similarly affected and quoted prices brought at the sale of beach and other lots a few weeks since when the land department had an auction. Those lots were, he said, a considerable distance out of town and yet brought two to three times the upset prices.

The subject was then deferred to the next meeting.

Capital Increase For Haiku Fruit & Packing Company is Considered

Increase of capitalization of Haiku Fruit and Packing Company is contemplated and a special meeting is to be held at the company's office in Haiku on May 5, to act upon the proposal. It is intended to increase the capitalization from \$615,000 to \$1,000,000, is the report emanating from Trent Trust Co., in Honolulu.

The increase will be made up of a 25 per cent stock dividend (7687 shares) to the stockholders of record the sale of 7687 shares to the stockholders of record at par; and the sale of 3876 shares in the open market for the benefit of the company.

According to the annual report to the company recently received here, dividends amounting to \$98,384.40 were paid during the year and undivided profits less reservations for taxes and other purposes, amount to \$209,662.27.

Tavares Reports

A. F. Tavares, manager of the company, says:

"The pack for 1920 less all bursts and swells amounted to 633,392 cases; 234,789 cases more than our 1919 pack, and 83,392 cases over estimate, which was 550,000 cases. The weather conditions though very dry were favorable to the growth of pineapples, so that the percentage of No. 1 fruit was far in excess of the estimate, while the No. 2 fell way below our expectation, requiring us to order extra No. 2, 4 box shooks and leaving on hand at the end of the year a large quantity of No. 2 box shooks, which will be used for the 1921 pack.

"The yield in tons was as follows: From our own fields, 1484 tons; from private growers 18,609 tons; and the average pack per ton of fruit was 31.52 cases, while that of 1919 was 33.05 cases. The average decrease in pack per ton was caused by the fruit being larger than last year the smaller the fruit the larger the average cases per ton. Another cause of this smaller average is the fact that our

In competition with all of the large print shops of Honolulu Maui Publishing Company was the lowest bidder for the contract for printing the journal of the territorial house of representatives when the bids were opened last Saturday and was awarded the contract. This is the largest single printing job ever undertaken on the Valley Isle as can be judged from the fact that the house journal of the last session was a book of 1573 pages.

Plan For Home For Children Dropped Before Opposition

Plans for a public children's home on Maui have been abandoned in the face of opposition which arose to the project and if there be any home it will be one conducted by the Catholic Church as an institution of that church though it is understood support would be voluntarily offered by some non-Catholics if that plan shall be pursued. Objection or opposition to the project centered on the proposals that the children would be in charge of sisters of the Catholic church, that the Catholic church organization would have the right to appoint four members of the board of trustees or management and that there was a possibility of county and perhaps territorial financial support for its needs while practically under sectarian control.

Originally it was planned to have a board of management of five to be composed of one member appointed by the Catholic Mission, one by Alexander House Settlement, one by the Board of Supervisors, one by the Woman's Club and the fifth to be the matron in charge of the home. Later the plan was changed so as to give the Catholic Mission power to appoint two or more members of the board and that body selected Mrs. H. A. Baldwin and Mrs. D. T. Fleming, two non-Catholics.

The plans provided that those in charge of the children in the institution and its matron should be sisters in the Catholic faith; children of Catholic parentage were to attend the Catholic school and children of other parentage to attend the public schools, those of the Catholic faith would attend the Catholic church with the sisters and those of other faiths could attend their own churches in the custody of adults.

It had been expected that the county would avail itself of the opportunity to place indigent children there instead of sending them to the crowded institutions of Honolulu or placing them in charge of individual citizens paid to render them needed care.

FOREIGN LANGUAGE PRESS

As a substitute for the Foreign Language Press Bill there has been prepared by Attorney Warren of Honolulu a press licensing bill even more drastic than the pending bill but placing the burden of translation upon the territory, the attorney general's office to employ the necessary interpreters.

Track and Field Meet Will be Held Tomorrow

Maui's track and field day will be held at Kahului tomorrow unless the clouds should open in a deluge and flood the grounds so as to make them unusable. This morning it was reported that both track and field were in fairly good condition though a little heavy as a result of the daily showers of the past two weeks. Arrangements were going forward throughout the day in final preparation for the contests.

With a surprisingly large list of entrants, both individuals and organizations, tomorrow's meet promises the keenest sort of interest and the hottest competition. If the track be heavy it will mean a slowing down of time but no diminution of effort and every endeavor is being made today and will be continued tomorrow morning to get the grounds in the best possible shape.

Refreshments will be sold during the meet and the proceeds will go to the establishment of a dental clinic on this island.

Maui Legislation Making Headway

Several Measures Enacted, Others Considered Certain and Only a Few Bills go to Discard.

Legislation desired for Maui is in most instances progressing favorably, reports County Attorney Bevins who is home from Honolulu for the board of supervisors meeting. However, some of the proposed measures have fallen by the roadside.

The County Library bill has been passed by both houses of the legislature and sent to the governor and the Kahului bath house bill has been enacted and signed. In the school budget is a provision for \$5000 for transportation of children and it is thought it is safe of passage. The act amending the eminent domain law so as to cover publications in other than daily newspapers is enacted. Several provisions that were in the proposed uniform traffic law have been put into separate bills, some enacted and others probable of enactment. Eight thousand dollars is the figure for circuit court expenses, there is a \$1500 appropriation for dependent children, a salary and expenses for an officer of the juvenile court in the court appropriations. The salary bills seems assured of passage and there appears no objection to changing the tenure of office for county officials from two to four years if it is finally determined Maui wants such an amendment. The uniform traffic bill has not been introduced. Its length appalled officials and legislators. Other county attorneys had it referred to them and some thought it too lengthy but could find nothing to omit. But the legislators were kanulua on considering such a lengthy measure.

Taxation on present year instead of past year valuation has gone into the discard. It was reported unfavorably out of committee and called impracticable. So also with the bill which would give a county the right to do any public work or building for itself when bids were considered exorbitant, for both Honolulu county and Hawaii county oppose it. These cover practically all of the subjects decided on as Maui legislation immediately before the opening of the session.

In the loan fund bill there is an appropriation of \$40,000 for Kahului harbor, \$300,000 for belt road, \$100,000 for county building, \$25,000 for Hana water works and the deleted item of \$25,000 for Wailuku water works has been restored.

SMASH-UP AT PAIA

This morning a plantation train collided with a Ford car at the crossing at Lower Paia and a wreck followed. The Ford was badly smashed, cars were thrown from the track and the brakeman was injured.

Kamehameha Students Entertain Maui Folk In Splendid Fashion

Kamehameha School students while guests of Maui turned the tables, became splendid entertainers and assisted greatly in adding to the attractiveness of the services in two of the churches as well. The boys themselves said they had a "dandy" time, or words to that effect and the Mauiites who heard them sing and play and saw them drill retort that they would not have missed their experiences for a great deal.

Practically every seat in the Territorial Building at Kahului was taken for the concert and operetta on Friday night and it is said that the advance sale was 500 tickets. With splendid voices, well trained the glee club singers rendered vocal numbers that proved most pleasing. The instrumental numbers were equally good and the operetta was a fitting climax. An informal dance followed.

Saturday afternoon at the Fair Grounds there was given an exhibition of drilling that was a genuine treat. Unfortunately for many would be spectators it rained in Wailuku and so numbers expected there would be no drill. But in Kahului there was no rain. The cadets showed a precision in their maneuvers and in the whole of the exhibition that would have been creditable in troops of the regular army.

Saturday night there was a well contested basketball game at Alexander House Gym, clean cut, well played and an exhibition of true sportsmanship, with the Maui team as victor by a narrow margin. After the game the greater part of the vacationists took the Kilauaea for home.

Sunday morning the glee club boys augmented the musical program at Makawao Church and in the evening sang at Wailuku Union Church. Monday afternoon they went over to Lahaina and gave a concert and then caught the Mauna Kea for Honolulu. Mauiites unite in calling them as fine a lot of boys as ever visited the island.

Chamber of Commerce Takes on Subject of World Press Congress

Entertainment of the members of the World's Press congress when they visit Maui at the time of the fair next October was brought up at the meeting of the Chamber of Commerce yesterday afternoon and a committee named to take up the subject with proper representatives of the Maui County Fair and Racing Association which organization will, it is expected, hold a meeting in the early future.

Following the reading of a letter from L. A. Thurston, chairman of the entertainment committee at Honolulu, the subject was brought under the attention of the Chamber and at the time its contents were told in an article in this paper. As then told, it is planned to have a large steamer carry the visiting party first to Maui and then to Hilo whence they will go up to the Volcano. Mr. Thurston wants to know at an early date what entertainment Maui will arrange and whether it will participate in any expense for chartering of the steamer over and above ordinary transportation which the members of the party will bear. Since the writing of that letter a bill has been introduced in the legislature appropriating \$25,000 toward the expenses of entertaining already there are 345 steamer reservations from the United States and South American members and Oriental, Canadian and Australian representatives are not included in that number.

Two standing committees are combined for the purpose of making arrangements on behalf of the Chamber for the coming of the delegates, the promotion and the reception committees. The first of these is composed of W. O. Aiken, W. A. Baldwin and R. A. Wadsworth and the second of E. R. Bevins, D. H. Case and J. H. Gray.

Game Birds Brought to Add to Maui's Supply

Bringing 23 crates of game birds secured for the county for stocking and replenishing purposes, Supervisor David T. Fleming returned to Maui yesterday after a trip to the Orient, Java and Sumatra. The birds were sent across from Lahaina yesterday morning and cared for in Wailuku until it shall be determined where they shall be released.

It was from the game fund, raised by shooting licenses fees that the purchases were made which consist chiefly of pheasants, doves and tree nesting pigeons.

Education Committee Of House is Coming

Maui is to have a visit from the committee on education of the house of representatives. Its members are expected to arrive in Lahaina late tonight or very early in the morning on the Kilauaea. There they will look over Lahainaluna school and it is probable they will take the opportunity to see some of the other school buildings and the sites for prospective school buildings as well as to look into school affairs generally.

The committee of the house is composed of Henry J. Lyman, chairman and Representatives Lowrey, Muller, Hoopole and Holt.

Lahainaluna affairs are the chief matter of concern for there are suggestions that it be made a high school and other suggestions of other changes for the institution.

Excellent Reports Made by Sanitarium To Supervisor Board

Five reports from the Kula Sanitarium were presented to the board of supervisors Wednesday and will be considered by the board at its meeting today. One report gave in detail the names, occupations and salaries of all employees of the institution and which were former patients. It has been the custom where possible to continue former patients in employment that they may be under observation for a time after discharge as patients.

The other four reports covered respectively the months of November, December, January and February. Annexed to the printed forms were separate sheets which showed in detail receipts from and costs of operation of the dairy farm, poultry farm, butcher shop and vegetable gardens and all four of them are now showing a balance on the right side of the books. There were 14 patients in the sanitarium at the end of February.

The detailed reports appear to contain all the information that the board suggested should be given to it in a motion passed at the March meeting.

Kahului Postoffice Mystery is Solved; Culprit Confesses

Kahului's post office thief, responsible for the miscarriage of many checks is in custody and has confessed. He was detected and arrested by Deputy Sheriff George Cummings and to him confessed. He will be sent to Honolulu for trial in the federal court.

Willie Yok Man, a part Chinese youth of 19 was the culprit. He has been employed as brakeman by the Kahului Railroad, he says, and was paid \$3.25 a day. According to his stories he would go to the post office about midnight and open the boxes of the Kahului Railroad Company and Baldwin Bank. He was looking for green backs, was afraid to try to cash the checks and burned them. He says sometimes he would find the boxes open and at others would work the combinations. He denies he had any accomplices.

Cummings has had the youth under suspicion of other offenses and on his arrest he confessed.

Variety Show Which Pleased at Lahaina Wanted at Wailuku

Efforts are being made to have the show so successfully produced in Lahaina on March 31 under the auspices of the Outdoor Circle brought to Central Maui and a performance given in Wailuku. If this be done it will be produced jointly for the benefit of the Woman's Club and the Outdoor Circle. Mrs. A. W. Collins was over from Lahaina yesterday and she and Mrs. Linton of the Woman's Club talked the matter over. Mrs. Collins afterward said that she would take it up on her return home and that a definite decision may be reached early next week. If, as is indicated, a favorable decision is reached the production will probably be offered sometime in the succeeding week, between April 18 and April 23.

As a result of the performance in Lahaina the Outdoor Circle netted between \$400 and \$500 and those from East and Central Maui that saw it came home enthusiastic. They have told their friends of their enjoyment of the affair and a desire to have a repetition here has been quite generally expressed.

Two features which were especially attractive were the cabaret scene with the black and white ballet and the Night in Hawaii, the latter feature having, perhaps, not been so extensively featured in the advertising as it might well have been.

Founding of Catholic Mission Commemorated

In commemoration of the seventh anniversary of the establishment of the first Roman Catholic Mission on Maui, celebration ceremonies were held at the Church of Our Lady of Victories in Lahaina last Sunday, which were largely attended from Wailuku and East Maui as well as by residents of Leeward Maui. Automobiles by the dozen and the score wound their way around the Paia from early morning until into the afternoon and later there was a regular procession of cars on the return journey.

High mass was said by Father James of Makawao who afterward made the address dedicatory of the beautiful shrine which was opened in memory of the anniversary. At high mass Father Englobert of Hana delivered the sermon in Hawaiian.

Following the high mass and the dedicatory services there was a fair and a luau attended by several hundred and a handsome sum, in the neighborhood of \$600, was realized. Father Bruno, of the Church of Our Lady of Victories thanked the gathering in the course of the afternoon festivities.

Drastic Limits Put On Text Book Changes

Drastic restrictions relative to changes of text books in the public schools are contained in Act 41 of the legislature. The measure was introduced by Representative M. G. Paschoal of this county as House bill No. 80, passed both branches of the legislature and received the approval of the Governor on March 31. Its text follows:

"Section 1. Whenever the department of public instruction shall have adopted a text-book or text-books for use in the public schools of the territory in connection with the course of study, such text-book or text-books shall not be changed for a period of five years from the date of such adoption.

"Section 2. The department of public instruction shall not, during any school year, change the text-books in more than one subject theretofore adopted for use in any elementary, grammar or high school of the territory.

STOCK IN MAUI ELECTRIC CO. IS OFFERED PUBLIC

Subscription Lists Will be Open Only Six Days; Shares Will be of \$20 Par Value and Issue \$50,000.

Organization of a Maui Electric Company to supply current for lighting and power in the territory formerly supplied by the Island Electric Co., is in progress. Announcement is made this week that subscription books for the purchase of stock in the company will be opened next Monday at the Baldwin Bank in Kahului and the Bank of Maui in Wailuku and that such subscription lists will remain open until noon of the succeeding Saturday, April 16.

It has been decided that the capital of the new company shall be \$100,000 of which \$50,000 in stock will be issued at this time and the remaining \$50,000 will be held in the treasury for issuance and sale at such time or times as further capital may be required. Shares are to be of the par value of \$20 each and payment for such shares as may be allotted to subscribers must be made to the banks by April 25. It is not expected that offers for less than five shares will be considered. Over subscriptions will be pro-rated.

The new company will have the franchise, plant and equipment of the Island Electric company purchased by the foregoing bondholders at the sale of the property on March 28. Under the circumstances it is apparent that there may not be a very large proportion of the shares now offered available for the general public should the old Island Electric Co. plan be paid for in stock in the new company or should the bondholders purchase shares in proportion to their former holdings in bonds.

No further developments in regard to the pending charter for a gas and electric company for the Wailuku and Makawao districts have been reported from Honolulu where the necessary legislation is pending nor has any further information on the subject transpired on Maui.

There has been introduced and is now pending in the legislature, also, a bill extending the time for the securing of a franchise for a Makawao electric company, a provision for which passed the last legislature but has not yet been approved by congress.

Social Workers Will Meet in Honolulu on April Twenty Third

Beginning with a reception and supper at Palama Settlement, Honolulu, Saturday, April 23, the Territorial Conference of Social Workers will continue until the following Saturday, giving programs each day except Sunday for the delegates and guests attending the conference while on Sunday special services at Central Union church are planned. Practically all the committees which are to handle the details of the conference have been named, and the program is now being worked out say latest reports from Honolulu.

Married in Honolulu—George L. Kennedy and Miss Isabel L. Borba were married in Honolulu last week and have returned to Wailuku.

Ladies Aid Meeting—Ladies Aid Wailuku Union Church will meet at the home of Mrs. Caleb Burns next Tuesday afternoon at 3 o'clock.

Woman's Guild Meeting—The postponed meeting of the Woman's Guild of the Church of the Good Shepherd will be held Tuesday, April 12th at Mrs. Fields' Wailuku.

Former Wailukan Dies—Adrian Edward Keenu, born in Wailuku, 65 years ago died in Honolulu, where he was resident, last week. He was buried in the Catholic cemetery there.

Injured Child Dies—Mary Kaona, the little Hawaiian child that ran in front of and was struck by a motor cycle ridden by J. R. Curtis last week, succumbed to her injuries last Saturday morning.

Mrs. Keonihapa Dies—Death of Mrs. Maria Kaanaana Keonihapa, widow of Johnson Keonihapa, at her home in Buckle Lane, last week, is reported from Honolulu. She was born in Hana nearly 75 years ago.

Deed Is Drafted—At the meeting of the board of supervisors Wednesday a deed was offered by the county attorney for execution by the H. C. & S. Co. to the county for a tract of land for a new Pottersfield.

Leave Granted Cannery—In a resolution passed by the board of supervisors Wednesday permission is granted the Haiku Fruit and Packing Company to erect and maintain a conveyor across the road at its cannery.

Mauna in Tomorrow—Announcement was received in Kahului yesterday that the Mauna would not leave Honolulu until today and would be in the Windward Maui port tomorrow morning instead of this morning.

Five Press Delegates—Hawaii is entitled to five delegates to the Press Congress that will be held in the Islands next October and Governor McCarthy has received a letter from Dean Williams asking the executive to name them.

Pension increased—Recognition of services rendered in educational work in the early days is shown in Act 49 of the legislature which increases the pension granted to William Cross Crooks in 1915 for 32 years of services in educational work from \$30 to \$50 a month.

Extension Made—Extension of the Child Welfare law's scope so as to cover cases of need not included in the old law is brought about by the passage by the legislature and approval by the governor last week of the amendatory legislation known as H. B. 78.

Paris Estate Estimate—An estate valued at about \$30,000 was left by the late Edwin H. Paris according to a petition filed in the circuit court by Mrs. Margaret Paris. Appointment of Senator Harry A. Baldwin as administrator is asked, and a hearing on this will be held, May 9.

March Sugar Bonus—The laborer's bonus for the month of March was 28 percent with a monthly advance of 21 percent according to the Hawaii Sugar Planters' Association's publication. The total price for the 31 days was 162,855 cents and the average price for 31 days was 5.8162 cents.

Family Group Pictured—Recently the five sons of William H. Rice of Kauai were all on the Garden Island at the same time and a family group was photographed. The sons are Senator Harold W. Rice of this Island, Arthur Rice of Honolulu and William H., Philip and Senator Cahries A. Rice of Lihue.

Safeguards Tax Payments—Requirement for residents to the territory who desire to travel to foreign countries would be required to furnish certificates of payment of indebtedness for taxes before being permitted to depart is contained in a house bill introduced by Representative A. M. Cristy.

Public Meeting Postponed—Following the resolutions of the chamber of commerce which asked an indefinite postponement of the public meeting on the subject of Kahului Harbor pier head lines which were sent to W. A. Johnson, major of the corps of engineers, Honolulu, a communication has been received by the chamber from him announcing the postponing until further notification.

Former Mauite Suicides—Telegraphic advices last week told of the suicide of Holmes Beckwith at Syracuse, New York, following his killing of Dean J. Herman Wharton of that institution. It is reported that he was demoted following his discharge from the institution where he was a professor. Beckwith was born in Haiku in 1884 and was a son of a former minister of Makawao Foreign Church.

Suicides While Insane—H. Shiroda, an Okinawa pineapple grower, committed suicide by hanging Monday at his home in the Makawao district. He was not dead when cut down but died shortly afterward before medical aid arrived. Shiroda was found by his two brothers. It is said that he had a considerable amount of pineapple land and seeking still more, and seemed bright and cheerful a few days before his death. It is thought he was temporarily insane when he took his life.

Grazing Bill Amended—On motion of Senator Harold W. Rice, senate bill 57, an administration measure authorizing agents of the territory to shoot or seize all cattle found on government forest reserves, and to fine the owner of the cattle \$10 a head, was amended so as to permit owners of stock to turn their cattle into their own forest lands in time of drought and famine, even when such land, with their consent, has been set aside by the government as a forest reserve.

Numerous comments have been made with regard to the planting of coconuts in Kahului all commensurate. As Kahului, the entry port for this side of the island, is the front door of windward Maui, it is, then, the place where first impressions are gained by visitors, and we all know how lasting are first impressions. And our own trees and shrubs are the things tourists want to see. They do not come here to see lovely roses, carnations, chrysanthemums and other blossoms that they can see in profusion and great beauty in the states; they expect to see waving palms and the bright colored hibiscus, bougainvillea, pink and golden showers, cup of gold and bignonia, for these are the things they have heard about, as indigenous to Hawaii. So let us plant these things, which are hard to surpass as to beauty, anyway. No one need wait for the civic department to plan; they are doing splendid work in this department, but each citizen of Maui can make a bower of beauty of his or her own premises, and thus help to bring about a glorious Maui.

April 11th to 17th is Humane Week and will be so observed, especially in the schools.

It is understood that the College of Hawaii is willing to establish extension courses on Maui. This is a splendid opportunity for our island, and it is hoped that in the coming months the plan will become a reality.

The library law is finally passed, with no reservations and there remains now the actual work of establishing a library on Maui. It is something to look forward to.

Reservations for 325 persons on regular steamship making the island run can be guaranteed, and reduced rates have been obtained for delegates and their friends and relatives from Australia and Latin America.

NOT A PRETTY PICTURE

By no means edifying is the sight of a scramble to secure legislative appropriations both from the loan fund bill and the appropriation measures, general and special. It presents the spectacle of a wild grabbing to get as much of the public funds and of the public credit as may be secured instead of a dignified effort to enact laws and to meet the actual needs of territorial expenditure. Little regard is paid to relative proportions or a fair division and in using the territorial credit for county improvements there is an utter absence of the ordinary business caution that would be used in borrowing upon one's own property.

When it comes to borrowing on public credit it would appear the ordinary citizen is quite ready to mortgage the county property for purposes for which he would never consent to place a lien upon his own holdings alone. Again, when territorial property is to be bonded the individual and the community seek to secure improvements for which they would never vote a bonding of the county at a plebiscite.

Instances are easy to find. Would any one dream so wildly as to picture the voters of Honolulu bonding the city and county property to build a \$250,000 swimming pool even for a war memorial? Hardly. Ballots would bury it.

Can the County of Hawaii be pictured as voting a bond issue of \$25,000 for a county fair? Yet the Hilo board of trade coolly proposes to ask that sum from the legislature. The mere fact that the Hawaii proportion of assessed valuation and of taxes paid is only a little more than a fifth of the whole does not (or does it?) enter into their calculations. They would have the taxpayers of the rest of the territory furnish them with about four-fifths of their needs for a fair.

The Hilo papers boast of "how well" Hawaii county has done in the loan fund and the school budget bills, meaning that the county gets more than its proportion of appropriations in both of them, in crude words that they are making the other fellows pay for them. Hawaii gets appropriations for hospitals instead of building its own while Maui levies a special county tax for hospitals and sanitarium support. Truly a contrast in the spirit of independence manifested by the two counties!

It would seem that in advance of each session it might be determined how much is to be raised by taxes and how much is to be borrowed. The costs of territorial government could be deducted from the amount to be raised by taxation and the balance pro-rated among the several counties in proportion to the taxes that each county pays. The school monies could be similarly apportioned.

As to loan fund appropriations the amount available under the credit of the territory could be determined and pro-rated according to assessed valuation. No county should be permitted to exceed its just share on that basis but if any county did not use such share the proportion not required should be permitted to accumulate for future years, for the use of that particular county. In such manner there would be instilled into the counties that need it a sense of proportions, a spirit of independence, a just understanding of the public credit and the extravagance that is engendered by the feeling that a county is getting a gift from the rest of the territory to be spent as it wills would give way to something like the care that the businessman exercises in his own affairs and the voter exercises in protecting the integrity of the property in the home county.

In other words, the constituents in the various counties would act like well brought up adults instead of like so many greedy little children.

SUNDAYS AND PLEASURE

Efforts to restrict amusements on Sunday more closely through amendatory legislation relating to Sunday sports have failed in the legislature. So also has a proposal to give the movie houses more leeway on the Sabbath.

On the mainland there have been concerted efforts, and such efforts will be continued at the coming session of congress, to bring about a return to what are usually called "old, blue laws." In some states, too, the anti-cigarette campaign which received such a set-back in the war days has been revived. Probably the proposed closer regulation of Sunday amusements here is a sporadic off-shoot of the mainland agitation. And the advisability of such legislation may well be questioned, especially at this time when so many feel their personal rights are affronted by the prohibition amendment. Persons, otherwise law-abiding, refuse absolutely to be deprived of alcoholic stimulants and are thus accessories after the fact in law breaking or law evading by the manufacturer or seller. Further restrictions on personal liberty at this time cannot do other than fan the flame of antagonism.

It is far and away easier to educate morality than to legislate it. At this time a majority of the people are seeking to enforce abstinence by legislation. A very considerable minority is not yet educated to accept such enforced abstinence, as a result can be seen the crime and disorder that yet has to be cured, the open defiance of the illicit distiller and the bootlegger and the comparative ease with which intoxicants are secured. But if the "puritanical Sunday" be thrust upon them, difficulties of enforcement would be even greater. If the present day observance or non-observance of the Sabbath does not suit the majority, let them educate by example and in the homes and bring about a willingness for a different course of conduct rather than to seek to thrust it down the public throats. Law officials have a task before them to enforce prohibition and it is always well to finish one task before another is undertaken.

Healthy sports, whether on Sunday or week day, are of physical benefit. To turn the young away from them does not mean they would seek the churches by any means. If not engaged in sports they might be doing something far worse. It's an old saw that says you can lead a horse to the water but you cannot make him drink.

UNIVERSITY EXTENSION

For the asking, it is said, Mauiites may bring university extension work to the Island of their home. Of course the asking must come from the proper sources but the belief is expressed that the University of Hawaii will be glad to extend its work to Maui if approached through the proper channels. Recently there were lectures given in Hawaii by representatives from the University of Hawaii and it is understood to be the purpose of the management to extend the influence of the institution throughout all of the Islands of the group, to make all feel it is their university.

Opportunity to secure such an education as a university can offer is given only to a minority of the people. Those who have a university education or fair education not secured in college or university, in a community such as Maui have small opportunity to keep up with study and educational affairs. Through extension work such opportunity is broadened. Subjects of deep interest and great importance can be covered.

It may be argued that a few lectures on a given subject, two or three, would be but superficiality. True, if it stopped there. But if

university extension work is to be carried on in Hawaii nei as in some parts of the mainland, such is not the case. As an outstanding example the University of Wisconsin and Chicago University come to mind. The work does not stop at a lecture or two. Several lectures are supplemented by a correspondence course designed at the university and that in turn by short intensive courses and well suggested reading.

It is also possible that such intensive courses could be held during the summer here on Maui, for it is generally admitted that no where in Hawaii can a superior climate be found. There would be an especial opportunity for teachers who desire to extend their studies during a vacation period.

Securing the privileges to be found through university extension efforts would seem to be a subject that may well be given the attention of the women of Maui. It is said the University, recognizing the inability of numbers to come to it, seeks to come to them, merely awaits a request. May it not be suggested that such requests could not come from a better source than the Woman's Club with such request supplemented by the Chamber of Commerce? It is a subject worthy of some consideration and if undertaken would make life more worth while for those who seek to keep abreast of the times.

CONGRATULATIONS

Both houses of the legislature have passed the County Library Law and since the Governor recommended such an act in his message and his frequently expressed his wish to see such legislation his approval may be taken for granted. It will mean much for Maui, it does already, for it means an early realization of long cherished hopes. And the thanks of the community will be due to Maui Woman's Club for the bill that has passed is practically as drafted for that organization.

And so it is a time for congratulations to be extended to the club. It is a considerable achievement, perhaps the club's greatest thus far. Other subjects it advocates are still pending in the legislature. At home it is making progress in community beautifying and in other directions, an otherwise undesirable way.

And so congratulations are the order of the day not only for the club but for Maui in its possession of such a live, up and at it organization.

The suggestion is made that a solution for the Lahainaluna problem would be to make the school a military academy specializing on vocational training for Hawaiian students, using the Kamehameha schools of Honolulu for a model. Lahainaluna has sent forth some splendid citizenry in the past and some of the one-time students might now give their views on what they believe best for Maui's fine old school on the hill.

Reports from Honolulu forecast the passage of the Foreign Press Bill with amendments which will make it necessary to translate only articles of a certain type or on certain subjects. Such a bill would be better than nothing but still better would be amendments so that the Territory should have its own translations made and hold the offenders to their responsibility. Maui News does not favor punishing the innocent for the sins of the guilty.

Maui legislators say their constituents are slow in accepting the invitation to tell their representatives as to their wishes for legislation. They are willing and ready to use their best endeavors to secure proper legislation that may be desired but are not being kept advised. They would appreciate cooperation and recognize that being away for weeks they cannot be in the closest touch with home affairs.

Hearst's papers are running articles on the Japanese situation in Hawaii and a headline says "Japanese secretly striving to secure industrial control." If such articles shall bring to mainlanders a realization of the necessity of permitting Chinese immigration at least in these Islands it will have effected a most desirable result even if it does so in no other way.

"Like a viper," must be the sentiment of the editor of the Honolulu Advertiser when, while trying to secure fairness for Japanese publications, one of those papers comes out with a scurilous editorial blaming the sugar interests for agitation which it has brought upon itself and its fellows.

Senator Desha's "Bathing Suit Bill" has now been sent to the committee on education of the senate. Quite right, that body is the one to determine how anatomy shall be studied, whether in books or by ocular demonstration.

And now Wela-ka-Hao, the Honolulu Ad Club organ has "done gone" got in Dorch with the American Legion over the Foreign Language Press Bill.

It is approaching the time when Maui should commence to do a little advance planning for the Fair, now only six months away.

On The Other Islands

Judge is Forgiving—Judge E. K. Simmons of Laupahoehoe, accompanied by Representative N. K. Lyman, called upon Governor McCarthy and asked that civil rights be restored to Wilson Nanakualua, who seven years ago blew up the side of Judge Simmons' home at Laupahoehoe, Hawaii.

Hilo Rainfall—The total rainfall in Hilo for the first quarter of 1921, as kept by C. E. K. Martin of the federal weather bureau, Hilo, is 60.28 inches, or an average precipitation of 20.09 inches per month since the first of the year.

Hilo Harbormaster—Captain James Reid was appointed harbormaster for Hilo by action of the board of harbor commissioners.

Hotel to Have Annex—Wm. Henry Rice is acquiring the Arthur Rice premises from Mrs. R. L. Wilcox and will remodel and repair them as an annex to the Lihue Hotel. The hotel business has been steadily growing for years, and has now outrun the present facilities and accommodations, so that it has been difficult to meet the current demands.

Banana Growers Unite—Those interested in banana growing on the Big Island held a preliminary meeting last week and decided to organize. W. A. Anderson of Hawaiian Banana Plantations Ltd., explained the advantages of organization. Investigation has shown there is a sufficient acreage available for banana growing to warrant direct shipments from the Big Island to the mainland.

Kuhio Wharf Sugar—There was loaded aboard steamers at Kuhio wharf last month 13,403 tons of sugar. It was carried on five steamers.

To Dehydrate Bananas—George H. Hughey, secretary of the Hawaiian Banana Plantations, Limited, announces that a banana dehydration plant, to take care of the surplus banana fruit grown in Hawaii is under consideration. He says it has the endorsement of the legislature, and urges the Japanese banana growers to extend their business in cooperation with his plant.

Kicks at Army—The Mutual Telephone Company complained to the public utilities commission that the company had been "unjustly deprived" of hundreds, perhaps thousands, of dollars, through alleged violation of the army's contract for phone service by using army and navy lines for long distance calls, in connection with company lines.

More Land For Hotel—Property owned by Mollie E. Hustace, adjoining the Moana hotel has been sold to the Territorial Hotel Co., Ltd., for a consideration of \$100,000. It is expected that the company will use the property for hotel purposes. The company has had the property under lease since 1916, with an option to purchase.

Horner Wins Out—Representative Norman K. Lyman's rider to the general appropriation bill, requiring that the territorial sugar expert shall devote all his time to the duties of his office, has been killed by the senate ways and means committee, it was learned, from Senator Charles A. Rice chairman.

Murder Shocks Kauai—One of the most brutal and cold blooded murders ever known on Kauai is reported in the Garden Island. A 13 year old Japanese girl was waylaid on her way to school and stabbed by a Japanese man who is reported to have said that he killed the child because of a grudge he entertained against her father.

Advertiser Changes Name—Under the new name of Honolulu Advertiser instead of Pacific Commercial Advertiser, Honolulu's morning newspaper made its appearance last Thursday. With the new title also appears a new "dress" or make up of its news columns, especially the front page of the first section.

Killed in Wreck—William Akana, former Kamehameha scholar and prominent athlete, recently head time keeper at Kilauea plantation, Kauai, was killed in an auto wreck near his home last week.

Lihue Issues Bonds—Ten years, 7 percent collateral notes are being offered for Lihue Plantation Company by Hawaiian Trust Company. The purpose of the issue is to furnish funds for capital expenditures incurred and projected, including the Ahukini project.

Honolulu is Loser—Because of the housing shortage in Honolulu the placing of eight additional mine sweepers at Pearl Harbor has been postponed under naval orders. The mine sweepers would have had with them between 500 and 600 officers and men.

Beer and Light Wine In Territory Sought

Under prohibition drunkenness and debauchery have increased in the Hawaiian Islands is an assertion made by Representative Evan da Silva of the Big Island in a resolution which he has introduced in an effort to secure federal legislation to permit the making and selling of beer and light wines in the territory.

The resolution reads as follows: "Whereas, the enforcement of the so-called Sheppard act and Volstead act has worked untold hardship upon the people of Hawaii; and "Whereas, under the enforcement of the provisions of these acts drunken-

ness and debauchery have greatly increased in the Territory of Hawaii; and

"Whereas, the people of Hawaii had no chance to express their views as to whether there should or should not be national prohibition;

"Now therefore, be it resolved by the house of representatives, the senate concurring, that the congress of the United States be petitioned to so amend existing laws that beer containing 4 1/2 percent alcohol and light wine containing 15 percent alcohol, may be manufactured and sold within the Territory of Hawaii.

"And be it further resolved, that copies of this resolution be sent to the president of the senate of the congress of the United States, the speaker of the house of representatives of the United States, and the delegate to congress from Hawaii."

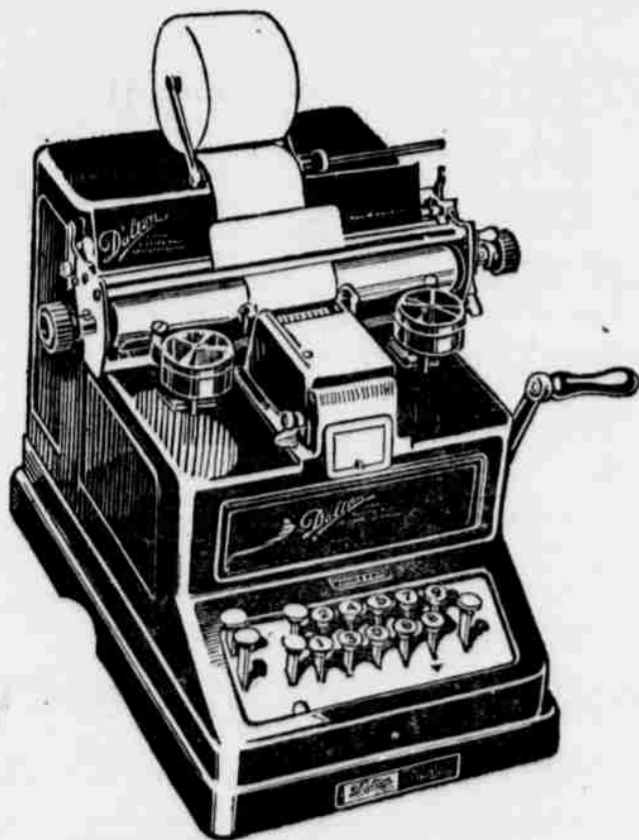

MAUI TWENTY YEARS AGO

(From Maui News of April 6, 1901.)

Mates, second and third mates of the steamers of the Inter-Island and Wilder companies are dissatisfied with their pay and have gone on strike.

The dispensary bill met its knock out on Wednesday. On Maui the opposition was not so much that the people object to restriction in the use of intoxicants as that they are opposed to coercive sumptuary legislation.

Wednesday will see the opening of Maui's new hotel in Wailuku. The rooms are elegantly furnished and the culinary department is well organized. No formality will attend the opening.

If there is to be racing this summer the Maui Racing Association would do well to take steps now to put the track in repair. The surrounding fences are down in several places and cattle and horses are roaming over the property tramping it out of any semblance to a track. It would cost but little to repair the fences and the track should be leveled and gone over with a road roller.

The new Maui Drug store at High and Main streets, Wailuku, will be opened for business next week with a large supply of fresh drugs and an experienced pharmacist in charge of the prescription department.

The new Settlement Building which will be known as Alexander Hall in honor of Father Alexander, the pioneer missionary of Wailuku, was opened Monday. The kindergarten is in charge of Miss Huntington, assisted by Miss Elizabeth Rogers and 30 tots are in attendance. Mr. and Mrs. Brown will have charge of the reading and play rooms, the former being equipped with a good supply of the latest books and serial fiction.

It has been suggested that an additional night police force is needed in Kahului to corral the drunken sailors who make the nights hideous down there from time to time.

The suit between the Wailuku and Spreckelsville plantations was heard in Honolulu on Wednesday and Wailuku won the first round on the question of the dumping of debris. The next question to be decided is whether the kuleanas on both sides of the stream admit of konohikis between them.

According to Washington specials to the New York Tribune has declined to enter a protest against the seizure of Manchuria by Russia, although approached by the other powers in reference thereto and warned that the consumation of the plan will mean the dismemberment of the Chinese Empire.
