

## ROOSEVELT-CARTER COMBINATION BROKEN

### SUCH AT LEAST CLAIMED

THE DETERMINATION OF ROOSEVELT AND MOODY TO INVESTIGATE THE JUDGE ROBINSON SUCCESSION MATTER IS CLAIMED BY SOME TO HAVE ENDED THE COMBINATION—BRECKONS MAY MAKE THE INVESTIGATION.

The general topic of discussion among all classes in Honolulu today is the matter of the appointment of a third circuit judge and the investigation which President Roosevelt and Attorney General Moody are supposed to be about to undertake. It is thought by some that District Attorney Breckons will be instructed to make the investigation while others are of the opinion that a man will be sent here from the Department of Justice, to investigate and report. A still further possibility is that the documentary evidence now on file in Washington will be considered sufficient.

### HAWAII STUDENTS AT STANFORD

MARY ROSALIE STOLZ BORN ON KAUALI WINS PHI BETA KAPPA. WAITING LIST FOR WOMEN.

(Special Correspondence.) STANFORD UNIVERSITY, Jan. 12, 1906.—The second semester of the present college year opened on January 9th with a registration of 1408 students. Only two changes of any importance have been announced. Professor James of Harvard is here to give a course in philosophy and by this re-establish the Stanford philosophy department. A new system of admission for women has been forced upon the registrar's office by the fact that the number of women students has reached the limit of 500 set by the founders. It consists of the establishment of a waiting list and the requirement that in the future all women who desire admission to the university must make application ten months in advance.

Most of the Hawaiian students who were here last semester are back again. Some of these have established scholarship records that are to be envied. One such is Miss Mary Rosalie Stolz, now a resident of California but born on Kauai where she also spent her childhood, who graduated at Christmas and was one of five elected to Phi Beta Kappa, the well known American scholarship society.

The Hawaiian students are pretty well distributed among the various departments as the following summary will show: law, A. Larnach, T. E. Robinson, H. I. Cruzan, W. G. Galbraith, E. N. Smith and F. Schneck; Latin, Miss E. R. Penrose of Hilo; Electrical Engineering, F. Maloane; English, Miss L. Wells of Lahaina, and the Misses E. Peterson and N. Craig; history Miss S. D. Halsey; civil engineering H. Pratt; geology and mining, C. Peterson; and A. A. Hottendorf, registered as a special student.

## Four Brazilian Rear Admirals Are Killed

(Associated Press Cable to The Star).

RIO DE JANEIRO, January 22.—The Brazilian turret warship Aquadaban has been sunk through an explosion in her powder magazine. Three hundred of her crew, and four rear admirals and the minister of marine who were aboard, perished.

PRESIDENT MAKES IMPORTANT NOMINATIONS. WASHINGTON, D. C., January 22.—The following nominations were sent to the Senate today by President Roosevelt: For ambassador to Japan, Luke E. Wright; for ambassador to Brazil, L. E. Griscom; for ambassador to Mexico, D. E. Thompson; for governor of the Philippines, H. C. Ide and for vice governor of the Philippines, General J. F. Smith.

REJECTED LOVER DOES POUL MURDERS. BOISE CITY, Idaho, January 22.—Henry Neuhanner today killed Oille Powell who had rejected him for Lafayette Gray. Neuhanner then killed his successful rival and the latter's mother and sister and then committed suicide.

FRENCH INFLECT HEAVY LOSS ON CHINESE. MARSEILLES, January 21.—News of a severe defeat of Chinese regulars by the French forces in Tonquin, has been received. Three hundred Chinese were killed and 300 wounded. The French losses aggregated 26.

## HANDING IT OUT TO THE GOVERNOR

PROMINENT ATTORNEYS EXPRESS THEIR VIEWS ON THE SUGGESTED INVESTIGATION OF THE ROBINSON JUDGESHIP CASE—WHAT AND WHO IS OR ARE TO BE INVESTIGATED IS ASKED—CARTER COMES IN FOR A FEW LEFT-HANDED COMPLIMENTS.

All along the line today the discussion of matters in general led to the question of the investigation which has been promised from Washington into the re-appointment of Judge Robinson to the circuit bench. Up at the Judiciary building there was a sort of a broad grin all over the place when a couple of attorneys chanced to meet and the general tenor of the conversation was to the effect that an investigation could only result in a complete exoneration of Judge Robinson—with all of the after—results which that implies. A. G. M. Robertson, president of the Bar Association, was guarded in his remarks. "The despatch from Washington, as published, says that 'Moody and Roosevelt have decided to investigate,'" he said. "The question is, what does that mean? Investigate whom? Investigate what? Does it mean that there will be a hearing of both sides of the controversy at the other end of the line or will there be an investigation into the facts here. W. O. Smith is now in Washington and he has all of the facts at command so that his views may possibly be consulted. I personally am in the heartiest accord with the action that was taken by the Bar Association in supporting Judge Robinson. As Republican National Committeeman, too, I have written to President Roosevelt at length respecting the whole affair and I have sent to him as well as to Senator Perkins affidavits of all who were present in Judge Robinson's chamber on the night over which the trouble arose. I have also sent the statements of the jurors in the case that was then under trial. Still the question to my mind is as to what is to be investigated."

Following this it was learned from another source that Governor Carter had not sent forward any formal charges, but there he had committed his views to a private letter to the President. It is understood that if this should be the case, Judge Robinson's friends in Washington will not present any affidavits until formal charges are filed.

S. M. Ballou who has just returned from Washington, and who is one of Governor Carter's counsel, had nothing to say. "I cannot really add anything to what has been said," he remarked blandly. "You see I was away when the occurrences spoken of took place—that is if anything did take place. I know nothing about it, you see."

## EFFECT OF ERRORS DURING A TRIAL

SUPREME COURT DECIDES THE CASE OF THE KAPIOLANI ESTATE AGAINST L. A. THURSTON IN FAVOR OF THE PLAINTIFF—ERRONEOUS RULINGS ON EVIDENCE HELD TO HAVE NOT AFFECTED JURYS' VERDICT.

The Supreme Court laid down some rules as to admissions of evidence, in a decision given this morning in the case of the Kapiolani estate against L. A. Thurston, an ejectment suit which had its second decision in the court today. The verdict in the circuit court was for plaintiff as in a former trial which the Supreme court set aside. This time the verdict is sustained, in spite of errors by the trial judge in the admission of evidence, and in a decision by Justice Hartwell the court discusses the question of how an erroneous ruling should be considered on appeal. The court after finding that certain evidence was wrongfully allowed to go to the jury, says:

The conclusions of an ecclesiastical tribunal. The case has had two trials with the same result, although the exclusion was not shown at the former trial. The judge who tried the case had time after the verdict to reconsider his ruling and in denying a new trial probably thought that the verdict was right. A trial judge properly refuses a new trial for admission of irrelevant testimony if he thinks that upon the other evidence the verdict was right and probably not influenced by the objectionable testimony, as in granting a new trial he is apt to regard the verdict as wrong."

W. A. Kinney and S. H. Derby appeared for plaintiff and D. L. Withington for defendant.

## FOREIGN NEWS BY CABLE

SAVE THE CONSTITUTION.  
WASHINGTON, January 21.—A petition of protest against the destruction of the old frigate Constitution, signed by thirty thousand residents of the State of Massachusetts, has been presented to President Roosevelt. The President has suggested that the old vessel be rebuilt and sent to Annapolis.

DOESN'T LAST LONG.  
QUAYAQUIL, Ecuador, January 21.—Moreno's government lasted just one hour. Rioting followed his assumption of power, and many people were killed. Then the people rejected Moreno, and proclaimed General Alfaro, leader of the revolution, president. Order has now been restored.

Yesterday's cable stated that the revolutionary army in Ecuador had entered Quito, and that Vice-President Moreno had assumed the reins of government and named his Cabinet.

RUSSIAN EDITOR GETS ONE YEAR.  
ST. PETERSBURG, January 21.—The editor of Russ has been sentenced to one year in prison for the publication in December of the manifesto of the Workmen's Council. The sentence has caused a radical moderation in the utterances of the newspapers.

BANNERMAN TO CONTROL.  
LONDON, January 21.—It is predicted that Bannerman will control 533 votes in Parliament, against 137 for the Conservatives.

GARRISONING VENEZUELA PORTS.  
WILLEMSTAD, January 21.—Venezuela is garrisoning her ports. The people are indifferent to the rupture with France.

FRANCE AND VENEZUELA.  
WASHINGTON, January 22.—France will be given a free hand in Venezuela.

FRANCE AWAITS REPORT.  
PARIS, January 22.—The Government will not take action in Venezuela before receiving M. Taigny's report.

QUIET SOCIALIST MEETINGS.  
BERLIN, January 22.—Contrary to expectations, the Socialist meetings on Sunday were unattended with disorders.

ALSO QUIET IN RUSSIA.  
ST. PETERSBURG, January 22.—Yesterday passed in quietness.

CALAMITY IN CHURCH.  
PHILADELPHIA, January 22.—A fire caused a panic in a colored Baptist church here yesterday. Eighteen persons were killed and forty injured.

JAPANESE LIKE WRIGHT.  
TOKIO, January 22.—The appointment of Gen. Luke Wright, retiring Governor of the Philippines, as Ambassador to Japan, is well received.

WARM WINTER WEATHER.  
WASHINGTON, January 22.—An unprecedentedly warm wave for this season prevails from the Mississippi to the Atlantic.

FROM SALT LAKE.  
Miss Schweitzer is expecting in the near future Miss Young of Salt Lake City, Utah, daughter of Major and Mrs. R. W. Young. The young lady will remain here several months. Her father, Major Young, was in command of the Utah batteries during the Spanish War and he was afterwards a judge on the Philippine Supreme Court.

Non-Secretive Washington

A striking contrast is presented by the action at Washington and the action here, in the matter of a recommendation of a circuit judge. Governor Carter, surrounding his actions with such secrecy that his closest associates did not know what he was doing, sent a name to the President. Even after it was sent no one here could get even a hint of who the man was.

The news from Washington ends the "one-man responsibility" proposition, whatever may be the final result of the Robinson investigation. The notion that President Roosevelt stood ready to act as Carter told him in Hawaiian affairs is dead. It can no longer be said that Carter's word is final as to appointment,—the President has accepted his duty of looking into such matters for himself and if Carter has failed to give a square deal, as a unanimous community thinks he has, the President will do it himself.

The single local defender of the governor's extraordinary action in the Robinson matter who has expressed any views, has for an argument that Carter should be sustained simply that if he is not he will resign,—in other words an injustice to Judge Robinson is to be allowed because correcting it will cause a change in governors. Of course this argument will not appeal to the President at all.

Russia And Japan

The appointment of Governor Luke Wright to be the Ambassador of the United States to Japan, and the appointment by Great Britain and other European Powers of Ambassadors instead of Ministers, is one of the fruits of the war with Russia. It is very flattering to Japan, for it is an acknowledgment by the other powers that she is now a first-class nation.

Russia alone of all the important powers has as yet not determined to pay this compliment to Japan. That she has not, is regarded in Europe as very bad diplomacy. It is a subject of considerable discussion in influential journals in Europe. But Japan it would seem, according to the London Daily Telegraph has found means to give diplomatic rebuff to Russia for her churlish action in the matter. It is indeed considered that the consideration of Russia's future attitude toward Japan as affected and symbolized by diplomatic relations is one of the important things the Russian cabinet has to consider. Shall Russia send an Ambassador to Tokio, or only a Minister-Plenipotentiary as heretofore? When Count Witte was in Portsmouth he had several conversations with Baron Komura and Mr. Takahira respecting the future relations of the two countries, and the accredited representatives who should maintain them. The Japanese plenipotentiary then expressed the Mikado's wish to despatch a representative of Ambassadorial rank to St. Petersburg, and to have a Russian diplomatist of like rank in Tokio. Count Witte, who desires to see cordial relations speedily established between the recent foes, telegraphed home communicating the Mikado's wish, and setting forth the desirability of casting around for a suitable diplomatist. But in St. Petersburg the matter was regarded from a different point of view, and no wish was cherished to comply with Japan's desire. Russia would continue to be represented by a mere Minister, not by an Ambassador, and the person selected for the purpose, owing to his knowledge of English, and to other considerations, some of which may seem extrinsic, was M. Bekhmetieff, now Minister in Sofia.

M. Bekhmetieff accordingly quitted Bulgaria and repaired to the capital of Russia, where he remained several days without any practical result; for Russia, having allowed it to be known through the intermediary of French diplomacy that she insists on being represented in Tokyo by a mere Minister, and refuses to appoint an Ambassador, was courteously informed through the same channels that Japan would prefer, for the time being, to send a mere Charge d'Affaires to St. Petersburg, and have a Russian representative of like rank in Tokyo. Owing to the Czar's unexpected decision M. Bekhmetieff, who hoped to have his status definitely decided and his appointment confirmed, left St. Petersburg without receiving any definite answer.

Thus, says a correspondent of the London Daily Telegraph, the matter is still in abeyance. The Minister-President, however, together with Count Lamsdorff, will doubtless solve the difficulty satisfactorily as soon as he can attend to it, for he must be well aware that the appointment of simple Charges d'Affaires would at the very outset of the peaceful era give an adverse turn to all the future relations between the two countries, and in view of the number and importance of the outstanding questions left open by the Peace Treaty might easily give rise to conflicts of a serious nature. For that reason, therefore, however, reluctant Russia may be to lead the way in recognizing the new status of Japan, there is great hope that minor considerations of this nature will eventually and speedily be sacrificed to the vast national and international interests which can best be served by the establishment and maintenance of good and neighborly intercourse between the two great peoples. If this conjecture, for which I have no official grounds whatever, should prove correct, Russia's first Ambassador to Japan would still be M. Bekhmetieff, who has spent more than the average number of years in the capital of Bulgaria.

A Fettered Succession

Chicago University although nominally a denominational institution, has always been looked on as being as little denominational as it is possible for an institution to be, and yet be classed as one. When it was established there was a good deal of talk about the merely nominal character of the bonds that bound it to the Baptist church. Indeed at the time there was a strong element of the Baptist communion which proposed to repudiate the claim of its founders that it was a Baptist institution. There was at the time and has been since little rallying of the denomination as a whole to the support of the institution. The institution, however, has not lacked support.

About the only features of the institution that marked it as a Baptist University was a provision in the character that a certain proportion of the trustees should be Baptists, and that the president of the institution should be a Baptist in good standing. This provision is at this juncture likely to interfere with that freedom of selection of a successor to President Harper which the trustees would like to have. It cuts out of consideration altogether, President Roosevelt, whose name was prominently mentioned in connection with the succession. Jacob Gould Schurman, President of Cornell University, is another

# KONA STORM IS NOW AT AN END

ROUGH WEATHER BEGAN SATURDAY TO SUBSIDE AND ONLY GENTLE WIND WAS PREVAILING THIS MORNING—ISLAND STEAMERS WILL MAKE THEIR USUAL RUNS THIS WEEK—BOAT UPSET AT MAHUKONA.

The Kona storm is ended. On Saturday night the wind began to moderate and changed to the westward and today there has been scarcely any wind at all and what wind there was was from the northwest this morning. The island captains think that the worst of the storm has passed, although the horizon to the south and west looked gray and murky. It is probable that considerable of a swell will be running at the various island ports for some days to come and the boats may not be able to make all of their landings as there will be some risk of upsetting the boats. The steamers are scheduled to start on their usual runs this week.

The various island boats arrived here Saturday, yesterday and today from island ports all with reports of very rough weather and gales in the various channels. The Likelike arrived Saturday evening from Lanai, Maui and Molokai ports. She was unable to land at Kalaupapa and other Molokai ports but stopped at Halawa, Puukoa and Kaunakakai and brought passengers from the latter port.

The steamer Kaula and W. G. Hall arrived Sunday morning from Kaula ports. Both had full cargoes of sugar. Rough weather about Kaula is reported. The steamer Maui arrived this morning from Kawaihine and Mahukona with 77 head of cattle and a small quantity of sugar. The vessel captured a boat while trying to send some cement ashore at Mahukona last week. Very rough weather about Hawaii and the channels is reported. The weather has moderated to such an extent that the S. S. Alaskan will probably be dispatched to Kahului this afternoon to take sugar. The bark Gerard C. Tobey is loading sugar. She will be inspected by the Federal inspectors of hulls while in Honolulu. Captain Scott expects to get away for San Francisco on Thursday with a full load of sugar. The ship Engelhorn has finished loading 1,265 tons of ballast and is awaiting orders. She may go back to the Colonies for a charter or else may go to the mainland. The bark Dumfrieshire will sail Wednesday for Eureka for a lumber charter to Callao. The steamers W. G. Hall and Kaula are discharging their Kaula sugar into the ship Erskine M. Phelps.

## ROOSEVELT-CARTER COMBINATION BROKEN

(Continued from page one.)

Attorneys are very generally of the opinion that Judge Robinson will secure a reappointment now. Last week few could be found who thought he had any chance. The news that there is to be an investigation at Washington has turned them nearly all the other way, and they are practically a unit in declaring that the judge is bound to be sustained.

Judge Robinson said this morning that an error had been made in quoting him on the subject of the investigation, in the Advertiser yesterday morning. "It was a telephone interview, and I must have been misunderstood," he said. "I was made to say that I admitted having been guilty of an indiscretion, but that it should not wipe out four years' good record. What I intended to say was that even if it should be conceded that I was guilty of an indiscretion,—which I do not at all concede,—such an indiscretion should not wipe out the record of four years."

"I have not heard any further news and do not know what course matters will take."

The judge's term expires tomorrow and there will be an interim with only two circuit judges here. The criminal calendar will be turned over to Judge Lindsay, while Judge De Bolt will keep on with the civil calendar. Considerable discussion is on among attorneys as to the political ethics involved in Anderson's acceptance of a recommendation as against Robinson after he had attended a meeting of the Bar Association and voted to endorse Robinson. The acceptance, it is said, was on the theory that Robinson's chances were ended. On a former occasion Anderson declined a recommendation, because the Bar had endorsed Robinson and Carter proceeded to endorse Robinson. Carter's withdrawal of this endorsement, it is stated, was regarded as settling Judge Robinson, hence Anderson was left free to take a recommendation himself. He did not attend the meeting of the Bar last Saturday.

District Attorney Breckons may be disqualified to act as investigator by reason of his having expressed himself and voted on Robinson's endorsement. Breckons has been a supporter of the judge from the first, and he voted to re-endorse him at the meeting last Saturday. It was Breckons, in fact who called for a rising vote. It is not at all unlikely, however, that he will be called upon to investigate and report.

Another feature of the proposition considerably discussed is that the action at Washington marks the end of the Carter-Roosevelt combination. The President has apparently withdrawn from the agreement so long maintained, to take Carter's word as final in the matter of Hawaiian appointments, and even if he should finally follow Carter's advice now, enough has happened to show that the combination is broken. This is a natural cause of jubilation among the governor's political opponents. The other faction of the local Republican party may have a chance to be heard.

There is a quite general impression that the governor will resign his office if opposed by Roosevelt. It is understood that one of the conditions on which he took the office was that he should have full sway as to appointments, and Roosevelt has shown the utmost confidence up to this time. In fact, it is stated by some, there is more reason for a resignation as matters already stand, than there was last June, when Carter offered to withdraw from the office.

Governor Carter returned to his office this morning from Haleiwa, making the trip with Mrs. Carter, in his new automobile. It is a very fine machine and made the trip in two hours and five minutes. The governor appeared in excellent health and spirits and said the trip had been a fine one.

and the plantation people is the interpretation of the contracts between them. The contract men appear to have the principal grievance. Chillingworth was empowered to present to Manager Bull of the plantation the various terms that the strikers demand. Chillingworth had not seen Bull this morning but spoke to Assistant Manager Worthington who seemed to think that the terms were not unduly severe and that an amicable agreement could be reached. Chillingworth left this afternoon for Waipahu to confer with Bull regarding the matter.

There was the utmost good feeling manifested at the close of the conference of the Japanese early this morning and the Japanese appeared then to be desirous of having the disagreements settled so that they could return to work. One important feature of their demands is that they receive the same money that Japanese on other plantations receive and that a complete interpretation of the terms of the contract be had so that no further misunderstanding can arise.

## STORM DESTROYED HOUSES AT KOOLAU

TWO DWELLINGS BLOWN DOWN AND ROOFS OF OTHER STRUCTURES BLOWN OFF.

Considerable damage has been done on the northern side of the island by the severe Kona storm that raged last week. While the Koolau side of the island is naturally sheltered, still it did not escape the fury of the southerly wind. The wind swept down the valleys on the Koolau side every day and night that the storm raged on the southern side of the island and on Thursday did more damage than has been reported on this side of the island during the entire storm.

Kaalea and Waialeale were the places that suffered the most. The roofs of two houses were blown off by the wind and two more houses were blown down. Natives and Chinese occupied the various dwellings. Fortunately no one was hurt by the collapse of the buildings. There were no freshets during the storm.

## CHANGES IN THE HILO POLICE

THE FORCE IS REDUCED FOR THE SAKE OF ECONOMY—THE OFFICERS RETAINED.

HILO, January 18.—There were several unexpected changes in the personnel of the police force last Tuesday and now there are not so many guardians of the peace as formerly. It will be remembered that by a resolution introduced by Supervisor Desha, the number and pay of police was to be changed on the 15th instant. By that resolution the number of captains was reduced and the hack officer, a place recently created, was to be discontinued.

The changes were to affect all of the districts and on Tuesday there were policemen from different parts of the island around the sheriff's office. That official announced during the day that the following would act as policemen until further notice in South Hilo.

Captain, Henry W. Martin; Lieutenants, J. Kaaliau and Simeona Kahana; Japanese policeman, Yotaro; Chinese policeman Keawchoku; Mounted patrol Harry Knell.—Hawaii Herald

## A SANITARY COMMISSION

SECRETARY ATKINSON'S RECOMMENDATION TO THE PRESIDENT IS BEING ACTED UPON.

Advices has been received from Washington to the effect that a sanitary commission is to be appointed to investigate conditions here and to recommend sanitary improvements. The appointment of such a commission is in line with a recommendation made to the President by A. L. C. Atkinson as acting governor.

The Commission is to be composed of one army officer, one Marine Hospital Service officer and one other, presumably a local medical officer, who will be selected by the Governor. The first officer from the army will be First Lieutenant J. R. Slattery, Corps of Engineers, U.S.A., on duty in this department. The Marine Hospital Service representative will be undoubtedly be selected by Dr. L. E. Cofer, and it is likely that Dr. Cofer will serve.

## SUGAR ON HAWAII.

## THE WRECK OF THE MARTHA DAVIS

Diver Terrill, who has been here for the past three weeks working on the submerged hulk of the wrecked Martha Davis, says the condition of the water is such that he cannot tell just what is left of the cargo. He discovered something in sacks which, when held close to his helmet, resembles an oil meal but he has not brought any of it to the surface and cannot tell what it is. There is a quantity of barley remaining in the hold. The idea of the diver is to use a centrifugal pump and get out whatever is in her and so far it has been impossible to get a pump of that sort here and the Lehua came up without one. He says he located the mainmast by feeling his way and has put his lines out so he can find it at any time but with a diminution of rain the water will clear up and there will be fewer obstacles in the way of progress.—Hawaii Herald.

## MAY MAKE JAP BOATS TURBINES

REPORTED THAT TOYO KISEN KAISHA MAY HAVE LINERS MADE INTO OIL BURNERS.

It is not by any means unlikely that a Japanese company, the Toyo Kisen Kaisha, will be the pioneer company to introduce the turbine and oil burning steamer on the Oriental run. The company has two large vessels being built near Nagasaki for the San Francisco run. These boats are to be first class and up to date in every possible respect.

According to news by the Mongolia the company is considering the advisability of making them turbine powered and equipping them with oil as fuel. Whether the Japanese government would allow such a thing to be done on the new boats is uncertain. The vessels will be subsidized by the government for possible use as war ships or transports but whether the officials will agree to give a subsidy for the new style of boat is uncertain. Should the government refuse a subsidy for turbine oil burners, it is not likely that the company would so equip them.

## HANDING IT TO THE GOVERNOR

(Continued from page one.)

"Well, perhaps, it would not be best to quote me. People might think that I was sore over the treatment accorded me by the Governor. Just cut me out," J. Alfred Magoon was quite unequivocal in his statement of his views. "It seems to me," he said, "that the Bar was most moderate in its handling of the case. The resolution passed was of the most temperate character, for it seems to me that Governor Carter was deserving of the most severe censure. Perhaps the moderate tone was the best, however, and the Association therefore acted wisely. I am heartily in favor of any investigation which will bring the facts to light, and I am also heartily for Judge Robinson."

Judge A. S. Humphreys had a word to say about Governor Carter.

"I never heard of a man in such a position as governor of a state or territory who would use his official position to advertise his business until I heard of Carter," he said. "He has been connected with a certain trust company and there on the letter paper his name appears as one of the officers, not as plain 'G. R. Carter' but as 'Governor Carter'! Then again, when it comes to an appointment to the bench, in the place of a man who has the unanimous endorsement of the Bar, who does he select? He sends on the name of a clerk in the office of the attorneys for the very trust company with which he has been connected. A very gentlemanly young clerk, to be sure, but a young man who has never tried a case in his life and who is utterly lacking in the experience necessary for a seat on the bench. What possible construction can be placed on the Governor's action in such circumstances? I trust that there will be an investigation and I trust that the investigation will reach as far as Governor Carter."

C. W. Ashford struck a chord in a minor key. "Of course I am glad to see any sort

of an investigation," he remarked, "and I am heartily for Judge Robinson, but what's the use? George is Rex and that's about all there is to it. I'm afraid that our old friend President Roosevelt has tied up to him."

"It looks pretty good to me," said thoughtful S. H. Derby. "There's a break in the clouds and a thorough investigation is what we are looking for."

E. B. McClanahan clothed himself in gloom when he was approached. "My attitude in the matter is that it should never have been brought up at all," he said, "and I did not go to the Bar Association for that very reason. It seems to me that the whole affair is very unfortunate and that there should be any investigation at all. What are the matters to be investigated anyway? I know of no facts nor have I heard of any specific charges made against anybody."

U. S. District Attorney R. W. Breckons had nothing to say. "I think that my endorsement of the Bar Association's resolutions will show where I stand," he remarked. "I hope to have nothing to do with the case, but I am holding myself open to any directions which may come from my superior officer, the Attorney General of the United States. I do not see how my participation in the Bar Association meeting would interfere with my gathering the facts if I were appointed or directed to do so."

The smile that spread over the classic features of Frank Thompson when he was asked his opinion as to an investigation of the Robinson case was alone worth the price of admission. "What's the use of saying anything?" he asked. "A full investigation will settle the matter for good. I may have something to say when the investigators get busy."

Gigantic Uprising of Chinese Being Organized

NEWS OF VERY DISQUIETING NATURE REGARDING CONDITION IN CHINA BROUGHT BY S. S. MONGOLIA YESTERDAY—DESPERATE EFFORTS TO EXPEL THE FOREIGN INFLUENCE CERTAIN TO BE ATTEMPTED VERY SOON IN NORTHERN PROVINCES.

News of a very sensational nature regarding conditions in China was received by the S. S. Mongolia. According to officers and passengers on that vessel another uprising of the Chinese against the foreign devils, an uprising that will exceed in character and energy the Boxer trouble of 1900, is likely to be started this summer or the following year. Practically every newspaper correspondent in China, says that such a condition is certain to occur and that when the storm does break it will be with a fury that will make the Boxer uprising seem as a mild rise of the tide compared to a tidal wave. The center of the impending uprising is in the northern section of China where the stronger breed of Chinese live. The men in that section of the Chinese Empire are a far different character of people from those who live in the southern provinces. The viceroys of several of the provinces are said to have from 100,000 to 200,000 men under arms. The Chinese have been drilled for some years past by German officers, principally, and are said to be fairly well organized, and up to a fairly efficient military standard. When the heads of the movement think that they have reached the point when the outbreak to expel the foreigners can be effective, the signal will be given and then will burst forth a terrible storm of rapine and murder and massacre. Some of the foreigners who have studied the situation think that the trouble will occur this summer, others think that the uprising will not occur so soon, but all are unanimous in declaring that the rising is inevitable and inevitable within a comparatively short time. Months and months even years may be required to subdue the uprising. The recent uprising in Shanghai against the foreigners was but a straw that shows this anti-foreign sentiment in China is blowing. That uprising which was primarily started against the British, had the backing and secret support of some very prominent and influential Chinese in Shanghai. Had it not been for the prompt action of the naval forces in landing 2,000 marines within a short time, the mob would have gained possession of the streets of the city and the uprising would have become extended and very serious. It is stated that the foreign forces did not start to shoot soon enough. Efforts were first made to quell the mob by clubbing them, but this simply served to incense the mob and the result was that the marines had to fire on the mob. About 65 Chinese rioters were killed, before the mob was dispersed. The key note of the impending uprising is found in the effect that the news of the Japanese victory over Russia has had upon the Japanese. The Chinese have from time immemorial considered themselves superior to the Japanese. In fact the emblem on the Chinese flag of the dragon swallowing the red ball is emblematic of the Chinese dragon swallowing the Japanese sun and was adopted after the Chinese had defeated the Japanese many years ago. Ever since the Chinese have heard that the Japanese have crushed the Russian power in the Far East the Chinese and especially the elder ones who have the old traditions, have been asking themselves that if the Japanese were able to defeat the Russians with such ease the Chinese immeasurably the superiors of the Japanese can certainly beat the white races. The hatred of the white races and foreign influence in China will be the passion that will arouse the Chinese into action. Thousands upon thousands of young Chinese are away in Japan and other foreign countries studying the methods of and ideas of civilization and they will exert their influence to arouse the national spirit. There are many Japanese living in China and it is said that their influence in against foreign influence.

### ALAMEDA DETAINED BY BAD WEATHER

VESSEL WAITED NEARLY A DAY AT SAN FRANCISCO BEFORE DEPARTING.

Nearly 51 hours late the S. S. Alameda arrived yesterday forenoon from San Francisco. She experienced one of the roughest trips in her career. The vessel left the Oceanic wharf at San Francisco on Saturday a week ago, but went to an anchor until Sunday morning as the sea was breaking across the bar. She did not get under way until Sunday morning. She ran into a southwest gale that kept with her until she made Oahu. The vessel was expected here Saturday but the storm kept her back over a day. Few of the passengers were able to appear at the table, as most of them were ill. Some of the officers of the vessel, even, were sick. No damage was done the vessel by the seas, although the waves swept over her at times. She brought 1,350 tons of freight for this port and had 130 sacks of mail.

Among the passengers were Mrs. Leopold Quayle, wife of the chief officer of the city of Sydney who is here for a visit; H. L. Rose, a surgeon, who goes to the Parker ranch; Evelyn Bendal, sister of young Bendal whose hand was torn off in an accident aboard the dredger Pacific recently, and who is now in the hospital. Thomas Craigie is clerk to Messrs. Bolles and Bulger, Federal Inspectors of Hulls and Boilers, who arrived to inspect local vessels; Captain H. M. Merriam, Artillery Corps, U. S. A., came here to join Mrs. Merriam and children his wife being formerly Miss Alice Lishman of Honolulu; W. Mills, Jr., is the representative of a North of Ireland linen house; Mrs. Waldeyer is the wife of the Maui civil engineer; W. M. Griffin, a prominent man of San Francisco, accompanied by Mrs. Griffin, will remain here a few weeks.

DEPORTATION SIDETRACKED.

Li Wah Ng Shi and Gi Yok the Chinese who were taken from the S. S. Coptic last week on cable instructions from the immigration department were sent back to San Francisco by the S. S. Mongolia on Saturday. It appears that the three men were to have been deported from San Francisco but U. S. Judge De Haven agreed to grant them an extension. Immigration Inspector Mehan for some reason, rushed the chinks aboard the S. S. Coptic and tried to railroad them to China. General Sargeant was communicated with and the result was that the Chinese were taken from the Coptic at Honolulu and sent back for a further hearing of their cases.

SEE AMERICA FIRST.

A letter has been received by Secretary Wood of the Promotion Committee asking him to be in Salt Lake on January 23, two days in advance of the opening of the "Seeing America" conference. The letter gives a list of leaders in the work who are invited to the preliminary meeting, which includes men from all parts of the country. The Commercial Club of Salt Lake has said that it would present a plan of procedure for the conference, which originated with that body, but the letter to Secretary Wood says that the work has now taken so wide a scope that it is desired to have advice from all who are interested in the movement. Hence the desire for a preliminary conference.

During the height of the late kona the waves dashed entirely over the Waikiki road at the entrance to Kapiolani park.

The Hawaiian Relief Society will meet on Tuesday morning at 10 o'clock at the residence of Mrs. Samuel Allen, Alakea street.

The postponed annual meeting of the Hawaiian Historical society will be held on Monday evening, January 22, at the Public Library.

The McCandless Building Co., Ltd., has petitioned for a registered title of the site of its proposed block, corner of King and Bethel streets.

The trail which is being built up Diamond Head will be finished in a few days. Permission to build it was given by J. W. Pratt, Commissioner of Public Lands.

The postponed annual meeting of the Hawaiian Historical Society will be held tomorrow evening January 22, at 8 p. m. at the Honolulu library. An interesting paper will be read by Chief Justice Frear on the history of the development of Hawaiian statute law. The public is cordially invited to be present.

### HENRY HOGAN WAS DEFENDANT

CHARGED WITH TOO FORCIBLY EJECTING PORTUGUESE CLIENT FROM HIS OFFICE.

Henry Hogan, the attorney, appeared in the police court this morning with conditions reversed. Instead of defending some unfortunate he was the unfortunate who was being defended. Hogan was charged with assault and battery on a Portuguese named J. Jacintho.

The Portuguese claimed that he had purchased some land from Charlie Achi but was unable to secure a deed. He tried to get this deed and finally went to attorneys to try and get some money. Finally he went to Hogan. The complaining witness claimed that he offered Hogan half of all the money he could collect but Hogan subsequently testified that he, Hogan, had demanded a fee, for he considered that the other agreement meant no money for him, as Achi did not seem to him a very good prospect.

Some days ago Jacintho went to the office of Hogan and demanded the papers in the case returned. Hogan refused to surrender them. The Portuguese threatened, so Hogan testified, to have the attorney arrested on a charge of keeping the papers, whereupon, so the Portuguese testified, Hogan struck him across the face and ejected him from Hogan's office.

The attorney took the stand and became at times quite excited and indignant. He admitted having ejected his former client but denied having made as vigorous assault as was claimed. The court fined Hogan \$25 and costs. Notice of appeal was given at once.

### FEDERAL INSPECTORS ON ANNUAL VISIT

NEW OFFICIALS ARRIVE BY ALAMEDA YESTERDAY TO MAKE INSPECTION.

The Federal inspectors of hulls and boilers arrived yesterday by the S. S. Alameda from San Francisco. Captain Whitney and Frank Newhall, the inspectors who visited these islands last year, did not make the trip this season, but Captain O. F. Bolles and J. K. Bulger of the San Francisco district are making the inspection. They are accompanied by their clerk, Thomas Craigie, who has been in the government service for thirty years. Mrs. Bolles accompanied her husband. Offices have been secured in the rear of the David Lawrence Cigar Company in the Young Building.

The inspectors expect to remain about a month at Honolulu. During that time they will inspect the various vessels engaged in the inter-island trade. The various steamers of the Inter-Island company's fleet have been prepared for inspection and the work will be commenced without delay. Any other vessels that are here requiring inspection will receive it. The bark Gerard C. Tobey will be the first sailing vessel inspected. Others may apply for inspection. The inspectors will visit Hilo and Kahului and possibly go to Kona to make inspections of craft at those places.

In addition to the inspection of the vessels, the various officers in the engineering and navigation departments will be examined. The licenses of some of the officers have expired. Other officers will be given an opportunity of taking the examination for higher grade of license than they now hold.

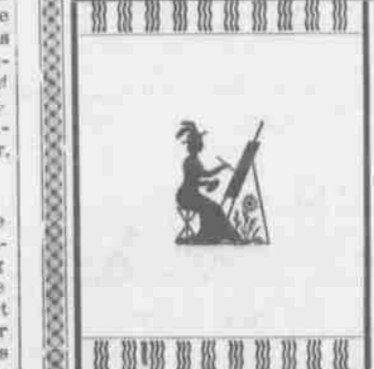
