### **VOLUNTEERS**



### RETURN TO 'IOLANI PALACE

WWII veterans of the 100th Infantry Battalion, the Military Intelligence Service and the 442nd Regimental Combat Team observed the 68th anniversary of the induction ceremony at 'Iolani Palace held on March 28, 1943. (See photo on Page 1.) It was an excellent opportunity to promote the Hawaii Regional Congressional Gold Medal events which will be held on December 17 in Honolulu.

As Club President Pauline Sato remarked in her brief speech to the gathering, "The Congressional Gold Medal is perhaps the final honor that can be bestowed by our country to these men who demonstrated bravery, courage, and, most notably, loyalty to their country."

Presidents of all four local AJA veterans' clubs addressed the group, along with MG Robert Lee, Barbara Tanabe, and Galen Ho of BAE Systems, which has been named a Title Sponsor for the regional celebration. BAE Systems is a global defense and security company with approximately 100,000 employees worldwide.

# INTERFAITH "PRAYER FOR JAPAN" HELD AT WASHINGTON NATIONAL CATHEDRAL

Marking one month since the 9.0 magnitude earthquake and resulting tsunami, His Excellency Ichiro Fujisaki, Japan Ambassador to the United States, and clergy of the Buddhist, Shinto, Hindu, Muslim, Jewish and Christian faith participated in an interfaith prayer service at the Washington National Cathedral on April 11, 2011.

US Senator Daniel Inouye and his wife, Irene Hirano Inouye, high-ranking government and private sector officials, Japanese American veterans and community members, and the general public filled the cavernous hall that previously held funeral services for men of prominence such as President John Kennedy.

"We, at the National Cathedral, join with people across the nation and around the world in continuing to pray for a country sorely tried in the past month, that its people may be strengthened, and that in the fullness of time they may rebuild their lives," said Cathedral Dean Samuel T. Lloyd III, who provided the invocation at the prayer service.

Following the service, Ambassador Fujisaki stood at the exit to express Japan's appreciation to each attendee.

On Monday, April 4, he met with a group of willing veterans at the Go For Broke Monument in downtown L.A. to take photos and interview them. 100th members present were Mas Takahashi, Ken Miya, Toke Yoshihashi, James Ogawa, Sam and Teri Fujikawa, and, from other Companies, Ken Akune (MIS), Don Seki and Hiro Nishikubo from Co. L, Chiz Ohira and Duke Ogawa, Co. H. We will look forward to seeing their book when it becomes published.

April 14, Thursday, was the first of a series of six sessions on Caregiving and Caretakers, arranged by Jason Young, VA Counselor at the West L.A. Veterans Center. Facilitators Dr. Lisa Hayden, Psy. 

# MAUI CHAPTER NEWS By Stan Izumigawa

My apologies to Maui member Tom Yamada for having an extra "to" added to his name in the

previous issue of the PPP. Inadvertent stuff like that happens because I never learned to type beyond the hunt-and-peck stage and, of course, because I did not proofread.

April 1 was the date of the premier showing at the Nisei Veterans Memorial Center of the video "Our Nobler Selves" produced by Barbara Watanabe, who was formerly with the NVMC. It features several Maui veterans from the 100th (Masao Sato, Akira "Jockey" Ishikawa, Ed Nishihara, and myself) along with several 442nd veterans, some of whom are deceased. Masao, who is not in the best of health, was not able to be present. Other 100th members present at the showing included Art Kurahara and Tom Yamada (who was one of those proficient in Japanese and served with the MIS). The video is scheduled for showing in Honolulu on April 30 and viewers will receive a brochure explaining that the video has become a tool for interacting with high school students throughout the State of Hawaii. Others appear to have heard or read about the video and have expressed interest in it. The NVMC owns the rights to the video, but its governing board has not yet determined whether it will be made available for sale to the public.

Retired General Robert Lee recently met with representatives of groups related to Nisei veterans concerning the design of the Congressional Gold Medal that will be awarded to the 100<sup>th</sup>/442<sup>nd</sup>/MIS veterans. He reviewed the various proposed designs for the coin medallion and identified the recommended choice of the various Nisei veteran groups on Oahu he has already met with. After some discussion, the Maui group concurred with that choice. There will be a ceremony in Washington, D.C., in the fall when the award is presented and it is hoped that enough of us veterans will be able to attend. The general also explained that a forthcoming tour of battle sites in Italy and France is being coordinated such that the group will make it to the Washington ceremony on its return leg of the trip. There will also be a ceremony in Honolulu in December.

## BAKER CHAPTER NEWS by Evelyn Tsuda

On March 23, 2011, a picture-perfect day, family, friends and members of Baker Chapter gathered at Punchbowl Cemetery for the inurnment of T/Sgt. Robert Yukio Ozaki, member of the 2<sup>nd</sup> Platoon of Co. B. As mentioned in the previous issue of the *Puka Puka Parade*, Robert died on May 22, 1945, while recuperating from battlefield wounds and was previously interred at a cemetery in Denver, Colorado.

Full military honors were rendered by members of the 100/442 Reserve unit. Robert's niece, Roberta (his namesake) Bishop, who gave the eulogy, described her uncle as "a Boy Scout, Iolani graduate, talented athlete, handsome, charismatic ladies' man, a defender of the underdog, a hero, a warrior, a son of Hawaii." She talked about her uncle's love of the islands and how he couldn't wait to return, and read a poem by Martin Kloess which was so fitting. It is quoted below:

#### THE HOMECOMING

There is a place there waiting for me.

We gather there as one family,
As flowers gathered there by that old tree,
With time, there watching, waiting for me.

Sgt. Ozaki is now resting under a beautiful tree with his parents (his father was a veteran of World War I). WELCOME HOME, Robert!

At our last chapter meeting on April 2, the members agreed to donate \$500.00 to the Red Cross for the Japan relief in response to President Pauline Sato's plea published in the last issue of the *PPP*. Although some members had already donated through other organizations, others dug deep into their pockets and donated another \$1,100.00. Thank you all for your generosity – the Japanese people will be forever grateful for your support.

The following is an excerpt from a speech given by Ted Tsukiyama (442/MIS) at the annual MIS luncheon on 1/29/11 which I'm sure you will find very interesting:

"There were already more than one thousand Nisei in service at the time of the Pearl Harbor attack. After the attack, they were all retained in service and assigned to the guarding and defense of Hawaii. All of them must have stories of the unique experiences they went through on that fateful day of Dec. 7, 1941.

### **Baker Chapter, continued**

One of the notable Pearl Harbor stories was the grounding of the Japanese midget submarine at Bellows Beach on Dec. 8, 1941, and the capture of the submarine commander, Ensign Kazuo Sakamaki, by Sgt. David Akui and two Nisei soldiers from Co. G, 298<sup>th</sup> Infantry. One of them was Thomas Kiyoshi Tsubota, later to become a member of the famed 100<sup>th</sup> Battalion, who trained at the MIS Language School at Camp Savage and then fought with the famed Merrill's Marauders of the Burma Campaign. Tsubota tried to question Sakamaki but he refused to talk. Tsubota must be considered a military historic figure because he participated in the capture of the first Japanese POW of the war and became the first Nisei soldier to engage in interrogation of a Japanese POW in WWII."

We received a surprise visit during our last meeting from Glenn and Linda Takata, who were here in Hawaii on a business and pleasure trip. Glenn did not need any introduction since he's a spitting image



of his dad, Yasu. (Thanks, Amy Muroshige, for being quick on the draw with your camera!) Glenn is a software engineer in Boston, Mass., where he's been living for about 40 years. It was certainly nice to see them and hope that they will visit us

whenever they are on their Hawaiian vacation.

Congratulations to Gary Galiher and Diane Ono who are among the 7 alumni to be honored at the UH Alumni Association's 2011 Distinguished Alumni Awards dinner and silent auction on May 12 at the Sheraton Waikiki Hotel. Proceeds from this annual event benefit the UH Alumni Association and are used to promote and support the university through alumni programming and student scholarships.

HONOR FLIGHT offers free transportation for veterans to visit the National Monuments in Washington, D.C. Veterans from Hawaii who wish to sign up for this program to attend the Congressional Gold Medal Ceremony in Washington, D.C., should complete the Veteran Application Form and Guardian Application Form. Please note that Veterans from Hawaii who are accepted may be responsible for a portion of the airfare. Application forms are available at the HONOR FLIGHT website: <a href="www.honorflight.org/apply/index.cfm">www.honorflight.org/apply/index.cfm</a>. Members without internet access should call the clubhouse office for assistance in obtaining the forms. Specific instructions (which are not on the website) for filling out the HONOR FLIGHT forms follow.

On the left side of the home page are links to veterans and guardians.

(1) <u>Very Important.</u> At the top of the first page of the application form, print in bold letters:

### JAPANESE AMERICAN

(2) Veteran and Guardian should print their first name, middle name, last name and date of birth as they appear on a photo ID (e.g., a current driver's license or passport). This is needed to obtain their airline tickets. (3) Make sure the completed application is sent to

- (4) On flight day, the veteran and guardian present themselves to the airline ticket agent at the airport, as instructed by HONOR FLIGHT.
- (5) Veterans who use wheelchairs are advised to bring their own wheelchairs. Motorized scooters are not recommended.
- (6) An 80- or 90-year-old person, such as a spouse of a veteran, cannot serve as a guardian. The Guardian must be able-bodied to push a wheelchair uphill. Guardians are usually next-generation family members who are asked to cover their own travel expenses. While HONOR FLIGHT cannot guarantee the guardian will fly free, it will try to make this happen.
- (7) HONOR FLIGHT will get the veteran and guardian from the Washington, D.C., airports to their hotel(s).
- (8) Somewhere on the application form, even if you need to put an insert, list the members of the veteran's entourage. HONOR FLIGHT cannot guarantee, but will attempt to have the veteran and his entourage travel on the same plane. As to whether this will happen will depend on the availability of seats. HONOR FLIGHT will not pay for the seats of the veteran's entourage.

### POST WAR IN ITALY by B.S. Akamine

Having so much money, fellow Bakerite Tamotsu "Curly" Akiyoshi and I went looking for the most prized camera at the time--LEICA with F2 lens. Curly had photo lab experience before entering the Army, so he was very knowledgeable in the field. We went to most of the camera stores, but couldn't find any Leica. The next best thing he said was a Rolliflex, but that was no mo' so he settled for the cheaper Rollicord. I settled for a Kodak Retina 1. The next challenge we faced was photo processing. Curly found the chemicals and photo printing papers. He also found a huge folding camera with bellows that can be adjusted for focusing, so we used that for our enlarger. We were in business. Our dark room was a room in the half-bombed out building that B Company occupied. We didn't have to worry about light leaking into the room because we did our printing at night. After a few weeks, we moved out of that building. Curly and I knew of the impending move, so we developed all the film into negatives and planned to print them when we came home. However, when we came home, my interest changed to movies. Curly's advice to me was to buy the best rather than start with a cheapie and then graduate to buy better equipment. So, I bought the latest thing--a 16 mm 50-foot film pack camera. The film pack cost more than \$2, but that included processing. Then, I needed a projector, so I got one with sound. Showing the movies, which everyone enjoyed, became quite a chore, lugging the projector, screen and films, that I gave that up and picked up a Polaroid and now I am enjoying my digital camera. Printing the photos at home is so easy now, too. As for the dozens of canisters containing the 35 mm negatives from Italy, I cannot find any of them. Fortunately, the photos that we did print have lasted 65 years, so I sent them to the 100th's Education Center to copy.

# OFFICIAL WHITE HOUSE COPY OF PUBLIC LAW 111-254 (AWARDING CONGRESSIONAL GOLD MEDAL)


At the March 19, 2011, meeting of the Board of Directors, an official White House Copy of PL 111-254, signed by President Barack Obama, Senate President Pro Tempore Daniel Inouye, and House Speaker Nancy Pelosi, was presented to Sgt. Bernard Akamine by MG (Ret) Vern Miyagi.

Summoned to the clubhouse by President Pauline Sato, Bernard reported without asking questions, where MG Miyagi presented the framed document to him in a brief ceremony. The Akamine family learned about the program to present copies of the document to frail or terminally ill veterans and applied to NVN. The family was advised to have a flag officer (active or retired) make the presentation, to invite witnesses, including other veterans, to the ceremony. Bernard, who is living with pancreatic cancer, was taken by surprise, but he managed to stand and thank everyone for the honor. Both Akamine and Miyagi worked together for several years on the club's annual memorial service, while Akamine was Chair and Miyagi was Chief of Staff of the Hawaii National Guard. Thanks to the National Veterans Network and the Japanese American Veterans Association for making this presentation possible. 
