POWERS LIMITED

In the matter of Judge Kalua's claim for \$854.80, for pain for which the Board of Health refused to pay, Deputy Attorney General Peters has rendered an opinion for Auditor Fisher which places highly important limitations on the power of the legislature in appropriating public money, especially during extra sessions. Kalua was given an appropriation of the full amount by the legislature in the extra session, in spite of the fact that the Board of Health rejected his bill, but he will not get the money under Peters' opinion.

Peter holds that the legislature has no right to make a special appropriation of the public money for the benefit of an individual, as was attempted in the case of Kalua. The money was set aside for the purely private benefit of Kalua, says the opinion, and not for any public purpose or benefit, and such an appropriation is not within the powers of the legislature. All appropriations must subserve some purpose of a public nature, such as the fulfillment of an obligation, moral or legal. The opinion may have an important effect on other appropriations of the extra session.

Another important ground on which the appropriation is held to be illegal is that the legislature, called in extra session to consider appropriations, can under the terms of the Organic act providing for such sessions, only appropriate money "for the necessary current expenses of carrying on the government and meeting its legal obligations." This contention affects all the appropriations of the extra session except those for expenses, and raises a question as to the validity of the loan appropriation bill.

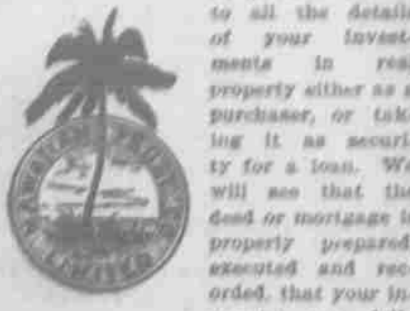

Some Obligations Already Incurred

Governor Carter has had a list made of the public works contracts pending and entered into by the government when he took office. It shows over a hundred thousand for which warrants will have to be registered, as there is no money to pay the contractors. Four of the contracts are loan contracts, made before the loan was floated, with contractors who are supposed to have been willing to take bonds if necessary. They have been paid in full. The list includes some of the contracts over which Carter and ex-Superintendent Cooper had differences in the late "cabinet," Carter objecting to the incurring of obligations by the old administration, to be met by the new. ANOTHER GREAT WORK COMPLETED

Rev. Hiram Bingham is just completing another monumental work of erudition. He has completed, and is now reading final proofs on a commentary of the New Testament in the language of the Gilbertese Islanders. This is supplementary to his wonderful work of translating the entire Bible out of the original Greek and Hebrew into the Gilbertese tongue, which was completed nearly eleven years ago.

The commentary is largely exegetical and very little homiletical or hortatory in its character, being designed to enable the Gilbertese Islanders to more fully understand the New Testament, drawing its figures of speech and its symbolism from a country and from conditions wholly different from anything the Gilbertese have ever known or have had opportunity of learning from any other source.

It is intended to read with the commentary, a little dictionary already printed in the Gilbertese tongue, making, making altogether a book of about 600 pages. This will supply the Gilbertese in addition to the complete Bible, with many helps to the study of the scriptures, including in three large Bible stories and other paraphrases of scripture prepared and published in the past.

The commentary now nearing completion is to be published by the American Tract Society, probably some time during the present year, though Dr. Bingham hopes to be able to have the work published here about two hundred copies of his fellow-men.

To Deport Stragglers On Transport Thomas

Seven stragglers from the fleet are to be sent away to Manila tomorrow on the transport Thomas. The vessel is not crowded and ample accommodations can be secured for them. Admiral Terry will arrange to have the stragglers taken in charge by the quartermaster of the vessel and be delivered to Admiral Tamm at the naval authorities at Manila.

This number represents a small part of the men who left the fleet. Fully 75 men were left behind by the fleet. Efforts are being made by the police to round them up and it is expected that a large number will be in custody when the next transport arrives here from the Philippines en route to the Philippines. The American fleet has been ordered to bring bay for target practice as there will be no difficulty in the stragglers being returned to their respective vessels as the fleet will be bound to go to Manila or Cavite within a few weeks.

WHAT HAPPENED TO PRINCE KUHIU

THE FACTS AS TO HIS ENCOUNTER WITH ATTORNEY CHARLES CLARK IN WASHINGTON.

The publication of two very different accounts of Prince Kuhio's arrest in Washington on January 2 has caused a good deal of local discussion as to what took place. One account stated that there was a fist encounter, while the other only referred to an altercation; one stated that the prince claimed his arrest from arrest as a Congressman and the other that he waived it, while a third difference was that in one account it was stated that the prince refused the friendly offices of Senators and Representatives who desired to assist him, the other account apparently omitted this. Below are given the exact words of the cable received and The Star and Bulletin versions as published. The cable message was worded as follows:

"Washington Kalaianaoale arrested disorderly conduct attorney Charles Clarke personal matter declined Congressmen humane arrest declined deposit bail spent night jail coffee sandwiches taken court Black Maria case continued Thursday." The Star, following closely the text of the message published it as follows: "WASHINGTON, D. C., January 5.—Prince Kuhio Kalaianaoale, Hawaiian Delegate to Congress, was arrested yesterday for disorderly conduct, as a result of an altercation with Charles Clarke. The dispute was over a personal matter. On being arrested Kalaianaoale claimed that as a member of Congress he was exempt from arrest and he declined to put up any bail, demanding to be released without. His demand was denied and he spent the night in jail, dining on coffee and sandwiches. He was taken to the court this morning in the Black Maria with other prisoners. The trial of his case was continued on Thursday.

"Charles Clarke is an attorney, who was in Honolulu recently. His wife and son are now living in Kalamook, and he recently left here for Washington. It is supposed that he had business in connection with the session of Congress."

In the Bulletin the following version was given: "WASHINGTON, D. C., January 5.—A sensation was created in Washington today by Prince Kuhio, the Territorial Delegate from Hawaii, who was arrested charged with disorderly conduct.

"Delegate Kuhio got into an altercation with Charles Clarke over a personal matter and a fist encounter followed.

"It is claimed that Kuhio being a Congressman was immune from arrest. The delegate, however, waived this privilege and when arrested declined to deposit bail. He spent the night in jail feeding on coffee and sandwiches. This morning the Delegate was taken to the Police Court in the Black Maria with other prisoners, refusing to accept the friendly offices of Senators and Congressmen, who desired to prevent his appearance in the Police Court. The case was continued till Thursday.

"Charles Clarke, who was the cause of Kuhio's arrest, came here a short time ago to act as an assistant secretary, he being a representative of business interests in Honolulu. The Hawaiian Delegate is obdurate and will give no explanation of the cause of the trouble or his reasons for refusing the advice of friends."

MERCHANTS WIN. The Merchants' Association has won its last case before the tax appeal court, in appealing against Assessor Pratt's valuation of merchandise stocks of the inventory figures. In the case of the Cash and the Pacific Hardware Company the court sustains the returns at twenty per cent less than the inventory value, agreeing with the owners of the property that they are entitled to such a concession for depreciation of stock while kept in store. The assessment against an assessment of \$218,074.41 and the Kash return of \$26,045.74 is sustained against assessment of \$16,028.67.

TAFT AND THE GRAND VIZIER. Associated Press, Morning Service.

TOKYO, January 5.—The Grand Vizier of Persia and Governor Taft of the Philippines were passengers on the S. S. Korea leaving yesterday for San Francisco via Honolulu.

A light seemed imminent owing to the clash of several factions in the society who had rival tickets in the field. Chu Gun was elected president and Cheng Leung secretary.

HAVE GREGORY A BAROMETER. The people of Eleele and Moehaike Plantation presented Captain Gregory of the steamer Miskahia with a fine banner for a New Year's gift this week.

FEW JAPANESE ARE LEAVING. Few Japanese are leaving Honolulu now. The S. S. Nippon Maru carried only fifty Japanese passengers from this port. The cold weather in Japan is said to be the cause of the small number of Japs going home.

MARRIAGE.

We are having our fill of reorganizing, and we every now and again come up against something which has been forgotten or misunderstood. The marriage license is a case in point.

Under this system a considerable number of such agents were appointed. The object of both departments was to render every facility for those who desired to enter into the state of matrimony and yet have thoroughly reliable agents to grant the licenses.

Take for instance the County of West Hawaii. The county seat is at Kailua. The county includes the districts of Kau, North and South Kohala, North and South Kona.

Even on this island, which represents the County of Oahu, the obtaining of a marriage license would be no easy task for anyone living in the vicinity of Kahuku, Kahana or Waimanalo.

THE BLACK SEA FLEET.

The oriental mix-up seems to get worse and worse. The latest plan of Russia is to get her Black Sea fleet into the Mediterranean. This is against the provisions of the Treaty of Paris and would call for immediate protest from the United Kingdom.

Of course the Russians might attempt to force their way through, but the Bosphorus is well fortified and the Turks are good gunners, a fact which was made clear during their last war with Greece.

The object of European diplomacy has been to keep Russia from expanding into Europe. The object of Russian diplomacy has been to expand to the Mediterranean and to the Atlantic.

Apart from personal fears of Russian expansion there are motives which interest the powers with regard to Japan. To permit the Russian fleet to get into the Mediterranean would be to assist Russia in attacking Japan.

BOUNTY FED SUGAR.

Collector Stackable has been notified of the following ruling of the Treasury Department:

In pursuance of the provisions of section 5 of the act of July 24, 1897, the following net amounts of the bounties paid or bestowed by the Government of the Netherlands on the export of sugars produced in that country are hereby declared for the assessment and liquidation of additional duties:

- 1. On raw sugar produced from beet roots, 1.75 florins per 100 kilograms of hard refined. (The output of refined sugar from raw is computed by deducting from the polarization of the raw sugar twice the glucose, four times the ashes, and 1 1/2 per cent for loss in refining.)
2. On sugar refined from beet-root raw sugar produced in the Netherlands, 1.88 florins per 100 kilograms.
3. On sugar refined from imported raw sugar, .13 florin per 100 kilograms, in addition to bounty, if any, allowed on the raw sugar by the country of production.

The liquidation of entries covering sugars produced in the Netherlands after September 1, 1902, will be made on the basis of the bounties herein specified.

The foregoing is subject to the qualification that where it is shown in any particular case by the evidence prescribed in Department circular 105 of September 17, 1903 (T. D. 24668), that no export bounty has been paid, no additional duties will be assessed under section 5 of the act aforesaid.

SHE DEFIED JUDGE DOLE

Three months for contempt is what Mura Kurahara got this morning from United States Judge Dole, for refusing to answer questions put to her by District Attorney Breckons. Mura was taken from the court to the marshal's office where she waited till noon for the prison wagon and sat crying all the time. She was wanted to testify in the case of Tereyama. Yesterday she refused and was imprisoned till this morning.

When she was called to the stand this morning Mura first said she didn't know how to answer. Then she said she wouldn't, and that was the end of it. Judge Dole warned her that if she did not answer she would be punished, but Mura stuck to her refusal. The court then adjudged her guilty of contempt and ordered her imprisoned for three months. Mura was weeping by the time she reached the marshal's office, and she wept most of the time till noon, wiping her eyes on a holo-ku. Mura is one of the numerous Japanese defendants. One report was that she had been terrorized into refusing to testify, but she says her only reason was that she thought she had a right to refuse.

The trial of Tereyama was continued, but nearly all the morning was spent in arguments between District Attorney Breckons and Attorney F. E. Thompson, over questions of admissibility of evidence. The case is on trial this afternoon.

KINDERGARTEN WORKERS MEET

This morning's regular business meeting of the Supervisors of the Free Kindergarten Association occupied but half an hour. The various kindergartens, it appeared, had reassembled, after their Christmas celebrations and vacations, and were reported to be in flourishing condition.

The ladies were glad to hear of a balance in the bank—always an agreeable asset! They were glad to learn that the little Christmas play given by the girls of the kindergarten training school had taught its object lesson to a crowded hall of parents of all nationalities and had, moreover, realized \$40 for the Children's Christmas trees. They were glad, indeed, of the results of the Doll sale at the Hawaiian Hotel by which the association is nearly \$400 richer. They passed a hearty vote of thanks to the chairmen, and through them, to their committees, for their enthusiastic efforts that resulted in so great a success.

Mrs. Thompson in her sanitary inspection had discovered a whole family afflicted with the virulent pink-eye, and was greatly encouraged in her work by having the father pay the doctor's bill—an unusual offer.

In the matter of nominations, Mrs. Clarence Cooke was appointed successor to Mrs. George Howard, on the buildings and grounds committee, and, on the Kawaiahao committee, Mrs. Doremus Scudder, to succeed Miss Snow.

Honolulu Will Be Lighted

All the members of the Board of Supervisors were present this morning when Chairman Hocking called the meeting to order.

The first business taken up was a communication that had been addressed to Chairman Hocking on the subject of the Board guaranteeing the Hawaiian Electric Light Company payments for the 70 arc lights that are used to light the streets of the city. The communication was as follows:

"A. Hocking, Chairman of the Board of Supervisors, County of Oahu, Territory of Hawaii:

"I enclose herewith copies of proposal made to Hon. H. E. Cooper, late superintendent of public works, together with a copy of his letter of acceptance covering agreement to furnish electric current for arc lights in the city of Honolulu.

"Seventy arc lights have been installed and are now in operation from our station. We would respectfully request that your honorable Board confirm and continue in operation this agreement until such time as the Board may elect to enter into a definite agreement.

"The Board will appreciate that if we continue supplying current for these lights without their authorization, we will be doing so at our own risk and loss. We assume, however, that it is not the desire of the Board not to discontinue the city lights and we would request that an early decision be reached. Very respectfully,

"The Hawaiian Electric Co., Ltd., A. Gartley, general manager."

The agreement with Mr. Cooper had provided for the installation and payment of the street lights. On motion of Supervisor Gilman the Board decided to continue the agreement until such time as the Board should decide to change it.

The question of requiring a bond of \$1,000 from Kallimai, the market caretaker, was then discussed. After considerable discussion it was decided to require him to file a bond of \$1,000.

On motion of Mr. Gilman the salary of the superintendent of the garbage and sewerage department was fixed at \$200 for the month of January and every month thereafter. The salary of the market keeper was fixed at \$75 and his assistant at \$50 a month. On motion of Mr. Gilman the clerk was authorized to appoint an assistant clerk, who should act as interpreter to the Board of Supervisors and otherwise assist the clerk at a salary of \$150 a month. Mr. Murray announced the appointment of Robert N. Boyd and this appointment was approved.

The recorder was authorized to appoint as a force for his office a chief clerk at a salary of \$150 a month, indexer at \$90; recording clerk, \$75; copyist, \$75, and three clerks at \$60 each.

RECEIPT THAT VIDA GIVES TO WILSON

The form of the receipt which Road Supervisor Henry C. Vida will give to his predecessor in office for the property turned over to the county, was presented by Mr. Vida this morning to the Board of Supervisors. The receipt is so framed as to enable Vida to turn the material back to the Territorial government should the county act under which the present transfer is being made, be declared illegal.

The following communication was read this morning at the meeting of the Board:

"To the Honorable Board of Supervisors, County of Oahu:

"Gentlemen:—Enclosed herewith I submit for your approval, form of receipt as handed to me by Superintendent of Public Works Holloway, for the transferring of properties in the possession of the Territorial road department to the County of Oahu.

"Should this form meet with the approval of your honorable Board I shall sign and deliver same to Mr. C. B. Wilson. Yours respectfully,
"Henry C. Vida, Road Supervisor, Honolulu."

The form of the receipt was as follows:

"As provided for in Section 476, Chapter 86, Act 31 of the Session Laws of 1903, I, for myself and my successor in office, hereby acknowledge receipt from Mr. C. B. Wilson, Road Supervisor, Honolulu, of all properties in possession of the Road Department, Honolulu, as shown by inventory attached, which I have personally checked; the same to be used only and solely for the uses and benefit of the County of Oahu, and maintained, managed and cared for by it at its own expense, until otherwise provided for by the Congress of the United States, or taken for the uses and purposes of the United States by direction of the President, or of the Governor of Hawaii, as provided in Section 91 of 'An Act to Provide a Government for the Territory of Hawaii,' passed by the 50th Congress of the United States, and I hereby agree, in consideration of the turning over of said property, to surrender

the same to the Government of the Territory of Hawaii, upon demand by it or its duly authorized officials."

The form was spread on the minutes of the Board. The road supervisor and all other heads of departments were ordered by the Board to send in inventories of the property received by them.

FORT ST. WHARF

A legal question has arisen in connection with the contract between the government and the Inter-Island Steam Navigation Company, concerning the construction of a new wharf for the company, at the foot of Fort Street, and an opinion is to be secured from the attorney general. The contract was entered into during the last administration, and provided for advances by the steamship company to help in constructing the wharf. One provision was that the company should have exclusive use of the wharf for ten years, and this is the feature which it is said may be attacked.

THOMAS BROKE ALL RECORDS

ARRIVED THIS FORENOON FROM SAN FRANCISCO WITH ONE DAY LATER MAIL.

With the distinction of having broken all transport records between San Francisco and Honolulu, the transport Thomas arrived off the port this morning shortly after 11 o'clock. She came down in 6 days 23 hours and 20 minutes reducing the best previous record of 7 days and 4 hours which was made by the Sherman.

Captain Lyman is master of the Thomas. The last time he visited Honolulu he was in command of the transport Sumner when General Chaffee and Governor Luke Wright of the Philippines were aboard as passengers.

The Thomas left San Francisco January 1 so brought one day later mail. The trip was uneventful, a four-masted schooner and a ship evidently the W. P. Frye, were sighted yesterday. Dr. Manning who is to relieve Dr. White of the local marine corps arrived by the vessel. Two casualties also stop at Honolulu. A sick soldier is to be left off at this port as he has consumption. The transport will take about 650 tons of coal, and sail for Guam and Manila at 4 p. m. tomorrow.

NUUANU ON TRIAL.

A jury was sworn this afternoon before Judge Robinson to try the case of David Nuuanu, charged with manslaughter.

**LUCIN CUT-OFF
AGAIN SINKING**

IT IS REPORTED THAT THE ROAD
ACROSS GREAT SALT LAKE MAY
NOT BE READY FOR SOME TIME.

OGDEN, Utah, December 29.—Owing
to a further settling of the track in
two places, the Ogden-Lucin cut-off of
the Southern Pacific across Great Salt
Lake will not be opened to regular traf-
fic on New Year's day, as planned. It
was announced that work had been
practically completed Thanksgiving
day, when E. H. Harriman and a large
party of invited guests, including many
prominent railroad men, inspected the
cut-off.

"Trains will be running regularly on
January 1st," declared Harriman on
that day. He was relying upon the as-
surances of William Hood, the chief
engineer, that the quagmires had been
conquered. His hope has proved false,
however. In two different places the
roadbed has sunk considerably since
then.

The engineers in charge are quoted as
saying privately that it will be several
months before trains can safely be run
over the cut-off.

**SANE MAN MANY
YEARS IN ASYLUM**

VICTIM OF A CONSPIRACY ES-
CAPES AND THE DOCTORS FIND
NO MENTAL WEAKNESS.

LAPORTE (Ind.), December 22.—
Carroll Roberts, in 1889, was a farmer
near Adrian, owning a large farm and
with money in the bank. His father
and one brother, H. Brant Roberts,
were also wealthy farmers. In that
year an insanity inquest was held re-
sulting in sending Carroll Roberts to
the insane asylum at Kalamazoo and
the appointment of a guardian for his
estate. His father died, leaving a will
which gave all his property to his son,
H. Brant Roberts, except a small an-
nuity left to Carroll. The will was set
aside on contest.

In September Carroll Roberts escaped
from the asylum. Expert alienists say
no evidence of mental defect in him has
been found. One physician, who tes-
tified as an expert in the insanity pro-
ceedings, says he was misled, and that
his evidence was a mistake. Roberts
will claim his share of his father's es-
tate and will ask to be restored to the
full status of a sane man. He charges
that his troubles were the outcome of
a conspiracy.

CORPORATION DISSOLVED.

The Bituminous Rock Paving Co.,
Ltd., which received its charter July
12, 1900, is dissolved. J. J. Belser,

SAN FRANCISCO SEES HER CHANCE

THINKS SHE WOULD BE THE NATURAL BASE OF SUPPLIES IN CASE OF WAR.

SAN FRANCISCO, December 26.—That this city would derive material profit from actual war between Russia and Japan has been practically demonstrated by the contract secured by Getz Bros. Co. It calls for the delivery of 2,000,000 pounds of cured beef to the Russian base of supplies in the Orient, and every pound of the meat will be shipped from San Francisco, which means work and wages for San Francisco residents.

"We obtained the order through our branch house at Shanghai," said Louis Getz yesterday, "and if we had not had a branch house there the order probably would have gone to a European agency. If the meat could be procured on this coast we could buy it here, but as it is, we have been obliged to send east for it. The first special trainload is now en route from Kansas City, and will arrive in time for shipment on the Coptic, due to sail on January 15. The consignment consists of 2000 barrels, each barrel containing 250 pounds, and it will be in as good condition when it reaches its destination as when it left the packing house."

Getz declined to disclose where the meat would be landed but it is pretty generally understood that Port Arthur is its destination.

"The remainder of the order will be shipped just as rapidly as we can find marine transportation for it," said he. "I have no doubt that other San Francisco firms will, directly or indirectly, reap some benefit from the warlike situation in the Orient, for San Francisco is the logical shipping point for all kinds of provisions."

DR. NOBLITT'S POSITION.

EDITOR STAR: In your report of the proceedings of the Board of Supervisors in its session of Wednesday, I am done a grave injustice not by the press, but by a supervisor who no doubt was innocent of any intention to do me an injustice and by the President of the Territorial Board of Health whose report through Supervisor Lucas to the board was unjust to me and untrue and was made either in inexcusable ignorance of the facts or with personal malice toward me.

Dr. Cooper knows or should know that I have a license to practice medicine in Hawaii which is in full force notwithstanding the strenuous, if ill-directed attempts of himself and of some of his confederates to render it void.

Dr. Cooper knows or should know that every lawsuit between the Board of Health and myself was won by me. To this there is no exception.

Dr. Cooper knows or should know that I brought a suit against the Board

of Health and had their action in my case declared null and void, and with a transcript of the judgment had the license record changed to conform thereto.

Perhaps Dr. Cooper, in his legal wisdom thinks I must have the decision of the court O. K. by himself or his board before it is effective. But as I have all the rights of any other member of the profession including the right to collect my accounts by legal process, I think I can safely neglect that formality. As man to man I ask nothing of Dr. Cooper not even fairness. But as a taxpayer to a tax-exeter I think common decency requires that when he makes injurious statements about any one he shall be careful to state the truth.

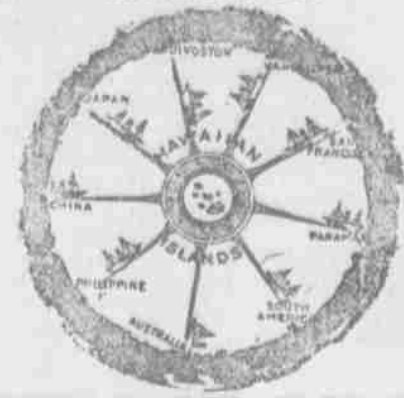

THE WEATHER BUREAU.

R. C. Lydecker, Territorial Meteorologist, has received the following letter, which explains itself:

United States Department of Agriculture, Weather Bureau, Office of the Chief, Washington, D. C.

December 19, 1903.

Mr. R. C. Lydecker, Territorial Meteorologist, Honolulu, H. T.

Dear Sir: In response to your letter of December 4, 1903, in which you make inquiry as to the probability of the U. S. Weather Bureau establishing a meteorological service in the Hawaiian Islands, permit me to say that this matter has been under consideration

for some time. Our estimates now before Congress provide for a sufficient sum to do this work, and if the estimates are approved, action will be taken to inaugurate a weather service in the Islands soon after July 1st, next.

SEVENTEEN JAPANESE CONSPIRATORS LINED UP BEFORE JUDGE DOLE THIS MORNING.

Seven men Japanese alleged conspirators lined up before United States Judge Dole this morning to plead to the indictment in which they were charged, with about sixty others, with a conspiracy to carry on Japanese brothels. They were all in the same indictment with the three who pleaded guilty yesterday. Three women whose cases were called were discharged, on motion of District Attorney Breckons, who said that none of the women would be prosecuted. The men, who organized the associations and who lived on the earnings of the women, are the ones the law is after.

Sato pleaded guilty to importing a woman for immoral purposes. His attorney, J. W. Cathcart, made a plea for a light sentence, saying that while Sato knew he had violated the United States law, he was not conscious of any moral wrongdoing. "His ideas on the subject of morality are very different from ours," said the attorney.

Breckons said he didn't oppose Cathcart's argument. "At no time since the defendant was arrested has he denied any of his acts," said the district attorney. "He admitted everything from the first and appeared to bring a woman here from Japan for immoral purposes." Judge Dole im-

posed a sentence of six months' imprisonment and \$1 fine, and costs.

Of the seventeen in line, five, represented by E. M. Watson, had already heard the indictment and their cases were postponed to next Tuesday, to be set for trial. In behalf of twelve of them Cathcart filed a demurrer and motion to quash the indictment, based upon the same grounds as in the cases formerly argued by Watson. The court ruled against the motion and demurrer pro forma and exceptions were taken. It is possible that the big indictment will yet find its way to the Ninth Circuit Court of Appeals.

When the name of Shira Ishi was called a Jap started from the audience, but was ordered back by Marshal Hendry. "Shira Ishi is a woman," said the marshal. Then the real Ishi came forward and was dismissed in accordance with the decision not to prosecute the women.

Superintendent of Public Works Holloway has plans all drawn for reorganizing the Honolulu wharf system, and is preparing to go ahead under the loan appropriation of \$300,000 as soon as they are definitely settled upon. He will hold a consultation with the best informed and most interested men before making any contracts, as it is reported that there have been objections made to the plans as prepared.

The main question is as to whether the wharves shall be constructed at the Waikiki end of the harbor, from Fort street to the naval wharves, as planned, or whether they shall be placed at the other end, on the curve of the deep water line between the railway wharves and Quarantine Island. "I understand that some people have urged the placing of wharves at the Ewa end," said the superintendent.

"Before taking action I shall have a consultation with a commission composed of such men as Captain Fuller, the harbor master, and others who are similarly familiar with the situation. We have the money and are ready to proceed when plans are finally settled."

The plans now prepared provide for bringing the line of the wharves up to Allen street, all along the front, cutting through the Pacific Mall and the Esplanade. All the wharves run Mauka and Makai in the plans, and are long piers 200 feet wide. The present Pacific mail wharf is entirely abolished, in its present condition it is little used and private wharves are getting the revenue. Seven men Japanese alleged conspirators lined up before United States Judge Dole this morning to plead to the indictment in which they were charged, with about sixty others, with a conspiracy to carry on Japanese brothels. They were all in the same indictment with the three who pleaded guilty yesterday. Three women whose cases were called were discharged, on motion of District Attorney Breckons, who said that none of the women would be prosecuted. The men, who organized the associations and who lived on the earnings of the women, are the ones the law is after.

Sato pleaded guilty to importing a woman for immoral purposes. His attorney, J. W. Cathcart, made a plea for a light sentence, saying that while Sato knew he had violated the United States law, he was not conscious of any moral wrongdoing. "His ideas on the subject of morality are very different from ours," said the attorney.

Breckons said he didn't oppose Cathcart's argument. "At no time since the defendant was arrested has he denied any of his acts," said the district attorney. "He admitted everything from the first and appeared to bring a woman here from Japan for immoral purposes." Judge Dole im-

posed a sentence of six months' imprisonment and \$1 fine, and costs.

Of the seventeen in line, five, represented by E. M. Watson, had already heard the indictment and their cases were postponed to next Tuesday, to be set for trial. In behalf of twelve of them Cathcart filed a demurrer and motion to quash the indictment, based upon the same grounds as in the cases formerly argued by Watson. The court ruled against the motion and demurrer pro forma and exceptions were taken. It is possible that the big indictment will yet find its way to the Ninth Circuit Court of Appeals.
