CONGRESS ADJOURNS FOR THE HOLIDAYS

(Associated Press Cable to The Star.)

WASHINGTON, D. C., December 21.—Congress today adjourned for the holidays, naming January 5 as the day for reconvening.

There has been considerable local interest in the question of whether the Senate would confirm the nomination of Cottrill of Toledo for collector of internal revenue for the district of Hawaii, before adjournment for the holidays. The nomination went in last Saturday, and it was thought that there would be action before now. The delay may mean that there is opposition to Cottrill and that the protest from here against his appointment may be headed.

KEEFE IS HUSTLING; SAYS IMMIGRANTS BROUGHT HERE NOT DESIRABLE ON MAINLAND

Immigration Commissioner-General Daniel Keefe arrived back in Honolulu from a tour of Hawaii and Maui Islands this morning, where he has been investigating the conditions prevailing among the plantation laborers. Commissioner Keefe will leave this evening at eight o'clock for Nawiliwili on the Claudine and hopes to get back some time Friday morning, in good time to leave for the Coast on the Mongolia on Saturday.

When seen by a representative of the Star this morning, Commissioner Keefe said that the conditions prevailing in the two islands visited were much the same as those here. He arrived at the island of Hawaii on Wednesday last and remained there until Monday last, when he left for Maui. He visited all the large plantations and was kept busy from morning to night. He saw the men at work, from the time of cutting the cane until the sugar was loaded on the cars for hauling to the ports. Commissioner Keefe talked with men of all nationalities as represented by those on the plantations; discussed immigration questions with plantation managers; saw the conditions under which the men live; investigated the cost of living and generally made a full and complete inquiry into all matters appertaining to his quest.

When Commissioner Keefe leaves the islands he will compile an exhaustive report dealing with the entire question and this report it is expected will run into many folios.

Until this report is completed Commissioner Keefe will not disclose the nature of the recommendations which he will make to the Immigration Department on his return East. He has made a special study, as far as possible in the short time at his disposal, of the various races working on the plantations.

"Are these men desirable immigrants?" he was asked.

"They would not be desirable on the mainland," was his quick rejoinder.

"But are they desirable here?" "I do not know. I am not saying they are. They certainly would not

be desirable on the mainland," he reiterated.

There were only two kinds of immigrants who went in anything like large numbers to the mainland, he said, and they were Porto Ricans and Filipinos. Neither Chinese nor Japanese were admitted, except under certain stringent conditions, and Portuguese did not migrate to the States in great numbers.

Commissioner Keefe is accompanied by his wife, who went with him to Hawaii and Maui and this lady will visit Kauai with him this evening.

LOW CAN WIN IF DWIGHT WILL WITHDRAW

A petition in behalf of Supervisor-elect Eben P. Low for chairman of the committee on roads has been circulated among local businessmen and signed by many. But the members of the board who decided against him are standing pat, and declare that it is a most unusual proposition for a member of the board to get out a petition to influence the board regarding committee assignments.

The only way for Low to get the chairmanship, say the other members, is for Dwight to give it up voluntarily. If Dwight will withdraw in favor of Low, the latter can have it, but without such withdrawal they propose to stand by their choice of Dwight.

Considerable efforts were made yesterday to straighten out the difficulty, in order that the new board might start harmoniously. No progress appears to have been made, however.

WAITING TO IMPEACH

The waiting stage has been reached in the matter of the refusal of the City and County Attorney's department to conduct prosecutions in the Circuit Courts. For the present, cases are being put over owing to the near approach of Christmas holidays, and, therefore, there is nothing to precipitate a crisis. The Attorney General, however, is determined to test the position if Catchart or his deputies should refuse to take action, for he stated this morning that, in the event of their declining to carry out their duties, he would act immediately. As soon as Catchart makes a definite refusal to prosecute a case, the case will be made the basis of proceedings for impeachment of the county attorney for nonfeasance in office.

Waldron's Report On Tour Of China

It is my firm belief that the Chinese value the friendship of the Americans more than that of any other nation on earth. At Peking we began to realize that the friendly feeling of the Chinese towards the United States extended from the lowest coolie to the Throne. From Commissioner Waldron's report to the Chamber of Commerce.

At the joint meeting of the Chamber of Commerce and Hawaii Promotion Committee this afternoon Fred Waldron submitted a report on his recent tour of China as a member of the party of commercial men from the Pacific Coast and Hawaii. The report is in part as follows:

As your delegate to visit China in response to the invitation of the Chinese Chambers of Commerce and in connection with the delegation invited from the associated Chambers of Commerce of the Pacific Coast I now have the honor to submit the following report:

The different cities represented in the delegation with the number of delegates actually attending were as follows:

San Francisco, three; Seattle, three;

Tacoma, three; Spokane, three; Portland, one; Oakland, two; Los Angeles three; San Diego, two, and Honolulu, one, with the exception of four days in Canton, when we were favored with the presence of Mr. E. C. Brown, your other appointee, who, much to his own and my regret, was for business reasons unable to join the party at an earlier date.

In handing you my report, I wish to state that my hardest task has been to condense matter, and in so doing I feel that it is an injustice to hundreds of Chinese official and commercial gentlemen who knew of no limit in their endeavor to extend in their welcome and hospitality a reception never before accorded a party of visitors in any country.

To illustrate the impossibility of embodying more than the principal events of the trip I shall here mention the programme followed at Shanghai and Hangchow, similar programs being the order of the day in all other parts of China which we had the pleasure to visit:

Garden party at Chao's Garden given by the Associated Chinese Chambers of Commerce;

Reception by the Chinese Young Men's Christian Association;

Evening reception by the American community of Shanghai;

Reception by the Shanghai Taotai (corresponding to Mayor);

RECORD MONTH FOR TRAVEL HERE

The present month is believed to be the record month in the history of Honolulu, in the number of passengers arriving by steamers from the mainland. With two big steamers still to come, the Wilhelmina and Sierra being due next week, the total of arrivals is over 500, and the total of departures from here is far below the average.

The next two months will probably exceed this one, however, in the number of passengers arriving. The book-

ings reported for next month indicate a continuance of the travel this way, while the several big excursions coming here in February will place that month far in the lead.

Another March excursion is being advertised in the eastern press, in the following language:

"Hawaii. A special cruise visiting Honolulu and Kilauea, the greatest volcano in the world. Sailing from San Francisco March 18, 1911."

CATCHART WILL PROSECUTE

Judge Cooper this afternoon made the following statement from the bench:

"In regard to the prosecutions by the County Attorney's office, while the Court has not made a formal order out to have no doubt as to the position of the court, it is hereby

ordered that in all criminal matters now pending on the calendar of the first Circuit Court, First Judge presiding, that the City and County Attorney, or his deputies as he may designate, shall appear and prosecute all cases pending before this court." Attorney Catchart:—"I bow to the ruling of the court."

ANTI-SPITTING ORDINANCE IS LAW, BUILDING ORDINANCE MOST WAIT

The announcement of the signing of the anti-spitting ordinance by Mayor Fern, and the development of the fact that there is no chance for the building ordinance to be completed and passed in the near future were the principal features of last night's meeting of the Board of Supervisors. The anti-spitting ordinance provides penalties for expectorating on the sidewalks and in other public places, and was passed only after a long fight in the board, Aylett having had very strenuous objections to it for some time. Cox and Kane also voted against it.

The building ordinance appears to be almost a building itself, and it has architects, contractors, plumbers and other practical men at work on it. The present draft of the law makes 125 pages of typewriting, so that the proposed law is a small book.

Aylett brought the matter up last night, by inquiring what had become of the ordinance. Quinn responded with a roast of the county attorney's department, which he said was holding the measure. He said the county attorney and deputies found time to attend to private practice but claim-

ed that they hadn't time to pass upon the ordinance. Deputy County Attorney Milverton replied that the ordinance was 125 pages in length and that he had gone through about a third of it and found many legal defects. He had only had it in his hands for a short time.

It is stated that there is no chance for the measure to be passed by the present board, or by the next, for some weeks. It is so long and full of details that it will require very extended consideration.

The bill for the bifurcated paving of a portion of Fort street was passed. It showed that the cost had been less than the sum appropriated.

The bill calls for 1337.5 square yards at \$3 a yard, amounting to \$4,012.50; nine lineal feet for curbing at \$1 a foot, or \$9, making a total of \$4,021.50.

For credits there were 541 3/4 cubic yards of rock furnished by the city at \$1.25, making \$677.19; use of roller, \$72, a total of \$749.19, leaving a balance due the Bitulthic Paving Company of \$3272.31. The appropriation for the work was \$4,900.

TERRIBLE MINE DISASTER IN ENGLAND

(Associated Press Cable to The Star.)

BOLTON, England, December 21.—Two hundred and ninety miners have been entombed here by an explosion and fire in a coal mine. The most strenuous efforts possible are being made to reach the buried miners, and the wildest excitement prevails. The wives, families and friends of the entombed workers, gathered at the mine in mobs which made it necessary for police to be employed to keep them off.

Bolton, which appears to have made a new and appalling record for mine disasters, is a city in Lancashire, England. It has a population of about 120,000.

REPUBLICANS DISAGREE IN LORIMER CASE

WASHINGTON, D. C., December 21.—Senator Julius C. Burrows of Michigan, chairman of the committee on privileges and elections, today presented a report exonerating Senator Lorimer of Illinois, who has been under investigation on charges of having gained his seat in the Senate by bribery of members of the Illinois legislature.

Senator Frazier, Democrat, of Tennessee, a member of the same committee, dissented, and Senator Beveridge of Indiana, Republican, did not concur but deferred expressing his opinion.

CHANGE NEW MEXICO'S BOUNDARY.

WASHINGTON, D. C., December 21.—President Taft in a message to Congress today advised the passage of a joint resolution authorizing annulment of a portion of the constitution of the new state of New Mexico, for the purpose of changing the boundary. The Senate has adopted the resolution as proposed.

REBELS IN AIRSHIP RECORD

CHIHUAHUA, December 21.—General Navarro's force is said to be surrounded by rebels and in danger of being forced to surrender.

BIG CINCINNATI FIRE.

CINCINNATI, Ohio, December 21.—A fire in the factory district here today cost two lives and caused a loss of two million dollars.

ROCKEFELLER

GIVES \$10,000,000

CHICAGO, December 21.—The announcement was made yesterday that John D. Rockefeller has completed his great gift of endowment to the University of Chicago, comprising a total of thirty-five million dollars for education in this institution.

The last installment of this gift, the details of which were completed yesterday, amounts to ten million dollars and rounds out nearly a quarter of a century of contributions by Rockefeller in behalf of the university.

One of the surprises in connection with this munificent gift is that with the legal papers setting aside this half-score of millions, the resignations of John D. Rockefeller Jr., and Frederick Gates, the personal representatives of Mr. Rockefeller on the board of trustees of the university, were also filed.

While no reason is given for this action on the part of the two Rockefeller trustees, it is presumed that it is for the purpose of notifying the university authorities that with the completion of his great gift he desires them to feel that the fund is no longer under the supervision of himself.

In making these gifts of millions of dollars to the University of Chicago it has been the idea of their donor to help deserving young men and women to a university education who otherwise would be unable to go through college.

REINFORCEMENTS TO HELP CRUSH REBELS

CITY OF MEXICO, December 21.—Determined to speedily crush out the last vestiges of rebellion against the Diaz administration in the state of Chiuhahua, the government yesterday dispatched a city battalion of infantry, a battery of light artillery with full complements of officers, men and horses on two special trains. With these reinforcements it is expected that the government troops now in the zone of revolution will quickly restore order.

LARGEST VESSEL AT THE HILO WHARF.

HILO Dec. 19.—The oil steamer Santa Rita, Captain Boyd, the largest vessel that has ever pulled alongside the local wharf, came in last Saturday afternoon, from Honolulu, bringing oil for the Hilo Railroad Co. The wharf looked very small when she was in her berth, the vessel being four hundred and thirty-five feet long, and, as one of the officers described her, being shaped a good deal like a match, very long and slim. She discharged 10,000 barrels of oil here.

The Santa Rita can carry a full cargo of 53,000 barrels of fuel oil, which would bring her down deep in the water, but was light when she arrived here, drawing only twenty feet. She is 4,000 tons register, but can carry about 7,000 tons of dead weight in her cargo. She was built on the Great Lakes with her sister ship, the Santa Maria, the two being then known as the Minnewaska and the Minnetonka. They were used for the grain trade, but were afterwards sold to the Union Oil Co., which brought them to this part of the world, where they run from Port Hartford, up and down the Pacific Coast, covering from San Diego to northern Alaska, and making occasional trips to Hawaii.

In order to get the two big vessels out of the Great Lakes a rather unusual method had to be used. They were too big to go through the locks of the St. Lawrence canal and to overcome this difficulty, they were cut in two, half of each vessel being

taken through at one time. After the locks had been passed they were put together again and brought around the Horn.

HAWAII PLANTERS IN ANNUAL MEETING.

HILO, Dec. 19.—The annual meeting of the Sugar Planters' Association of the island of Hawaii was held last Thursday in this city, a large number of the managers from all over the island being present. The following officers were elected for the ensuing year: C. C. Kennedy, president; John A. Scott, vice-president; John Watt, treasurer; William Pullar, secretary. Numerous matters in regard to work on the plantations were talked over and U. S. Commissioner of Labor Keefe was present for a time, talking over labor conditions with the members of the Association.

NAVY HEALTH GOOD

The health of the American navy was better during 1909 than in any other yearly period of the last decade, and the death rate was the lowest ever recorded for that arm of the fighting service. These gratifying facts are announced in the annual report of Surgeon General Stokes, and are attributed largely to the increasing recognition of the preventive, as well as the curative, functions of the medical department.

The record death rate was five per 1,000. The percentage of sick from disease and injuries during 1909 was 4.619, as compared with a ten-year average of 5.218. From disease alone in 1909 the percentage was 3.952, which is lower than any year since the Spanish-American war.

Require Ability to Swim.
Ability to swim well, in the opinion of the surgeon general, should be insisted upon by naval authorities as a prerequisite of officers and enlisted men upon their entry into the Navy or Marine Corps. This requirement he says, would contribute to the saving of a considerable number of lives. The present annual physical test for naval officers, consisting of walking or riding a prescribed number of miles within a time limit, according to the consensus of opinion of medical officers, the surgeon general says, has utterly failed to accomplish the design to encourage regular daily exercise, very few having derived any real benefits, while considerable tangible harm has resulted. Dr. Stokes recommends that more recreative and continuous exercise be substituted, and for the younger personnel of the navy he urges the adoption of the Swedish system of physical training which is followed in the British service.

In view of the high rate of typhoid fever in the navy, the surgeon general recommends that the entire personnel under fifty years of age be vaccinated against that disease.

The establishment of a medical reserve corps which would be available in a national emergency is urged by the report and the construction of two more hospital ships is requested. The surgeon general also urges the adoption of the bubbling-spring device for drinking fountains throughout the entire service, ashore as well as afloat.

FOR CONSTITUTIONAL STABILITY.

It is to be hoped that the Chamber of Commerce will have a full attendance and give a unanimous vote against all irresponsible tinkering of the Organic Act. This is the constitution of the Territory, its fundamental law, and must not be treated like a parish code of rules and regulations. Constitutional law must be stable, or there will be an end of the security of government. The strong barricades erected by the fathers of the country against changes in the fundamental law of the nation by the breath of ephemeral popular caprice, or by sudden movements of selfish interests planned in secret, have been imitated by the states of the Union. If a temporary majority in Congress, or in a state legislature, could alter the national constitution or a state constitution in a day, conditions akin to revolutionary would be liable constantly to prevail either throughout the nation or among its component states.

Hawaii was adequately represented in the commission that framed its constitution, and in its deliberations that body gave public hearings at which every local interest and shade of opinion was respectfully consulted. The resultant draft of constitution for the Territory of Hawaii was carefully deliberated over and amended by Congress, and the final shape in which it was approved by the President should have been established against any changes that had not been as carefully, publicly and solemnly brought about as had been the original document.

Yet it was not long before a Chicago corporation having a pull in Congress managed, through a sneak movement, to procure an amendment of the Hawaiian constitution for its own expected advantage in a lawsuit the corporation had pending in the Territorial courts. So quietly was the thing accomplished that the first intimation Hawaii received of the amendment was through a cablegram to the corporation's counsel in Honolulu. This was nothing short of an outrage. The provision so clandestinely amended, by a rider to an appropriation bill, had been one of those to which the framers of the Organic Act, as well as Congress, had given most careful consideration. By the amendment, moreover, the poor litigant is placed at a crushing disadvantage with his rich antagonist at law.

That the warning received in the case just mentioned has not been altogether in vain is evident in the present community alarm over the attempt being made to railroad through Congress the McCrosson private measures involving amendments of Organic Act provisions that have only recently been amended upon a basis first adopted by the Legislature of Hawaii. The business organizations of the Territory, the entire body politic in fact so far as it yet has opportunity of expression, ought to give no uncertain voice at Washington in denouncing any such attempt to subordinate public to private interests.

C. B. Fillebrown of Boston is devoting a part of his fortune to the single tax propaganda. He has lately issued for free distribution at a cost of \$10,000, an epitome of his book, "The A, B, C of Taxation." This he is sending to members of Congress, of the Massachusetts Legislature and the Boston Chamber of Commerce, as well as to business men and others. Hawaii has been in need of tax reform since the beginning of civilized government here. Many, at various times, have essayed to improve our tax laws, but the only result seen today is of crazy quilt pattern. In the meantime the single tax, to a more or less modified extent, is making headway by success in different parts of the Union. Our legislators ought to send for Mr. Fillebrown's little book. Its study at any rate will not hurt them.

"Did the members" (of the Republican territorial committee) "appreciate the fact that no state legislature ever attempts to handle bills intended for Congress and would be simply swamped if they did?" the morning oracle inquires. The query is altogether inept and irrelevant. Congress is the supreme legislative authority for the territories, while it has absolutely no jurisdiction over local affairs of the states not specifically reserved by the constitution. There are places in the Organic Act where either the Congress or the Legislature may legislate on a given subject. All charters conferring exclusive rights granted by the Legislature must be approved by Act of Congress to become valid.

The movement for children's playgrounds should be steadfastly promoted until the end is gained. There was a public lecture on the subject more than a year ago, by Dr. Hand, the physical director of the Y. M. C. A., but no action followed. Mainland cities are spending much money on children's playgrounds. San Francisco has a fine example of a modern children's playground, as an illustrated page in a late issue of the Chronicle shows. It is equipped with apparatus for open-air athletic exercises, besides requisite conveniences for sports and games.

According to the morning cable the Mexican rebellion is in for another suppression before dark. Mexico ought soon to have the best army for its size in the world, with daily shooting practice at live targets.

that the Hilonian sailed on the 19th inst.

Steamers from the islands report exceptionally fine weather, which promises well for the Christmas and New Year holidays. The Claudine had fine weather throughout her last trip to Maui and Hawaii and the W. G. Hall reports fine weather and smooth sea the whole way.

The British collier Heliopolis, now discharging coal at the naval wharf, is expected to be through about the end of the month. No orders as to her next designation have yet been received by the agents.

The Pacific Mail steamer Mongolia is expected to arrive in port at two o'clock Friday afternoon, according to a wireless message received last night. The conditions were against wirelessing and this was all the news that could be received from the Mongolia. If the Mongolia arrives in on Friday afternoon, she will be despatched for the Coast on Saturday morning.

The Canadian-Australian steamer Zealandia, which is now en route to Sydney, passed through Suva on the 19th inst. and is expected to reach the Australian port on Saturday next. She will be in Brisbane in time for Sydney mails to be sent overland and reach their destination before Christmas.

BY AUTHORITY

ORDINANCE NO. 20.

AN ORDINANCE RELATING TO EXPECTORATION IN THE CITY AND COUNTY OF HONOLULU. Be It Ordained By The People Of The City And County Of Honolulu:

SECTION 1. No person shall expectorate upon any sidewalk, or upon the floor or any part of any street car, railroad car or other public conveyance, or upon the floor or any part of any public building or any building common to the use of the public, within the City and County of Honolulu.

SECTION 2. Any person violating any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine of not less than One Dollar (\$1.00), nor more than Ten Dollars (\$10.00).

SECTION 3. This Ordinance shall take effect fifteen days from and after the date of its approval.

SUGAR MEN MUST TESTIFY IN EAST

SAN FRANCISCO, December 9.—Deputy United States Marshal B. F. Towle yesterday served copies of the complaint and subpoenas in the Sugar Trust case to be tried in the United States Circuit Court for the Southern district of New York next month. This is an action brought by the government alleging the existence of an unlawful trust and combination in restraint of trade.

The following defendants residing in this district were served: John D. Spreckels, individually and as president of the Western Sugar Refinery, California Sugar Refinery and Spreckels' Sugar Company; Adolph B. Spreckels, Alexander T. Morrison, William H. Hannan, J. D. Spreckels Jr., Alameda Sugar Company, Union Sugar Company, John L. Howard, individually and as president of the two last named companies.

These defendants are ordered to appear before the Federal Court in New York city and answer to the complaint against them on the first Monday in January.

WALDRON'S REPORT

(Continued from Page One.)

Banquet by Shanghai Chamber of Commerce at Chang Su Ho's Garden; Reception by the International Institute;

Dinner by the Chinese Press of Shanghai;

Trip by house boat to Kashing, thence by train to Hanschow, thence by sedan chairs to Westlake;

Banquet given by the Governor of Chekiang province at Yamen of the Commissioner of Foreign Affairs at Hanschow;

Witness the Hangchow "Bore"—a monthly tidal phenomenon—although having a much greater volume of water in the Fall months;

Entertainment at Kashing, Fengtien and Suchong stations on the return trip to Shanghai;

Reception by the Imperial Polytechnic School;

Theater party—to see the opium play, a composition designed to impress upon the people the evils of the opium habit.

The commission was much surprised and very favorably impressed with the excellent railway service of the Shanghai-Nanking Railway. The cars are up-to-date and the road well ballasted. Our visit to Nanking was most interesting from many standpoints. It was our first real sight of rural inland China, although with the immense mileage of natural and artificial canals one never appears to be very far inland. Nanking is one of the oldest cities in China and was formerly the capital.

Approaching by the train, the walls of the city look very formidable, but upon our entering the city at night the sight which greeted us made it very hard to believe other than that we were approaching a great exposition in a modern city. Of course, this applies only to the exposition ground, the numberless building all of which were brilliantly lighted by thousands of electric lights—making a veritable fairy land.

The Nanyang Industrial Exposition is the first exhibition ever held in China, and marks a great step in the forward movement of the empire. The buildings were of modern architecture, well arranged, and the exhibits from all the different provinces of China, besides a great many foreign exhibits, were very creditable.

Notable among the many entertainments at Nanking was the banquet given us by the Viceroy, and I must not forget the reception tendered the ladies of the party by the wife of the Viceroy, Lady Chang, who not only speaks excellent English, but is in every way thoroughly accomplished.

Arriving at Hankow with the usual comment as to first impression "that we were in the Chicago of China;" four days were spent in Hankow, which was all too little for so much of interest. From a commercial view, the Hanyang Iron and Steel Works is the most important enterprise. The ore is supplied from the Tah Yeh mine, and the view from the outside of the immense plant, or watching the molten metal and the steel rails being made in the interior, reminds one more of Pittsburgh than anything one would expect to see in China.

Captain Dollar has recently contracted for a yearly supply of pig-iron running into several thousand tons, which he will transport to the Pacific coast, and it is probable that Hawaii will derive most of her future supplies from the same source, as the iron has met with particular favor from the foundries.

At Wuchang, across the river from Hankow, we visited the Boone University conducted by the missionaries on the principles of military school. We were privileged to see the students in their neat and attractive uniforms give a drill exhibition, in connection with which they have an excellent band.

Banquets by the Viceroy of Hupeh at his palace in Wuchang and by the Hankow Chamber of Commerce at the Chinese Race Club were events too elaborate not to mention at this time. At the Chamber of Commerce banquet each member of the party was presented with a solid gold badge, in a horse-shoe design, with the United States and Chinese flags crossed. The names of the ladies in full and the initials of the gentlemen were engraved on the bar of each badge.

It was at Hankow that we were brought into close contact with the work of the Missionaries, and I must confess that my opinion took a decided change from my former unfavorable ideas, to a great appreciation of the work that these people are doing in China. The biblical teaching of these missionaries is by far the smallest feature of their work, their time being taken up with the practical educa-

tion of the Chinese students, who will in turn become valuable teachers of modern methods and of what the Chinese are most in need of—system.

To turn the tide of thought of the stupendous population of more than four hundred millions is a task that most of us ordinary mortals would shirk, but these missionaries are not only starting, but will finally succeed, in making the average Chinaman a man to be envied.

The principal entertainments at Peking included a visit to the Great Wall of China, one of the seven wonders of the world. No doubt you are all familiar with its appearance from the various illustrations you have seen. The wall averages twenty-five feet in height, about eight feet wide on top, and is fifteen hundred miles long. It is a wonderful state of preservation, a large portion of the wall being in perfect condition, notwithstanding that it was built 2300 years ago.

Visits were made to the Summer and Winter Palaces, and also the Summer Palace of the late Empress Dowager, each of which contains a wonderful collection of antiques in marble, jade, wood, porcelain and cloisonne.

The party was also honored by the Prince Regent's graciously giving an audience to the Commissioners at the Palace in the Forbidden City, at which time we were accompanied by United States Minister Cathoun.

After the audience a grand banquet was given at the Foreign Office. From Foochow we went to Amoy, in the vicinity of which I noticed small areas of sugar cane. At the present time they have no modern mills, but I was informed that the Japanese were figuring on putting in a plant.

At each place visited there was an allotted time insisted upon for us to talk over business conditions and prospects of trade between the two countries. It was generally conceded that the Americans had not gone after the business as had other nationalities, particularly the Germans and later on, the Japanese. This was more or less explained from the fact that the Americans have met with such prosperity at home that it was not necessary for them to compete against lower priced labor of foreign countries. In my opinion, under present conditions, the balance of trade between the two countries will be much in favor of China.

It is my firm belief that the Chinese value the friendship of the Americans more than that of any other nation on earth. They missed no opportunity of expressing their appreciation of the action of the United States in returning to them the Boxer indemnity. Against this expression of good will they believe the United States has done them grave injustice in shutting them out from the Philippine Islands. For the past four hundred years the Chinese from Am-

CALIFORNIA TO MEET VICTORIA

BERKELEY, Dec. 6.—With the University of California Rugby team bring both the Keith cup from Victoria this Christmas and with it the coast championship, or will the blue and gold team, which will make the trip, meet its Waterloo at the hands of the sturdy ruggers of the north?

California is sending a strong team north this Christmas, and the Rugby world is waiting to see whether this team, which all critics agree is the greatest playing machine that has been developed in the United States since the inception of the new game, will wrest the laurels from the Canadians.

The team expects to go on the field in the best possible condition.

Of the men who played in the big game of November 12, only two, Pauly and Swartz, are unavailable for the trip. A number of other scrum men have not as yet definitely decided to make the trip, but they will probably fall into line before the sailing date.

BLAMES FARMER FOR HIGH COST OF LIVING.

NEW YORK, December 10.—The high cost of living is put squarely up to the farmers by Sir Horace Plunket, president of the Irish Agricultural Society and originator of the co-operative dairies movement in Ireland, who is in New York for a two months' vacation.

"I believe that the increased cost of living has been caused primarily by the failure of farmers to organize and do their own distributing," he told his interviewers on his arrival. "They are beginning to realize that their inaction perhaps has been more the cause of the higher cost of living than the monopoly of industries by the trusts."

"The co-operative dairies movement

in Ireland is highly successful. There are 990 co-operative associations, with a membership of about 90,000 producers, and their business during the last year has amounted to approximately \$15,000,000."

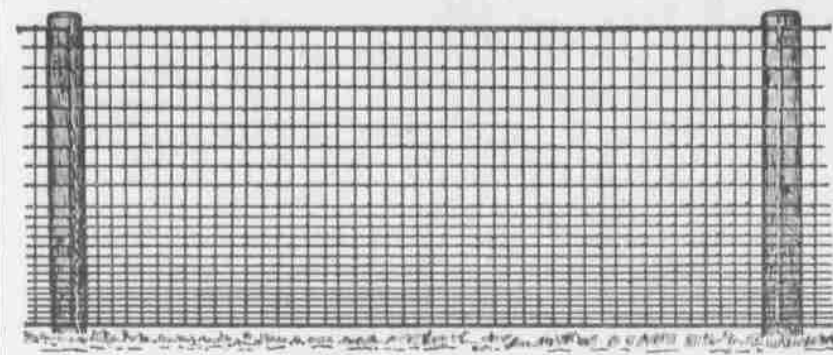

DOVES BEING EXTERMINATED

Fearing that doves will be exterminated unless a law is passed to protect them, W. H. Charlock has taken the matter up and will have a bill introduced before the next legislature to prevent indiscriminate shooting of these pretty birds. A petition has been circulated and signed as follows:

"To the Senate and House of Representatives, Territory of Hawaii:

"We, the undersigned licensed sportsmen of the City and County of Honolulu, respectfully petition your honorable bodies to close the shooting season on doves for the Island of Oahu till August 1, 1913.—W. Lane, R. H. Rycroft, S. W. Spencer, James W. Harvey, Clifford E. White, C. Ming, Robert B. Booth, James E. Jaeger, L. M. Vetlesen, W. H. Charlock, W. E. Wall, J. Schley, E. I. Spalding, Charles H. Hustace, E. A. McInerney, Henry Freitas, Henry D. Gilles, Edw. W. Paris, John B. Enos, George W. Macy, J. L. Fleming, K. Ono, John B. Williams, C. M. Tai, E. Swan, A. M. Alexander by John Waterhouse, H. F. Beltemann, D. L. Austin, K. B. Porter, M. S. Hamman, A. K. Lucas, G. E. Smithies, Clinton Gowan, W. M. Vincent and Tam Hing."

REPUBLICANS WANT LOCAL DISCUSSIONS

The Republican Territorial committee last night passed a resolution along the same lines as that put forward by the chamber of commerce. The resolution is as follows:

"Whereas, There are reported to be several bills pending before congress vitally affecting the interests of the people of this Territory, and

"Whereas, One of these bills is in direct opposition to a plank in the platform adopted by the Republican Party of the Territory of Hawaii, in convention assembled on the 12th day of September, 1910, to wit: The Republican Party regards the plebiscite as a conclusive expression of the sentiment of the people of this Territory in favor of the present liquor law and of its enforcement in good faith. We therefore pledge our representatives in the legislature against any change or modification of that law, and demand its faithful, impartial and vigorous enforcement, and pledge them to make the necessary appropriations to carry out the law," now, therefore, be it

"Resolved, That the Republican party of Hawaii deprecates the practice of submitting to Congress measures affecting the local affairs of Hawaii, which have not first received the approval of the people of this Territory, and

"Resolved, That the Congress of the United States be and hereby is respectfully petitioned not to pass any such bills unless first approved by the people of Hawaii through their Legislature, and

"Resolved, That copies of this resolution be sent to the President of the United States; the Secretary of the Interior, the President of the Senate, the Speaker of the House of Representatives, the Chairman of the Committee of Territories of the Senate and of the House of Representatives, and to our delegate to Congress."

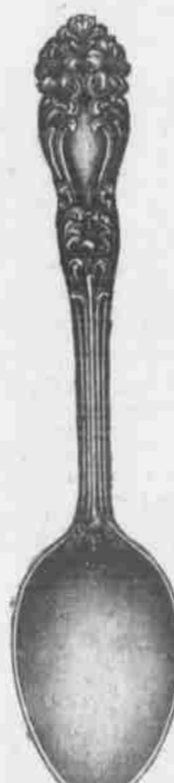

ROOSEVELT AT LUNCHEON WHERE HIS FUTURE WAS DISCUSSED

(Correspondence Philadelphia Public Ledger.)

NEW YORK, Dec. 5.—Colonel Roosevelt met at an informal luncheon a day or two ago a small company—probably six or seven men—all of whom are interested in one way or another in politics; and, of course, all were, and even now are, on most friendly terms with Roosevelt. His brother-in-law, Douglas Robinson, was one of the party, as was his editorial associate, Lawrence Abbott. The editor of one of the newspapers of Kansas City also sat at the table, and at Colonel Roosevelt's right hand sat President Van Hise, of the University of Wisconsin. In addition there were two or three men prominent in educational and in philanthropic work. At this luncheon some things were said which may furnish the first clue given since election, if not to the purpose of Colonel Roosevelt, at least to that entertained by his more intimate friends. The Colonel himself has been of incessant activity, though very quiet, since election. He has been receiving information from those in whom he has confidence. It has been his desire to analyze the influence which led to the Democratic triumph so that he may be better able to guide his conduct. Colonel Roosevelt has no illusions respecting the personal meaning of the recent election. He is reported by those who have talked with him and who have high regard for his very shrewd political judgment and political ability to have said that if there be a great impairment of prestige of a party leader, that is usually a permanent impairment. It has rarely happened in our history that a great leader who has lost his prestige has ever regained it with his party.

It was, of course, regarded as of some significance that the guest of honor at this luncheon should have been the president of the University of Wisconsin, Doctor Van Hise. His relations with Senator LaFollette are intimate. The common opinion here has been that it is through the favor and confidence of Senator LaFollette that President Van Hise received appointment to the executive chair of the University of Wisconsin, although his own brilliant career, especially in the field of geology, would fully have justified his selection to the presidency of the university. Wisconsin University's president is, if common understanding be correct, quite as radical in his political views as is Senator LaFollette. It was plainly the conviction of President Van Hise that Colonel Roosevelt should remain active in politics, being careful, however not to identify himself with the conservative element of the Republican party. It seemed almost as if he had brought a message from LaFollette, and one which had the presidency of 1912 in view.

There was a general exchange of opinion. Some went so far as to say to Roosevelt that had he been the candidate for governor of New York, he would have triumphed by 200,000

plurality, and the Democracy would have lost the legislature and therefore the United States senatorship. Others voiced the opinion that had Colonel Roosevelt been a candidate this fall there would have been no Democratic triumph throughout the city. Some ventured to suggest that he should seriously consider whether or not he should put himself in the position of the Republican insurgents hoping by this action he would be able to attract a small portion of the so-called radical element of the Democratic party. These things were said bluntly, plainly and earnestly to the ex-President.

ANOTHER OPINION.

Colonel Roosevelt then turned to some who were present, but who had not spoken, and asked them if they were also of the opinion which they had just heard. He seemed earnestly to desire a sincere opinion from these men who had been silent. At last one of them said, in effect: "Colonel Roosevelt, I should prefer to say nothing. This meeting has taken the place of a political conference. Instead of a friendly luncheon party. Since you ask me for my view I will tell you that I am persuaded that all you have heard said is inaccurate. In my opinion you could not have been elected had you run for Governor of New York. In my opinion you will do well to weigh very carefully words that are spoken in compliment to you. For I tell you that I am now brought into very intimate association with many educational, philanthropic and professional people, people who are of much intelligence and of high character, and I am compelled to say to you that with these people you have lost ground."

Of course this statement which illustrates the saying, "Faithful are the wounds of friends," caused much dissent. In fact, there were intimations that the speaker spoke from the point of view of the so-called "interests," and that his judgment was not impartial, since it was due to association with men or corporations of great wealth. His only reply was that of course he could not make any answer to accusations of that kind. Colonel Roosevelt himself said nothing but it was impossible to judge whether or not he had received this statement in a friendly spirit.

THE NEW CAMPAIGN.

This incident, together with others, has persuaded many Republicans that it is now the firm purpose of the leaders of the insurgent element to take strong issue against President Taft and his administration, not necessarily to the point of splitting the Republican party, but with a view of placing Colonel Roosevelt in nomination for the Presidency in 1912.

The intimation to him was very broad, almost as clear as outspoken words would have been, that the more prominent of the insurgent leaders are determined to name Roosevelt for President in 1912. He made no answer to it, at least of a kind which would tend to show that he is favor-

ably impressed. His whole attitude was that of a man seeking information.

THE TAFT POINT OF VIEW.

On the other hand, some of the friends of President Taft in this city assert that the report is correct that President Taft has been told the time has come for him either to accept or give battle. He moves slowly, with judicial deliberation. He has some very strong political friends. The common impression in this city is that he will find one of the wisest and staunchest supporters in Ellhu Root. New York has not yet recovered from the astonishment which the campaign speech of Mr. Root a few days before election occasioned. And that is due to the fact that this speech could be interpreted as sincerely friendly to Mr. Roosevelt, or as something entirely different. It was the oracular quality of a portion of his speech which caused suspicion, or at least wonder.

There are some reasons for surmising that both of the Republican senators from New York are wondering whether a permanent split in the Republican party has not come.

One fact has been made very clear, and that is that the animosity displayed toward President Taft by some of those who are insurgents is so deep that it is certain to be abiding. Whether he has the greater gift of politics, that of marshaling men to his support, remains to be determined. Underneath all of the comment, much of which is superficial, there lurks a suspicion that the election of 1910 points to the inevitable success of the Democratic party in 1912, and in all probability with Judson Harmon, of Ohio, as the Democratic candidate for President.

AT THE THEATERS

Honolulu theater-goers had another "first-night" last evening, and they took full advantage of it for at an early hour, it was impossible to find even standing room at the remodelled Empire Theater. This house was successfully reopened last night under the management of J. T. Scully, and an excellent program was submitted. All the theaters are playing to crowded houses, everywhere it is the same. Good programs are being submitted, and it is certain that as long as the present high standard is maintained, there will be no diminution in the sizes of the audiences.

EMPIRE RE-OPENED.

The remodelled Empire was opened last evening under the management of J. T. Scully, and it can be said at once that the new company was a thorough success. There was an overflowing audience, who bestowed well-merited applause on every item put on. The hit of the evening was undoubtedly gained by the Gladstone Sistrars. Their voices are out of the common dancers' voices rarely baffle feats, however, are their specialties, but they sing pleasingly, and they dress well. Their dancing and acrobatic feats, however, are their specialties, and for these they were encored several times; in fact the audience was loth to let them go, and long after a

picture had been projected on the screen, the applause continued. The Bartelli Brothers are excellent musicians, who play what appear at first glance to be a mandolin and a guitar. The latter, however, looks more like a harp. They produce sweet music on these instruments, but unfortunately they chose pieces that were far too long, and the audience became tired of the numerous repetition, and in order to mark its disapproval, began to applaud. After several rounds of applause, the hint was taken, and the musicians, who were picturesquely garbed in nondescript costumes, departed, only to return and commit the same error. This, however, can be remedied, and then the Bartelli Brothers will be favorites, for they are undoubtedly clever players. Edna Randall sang Tosti's "Goodbye" and "Just a Song at Twilight." These, however, were too ambitious for her voice, and she would be well-advised to confine her efforts to something lighter, at which she would be sure to be more successful. All the same it must be admitted that she proved popular with the majority of the audience, for she was loudly applauded for both songs. Her voice though is not equal to Tosti's "Goodbye." The Great Snook talked a lot and did a few tricks, all of which were of the Davenport Brothers type. He is tied securely to a chair by a committee of four from the audience, and having been placed in a cabinet he performs all sort of tricks, such as strumming on tamborines and

ringing bells, and then passing these instruments out of the cabinet. At the conclusion of this demonstration the curtain is drawn aside, and he is shown to be just as securely tied as when he entered the cabinet. He performs other feats along these lines, and his turn went well, although the audience seemed to tire somewhat of his long explanations. A member of the committee who apparently rejoiced in the title of "Peanut" played no inconsiderable part in the performance, especially when he was arrayed in the Great Snook's dress coat, which surmounted a pair of light trousers and tan shoes.

The remodelling of the Empire has been along lines that are a thorough improvement on the previous condition of this theater, but as a full description of the alterations have appeared in these columns, there is no need for recapitulation at this time. The orchestra, under the baton of Harry Wells, was an efficient one, and supplied the incidental music.

THE BIJOU.

Counter attractions seem to have no effect upon the attendance at the new Bijou theater. Last night both performances drew almost capacity houses and the same enthusiasm which marked the opening of the popular house was in evidence. The vaudeville bill this week is splendid and the motion picture reels at the best as yet seen at the new playhouse.

Dunn and Branton are doing a particularly clever turn and Walter Perry is hitting them just right with his funny stories and parodies. Gladys Middleton's songs are instantaneous hits and her pretty gowns add zest to her act. "Two Awful Dads," the after piece in which the members of the American Musical comedy appear, is one of the best bits of comedy the company has done. Tomorrow night a complete change of bill will be offered and on Friday "amateur night" will be repeated. Next week a new lot of faces will be seen on the Bijou stage. Several artists from the mainland will arrive on the Wilhelmina.

THE PARK EXCELLENT.

True to tradition Manager Congdon is giving an excellent show at the Park, for the program that is submitted is a well-balanced one, and is good in every way. Morris and Wilson have changed over to "Fun in a Chinese Laundry," and it is fun too. Wilson is seen lying on the table of the laundry when the curtain is raised, and from that moment the fun begins. Morris immediately enters, and the two of them lose no time in producing a series of laughter, which is freely punctuated by rounds of hearty applause for the clever acrobatic business. This is an excellent turn, and will no doubt prove just as popular as their opening piece, "Hostler Joe."

HUMAN LIVES IN MONEY VALUE

SACRAMENTO, December 12.—The commercial value of babies is made the topic of an article in the bulletin of the State Board of Health issued today. Among other things, the article contains an estimate which shows that the average cost of the upbringing of a baby from birth to twenty years is \$4150, and his average commercial value at that time is \$4000. These figures are based on the net earning capacity of the average citizen, for all the gainful occupations in California as reported in the State Labor Commissioner's report for 1908 and 1909, capitalized at 6 per cent interest.

As an investment it is estimated that by the age of 30 the average man in worth \$16,000—\$4000 value plus \$12,000 gross earnings—and has cost \$10,150 for growth and maintenance, or a net gain of \$5850 in thirty years.

The average value for all citizens of the United States was reported by the National Conservation Commission to be \$2900. Upon this basis the labor element in our professional and industrial activities in the State represent \$6,895,000,000, or approximately twice the total value of all other sources of our wealth. Upon this basis the article shows that the State is losing through preventable and postponable deaths, expenditures for illness and the like, probably \$100,000,000.

NATION EMPLOYS 60,000 FARMERS

In the South today there are 60,000 demonstration farms backed by the Government to show the "poor whites" how to farm. As soon as these farmers are shown that their land will grow crops they are willing to try.

When an individual cannot be persuaded to farm as he is advised, he must be hired to do so. He himself must grow a garden about his house, raise chickens, feed some hogs, cultivate crops under instructions. He must himself perform the miracle.

The Government selects one farmer in a neighborhood.

This one man becomes the demonstrator under the direction of the De-

partment of Agriculture. He has been selected in the first place because of suspected latent possibilities. After the first year he follows instructions eagerly and works ceaselessly. His neighbors have seen success, and it has impressed them deeply, for he is in no way different from them.

This year his fence bears a placard which announces that his is a demonstration farm of the government. He receives bulletins through the mail. He has been selected from among them all, and feels proud of himself.

Under the circumstances he feels that there should be no weeds in his

fence corners, his horse should have better harness, his house a coat of whitewash.

With the ripening of the second crop comes the local agent of the department. The farmers of the neighborhood are called to meet at the demonstration farm, and are schooled in the manner in which the remarkable crop was grown. They are told in detail how to go and do likewise. They buy seed from the demonstration farm and are advised by the local agent.

The following year half of the farms in the neighborhood are producing

these same increased crops, and usually in five years the whole community is at it.

METHODIST CHURCH GAINS 63,000 MEMBERS IN YEAR.

CHICAGO, December 12.—The entire membership of the Methodist Episcopal church increased 63,047 last year, according to a statement made today to the Chicago Methodist Ministerial Association by Rev. David G. Downey, corresponding secretary of the board of Sunday-schools. The secretary further surprised his hearers by saying: "We have ceased to

expect accessions from the regular church and Sunday-school meetings. We find that we can increase our membership only by occasional spectacular and sporadic meetings."

SUBSIDY BILL IN SENATE.

WASHINGTON, December 12.—The ocean mail bounty bill came up as the unfinished business in the Senate today, but the Senate laid it aside temporarily. This of course was taken on motion of Senator Gallinger to accommodate other business and does not mean that the bill will not be pressed later.

TEN INCHES OF SNOW IN A BIG CITY

PHILADELPHIA, December 7.—Snow ceased falling at 10 o'clock last night, with the prospect that there would be a resumption of the storm today. Up to 8 p. m. the snowfall in this city for the 23 hours, during which the snow had continued, amounted to 10 1/4 inches.

On the level, however, the snow was found to be only 8 inches deep, owing to the character of the fall at the beginning of the storm, which generally was wet. In the early hours of the morning, the northeast wind, blowing at the rate of 23 miles-an hour, piled the snow high in drifts in exposed parts of the city, and caused some walks to be entirely denuded of the white pall.

At times during the day the storm reached the dimensions of a small blizzard, and had the effect of keeping from the streets all but those whose business obliged them to go out. There was a high wind practically all day long, increasing in violence and keenness in the central part of the city, where the tall buildings appeared to give it special strength.

Owing to the violence of the storm and the deepness of the snow in various parts of the country, some of the Philadelphia bound trains were from two to five hours overdue when they arrived here. It was reported that the drifts in some places were many feet in depth, but the general train service was regarded as good under the circumstances.

Profiting by their experience last Christmas, when practically every line of street cars in the city was tied up by the storm, the Rapid Transit Company, with this vision before them, took care not to let the storm get the better of their efforts. All night on Monday the company kept sweepers and plows at work, and every line was open all through the storm. There were the usual blocks, caused by falling horses or stalled wagons in the tracks, and necessarily the service was not so good as on normal days.

Early in the day the city took occasion to begin the removal of the snow

from the principal streets in the central part of the city. At daylight over 100 teams and a small army of laborers were set to work by Edwin S. Vare, contractor, under the supervision of Chief John Virdin, of the Street cleaning Bureau, and the deep snow in the main thoroughfares was attacked with so good a will that before nightfall little snow was left on the streets. By noon it was said 500 teams were in service on Chestnut, Arch, Market and Walnut streets, where the snow was shoveled into the wagons and drawn to the nearest sewer manhole, where the load was dumped. This made quick work of the snow, which, however, continued to fall with ever-increasing violence although there were cessations from time to time. Yet the streets were in a passable condition for teams and motor cars.

At the local Weather Bureau last night it was said that snow would continue to fall all night, and that the weather today would be unsettled and cold. The intensity of the storm has added but little to the precipitation of the first hour's fall.

BRICKLAYERS TO DEMAND AN INCREASE IN PAY.

NEW YORK, December 12.—Ten thousand union bricklayers in New York will demand an increase of wages to 75 cents an hour beginning January 1st, when their agreement with the Builders' Association expires. The associations will refuse the demand, which will then go to a trade arbitration board for adjustment. The bricklayers now receive 70 cents an hour, with double wages for overtime and work on Sundays and holidays.

POLITICAL PRISONERS FLOGGED IN SIBERIA.

ST. PETERSBURG, December 12.—Opposition parties in the Douma have united in addressing an interpellation to the Ministers of the Interior and Justice regarding the reported flogging of political prisoners in Siberia. It is charged that the Government is taking a brutal revenge on its political opponents and by so doing is disgracing Russia.

It is reported that Sasonoff, the assassin of Von Plehve, died in Serantui prison as a result of flogging or of self inflicted injuries.

M. Kokovsoff, Minister of Finance, has informed the budget committee that the revenues of 1910 are \$100,000,000 in excess of those of 1909, but that income tax legislation will not be abandoned.
