## A P. G. PROBLEM.

### How To Evade a Treaty Clause.

The *Advertiser* has finally come to the conclusion that the franchise must be granted to the Japanese residents in Hawaii, but the reasoning of the morning organ is certainly not sound nor just. It uses the *argumentum ad hominem* that, if we don't grant the franchise, we will be whipped because the Japanese government is backed "by more guns and men" than is Hawaii. The *Advertiser* asserts that "it is very questionable whether the claim is well founded," although it admits that "the convention between Hawaii and Japan contains something like a favored nation clause. We do not know how the editor of the *Advertiser* reads English and interprets treaty clauses, but we cannot see how anybody can misunderstand Article II in the Japan-Hawaii Treaty or only see something like a "favored nation clause in it." The article reads:

The subjects of each of the two high contracting parties, respectively, shall have the liberty freely and securely to come with their ships and cargoes, to all places, ports and rivers in the territories of the other, where trade with other nations is permitted; they may remain and reside in any such ports; and places respectively, and hire and occupy houses and warehouses, and may trade in all kinds of produce, manufactures and merchandise of lawful commerce, enjoying at all times the SAME PRIVILEGES as may have been, or may hereafter be granted to citizens or subjects of any other nation, paying at all times such duties and taxes as may be exacted from the citizens or subjects of other nations doing business or residing within in the territories of each of the high contracting parties.

And in connection herewith we will ask all the editors of the *Advertiser* to read Article IV of the same treaty which says:

It is hereby stipulated that the Hawaiian Government and its subjects upon like terms and conditions, will be allowed free and equal participation in all privileges, immunities, and advantages that may have been or hereafter be granted by His Majesty the Tenno of Japan to the government citizens or subjects of any other nation.

We fail to see that the Japanese are not entitled under the above named articles to the franchise as well as to all other privileges of the citizens of the "most favored nations in" Hawaii. We cannot agree with the *Advertiser*—presumably representing the P. G.—that the right of the Japanese is only backed by guns and men, and not by law and justice. If it was not that law and justice demands, we should not for a moment advocate—as we always have—the granting of the franchise to the Japanese residing in Hawaii and otherwise qualified. But we must say that if the government sentiments are represented by the *Advertiser*, it is indeed in a pitiful condition. Bulldozed by the American (?) League (even in advocating Sunday concerts); fearing Japanese guns and men, and trembling for Chinese boycott, and uprisings the men who led the country into its present sad plight have good reasons to say "Save us, save us from our own revolutions, they work like a boomerang." If any hope exists in the mind of the P. G. that the Japanese government will not press the claim for a franchise, let them study the political situation in Japan as it is today. The general election has just taken place. The Radicals secured 120 seats while the combined six parties that support the present government count on 132. One of the

principal planks in the platform of the Radicals is the "Strict Enforcement of the Treaties," which not alone has reference to the foreigners residing in Japan, but also to Japanese residing abroad. It is hardly possible for the Japanese government to hold the six small parties together against the Radicals and the method that will likely be adopted is to make the "Defenses of Japan" and the "Strict Enforcement of Treaties" the two principal measures of the government which, if adopted—as they undoubtedly will be—will possibly secure the present administration in power. The victory of the Radicals in Japan means measures of education and enlightenment and it means that the Japanese in Hawaii will be encouraged to insist in receiving what according to the treaty, is due them. Here is now an occasion for the coming convention in Honolulu to show its wisdom, statesmanship and general common sense.

## ALL IN LINE.

Agitation Amongst Asiatics.

While the question of a franchise for the Japanese has been foremost in the minds of our politicians, the Chinese have not been idle. There is no treaty between China and Hawaii, but the Chinese residents here who pay nearly one fourth of all the revenue of the country feel that they must protect their interests, and have a right to be heard in the Councils of the land. The precipitation with which the P. G. dropped the obnoxious license act has shown the Chinese that they have sufficient power to dictate to the government, and they are determined to have their rights. This movement has been anticipated for some time which can be seen from the following remarks that appeared in the *San Francisco News Letter* of March 10th. It says:

A menace which, according to the latest devices, has appeared itself is the restfulness of the Chinese on the Islands. These shrewd heathen, knowing that they control a very great proportion of the business of the Islands, and that in numbers they are strong, have heretofore lain dormant and have hardly been taken into account. We may be sure that if they had believed that the Islands would be annexed to the United States, they would have been heard from long ago. But now that they have seen the curtain rung down on that farce, and are observing the self-aggrandizing movements of the Provisional Government, they are meeting together to discuss their interests, and are talking alarmingly about certain ironclads which fly the yellow dragon. Why should they not vote under the proposed constitution, and why, as they are taxed, should not as many of their number as they can elect into office assist in the conduct of the government? And if Chinese war ships are required to enforce their rights, we may be sure that the Emperor of China will not be slow in sending them. The Provisional Government cannot be in a happy frame of mind over these unexpected and annoying developments.

The agitation among the Chinese is now carried on in a manner which only Chinese can do. Last night a most important meeting was held, which resulted in general orders, being sent out to the Chinese residents which will tell them what to do, and at the same time tax each of them for the purpose of raising necessary funds to carry their point. The Chinese mean business and if the government is ready to give way to the Japanese, because they have guns and men, they will also have to give way to the Chinese who have even more guns and more men. Look out for, there are breakers ahead!

The *Advertiser* now proposes that the new constitution shall provide that only Hawaiian citizens be given the franchise. Great Scott! Isn't that what the Hawaiians have been fighting for since 1887 and against which the Reform Party and the *Advertiser* kicked so persistently. The wisdom and foresight of the National Reform Party is now being realized.

## The Maternity Home.

One of the most useful institutions in this community is the Maternity Home. It has often been demonstrated that one of the main reasons for the rapid decrease of the Hawaiians was the lack of care shown to newborn children and to birth-giving mothers. At the Home the Hawaiian women find all the attention and proper treatment necessary and the institution shows as good results as it could be expected with the limited means at its disposal. In all other communities such institutions are supported, if not altogether carried on at the public's expense here the Home is nearly altogether depending on individual charity. The Home has felt the hard times as well as other charitable institutions, and it is now proposed to raise funds by the giving of a grand luau which will take place on the 31st inst., at the Home on Beretania street, beginning at 1 o'clock p. m. It is to be hoped that a large number of people will patronize the affair, which will be as perfect in its kind as anything ever seen here. Tickets at the reasonable price of \$1 each can be had from the ladies managing the luau and also at the HOLOMUA office. Tourists and visitors should not lose this opportunity to see a real "live" Hawaiian luau.

It is reported that some little force and persuasion is being used to compel about forty or fifty natives working at the Kamehameha School grounds to subscribe to the election oath.

THERE are many people who a year ago hardly had shoes to their feet, now wear most gaudy headgear, in various official positions.

RENEGADES who may desire to vote must remember that they cannot hold any office unless they become naturalized.

THE "Coming of Arthur" is looked forward to with great interest by both great and little p. g.'s. Why so much interest in royalty?

HAWAIIANS should not forget that March 27th brings to mind the date on which one of their best countrymen, was duped into disloyalty by designing followers. That man was the Chief Boki.

The biblical incident of "money-changers in the temple" probably had a close parallel this afternoon in the edifice patronized by fashionable people and yept the Central Union Church. According to the *Tiser* the Woman's Board of Foreign Missions would meet first for prayer and lectures, and then there would be just a little "sale of fans and mats." Christ did not call, the chances are that He would not be recognized if He did, and if any rampus was made He would be quickly vilified by the power behind the Woman's Board, their pens, and their friends, who now hold the fort without any "divine right."

## An American League.

A secret labor organization, which has kept its secret since December 27th—rather a long time to keep a secret in the circumstances—met in Lansing, Mich., yesterday. The organization is to be called the Order of Loyal Americans, and is to be non-sectarian and non-partisan, but is to "take a prominent part in politics and pursue an aggressive policy." Its movements are to be in accordance with "military orders from headquarters." We fear the life of the new organization will be brief though beautiful. We hardly think any large number of Americans will be directed in their political course by any military orders from any headquarters. As for the aggressive policy, usually in such cases it consists in a raid upon the pockets and sacks of candidates, followed by a dirvy of coin by the officers and the distribution of a ration of soap to the rank and file.—*Exchange.*

## CHRONICLE GULLINGS?

Correspondent Chips, with Comments.

Special Correspondence of the CHRONICLE.

Honolulu, Mar. 3.—The last act in the Hawaiian drama is rapidly nearing an end. \* \* \* (No date set.)

President Dole and his Cabinet are hard at work on the new Constitution, and all necessary details toward a Constitutional convention are being arranged. During the present month all matters relating thereto will have been arranged, and the prediction is confidently asserted that by July the Hawaiian islands will be governed under a new form. While it is true that there are some noticeable dissensions among the rank and file of the Provisional Government's supporters, nothing which is likely to cause a serious split in the party is imminent. \* \* \* (Ha! a date, July.)

Since the reported attempt some weeks ago to throw dynamite bombs among the Councillors while in session additional precautions have been taken and extra guards placed in and around the executive building. Sentinels have been doubled around the Government buildings. \* \* \* (Not to be outdone, the above contemptible faked "dynamite par" is introduced.)

Much excitement was caused yesterday when it was rumored that ex Queen Liliuokalani contemplated leaving Honolulu for one of the other islands. The story goes that she believed there was about to be serious trouble, and with a number of her immediate retainers she was anxious to secure safety in flight. The first report said that she would leave her old home at Washington place and proceed to her villa at Waikiki beach, near the ocean. From this point a boat for a hurried trip, if necessary to a man-of-war, could be easily and quickly accomplished. Should the expected trouble occur in town the note of alarm could be given by either a telephone message or rockets. Immediately upon such signal her ex-majesty would seek protection aboard the English gunboat. Effort is being made to discover if her attack of nervousness is a revival of fear or simply part of a precautionary moment. \* \* \*

(We can laugh at the above; fluent, imaginative, but of course based on "it was rumored.") It has been settled that Colonel J. H. Soper of the Provisional forces will retire. \* \* \* (News indeed! Soper is not a "bad man," but "for this relief, much thanks.") He (Soper) will be succeeded by a skilled military instructor from West Point, who is expected here by the next steamer from the Coast. The plan is to allow Colonel Soper to retain his rank and pay during the remaining year of his enlistment, while the new commander will receive a commission as Lieutenant Colonel, but be in reality at the head of the army. \* \* \* (Does UNCLE SAM say all this?)

Of late Minister Willis has been making quite a show of friendship for the Government, and is doing all in his power to overcome the feeling raised against him by his actions in attempting the restoration propaganda. Up to the present time the Provisional Government has received no intimation of the recall of Minister Willis, and the local press has ceased agitation for his recall. \* \* \* (An intimation that a Kentuckian takes water.)

No new developments have come to light in connection with the French Commissioner's credentials to the Queen. M. Verleye, the prospective French Commissioner, is authority for the statement that the French cruiser *Duchassaing* will arrive here shortly from Valparaiso. Mails have already arrived for the vessel. It is evident M. Verleye intends remaining in this country, he having furnished a cottage and settled down to residence. C. S. BRADFORD.

## NOTICE FROM THE Hui Aloha Aina TO THE HAWAIIAN PEOPLE

Whereas, the Provisional Government proposes to call a Constitutional Convention for the purpose of preparing a new Constitution for the Hawaiian Islands, allowing only 18 delegates to be elected to sit with the now elected members of the present Executive and Advisory Councils, which body consists of nineteen members which would constitute a majority of the proposed convention, and therefore able to defeat any wishes of the Hawaiian People. And whereas it is further proposed to allow all foreigners who were in the country on or before January 1st, '94, the right of franchise, and, whereas, each del-gate and each voter will be obliged to take an oath derogatory to the dignity, traditions and autonomy of the Hawaiian Nation which is a clear violation of their Constitutional rights. Therefore, be it resolved that we earnestly recommend all members of the "Hui Aloha Aina" and all Hawaiian sympathizers to refrain from participating in the coming election of delegates to the proposed convention. And all members of the "Hui Aloha Aina" are especially cautioned against taking any of the prescribed oaths or taking any part whatever in the aforementioned elections, or joining any of the clubs started to prepare the same, and from joining in any acts whatever affecting the Hawaiian Nation or people's appeal now under consideration before the Executive and Legislative authority of the American Nation.

## THE SPRECKELS COMPANY.

### Attorney Bishop Returns from Hawaii.

Thos. B. Bishop of the law firm of Garber, Bolt & Bishop, returned this morning on the Mariposa from the Sandwich Islands.

Mr. Bishop left seven weeks ago in quest of health at the same time fulfilling an important business mission. He was the confidential representative of C. A. Spreckels and the Hawaiian Sugar and Commercial Company, and while absent was engaged in looking up the titles and expediting the accounts of the company in the islands, where their extensive real and personal properties are located.

Ever since the big compromise of the suit, after which Claus Spreckels found himself without a dollar in the enterprise which he had begun, the new management has been engaged in taking inventories of the company's properties, verifying financial statements and shaving down expenses.

As the legal representative of the new company, Mr. Bishop while absent worked along those lines. He found the realty holdings of the corporation to be very extensive. Hundreds of titles were examined claims adjusted and accounts so settled that the main office of the company in this city will soon know exactly their financial and legal standing.

Of the 40,000 acres owned by the company in the islands nearly 6,000 are planted in sugar cane. Mr. Bishop says the company is in a most flourishing condition and will this year have an output of over 10,000 tons of sugar.

The Spreckels company also owns 75 miles of railroad and a number of great supply agencies. About 1,700 persons, principally Mongolians, are employed on the plantations.

Since the transfer of the management, a few months ago, by Claus Spreckels to his sons the value of the stock has greatly enhanced. Once worth \$60, it then had reached the low ebb of \$5 per share. Now it is again worth \$69.

Radolph Spreckels, President of the company, accompanied Mr. Bishop in his visit to the various plantations Manager Gus Spreckels was expected today, but Mr. Bishop says he will return by the next steamer.

Speaking of Hawaiian land titles Mr. Bishop said that they were most interesting to him, showing that a real feudal system had existed there. All titles came from the great chief through his sub-chiefs. The judiciary of the lands had always been singularly efficient, and he found no difficulty in getting correct abstracts of title; in fact it was a very simple matter.

As to affairs in general in the islands Mr. Bishop said that he did not remain quite long enough to get an adequate idea of the situation. He had spent most of his time in sight-seeing and he had found the island indescribably beautiful and interesting.

The people seem to think as much as ever of their old Queen. At the same time, the Provisional Government seems to have a good grasp on affairs. There were elements of unrest quite apparent.

His trip had done him a world of good, and he had not been sick either going or coming across the ocean, although Mrs. Bishop had been at times unwell. - S. F. Bulletin

**Annexation versus Population.**

In connection with the study of our population, and the able deductions made thereon by Mr. Marques, another aspect, not considered by him, will certainly interest the readers. We allude to the claims of membership made by the celebrated Annexation Club, who assume to be the People.

The figures thereof, published in the "truthful" *Hawaiian Annual*, are as follows:

While temporarily assuming, for sake of argument, the above figures to be *bona fide* and correct, let us examine them under the light of the Census.

First, the Americans, in the census made by an American Superintendent, only mustered a general total of 1928, men, women and children, and according to the Customs reports, this number has decreased, if anything, since the census, barring out, of course, the handful of adventurers imported from America (but not all Americans) by the Provisional Government as soldiers or spies. Therefore, to make up the 1449 Americans claimed by the Annexation Club, we must take all the men above 15 years of age, viz: 1197, all the males below 15, viz: 100, and still enrol 151 women. But even this would be incorrect, for the undisputable reason that the Americans on the Islands are far from being all in favor of annexation, as proved by the signatures against it collected by the Hoi Aloha Aina Association; so that, in Honolulu alone, at least, one hundred women more must have been gathered to the Annexation rolls, in order to make up for the American men who have not joined, and thus reach the claimed total. Yet, at one time, the Annexation Club very indignantly denied having accepted even signatures of American minors, the Panahou boys, for instance, to whom the heroic Rev. (1) Hosmer teaches military tactics and the art of shouldering guns for night watches, instead of the ordinary American curriculum of scientific, literary and biblical studies!

However, from the above investigation of figures, we see that the American element of the Annexation Club is formed of 82 per cent. of males over 15 years, 7 per cent. of male children below 15, and 11 per cent. of females, the ages of whom are not given, but may be presumed as within that period favorable to annexation.

Now applying this same percentage to the total Membership 6,596, in this total, the number of males above 15 years must be only 5,276, or not quite one quarter of the total number, 22,171 of males above 15, living in this Kingdom (Asiatics not included.)

Passing on to the Hawaiians, the number 1671, claimed by the Club, seems very modest, out of total of 14,429 males over 15, and out of a total Hawaiian population of 40,622; but even thus, what does the figure 1671, represent? Leaving the female element out of the question, and supposing the number to be correct and composed only of males, it must include all the poor devils of men employed in any capacity, as government or public servants, who—with the noble exception of the Royal Hawaiian Band boys—have been obliged to sign on the Annexation roll, much against their heart's desire, to save their daily bread and butter; it also comprehends probably all the Hawaiians in the jails, and all such of the Hawaiian school children, who could be coerced into adhesion by their teachers, witness the Kamehameha school boys, who, it is said, were privately warned of the penalty of expulsion if they refused to take the annexation pledge, and the teacher, another Reverend(?), Oleson, by the undaunted lies he uttered in America, has shown that he was quite missionary enough to make any use of his authority over the boys to further his ends. Thus it would be exceedingly interesting to know how many Hawaiians of legal age, did really join the Annexation club voluntarily, and not under compulsion or even misrepresentation, as R. W. Wilcox, Prince Koniakea and others did, who manfully withdrew as soon as they discovered their error.

Concerning the Portuguese, it would also be edifying to find out how many Manuel or Antonio—"his cross" X—were made to appear on the list, in excess of the real total number of Manuels or Antonios, positively found in the whole Portuguese colony? Crosses, for illiterate men who cannot be used to unmask the fraud, are so easily duplicated!!

The Germans and Scandinavians are not worthy of being enquired into, and in what concerns the members included in the elastic category of "others," many are rumored to be names of such dead men existing on the old voting Register, the detection of which was considered most unlikely.

Lastly, the Club roll is rather discreet about the Britishers, only 351 being claimed out of a total of registered voters of 505. But among these 351, there must be more than the usual proportion of minors and women, for we defy the club to justify of 351 true Britishers favoring annexation and piracy.

One more remark: by taking the Club's figures and comparing them with the corresponding totals in the census, we find that they indicate that 75 per cent. of the American colony belongs to the Club, while the other nationalities give the following proportions:

Only 4 per cent. of the total of Hawaiians; Portuguese, only 19 per cent.; Britishers, only 26 per cent.; Norwegians, 32 per cent.; Germans, 40 per cent.; and "others" 58 per cent.

And this shows, that, even with all the possible doctoring and stretching of figures for their membership, the truth will ooze out and prove how the sympathies of the People stand in regard to annexation.

With this unwelcome proof, and knowing that their rolls of membership could not stand any critical examination, is it to be wondered then, that the Annexation club refused to submit them to the scrutiny of Commissioner Blount, while, as a significant contrast, the Hawaiian Patriotic League, not only sent their books, with over 8000 signatures all of registered voters, to Mr. Blount, but left them in his charge, for all the time he needed for a full investigation!
