# JAPAN GIVES AMERICANS WAR MEDALS

## Mikado Presents Americans With Medals Of Honor

WASHINGTON, D. C., July 3.—The Emperor of Japan has given war medals to Americans who were with the Japanese army during the war with Russia. The recipients include ten nurses and sixteen nurses.

TANGIER, Morocco, July 3.—Sir Harry McLean, commander of the Sultan's body-guard, has been captured and is held hostage by Rasuli on condition of full pardon and indemnity for loss.

KAISER AT COPENHAGEN  
COPENHAGEN, Denmark, July 3.—The Kaiser and Empress of Germany have arrived here.

RUSSIAN OFFICER STOPPING IN HONOLULU CALLS ON PRINCE

Lieutenant Seminael, a Russian military attaché of the Russian Embassy at Tokio, is stopping at the Hawaiian Hotel. He paid an official call on General Prince Fushimi this morning at the Young Hotel. Lieutenant Seminael was a center of attraction. After he had paid his official call he was met by a Bulletin reporter and asked as to his talk with the Prince. "Well, I simply came here to pay my official respects to His Royal Highness," said Lieutenant Seminael. "There is nothing to give out for publication except that our conversation was very pleasant and friendly."

The Russian attaché arrived by the last steamer from the Orient and will soon return.

## JOE COHEN IS SUED FOR CRACKER MONEY

Biscuit Company Wants Him To Square Up For Goods

Joe Cohen appears to be having troubles of his own these days. Monday he was sued by a member of the band for salary due from the disastrious trip to the States made by the band last year, and now another suit has been brought against him.

The Pacific Coast Biscuit Company, successor to the Portland Cracker Company, has brought suit for accounting. The complaint alleges that on January 7, 1899, Cohen entered into an agreement with the Portland Cracker Company, which has since been absorbed by the Pacific Coast Biscuit Company, to become their agent in Honolulu, and he remained such until July 9, 1901.

During that time, the plaintiff alleges, goods to the amount of \$10,183.85, were shipped to Cohen. But he has accounted for but \$7,342.33, being shy \$2,841.52, which is greatly in excess of the commissions coming to him as agent.

The plaintiff asks that Cohen be ordered to account for the balance, and that the plaintiff may have access to his books, and that suitable relief be afforded the plaintiff.

## PRINCE DEPARTS

The British cruiser Monmouth with General Prince Fushimi and his suite on board pulled out of the harbor promptly at 3 o'clock this afternoon. The Prince was accompanied to the ship by Consul Saito and British Consul Forster. Acting Governor Atkinson later called on board the ship to pay his parting respects to the Prince.

The Japanese reception committee with the band was on board the island steamer Cummins. A large number of Japanese school children were on the wharf to give a parting salute. After successfully making the turn in the harbor the cruiser was quickly off and away to Japan.

## FISHER RESIGNS

Auditor Fisher has tendered his resignation to Chief Justice Frear, in compliance with the custom that governs heads of departments when a new executive is appointed.

Prince Fushimi and his party have procured a large number of various Hawaiian fruits which they intend to enjoy during the voyage to Japan.

Private Line On Hawaii To Stop Leakage Of Messages

Superintendent of Public Works Holloway, acting under the law in such cases, has granted to the Wireless Company permission to string wires on Hawaii. The line which it is proposed to run will connect Pukoo and Hilo. Mr. Holloway states that the reason the company wishes to run its own line is that in the past there has been too much leakage and too little secrecy in the transmission of messages. ## National Friendship Is Closer Than Ever Says Prince Fushimi

The friendly relationship between the United States and Japan is much closer today than it has previously been.

The above statement was made by Prince Fushimi to a Bulletin reporter this noon at the Young Hotel, where prominent Japanese were presented to His Royal Highness by Consul General Saito.

At about noon today there had already gathered at the Young Hotel reception room R. Akai, manager of the Yokohama Specie Bank; Dr. Oyama, Dr. Haida, Dr. Uchida, Dr. Aitamura, Dr. Katsunuma, Rev. G. Motokawa, Editor Mikami, Nakamura, Y. Niya, S. Tanaka, T. Sumida, Tsurushima, T. Odo, T. Yoshii, Hamamura and others. S. M. Damon and W. O. Smith were also among the callers on Prince Fushimi who were presented by Consul Saito.

Dr. Haida on behalf of the Mollath school-children presented bouquets of Hawaiian flowers, consisting of maidenhair ferns, roses and other attractive flowers, to the Prince.

"I am very much pleased with your reception and wish you success," said the Prince to the reception committee as it was presented to him.

The ceremony was short and simple and the committee left immediately after it had been presented.

Prince Fushimi was a visitor at the Bishop Museum this morning. He was met at the main entrance by the trustees of the school, where he was royally received. The Prince was highly pleased with the contents of the Museum and was especially delighted in seeing the Hawaiian coat of arms, royal emblems (kahilis) and ahupua'a. He was accompanied by Acting Governor Atkinson, Consul General Saito and the reception committee.

After his inspection Prince Fushimi received the officers of the Japanese charity society, who came there to meet him.

While on the Kamehameha School grounds near the Museum, Prince Fushimi saw a Japanese retired soldier, Murakami by name, who was decorated with medals which he had won during and after the war.

Prince Fushimi called him up and asked him how he was. The gallant soldier answered that he felt that it was an honor to fight for his country.

Prince Fushimi asked further of Murakami how he felt when he received his medals. The soldier politely answered that he simply did his duty.

## Richard Ivers Is Appointed

Richard Ivers was this morning appointed Superintendent of Immigration in place of E. D. Tenney, resigned. His commission has been signed and he assumes the duties of his new office at once.

"I am glad to be able to get so good a man as Ivers," said the Acting Governor in announcing the appointment. "Mr. Tenney has done wonders in bringing immigrants to this Territory, and I believe that Mr. Ivers is a man who will carry on the work steadily. He has plenty of sand and ideas of his own, and I think he will make a good man."

Richard Ivers' commission is for two years, but it is not certain that he will hold the position that long. Although it is not officially so stated, it is believed that when Tenney returns from the States, Ivers will resign and Tenney will be reinstated Superintendent of Immigration. Tenney's resignation, as stated yesterday, was necessitated by the fact that there must be a head to the Board of Immigration in the Territory to settle accounts, pay out money, etc.

## FIRE CANOES AT SEASIDE

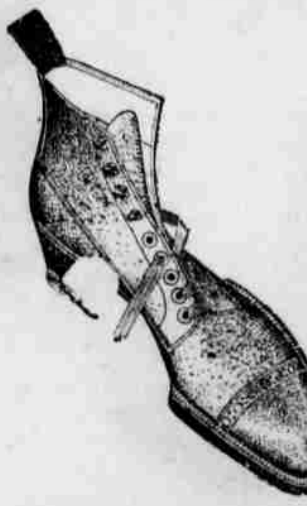

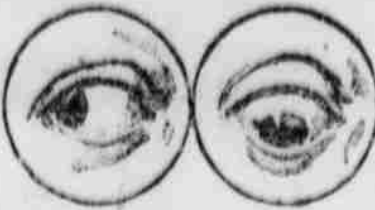

JAPANESE MUST PUT UP DEPOSIT

Will Be Vaccinated and Examined By Doctors

The sailing of the Kumeric for Vancouver with her load of Japanese emigrants will not take place before the latter part of the week, owing to the number of matters which have to be attended to before she can depart. The entire number of the emigrants will have to be vaccinated and pass a strict medical examination. Each will also have to put up a deposit of \$25, as he has to have that much money in his possession before he can enter Canada under the laws of that province.

Advices to this effect have been received both by the hui which has chartered the vessel, and by Davies & Co., who are her agents. The hui people state that all these conditions will be complied with. Those not able to put up the \$25 will not be given tickets, but it is stated that no trouble is anticipated on this account as most of the intending passengers have that amount of money. The deposits will probably be made with the Yokohama Specie Bank.

The Federal inspectors of hulls and boilers have filed their report. It is understood that they report that the Kumeric can carry 1250 persons with her present equipment and more if she can provide life preservers for them. The hui expects to provide these and to ship about 1500 passengers.

FEMALE TENNIS CHAMPIONSHIP Philadelphia, July 2.—Evelyn Sears of Boston has won the ladies' tennis championship of America.

IAUKEA HAS NOT HE SAID, BEEN CONSULTED

County Sheriff Iaukea stated this morning that he had not as yet been consulted by the delegation of Hawaiians which intends to wait on Governor Frear in a few days to suggest to him a few names of likely Hawaiian candidates for heads of Territorial departments. The delegation has Iaukea in view as one of these departmental possibilities, but the Sheriff himself has not been asked if he wants to have his name entered.

"No; I have not been consulted by the delegation," said Iaukea. "The first I knew about the matter was when I read about it in the Bulletin yesterday."

"Well, will you consent to the delegation using your name?" asked the reporter.

"I would rather that they would not," answered the Sheriff. "I am perfectly satisfied where I am. However, if a position as head of one of the departments of the Territory were offered me, I should not take it unless I could first be assured of who my successor as County Sheriff would be, so I could know that the work of the police department would be carried on on the same lines as it is at present."

Those who are in charge of the matter of getting up the delegation and the selection of the candidates who are to be proposed for office have not as yet held their caucus, and some of them prefer to wait with it until after the return of Frear from Kaula.

PASSENGERS BOOKED

TRANSPORT WIRELESS

Washington, June 21.—Wireless telegraphy is playing an important part in the calculations of both the Army and the Navy. The new science is being developed rapidly, and it is destined to be most important in both Army and Navy operations in peace as well as in war.

The transports are now being equipped with wireless plants. These wireless plants were designed, assembled and furnished by the Signal Corps and are said to be superior to any others yet set up. All of the transports are to be equipped with the wireless. One great convenience experienced in having such means of communicating with the shore is the ability to make known the wants of the transport in regard to coal, stores and other matters long before reaching shore.

Another great aid to the navigation of transports is the installation on the Kilpatrick, plying between Newport News and Havana, of a submarine signal apparatus, by means of which it can locate in a fog lighthouses and submerged bells at a distance of fourteen miles.

Improved sets of wireless telegraph apparatus have been made in the signal corps laboratory in Washington, under the direction of Major Edgar Russell, who will superintend tests of them at Fort Leavenworth at the maneuvers attending the graduation exercises of the signal and other service schools there.

The Army has a station at Jolo, in the Philippine islands, which is able to hold communication with a station at Hongkong, 1000 miles distant. Another wireless station is to be established at Penang, in the Philippines, in the fall.

## KEIFER SPEAKS ON ISLAND DEFENCES

General Keifer, who was among the first party of Congressmen that visited these islands, is quoted by the Los Angeles Times of June 18 as follows: "Pearl Harbor could be easily fortified so as to make it impregnable to a foreign fleet," said Gen. Keifer, who served in the Civil War, and afterward commanded a brigade in the Cuban campaign. "Naval warfare is similar to that on land. An enemy must have a base of supplies. With the Hawaiian Islands firmly in our possession, no hostile fleet would dare sail past to attack our mainland. I do not anticipate war. We do not want war, and for that very reason, with Pearl Harbor strongly fortified, we would have a coaling station secure against an enemy's fleet, and at the same time have a refuge for our vessels."

Congressman Keifer was astonished at the number of Japanese upon the islands. He said he was informed there were more than 60,000. Among this number were colonels, captains and other officers who served with distinction in the war with Russia. The native population is gradually dying out. The American residents are in a minority.

"Japan could seize the Hawaiian Islands in one day," continued the Congressman. "The Japanese residents are practically all soldiers. A fleet could sail into the harbor and with one blow capture our fair possession. It is no secret—for I recently advocated a large appropriation from the floor of the House—that a lot of money is needed to put Pearl Harbor in a complete state of defense. We need a modern fort there, with the best guns obtainable, batteries, mines, and all that. No occasional appropriation spent in a careless way will secure proper fortifications. "As an old soldier, I believe in time of peace we should prepare not for war, but rather to prevent war. As I said, a strongly fortified harbor in the Hawaiian Islands will be a strong argument for peace."

## KALAU SAYS JACK

ATKINSON

### IS OFF HIS BASE

The publication by the newspapers of the number of statements which have been filed so far under the new law, which provides that every possessor of a shooting-iron must file a report thereof with the County Clerk, has aroused Acting Governor Atkinson, and he has penned a letter to County Clerk Kalaokalani, in which he states that the law provides that these statements must be kept secret, and calls attention to the fact that the law also provides a penalty for the violation of this provision.

Kalaokalani this morning stated that he had received this letter and expressed himself rather vigorously on the propriety of the action of the Acting Governor.

"Atkinson is off his base when he says that the law provides that such information as I have given out, which is merely a statement of the total number of permits filed, is prohibited by law. What the law prohibits is the furnishing of information in regard to any particular statement or statements, and such information I have and will not give out. It strikes me that his action in this matter favors rather of discourtesy."

## KAUAI BENEVOLENCE

Lihue, July 1.—The Ahahui Aloha, a branch of the Ladies' Benevolent Society of Kapaa, held its annual meeting at Kapaa church yesterday. The meeting was attended by an unusually large number of people, a delegation from the mother society headed by its vice president, Mrs. W. Ellis, helping to swell the attendance.

After an earnest prayer meeting had been held the business part of the society was proceeded with, reports of the officers were read and accepted and officers for the coming year elected. The result of the election was, President, Mrs. C. K. Haue; vice president, Mrs. J. M. Kaneakua; secretary, Mrs. Kaauwai; treasurer, Mrs. J. Opio. The society, which has for its object the assistance of women in straightened circumstances, is doing a lot of good and should have the support of the community.

## JAPANESE HONOR GENERAL PRINCE FUSHIMI

Nothing better and more appropriate word could be found in the land of the chrysanthemum than "honor," which was shouted and cheered to its echo last night in honor of General Prince Fushimi, who is returning to his native land. The Japanese lantern parade last night was typically a Japanese affair. Lanterns of various colors with appropriate welcoming words greeted Prince Fushimi, who watched every float with interest. There were four main-of-war floats in the parade and each ship was well manned with an admiral in full uniform. His majesty's float was an empty boat. This float won the admiration of Prince Fushimi, who signalled the admiral to remain longer in front of the Young Hotel than any other ship.

One of the war-ship floats, by accident, met a typhoon, during the passage and got around near the messenger service office. The officers were unable to do anything with her and they left her after giving three parting bangs.

The procession formed at Aala park promptly at 7:30, and after discharging fireworks the line, headed by the band, marched up Beretania street. At the Japanese consulate banners were given, then along Fort and Hotel streets to the Young Hotel, where General Prince Fushimi received the parade. Capt. Berger here struck up the "Kikazaryo," the Japanese National anthem, amidst cheering and deafening bangs. The prince appeared at the window of his apartments and acknowledged the royal reception extended to him by his loyal fellow countrymen.

Acting Governor Atkinson stood by the Prince. Major Takeuchi and Dr. Haida were stationed at one in the Young hotel windows and conducted the movement of the parade. The procession moved along as they gave out orders.

Everything went along without a hitch and the procession was broken only after arriving at the Monmouth, where parting bangs were given.

Prince Fushimi was banqueted last night at the Young hotel by Consul Saito and British Consul Forster. Among the guests was the Acting Governor.

HONESTY IS PATRIOTISM.

Patriotism of the present day consists
largely in being honest.
This does not apply to officials
alone, for officials take their character
from the type of people behind
them.

No citizen of the United States is
an honest American who finds it too
much work to give a little personal
attention to public affairs, and then
complains bitterly because those affairs
are in the hands of corrupt men
and therefore mismanaged.

It is an appropriate and splendid
custom that the American people on
the anniversary of their independence
should devote the day to lauding their
Nation. Of late years they have spent
a large part of the remaining 364 days
of the year in dwelling upon its
faults.

Our is indeed a great Nation with
a glorious record in the past and a
courageous spirit for anything that
may come in the future. We have
our faults and have learned many bitter
lessons. Nevertheless we have
set the pace for the world in many
of those principles of government that
make for the betterment of the
condition of all mankind. We are a
nation of peace-lovers, never afraid to
fight if there be good cause for it.

Our greatest danger is public indifference
to National problems until
they become acute, and the increase
of an obnoxious element that will
sacrifice self-respect, principle and
anything else in order to be the
recipient of official favors and with
the winning side.

Then there are others who always
wait for an opportunity to do great
deeds before they attempt to do anything.
Roosevelt in one of his recent
speeches made pertinent reference to
this class by repeating the story of
the young man who spent a good
share of his time thinking on what
grand things he could do "if conditions
were different." His mother was
a hard-working woman. He had
been reading of the brave rescue of
a young woman from a burning building,
and remarked to his mother,
while she was busy with her housework,
"I would like to rescue someone
from a burning building." The
mother stopped long enough in her
work to say, "Well, I'll tell you. This
building ain't on fire, but if you will
split the kindling wood I will be
obliged to you."

The citizen who does nothing but
complain, the citizen who is always
reaching for a position on the bandwagon
regardless of which way it
leads, the citizen who can't find anything
to do but is forever hoping for
something great, and the citizen who
plays the hypocrite,—each and all are
as dishonest and as unpatriotic as the
corrupt official and his tools who steal
the money of the people.

There were dishonest men in the
colonies on the Fourth day of July,
1776. There were men of the same
character during the years of struggle
which finally brought forth a united
Nation.

But these were not the patriotic
men whose memory we revere and

**BRITISH CRUISER H.M.S. MONMOUTH**

**Officers Disappointed In Not Getting Ashore**

The H. M. S. Monmouth is comparatively a new vessel. She was built on the Clyde in 1902. Her average cruising speed is 14 knots, although under forced draught she will make 23 1/2 knots. Her armament consists of fourteen 6-inch guns, ten 12-pounders, three 3-pounders, two maxims and four torpedo tubes.

Of her officers, there are nineteen wardroom officers, seventeen governing officers. The total complement being 680, including 70 marines.

Her notice of coming to Honolulu, or in fact in connection with the Japanese prince, was quite short. The Monmouth was lying at Nanaimo, B. C., and at 4 p. m. on the 14th of June was making ready to sail for Waikiki, but received orders an hour and a half before that time to proceed to Vancouver and take the Prince on board for Honolulu.

An examination of the ship, which was made by a Bulletin reporter, who was very graciously received by Marine Lieutenant Jones. The vessel's condition inside is of the neatest and the apartments of the officers are roomy and fitted with every convenience. She is the first English war vessel to visit these islands in about three years.

Many of the officers on board are greatly disappointed in not getting some time ashore.

There will be all kinds of sports dear to the heart of the growing generation, as well as plays for the tots. And the Lihue ladies will be there to see that all the youngsters have a good time. There will be mountains of cornucopias filled with ice cream and doughnuts like those mother used to make, and is making today for that matter, and any amount of other things toothsome both to the small children and the grown up ones.

The members of the Kegel Club will enjoy the excitement of the semi-annual contest for the silver cup offered by C. M. Cooke. The games will be going on the better part of the day as the seven hours of bowling will only allow of twenty-eight contestants. Whether the fair bowlers from the ladies' club will try for the cup is as yet unknown.

**BIRTHS AND DEATHS FOR MONTH OF JUNE**

The Board of Health's mortality report for the month ending June 30 shows a total of 82 deaths. Of these 49 were of males and 33 of females. Forty-one were Hawaiians, 10 Japanese, 1 Korean, 4 part-Hawaiian, 1 Porto Rican and 11 Portuguese.

This makes the annual death rate per 1000 population, 25. There were 43 births reported and 138 marriages.

## CHARGES MILLS WITH RUNNING BLIND PIG

The Honor board held another public hearing yesterday afternoon for the purpose of considering the application of White & Colburn for a license for their place at Pearl City. There was a protest against the granting of this license, signed by a number of citizens, including J. R. Mills, whose name came last on the protest. A. V. Gear, who represented the applicants, made a serious charge against Mills. He said that Mills protested against the granting of a license to White in order that there might be no saloon at Pearl City and he might run a blind pig himself. Gear charged in fact that Mills is now running a liquor business without a license. The protest was made on the ground that White kept women on his premises, and that drunken men and women carried on noisily most of the night and all day Sunday.

Before the application was taken up for consideration Gear asked permission to amend it, as Colburn had decided to withdraw his name and leave the firm. The permission asked for was granted.

The Board said it would consider the application.

Gear then presented two applications for rehearings. One was for Fred. Kiley, of the Favorite Grotto, who stated in his petition that he was willing to forego the Sunday and after hours, and to close up all entrances and take out such partitions as the Board might deem advisable. The other petition was on behalf of Manuel Madeiros Calbau, who wants to run a Kakaako saloon. The Board said these petitions would be considered.

Plans to assassinate the Governor of Illinois are reported to have been discovered. The assassin is said to be one Frank Norden, an ex-convict who has escaped from Joliet Penitentiary. The theory is that Norden is a convict who was convicted when the Governor was State's Attorney.

## PHOTOGRAPHERS ARE SEEKING LADY MEMBERS

The Hawaiian Photographic Society will hold a meeting this evening at the rooms of the Kioloana Art League at 8 p. m. The Society is now organized, and will decide upon the question of locating itself at the Art League rooms, and furnishing for its members a dark-room, which will be available to the members at any time. Also the question will be proposed (and in courtesy extended to ladies of joining the Society at half the regular dues, which will entitle them to all the privileges of membership. Those who have not already joined the club, and who desire to do so, may attend and will be elected to membership upon handing in to the secretary a written application.

## HAWAII'S JAPANESE FORMIDABLE FORCE

The Los Angeles Times, June 12, contains the following article: That in case of war with Japan the Japanese on the Hawaiian Islands would rise to a man against the United States and that they feel very resentful toward America and Americans was the crux of a statement made by Jarrett T. Lewis of Hilo, Hawaii, who is visiting Judge Jarrett T. Richards.

"If anything unpleasant arises," continued Mr. Lewis, "the Hawaiian Japanese would be a formidable force to reckon with. There is no doubt that they feel great resentment toward the United States and a great many of them are only too willing to stir up strife. They were greatly agitated during the discussion of the school question in San Francisco and they fully expected war. When the Japanese warships were at the islands many Japanese walked great distances to see them and were sorely disappointed when the ships sailed, because they were convinced that their coming had something to do with possible strife."

## WILL INVESTIGATE PUNAHOU FIRE

F. C. Stanford of the Norwich Union Fire Insurance Society arrived in the Alameda and will stay in the islands for some weeks. It is his intention to adjust the Punahou fire loss, which is rather complicated because of the fact that double insurance was taken on it, or \$800 by the trustee of the Oahu college and for \$7000 by Contractor Campbell, thus making the total insurance much greater than the actual loss. He will incidentally look into the cause of the fire and is to this end conferring with the police department and examining the records of the fire inquest. He will also take a trip to the other islands to look into the condition of the business of his company.

## ACTING GOVERNOR CALLS ON BRITISH CAPTAIN

Acting Governor Atkinson this morning called on the captain of the British cruiser Monmouth, to return the call of the captain on the Governor yesterday. Atkinson was accompanied by Adjutant General Jones and Comdr. Sam Johnson. The warship saluted as the visitors came aboard.

## U. S. DEPARTMENT OF AGRICULTURE

**WEATHER BUREAU.**  
The following data, covering a period of 32 years, have been compiled from the McKibbin and Weather Bureau records at Honolulu, T. H. They are issued to show the conditions that have prevailed, during the month in question, for the above period of years, but must not be construed as a forecast of the weather conditions for the coming month.

Month, July, for 32 years.  
Temperature (1890-1906)—Mean or normal temperature, 78. The warmest month was that of 1900, with an average of 79. The coldest month was that of 1894, with an average of 76. The highest temperature was 88, on July 28, 1900. The lowest temperature was 63, on July 1, 1899.

Precipitation (1877-1894, 1905-06)—Average for the month, 1.45 inches. Average number of days with .01 of an inch or more, 14. The greatest monthly precipitation was 6.03 inches in 1880. The least monthly precipitation was 0.34 inch in 1882. The greatest amount of precipitation recorded in any 24 consecutive hours was 3.17 inches on July 12, 1880.

Relative Humidity—Average: 9 a. m. 66 per cent., 8 a. m. 66 per cent.; average 9 p. m. 72 per cent. (1895-1904); 8 p. m. 70 per cent. (1905-6).

Clouds and weather (1890-1906)—Average number of clear days, 13; partly cloudy days, 17; cloudy days, 1.

Wind—The prevailing winds are from the NE. (1875-1894, 1905-06). The average hourly velocity of the wind is 3.8 miles (1905-06). The highest velocity of the wind was 27 miles from the NE, on July 6, 1905 (1905-06).

## JAPAN'S FINANCE

Tokio, June 19.—The Jiji Shimbu roundly accuses the Japanese public of financial carelessness, declaring that the system of credit has not been properly developed, thereby causing depression in the stock market such as that now prevailing.

The Asahi does not join in the general pessimism governing economic circles because the foreign trade is showing an unprecedented increase, especially in exports, while the productive conditions and the monetary market show no signs justifying general gloom. The postal bank savings, it also points out, have reached 78,000,000 yen (\$39,000,000), the largest figure in the history of the country.

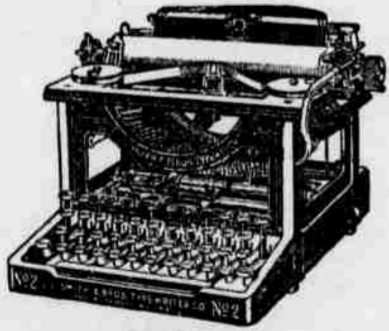
