

Among the Legislators

Comment Regarding the Changes in the House and Senate.

The House took a fall out of the governor's veto of the belt road bill yesterday and passed the measure unanimously, almost, over his head. The governor thought the money for the purpose was not in sight just now and when it was needed for the roads, June and December, just after the taxes come in, it would be needed for other things. Representative Rice waxed wrathily over the veto and accordingly expressed himself. It will be a long time, in my opinion before the funds will be available.

There is a hub bub in town. The Brewer estate bought from Bruce Cartwright a mere shack on Hotel at Union street with the intention of erecting a two story building that would be a credit to the town. At present the place is occupied by the Palm Bakery and its proprietor has in mind the fitting of a modern restaurant and bakery. But the Brewer estate finds there is not enough land to allow the building of a place such as is needed so a request is made for a portion of city property. If granted the street, Union, would be as narrow as the most confined trial in Lahaina. Another thing. Many of the residents, taxpayers and persons who have an idea for civic beauty have asked that Union street be widened and that Bishop street be extended. If the street is sold to Brewer this cannot be done and the House found itself yesterday with a deluge of protests from property owners against any job that would prevent the widening of the street. I think I can see the chances for a new bakery glimmering. I think, also, that Bishop street will be widened, if there is a change in the office of superintendent of public works.

Now it appears Hutchinson Sugar Co., has been encroaching on the water supply at Waiohinu that really belongs to the Hawaiians in that district. Representative Yates is up in arms with a concurrent resolution directing the attorney general to proceed against the company. According to the result of an investigation by a committee it seems the water belonging to the natives has been diverted and they get none of it. Possibly this action will help the Kau ditch scheme. If there is a decrease of the company's supply, more must be had and it may be necessary to get it from somewhere else. Hilo, perhaps, though John Searle, who once lived on the plantation and was a division luna, is pregnant with ideas of getting water. He knows every pond and puddle within fifty miles of the plantation boss' house and can measure the quantity with his naked eye.

Senator Fairchild came out strong today with a letter from W. O. Aiken of Maui, a gentleman whom he terms a real bona fide small farmer. This may all be true but what is it, except a grouch, that would throw Fairchild across the line? It sounds fine to have such an able member of the senate fight the cause of the weak but all the time he spouts I'm busy looking for the lemon. There must be something and I am with the man who says he is getting back on the government for failing to keep its end of a promise.

So Maui is to have a mayor and Keliinui is to have the honor and emoluments of the office. He does not say all this but one can read

What the Wrestlers, Boxers and Base Ball Artists Are Doing.

He went through a few stunts in the presence of several hundred persons and then called for an opponent. HONOLULU, April 21.—The captain of the Oteric has been fined \$10,000 on account of the mortality on the steamer. There are five cases of scarlet fever on quarantine island of children from the Oteric.

Cholera on Hawaii.

HONOLULU, April 20.—One case of cholera has appeared at Honokaa, Hawaii.

No new cases in Honolulu, and the quarantine is very strict. All baggage is being examined.

The S. S. Oteric is being held till responsibility for the deaths on the voyage has been fixed.

The Gold Mine at Iwilei has been destroyed, and the Hawaiian and Russian shacks will be burned.

Nearly \$250,000 will be available soon for sanitation.

The governor's veto of the belt road bill was supported in the Senate.

The American schooner Helene arrived in port partially dismantled. Kuhio says if he has the backing of the Legislature regarding a national park at Kilauea, he will fight for it in Washington.

Mexico Makes Charges.

WASHINGTON, April 21.—Mexico makes counter charges in a diplomatic note to the United States. It accuses Americans of being at fault in the affair at Douglas.

CITY OF MEXICO, April 21.—The Minister of War, Delabarr said today he was not attempting to hide the serious situation between the United States and Mexico. While a friendly feeling existed, a conflict was imminent.

WASHINGTON, April 21.—Ambassador Wilson called on Delabarr and asked him if he intended to force intervention. Delabarr replied he had no such intention.

WASHINGTON, April 21.—La Follette's resolution requesting the Secretary of the Interior for a statement of entries on Alaskan lands made by the Guggenheims, has been adopted.

Peace in Sight.

WASHINGTON, April 19.—The rebellion in Mexico may end in consequence of the wounding of Americans in Douglas. Madero's representative has wired a suggestion of an armistice. Principle in the terms of peace offered is the resignation of Diaz.

DOUGLAS, April 19.—The battle of Agua Prieta, ceased only after the rebels had exhausted their ammunition.

EL PASO, April 19.—Madero and a guerilla leader are within 12 miles of Jaurez.

DOUGLAS, April 19.—Col. Medina and a lieutenant crossed the line after the fighting and surrendered. The colonel said his men were full of booze, and were carousing instead of being in the trenches and fighting.

Rebels Winning.

EL PASO, April 20.—Many bridges have been burned in Northern Mexico.

AQUA PRIETA, April 20.—The rebels have burned the railway depot here, and several people were shot.

WASHINGTON, April 20.—Former Speaker Cannon opposed Canadian Reciprocity on the floor of the House yesterday.

EL PASO, April 20.—The rebels have demanded the surrender of Jaurez.

Contract Jumped

The Packer's Association Are Reaping the Reward of Treachery.

Labor troubles of a south seas' type found their way into the economic burdens of San Francisco, when a band of 267 laborers, composed of Filipinos and Hawaiians, shipped there by contract on the steamer Korea to work in the canneries of the Alaska packers' association, flatly refused to proceed and squatting down on the edge of the Pacific Mail pier gave themselves up to song. The agents of the association begged, stormed and pleaded. They waved aloft the contracts, ready to be signed. They spoke in three languages and with many gesticulations; but inasmuch as the burden of their speech did not contain the requisite price, the appeals of eloquence changed to profanity.

The islanders heeded them not. They tinked their melodious tunks on their guitars and mandolins, and departing in a body to the Filipino club in Stockton street near Jackson left behind them the echo of the Hawaiian song of farewell: "Alloahe, alloahe, until we meet again."

Accordingly there are 267 unemployed south sea islanders in the city, but those who have charge of them have little fear of the future, saying that the demand for their labor is high and that there will be no difficulty in placing their services.

The complaint of the men was that they had been brought to San Francisco by fraudulent representations. They said they were willing to go to Alaska if they could be guaranteed \$150 for the season, plus transportation and board and lodging. This, they said, was less than the understanding on which they had originally agreed, but for the sake of friendship they would accept. The Alaska packers' association was willing to agree to the terms, but the Chinese contracting company, Chu Chu & Co., refused to guarantee.

"Pooh, pooh!" said Chu Chu. "No guaranty."

Whereupon there came the tinkling and the tunking of the mandolins and guitars. The men stood pat. The agents of the Alaska packers' association flew from them to the contractors trying to effect a compromise, but in vain. Then a show of force was tried.

A detail of patrolmen from the Morse agency were hurried to the scene. They surrounded the islanders and herded them to one end of the pier, refusing to allow them to leave and attempting to forbid others from talking to them. For a time the show prevailed among the more ignorant. Others, however, knew better.

The laborers remained on the pier only so long as their leaders tried to effect a plan which would please all parties. The talkfest went on interminably, but to no purpose. Ultimately a leader stepped on a box and said about three words. The entire party arose and walked away, past the line of specials, who knew they could do nothing.

"Ai, ai, stop him," said Chu Chu, the contractor, scurrying around. "Ai, mister, stop him, stop him."

The disappearing line cost him approximately \$12,700, and he jumped up and down on the pier, voicing his discontent. None could stop them. They were American citizens on American soil.

Racy Paragraphs From the Capitol On Current Topics.

Two suicides and a murder in one day puts Honolulu in a position to claim her rights as a metropolitan city. Murder of a Hawaiian woman by her kane first occupied the attention of the police. Then came a call to the residence of a young man named Bushnell on Spencer street. The Hawaiians selected the razor route and the haole a pistol as a means to the land of dreams. The latter was a sufferer from tuberculosis and had just secured employment on the Rapid Transit lines. And that seems rather strange in view of the fact that an applicant for a position in that company must first pass a medical examination by the company's physician. According to the doctor the young man was in healthy condition. He had been a patient at Leahi Home for a time and was on the mainland for a year or more. From there came the report that he had died of consumption. I mention the details merely to show that even the best of doctors can make a mistake in his diagnosis of a case. The Hawaiians who passed out by violent means got what was coming to them. Not long ago the woman received a shot in her jaw handed out by her real husband, so reported at the trial, and the gentleman in the case is doing a five years stretch in consequence. Soon after he had been settled firmly in his new home the wife took up with the man who killed her. No better evidence of her unfaithfulness is required. It seems to me that it is up to the governor to pardon the man in jail on the ground that his crime was justifiable. A man hates to be played for one of those things represented in the list of births every minute in the day.

Come to think of it Honolulu is having a good crop of murders and crimes of less consequence. A psychologist should be able to determine the reason. It is not difficult to recall the time when a murder here was a rare occurrence; now it is a frequent one. Something is certainly very rotten in Denmark. The public would be grateful to the man who could turn back the hands of the clock to the time when paikau and che fa were the only causes for putting men inside the station house in Honolulu. I do not know what to attribute it to. In the case of the Hawaiian man and woman mentioned above it was a case of pure devilishness on the part of the woman and inability to stand for her talk on the part of the man. There are things that will drive a man to murder and a talking woman is one of them.

In a London workhouse there is a woman so charged with germs of some sort that she is kept in quarantine so as to prevent the disease spreading. In New York there is famous "Typhoid Mary" who leaves death and sorrow wherever she goes. It was a long time before the physicians could find the source of the disease until finally it was traced to her and she was boxed up in a quarantine place and will remain there until she is free from trouble. Now Honolulu comes forward with the worst in the lot for it has a real cholera germ distributor in Hulu, a patient in the quarantine hospital. This is unfortunate for, as far as

The corporate interests on the mainland that have been waxing fat these many years on a prohibitive tariff on the necessities of life, and who have banded themselves together under the name of the American Protective Tariff League, are fighting tooth and nail against Canadian Reciprocity. These corporate interests which have so long held the farmer and farm products under their thumb, and squeezed them to the last drop of blood, now come forth as the self appointed champions of the American agriculturist. They claim that Canadian Reciprocity is a gross violation of the policy of protection, and that it unfairly sacrifices the interests of American agriculture. If the farmer reaped the benefit from protection this might be an argument, but he does not. It is the wholesale dealer in farm produce that gets protection. These wholesalers well know that they have the farmer nailed down to the lowest possible price for his produce, and that if the protection is taken off they cannot continue charging the present excessive price for necessities, but will have to be content with legitimate profits. They assume the form of robust selfishness and ask the very people they gouge to assist them in defeating an agreement that will stand as a monument to the sagacity and disinterested honesty of President Taft. As one Congressman puts it: The farmer's load is becoming unbearable, so much so that the farms are being abandoned, and the cry goes up from the cities "Back to the farm." Why do they raise this cry? No one need cry "Back to the railroad," because railroading is profitable, but it is back to the farm in order that there may be a broader foundation of poverty stricken bodies for the velvet feet of the wholesalers to tread upon. Canadian Reciprocity will be a godsend to the farmer and to the consumer, and if these two will work together for the common good, the bloodsucking wholesaler will be eliminated, and the consumer will live, while the farmer will come into his own again.

That political machine, the Territorial Board of Health, is giving a continuous performance of how to get money from the Legislature. The members of this board are so busy pulling wires that the legitimate business, for the doing of which they owe their existence, is being neglected and overlooked. While they are busy bluffing the Legislature into giving them control of the garbage department of Honolulu, disease is rampant throughout the city. For example a Filipino and his wife came to Maui from Honolulu about a week ago. Thursday the authorities learned the Filipino had smallpox. After a chase they landed their man who they found hiding in a canefield. The disease is pretty far advanced in the man, but the woman has passed the worst stages and is convalescing. This must have been contracted in Honolulu, and in the case of the woman, the disease must have shown before she left. Both are now in the quarantine hospital at Kahului. This is a simple instance of the wide awakesness of the Board of Health. They are awake to their political standing only, but for real legitimate work in ferreting out and preventing the spread of disease they are a joke. We cordially agree with the Star that if we are to uphold our reputation as the "Paradise of the Pacific," control of our sanitation must be in the hands of the federal authorities. They do things then talk about them afterward. The Territorial Board of Health spills plenty of hot air, but as to their accomplishments, their past record speaks for itself.

The Hilo celebration this year will be strictly a family affair and while our brethren from the other islands are, as always, welcome within our gates, they will, if they come, come strictly as guests and not as patrons. The celebration is strictly pro bona publico, and as the funds are subscribed here, and there is no wish to make money out of the affair, we do not need or look for any assistance from the other islands, except possibly in the way of a few contestants in the sports events which may be arranged.

The fact that Kahului is running a celebration in a business way should certainly not deprive the citizens of Hilo of an opportunity to vent their patriotic feelings, and it is probable that the people on the other islands, when they thoroughly understand the situation, will agree in this.—*Hilo Tribune.*

Interesting Experiments in Wireless Telegraphy.

By an experiment on the west slope of the hills back to Twin peaks, San Francisco, with two box kites and a half mile of wire, Richard Fontana and Leone Cadenasso, experts of wireless telegraphy, marked a new epoch in receiving wireless messages with detached aerials. At the completion of their test Fontana and Cadenasso had received flashes sent from over 5,000 miles of sea, which were caught by two slender drifting antennae attached to their kites a half mile in the air.

The object of the experiments was to prove the theory that the tall poles used at the present time at wireless stations are superfluous in receiving messages from a great distance, and that an aerial with only one end attached to the grounding medium is better in long distance telegraphy than the wires strung from a pole.

Fontana and Cadenasso first sent up the kites with 800 feet of wire and immediately caught a cipher from Honolulu, and then several from ships at sea in a long sweep from south of the equator to the northern coast of British Columbia.

With a half mile of the wire up and the thin aluminum wires sweeping in the wind from the kites' ends, the instruments on the ground below clicked off an unintelligible message, which was found to have come from off the coast of Japan.

Fontana and Cadenasso hope to prove by a series of tests to be made that the box kite apparatus and the detached aerial, are superior to the pole system. The latter is said to require a greater number of batteries and more wire than the new method, but has been unable to get messages from over so great a distance.

Final Report of Grand Jury.

There have been presented to the Grand Jury by the County Attorney's Department four cases, in each of which a careful investigation has followed, resulting in the finding of true bills in all of these cases and for the different offenses herein set forth:

Territory of Hawaii vs. Aleka Kanuu, Larceny in the First Degree; Territory of Hawaii vs. Jim Tai On, Burglary in First Degree; Territory of Hawaii vs. Kahuila, Burglary in First Degree; Territory of Hawaii vs. H. Lono Kaiiaki and Aleka Kanuu, Adultery.

At this session the Grand Jurors have made further investigation into cases of illicit cohabitation, and find that, since the last session of the Grand Jury, there have been some forty odd marriages in the County of Maui between persons who are alleged to have been living together in open adultery, and still others are taking steps necessary to the consummation of legal marriages. The Grand Jurors believe that there are now comparatively few cases of this kind remaining, and the attention of the Sheriff's Department has been called to such as remain. We have deemed it wise to pass the matter for the present, leaving such further consideration as the situation demands to the coming Grand Jury.

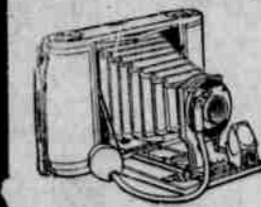

Honolulu News.

HONOLULU, April 18.—The doctors claim to have the cholera situation well in hand.

Mortality on Oteric due to passengers not reporting sickness to the doctor.

In the case of a Japanese charged of a statutory crime, and convicted by a jury, Judge Cooper made an investigation on his own account. He found the prisoner guilty of a lesser crime, and set aside the verdict. He was retried, plead guilty, and sentenced.

A Hawaiian killed his mistress and then committed suicide here yesterday.

The Board of Health will undertake the collection of garbage in Honolulu and Hilo free of charge. Citizens will act in regards to cleaning of infected places.

The governor vetoed the bill providing for belt roads. The veto was immediately overridden unanimously.

HONOLULU, April 17.—There have been three deaths from cholera to date. All Hawaiians. One of those who died was a guard.

The bill providing for the election of supervisors-at-large for Maui passed its second reading in the House Saturday. All Maui members voting in favor of it with the exception of Waiahole.

No appointment has yet been made to the position of city physician. Dr. Raymond may get the appointment.

HONOLULU, April 15.—Dr. Mackall the City and County Physician has resigned. Dr. Emerson is temporarily in charge. Dr. Hobby has been offered the position but declined. The Board of Health has been accused of acting in bad faith.

It has not been positively determined that the latest case is cholera. Another test is being made.

The Spanish and Portuguese immigrants have been landed at the Channel wharf, and at quarantine island.

Additional troops will be here soon, and will be quartered temporarily in the drill shed.

Peace Offered Madero.

CHIHUAHUA, April 18.—Delegates approached Madero yesterday with peace proposals. They were forced to leave the railroad 90 miles south of this city. Rebels had destroyed a bridge and cut lines of Mexican Central.

DOUGLAS, April 18.—Seven Americans in this city were wounded yesterday by bullets from across the line.

WASHINGTON, April 18.—The State department has demanded of Mexico assurances that Americans will not be further imperiled.

SEWARD, Alaska, April 18.—The ship Jabez Howe is ashore here, and will be a total loss.

SAN DIEGO, April 18.—The cutter crew of the U. S. S. California won the championship from the Maryland in a three mile race here yesterday.

Civil War in Mexico.

CITY OF MEXICO, April 17.—The government officials have thrown off minimizing the gravity of the situation forced on the country by Diaz. They acknowledge that the revolution is gaining. The entire country is now in a state of civil war. A general call was sent out yesterday for volunteers.

AGUA PRIETA, April 17.—A strong body of federals hastening to the relief of the garrison here are penned up by a superior force of rebels. The rebel commander is digging trenches.

JAUREZ, April 17.—The advance guard of the federals came in contact with the insurgents yesterday. They skirmished throughout the day when the federals withdrew and are putting this city in a state to resist attack.

WASHINGTON, April 17.—President Taft sat up till midnight last night receiving bulletins from the Mexican border.

BIRKENHEAD, Eng., April 17.—The agitation against proselytizing of Mormon Elders came to a head last night when a riot broke out. Several persons were injured.

SAN FRANCISCO, April 17.—The steamer Senator arrived yesterday with 126 laborers on board. The laborers refuse to tranship to Alaska, and demand to be landed.

Ultimatum Sent Rebels.

AGUA PRIETA, Mexico, April 15.—Heavy reinforcements arrived last night. The insurgents under Lopez carried the attack all day in the face of machine gun fire. Last night an American officer delivered an ultimatum to Lopez, if any more bullets were sent into the town of Douglas, he would cross the border with his cavalry, and put an end to the fighting.

WASHINGTON, April 15.—A special cabinet meeting was called yesterday afternoon to consult on the situation on the Mexican border. Taft is determined that nothing shall occur to further endanger the lives of American citizens.

WASHINGTON, April 15.—The agreement between officials of the Canadian government and the State Department regarding reciprocity of trade, must be sanctioned by both parties. The matter was formally laid before the house yesterday.

ORDINANCE NO.

AN ORDINANCE PROHIBITING THE PEDDLING OF FISH AND OTHER MARINE PRODUCTS, FRUIT AND VEGETABLES, WITHIN A RADIUS OF ONE MILE FROM THE "WAILUKU MARKET," AND PROVIDING A PENALTY FOR THE VIOLATION OF THE PROVISIONS THEREOF.

Be it Ordained by the Board of Supervisors within and for the County of Maui:

Section 1. The peddling of fish and other marine products, excepting Opili and Limu in closed containers, fruit and vegetables, within a radius of one mile from what is commonly known as and called the "Wailuku Market," situate at the junction of Market Street and Mill road, in Wailuku, is prohibited.

Section 2. Any person who shall violate any of the provisions of this ordinance shall, upon conviction thereof, be fined in a sum not less than One Dollar and not exceeding Ten Dollars, together with costs of court; and, in the event of default of payment of such fine and costs, shall be imprisoned in the County Jail until the same shall have been discharged by operation of the general laws applicable to such cases.

Section 3. This ordinance shall take effect from and after its publication once a week for a period of two consecutive weeks in a newspaper of general circulation published in the County of Maui, and the posting of a true copy thereof upon a bulletin board in front of or near the rooms occupied by the Board of Supervisors.

the doctors are able to tell, he is in other respects a first class insurance risk.

The whole cholera situation is mysterious. As mysterious as is the case of Hulu and it has crushed life out of business. It has been decided that the Manoa stream is contaminated. That there is not enough disinfectant in two states to drench the bugs and kill them. The solution seems to be filling in the duck ponds and the taro beds at a cost of ever so many million dollars and to raise the money the city will have to bond itself. This morning an order came from the head of the marine hospital service to Ramus forbidding passengers taking away water in bottles, not even soda water, nor vegetables, fruits, meats, milk, candy and what not. Poi is, of course the top notcher in contraband articles. This is bad for it would appear the steamers will have to bring stores for the round trip. Also, following the plebiscite, at even this long range, it would appear that the anti-prohibs have the support of the doctors. There is a song which says something about the uselessness of water when you are dry. What, then is the matter with Budweiser? If one may not have a long cold draught of sparkling water what is one to take if not beer? The newspapers have started a wrangle as to what is and what is not infected. The Star insists that it has not been proven that poi is the source of the break though admitting that the Manoa stream was polluted by a Hawaiian who was early stricken with the disease. The editor pertinently asks where he got his infection. He died before giving out the information.

Yesterday two supervisors made the rounds of the poi shops, all of them out of business temporarily, and then went into a bakery or two where they were confronted with a condition even worse than the poi shops supplied. I am told that Inspector Blanchard has said there is but one bakery in the city that should be allowed to do business until they got rid of the filth. In one of the best known places there was enough dirt on the walls to keep a vacuum cleaner working overtime for a week. This should give you an idea of what a resident of this metropolis has to put up with. Me for the simple life after this session of the legislature. A specialist in diseases assures me that thirty-four cases of cholera have been traced by Dr. Currie directly to the Manoa stream. And yet the Hawaiians will not admit that the disease from which so many have died is cholera. They have been most persistent in deceiving the inspectors and the physicians. This is particularly the case with those with whom Currie has come in contact.

The pantaloen skirt "has come." I can understand, now that I have seen what I take to be one of them, why England throws the stony glare on a suffragette. The wearer of the pantaloen combination here is said to be a dress maker. Judging from what I saw of her costume on King street the other day she can lay claim to being a pants maker as well for she wore the genuine article turned up, just as they wore them in dear old Lunnun on damp bad days. The tout ensemble did not appeal to me because I considered the woman who wore the costume old enough to be thinking of better things. Between us it was raw.

Mrs. McQuaid, the wife of the man who shot Volney Driver a few months ago has begun action for divorce by charging cruelty. Take it by and large this was a case in which the sympathy was all one way. McQuaid got it. Now he is brought into court and the judge tells him he is not to molest the woman who is mother of his children. If he were half a man he would let the ocean separate them. To go back a dozen years. When McQuaid was courting this little

girl she showed indifference while he was the ardent lover. As a matter of fact she felt that she was "O'er young to marry yet," and declined his offer. She admitted to her friends that she did not love the man. She told him the same thing but he was so much in love with her that he was willing to take a chance. You can readily see where the chance has brought him. He is a wreck wandering about the street from morn to night, or rather he did before the trial, looking more like a man with the willies than otherwise. Of course no one can blame him as long as he still held a warm spot in his heart for the woman. He was blamed for not dampening his fires. She is in love with Driver. At least she is said to have told her husband so when he was on his bed in the hospital. And Driver. He paid in cash dearer for his marksmanship than did McQuaid and one was as bad a shot as the other.

So the voyage of the Senator was not an unqualified success. In other words the laborers destined for the canneries seem, from a cablegram at hand, to have slipped it to the contractors in great shape. No sooner had the steamer arrived in the bay at San Francisco than a demand was made by the men to be landed on the dock. Union labor had met the enemy before it had a chance to take root on California soil. Just leave it to the Unions over there to be ready for new obstacles to surmount; they sweep with an iron hand. A copy of the contract the men are expected to sign has been obtained and published in the Star. It is a peach. Among other things the laborer agrees to work day and night, Sundays and holidays not excepted, if so ordered by the cannery superintendent and he is not to grouch if Sam gets off earlier than he. Another thing. They are not expected to complain if they do not get more than two meals a day, one at eight in the morning and the next at four in the afternoon. Forty dollars advance money is to be paid after the laborer goes aboard the steamer bound for Alaska and the balance, if any is due by the foreman, five days after returning to San Francisco. It would appear that the cannery had a cinch.

Twelve months ago it was pointed out to me why August Ahrens would make two stools of cane grow on the land of the Pacific Sugar mill where none grew before. The ditch was to be a factor and careful attention to cultivation a close second. Incidentally I was advised to take a flyer in the market making that stock the objective. Needless to say I never fly. Even Mountain King at six and a half and with an upward tendency had no allurements for me. Today Pacific sold at \$115 an advance of twenty dollars over the last sale and I have reasons for saying the next sale will be at a higher price. Hawaiian Commercial sold at \$39 and McBryde at \$6.87½. There is to be something doing in Mutual Telephone shortly. A special meeting of the shareholders is called for next month and I am informed there is a probability of a nice juicy dividend, possibly in stock, being declared. I think the company is making money and the shareholders are to have some of it.

There is no change in the theater combine. Winkleback, who originated the popularity contest is on his feet again with the same sort of a proposition and the Independent Theater, the only one not in the trust, is to give away an automobile and what not to the persons getting the most votes. It is a money grabbing business but the public will be glad to see the Independent crowded every night as a disapproval of the ways of the combine.

The Advertiser informs us this morning that the second outbreak of cholera is at an end. I would not like to say it aloud but I have a right to think that the buddle surrounded poor old Mackall and it was hoped that when the blow came it would find him out of office. I do not wish to imply that the germs
