## BY AUTHORITY.

AN ACT  
TO AUTHORIZE THE MINISTER OF FINANCE TO REMIT THE POSTAGE  
ON CERTAIN CLASSES OF MAIL MATTER, POSTED BY THE HAWAIIAN  
BUREAU OF INFORMATION, LIMITED, FOR TRANSMISSION ABROAD.  
Be it Enacted by the Queen and the Legislature of the Hawaiian  
Kingdom:  
SECTION 1. The Minister of Finance is hereby authorized  
to furnish postage without charge for all mail matter pre-  
sented at the General Post Office by the Hawaiian Bureau of  
Information, when such matter is for gratuitous distribution  
and issued for the purpose of advertising the Hawaiian King-  
dom abroad.  
SECTION 2. The Minister of Finance shall provide proper  
rules and regulations for the guidance of the Postmaster-  
General in carrying out the provisions of this Act.  
SECTION 3. This Act shall take effect from and after the  
day of its approval.

## AN ACT

TO PREVENT FRAUDS IN THE SALE OF BUTTER AND TO PROVIDE  
FOR THE PUNISHMENT OF THOSE PRACTICING SUCH FRAUDS.  
Be it Enacted by the Queen and the Legislature of the Hawaiian  
Kingdom:  
SECTION 1. Whoever knowingly sells to any person or of-  
fers for sale any butter manufactured from or by the use of  
"oleomargarine," so called, unless the package containing the  
same shall be distinctly marked "oleomargarine," shall be  
deemed guilty of a misdemeanor and punished by a fine of  
not more than two hundred dollars or imprisoned not more  
than twenty days or both.  
SECTION 2. Whoever knowingly imports, manufactures, sells  
or offers for sale any substance purporting to be, or having the  
semblance of butter, which substance is not wholly made from  
pure cream or pure milk, unless the same is imported or man-  
ufactured under its true and appropriate name, and each pack-  
age, roll or parcel thereof, and each vessel containing one or  
more packages of the same, has distinctly and durably painted,  
stamped or marked thereon the true and appropriate name of  
such substance, in ordinary bold faced capital letters, or who-  
ever sells, any such substance to consumers without deliver-  
ing with each package, roll or parcel so sold, a label on which  
is plainly and legibly printed the true and appropriate name  
of such substance, shall be guilty of a misdemeanor and pun-  
ished by imprisonment of not more than sixty days or a fine  
not to exceed two hundred and fifty dollars or both; but  
nothing contained in this Section shall be construed to pre-  
vent the use of harmless coloring matter in the manufacture  
of butter.  
SECTION 3. This Act shall become law from the date of its  
approval.

## AN ACT

TO AMEND SECTIONS 1 AND 2 OF AN ACT ENTITLED "AN ACT TO  
FURTHER SECURE POSTAL SAVINGS BANK DEPOSITORS," APPROVED  
THE 30TH DAY OF AUGUST, A. D. 1892.  
Be it Enacted by the Queen and the Legislature of the Hawaiian  
Kingdom:  
SECTION 1. Section 1 of the Act entitled "An Act to further  
secure Postal Savings Bank Depositors," approved the 30th  
day of August, A. D. 1892, is hereby amended by striking out  
all that part of said Section after the words "at the time of  
issue," so that said Section as amended shall read as follows:  
"Section 1. For the purpose of further securing deposi-  
tors in the Hawaiian Postal Savings Bank, the Minister of  
Finance, with the consent of the Cabinet, is hereby author-  
ized to sell at not less than par, from time to time, Treasury  
Notes of the Hawaiian Government, not exceeding the amounts  
of the deposits in the Postal Savings Bank at the time of  
issue."  
SECTION 2. Section 2 of said Act is hereby amended by  
striking out the word "five," and inserting in its place the  
word "one," so that said section as amended shall read as  
follows:

"Section 2. Such notes shall each be of the denomination  
of not less than one hundred nor more than five thousand dol-  
lars; shall be payable in not less than three months nor more  
than eighteen months after date of issue; shall bear interest at  
a rate not exceeding six per cent. per annum, payable semi-  
annually; and shall be payable, principal and interest, in gold  
coin of the United States of America or its equivalent, and  
shall be exempt from any taxes whatsoever."  
SECTION 3. This Act shall take effect from the date of its  
approval.

AN ACT

To Repeal An Act Entitled "An Act Granting a Franchise to Establish and Maintain a Lottery" approved on the 18th day of January, A. D. 1893.

Be it Enacted by the Executive and Advisory Councils of the Provisional Government of the Hawaiian Islands:

SECTION 1. An Act entitled "An Act Granting a Franchise to Establish and Maintain a Lottery," approved on the thirteenth day of January, A. D. 1893, is hereby repealed.

SECTION 2. This Act shall take effect from the date of its publication.

Pledged to neither Sect nor Party, But Established for the Benefit of All.

FRIDAY, JAN. 27, 1893.

A decision of interest to sailors has been rendered by Judge Nelson in the United States District Court at Boston. He passed upon the treaty of June, 1892, made between the United States and Great Britain, and held that under the treaty consuls are not given power to hear and finally determine differences between a master and a seaman.

The martial law is greatly appreciated at the Police Station. One arrest in three days owing to the early closing of the saloons makes the superior officers think there won't be any use for their jobs if it is kept up. But they forget the numerous semi-official temporary arrests made at night for the breaches of the law and the number of times the unfortunate policemen have to ask, "Have you got a pass?"

By latest advices a fatal cattle disease is raging in Japan and has totally destroyed the dairy industry round Yokohama. Not a head of cattle is living in a radius of 30 miles from that place and the disease is spreading. A beef famine is imminent. In Central Africa millions of cattle and buffaloes are also reported as dead from some new and speedily fatal disease. Whatever else we have in Hawaii our food supply is not in danger.

How injurious to a country is the effect of people thoughtlessly wagging their tongues without pondering on the result of their foolish utterances may be seen in the storm raised in the States by the suggestion that Mr. T. H. Davies' recent visit here was that of an emissary of the English Government, when it really was but his ordinary annual trip to personally inspect his business interests. But fools must clatter till the end of the world.

It seems as if the spoils were getting pretty well distributed. Whether the treasury can stand the expense of the new offices and departments is a matter which the financiers of the present administration will have to answer for themselves. But as taxation without representation is a wholly un-American system, we expect to find ultimately the matter laid before the taxpayers, who will consider whether this extraordinarily extravagant outlay is even temporarily necessary.

There is a present appearance that the projected great naval review at New York next spring, following the rendezvous at Hampton Roads, Virginia, will not take place. So far only six nations have accepted the invitation of the United States to participate in the review. An appropriation of \$300,000 is wanted to carry out the objects of the rendezvous and review and, unless this be granted by Congress, Secretary Tracy thinks it would be better to withdraw all the invitations and declare the review off.

The Advertiser this morning prints a letter which upholds Messrs. Kauhane, Iosepa, Waipulani and Kaui, members of the late Legislature, as being worthy of honor for having been free from all suspicion of bribery during its sessions. It is extremely significant that its editorial columns merely endorses the first two of these worthies. We suppose the others were too bitter a pill even for the Advertiser to swallow. And even of those two it may be said that influence strong had to be used to keep them in the straight path.

The Advertiser says this morning "There can be no doubt that the proclamation of martial law was one of the wisest acts of the administration." Passing over the implied accusation that all the acts of the administration have not been wise, we will simply say that if left to the voice even of its supporters no other act of the administration has been so strongly condemned for its foolishness. Not only because of the irritation and friction its absurd enforcement has created here, but on account of the untoward and objectionable influence the news of its proclamation will cause on our commercial relations abroad, where people do not understand the opera-bouffe element in the affair which has caused those playing at soldiers to desire some raison d'etre for their existence.

The hours of martial law for the city have been curtailed, being made from 11 p. m. to 4 a. m. instead of from 9 p. m. to 6 a. m. This is only reasonable action on the part of the Government. With all the vital points strongly occupied and the existence of the greatest possible facilities for transmitting alarms, nothing more than an ordinary watch distributed throughout the city is

necessary for any period of the twenty-four hours. There does not seem to be the slightest need for continuing the martial law in business hours inside of the Government building grounds. Common police precautions against the assembling of crowds or the loitering of individuals within the precincts should be enough, in addition to a garrison inside the building but out of sight and out of the way of people having business there.

LET THERE BE LIGHT.

One thing is absolutely necessary to the maintenance of confidence in the present administration, and that is a frank public statement of the position of affairs. It will not do to spring anything suddenly on the people. Whether changes are contemplated, whatever plans of future government, whether independently or in union with the Great Republic, must be made public, or endless dissatisfaction will ensue if nothing worse. If our rulers are negotiating to make us a state, a territory, or a district similar to that of the capital city, or if they propose to make this a protectorate under the aegis of the United States alone or of the Powers jointly, or whether they propose to erect this into an independent republic, or return to the monarchy so recently summarily abrogated or to have a regency during the minority of the Heir Apparent, or whatever scheme of stable and permanent government they have in hand, they must make it public and gain the consent of the majority after a full and free discussion. Otherwise it doesn't go. There will always be trouble just as Ireland and Great Britain will always have trouble till the same demand is conceded that the majority freely and willingly prefer the form of government they live under. Let us then have no more star chamber business. Nothing tends to allay fear and remove distrust so much as full and perfect knowledge.

CONFESSING WEAKNESS.

An article in the Advertiser this morning would indicate that there has already appeared dissension among the active supporters of the Provisional Government. That paper's attempt to lay the blame for this development on the "enemies of the new order" is a rather small subterfuge. It has been rumored for some days that the division of the spoils had caused some friction in the councils of the dominant party, but it is simply ridiculous to insinuate that the stayers by constitutional politics had anything to do with this interecine trouble of those who have adopted the principles of government by force. The persons least to be feared for making any trouble at this juncture are those who have not enlisted to support the new administration with arms. They calmly await the decision of the great Powers as to the right, justice and necessity of the recent violent overthrow of the Hawaiian Constitution and of popular government in these islands. They are not making a sign of opposing the temporary control of affairs by the Provisional Government, except in the exercise of the ordinary rights of discussion and criticism that even the government-by-gun party has not ventured to abrogate. Believing as we do in having whatever government exists at any given time strong enough to maintain law and order, it is with regret that we find the organ of the Provisional Government taking pains to expose the first element of weakness which has developed behind the scenes.

MURDER: STOP THIEF!

A mistake; a falsehood. In this morning's issue of the Advertiser mention was made about Luning getting judgment against me for \$21. It is a mean, insignificant lie, a falsehood, that the respectable portion of the community will not believe—a little cheap advertising which otherwise could not be gotten unless paid for.

Judgments can be gotten very easily, but to collect judgments is another thing. Luning got judgment against me some time ago for some shirts, but that judgment he only got in his mind; it was not in reality, for if he wants to get judgment against me he must pay for it, which Mr. Luning, like a nice little man did, not only pay me for the shirts but also all the costs. Perhaps he did not know that the shirt man was dead on to him, as the rain said to the dust—"I am on to you; your name is mud." It is with great regret that I must put myself before the public with such a man as Luning. All I have to say is that it is a malicious falsehood in saying that Luning got a judgment against me for \$21, which everybody will disbelieve.

BIG COAL DEAL.

Another Bite Out of Canada by American Capitalists.

HALIFAX, Nova Scotia, Jan. 11.—It is stated on good authority that the anthracite coal combine of the United States and the Canadian Pacific Railroad have about concluded a deal by which, for the consideration of \$17,000,000, they secured control of the coal-fields of Nova Scotia to protect themselves against Nova Scotia coal in case the duty on coal is removed. The Legislature has been called to ratify the deal.

PHILADELPHIA, Jan. 11.—The reported purchase of the Nova Scotia coal-fields by Pennsylvania coal operators, the Reading Railroad Company and others could not be actually confirmed here, but that such a deal has been consummated is generally believed in financial circles. It is said that William C. Whitney of New York is interested largely in Nova Scotia deals and that his brother went to Halifax some time ago to complete the final negotiations of the sale.

Nearly 300 people are on the verge of starvation at Homestead, Pa., and another strike is threatened there.

The richest find of gold ever made in Southern Mexico is reported. There is a great rush to the diggings.

The idea, there, is, that revolutions mean a general flattening out of business, and a probable failure on the part of merchants in the rebellious community to liquidate their bills; that one-half the population carries guns and the other half welters in red, red gore. The arrival in San Francisco of the Commission sent out by the present government will go far toward dispelling any fears or false ideas which the people may have regarding the situation here. Through it, our friends across the sea will learn of the peaceful and submissive character of the Hawaiian and the gentlemanly bearing of the white population who deemed a change of government necessary.

More danger follows the downfall of a ward political faction in New York than the establishing of a Provisional government in these Islands; the Hawaiians are, at least, civilized and intelligent.

Speaking of intelligence. 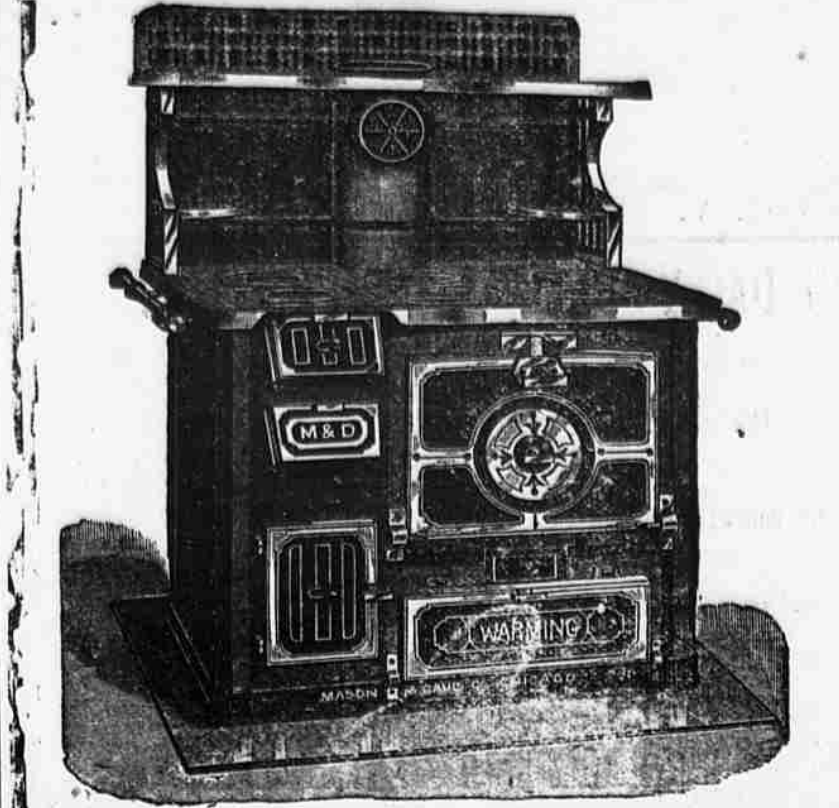

SPLIT VOTES.

States That Gave a Divided Vote in the Presidential Election.

The California members of the Electoral College met in Sacramento and gave eight votes for Cleveland and Stevenson and one vote for Harrison and Reid.

The Electors of Oregon cast three votes for Harrison and Reid and one vote for Weaver and Field.

The Electors of Ohio voted 22 for Harrison and one for Cleveland. This is the first Democratic electoral vote in Ohio in forty years.

North Dakota's Electors voted one each for Cleveland, Harrison and Weaver.

In Michigan the votes of Electors went nine for Harrison and Reid and five for Cleveland and Stevenson.

Russo-American Alliance. The St. Petersburg correspondent of the London Times says: "Professor Martens, the great Russian authority on international law, has been appointed a member of a special commission in connection with the seizure of British sealers in Behring Sea. This leaves no doubt that Russia will deal with the question from an international point of view and confirms the belief that it is her intention to follow America's lead and claim that the Behring Sea is closed with exclusive rights to the west of the imaginary line drawn by the Americans. There is every indication that Russia and America are working hand in hand against England."

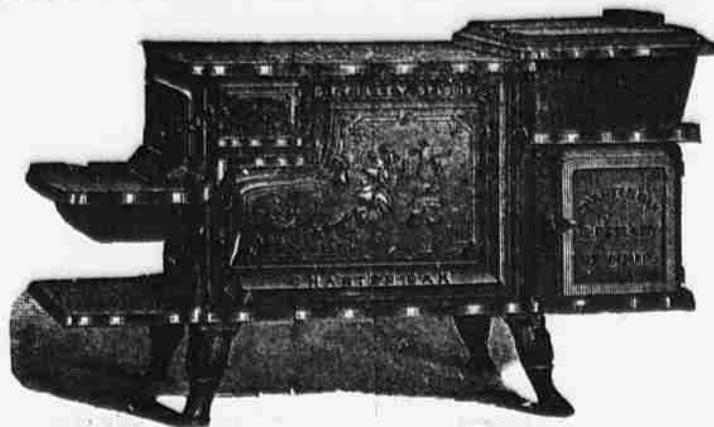

**EIFFEL'S GRABBING.**

**Specimen of Tall Stealing From the Panama Canal Funds.**

The following is a portion of the telegraphed report of the trial of Charles de Lesseps, Fontane, Cottu and Eiffel, accused of complicity in the Panama Canal frauds:  
When the court was solemnly convened President Porvior proceeded to examine Fontane, who said shortly after the formation of the Panama Canal Company he was placed in charge of the company's business with the press. He detailed at length what his duties were, and gave much valuable information regarding the bribery of newspapers to prevent hostile attacks upon the company and to prevent the publication of matter that would have shown the true condition of affairs on the isthmus of Panama. Fontane stated that he had held his position as manager of the company's press affairs until 1885, when the exactions of the newspapers became so heavy that he was compelled to abandon the position. Since that time he had been merely the private secretary of De Lesseps. He had distributed to the press only 60,000 francs in drafts payable to bearer.

In the examination of Mr. Eiffel he admitted that he had cashed checks for 12,000,000 francs which were ostensibly drawn to pay for machinery, while he actually expended only 1,500,000 francs for that purpose. He gave 2,000,000 francs to M. Hebrard to secure contracts with the company, and 2,000,000 francs to De Reinach to secure the latter's influence in his favor with the Government. Two million francs were also paid by him to a certain contractor, whose favor, like that of Hebrard and Reinach, was indispensable.

All of these admissions were made only after a severe course of questioning. The presiding Judge then asked Eiffel what he did with the 6,000,000 francs received by him for taking to pieces, shipping to the isthmus and reconstructing machinery, which, as a matter of fact, he never even supplied in this country. "I kept that sum," replied Eiffel calmly, "because it formed part of my remuneration for the risk I was undertaking."  
"Your contract," said the Judge, "provided that you were to receive 30 percent to be paid within thirty days of the date of sending the orders. Now, you took 2,875,000 francs from one firm as a percentage, although your orders were never executed."  
Eiffel replied that it was not his fault that the order was not executed. He himself had often paid on contracts which were never executed. Besides this, there was the contingency contemplated by the general condition of the transaction. "I consider such a transaction as void," said the Judge, severely, "since it was the result of an error, to call it nothing worse. The Prosecutor-General will tell you more about this to-morrow and at the subsequent sittings."  
Eiffel quailed visibly under these words.

**OPIUM LICENSE.**

**What Effect the Chronicle Thinks It Will Have on Hawaiians.**

The following is an editorial paragraph in the San Francisco Chronicle:  
Hawaii proposes to legalize the sale of opium and its use in smoking. The country is so hard pressed for coin that all the old moral arguments have proved of no avail against this measure for increasing the revenue. One result will probably be a great increase in the opium habit, which has already gained a firm hold on thousands of the natives. With free indulgence in this vice it will not require many years to wipe out the small remnant of the once-powerful Hawaiian race. In connection with the subject of opium smoking it is noteworthy that English physicians in China are making reports on the small effect of the drug upon the Mongolian. They claim that opium smoking is attended with less baneful results than whisky drinking, and their facts and arguments are used by the English newspapers in Shanghai and Hongkong to justify the British policy that forced Indian opium upon the Chinese. This is an ingenious method, but the conclusions reached by the doctors do not agree with the observations of travelers in the districts of China given up to culture of the poppy.
